# Two emaSwati nabbed with E4.7m of dagga at Oshoek border

SOUTH African Police on Monday made a breakthrough by arresting two suspects from Eswatini after they were found in possession of more than E4.7 million worth of dagga.


The two Swati men aged 33 and 34, it is said, were spotted and arrested after an intense search at the Oshoek Ports of Entry in the Republic of South Africa.

Oshoek is one of the main border gates between Eswatini and the Republic of South Africa but the SAPS on their website did not mention if the arrested duo were entering SA or were leaving for Eswatini.

"The SAPS members from Border Policing made a breakthrough by arresting two suspects, aged 33 and 34 after being found in possession of more than R4.7 million worth of dagga near Oshoek Ports of Entry on Monday, 22 April 2024," the SAPS was quoted in its official Facebook page yesterday.

It is said that the members of the SAPS were doing their routine patrol duties near the Redhill-off ramp when they spotted a white Toyota Hilux, branded with a certain Courier company logo. Upon stopping this vehicle, the report discloses that they conducted a thorough search and it was during this time when the astute members discovered large wrapped packages, loaded with 1,133 kg of dagga at the back of the bakkie.

It is said that the estimated street value of the dagga is at about R4, 758, 600, 00 and



according to the report, it was also during this period when the two male suspects were apprehended and charged for dealing in dagga.

Meanwhile, this is not the only major bust, but it has also been reported on the SAPS website that the border policing unit has arrested a 43-year-old truck driver from the Kingdom of Eswatini for allegedly attempting to smuggle dagga into South Africa. In a statement on Friday, the SAPS said the male suspect was apprehended at the Oshoek Port of Entry in the early hours of Thursday morning, last week.

According to police, at around 00:30 am, the suspect was searched by members of the SAPS on the arrivals side of the port of entry.

"It was during this search that the astute members discovered the dagga concealed under a load of timber. As a result, the driver was detained

and charged accordingly," the statement said.

A total of 150kgs of dagga with an estimated street value of R630 840 was seized.

The truck, with number plates from the Kingdom of Eswatini, was confiscated together with the seized dagga for further investigation. The suspect is expected to appear at the Elukwatini Magistrate's Court today.

Mpumalanga Provincial Commissioner of the Police, Lieutenant General Semakaleng Daphney Manamela, in the statement applauded the members for their dedication.

"The continuous arrests and successes witnessed at the borders prove that indeed the members are working with diligence. They are doing an excellent job daily," General Manamela said.

### 14-year-old boy stabs 16-year-old to death

Another gruesome murder occurred at Lobamba whereby a 14-year-old boy stabbed and killed a 16-year-old boy who was selling in this area at Sihlahleni traffic circle, yesterday.

Deputy Police Information and Communication Officer, Assistant Superintendent, Nosipho Mnguni confirmed the alleged murder.

The 14-year-old suspect is expected to be brought before the Magistrate court on Wednesday (today) where he will be formally charged with the murder.

It cannot be ascertained at the time of going to the Press if the suspect is attending school or not.

In an earlier report, Judge Langwenya stated that Eswatini came third at the rate of 9.31 stabbing deaths per 100,000 people.

She said death by stabbing was a tragically common occurrence in the world today and it is one of the leading cases of violent deaths ranking in the top three alongside shootings and beatings.

### 3% of girls in Eswatini engage in sex at the age of 15

THREE per cent of girls aged 15-17 had had a sexual experience by the age of 15 and none of the boys had sex by this age.

This is contained in the 2024 Eswatini National Population Policy Draft.

The 2024 Eswatini National Population Policy is built on the experiences from the review of the 2002 National Population Policy. The 2002 policy was Eswatini's first National Population Policy and was developed as part of the Programme of Action of the 1994 International Conference on Population and Development.

Apart from addressing high levels of main total fertility has been observed in both in 2021-22. It states that current estimates ternal mortality and emerging issues, the rural and urban areas, however, it has been show that the proportion of women aged 2024 National Population Policy has also more pronounced in urban areas. 15-19 years who are married or in the union been developed to accelerate the integration of population variables into development planning and efforts aimed at harnessing the demographic dividend.

According to the 2024 National Population Policy Draft, Eswatini's fertility has been falling over the past decades.

"A trend analysis reveals that the Total Fertility Rate (TFR) declined from 7.8 children per woman in 1966 to 3.2 children per woman in 2021-2022. This translates into a decline of about four children per woman," read the policy draft in part.

According to the policy draft, the decline

The policy draft further states that in 2007, the fertility rate in urban areas was three children per woman, while in rural areas, it was 5.6 children per woman.

'Similarly, in 2021-22 fertility was 2.9 for urban areas and 3.3 in rural areas. However, it is worth noting that there was a slight increase in TFR for urban women from 2.3 in 2007 to 2.9 in 2021-22," read the policy draft. According to the policy draft, the country experienced a notable decline in teenage pregnancy, with the adolescent birth rate dropping from 87 per 1000 adolescents in 2014 to 78 per 1000 adolescents was at three per cent in 2021-2022 reducing from four per cent in 2014.

The policy draft further states that sexual debut figures reveal that three per cent of girls aged 15-17 had had a sexual experience by the age of 15 and none of the boys had sex by this age.

"These indicators influence the early start of childbearing which hurts education attainment and prospects of gainful employment," read the policy draft. It further reveals that (TFR) is expected to continue to fall from 3.2 per cent in 2017 to 2.5 per

### Siblings fighting over E52 000 worth estate

TWO siblings decided to battle it out before the Commission of Inquiry of the Master of the High Court over their late mother's vehicle worth E52,000.

Boycey Magongo made his submissions before the Commission wherein he stated that his sister should have not been appointed as an executor of their mother's estate.

He stated that his sister Bongiwe once threatened to assault him and reported him to the police for stealing their mother's vehicle when such was not the case. Instead, he bought the vehicle from his mother when she wanted to renovate her kitchen.

His sister Bongiwe was present and told the Commission that she had a car breakdown and had to borrow her mother's car, who told her to ask Boycey because he disappeared with it such that she could no longer go to hospital.

When Bongiwe called Boycey he stated that the car was at the garage being replaced with shocks and other items and was in short of E2,500 for payment, which she said she would pay because she needed to use it.

It turned out that Boycey had pawned the vehicle for a loan.

"I asked our mother about this, and she was beyond baffled as we all were because the vehicle was under her name not Boycey's. I then advised her to open a case with

the police because what our brother had done was illegal," she said.

Their mother opened a case that is pending in court restricting the sale of the vehicle which will allow for the estate to be winded up.

According to Bongiwe, when Boycey found out that police officers from Manzini were looking for him, he rushed to Mbabane police station to report that officers from Manzini were harassing him.

When the officers called the Manzini office, they were directed to tell Boycey to report to the Manzini police station or he would be listed as a fugitive.

He immediately reported to Manzini, and

he was arrested and charged with the theft of a motor vehicle.

When their mother died on April 25, 2023, Bongiwe had to list all her properties as inventory which consisted of the vehicle only because the homestead is on Swazi Nation Land and cannot be sold.

However, the vehicle was found to have been illegally registered under Boycey, and he said he had bought it from their mother.

Boycey was questioned on why his mother would report him for stealing the vehicle if he had purchased it and when asked to produce receipts, he said his mother never gave him any.

According to Bongiwe, Boycey does not

listen to any of his siblings such that they have been to Umphakatsi which also washed its hands on his conduct and the matter has been reported at the Magistrates Court for a peace binding.

The vehicle cannot be sold, and the money distributed until Boycey's criminal matter has been concluded as it is an exhibit as per the directive from the prosecutor handling the matter. Therefore, the estate remains unwinded.

### Nibanga lite'

DEPUTY Chairperson of the Commission of Inquiry probing Master of the High Court Judge Mzwandile Fakudze said the siblings are fighting over nothing and should find means to keep the peace.

"This is an estate of E52,000 and you all are grabbing each other's throats over nothing," he said.

Fakudze said the siblings should listen to Umphakatsi, stop fighting, and consider that the family homestead is built on Swazi Nation Land and therefore cannot be distributed.

As a result, they should live in harmony for their sake and that of their children.

### 'Side chick' (38) lays rape charge against married man (34)

FOR every action, there is an opposite reaction.

This is evident in a situation whereby a married man who has found himself in hot water after his sexual partner reported him to the police for allegedly committing the offence.

The accused person Sandile Shoba Ginindza put in an urgent bail application at the Hogh Court on Tuesday where he disclosed that he is married, and the complainant is his sexual partner.

In his affidavit, Ginindza stated that he had known the complainant for quite some time and had a sexual relationship whilst he was residing at his parental homestead at Mpolonjeni in Mbabane before he relocated to his homestead at

On the day of the alleged incident, the couple went out for alcoholic beverages at Mpolonjeni where they were together with their friends.

"Whilst enjoying alcoholic drinks, we would from time to time kiss each other. She was the one who was pursuing me in the presence of my other friends," he submitted.

According to Ginindza, late in the night, he informed one of his friends that he was calling it a night and was headed home.

The complainant offered to accompany him as it was already dark, and he was no longer familiar with the area because he resided at Luve.

Ginindza said he innocently agreed to her offer, and they left for his parental homestead, however, upon arrival at the gate, she allegedly started kissing him and further suggested that he walk her to her house because she was home alone.

"To my surprise and dismay, she told me she did not feel safe as it was dark, yet she was the one who had accompanied me home

When we got to her house, she invited me inside and proceeded to her bedroom where she returned with condoms, told me to put one on and engage in sexual intercourse with her," he said.

However, Ginindza was baffled when he received a call on April 18 whilst at his homestead at Luve that she should report at the Mbabane Police Station which he


Upon arrival, he was arrested and charged with contravening Section 3 (3) of the Sexual Offences and Domestic Violence Act (SODV) 15 of 2018.

He told the court he is married with three minor children and resides with his elderly grandmother at Luve all of whom are fully dependent on him for maintenance and upkeep.

He submitted that he would plead not guilty to the charge and further undertook that he would adhere to all bail conditions imposed by the High Court.

## SOS Children's Villages empower youth

### TEACH them young!

SOS Children's Villages Eswatini organized a comprehensive training session which focused on cybersecurity, sexual reproductive health rights, and mental health awareness. The initiative, which targeted approximately 150 children and young people from Lugongolweni, Langa, Sikhuphe, and other locals within the Lubombo region. In a statement shared by SOS Children's Villages Communication Coordinator Temalangeni Dlamini, the event was aimed at addressing the multifaceted challenges faced by adolescents, particularly during school holidays.

The training, spearheaded by SOS Children's Villages in Siteki, emerged from a recognition of the vulnerabilities children encounter when left idle at home. In response, the organization seized the opportunity to educate youngsters on safeguarding themselves across various domains, including online safety, physical health, and mental well-being.

During the event, the sessions commenced with discussions on child protection and safeguarding, led by Gugulethu Mavuso, the National Child Safeguarding Coordinator SOS Children's Villages. Mavuso highlighted the reciprocal nature of rights and responsibilities, urging participants to honor their obligations while demanding respect for their rights. Emphasizing the importance of parental involvement, children were encouraged to actively engage in household chores and maintain respectful communication with their guardians.

Assistant Commissioner Nicholas Jele and Cyber Crime Investigator Sergent Ntokozo Msibi from the Fraud & Commercial Unit's Cyber Desk addressed the prevalent threats of cybercrimes and online harassment and they provided insights into cybercrime prevention strategies. Commissioner Jele issued a stern warning against engaging in illicit online activities, particularly cautioning against divulging personal information and forming relationships with strangers that could potentially lead to child trafficking.

The pivotal role of parental support and understanding in navigating these challenges was emphasized throughout the training. Participants were urged to maintain open communication with their parents or trusted individuals, seeking assistance whenever faced with difficulties or threats.

Further enriching the program, Bukiwe Dlamini, Prevention Officer from Bantfwana Initiatives, shed light on the importance of mental health maintenance. Dlamini shared the positive aspects of leisure time, urging the youth to harness their creativity and explore new avenues of expression during periods of idleness. Dlamini emphasized the need for relaxation and play, as vital components of mental well-being. She further said such aims to mitigate the risk of depression and other mental health issues that could potentially escalate to suicide.

SOS Children's Villages Eswatini is an independent, non-governmental child welfare organization and an affiliate member of SOS Children's Villages International. Established in 1989, SOS main objective is to support and provide quality childcare to children who have lost parental care and those at risk of losing parental care.

The organization since its inauguration has strived to drive its mission of building families for children in need, helping them shape their own futures and contribute to the development of their communities. Currently, SOS has 288 children in the three villages. It also have 3213 children and youths being assisted in communities under the Family strengthening programmes.

### Young man who loves widows, challenges MPs;

### Enact law protecting widows urgently

A young man who has been advocating for the rights of widows for over 8 years now is urging the government to pass laws that protect them and their children.

Delaying the enactment of such a law will have consequences for the children of current lawmakers in the future, according to Lungelo Zulu, Director of Umhluma Women and Youth Foundation, a widows' organization.

Zulu shared, "After losing my father 21 years ago, I developed a deep appreciation for widows. Unfortunately, due to the Inheritance Rights Act, my siblings, mother, and I were not entitled to any inheritance from my father's estate. The issue was that we were the children of his second wife."

Zulu confided in Eswatini on Sunday that he and his siblings had to experience the sorrow and difficulties of losing their father,

only one providing for the family. Zulu recalled the challenging period after their father's passing and emphasized the absence of assistance and safeguards given to widows and their children in such circumstances. "We didn't receive anything after our father's death," he revealed honestly.

Zulu, who possesses a deep empathy for those who are in similar situations, passionately urged the members of Parliament to consider the suffering of widows and their children. Zulu requested the Parliamentarians to take concrete steps to ensure that the welfare and rights of widows and their children are protected by

It is important to note that in the absence of adequate legal provisions, widows and their children face a host of challenges.

Zulu further pointed out that their organization, which has been operational for 8 years, advocates for the rights of widows and provides advice on all customary rights issues. They also provide capacity building on self-sustainable development to reduce

Zulu spoke to Eswatini Sunday, stating that during their youthful years, they have devoted themselves to advocating for the rights, welfare, politics, and legislation concerning widows.

The director also urged the church to fulfill their biblical obligation to take care of widows and their orphaned children.

"I constantly speak about the plights faced by widows in the country because I know the widowhood experience through my mother. Growing up without a father is hard and painful," pointed out the director.

Zulu believes that it is important to have this law because it will legally protect and safeguard the rights and welfare of widows.

""My request to the newly elected Member of Parliament is to raise motions in the parliament regarding the rights of widows in the country. It is important to protect and respect them, as anyone can become fatherless anytime and can become a widow anytime. Therefore, I urge all the Parliamentarians to take necessary steps to safeguard their rights."

Zulu made an appeal to all women to prevent any widow or child from shedding

tears. He emphasized that nobody chooses to become a widow or fatherless. Therefore, it is our collective responsibility to take care of them.

The sad truth is that anyone can become a widow or fatherless, anytime.

Joram Suborurema of Malkerns Square appeared yesterday before Principal Magistrate David Khumalo at the Manzini Magistrates Court.

He was charged with the contravention of Section 91 (1) as read with Section 122 (2) of the Road Traffic Act 6 of 2007.

According to the charge sheet, being the driver of a Honda sedan, Suborurema wrongfully drove the said vehicle at Nyandza under the influence of intoxicating liquor or drug with a reading of 0.73mg/l which was above the legal limit of 0.38mg/l.

His particulars of drink-driving were said to have been that he had a sharp smell of liquor through his breath and bloodshot eyes.

According to Suborurema, he was shocked after being arrested for driving a motor ve-

hicle while under the influence of alcohol since he had only imbibed the liquor on the previous day of his arrest.

He, therefore, opined that his arrest was unlawful since the reading on the breathalyzer was not factual.

According to the senior citizen, when explaining the circumstances leading to his arrest, he was celebrating the release of his relative from prison after being arrested for over 30 years.

He said thereafter, he never touched alcohol until he was arrested for drink-driving the following day.

He complained that even though he was 74 years of age, the police were keen to keep him in police cells for a longer period before he could appear in court.

The presiding magistrate elucidated to Suborurema that police officers were laymen, and therefore, they were not privy to how one has to temper with a breathalyser.

He, therefore, sentenced him to one-year imprisonment with an option of paying a fine of E2 000.

### Man granted E3k bail for stealing two goats

A man from Nkhaba was granted bail of E3000 for stealing two goats worth E2,400 and a Samsung tablet worth E1,500. Sabelo Seluleko Mamba appeared before Magistrate Lenhle Zulu and, in his plea for bail, stated that he was a breadwinner at home, had children of his own, and that his parents were sickly.

The magistrate, after careful consideration, granted him bail, subject to certain terms that are designed to reduce the risk of further offences being committed.

It should be noted that a breach of bail conditions is not an offence but does carry a power of arrest. It is encouraging to know that up to 90% of defendants are successfully bailed with conditions, which are complied with and have therefore meant that the victim or community has been protected from further harm while preventing the need for unnecessary or inappropriate detention in police custody or prison custody.

Another matter of Sihle Ntshangase was taken down by the court after seeing traces of passion. Ntshangase appeared before the court for stealing items worth E2,800 from the mother of his baby. He took Avon lotions, Avon oils, Chanel perfume, a sling bag, baby wipes, perfumes, and Air pods. The value of the stolen items combined was E2,805. Magistrate Zulu warned both parents not to use the child as a weapon in their fights and further warned the mother, Ms Babazile Dlamini, not to defer payments of maintenance. She made it clear that the child would be taken away from both if they continued

with such behaviour.

In the same court, two warrants of arrest were issued to Alpheus Mamba and Sibusiso Mpungose. Two young boys were called in front of the magistrate for theft, on April 20, 2024, in Nkoyoyo. They broke into a home and stole a brush cutter worth E2,700. They both had a lawyer who mitigated on their behalf.

The brush cutter was also brought to court as evidence and it highlighted that it was recovered as soon as they stole it. They were charged E1500 each and faced five months in prison. This was the same fate for Mr. Melusi Sherpad Shongwe who drove into another car at Pick n Pay traffic lights.

When he did this on March 25, 2024, he rammed into another car that he could not help fix. He was fined E500 for negligent driving, and default of payment grants him five months behind bars. It is important to note that the court takes all matters seriously and strives to ensure that justice is served fairly and impartially.

A rape suspect, Bonginkhosi Ayanda Mavuso (23) has told the High Court that the complainant he is accused of raping lied about her real age.

He was on April 3 arrested for rape and charged with contravening Section 3 (3) (a) of the Sexual Offence and Domestic Violence Act 15 of 2018 for unlawfully having sexual intercourse with an 11-year-old once without a condom.

The high school-going suspect told the court that he met the victim three months ago at a sports ground where he is currently schooling and when he proposed love to her, she told him she was 18 years old.

He took into consideration her mature body structure and the fact that they met at the High School sports ground and believed her.

Mavuso stated that before they engaged in sexual intercourse on the day in question, she allegedly disclosed to him that she previously had engaged in sexual relations with two other boys from the surrounding area, and assured him she was of mature age and could consent to the encounter.

"I only discovered her real age when I was arrested that she had lied. At all material times in our two-month relationship, I was under the impression that the complainant is 18 and was about to complete high school," Mavuso submitted.

He stated that he is innocent and will plead not guilty during trial

Bail was granted at E50,000 and Mavuso was ordered to pay E5,000 cash and the rest as surety and he is expected to report at the Piggs Peak police station every last Friday of the month pending finalisation of the mat-



THE Minister of Agriculture, Mandla Tshawuka, alongside Minister of Tourism and Environmental Affairs Jane Mkhonta and Principal Secretary Sydney Simelane, attended the Food and Agriculture Organization (FAO) 33rd Africa Conference and the Moroccan International Trade Fair.

The conference, which is a pivotal platform for discussions on pressing agricultural and environmental issues, saw Minister Tshawuka actively engaging on crucial topics such as the Blue Economy and the transformation of agrifood systems.

During the conference, Minister Mandla Tshawuka highlighted impactful contributions that expressed Eswatini's commitment to addressing regional challenges and strengthening sustainable development. According to information shared by the Ministry, in a morning session focused on the Blue Economy, Tshawuka highlighted the unique predicament faced by landlocked countries, including Eswatini, which lack direct access to ocean resources.

When unpacking the study, Dr Rejoice Maseko said it was amazing to see the numbers, but they also proved more women needed to join the field.

On Tuesday, the country and the world at large celebrated women in science. This forum organized jointly by the Ministry of ICT, the Women in Science Engineering and Technology (WISET) and the Joint River Basin Authorities.

This event sought to honour women in science and encourage active participation of women and girls in science and innovation. It also allowed women in Science, Technology, Engineering, and Mathematics (STEM) to engage with professionals, policymakers, and aspiring women leaders, fostering collaboration and inspiring change.

"A study by UNESCO in 14 countries revealed that the probability for female and maybe male students graduating with a Bachelor's degree, Master's degree and Doctor's degree in science-related field are 18%," said Maseko.

Maseko in addition, said in most western countries women are highly underrepresented in those Science, Technology, Engineering, and Mathematics (STEM) fields that have not a direct connection with the provision of care,

such as engineering and computer science (UNESGO, 2021).

"However, women are highly represented in those STEM fields associated with health and the provision of care, such as medicine, chemistry, or biology," she said.

Interestingly, current research has identified a paradox between levels of gender equality and the participation of women in

STEM fields. In this way, the more egalitarian the countries are (for example, Norway or Finland), the less female participation in STEM fields. On the other hand, there is a tendency to make invisible the contributions of women in scientific and technological fields whereas, on the contrary, highlight the contributions of men in these areas.

This undoubtedly has an impact on

the way in which these contributions are transmitted and taught in the school and university contexts, but it also has an influence on the workplace, where on many occasions, the contributions of women to the development of a discipline, an idea, or a specific project tend to be undervalued. Likewise, in many societies' male-dominated STEM.

JOHANNESBURG — South Africa's central bank said on Tuesday that the path back to 4.5 per cent inflation would probably be "bumpy and protracted" after setbacks in the disinflation trajectory in recent months.

The South African Reserve Bank (SARB) has held its main interest rate at 8.25 per cent since May 2023, keeping policy restrictive to try to steer inflation towards the midpoint of its 3 per cent to 6 per cent target band.

In March headline inflation slowed to 5.3 per cent in annual terms from 5.6 per cent

In a biannual review of its monetary policy stance, the bank said the slower pace of disinflation partly reflected normalising

services components and elevated inflation expectations.

Administered prices continue to exert substantial upward pressure on headline inflation, it said in its April Monetary Policy

The SARB, which is in discussions with the National Treasury about lowering its inflation target, also said in the document that it had modelled the impact of targeting 3.0 per cent inflation over a five-year timeframe.

That modelling showed the economic growth rate decreased by about 0.3 percentage points relative to the baseline, but the decline was quickly reversed and surpassed as growth strengthened more than the initial weakening.

The central bank added markets now expect the repo rate to remain unchanged this year. (Reuters)

### Capitec expects loan losses to be within target in 2025

JOHANNESBURG — South African lender Capitec Bank said on Tuesday its loan losses in retail banking will likely shrink to within its target range in 2025, as its full-year profit rose by 16 per cent, sending its share up 7.43 per

Capitec Bank is one of the fastest-growing South African lenders, targeting low-income earners who were largely ignored by the country's bigger, established banks. But this exposure has meant higher

impairments, with its customers under pressure from 10 successive interest rate hikes and higher food inflation.

The lender, South Africa's biggest retail bank by customer numbers, has seen a slower migration of retail credit into underperforming loans from performing loans in the second half of its 2024 year ended Feb.29, CEO Gerrie Fourie told investors.

Client cash flow strain, however, has improved over the last six months, with customer insufficient fund transactions coming down, he added.

But estimated credit loss increased in the full-year period, and as a result, the credit loss ratio - a measure of bad loans as a percentage of total loans - in retail banking increased to 101 basis points (bps) from 80 bps in 2023.

"The credit loss ratio is expected to return to through-the-cycle target of 8.5 per cent (or 85 bps) by February 2025," Fourie said.

The company, with 22 million retail clients, said overall credit impairment charges rose by 38 per cent to 8.7 billion rand (\$453.21 million). At group level, its credit loss ratio rose to 87 bps from 70 bps.

Capitec said it continued to tighten its credit-granting criteria.

The group's headline earnings per share the main profit measure in South Africa rose to 9,171 cents as its net transaction and commission income grew by 29 per cent to 14.8 billion rand.

After terminating its funeral product cooperation arrangement with insurer Sanlam, Capitec said it will start adding life cover as it continues building its insurance business. (Reuters)

### PepsiCo's results beat as international demand, higher prices drive growth

PEPSICO beat Wall Street expectations for first-quarter revenue and profit on Tuesday as demand for its sodas and snacks like Cheetos and Doritos in international markets drove growth even as it witnessed a slowdown in the United States.

Consumers across Europe, Asia Pacific and China shelled out money for PepsiCo's pricey sodas and chips, while customers in the U.S. cut back on the products due to strained budgets.

"We've had three years of ... massive consumer inflation and that has to be absorbed and I think the cumulative impact of that put a bit of strain on the consumer. But we expect that to abate as time goes on,"

PepsiCo CFO Jamie Caulfield said.

The company's average prices jumped 5 per cent in the first quarter. Its organic volume slipped 2 per cent, compared to a 4 per cent drop seen in the fourth quarter.

International business accounted for about 40 per cent of PepsiCo's fiscal 2023 revenue, while its North America businesses accounted for the remaining.

PepsiCo has been expanding its portfolio in developed and emerging markets to drive demand by launching items such as flavored Quaker instant oats and Celsius energy drink, CEO Ramon Laguarta said.

Shares of the company, which also maintained its fiscal 2024 forecasts, fell 1.5 per cent.

First-quarter sales at PepsiCo's largest business, its North America beverage unit,

rose 1 per cent, while organic volume fell 5 per cent.

Total sales at its Quaker Foods North America unit fell 24 per cent following Quaker product recalls first made in December in the U.S. due to a potential salmonella contamination.

PepsiCo expects its North America businesses to gradually improve as impacts associated with product recalls moderate.

The company's first-quarter net revenue rose 2.3 per cent to \$18.25 billion, beating LSEG estimates of \$18.07 billion. PepsiCo's core profit of \$1.61 per share topped expectations of \$1.52.

"This is going to be another year of priceled revenue growth even though pricing has come down," Wedbush analyst Gerald Pascarelli said. (Reuters)

# SINGER John Legend says former President Trump is a racist down "to his core."

Speaking to MSNBC's Jen Psaki, Legend spoke of Trump's response to the Black Lives Matter protests following the 2020 murder of George Floyd.

"When we protested the killing of George Floyd, he was advocating for the military to shoot us in the streets," Legend said. "He has made it clear throughout his life that he believes Black people are inferior. Like, he believes that, to his core, in his bones."

According to then-Defense Secretary Mark Esper, Trump asked authorities in 2020 if they could shoot protesters in the legs during the unrest across the country. Gen. Mark Milley, who was the chair of the Joint Chiefs of Staff in 2020, also told The Wall Street Journal that Trump's idea for law enforcement to handle protesters was to "crack their skulls."

Trump has faced accusations of racism throughout and before his political career. He launched his 2016 campaign decrying immigrants as criminals and "racists," and earlier this year he hypothesized that "the Black people" appreciate him more because of his criminal indictments.

"And a lot of people said that's why the Black people like me, because they have been hurt so badly and discriminated against, and they actually viewed me as I'm being discriminated against," Trump said in South Carolina in February. "It's been pretty amazing, but possibly, maybe, there's something there."

# John Legend says Trump believes 'to his core' that 'Black people are inferior'

On Sunday, Legend also spoke of how Trump would avoid renting units in his buildings to Black Americans, something the FBI detailed in 20117.

Legend said Trump "believes in a genetic hierarchy of humanity, and it's racially determined."


Trump, who is seeking a second term in the White House, has been working to court Black voters this election cycle. In February, he attended the Black Conservative Federation's annual gala and he has hinted at choosing a Black running mate.

Trump has also claimed that he was the best president for African Americans. He has pointed to Black unemployment rate under his administration, funding for historically Black colleges and universities and criminal justice reform that passed during his time in office.

But Legend dismissed these comments, particularly claims of Trump's success with criminal justice reform, pointing out that Trump had previously called for shoplifters to be shot on the spot. (msn)

# Two lifeforms merge into one for first time in a billion years

FOR the first time in at least a billion years, two lifeforms have merged into a single organism.

The process, called primary endosymbiosis, has only happened twice in the history of the Earth, with the first time giving rise to all complex life as we know it through mitochondria. The second time that it happened saw the emergence of plants.

Now, an international team of scientists have observed the evolutionary event happening between a species of algae commonly found in the ocean and a bacterium.

"The first time we think it happened, it gave rise to all complex life," said Tyler Coale, a postdoctoral researcher at University of California, Santa Cruz, who led the research on one of two recent studies that uncovered the phenomenon.

"Everything more complicated than a bacterial cell owes its existence to that

event. A billion years ago or so, it happened again with the chloroplast, and that gave us plants."

The process involves the algae engulfing the bacterium and providing it with nutrients, energy and protection in return for functions that it could not previously perform – in this instance, the ability to "fix" nitrogen from the air.

The algae then incorporates the bacterium as an internal organ called an organelle, which becomes vital to the host's ability to function.

The researchers from the US and Japan who made the discovery said it will offer new insights into the process of evolution, while also holding the potential to fundamentally change agriculture.

"This system is a new perspective on nitrogen fixation, and it might provide clues into how such an organelle could be engineered into crop plants," said Dr Coale.

A 25-year-old "sugar baby" was handed a nine-year prison sentence for defrauding men she met on dating apps out of more than \$1 million, and selling a manual on how to carry out similar scams

Mai Watanabe, also known as "itadaki joshi Riri-chan," which translates as "sugar baby Riri," was sentenced by the Nagoya District Court on Monday, The Japan Times reported.

The news outlet said that Watanabe was also fined 8 million yen, about \$52,000.

According to the court's ruling, Watanabe defrauded three men in their 50s out of a total of around 55.8 million yen, about \$1 million, between 2021 and 2023, the Nippon

news agency reported.

She swindled one victim out of 117 million yen, about \$756,000, by convincing him that she needed the money to pay off a debt, according to the Kyodo news agency, which added that she used a similar story to defraud the other two men.

Nippon reported that Watanabe used most of the money to make payments at male host clubs in Tokyo's Kabukichō district.

In these clubs, female customers pay for male company and are often poured drinks and flirted with by male hosts.

Kyodo, citing the court's ruling, said that Watanabe was also convicted of creating a manual on how to execute similar scams.

# Fuming residents set seven classrooms alight

MAFIKENG - Teaching and learning was badly disrupted at the at Tosca Primary School in the Kagisano Molopo Local Municipality, North West, after seven classrooms were set on fire by angry residents.

The residents burnt school furniture, files, textbooks, and Grade R equipment during the violent and fiery action last Friday.

The North West Department of Education spokesperson, Mphata Molokwane, said in a statement that this comes after officials from the Department of Employment and Labour closed a block of three classrooms at the school last week on Tuesday, due to inadequate conditions for learning and teaching.

Following that, fuming residents in the area went to the school's premises intending to shut the school down.

"It is further alleged that on the day of

North West Education MEC Viola Motsumi has condemned the act, expressing concern over the continued targeting of school properties as a means of venting

"This is extremely sad and disturbing. It is disturbing that there are still communities in this province who vent their anger by burning school properties," Motsumi said.

"A school is a centre of knowledge for the community. Really, how do we expect learners to acquire information when we burn schools?,"

#### Result

Motsumi said that as a result of this incident, learners have lost five days without learning and teaching.

She added: "We have lost all the records of learners due to this horrible incident. As a department, we condemn this incident in the strongest terms and call for the immediate arrest of all those behind this fire.".

Meanwhile, the department said that it is committed to delivering mobile classrooms, today on Monday, to assist with teaching and learning.

Molokwane mentioned that a team of counsellors from the department has been put on standby to counsel learners and teachers as soon as teaching and learning

Plans to send some asylum seekers to Africa have met with fierce criticism, but the bill passed on Monday when the Lords dropped their opposition.

Mr Sunak said in a statement "nothing will stand in our way" now of getting flights off the ground.

But the scheme could still be held up by challenges in the courts.

Ahead of the bill passing, the prime minister said flights to Rwanda would take off within 10 to 12 weeks, missing his original

In a statement on Tuesday, he called the passing of the Rwanda bill "not just a step forward but a fundamental change in the global equation on migration".

He said: "We introduced the Rwanda bill to deter vulnerable migrants from making

perilous crossings and break the business model of the criminal gangs who exploit

"The passing of this legislation will allow us to do that and make it very clear that if you come here illegally, you will not be able

Charities have also hit out at the scheme, with leading human rights groups describing it as a "breach of international law".

During a live TV report by the BBC's home affairs correspondent Tom Symonds in Calais on Tuesday morning, a group of about 30 migrants boarded a small boat on the beach and could be seen heading out into the Channel towards the UK.

Asked about the moment shortly after during an interview on BBC Breakfast, Minister for Illegal Migration Michael Tomlinson said the bill passing was a "landmark moment", and that the deterrent would be felt when flights get off the ground.

### Senegal's new leader calls for 'rethought' relationship with EU

DAKAR - Senegal's new leader Bassirou Diomaye Faye has called for a "rethought" relationship with the EU during a visit by European Council President Charles Michel.

Faye, who was inaugurated as president on April 2, was elected on pledges of radical reform and promises to restore national "sovereignty" over key industries.

Speaking at a joint press conference with Michel on Monday night, Faye said cooperation between Senegal and Europe was "dense and multifaceted, but together we want a rethought, renovated partnership", one "capable of supporting the innovative dynamic we want to imprint on our relations".

As part of his promised reforms, Faye recently announced the renegotiation of oil and gas contracts, and hopes to do the same with fishing agreements signed with the European Union.

Fishing is a significant part of Senegal's economy, but the industry is grappling with the effects of overexploitation of marine

Michel said the two parties "should not dread" broaching difficult subjects if it meant "bringing about improvements for both sides", pointing to the fisheries issue

Faye said his government would pursue a model of boosting development from within, focusing on agriculture, livestock and fishing, while also strengthening infrastructure such as railways, electrical grids, telecommunications and roads.

"European investors whose companies have recognised skills in these different sectors are welcome," he added.

Michel said Europe had an "objective interest in Senegal being able to meet the challenges of development, economic emergence and improvement of the living conditions of the people".

### Truce crumbles in Sudanese army's last Darfur holdout

CAIRO/DUBAI - Attacks around the Sudanese city of al-Fashir have shattered a truce that protected it from a year-old war, leading to warnings of a new wave of inter-communal violence and humanitarian risks for 1.6 million residents crammed into the North Darfur capital.

Al-Fashir is the last major city in the vast, western Darfur region not under control of the paramilitary Rapid Support Forces (RSF). The RSF and its allies swept through four other Darfur state capitals last year, and were blamed for a campaign of ethnically driven killings against non-Arab groups and other abuses in West Darfur.

The fight for al-Fashir, a historic centre of power, could be more protracted, inflame ethnic tensions that surfaced in the early-2000s conflict in the region and reach across Sudan's border with Chad, say residents, aid agencies and analysts.

Al-Fashir's population includes an estimated half a million people displaced during that earlier conflict, when the army, assisted by Arab militias that evolved into the RSF, put down a rebellion by non-Arab rebel groups.

About half a million more people moved into the city during the war that broke out between the army and the RSF in the capital Khartoum in April 2023, as long-simmering tensions over integrating the two forces came to a head.

As the war spread to other parts of the country, local leaders brokered a truce in al-Fashir, with the RSF confined to eastern areas of the city while the former rebel groups stayed neutral.

But the arrangement fell apart after the RSF took the town of Melit this month, effectively blockading al-Fashir.

# Biden and Trump face enthusiasm test in bat

PHILADELPHIA - U.S. President Joe Biden and Republican challenger Donald Trump go before voters on Tuesday's primaries in the battleground state of Pennsylvania, one of the last tests of voter enthusiasm ahead of November's general election.

Pennsylvania, with 19 Electoral College votes toward the 270 needed to win, is a top prize and a toss-up in the 2024 presidential election featuring a Biden-Trump rematch.

In 2020, Biden won Pennsylvania by less than 1.5%, or roughly 80,000 votes. Trump beat Democrat Hillary Clinton there by fewer than 45,000 votes in 2016.

Biden clinched the Democratic nomination and Trump secured the Republican nod in early March, and neither faces serious opposition on the primary ballot. Still, the pair have visited the state in recent weeks and focused on the general election rather than Tuesday's vote. Biden was born and spent part of his childhood in the state, and has for decades been a fixture in the politics of neighboring Delaware.

Incumbent U.S. Senator Bob Casey, a Democrat, and his Republican challenger, Dave McCormick, are both expected to breeze through Tuesday's primaries. The race, which opinion polls show as close, could help decide whether Democrats retain control of the Senate.

Muslim and Arab-American voters are mounting an "Abandon Biden" campaign in Pennsylvania to protest the president's

handling of the Gaza crisis. He faced similar efforts in battleground states like Arizona, Wisconsin and North Carolina, with the biggest turnout a 13% uncommitted vote in Michigan's primary.

Organizers in Pennsylvania are aiming to get 40,000 write-in "uncommitted" votes. The results are not expected to come on Tuesday night because they will have to be entered manually.

Pennsylvania is home to a sizeable Arab-American population, but also one of the largest Jewish populations, trailing only New York, California, Florida and New Jersey, according to a U.S. Jewish population report

Although Trump's former rival Nikki Haley, a former South Carolina governor and U.N. ambassador, remains on the Pennsylvania ballot, voting is confined to registered Republicans and the primary locks out the independent voters who favored Haley during her run. (**Reuters**)

# China-US relations stable despite US 'interference', Chinese official says

BEIJING, April 23 (Reuters) - Relations between Beijing and Washington are stabilising despite U.S. actions that harm Chinese interests, a Chinese foreign ministry official has said ahead of a visit by U.S. Secretary of State Antony Blinken.

In laying out goals for the visit, the unnamed official, described as directorgeneral of the foreign ministry's department of North American and Oceanian affairs, said relations should stabilise and advance on a sustainable path.

But he said Chinese interests and its "bottom line" must be safeguarded, the state

news agency Xinhua reported on Tuesday.

"The United States stubbornly promotes the strategy of containing China, continuously adopts erroneous words and actions that interfere in China's internal affairs, smear China's image, and harm China's interests," the official was quoted as saying. During Blinken's visit, China will focus on strengthening understanding and dialogue, managing differences and promoting mutually beneficial cooperation and shared responsibilities, the official added. The trip will be Blinken's first to China since June, when the United States was trying to restore high-level engagements after "spy balloon" incidents, and increased

tensions around Taiwan were souring relations. Since then, friction has eased, but Blinken is expected to raise a number of concerns related to the South China Sea, the Russia-Ukraine war and the crisis in the Middle East, among others.

Chinese President Xi Jinping and U.S. President Joe Biden recently held talks that touched on hot-button issues, most notably ongoing confrontations in the South China Sea, and peace and stability across the Taiwan Strait. Xi had said ties between the China and the U.S. were beginning to stabilize, but that they could "slide into conflict or confrontation", according to Xinhua. (BBC News)

### Judge to consider gag order violations in Trump hush money trial

NEW YORK, April 23 (Reuters) - The judge overseeing Donald Trump's criminal hush money trial will decide on Tuesday whether the former U.S. president should be punished for violating a gag order that prevents him from criticizing witnesses and others involved in the case.

Prosecutors are asking Justice Juan Merchan to fine Trump for criticizing porn star Stormy Daniels and his former lawyer Michael Cohen, both of whom are expected to testify. They also have highlighted Trump's claim last week that people were lying to get on the jury so they could convict him.

Merchan could opt to fine Trump \$1,000 for each of those violations, as Manhattan District Attorney Alvin Bragg's office has requested.

Prosecutors have asked Merchan to remind Trump at the 9:30 a.m. hearing (1330 GMT) he may face more severe consequences if he keeps violating the order. The law permits the judge to send Trump to jail for up to 30 days, in what would be a dramatic twist to the first criminal trial of a former U.S. president.

Trump says the partial gag order, which prevents him from publicly criticizing witnesses, court officials and their relatives, is a violation of free speech.

Trump is charged with falsifying business records to cover up a \$130,000 payment before the 2016 election to buy Daniels' silence about a sexual encounter she says they had in 2006. Trump has pleaded not guilty and denies an encounter took place.

Prosecutors say it was part of a wider conspiracy to hide unflattering information from voters at a time when he was facing multiple accusations of sexual misbehavior.

"It was election fraud, pure and simple," prosecutor Matthew Colangelo said on Monday.

In his opening statement on Monday, defense lawyer Todd Blanche said Trump did not commit any crimes. "There's nothing wrong with trying to influence an election. It's called democracy," Blanche told jurors on Monday.

He said Trump acted to protect his family and his reputation and accused Daniels of trying to profit from a false accusation that they had sex.



# **Jackie Phomotse** writing another book

**CONVICTED** author Jackie Phamotse has announced that she will be releasing another book as part of her 'Bare' series.

Phamotse has been using her time under house arrest constructively and has completed the new manuscript for her new book under the 'Bare' series.

Randburg Magistrate's Court sentenced the explosive author to a two year sentence for defaming media moguls Romeo and Basetsana Kumalo, after she published a tweet alleging that Romeo had engaged in a sexual encounter with another man.

Phamotse's 'Bare' series explores the flashy, yet dark side of slay queens, blessers and human trafficking - all relevant topics in South African society.

The popular author shared on Instagram that the manuscript was done, after her readers requested another book and in her caption seemingly threw shade at the legal battles she has been facing.

Phamotse tweeted: "The BARE nation wanted a book and that's what I will deliver! Manuscript done. The worst thing you have ever done was to let me have my pen!

In response to a tweep, who advised Phamotse not to mention any names in her book, she clapped back that people should wait to read the book before assuming what it is about. "Wait until you know what the book is about! Stop assuming, the manuscript is highly protected at this point.

"I'm a writer that's my job and that's what I will continue to do for the rest of my life. God willing. You must have lost your mind if you think I won't work. When the time is right, we will reveal the book's contents," wrote Phamotse.

Phamotse pleaded that people revoke their lies and reminded them that no one ordered her not to work and that her life will continue as it was.

### Why does medicine keep getting it wrong?

IN the case of children with genderrelated distress, the Cass Review, published two weeks ago, makes it clear that for years, doctors have been prescribing powerful hormones to these children despite a lack of evidence that this would help them.

'The reality is that we have no good evidence on the long-term outcomes of interventions to manage genderrelated distress,' wrote Dr Hilary Cass, a paediatrician who was commissioned to review NHS services for gender.

Dr Cass described how clinicians had become widely influenced by a single Dutch study, which excluded children who had dropped out of the research because they developed problems on treatment.

Yet doctors applied the findings to many more children and, as she wrote, 'abandoned normal approaches to holistic assessment'. So children were not having, for example, the impact of depression assessed.

As a result, young people with gender dysphoria (where they feel their biological sex does not match their gender), who have often been suffering very much, have been poorly served by the healthcare service.

I've met many who went to the NHS for help and ended up with surgery and medication whose side-effects they later deeply regretted.

But, unfortunately, this is only part of a longer-term pattern of health services acting without good- quality evidence.

The only reason why medicine should have any authority is because it is based on science — where assumptions and hypotheses are tested, and questions about harms and unintended consequences are asked. If it's not based on science, frankly, it may as well be homeopathy.

It's easy to think that you are helping when, in fact, you are harming people.

Back in the 1980s, it was recognised that some people who had heart attacks go on to develop fatal heart rhythm disorders — these patients often had abnormal heartbeats and the logical assumption was that reducing these would cut death rates.

And yes, trials showed that taking drugs called class Ic antiarrhythmics did reduce those abnormal beats.

However, when high-quality trials were eventually done, it was clear that they did the opposite in terms of saving lives; in fact, the drugs led to an increased risk of death. What seemed 'logical' was actively harmful.

And it's not enough to say you have 'evidence' — it has to be good quality. Take arthritic knees. For decades surgeons would do 'washout' arthroscopy, where patients have incisions in the joint which are then washed out with saline — the idea being that fragments of cartilage are cleared, making the joint work more efficiently.


Certainly, patients tended to report that it made them feel better. But in 2002, a trial compared knee arthroscopy to a placebo — patients either had the real operation, or a 'placebo' procedure where they also had small skin incisions and the surgeons 'splashed' the saline to make it sound like the real operation was happening, but didn't actually put the saline into the joint.

Both placebo and real surgery groups got better, with patients describing less pain and better function for months afterwards.

Medicine that can't help you can only harm you - either through side-effects, or costs to the patient and the health service. That's why, unless it's in very specific

circumstances, the National Institute for Health and Care Excellence (NICE) now makes clear that 'arthroscopic knee washout alone should not be used as a treatment for osteoarthritis'.

There are other examples. For years, pregnant and breastfeeding women with a family history of allergies were told to avoid eating peanuts, in case they increased the risk of allergy in their child; parents were also warned against giving peanuts to children under three.

But the rates of peanut allergy in the population soared — the problem was that the studies that supported this avoidance were mainly 'look-back' studies, relying on people's recall of what was eaten.

Then, in 2015, a 'forward-looking', randomised controlled trial (the gold standard for testing a new approach, where a control group doesn't get the intervention) found infants with severe eczema or egg allergy actually developed fewer allergies to peanuts if they were introduced as part of their normal transition to a solid diet, compared with children whose parents were told to avoid them (the control group).

was lacking in the research — that single Dutch study — was information about

In fact, we now have data showing contentedness' — in other words, feeling unease in the physical body — tends to improve with age, something that should give great hope in the midst of what might be huge despair. The Dutch research also didn't have control groups, meaning we couldn't compare what would have happened without medical intervention.

It's tempting to conclude that any improvements are down to the treatment, when in fact, young people may have done just as well — or better — without.

### How should we be getting round this and making sure we do act on truly good-quality evidence?

That's what NICE was set up to do when it was founded in 1999. It was a move away from what was nicknamed 'eminencebased medicine' — doing things because esteemed professors said it worked — and towards 'evidence-based medicine'.

Dr Cass is clear in her report that the clinicians she met had the 'best intentions' - and I am sure that is the case.

However, best intentions don't work

well in medicine unless you also have good-quality evidence on your side.

The paediatrician and best-selling author Dr Spock, for example, was by all accounts a compassionate, caring man. He recommended, from 1956 until the late 1970s, that babies should be put to sleep

After all, isn't it obvious that vomiting would be less dangerous in that position?

But, as we now know, it was wrong; Dr Spock had based it on a theory, not high-quality evidence. Researchers later estimated that 50,000 infant deaths in Europe could have been avoided had the high-quality evidence from the 1970s onwards — suggesting it was better to put babies on their backs - been acted on

We've become used to the pharmaceutical industry putting pressure on doctors to prescribe the latest drug, even if there are worries about side-effects - and while we still aren't good enough at resisting this, there's at least (usually) an acknowledgement that we should try to resist biased information.

Yet, in the case of gender dysphoria in young people, lobby groups seemed to have been welcomed into the NHS.

Training modules were often sponsored by activist groups — who have every right to express their views, but do not necessarily have expertise in critical appraisal of evidence. This also meant that the voices of people harmed by medical intervention didn't get heard enough.

Unfortunately, asking questions was often met with hostility - and worse rather than a discussion of the evidence base. A recent conference in London to discuss the uncertainties about how to best treat children with gender dysphoria was targeted by protesters with smoke

# Your guide to preventative health screenings you should get in your 40s

SO you've reached the Big 4-o? It's time to celebrate - and to make plans for some preventative care and screenings to help keep your health on track.

CBS News HealthWatch has compiled a series of guides to help you know which preventative screenings should be on your list, starting with people in their 20s and in each decade through your 60s. Compared to those in their 20s and 30s, people in their 40s have some additional recommendations to consider, including mammograms and colon cancer screening. So what should 40-somethings have on their preventative checklist? Here is a look at the guidelines experts recommend for people at average risk:

### Vaccines in your 40s

In your 40s, it's important to make sure you're up-to-date on a few vaccines, including the Td or Tdap booster shot, which protects against tetanus and diphtheria, as well as the Covid-19 vaccine and annual flu shot, which are recommended for people ages 6 months and up.

### Colon cancer screening in your

At age 45, people should begin screening for colorectal cancer, according to the U.S. Preventive Services Task Force, an independent panel of national experts. This can be done via several different screening strategies. "Obviously the gold standard still remains the colonoscopy, but Cologuard (a brand of at-home stool tests) is a great test," says Dr. Robert M. Biernbaum, chief medical officer for WellNow Urgent Care. The frequency of testing will depend on the test type and an individual's risk level. In 2018, the recommended age to get a first colonoscopy screening was lowered to 45, from 50, for those at average risk, because rates of colon cancer have been increasing in younger age groups. If you're at increased risk, which includes having a family history or inflammatory bowel disease, talk to your doctor about being screened earlier.

### Mammograms for women in their 40s

For women, your 40s is the age range when doctors recommend starting mammograms or other exams to screen for breast cancer, for those at average risk.

The latest draft guidance from the USPSTF says breast cancer screenings for women at average risk should be done every other year starting at age 40, 10 years earlier than the panel previously recommended in 2016. (It previously recommended women in their 40s make individual decisions about screenings based on their health history.) Other organizations already recommend annual



mammograms at 40, including the American College of Radiology.

### Sexual and reproductive health in your 40s

For women, cervical cancer screenings should continue on the same schedule as in your 30s, for those at average risk, the USPSTF recommends: "Screening every 3 vears with cervical cytology alone, every 5 years with high-risk human papillomavirus (hrHPV) testing alone, or every 5 years with hrHPV testing in combination with cytology (cotesting)." The American College of Obstetricians and Gynecologists recommends visiting an OB-GYN, at least once a year for a well-woman visit and deciding with your doctor how frequently to do a pelvic exam. You may also want to talk to your doctor about menopause or perimenoupause, which is when the body is transitioning to menopause, marking the end of someone's reproductive years. Perimenopause can last anywhere from 7 to 10 years, throughout your 40s and early 50s, Dr. Jessica Shepherd, OB-GYN and chief medical officer of Verywell Health, previously told CBS News.

"The average age of menopause is 52, so during that perimenopausal timeframe is when you might start to have symptoms," Shepherd said, adding some may notice changes as early as their mid-30s in certain cases. If you're postmenopausal in your 40s, ask your doctor about any additional tests you may want to consider, such as ovarian screening. For men, the USPSTF does not recommend routine testicular cancer screenings; however, the American Cancer Society recommends testicular exams be incorporated into a male patient's annual physical exam or performed as a self-test at home. For anyone who is sexually active, the CDC recommends getting HIV-tested at least once. Depending on risk factors, it

is also recommends getting tested for other sexually transmitted diseases and infections, including hepatitis B and C. People should also be screened for whether they are at risk for HIV and should be on PrEP, a highly effective HIV prevention drug. See the CDC's website for a breakdown of specific recommendations.

### More screenings to consider in your 40s

Heart health — The American Heart Association recommends getting your blood pressure checked every 2 years if it's below 120/80 mm Hg but more often if it's higher. Cholesterol levels should be checked every 4 to 6 years for average-risk adults. "After age 40, your health care professional will also want to use an equation to calculate your 10year risk of having a heart attack or stroke," the AHA says on its website. Diabetes risk – Beginning at age 45, the AHA recommends testing for prediabetes and risk for future diabetes. "If tests are normal, it is reasonable to repeat testing at a minimum of 3-year intervals," the AHA notes. The USPSTF also recommends screening for prediabetes in the 40s and to assess whether someone should be on a statin, a cholesterol-lowering drug. Skin health — To check for skin cancer, a yearly dermatological exam is recommended by the Skin Cancer Foundation. Eye health - Chances are you've already had multiple comprehensive eye and vision exams before hitting 40, but if not, it's definitely the time to do so, according to the American Academy of Ophthalmology. "This is when early signs of disease or changes in vision may appear," its website notes. "It is important to find eye diseases early. Early treatment can help preserve your vision." The American Optometric Association recommends an eye exam at least every 2 years between the ages





# Mourinho says he didn't get the same support as Ten Hag at Man Utd

FORMER Manchester United manager Jose Mourinho has said he did not have the same kind of support at the club during his 2-1/2 year tenure as current Old Trafford boss Erik ten Hag.

The 61-year-old Portuguese, who last managed Serie A side AS Roma before being sacked in January, was fired by United in December 2018 following a series of dismal results having won the League Cup and Europa League in the 2016-17 season.

Mourinho, who has also managed Porto, Chelsea, Inter Milan, Real Madrid and Tottenham Hotspur, added that there were still a few players at United who he did not want when he was there.

"What Ten Hag has in his time at Manchester United I didn't have. I didn't have that level of support. I didn't have that level of trust," Mourinho told The Telegraph. "So I left sad because I felt I was in the beginning of the process.

"In some moments, I felt if they trusted me and believed in my experience, things could be different.

"There are a couple of players still there I didn't want five or six years ago. I think they represent a little bit what I consider not the best professional profile to a club of a certain dimension.

"But I did my job there. Time always tells the truth. I would love Manchester United to succeed."

Under Ten Hag, United ended a six-year trophy drought last season by winning the

League Cup after the Dutchman joined the club from Ajax Amsterdam in 2022.

United are seventh in the Premier League, with British billionaire Jim Ratcliffe having struck a long-awaited deal in December to buy a 25% stake in the club and take charge of soccer operations to try to revive their fortunes on the pitch.

Mourinho, who is presently without a club, said there was still a long way to go in his managerial career.

"It is not like I am 61 and I want to stop at 65," he said. "No way at all. There is still a long career to go."

"Now that we have finalised our roster with a team of world-class golfers, I am even more confident that this group will proudly represent the Jupiter area and connect with our fans for years to come"

Homa, a six-times winner on the PGA Tour who is ninth in the world rankings, had his best major outing at this year's Masters where he finished in a share of third place.

World number 23 Kim is a rising star as the 21-year-old South Korean already has seven international victories in addition to three triumphs on the PGA Tour. Kisner, a four-times winner on the PGA Tour, match play wizard and one of the game's top personalities, has made just one cut in seven events this year on the U.S.-based circuit. (**Reuters**)

### Inter become Serie A champions with derby win over Milan

INTER have won the 2023-24 Serie A title after an incredible season.

The team coached by Simone Inzaghi has secured its 20th Serie A title, the second-most of any in Italy, behind only Juventus. The Nerazzurri lead the league from wire to wire and deserved to win locking up the historic Scudetto in a season where they absolutely demolished the competition.

By winning the 2023-24 title, Inter win the 20th Scudetto in their history, the so-called second star. In Italian soccer, teams that win at least ten Serie A titles can sew one star on their jerseys, twenty gets you two, and so on . Inter, from next season, can officially show their second star on the official jersey and logo. The Nerazzurri become the second Italian team, after Juventus and their 36 Serie A titles, to be entitled to it.

This is also the first Scudetto for manager Simone Inzaghi, who finally made his dream true. Inzaghi joined Inter in the summer of 2021 to replace Antonio Conte, only a few days after the Nerazzurri won their 19th title

The club was forced to make some changes over the years but Inzaghi kept the club competitive since the beginning, winning the Coppa Italia twice, and the Supercoppa Italiana three times in his first two seasons in charge.

After reaching the 2022-23 Champions League final which Inter lost 1-0 to Manchester City, the club and Inzaghi himself started this season with a clear target of winning the championship.

Only Roberto Mancini and

Helenio Herrera (7) have more than him up to now.

The club worked over the years to create a solid group inside the dressing room, but it's one that was also changed throughout the years as the club needed to sell players over the past two years due to their financial situation. Despite losing players such as Achraf Hakimi, Romelu Lukaku, Edin Dzeko,

Milan Skriniar or Andre Onana, to name the most relevant ones, Inter were able to keep the level of the roster high and were able to compete in Italy and also in Europe in the past three seasons. # Barca may request Real replay - Laporta

### ... if VAR is found wrong to disallow Yamal goal

BARCELONA may request a full replay of Sunday's 3-2 LaLiga loss at Real Madrid if Lamine Yamal's 28th-minute attempt to score, deemed not a goal after a VAR review, is confirmed to be a goal, club president Joan Laporta said.

The club will request all footage and audio of the incident from the Spanish Football Federation, Laporta said on Monday.

The match was paused for several minutes as the VAR tried to determine whether Yamal'a effort had crossed the goal line, but it could not find a clear camera angle and the decision not to award a goal stood.

"If... the club understands that an error was made in the revision of the incident, we will take all available measure to reverse the situation, without discounting, obviously, any necessary legal action," Laporta said.

"If it is confirmed that it was a legal goal, we will move ahead and we do not discount requesting that the game be replayed, just as has happened in another game in Europe due to a VAR error.'

A Belgian Pro League match between Anderlecht and Genk, originally played in December, was scheduled to be replayed in full due to a VAR error, after the Disciplinary

Council for Professional Football ruled in favour of a Genk appeal.

Laporta said he was dissatisfied with "improper use" of VAR, adding the tool was creating "confusions with contradictory criteria according to matches and teams."

"We understand the difficulty faced by officials, but it's for that reason that such tools exist (like VAR) which should help the competition be fairer and not the other way around," he said.

Barcelona, with 70 points after 32 matches, trail leaders Real by 11 points.

### Bonmati, Djokovic win top Laureus awards

World Cup winning midfielder Aitana Bonmati was named the Sportswoman of the Year, while Serbia's Novak Djokovic captured the top men's honour at the Laureus awards ceremony on Monday.

Bonmati, who has cemented her place at the top of women's football by winning FIFA's The Best, Ballon d'Or and World Cup MVP among other accomplishments, made her way on to the stage for a second time on Monday as the Spanish women's football team were named Team of the Year, the first female squad to win the award. Seventime Super Bowl champion Tom Brady handed Djokovic his fifth Laureus award after the top ranked tennis player enjoyed a remarkable 2023.

The Serb equalled Margaret Court's all time record haul of 24 Grand Slam titles after winning U.S. Open last September.

Djokovic contested all four major finals in 2023, also winning the Australian and French Opens. He was the runner-up at Wimbledon.

England midfielder Jude Bellingham, who has taken LaLiga by storm in his first season with Real Madrid, was named the Breakthrough Player of the Year, the first footballer to win this award. Gymnast Simone Biles won Comeback of the Year award after winning four gold medals at last year's world championships, her first international event since competing at the Tokyo Olympics in 2021.

# 'Produce audited financials', court orders Zakhele, Thoba

THE High Court has ordered Eswatini Athletics President Zakhele Dlamini and Chief Operations Officer Thoba Mazibuko to produce audited financials to member clubs.

This follows after member clubs moved an urgent application in this regard demanding that the president, treasurer and chief operations officer to produce audited financial and hold a special and general metting to fill vacancies of board members.

The court also ordered Dlamini and Mazibuko to hold the requested meetings by the club members within 14 days.

In an urgent application filed on April 18 at the High Court, Edward Ndlangamandla a member of the Nhlangano Track Athletics stated that on April 14,11 athletics clubs resolved to launch proceedings.

These are UNESWA, Swazi Slojos, Manzini Striders, Mhlatane, Mbabane, Manzini, Nhlangano, Ngculiwini, UEDF, RES, and GFC athletic clubs.

He stated that discord began to prevail under Dlamini's administration occasioned by a series of unprecedented acts which led the club to request a general meeting, known as a special meeting.

Dlamini allegedly facilitated the meetings for clubs more than three times after the members had on several occasions made

requests and he allegedly appointed a disciplinary committee and instituted proceedings against members following the constitution which is the backbone of the federation.

Ndlangamandla stated that Dlamini further unilaterally selected teams and officials for international participation without the mandate of the executive board and has the power to confirm athletes for international meetings, contests, and meetings.

### Grievancies

On behalf of the club members, he stated other grievancies in that other executive board members wrote a letter on January 28 denouncing and distancing themselves from the unconstitutional acts of Dlamini and

An annual general assembly was scheduled to be convened on March 16 which was aborted by Mazibuko without any just and reasonable cause.

Immediately after the scheduled Annual General Meeting (AGM) three of the voting executive board members tendered their resignation citing amongst other issues. These are Sipho Vilakati, Sanele Mamba and Dr Zabenguni Mkhatshwa.

Ndlangamandla stated that Mazibuko continued to sow seeds of inharmony within the federation by fostering practices contrary to those which had hitherto ensured the smooth operation of the federation.

The member clubs learnt of the resignation

After receiving a request for the meeting, Mazibuko notified member clubs that such a meeting would be held on April 4 at Olympiafrica Centre at Lobamba.

"The unsuspecting member clubs were then informed that a correspondence from the Confederation of African Athletics was sent to Dlamini and Mazibuko instructing that the meeting be postponed until the CAA delegation comes to Eswatini to resolve the leadership challenges," he said.

He stated that the clubs were perplexed by this ordeal because they had not reported to any regional or international federation that they had failed to resolve their issues within the proper availed structures in the country.

He stated that the clubs suspect that Dlamini who also sits on the CAA board manipulated the situation and gave the CAA the wrong impression that there were leadership challenges within Athletics Eswatini, whereas there are only vacant positions that need to be filled.

The question that boggles one's mind according to Ndlangamandla is when the CAA delegation intends to finalise the travel logistics to Eswatini because it has no mandate or clear mechanism as to how to intervene in issues affecting the federation.

He stated that no communication was forwarded to the World Athletics hence it remains a mystery how CAA mandated itself to intervene on issues when they have not failed to do so let alone mandated by WA.

He stated that the club members feared that due to the defunct executive board that can make any decision in terms of accountability and governance the Federation risks facing suspension by these affiliates due to improper constitution.

"We may further lose our licence to operate which was due for inspection on April 1 by EOCGA and ESRC," he said.

He added that the clubs learnt from the media that the Federation organised buildups to the National Championships Youth and Junior athletics without the quorate of the board.

"We believe that the life of any Federation rests on transparent administration being at the helm and members being entitled to its effective control including finances to which respondents are currently having free reign over," he added.

# Bull stars go on strike

THE cat is out of the bag - Mbabane Highlanders players were on strike last

Challenging for the league title before suffering a 4-1 defeat at the hands of Young Buffaloes last Saturday, Highlanders blew it all away. It has transpired the match nearly did not happen as Inkunz'emnyama players had planned to boycott it too after staying away from training all week but last Friday.

"There was no training all week but a few hours on Friday. Its Buffaloes we were going

to play, and they destroyed us. Our players had misunderstood that their month-end last term was on the 17th, so they were paid on the sane day even now," said an impeccable source.

The source said this was well known by some supporters of the club, and rightly so, as one fan put it on Facebook. The fan even included all their defeats where players were not training due to delayed salaries, including losing to Mbabane Swallows in the Ingwenyama Cup 2024 and the 5-0 first round drubbing by same Buffaloes.

Swallows beat Highlanders 3-0 to reach the cup finals but lost to Green Mamba.

"A lot of games they played without good

enough preparation we won't mention. In a week, it is a norm to train once before the game. What do you think is not going well inside their camp? Mind you some players if not all will leave the team off season," wrote a supporter on Facebook under the page Premier League of Eswatini yesterday.

It transpired that the supporter was right about the strike last week. The team's head coach Milton Dlamini lamented the lack of discipline among the players. He ran short of mentioning what discipline issues, but sources claim some players could not help it, as they allegedly engaged in unexpected activity later on the day.

"What I can say is that we all received our pay last Friday, and yes, we had not trained all week," one of the players concurred.

Dlamini has been criticised and supported by some for his post-match outburst. The team's Managing Director (MD) Chief Ally Kgomongwe has also encouraged him to be mindful of his tongue, saying it was painful to lose like that, but you do not speak ill of your players.

It turns out Dlamini may have hit the nail on the head about the lack of discipline given the news of a strike all week.

"The sad thing is that even our coaches aren't working together. Milton and Siya seem to not have a good working relationship, and already, our MD knows as he has been told," a source claimed.

Speaking to Dlamini and the team's physical trainer, Siyabonga Bhembe, the latter affirmed he was aware that the MD received a report of that sort about their working relationship with the former.

Dlamini's assistant is Dumsani 'DU' Makhanya. It was claimed that Dlamini may be wanting his own technical team, with his main issue said to be Bhembe, who has good ties with Kgomongwe. Dlamini asked not to comment, especially because the MD had already spoken about the situation of the team. Meanwhile, Highlanders officially dropped off the league title race after they lost 4-1 to the army side.
