# OVC grants to be paid timeously — DPM's Office

THE government through the Deputy Prime Minister's Office has made an audacious pledge of paying school grants for orphaned and vulnerable children (OVC) timeously this year.

Public schools are scheduled to open on Tuesday, January 23.

This was disclosed by the Principal Secretary (PS) in the Deputy Prime Minister's office Melusi Masuku who said the office intends to make the payments early to ensure that no pupils would be sent home due to unpaid fees this year.

"As the DPM Office, in conjunction with the Ministry of Finance, we have ensured that one-third of the grants will be paid timeously to avoid inconveniencing the children. This is to ensure that the children are properly admitted and afforded education in the different schools," Masuku said.

The PS said the DPM's Office is not anticipating getting reports of OVCs who would be sent home for not paying their school fees, owing deposits or top-ups.

He said the DPMO and Ministry of Finance will also ensure that by the time the second term kicks off, two-thirds of the money expected to be paid by the government would have been paid in full to avoid children ending up attending classes due to owed money.

He said this is intended to assist schools

in paying bills and support staff to ensure its smooth running and operations.

The Director of Social Welfare Mcusi Shongwe said the intake for 2024 was almost complete and applications were coming in, allowing the office to consolidate the list of beneficiaries.

According to the Director, the OVC grant is a bursary for secondary and high school education that targets poor OVC and is directly paid to schools.

He said the government pays E1 950 for OVC in Forms 1 - 3 and 5, then E2 500 for pupils in Form 4 because of the increase in the number of subjects.

Shongwe said the assessment which will be conducted by the DPM's Office will allow the government to compile a list of the OVC in the country which includes single and double orphans, as well as those who are vulnerable.

According to the 2016/17 Eswatini

Household Income and Expenditure Survey, the grant only covers 19 per cent of households, yet 60 per cent of all children in the country were classified as vulnerable and 71 per cent of these are orphans and vulnerable children.

The survey recommended that fiscal resources need to be reallocated from non-priority sectors to cover the full costs of reaching all children in need.

A Stokvel treasurer has pleaded guilty to staging a robbery of E48 000 which was saved with his fellow members.

Bongani Tsela was charged with theft after he allegedly stole money which was entrusted to him as the treasurer of a stokvel that was formed by a group of security guards who stay at a certain rented compound at Mcitsini, Mbabane.

According to reports, after allegedly stealing the money, Tsela came up with a plan to stage a robbery so that his fellow members would eliminate him as a suspect.

The accused is said to have tied his hands and feet, blindfolded himself making sure that it seems like someone has come in and robbed him. However, as the police intensified their investigations, they detected that he was the suspect.

On the first day of his trial on Monday, the accused pleaded guilty to the charge of theft. The crown paraded its first witness, Amos Magagula who was also a member of the stokvel. Magagula told the court that they formed the stokvel in December 2022, after deserting another stokvel which they were members of. He told the court that it was Tsela who came up with the idea that they should form a stokvel, telling them (the other members) that he believed the treasurer of the previous stokvel had stolen

some of the money.

He narrated to the court that they held a meeting with other security guards who lived in the same compound together with him and Tsela to start the stokvel and they agreed to elect Tsela as their treasurer as he had promised to be faithful and accountable at all times. Magagula said the stokvel's main objective was to spend the savings on buying groceries at the end of the year and share it among themselves. It had 26 members.

The witness explained that they contributed E150 as a monthly subscription per person, adding that he (Magagula) registered two names so he could contribute E300 every month. He also told the court that they had agreed that the money would be kept in Tsela's mobile money account.

Narrating the events leading to the day of the staged robbery, Magagula said earlier that day, they had a meeting at Mbabane Market, where they discussed how they were going to buy the groceries as the year was coming to an end.

In the meeting, Magagula said Tsela told them that they had accumulated E48 000 over the year 2023 and it was short by E4000 which was money that was being owed by some members who had not yet paid back the money they had borrowed.

Magagula said later that night while he was in his house, he heard a big bang which came from Tsela's house. The witness said together with three other men they rushed to Tsela's house where they found him in a terrific condition, Tsela had tied both hands

and feet with a cloth-like item, the accused also had socks in his mouth and his eyes were blindfolded.

The accused was also groaning indicating that he was in intense pain. Magagula said they called community police who came to inspect the situation. Upon their arrival, they tried to ask the accused a few questions however he could not speak. When asked where is the money the accused is said to have pointed to a drawer and when one of the community police opened it, he found a big empty purse. Realizing that the money was not there, Tsela was heard speaking for the first time saying "Oh Lord people's money is gone".

Magagula said the accused was then taken to hospital, upon his arrival from hospital the next day the accused told the witness that he was attacked by three men who were carrying bush knives and robbed him of the stokvel money. Magagula said he did not believe Tsela's story as he did suspect that the accused might have planned the whole

During cross examination Tsela refuted the claim that he is the one who came up idea of starting the stokvel, and had no further things to say. The matter will be heard again in court on January 18, 2024.

## St Phillips community equipped with Malaria preventative lessons

THE buzzing whine of mosquitos will pose less fear to the residents of St Phillips these days, thanks to a proactive initiative by the Ministry of Health.

In a recent outreach programme, the Ministry equipped the community with crucial knowledge and tools to combat malaria, a disease prevalent in some parts of Eswatini, mostly in the Lowveld.

The ministry's outreach provided with residents comprehensive information sessions where experts delivered informative talks malaria symptoms, transmission, and prevention strategies. This awareness campaign aimed to dispel myths and misconceptions, empowering individuals to identify and address potential risks.

It also expressed the importance of using insecticide-treated nets (ITNs). Residents further received clear instructions on hanging, washing, and repairing ITNs, ensuring their effectiveness and longevity.

"The Ministry recognises that St Phillips, with its extensive sugar cane plantations and agricultural schemes, attracts a lot of people, increasing the risk of malaria transmission," shared Elias Ngcamphalala, a resident of St Philips, highlighting the impetus behind the programmes.

Fight

The Ministry asserted that the area has many activities due to the sugar cane plantations and such can create ideal breeding grounds for malaria.

His Majesty King Mswati III has been championing the fight against malaria in the country and Africa. His efforts led to the birth of the End Malaria Fund, which is an initiative established to curb the spread of malaria. The fund expresses that ending

malaria remains a strategic priority for all sectors and at all levels (from national down to the community). The End Malaria Fund actively sensitises religious and traditional leaders, parliamentarians, and business leaders to the objectives of the National Malaria Elimination Strategy.

The Fund has worked on many activities which include organised meetings with traditional leaders and the National Malaria Programme to discuss how they can champion malaria. Also, it has hosted events with national leaders commemorating the launch of the National Malaria Elimination Strategic Plan to raise the visibility of national objectives, created a platform for the Youth of Eswatini to contribute to the strategy of creating a Youth Army that will lead the malaria elimination agenda, stakeholder engagements, including Church Forums to discuss how the church can play its role in malaria elimination and resource mobilisation.

#### Unroadworthy Sam & Sons bus crashes near Mahhala

Along-running saga of public concern culminated into a tragedy on Sunday when a visibly dilapidated Sam & Sons bus which was from Mbabane enroute to Manzini was involved in an accident near Mahhala, Matsapha, leaving the driver of the bus seriously

Eyewitness Ndumiso Ngwenya gave a chilling account of the incident. "The bus was not speeding, and then suddenly it swerved violently, unable to make the turn properly," he described. "It seems the driver completely lost control of the steering wheel." The bus veered off the road and hit the concrete bridge of the Mahhala traffic circle.

Ngwenya's words echoed a mounting chorus of complaints about the bus's condition. "This wasn't a surprise," he stated with stark honesty. "Everyone knew this bus was in trouble. It looked worn out, the brakes often seemed to malfunction, and the doors barely shut properly. Mechanics were always tinkering with it, but it never seemed truly fixed."

These concerns had been voiced

publicly, with passengers taking to social media, Facebook to be precise to urge Sam and Sons to address the bus's evident unroadworthiness.

Tragically, these pleas fell on deaf ears,

leading to this avoidable accident. Many applauded the driver for trying to maintain balance and that the accident didn't happen in the notorious Malagwane hill which could be worse news.



#### Weekend tragedy:

### 4 die in car crashes, including 2-yr-old

OVER the past weekend four people, including a two-year-old child were tragically lost in separate road accidents across the Kingdom.

This sobering statistic was highlighted in a report by the Royal Eswatini Police Services (REPS). The police also highlighted that one woman drowned whilst crossing the Ngwavuma River.

The police reported that near kaHhelehhele in the Hhohho region, a Honda sedan driven by a 34-year-old man of kaHhelehhele reversed and knocked a 2-year-old child who sustained injuries on the head and died while undergoing treatment at Mbabane Government hospital.

Also, near Nkwene along Nkwene clinic on MR9 public road, a 23-year-old woman of Mehlwabovu fell off a Nissan hardbody van driven by a 43-year-old man of Mehlwabovu.

#### **Injuries**

The woman is reported to have sustained serious injuries and was rushed to Hlathikhulu Government Hospital where she was certified dead upon arrival.

In Gege, near Sicunusa T-junction along MR4 public road a Toyota Quantum driven by a 29-year-old man of Malangeni collided with a Toyota sedan crystal light driven by a 33-year-old man of Nsuka which disregarded a stop sign. It is reported that the driver of the sedan and his passenger, a 33-year-old man from Nsuka, suffered serious injuries and were certified dead upon arrival at Mankayane Government Hospital. Seven passengers from the Toyota Quantum were treated and admitted at Mankayane Government Hospital while two passengers from the sedan were also admitted.

Police have also shared that a 40-yearold woman from Nsindatje was discovered to have drowned while crossing the Ngwavuma River at KaLiba.

## Ministry of Housing's identifies growth points poised to be developed into towns

THE Ministry of Housing and Urban Development has unveiled exciting plans for Eswatini's urban landscape.

Minister of Housing and Urban Development, Apollo Maphalala, recently shared the identification of several growth nodes across the country, which are areas exhibiting the potential to develop into thriving towns and cities.

These promising locations include Siphofaneni, Hluthi, Luve, Mliba and Madlangempisi, representing a significant shift towards decentralised development.

The Ministry emphasized that the central government can initiate discussions and processes towards declaring growth nodes as controlled areas for better development management. The 'bi-modal' approach helps in balancing the interests of local communities and the programming of central government regarding settlement patterns and development control.

#### Strategy

The Ministry's strategy on a "bi-modal" approach recognises the existing administrative structures within each growth node, and the government central offers two complementary pathways for development.

Maphalala who is also a Kukhanyeni Member of Parliament (MP) is seasoned in town development as he has served in many towns across the country including Nhlangano, Piggs Peak and Malkerns where

he was the town's, Chief Executive Officer. Maphalala outlined that the Ministry of Housing and Urban Development has identified and profiled most of the prospective growth nodes through the regional spatial planning project undertaken in past years.

"The Ministry is currently engaged in internal processes to develop a national framework of support to the administrative structures currently governing undeclared growth nodes. The framework will include spatial planning, management, and building control, amongst other services," said the Minister "This will involve other Ministries that house the competencies for the identified service support planned for the growth nodes. The success of all of these initiatives will largely depend on the affinity of the stakeholders involved in the processes."

When enquiring if the Ministry will guide the future development of such areas and similar settlements. The Minister of Housing and Urban Development expressed that there are comprehensive plans and strate-

The Ministry has compiled national and regional spatial plans. However, the Minister added that these plans have no legislative anchor and therefore remain advisory in effect. The Ministry also has initiated stakeholder consultation to promulgate country-wide spatial planning and land-use management legislation. The proposed legislation will, amongst many benefits, help in the coordination of physical planning and land-use management activities housed under several government ministries and departments. This will ultimately help to control and inte-

grate future development and human settlements. Two complementary pathways may be implemented for the development of such areas which are the development control instruments and regulatory frameworks. This asserts that growth nodes can proactively request assistance from the government in establishing efficient development control instruments and regulatory frameworks.

These tools, tailored to each location's specific needs, will guide responsible growth and ensure orderly urban expansion. Another pathway is the controlled area. In cases where rapid development demands more intensive management, the government may declare the growth node a "controlled area." This designation empowers the government to implement regulations and invest directly in infrastructure and service provision, accelerating the transformation into a fully-fledged town or city.

This flexible approach balances local autonomy with strategic central government support. Growth nodes will continue to retain their unique identities and administrative structures while receiving the necessary resources and expertise to unlock their full

### All systems go for government's Geoscience Mapping Survey Phase II

THE government through the Minister of Natural Resources and Energy will begin the second phase of the Eswatini Multi-disciplinary Geoscience Mapping Survey in earnest.

The survey is expected to start next week after the Eswatini Civil Aviation Authority (ESWACA) granted a safety licence to the Council of Geologists in South Africa.

Phase I of the survey was completed in 2021, which identified minerals such as gold, iron ore, diamond, and copper-nickel-platinum group elements in the Hhohho and Manzini Regions.

The newly-initiated Phase II will extend the exploration to the Shiselweni and Lubombo Regions and is expected to cover about 10,000 kilometers.

The survey will be conducted in conjunction with the Ministry of Natural Resources and Energy under the Geologist Survey Depart-

According to the Head of Geologists in Eswatini Dr Noah Nhleko the Phase II project encompasses an airborne geophysical survey, integrating high-resolution geophysical data with existing geological and geochemical information.

He said the application of artifi-

cial intelligence (AI) aims to identify and prioritize potential mineral targets, streamlining the mineral exploration process.

Dr Nhleko said the council was granted the licence allowing them entry into the country and to also land/park their helicopters at Sikhuphe International Airport.

Dr Nhleko said what remains is the transport licence which they hope will be issued by Thursday,

"The survey is expected to begin on January 22 and the data collection will begin at Sikhuphe before moving to other parts of the region including Lomahasha, Simunye, and Mpaka amongst others," he

He further stated that the Council brought three helicopters to ensure the data collection process is

According to Dr Nhleko, normally, one helicopter would be used, taking about six months to collect data. However, the council decided on three helicopters to create a shift schedule allowing for the team to rest and a quick process.

"We might have challenges due to the ongoing rains, therefore the projected completion period of the project is six months minimum depending on how they will work," he

In November 2023, Minister of Natural Resources and Energy Prince Lonkhonkhela when launching the second phase of the survey emphasized the integral role of geoscientific mapping and landscape characterization in stimulating economic growth and attracting investment.

He said the country's roadmap for 2018 to 2023 identified the mining industry as one of the pillars for the economic recovery of

The Minister said for investment to take place in this sector of the economy, quality, and reliable geoscientific data and information is one of the requirements for potential mining investors to make quick decisions on investing in the

"Geoscientific mapping and characterization of the landscape of the Kingdom of Eswatini forms an integral part in stimulating economic growth and investment. A full geoscientific understanding underpins any efforts towards sustainable development of the Kingdom's potentially vast and untapped onshore mineral resources," said Prince Lonkhokhela.

in-house psychological counsellor, Praisy Thwala. The speakers will share their expertise on the dangers of drugs and gangs, offering valuable insights and guidance to students. The workshop will move beyond traditional lectures, incorporating interactive activities to keep students engaged and retain information effectively.

## Man arrested for raping mentally-ill woman

ALMOST six months later, Samkeliso Magagula has been arrested for allegedly raping a mentally-ill woman in June 2023.

Magagula made his first court appearance at the Mbabane Magistrate's Court before Magistrate Innocent Motsa, where his case was committed to the High Court.

The accused's is charged with contravening Section 3(1) of the Sexual Offences and Domestic Violence Act, 2018. The charge sheet adds that on June 11, 2023, Magagula unlawfully had sexual intercourse with Lindiwe\* without using a condom.

The alleged rape is accompanied by aggravating factors, which state that the accused did not use a condom during the commission of the offence thus exposing the victim to sexually transmitted diseases. It is worth noting that the victim is said to be mentally-ill and thus, by law, could not

It is worth noting that last week, two men were charged with a similar offence and made their appearances in the same court.

One of the rape suspects is a man who shall not be identified to protect the identity of the minor. The accused allegedly raped his 13-year-old daughter. The accused's charge sheet states that he is alleged to have sexually assaulted his daughter at his homestead in Mcaphozini from May 6, 2023, to May 8, 2023.

"The accused did unlawfully have sexual intercourse with one Londiwe\* being his daughter who is 13 years of age without a condom and therefore, contravening Section 3(1),3(2),3(3)(c) read together with Section

3(9)(A) of the Sexual Offences and Domestic Violence Act 2018," read part of the charge

#### Remanded

Moreover, the accused's charges are accompanied by aggravating factors as envisaged by Section 185 of the Criminal Procedure and Evidence Act 67/1938 as amended in that, the accused did not use a condom thus exposing the victim to the risk of contracting sexually transmitted infections including HIV and AIDS. Another factor is that the person had sexual intercourse with a minor person under the age of 18 years.

The crown applied that the accused must be remanded into custody pending committal to the High Court. Magistrate Motsa's ruling assured that the suspect will be remanded into custody until January 26, 2023, pending his committal to the High Court. Furthermore, the accused

shall move his bail application to the High

The second case from last week was of Nkosinathi Nxumalo (36), who was also charged with the same offence of rape. It is alleged that Nxumalo raped an 18-year-old without a condom in a toilet.

"On August 31, 2023 at Zulwini area in the Hhohho district, the accused person unlawfully had sexual intercourse with one Sibongile\* who is 18-years-old without a condom while in the toilet," the charge read.

Nxumalo's charge is also accompanied by aggravating factors, which are that the accused is alleged to not have used a condom during the commission of the offence thus exposing the victim to the risk of contravening HIV/AIDS.

Nxumalo will remain in custody until January 29, 2024 pending committal to the High Court.

### Employee fired for disposal of used sanitary pad in dustbin

AN employee of one of the butcheries in Malkerns was fired after her employer retrieved a used sanitary towel she had disposed of in a dustbin which was inside the business instead of dumping it in a pit latrine.

Speaking to Eswatini TV, the employee, Vuyisile Dlamini, said the used sanitary towel was discovered by a janitor who was looking for something to use for collecting dirt, and when she asked who had put it in the bin, Dlamini admitted it was her.

"I think it would have been bad if I denied disposing it in the bin, only for the truth to come out later, making things worse for myself," she said.

Dlamini said her dismissal was unfair and illegal, thus requiring that her employer write a formal letter stating the reasons for firing her the way he did.

She said she wants to continue with her life, she has debts and for her to close some accounts she needs a letter of dismissal from

Dlamini said she believed the dismissal was unlawful and intends to approach the Conciliation Mediation and Arbitration Commission (CMAC) offices to register a dispute with her employer because she neither received a written nor verbal warning.

She said there was no bin or latrine



specifically allocated for female employees time, the dustbin was the closest place where she could dispose of it.

#### Wrong

"I admit that it was wrong for me to use a dustbin, but the problem is that there was no provision for us to dispose of such things at the workplace because women are not accommodated," she said.

The owner of the butchery who was identified as Fakudze confirmed firing his employee and said he was disgusted by the conduct forcing him to send her home on the

In response to whether there is an area for

women to dispose of their used sanitary towels, Fakudze said there was one and when requested for a picture of it, he said there was no need for such evidence.

"I don't care what she decides to do, I made my decision and that is final. She can go to CMAC if she feels the dismissal was unfair," Fakudze said.

#### **Advised**

Meanwhile, Labour Commissioner in the Ministry of Labour and Social Security, Mthunzi Shabangu said there was not much he could say on the matter and advised that Dlamini should go to the labour's office or CMAC which are entities available to assist employees countrywide. According to Section 37 of the Employment Act of 1980, "When the conduct of an employer towards an employee is proved by an employee to have been such that the employee can no longer reasonably be expected to continue in his employment and accordingly leaves his employment, whether with or without notice, then the services of the employee shall be deemed to have been unfairly terminated by his employer."

In terms of the certificate of employment, Section 38 states that: "Any employee whose services are terminated shall be entitled to receive a request, at the time of such termination, a certificate from his employer specifying the dates of his engagement and termination as well as the nature of the work on which he has been employed."

#### Man handed E1600 fine for stalking woman

THE claws of the Sexual Offences and Domestic Violence Act of 2018 (SODVA) strike again as 38-year-old Mntambe Americo was sentenced to a year imprisonment and pay a fine of E1 600.

The sentence of Americo was handed down at the Mbabane Magistrate's Court by Magistrate Qondile Mtetwa on Monday. Americo was accused of stalking Cynthia\* by loitering near her residence and calling her cellphone countless times. The accused was then charged with contravening Section 10 (1) as read with (2)(a),(b),(c) and (iii) of the SODVA. "In the Hhohho region at Dalriach East, the accused person unlawfully stalked Cynthia by entering her place of residence, loitering and calling her cellphone countless times thus causing her reasonable apprehension of fear," reads the charge sheet.

Americo pleaded guilty to the charge, and also told the crown he was a first time offender. He was found guilty as per his plea. In his mitigation statement, the accused said he and the victim would call each other because he worked at the victim's home as a gardener so they would always talk about work.

"She never complained about me calling her before, I never knew I was overstepping or harrasing her," Americo said.

He further asked the Court to be lenient when handing down his sentence, because he lives and survives on a part-time job and he has five children who are dependent on him. Magistrate Mtetwa sentenced the accused to two years imprisonment or to pay E1 600. The SODV Act was drafted to better protect the rights of everyone, be it women, men, or children. While in previous legislature rape was recognized, the difference now is that the Act takes into cognisance other acts which were not previously defined as rape and qualified as lesser crimes. \*Not real names

## 35 Phumelela Exipro members to share over E140k after liquidation

A total of 35 emaSwati will share over E140 000 worth of savings after the liquidation of their co-operative, Phumelela Exipro Savings and Credit Cooperative Society Limited.

Phumelela Exipro was placed under liquidation by the Financial Services Regulatory Authority (FSRA) in consultation with the Commissioner of Co-operative Development (Commissioner of Cooperatives).

Through a statement, the FSRA notified stakeholders and members of the general public that Phumelela Exipro Savings and Credit Cooperative Society Limited ("Phumelela Exipro") has been placed under liquidation in terms of Part XIV of the Cooperative Societies Act, 2003.

According to the statement, the liquidation process is overseen jointly by the FSRA and the Commissioner of Cooperatives, under the Ministry of Commerce Industry and Trade

"The Commissioner of Cooperatives, in consultation with the FRA, has appointed Ms Khanyisile Ginindza as the Liquidator responsible for the finalization of the liquidation process," read part of the statement.

Phumelela Exipro Savings and Credit Cooperative Society Limited Chairperson Thulani Shongwe stated that they started the society as co-workers who were working at Exipro Swaziland Pty (Ltd), a company located in Matsapha which manufactures water tapes.

Shongwe explained that when this company

was restructuring in October 2022, 95 per cent of the society's members lost their jobs in the company including himself as the chairman.

He stated that they had to meet and discuss a way forward and they decided that they had no choice but to liquidate savings and credit institutions because they did not have enough sources of income.

He said while still working, it was easy for them to subscribe and save in society as they had given the company authority to deduct their contributions from their salaries

and send them to the society's account.

He explained that the decision was taken by all members of the society after they signed a petition which was submitted to the commissioner of cooperatives.

He went on to say that after they were laid off from their jobs it was obvious to them that they had to liquidate and share what they had as savings.

The Commissioner of CooperativesBongani Maziya confirmed that this liquidation was applied for by the members of the society and they made clear submissions

as to why. Maziya stated that they explained that since they were laid off, and most of their members were currently unemployed they didn't have any source of income to contribute to society.

Efforts to get a comment from the Liquidator, Khanyisile Ginindza were not successful as her phone rang unanswered when called several times on Monday.

The Commissioner of Cooperative Development is mandated by the law to support and facilitate the development of cooperative

societies through promotion, business training, and supervision.

According to their website, they are also mandated to assist cooperatives to overcome many

### EEC gearing up to develop an Optimum Financing Structure

THE Eswatini Electricity Company (EEC) is looking for suitably qualified companies for the development of an Optimum Financing Structure Study to submit their proposals.

In their Request for Proposal (RFP), EEC stated that in Directive No. 1 of the February 2023 Tariff Order, the Eswatini Energy Regulatory Authority (ESERA) directed EEC to conduct a study for an Optimum Financing Structure to inform the treatment of the weighted average cost of capital (WACC) for future tariff applications and determinations.

The company said the optimum financing structure is the best mix of debt and equity financing that maximizes the company's value while minimizing its cost of capital.

"The focus of the study would therefore be to ascertain the appropriate gearing, cost of debt, as well as cost of equity that will maximize the company's value, given local conditions," read part of RFP.

The RFP further details that the study for the optimal capital structure will cover gearing, stating that the study should consider local financial markets, economic indicators, and local tariff objectives to determine an optimal debt and equity range suited to the EEC's operation.

EEC stated that since the optimal level of



gearing is a moving target that changes over time, the study should present a gearing model whose inputs can be updated to inform the optimal gearing ratio at a point in time, and over a projected period of five years

In the determination of optimal gearing, the RFP document states that the study is expected to cover or demonstrate, benchmarking with comparable electrical utilities in the SADC region, benchmarking with local comparable and capital-intensive parastatals, consideration of the risk perception of the EEC by relevant local financiers, the actual cost of debt of a

typical duration used to finance assets of a utility company at the time of the study, and the cost of equity required by investors for investments of similar risk at the time of the study.

EEC added that the initial primary outputs, therefore, will prioritize the demonstration of a five-year projection of the company's optimal gearing, and a methodology and tool that can be used to determine optimal gearing in response to real-time changes to input variables.

They further stated that when it comes to the cost of equity, the study should establish a methodology by which the EEC can calculate the appropriate cost of equity.

"This shall take into consideration the ownership structure of the utility. The study shall also consider the methodology required by the Electricity Multiyear Price Determination Tariff Methodology for determining the cost of equity, currently the Capital Asset Pricing Model (CAPM)," reads the RFP.

Furthermore, the study shall consider the most appropriate proxy for a risk-free rate, benchmarking with other capital-intensive regional parastatals to determine the appropriate range for a Beta, as suggested by the ESERA Tariff Methodology, benchmarking against other regional entities to determine an appropriate risk premium, as suggested by the ESERA Tariff Methodology.

a regulative, whilst accommodative environment for current and future development trends," read part of the RFP.

They further explained that the need for

the scheme came with that it aims to regulate development to ensure the harmonious development of the built environment.

Managing Director Kristalina Georgieva welcomed the debt deal agreement on Friday, saying it clears the path for the executive board's first review of Ghana's programme.

A sign off by the board is usually seen as a formality once a date has been agreed.

The West African country defaulted on most external debt in December 2022 after servicing costs soared.

It also needs to reach a relief deal with private holders of about \$13 billion in international bonds.

The bonds rose almost 1 cent on the dollar

on Monday, with the 2042 maturity up the most, climbing 0.82 cents to 43.09 cents, its highest level since early November.

"Recently, China encouraged all parties to overcome technical difficulties and narrow differences, and finally led all parties to reach a basic consensus on Ghana's debt settlement plan... on January 8," Chinese Foreign Ministry spokesperson Mao Ning said on Monday.

Some members of the Official Creditor Committee, which is co-chaired by China and France, are still "going through their internal procedures," she told reporters at a regular news briefing.

Ghana is aiming to restructure \$20 billion of external debt, which totalled about \$30 billion at the end of 2022, under the Common Framework, a debt restructuring process set up by the G20 countries during the Covid-19 pandemic. It has targeted cutting \$10.5 billion from payments due between 2023-2026.

The IMF second tranche payout, once signed off, should also trigger \$550 million in additional World Bank funding, Ghana's finance ministry said on Friday. (Reuters)

### Nigeria's inflation rises to more than 27-year high in December

ABUJA — Nigeria's inflation rate rose to its highest in more than 27 years in December as food prices surged, exacerbating a cost-of-living crisis and piling more pressure on the central bank to raise interest rates.

Consumer inflation rose for the 12th straight month in December to 28.92 per cent year on year from November's 28.20 per cent, the National Bureau of Statistics said on Monday.

Inflation in Africa's biggest economy and most populous nation has not climbed this high since mid-1996.

The food inflation rate, which accounts for the bulk of Nigeria's inflation basket, rose to 33.93 per cent in December from 32.84 per cent a month earlier.

The statistics office said prices rose for a broad range of food items including bread

and cereals, oil, fish, meat, fruit and eggs.

Analysts say higher fuel prices and a weaker naira currency have also stoked price

David Omojomolo, Africa economist at Capital Economics, said "inflationary pressures are only likely to build from here," citing second-round effects from the removal of a fuel subsidy last year and naira

He predicted that inflation would breach 30 per cent by the end of the first quarter and said it was unlikely to peak until the middle of 2024.

President Bola Tinubu last May embarked on Nigeria's boldest reforms in decades by scrapping a costly but popular fuel subsidy and devaluing the currency to try to revive economic growth. But growth is yet to pick up while inflation has worsened.

Central Bank of Nigeria (CBN) Governor Olayemi Cardoso is yet to hold a rate-setting meeting since taking office in September. (Reuters)

#### ERIN McGoff has 3 million followers on social media, but with the money she gets from Instagram and TikTok, she wouldn't be able to pay for the plate of mozzarella sticks we're sharing in a Baltimore

"On Instagram, I'll have a video hit 900,000 views and make six dollars," McGoff said. "It's insulting."

Like most content creators, McGoff makes her living from brand deals, sponsorships and subscription products, rather than from the platforms themselves. But that reality is emblematic of the conundrum creators find themselves in: they're propelling social platforms to new heights, but those same platforms can betray them at any second with one small algorithm change or unfounded suspension.

Creators deal with the same stresses of any self-employed business owner, but at the same time, they're wholly dependent on the whims of massive social platforms, which don't pay them enough, or at all, for creating enormous value. And when it comes to brand deals and partnerships, there's no standard to make sure creators are being compensated fairly.

"TikTok and Instagram are making so much money off of ads, and they're not sharing that with creators," McGoff told TechCrunch.

The creator economy has a sustainability problem. According to Matt Koval, an early creator who then worked for a decade as You-Tube's first creator liaison, a creator's career span usually lasts between five and seven years.

"If creators don't capitalize on their flash of fame and turn it into some kind of sustainable business, they can find themselves in a really hard place of, 'Well, what do I do now?" he said in a YouTube video.

Since starting her social media accounts in 2021, McGoff has made more and more money each year, but she's still worried that her job could disappear at any moment. What if her TikTok account gets taken down? What if her followers

get bored of her? With the exception of a small elite group, there's really no blueprint for what a career as a content creator looks like ten, twenty or thirty years down

"You have to act like your influencer money could go away tomorrow," she said. "A lot of creators just think, 'I'm gonna make videos online and make a bunch of money,' and that's unfortunately not sustainable. You have to have a business mindset and understand how to make money work for you."

These anxieties aren't unique, nor are they're not unfounded. While creators try to build their multifaceted businesses, they're also beginning to wonder if they can work together to advocate for more transparency with platforms and brands, which might help make their careers more tenable.

Last year, creators watched as Hollywood's writers and actors

unions picketed incessantly under the unforgiving Los Angeles sun, eventually winning contractual changes with studios that will help them secure better treatment and pay. Some creators even pledged not to cross picket lines during the strikes. Gen Z has come of age in an era when workers at Amazon, Starbucks, REI, Trader Joe's, Home Depot, UPS and so many more are waging high-profile strikes and union drives to fight for better working conditions. And this generation – which spends a whole lot of time on social media - is the most pro-union generation alive.

Is now the time for content creators to get their due?

#### A lack of transparency

As a creator making videos and resources around career advice, it makes sense that McGoff is thinking so intently about her career trajectory. The same goes for Hannah Williams, the founder of Salary Transparent Street (STS), which has amassed over 2 million followers across platforms.

In her videos, Williams asks people on the street to share their salary as a means of promoting pay transparency - since she started her TikTok account in 2022, STS has grown into a broader resource hub to help people get paid fairly.

### As more than \$1 trillion flows into tech ...incentive-tracking apps find firm footing

SPEND some time with people in the climate tech world and you'll soon learn that a lot of them share something in common: They're not used to having a lot of money.

That's because for years, climate represented a cost for many businesses, not an opportunity. Fortunately, that's started to change recently as investors have rushed into the space, seeking opportunities in "double-digit trillion-dollar markets" that are "largely decoupled from general tech investing," Joshua Posamentier, managing partner at Congruent, told TechCrunch+.

Investment in climate tech has been gathering pace over the past five years or so. While the sec wasn't entirely immune to the slowdown that gripped the rest of the startup world over the past couple of years, we did see signs of a rally in the third quarter.

This continued strength is due in part to both U.S. and European commitments to climate-forward industrial policies. Between the Inflation Reduction Act (IRA) and the Bipartisan Infrastructure Law in the U.S. and the Green Deal in the EU, nearly \$1 trillion

in tax credits, grants, and other incentives are available for climate- and energy-related investments and purchases.

actually might be a conservative one. The IRA alone might yield more than that since many of the tax credits are uncapped; Goldman Sachs estimates the law's climate provisions might pay out \$1.2 trillion in incentives, spurring some \$3 trillion in private investment.

That's not enough to get the U.S. or the EU's economy to net-zero carbon emissions (or to make up for historical emissions), but it's a down payment

so large it can be hard to keep track of it all.

In fact, climate tech today finds itself in the unusual position of But that trillion-dollar forecast being so awash in cash (relatively speaking) that there are a number of websites, apps and startups rushing to track it all and help companies and customers make the most of the incentives.

Making sense of it all

"Unfortunately, there's no comprehensive database out there for all of these rebates and incentives," said Thomas Stephens, co-founder of Upfront, a startup that's cataloging incentives for merchants.

#### Microsoft topples Apple to become market cap leader


MICROSOFT has eclipsed Apple to become the world's largest company by market capitalization, driven by its deep focus on generative artificial intelligence (AI), a sector that has garnered increasing investor favour.

The tech giant, which along with Nvidia and Amazon placed a significant emphasis on AI, has experienced substantial market surges over the past year. Notably, Microsoft's market value has risen by over \$1 trillion.

Analysts are drawing parallels between this shift and the early 2000s, when technology and internet companies began to replace consumer and financial firms at the forefront of the market's highest echelons.

According to LSEG data, Microsoft's market cap stood at \$2.887 trillion, its highest ever, while Apple's market cap was \$2.875 trillion as of Friday's close after peaking at \$3.081 trillion on Dec. 14. Microsoft has incorporated OpenAI's technology across its suite of productivity software, a move that helped spark a rebound in its cloud-computing business in the July-September quarter. Its AI lead has also created an opportunity to challenge Google's dominance of web search.

## Zuma asks for prayers as he sets his sights on Union Buildings

FORMER South African president Jacob Zuma is gunning for a third time as the head of state if his hint at a Nazareth Baptist Church service at the weekend is anything to go by.

Addressing scores of worshippers at the church commonly known as Shembe, Zuma asked for their blessings and prayers, as he plots to stage a spectacular return to politics.

The worshipers, under Mduduzi "uNyazi LweZulu" Shembe of Ebuhleni faction, are on their annual pilgrimage to the holy Khenana Mountain in Ndwedwe in the north of Durban.

Since December, Zuma has been on a campaign trail across the country for the newly formed uMkhonto weSizwe Party (MKP).

This after he declared on December 16 that he would not vote for the ANC in the general elections

which are expected to be conducted in the first six months of 2024.

His unexpected announcement left the governing party divided, anxious and uncertain ahead of what is likely to be the fiercest elections since 1994.

There are mooted plans to expel Zuma from the ANC following his decision to ditch the party he once led as its president.

Political comeback

Addressing the worshippers while kneeling down and surrounded by church elders, reverends, and evangelists, Zuma said: "As you all know, I was prematurely removed from office because I was trying to help the poor.

"But the conduct of some people has forced me to make a political comeback to resolve the issues of the poor. I would like ubaba [church leader Shembe] to pray for me as I am eyeing a comeback.

"I listened attentively to his prayer and sermon today, and I

would appreciate it if his hands could touch me because I want to bounce back."

Shembe church spokesperson Thokozani Mncwabe said the church knew Zuma would attend the service


"Msholozi's visit is not special. He has been to our headquarters in Ebuhleni in Inanda in the past and would have private meetings with our leader," said Mncwabe.

"Remember we are in crunch election time, so we anticipate many political leaders to come in numbers seeking blessings from our leader.

"Most recently, we had the PAC leader [Mzwanele Nyhotso] on our shores."

Founded in 1910 by prophet Isaiah Mdliwamafa Shembe, the Nazareth Baptist Church is the second-largest indigenous church in the country with an estimated 12.8 million followers.

President Hage Geingob urged Germany to reconsider its involvement, citing the historical context of Germany's acknowledgement of genocide in Namibia in 2021. During the period from 1904 to 1908, German colonizers perpetrated what historians consider the 20th century's first genocide, resulting in the massacre of over 70,000 Herero and Nama people.

President Geingob argued that Germany's moral commitment to the United Nations Convention against genocide, including atonement for the Namibian genocide, conflicted with its support for Israel. He stated that the German government had yet to fully address its historical wrongdoing in Namibia.

Germany, however, dismissed the genocide accusation against Israel, characterizing it as a "political instrumentalization" of the UN genocide convention. The German government emphasized its commitment to the convention, given its historical responsibility stemming from the Holocaust.

In response to the accusations, Germany highlighted the recent conflict triggered by Hamas's attack on Israel in October. The government argued that Israel, acting in self-defence, faced an existential threat from Hamas, an organization aiming to destroy the country.

The ongoing conflict has claimed

numerous lives on both sides. According to the Hamas-run health ministry, nearly 24,000 people, primarily children and women, have lost their lives in Israel's retaliatory attacks on Gaza since October.

Concerns about a potential famine and the spread of disease among displaced people in Gaza have been raised by the UN and humanitarian organizations, urging the allowance of more aid into the territory.

South Africa initiated the case at the ICJ, presenting a comprehensive list of alleged Israeli offences, including the indiscriminate killing of Palestinian civilians and the widespread destruction of Gaza's infrastructure. Israel vehemently denies these allegations, labeling them as "baseless" and countering that, if anyone is guilty of genocide, it is Hamas.

The ICJ will now play a crucial role in determining the validity of South Africa's claims and shedding light on the complexities surrounding the Israel-Gaza conflict.

## Health authorities rallying to contain worst cholera outbreak in Zambia

ZAMBIA is dealing with one of its worst cholera outbreaks in recent years as 351 people have died and nearly 9,000 active cases have been registered.

Health workers say they are scrambling to contain the crisis that has the potential to be the worst the country has seen since the first in 1977.

On Friday, relatives of people being treated gathered outside a stadium in the capital Lusaka to wait for information about their loved ones.

"They are announcing names here, but (inaudible) my nephew. So I don't know what is going on. Whether my nephew is dead, I don't know. Whether he is alive, I don't know" uncle of a cholera patient said.

President Hakainde Hichilema has urged people to relocate from towns to villages as poor sanitation in some densely populated urban areas was a good breeding ground for cholera.


The prohibition of funerals and family burials has remained in place. More emergency rules are being brought according to the country's health ministry.

"I've told them that they cannot participate in burials, and I also told them that they cannot have funerals at their homes. I also told the general public not to attend funerals anymore" says Sylvia Masebo, Zambian Health Minister.

"To avoid those funerals, especially if someone has died from cholera because they are risking their lives. I think in the beginning it was a bit difficult, but I can tell you that, generally I think, the message is sinking."

Cholera is transmitted through the ingestion of contaminated food and/or water. Experts have suggested climate change to be responsible for heavy rainfalls which contaminated drinking water for those living in crowded, poorer areas.

## 'China should intervene to end Russia, Ukraine war'

DAVOS, Switzerland - China needs to be involved in talks to end the war with Russia, Ukraine's top representative said after a high-level diplomatic meeting ahead of the World Economic Forum in Switzerland.

Ukraine's presidential chief of staff Andriy Yermak said on Sunday it was important that Russian ally China was at the table when Kyiv convenes further meetings on its peace

Chinese Premier Li Qiang will lead a delegation in Davos this week. Asked if President Volodymyr Zelenskiy would meet Li, Yermak told a news briefing "let's see", adding he had not seen the Ukrainian president's final agenda.

Zelenskiy is due to arrive in Bern, Switzerland on Monday to meet the President of the Swiss Confederation Viola Amherd.

Swiss Federal Councillor Ignazio Cassis, who attended Sunday's discussions, told an earlier news conference: "We must do everything to end this war."


"China plays a significant role. We must find ways to work with China on this," Cassis said, adding that both Russia and Ukraine were not willing to make concessions.

Zelenskiy is also likely to meet JPMorgan Chase (JPM.N) CEO Jamie Dimon at Davos this week as he tries to seek support to shore up funds for Ukraine, a source familiar with the matter said. Bloomberg News first reported about Zelenskiy's plans to meet Di-

President Vladimir Putin sent thousands of troops into Ukraine in February 2022, triggering the biggest confrontation between Russia and the West since the 1962 Cuban Missile Crisis.

Cassis said that countries that had a dialogue with Russia, such as Brazil, India and South Africa, were involved in the Davos discussions and could play an important role.

A European Union official said Ukraine's Western partners had expressed unequivocal support for Kyiv and its peace plans, with

a call on the Global South nations to make clear to Russia the importance of respecting the United Nations charter and its core principles in the interest of global security.

#### **GLOBAL SOUTH**

The role of the Global South in Ukraine's peace formula talks has come into focus in the lead up to Davos. Many of the nonaligned countries from Africa, Latin America, the Middle East and Asia that have largely stayed on the sidelines over Ukraine will be represented in the Swiss mountain resort.

The EU official said the Global South partners had generally expressed empathy with the fate of Ukrainians. Some highlighted the need for engaging with Russia's concerns.

Yermak said nobody had asked him about any compromise over territory during Sunday's meeting.

Ukrainian President Volodymyr Zelenskiy was not at Sunday's meeting. But Cassis said he would appear at the summit and there would be opportunities for diplomats to

Zelenskiy was represented by his chief of

staff Andriy Yermak, who said there were participants from 18 Asian countries, 12 African countries and 6 South American coun-

"Countries from the Global South are increasingly involved in our work," Yermak said earlier on his Telegram account.

Ukraine, with strong backing from its allies, has consistently said it will not give up until it has reclaimed every piece of territory that Russia has taken.

It is unclear, however, if countries in the Global South agree with that as a peace for-

Nigeria's national security adviser Nuhu Ribadu told Reuters that the African oil producer stood by Zelenskiy's side, saying it will deal with the consequences of rising food

The talks were also attended by the U.S. special representative for Ukraine's Economic Recovery Penny Pritzker, as well as James O'Brien, the U.S. Assistant Secretary of State for European and Eurasian Affairs.

### Taiwan loses ally, accuses China of post-election ploy

SYDNEY/TAIPEI - Taiwan lost one of its few remaining diplomatic allies Nauru to China on Monday, just days after it elected a new president, and accused China of attempting to pressure it while it affirmed the will of Taiwanese to go out into the world.

China claims Taiwan as its own territory with no right to state-to-state ties, a position Taiwan strongly disputes, and the two have for years traded accusations of using "dollar diplomacy" as they compete for diplomatic recognition.

Taiwan security officials told Reuters before Saturday's election that China was likely to continue to whittle away at the handful of countries now down to a dozen - that maintain formal diplomatic ties with Taipei.

Lai Ching-te, repeatedly criticised by China before the poll as a dangerous separatist, won the election for the ruling Democratic Progressive Party (DPP) and will take office ▲ Taiwan President-elect Lai Ching-te, of Democratic on May 20. ment of the tiny Pacific Island nation of Nauru said that "in the best interests" of the country and its people it was seeking full resumption of diplomatic relations with China and would cut ties with Taiwan.

Nauru has recognised China before, between 2002 and 2005.

China and the United States have in recent years stepped up their competition for influence in the Pacific. In 2019, Kiribati and the

Solomon Islands both ditched Taiwan for China in the space of a week.

The U.S. affirmed that its commitment to Taiwan is 'rock solid" after Saturday's election, in comments delivered by former U.S. National Security Advisor Stephen Hadley on Monday during a trip to the island.

Taiwan's Deputy Foreign Minister Tien Chung-kwang told a hastily ar-

ranged media briefing after Nauru's an-

nouncement the that news had

come suddenly.

Beijing specifically chose the sensitive timing after the election to target Nauru, Tien said, calling the move "ambush-like" and equivalent to a "a blatant attack on democracy", just as many countries were offering congratulations to Taiwan on the smooth voting process.

"Taiwan did not bow to the pressure. We elected what we want to elect. That's unbearable for them," he added.

China had offered Nauru, with a population of 12,500, money far in excess of what Taiwan provides its allies, Tien said.

"Once again, it proves that China's trying everything they can - money diplomacy - to repress us," he said.

A senior Taiwan official briefed on the matter, speaking on condition of anonymity as they were not authorised to speak to the media, said Beijing is offering Nauru \$100 million a year.

A Nauru government spokesperson declined to comment

China's foreign ministry said it appreciated and welcomed Nauru's decision. It did not directly answer a question on how much money it offered.

#### **Pope Francis** defends samesex blessings declaration

ROME - Pope Francis on Sunday defended a landmark decision approving blessings for same-sex couples, suggesting that those in the Catholic Church who have resisted it have jumped to "ugly conclusions" because they do not understand it.

In a television interview, Francis made his first public comments since the Dec. 18 declaration sparked widespread debate in the Church, with bishops in some countries, particularly in Africa, refusing to let their priests implement

"Sometimes decisions are not accepted, but in most cases when decisions are not accepted, it is because they are not understood," Francis said in response to a specific question about the December declaration.

"The danger is that if I don't like something and I put it (the opposition) in my heart, I become a resistance and jump to ugly conclusions," he said during a link from his Vatican residence with the "Che Tempo Che Fa" program on Italy's Channel 9.

"This is what happened with these latest decisions on blessings for all," he said, referring to the declaration known by its Latin title Fiducia Supplicans (Supplicating Trust). It was issued by the Vatican's doctrinal department and approved by him.

Since the original declaration, the Vatican has been at pains to stress that the blessings did not amount to an approval of gay sex and should not be seen as anything remotely equivalent to the sacrament of marriage for heterosexual

Some bishops in France told their priests they could bless gay individuals but not couples.

The Church teaches that gay sex is sinful and disordered and people with same-sex attractions should try to be chaste and the pope appeared to be alluding to this is his response.

"The Lord blesses everyone," Francis said. "But then people have to enter into a dialogue with the blessing of the Lord and see the path that the Lord proposes. We (the Church) have to take them by the hand and lead them along that path and not condemn them from the start". (Reuters)



AN anxiety attack tends to occur in response to certain stressors and may build gradually while panic attacks can occur unexpectedly and abruptly.

Both may indicate an underlying health condition. You might hear people talking about panic attacks and anxiety attacks like they're the same thing. But they're different conditions.

Read on to find out more about the differences between panic attacks and anxiety.

#### WHAT IS AN ANXIETY ATTACK?

The "Diagnostic and Statistical Manual of Mental Disorders, 5th edition" (DSM-5) does not mention anxiety attacks, but it does define anxiety as a feature of a number of common psychiatric disorders.

This includes the following conditions:

- generalized anxiety disorder
- panic disorder
- ► separation anxiety disorder
- ▶ agoraphobia without history of panic disorder
- post-traumatic stress disorder
- ► social anxiety disorder
- ▶ obsessive-compulsive disorder
- specific phobia

Anxiety is usually related to the anticipation of a stressful situation, experience, or event. It may come on gradually.

Symptoms of anxiety include:

- worrv
- distress
- ▶ fear

The lack of diagnostic recognition of anxiety attacks means that the signs and symptoms are open to interpretation.

That is, a person may describe having an "anxiety attack" and have symptoms that another person has never experienced despite indicating that they, too, have had an "anxiety attack."

#### WHAT IS A PANIC ATTACK?

Panic attacks come on suddenly and involve intense and often overwhelming fear. They're accompanied by very challenging physical symptoms, like a racing heartbeat, shortness of breath, or nausea.

DSM-5 recognizes panic attacks and categorizes them as unexpected or expected.

Unexpected panic attacks occur without an obvious cause. Expected panic attacks are cued by external stressors, like phobias.

Panic attacks can happen to anyone, but having more than one may be a sign of panic disorder, a mental health condition characterized by sudden and repeated panic attacks.

#### SYMPTOMS OF PANIC ATTACK VS. ANXIETY ATTACK

Panic and anxiety attacks may feel similar, and they share a lot of emotional and physical symptoms. You can experience both an anxiety and a panic attack at the same time.

For instance, you might experience anxiety while worrying about a potentially stressful situation, like an important presentation at work. When the situation arrives, anxiety may culminate in a panic attack

A panic attack or anxiety attack can both cause physical and emotional symptoms, including:

- apprehension and worry
- distress
- fear of dying or losing control
- ▶ a sense of detachment from the world (derealization) or oneself (depersonalization)
- heart palpitations or an accelerated heart rate
  - chest pain
  - ▶ shortness of breath
- ▶ tightness in the throat or feeling like you're choking
- dry mouth

The difference between a panic attack and an anxiety attack?



- sweating
- chills or hot flashes
- trembling or shaking
- numbness or tingling (paresthesia)
- ▶ nausea, abdominal pain, or upset stomach
- headache
- ▶ feeling faint or dizzy

It may be difficult to know whether what you're experiencing is anxiety or a panic attack. Keep in mind the following:

- ▶ **The cause:** Anxiety is typically related to something that's perceived as stressful or threatening. Panic attacks aren't always cued by stressors. They most often occur out of the blue.
- ▶ The level of distress: Anxiety can be mild, moderate, or severe. For example, anxiety may be happening in the back of your mind as you go about your day-to-day activities. Panic attacks, on the other hand, mostly involve severe, disruptive symptoms.
- ▶ **Fight-or-flight:** During a panic attack, the body's autonomous fight-or-flight response takes over. Physical symptoms are often more intense than symptoms of anxiety.
- ▶ **Speed of onset:** While anxiety can build gradually, panic attacks usually come on abruptly.
- ▶ **Effect:** Panic attacks typically trigger worries or fears related to having another attack. This may have an effect on your behavior, leading you to avoid places or situations where you think you might be at risk of a panic attack.

#### CAUSES OF PANIC ATTACK VS. ANXIETY ATTACK

Unexpected panic attacks have no clear external triggers. Expected panic attacks and

anxiety can be triggered by similar things. Some common triggers include:

- a stressful job
- driving
- social situations
- ▶ phobias, like agoraphobia (fear of crowded or open spaces), claustrophobia (fear of small spaces), and acrophobia (fear of heights)
- reminders or memories of traumatic experiences
- chronic illnesses, like heart disease, diabetes, irritable bowel syndrome, or asthma
  - ▶ chronic pain
  - withdrawal from drugs or alcohol
  - caffeine
  - ► medication and supplements
  - ► thyroid problems

#### RISK FACTORS FOR PANIC ATTACK VS. ANXIETY ATTACK

Anxiety and panic attacks have similar risk factors. These include:

- experiencing trauma or witnessing traumatic events, either as a child or as an adult
- ▶ experiencing a stressful life event, like the death of a loved one or a divorce
- experiencing ongoing stress and worries, like work responsibilities, conflict in your family, or financial woes
- living with a chronic health condition or life threatening illness
- having an anxious personality
- having another mental health condition like depression
- having close family members who also have anxiety or panic disorders
- using drugs or consuming alcohol
- ▶ People who experience anxiety are at an increased risk of experiencing panic attacks. But having anxiety does not mean you will experience a panic attack.

#### DIAGNOSING PANIC ATTACK VS. ANXIETY ATTACK

Doctors can't diagnose anxiety attacks, but they can diagnose:

- anxiety symptoms
- anxiety disorders
- panic attackspanic disorders
- A doctor will ask you about your symptoms and conduct tests to rule out other health conditions with similar symptoms, like heart disease or thyroid problems.

To get a diagnosis, a doctor may conduct:

- a physical exam
- blood tests
- ▶ a heart test, like an electrocardiogram (ECG or EKG)
- ▶ a psychological evaluation or questionnaire

#### TREATMENT AND MEDICATION FOR PANIC ATTACK VS. ANXIETY ATTACK

Speak with a doctor about other treatments for anxiety and panic attacks. Here are some treatments they may discuss with you.

- ► Counseling and psychotherapy: Talking therapies for anxiety and panic disorders can involve the following, often in combination.
- Cognitive behavioral therapy (CBT): This type of therapy can help you see things that worry you in a new way. A counselor can help you develop strategies for managing triggers when they arise.
- ▶ **Cognitive therapy:** This can help you pinpoint, reframe, and neutralize the unhelpful thoughts that often underlie an

- **Exposure therapy:** This form of therapy involves controlled exposure to situations that trigger fear and anxiety, which can help you learn to confront those fears in a new way.
- Relaxation techniques: These include breathing exercises, guided imagery, progressive relaxation, biofeedback, and autogenic training. A doctor can talk you through some of these.

A doctor may suggest attending individual sessions, group sessions, or a combination of

#### **MEDICATION**

Examples of medications your doctor may

Antidepressants: These medications include selective serotonin reuptake inhibitors (SSRIs) serotonin-norepinephrine reuptake inhibitors (SNRIs).

- ▶ **Beta-blockers:** These medications can help manage certain physical symptoms, like a rapid heart rate.
- Anti-anxiety drugs: This includes benzodiazepines, a sedative medication that can suppress symptoms quickly.

All these drugs can have adverse effects. SSRIs and SNRIs are for long-term use, and it can take time to feel the effects. Benzodiazepines are for short-term use only, as there is a high risk of dependence.

Oftentimes, a doctor will recommend a combination of treatments. They may also need to alter your treatment plan over time.

#### HOME REMEDIES FOR PANIC ATTACK VS. ANXIETY ATTACK

You should speak with a doctor or mental health professional to find out what you can do to both prevent and treat anxiety- and panicrelated symptoms. Having a treatment plan and sticking to it when an attack happens can help you feel like you're in control.

If you feel an anxiety or panic attack coming on, try the following:

- ► Take slow deep breaths: When you feel your breath quickening, focus your attention on each inhale and exhale. Feel your stomach fill with air as you inhale. Count down from four as you exhale. Repeat until your breathing
- Recognize and accept what you're experiencing: If you've already experienced an anxiety or panic attack, you know that it can be incredibly challenging. Remind yourself that the symptoms will pass and you'll be alright.
- Practice mindfulness: Mindfulnessbased interventions are increasingly used to treat anxiety and panic disorders.
- ► Use relaxation techniques: Relaxation techniques include guided imagery, aromatherapy, and muscle relaxation.

## Jump Rope vs. Running:

JUMPING rope is a low cost exercise that requires little equipment and minimal space.

Running is also a low cost exercise, but it typically requires increased space to perform unless you're running on a treadmill. However, that compromises the affordability.

Still, both are economical and efficient ways to work on your fitness, whether you're working on endurance or intensity. As such, you may wonder which is better for you, or whether you should focus on one over the other.

#### DO THEY BURN THE SAME **AMOUNT OF CALORIES?**

Both jumping rope and running burn a significant amount of calories. When comparing the number of calories burned during a 10-minute session of each, jumping rope offers a slight advantage.

Listed below are the estimated number of calories burned for each activity at comparable intensities for a 150-pound (68-kg) person performing each exercise for 10 minutes:

Intensity

- Jumping rope
- Running

- ▶ 105 calories
- ▶ 117 calories

Medium

- ► 140 calories
- 125 calories

- ▶ 146 calories
- ► 140 calories

While other factors affect calorie burning, including your age and sex, these are the general guidelines.

#### DO THEY WORK THE BODY THE SAME WAY?

#### Muscles used

Both running and jumping rope involve the use of your lower extremity muscles for propulsion, while your core muscles provide trunk stabilization.

Also, single-foot rope jumping and the stance phase of running require somewhat similar trunk and hip stabilization.

However, running requires increased use of your buttocks (hip extensors) through a greater range of motion for propulsion. Yet, alternating single-foot rope jumping requires increased use of your hip abductors to keep your pelvis stable, just like during the stance phase of running. Jumping rope also involves resistance to control the rope, involving your shoulder, biceps, triceps, and forearm flexor grip.

Meanwhile, running involves minimal resistance but the repetitive contraction of your shoulders (deltoids) and sustained flexion of the biceps to counterbalance your leg movement.

#### ► Impact force

The amount of impact force on your lower extremities is relatively similar between jumping rope and running.

The impact force differs between

single-skip rope jumping (single unders) and double-skip rope jumping (double unders). Double unders typically have a higher impact force than single unders.

#### ► Aerobic or anaerobic?

Both forms of exercise can be performed as aerobic exercise to enhance endurance by maintaining a steady pace over a longer duration.

In addition, sprints or high intensity intervals, which are considered anaerobic activities, can also be performed with both jumping rope and running.

Either is a good choice for high intensity interval training (HIIT), which involves short bouts of exercise at 80-95% of your max heart rate interspersed with periods of lower intensity exercise at 40-50% of your max heart rate.

#### DO THEY BOTH BURN FAT?

One recent 12-week study observed that a jump rope program reduced body fat and improved risk factors associated with heart disease. Other studies have found similar results regarding body fat reduction. The challenge is that both the quantity and size of studies on rope jumping tend to be smaller than those on running. Running has been shown to be an excellent method of burning body fat. In fact, similar calorie expenditures were observed for various forms of running, including continuous endurance running and high intensity interval training (8).

#### DO THEY BOTH IMPROVE ENDURANCE AND SPRINT PERFORMANCE?

Both exercises have been shown to improve cardiovascular endurance — even if a rope wasn't used to perform the jumping task. There are alternatives to corded jump ropes that put the body through the same movement but require less coordination.



There's a correlation between jump rope speed (or the ability to perform double unders) and sprint speed. Thus, the ability to perform double unders may correlate to improved sprinting abilities given the anaerobic nature of the exercise.

In fact, double-under rope jumping has been a stable component of high intensity interval training and CrossFit programs since their inception.

#### WHO SHOULDN'T RUN? WHO SHOULDN'T JUMP ROPE?

Both activities involve increased ground reaction forces compared with activities like swimming, cycling, and walking. Thus, both activities may be difficult for people with lower leg injuries at the hips, knees, or ankles.

However, there are alternatives to running on land. There are gravity-reducing, or unweighting, treadmills, which assist a portion of your weight to decrease the mechanical stresses on your body. Also, aqua jogging allows you to perform the mechanics of running in shallow or deep water.

Finally, the DigiJump machine offers a lower impact surface for simulating jumping rope. In addition, you can use a mini trampoline to simulate jumping rope.

#### HOW SHOULD I CHOOSE?

Both forms of exercise have been shown to improve cardiovascular endurance. However, if you're pressed for time, jumping rope may benefit you more than running.

Nevertheless, if your goal is to be a better runner or compete in running races, running is a better option. Furthermore, if you're more inclined to enjoy a change of scenery during exercise, running is definitely a better option.

That said, jumping rope can be an alternative exercise to perform on days in between running to change the pattern of muscle activation while still working your cardiovascular system. Healthline

## Osaka falls at first hurdle on Grand Slam return

MELBOURNE - Naomi Osaka was disappointed to bow out of the Australian Open in the first round on her Grand Slam return on Monday but thought she was making rapid progress in her comeback after 15 months out of the game.

The Japanese former world number one, who took time out to have daughter Shai, went down 6-4 7-6(2) to French 16th seed Caroline Garcia on the Rod Laver Arena court where she won two of her four Grand Slam titles.

"I thought it was a really good match. For me, I felt like I did the best that I could possibly do," she told reporters.

"I think I still feel like a bit disappointed ... I did feel nervous, but I felt like I kept telling myself to be positive. I thought I kept doing better as the match went on.

"So, yeah, I'm not too happy right now, but I think I can learn from the progress."

Taking on the experienced Garcia was always going to be a big challenge for Osaka, who had played only two matches in Brisbane two weeks ago since her return to tournament tennis.

A double fault gave Garcia the first break point of the match in the fifth game and the former world number four converted it to

Osaka had a sniff of a break back at deuce in the eighth game but dumped a routine backhand into the net and Garcia held with back-to-back aces before going on to take the set.

BACK FOOT

Twice U.S. Open champion Osaka won her first three service games of the second set to love, but Garcia was serving so well that Osaka was unable to build any pressure

"I felt like I was constantly on my back foot and really hesitant," Osaka added.

"I was a little bit overthinking in my head

Garcia, who raced through the second-set tiebreak to clinch her place in round two, said she was sure it would not be too long before Osaka was back at the top of the game.

"She has had an amazing career, she has been away for 15 months and been through a lot," the 30-year-old said.

"Six months after giving birth and she's playing amazing, so we have to watch out."

It was Osaka's earliest exit in eight visits

to the Australian Open and her third successive loss in the opening round of a Grand Slam after she fell at the first hurdle at the French and U.S. Opens in 2022.

The 26-year-old was clearly struggling to reconcile her disappointment at the loss with the fact that she was so competitive after such a long period on the sidelines.

"Of course, there's a voice in my head that is, 'Who are you to think you can come back and immediately start winning matches?"," Osaka said. "I don't know. I kind of always expect myself to stand a chance anyways." (Mail Sport)

"I think it's early February, I hope they don't find anything dodgy on my CV," the INEOS chairman said with a laugh. "I have met (manager) Erik (ten Hag) obviously but it would be inappropriate to (to say anything) until it's all formalised," he added.

Ratcliffe, who plans to attend "quite a lot of games," said he has dreamed of United ownership for a few years.

"It's taken a few turns along the road, but it all turned out well in the end," he said.

The 71-year-old explained he was "about 10" when he took in his first game at Old Trafford, and his most recent visit to the stadium before Sunday was two or three years

## Cameroon, Guinea share the spoils

YAMOUSSOUKRO - Cameroon came from behind to share the points with 10-man Guinea in a 1-1 stalemate in the first game for both teams at the Africa Cup of Nations finals in Ivory Coast on Monday. Franck Magri equalised early in the second half after Guinea had taken a 10th minute lead through Mohamed Bayo but then had captain Francois Kamano sent off.

The draw at the Charles Konan Banny Stadium in the Ivorian capital followed the opening Group C game where holders Senegal easily disposed of Gambia 3-0.

Cameroon were without Andre Onana in goal but he did arrive ahead of the game after featuring for Manchester United in Sunday's 2-2 draw with Tottenham Hotspur at Old Trafford.

Guinea were handed a fortunate lead following some horror defending from the Indomitable Lions.

After Bayo's initial shot at goal was parried away by goalkeeper Fabrice Ondoa, there were two chances to clear the ball but under pressure the Cameroon defence botched their efforts and centre back Olivier Kemen ended up kicking the ball back towards his goal and into the path of Bayo, who need no second invitation to finish from close range.

#### Equaliser

Cameroon might have had a quick equaliser but Andre-Frank Zambo Anguissa missed a good opportunity at the back post from Georges-Kevin Nkoudou's 13th minute freekick.

But their chances were enhanced on the stroke of halftime when Kamano was sent off for a challenge from behind on Magri, standing first on his heel and then ankle.

Initially he was cautioned but after the referee was advised to review his decision via VAR, it was changed to red.

With the one man advantage, Cameroon dominated the second half attacks with the equaliser coming in the 51st minute after Nkoudou put in a cross to the back post and Magri climbed high to head home despite the attention of Guinea defender Antoine Conte.




