CJ launches investigation into the operations of the Master's office

FOLLOWING an outcry, emaSwati will be pleased to learn that the office of the Master of the High Court will be investigated.

On Tuesday, Chief Justice Bheki Maphalala announced a Judicial Commission of Inquiry which will investigate the Master of the High Court concerning allegations of impropriety, maladministration, abuse of power, and incidental matters.

Speaking at a press conference at the High Court, the CJ referenced the submissions and grievances made towards the Master of the High Court by emaSwati during the Sibaya, the People's Parliament.

"As the court, we are the third arm of the government as per Section 139 (5) of the Constitution which further permits us to be independent as the Judiciary. I deemed it fit to assemble this Commission that will address all the issues in the office of the Master of the High Court and ensure its smooth running," the CJ said.

The Commission is chaired by Judge Majahenkhaba Dlamini of the Supreme Court, the Deputy Chairperson is Judge Mzwandile Fakudze of the High Court, and three members, Judges Sifiso Nsibande, Maxine Langwenya, and Lorraine Hlophe, and the secretary of the Commission is Registrar Siphiwo Masuku.

According to the CJ, the Commission will inquire into, make findings, report, and issue recommendations concerning the office of the Master of the High Court.

Investigation will be conducted on the allegations of impropriety in handling the estates of deceased people, the winding up of companies, and the administration of the Guardian Fund.

The commission will further investigate whether there are any irregularities, undue enrichment, corruption, and influence in the appointment of executors in contested estates and the appointment of liquidators in the winding up of companies.

"One of the major thorny issues raised at Sibaya was corruption which as the High Court we need to curb and play our role as the third arm of the government," he said.

Therefore, the commission will also inquire into the allegations of lack of accountability, effectiveness, and oversight in the execution of functions by officials employed by Master, further, to establish whether they (officials) received benefits, directly or not from the estates of deceased persons, or were involved in any acts of corruption.

Embezzlement allegations by officers employed by the Master of the High Court will be investigated, particularly those concerning the Guardian Fund.

The CJ went on to say that from there on, the Commission will consider whether there is a need to review the present legislative and operational framework and make remedial actions, if any to address deficiencies identified in unity with the terms of reference.

"Before commencement of duties, every Commissioner is expected to take an oath. The Chairperson will decide when, otherwise the Commission is expected to start working effectively today (Tuesday)," the CJ said.

The Commission will work at the Industrial Court of Appeal where it will hold public and private hearings in a manner that will be deemed necessary and convenient.

Maphalala further stated that the Commission will examine and review the

policies, procedures, practices, and conduct relating to the operations of the office of the Master of the High Court.

Oral and written submissions from interested parties will be invited.

The Commission is further expected to

The Commission is further expected to conclude and submit a report of its findings and recommendation after three months.

... E1000 fine for giving false testimony

As the investigations to the Master of the High Court's office are set to begin, the Judicial Commission of Inquiry will subpoena witnesses to attend and give evidence before it.

In the event a witness gives false testimony, they will be guilty and liable on conviction to a fine not exceeding E1000 or be imprisoned for six months or both.

This is according to the terms of reference for the Commission.

The terms of reference state that the Civil Service Evidence Act No: 16 of 1902 shall apply to the giving of evidence before the Commission as though they constituted a court

The Commission may, if necessary, investigate and make findings and recommendations on, any other matter regarding the Master of the High Court, regardless of when it is alleged to have occurred, on condition that such other investigations, findings, and recommendations do not cause any delay in the submission of the report.

The Commission has the power to summon a witness in a similar way a subpoena is issued at the Magistrates Court.

It can also require any person, subject to any privilege which may be claimed by the person under the law, to furnish information on matters which, in the opinion of the Commission, may be relevant to the subject matter of inquiry.

A witness before the Commission shall take an oath or make an affirmation in the form in use at the Magistrate Court. The Chairman shall administer the oath or accept the affirmation.

Hope for a proper budget to curb corruption

Chief Justice Bheki Maphalala says he hopes the 12th Parliament will allocate a budget that will be enough to fight against corruption in the country.

Maphalala said the court noted that corruption was one of the major thorns presented at the People's Parliament.

"One other issue raised by emaSwati during Sibaya was corruption, something we as the court associate ourselves with fighting. We hope the new government will allocate enough funds to those responsible for fighting against corruption," he said.

The CJ clarified that the courts also make verdicts and judgments based on the evidence presented in court and not on what the people say, "we cannot just put people behind bars without reasoning."

AFTER three years of non-usage of breathalyzers following their ban at the height of the Covid-19 pandemic outbreak, the Ministry of Health has confirmed that the ban on breathalyzers has been lifted.

This was confirmed by the Director of Health Services at the Ministry of Health Dr Velephi Okello. She said since The Ministry of Health announced the de-scalation of the Covid-19 response in September 2022 all measures that were meant to minimize the spread of Covid-19 were lifted, so it was obvious that breathalyzers will also return.

The return of the device was evident at the Mbabane Magistrate's Court on Monday as suspects charged with driving under the influence of alcohol had their charge sheets indicating the milligrams per litre of alcohol alleged to be found in their system.

The Magistrate's court recorded 6 cases of drunken driving on Monday. One of the accused Mzwandile Hlophe had his charge sheet stating that on January 14, 2024, near Ngwenya in the Hhohho region, Hlophe being the driver of a motor vehicle

wrongfully drove the vehicle along Ngwenya public road whilst other the influence of an intoxicating liquor, or drug which have a narcotic affect. "The accused had an alcohol

content of 0.93 mg/l" part of the charge sheet reads. The accused was fined E1,900 or spent 12 months in prison.

Another suspect was Dumsane Simelane, his charge sheet read that "On January 14, 2024, at about 23:45 hours near City Centre, in the region of Hhohho, Mbabane the said accused being the driver of motor vehicle, Audi A3 sedan did wrongfully and unlawfully drive the said vehicle along Chinese Traffic Lights whilst under the influence of intoxicating liquor or drug having a narcotic effect with alcohol content of 1.17m/1.

Emaswati had mixed feelings about the return of breathalyzers. One Mbali Dlamini who was found at the premises of the court

lauded the return of breathalyzers, stating that some people were arrested for nothing as people were arrested for merely having a strong smell of alcohol coming out of their mouth. Themba Sibandze stated that it

> was much better when there were no breathalyzers because they were able to win cases in court, as the crown did not have strong

The call for the devices to be brought back was made by Acting Magistrate Innocent Motsa, the judicial officer who was presiding over a case of Skhumbuzo Simelane who was accused of drunken driving. Simelane's charge sheet

read that on January 6, 2023, near

evidence against them.

ka Zondle in Mbabane Simelane was driving a vehicle along Jojo Street whilst under the influence of intoxicating liquor or a drug having a narcotic effect and thus contravened Section 122(2) of the Road Traffic Act of 2007.

Simelane pleaded guilty and was found guilty as per his plea. When the time for mitigation came Motsa stated that Section 122 (2) of the Road Traffic Act which Simelane has contravened stipulates that a suspect should be granted a fine not exceeding E5,000 or sentenced to 2 years imprisonment. "The government funds are going to waste as the courts cannot give suspects the maximum fine of E5,000 because the crown lacks evidence which is the measurements from the breathalyzer," Motsa said. He said that they are pleading with the police to bring back the device, as it would simplify the court process. Motsa added that relying solely on the strong smell of alcohol from the individual's mouth is unprofessional for documenting details of drinking and driving offences, and this is what the REPS used to apprehend offenders.

tions, and 10 organizations. Uganda's Foreign Minister Gen. Abubakar Jeje Odongo opened the summit with the norm and practice of NAM.

NAM was founded in 1961 at the height of the Cold War between the West and East. But, unlike other regional and international organisations, it neither has a formal founding Charter, Act, or Treaty, nor a permanent secretariat.

Parents/guardians warned on neglecting children's upbringing

THE Deputy Prime Minister's Office has warned parents not to abdicate their duty to be involved in their children's upbringing as positive role models.

The above is reflected in a statement published by the DPM's office on Tuesday. The statement was aimed to remind parents to make sure that they play their roles as children are going back to school.

The office states that as emaSwati anxiously waits in anticipation for the start of the new school year, the Office of the Deputy Prime Minister, in fulfilment of its mandate as custodian of children and family issues as well as its obligations under the Children Protection and Welfare Act/2012, takes this opportunity to remind parents/guardians of their moral and legal duty and responsibility to care for their children and to ensure that their welfare and future is protected and secured.

"It is disheartening to note increasing numbers of children who are school going age roaming the streets and not attending school. The Office of the Deputy Prime Minister cautions parents/guardians not to abdicate their duty to be involved in their children's up-bringing as positive role models," the statement reads.

"The office made a promise that this year it will increase efforts to monitor

the well-being of children. The office of the Deputy Prime Minister will up-scale efforts to monitor these children, implement and enforce relevant provisions of the Children Protection and Welfare Act. Those parents/guardians found to be on the wrong side of the law will be prosecuted," the statement emphasises.

The office of the Deputy Prime Minister also informed that it still condemns violence against children and women and, to this end, reminds the public that gender-based violence is unacceptable and, therefore, an

offence punishable by law.

"The office of the Deputy Prime Minister wishes all children a successful new school year and may their dreams be fulfilled," the statement reads.

The DPM's office shared this statement because of the increasing cases of maintenance where one parent fails to play their role of being involved in the child's upbringing, which is seen in courts and by the social welfare department. The director of social welfare Mcusi Shongwe said last December they had 975 cases of maintenance

which they are actively working on to assist the parties involved. He added that the number of cases which they attend fluctuates with time.

"In December, the social welfare department was dealing with 975 cases which we were facilitating," Shongwe said. The mandate of the social welfare department is to develop, facilitate and monitor the implementation of effective policies and strategies for integrated social welfare services that meet the needs of all vulnerable groups.

Furthermore, to implement comprehensive social welfare services focusing on all vulnerable groups which are families, older persons, disabilities, children, ex-servicemen, substance abuse people, and persons affected with HIV/AIDS provide an affordable, accessible, and comprehensive social security system that prioritises the most vulnerable. They also administer the OVC school bursary and that of the elderly.

NATICC empowers over 100 KoNtjingila residents with life skills

A step in the right direction! Over 100 residents of KoNtjingila gathered for a powerful and transformative session delivered by the Nhlangano AIDS Training Information and Counseling Center (NATICC) on Sunday.

The engaging session delved into the crucial concepts of emotional intelligence, personal development, and the art of effective decision-making.

The workshop, held at the New Nazareth Church (a branch of the Free Christian Evangelical Fellowship), provided participants with valuable tools and techniques to navigate life's challenges with greater awareness and control. Through interactive exercises and insightful presentations, NATICC facilitators equipped attendees with knowledge and skills that include recognizing and managing emotions. Participants learned to identify their emotions, understand their triggers, and develop healthy coping mechanisms. This self-awareness empowers them to make informed choices and build stronger relationships.

NATICC highlighted that the workshop explored individual strengths and weaknesses, helping participants set realistic goals and cultivate a growth mindset. This newfound confidence can propel them towards personal and professional achievements. Further,

participants gained crucial skills for analysing situations, weighing options, and making impactful choices with clarity and purpose. This empowers them to navigate life's complexities with greater certainty and control. Tandzile Mabuza of KaGwegwe said that she believes such sessions are very important for them as they are still growing up. "The workshop was truly eye-opening, and I think we do need such sessions. I went to church thinking that it would be a normal service but was appalled by the NATICC team that graced us" shared Tandzile "I learned so much about myself, how to manage my emotions effectively, and how to make proper decisions as every decision I make has longlasting impact in my life. This knowledge is going to make a big difference in my life.' Honoured

NATICC expressed that they were honoured to be part of the session where they made sure that they impacted the lives of the people. The organisation is a faith-based, non-profit NGO that provides information, training, and counselling on HIV/AIDS in Nhlangano, Eswatini. The formation of the organisation in 2002 was prompted by the fact that the Shiselweni region has continued to have high infection rates (42.5 per cent in 2004) as compared to other regions in Eswatini.

NATICC is funded by the Norwegian Agency for Development Cooperation and Norwegian Church Aid. NATICC comprises a team of well-trained HIV/AIDS educators and counsellors. Its centre is based at the Bethesda Mission Station in Nhlangano, but NATICC reaches out to the whole of the Shiselweni Region. NATICC is the voluntary counselling & testing (VCT) Centre for Nhlangano.

Abuse cases rise in the Kingdom as...

SWAGAA reports 173 cases across six sites countrywide

A grim picture of abuse in Eswatini emerges as the Eswatini Action Group Against Abuse (SWAGAA) reports a worrying number of 173 cases from just six of their sites in December 2023.

This data, encompassing areas like Manzini, Mbabane, Simunye, Hlatsi, Mankayane and Pigg's Peak, lays bare the ongoing struggle against abuse in various forms within the Kingdom. SWAGAA asserted such in a shared report.

SWAGAA's counselling department provided post-abuse care services to a total of 173 clients who reported gender-

based violence cases, that is, the client was either sexually, physically, neglected, financially, emotionally or other which includes health issues, anger issues, depression, psychological distress or wayward behaviour.

According to the report, 96 survivors in the Manzini region reported abuse-related cases, 52 in Hhohho, 16 in Lubombo, and 9 in Shiselweni. There were 90 recorded cases of emotional abuse, 27 cases of neglect, 10 cases of physical abuse, 5 cases of financial abuse, 24 cases of sexual abuse, and 40 cases of other forms of abuse. SWAGAA's reports highlight that emotional abuse records the highest number of cases this month; followed by other forms, neglect, sexual, physical, and lastly financial.

HMCS champions gender mainstreaming for officers through Lisango Lemajaha

IN a groundbreaking move, His Majesty's Correctional Services (HMCS) is setting a new standard for inclusivity within its ranks.

Last week, Commissioner General LaMakhosini Phindile Dlamini took centre stage at the Lisango Lemajaha event, a unique platform aimed at sensitizing male officers on crucial life issues through a lens of gender mainstreaming.

Held at Matsapha Correctional Centre, the event served as a powerful forum for open dialogue and introspection. Male officers, often stereotyped as embodying stoicism and emotional resilience, were given the space to address sensitive topics like anger management, accepting defeat, suicidal tendencies, sexual and domestic violence, and financial management.

This deliberate shift away from traditional approaches to officer well-being highlights HMCS's commitment to fostering a more empathetic and aware correctional environ-

"His Majesty's Correctional Services is part of the Southern African Development Community (SADC), where issues of Gender mainstreaming emanate. In a meeting in April 2019 in Luanda, Republic of Angola the topic of Woman Network and Gender mainstreaming was deliberated and a decision to launch the network was forwarded to member states.

Launched

Then on the 14th May 2019 in Gaborone the Republic of Botswana the Regional Woman Network and Gender Mainstreaming was launched.," declared Commissioner General Dlamini in her address. "Furthermore, besides the symbolic launch of the Forum, a Strategic Plan (2020-2025) Thematic Area 9, we as Corrections/Prisons/Correction are expected to do something towards sensitizing officers on issues of gender main-

The presence of officials from the Deputy Prime Minister's office and PSHACC (Public Service High Commission) added further weight to the initiative. Their participation underscored the broader implications of HMCS's progressive approach, signalling a potential ripple effect across government agencies in embracing gender awareness."

Gender mainstreaming is a strategy that aims to improve the quality of public policies, programmes, and projects, ensuring a more efficient allocation of resources. The Council of Europe expresses that better results mean increased well-being for both women and men and the creation of a more socially just and sustainable society. HMCS's initiative has received accolades from some organisations. Ntombi Mncwango of Siphila Sonkhe SiboMake highlighted that they applaud the HMCS administration for leading such an initiative. Mncwango said that this is commendable being done at a time when the country is fighting the soaring cases of Gender-based Violence (GVB). Mncwango said that the way they view such as an organisation is that Lisango Lemajaha is more than just a one-off event; it represents a paradigm shift within HMCS. "To me, such an initiative challenges long-held assumptions about masculinity and prioritizes the emotional

well-being of all officers, regardless of gender," Ntombi asserted "By providing a safe space for open dialogue and addressing traditionally taboo subjects, the platform fosters a sense of empathy and understanding that transcends professional boundaries."

Commissioner General further highlighted that The Kingdom of Eswatini falls within the Global Village, in alignment with the regional and international conventions on strengthening the capacity of rights-holders, particularly men, women, children and other vulnerable groups, to participate in decision-making processes, claim their rights and access to justice.

In the same vein, the department of His Majesty's Correctional Services has adopted such initiatives and engaged Lutsango in 2022 to equip them on several issues affect-

Senior Magistrate frustrated over ATM bombing case

SENIOR Magistrate Sifiso Vilakati has expressed his frustration over the ATM bombing case which is still unsolved two years later.

Vilakati expressed his frustration in court on Tuesday where the trial of the case was supposed to continue, however, due to the ineptitude of the defense it did not continue. Vilakati said the delay in the finalisation of the matter is causing him distress as he must finalise cases as soon as possible so that the accused involved can know their fate and move on with their lives.


He added that he always makes this case his priority when it is its day in court, because of the seriousness of the crime, so it does not sit well with him when the case is postponed.

"It is unacceptable that a case of 2022 is still pending even in 2024," Vilakati said. The magistrate was referring to the case of three South African nationals Sicelo Msibi, Muziwandile Lukhele, Given Mavuso, and one Swati citizen, Lindani Zitha, who are facing 17 charges, including robbery, malicious damage to property, and kidnapping, among others.

These alleged acts by these men are said to have resulted in over E2 million stolen and malicious property damage. It's worth noting that the 17 charges also include the use of explosives to bomb the FNB ATM situated in the Mbabane Industrial Site, resulting in property damage amounting to E785 000. The accused were apprehended by the police on August 21, 2022.

The matter was supposed to resume last

Thursday, however, the only accused out on bail Zitha was not present in court and was charged with contempt of court. After he failed to appear in court Zitha made his appearance at the Mbabane Magistrate's Court on Friday, where he was formally charged with contempt of court.

Guilty

His charge sheet read that on January 11, 2024, at Mbabane Magistrate's Court in the Hhohho region, Zitha unlawfully and intentionally failed to appear before the Magistrate's court while warned to do so.

Zitha pleaded guilty to the charge, he was therefore found guilty as per his plea. In his mitigation statement, he asked the court to be lenient when handing down the sentence because he did not intentionally abscond the court. Stated that there was a miscommunication between him and his

lawyer," my lawyer and I had communicated that the trial would be resuming on January 15 so he did not know I have to be in court," Zitha said.

He was, therefore, sentenced to five months imprisonment or pay E500.

Explaining the delay, the defence council Sivesonke Ngwenya said the matter could not continue the past days because he also mixed-up dates and thought the matter would be before the court on January 15, He further apologised that the defence would not be able to continue even today since they are unprepared.

The crown counsellor also indicated that he is currently on leave and will be back in February. It is worth noting that the crown is still yet to parade more witnesses and the matter will return to court on February 6,

Man defrauds Build It

HAVE you ever thought of approaching a retail shop with a fake receipt and claiming a refund?

Well that was Banele Vilakati's grand plan which he used in his clandestine move of defrauding Build it E1 249.90.

According to the charge sheet, on December 23, 2023, while everyone was preparing for Christmas, the accused person concocted a plan of creating a fake receipt which he took to Build it, Mbabane, to make a refund claim of returned goods.

"The accused is charged with fraud, as he, on December, 2023 near Build It Plus, in Mbabane, unlawfully and intentionally misrepresented himself to Eugene Mayore who is an Assistant Manager by submitting a receipt claiming for a refund on returned goods and by means of the said misrepresentation induce the assistant manager to a loss of E1 249," the charge sheet reads.

False receipt

It was also detailed in the charge sheet that when the accused presented the false receipt, he knew that the goods were never returned to the shop.

Appearing before Magistrate Qondile Mtetwa, Vilakati conducted self-defense and pleaded guilty as charged. The crown presented that the accused had no previous conviction and was therefore found guilty as per his plea.

In his mitigation statement, he pleaded with the court to be lenient on him because it was his first time committing such an offence. May the court allow me to return the money to the shop and if I am to be held in custody no one would take care of my family" the accused said. He added that he has one child who is solely dependent on him.

Taking all that into consideration the court sentenced the accused to 10 months imprisonment or to pay a fine of E2 000. In 2021, the late National Commissioner of Police William Dlamini disclosed that Eswatini lost E55 million through fraud in the period spanning from October 2021 to September 2022, indicating a 0.5 per cent increase when compared to the previous year.

Man faces 12 months imprisonment for assaulting his brothers

AFTER pleading guilty to assaulting two of his brothers, Muzi Dlamini of Korinte was sentenced to 12 months in prison or pay a fine of E2 000.

The accused appeared before Magistrate Mtetwa and was charged with contravening Section 77(1)(a) of the Sexual and Offenses and Domestic Violence Act of 2018. According to the accused's charge sheet, he assaulted his brother Sipho* with a slasher and a pipe several times all over the body. Moreover, Dlamini also assaulted Lwazi* using the same weapons.

"On December 31, 2023, at Korinte in the Hhohho region, the accused wrongfully and unlawfully assaulted Sipho using a slasher and a pipe all over the body, several times" reads the charge sheet. The second count states that on January 11, 2024, at Korinte, Mbabane, the accused again wrongfully and unlawfully assaulted Lwazi with a slasher several times all over the body thus committing the offence of assault.

Dlamini pleaded guilty to both charges and in his mitigation statement, he informed the court that he could not afford to be jailed because he has dependents, his two brothers who were the complainants in the case.

In another separate case which was

tried in the same court by Magistrate Mthethwa, Zinhle Nkambule of Lobamba was charged with contravening the same Act. It is said that Nkambule damaged his ex-boyfriend's tyres worth E2 600.

Damage

"In that upon or at about, January 14, 2024, near Lobamba area in the district of Hhohho, the said accused person did wrongfully, unlawfully damage front and rear right tyres which are valued at E2 600.00 in the lawful possession of his ex-boyfriend with intent to injure the property and thus contravened

the said Act," the charge reads.

The accused pleaded guilty to the charge; she told the court that they previously argued with the ex-boyfriend which led her to damage the tyres.

She further apologised for her unlawful act, stating that she did not intend to commit the crime. She disclosed that she is unemployed and has four children that are dependent on her.

She was sentenced to 12 months imprisonment or pay a fine of E1 600.

Eswatini inks Bilateral Air Service Agreement with Ethiopia, Rwanda

THE Eswatini Government has signed a Bilateral Air Service Agreement (BASA) with the Governments of Ethiopia and Rwanda.

Ideally, the signing of this agreement is expected to enhance connectivity between these countries and facilitate the aviation sectors of these countries to realise and tap into the economic and social benefits.

This will also promote international air links between countries and enhance business and tourism opportunities through air transport.

The Minister of Public Works and Transport Chief Ndlaluhlaza Ndwandwe said the BASA is crucial as it establishes the legal framework for air services between the two countries.

He stated that it promotes international air connectivity, encourages tourism, fosters economic ties, and ensures regulatory coordination for safe and efficient air travel.

"BASAs also provide a foundation for airlines to operate routes, contributing to increased trade and cultural exchange between nations," said the minister.

Ndwandwe also explained that a BASA is the backbone on which air transport between two or more countries is coordinated, without which there would be no legal framework for operations. He said a BASA stipulates the conditions on which air operators from each country are to operate.

He added that the BASA which was signed on December 4, 2023, is what will then enable the airlines to form a partnership, Eswatini Air, Ethiopian Airlines and Rwandair.

Eswatini Air was recently launched in the country and not so long ago they welcomed an agreement with Zimbabwe allowing Eswatini Air to use their route and vice versa.

According to their website, they are the

national airline of the Kingdom of Eswatini and a strategic business unit within the Royal Eswatini National Airways Corporation's (RENAC) portfolio of aviation services.

"King Mswati III International Airport is the airline's hub and main base of operations. As a national airline, we represent the country's traditional values and we are committed to providing award-winning customer service," read the website.

The website stated that the airline takes over from where Royal Swazi Airways left off when it ceased operations in 1997 and will position itself as a niche carrier providing direct air linkages for passengers and cargo between Eswatini and other countries.

The initial set of destinations includes direct flights between Eswatini and Johannesburg, Durban, Cape Town, and Harare.

SA train smash: Eswatini Railways operations not affected

FOLLOWING a collision between two coal freight trains on Sunday which resulted in Transnet Freight Rail (TFR) closing the export coal line to Richard's Bay Eswatini Railways (ESR) has assured its customers that all is well on their side.

According to South African media reports, the crash followed a shift change, indicating a communication failure could be to blame. Transnet runs a manual train management system and cannot remotely track trains in real-time. The incident, which took place at Elubana in northern KwaZulu-Natal, followed two near-collisions in recent months at the same spot, where an oncoming train stopped just short of colliding with the train on the line.

Eswatini Railways (ESR) Corporate Communications Manager Sive Manana said they were aware of the accident, and that their trains have not been affected yet directly.

"Not many effects, but there are disturbances. But obviously resources in natal have been channelled to the accident which may disturb service a bit," he said.

He stated that they are still monitoring the

situation and react accordingly. He also urged customers not to panic and that all will be resolved soon.

TFR confirmed the incident on Monday and said recovery efforts were underway. The cause of the accident was being investigated, it said, and further details would be

communicated in due course. It did not confirm or deny the recent near collisions and said all such incidents were investigated as a matter of course.

News24 has further reported that the collision has again closed the export coal line to Richard's Bay in a setback to attempts by the government and businesses to restore SA's failing logistics sector.

TFR does not have a digitized train management system to track trains and relies on signalling and phone communication to

schedule trains and manage their movement. Signalling equipment is frequently stolen, making phone communication between the train control operator and driver the only way of avoiding collisions.

Initial and unconfirmed reports from inside Transnet indicate that Sunday's accident resulted from human error when a shift change failed to alert the incoming shift of a stopped train on the line. The train had stopped because of a power outage in Richard's Bay on the line ahead.

Shell to exit Nigeria's troubled onshore oil after nearly a century

LONDON — Shell is set to conclude nearly a century of operations in Nigerian onshore oil and gas after agreeing to sell its subsidiary there to a consortium of five mostly local companies for up to \$2.4 billion.

The British energy giant pioneered Nigeria's oil and gas business beginning in the 1930s. It has struggled for years with hundreds of onshore oil spills as a result of theft, sabotage and operational issues that led to costly repairs and high-profile

Since 2021, Shell has sought to sell its Nigerian oil and gas business, but will remain active in Nigeria's more lucrative and less problematic offshore sector.

Shell's exit is part of a broader retreat by western energy companies from Nigeria as they focus on newer, more profitable operations. Exxon Mobil, Italy's Eni and Norway's Equinor have struck deals to sell assets in the country in recent years.

The British major will sell The Shell Petroleum Development Company of Nigeria Limited (SPDC) for a consideration of \$1.3 billion, it said in a statement, while the buyers will make an additional payment of up to \$1.1 billion relating to prior receivables

"This agreement marks an important milestone for Shell in Nigeria, aligning with our previously announced intent to exit onshore oil production in the Niger Delta, simplifying our portfolio and focusing future disciplined investment in Nigeria on our Deepwater and Integrated Gas positions," Shell head of upstream Zoë Yujnovich said.

The buyer, the Renaissance consortium comprises ND Western, Aradel Energy, First

E&P, Waltersmith, all local oil exploration and production companies, and Petrolin, a Swiss-based trading and investment

The sale, which Renaissance confirmed, requires the approval of the Nigerian

Spills and lawsuits

Renaissance will take over responsibility for dealing with spills, theft and sabotage, said Shell, which has faced in recent years multiple lawsuits for compensation over damage caused as a result of spills in the Niger delta.

Nnimmo Bassey, Executive Director of Nigerian advocacy group Health of Mother Earth Foundation said: "Shell must own up to its responsibility."

"This means full payment for the remediation and restoration of the polluted areas as well as reparations to the host communities. They cannot walk away from the virtually irreparable harm they have caused," Bassey said in a statement.

Shell's SPDC Limited operates and has a 30 per cent stake in the SPDC joint venture that holds 18 onshore and shallow water mining leases. Shell's resources in SPDC reached around 458 million barrels of oil equivalent by the end of 2022.

Other partners in the joint venture are the state's Nigerian National Petroleum Corporation (NNPC), which holds 55 per cent, TotalEnergies, with 10 per cent and Italy's Eni with 5 per cent.

Apart from its operations and stakes in several fields deep offshore, Shell still has a liquefied natural gas plant and other assets in Nigeria.

SPDC, which remains the operator, was formed in 1979, incorporating assets of the older Shell-BP consortium, with its current partners entering at later stages. (Reuters)

Transnet works to clear coal export line after train crash

SOUTH Africa's Transnet is working to clear the country's main coal export railway line after two trains collided on Sunday, the firm said on Tuesday, without saying when services would be

Transnet said no serious injuries were reported after the accident, but the disruption to South Africa's major coal export terminal at Richards Bay will throttle mineral shipments already constrained by locomotive shortages as well as rampant cable theft and vandalism of infrastructure.

The state-owned firm in an emailed response to Reuters did not provide details of what caused the accident and when service would be restored on the coal line.

Major coal exporters Thungela Resources and Exxaro Resources did not immediately respond to queries about how the derailment was affecting haulage to port. Glencore, another major coal exporter from South Africa, declined to comment.

Transnet has struggled for years to haul commodities to ports due to equipment shortages and maintenance backlogs after decades of under-investment.

This has forced companies such as Thungela and Africa's biggest iron ore exporter Kumba Iron Ore to cut production due to limited capacity to transport commodities via rail to port.

Some miners have been moving coal to port by road, a more expensive and environmentally damaging option than rail, but Transnet - which also operates South Africa's ports - in November announced curbs on trucks going into the Richards Bay port, citing "unprecedented congestion" on the coastal town's roads. South African rand weakens as Red Sea tensions push dollar up

JOHANNESBURG — South Africa's overwhelming win in the Iowa caucus has rand weakened early on Tuesday as more attacks on ships in the Red Sea weighed on risk sentiment and hawkish comments from the World Economic Forum pushed the dollar higher, analysts said.

At 0718 GMT, the rand traded at 18.8350 against the U.S. dollar, about 0.8 per cent weaker than its previous close.

The dollar was last up about 0.3 per cent against a basket of global currencies.

"News of a missile strike on a US-owned ship in the Gulf and Donald Trump's seen risk-off in markets and a stronger dollar," Andre Cilliers, Currency Strategist at TreasuryONE, said.

Hawkish comments from European Central Bank officials in Davos also spurred investors to pare back bets on near-term rate-cuts by the U.S. Federal Reserve, further boosting the dollar.

There were no economic data releases scheduled in South Africa on Tuesday.

South Africa's benchmark government bond was weaker in early deals, with the yield up 4.5 basis points to 9.770 per cent. (Reuters)

Margherita Della Valle, Vodafone Group chief executive, said: "This unique strategic partnership with Microsoft will accelerate the digital transformation of our business customers, particularly small and medium-sized companies, and step up the quality of customer experience for consumers."

The alliance aims to overhaul Vodafone's customer experience, develop digital and financial services for businesses, and revamp the company's global data center cloud strategy.

Vodafone also hopes to expand its platform, ultimately connecting more devices, vehicles, and machines.

Microsoft CEO Satya Nadella added: "This new generation of AI will unlock massive new opportunities for every organization and every industry around the world."

Five key areas of collaboration have been identified by the companies, beginning with Vodafone's digital assistant, TOBi, which is set to be supercharged by generative AI powered by Microsoft Azure OpenAI.

Tighter connections will also be forged between Vodafone and Microsoft in terms of IoT, and Vodafone has shared plans to modernize its data centers on Microsoft Azure.

Moreover, the two tech titans hope to help SMEs that use their services to grow, with a particular focus on the African continent where digital literacy, upskilling, and youth outreach programs are set to be deployed.

Synopsys to buy engineering Ansys in \$35 billion deal

SEMICONDUCTOR design software firm Synopsys on Tuesday announced it would acquire Ansys, an engineering and product design software firm, in a cash-and-stock deal valued at approximately \$35 billion.

The acquisition is one of the largest tech deals announced in recent years.

Synopsys will pay consideration of roughly \$390 per share: \$197 per share in cash and roughly one-third of a Synopsys share for each Ansys share. The deal is expected to close in the first half of 2025, pending regulatory and shareholder approval.

Synopsys shares were up 3% on Tuesday morning, after a 12% slump since The Wall Street Journal reported in December that the two companies were in advanced talks. Ansys shares slipped 4% but were up more than 14% in that same period since

Ansys shareholders will own 16.5% of Synopsys following the merger, Synopsys

CEO Sassine Ghazi said during a conference call following the announcement. The deal will be partially funded by \$16 billion of debt financing, Synopsys said in a release. The remaining \$3 billion non-equity consideration will come from Synopsys' cash. For the quarter ended October 31, 2023, Synopsys reported cash and cash equivalents of \$1.4 billion.

The deal will not immediately be accretive until at least a year after the deal closes, Synopsys CFO Shelagh Glaser said.

"This is the logical next step for our successful, seven-year partnership with Ansys and I look forward to working closely with Ajei and the talented Ansys team to realize the benefits of this combination our customers, shareholders and employees," Ghazi said in a release.

Several deals have closed in recent months, including Microsoft's acquisition of Activision Blizzard and Broadcom's acquisition of VMware. (Reuters)

Musk wants 25% voting control at Tesla

TESLA and SpaceX CEO Elon Musk, who also owns the social network X (formerly known as Twitter), said Monday that he wants about 25% of voting control over his electric vehicle business.

Musk already owns around 13% of Tesla, or approximately 411 million shares of the company's 3.19 billion shares in common stock outstanding, as reported in the company's last financial filing for the third quarter of

That's a large stake, especially considering that Musk sold tens of billions of dollars worth of his shares in Tesla in 2022, largely to finance a \$44 billion leveraged buyout of

Now, Musk is angling for even more control over Tesla.

Specifically, Musk wrote on Monday, "I am uncomfortable growing Tesla to be a leader in AI & robotics without having ~25% voting control. Enough to be influential, but not so much that I can't be overturned."

"Unless that is the case, I would prefer to build products outside of Tesla," the billionaire executive said on X.

"You don't seem to understand that Tesla is not one startup, but a dozen. Simply look at the delta between what Tesla does and GM. As for stock ownership itself being enough motivation, Fidelity and other own similar stakes to me. Why don't they show up for work?"

Tesla did not immediately respond to a request for comment.

Musk's post stood at odds with remarks he previously made suggesting Tesla is already an important artificial intelligence and robotics company, and its value hinges on its prowess in these domains.

In April 2022, Musk predicted during Tesla's first-quarter earnings call that the company's humanoid robot, Optimus, "ultimately will be worth more than the car business and worth more than full self-driving."

Tesla unveiled an early Optimus prototype at Tesla AI Day in September that year, and Musk said in a post around that event, "The point of AI Day is to show the immense depth & breadth of Tesla in AI, compute hardware & robotics."

Kenya seeks rapid resolution with Tanzania after announced flight ban



"You should also remember that he tried his best to run to become a national deputy federal chairperson in 2010, but he failed to convince delegates to vote for him."

Another insider said Ramulifho's other attempt was in 2018 when he wanted to be the deputy chairperson of the federal council and interim federal chairperson, a position that was left vacant by Athol Trollip, who joined ActionSA, but he lost to Ivan Meyer.

Turkish court fines Somali leader's son over fatal car crash

THE son of Somalia's president was sentenced by a Turkish court on Tuesday to 2-1/2 years in prison for causing death by negligence, which was converted into a fine of 27,300 Turkish lira (\$900), state media reported.

Mohamed Hassan Sheikh Mahmoud was driving a car carrying a diplomatic licence plate on Nov. 30 when he hit a motorcycle courier in central Istanbul, seriously injuring him.

He had left the country on Dec. 2, following a police interrogation. An arrest warrant was issued for him after the courier died in hospital on Dec. 6. Mahmoud was tried in absentia in Istanbul on Tuesday, having been back to Turkey to appear before the court last week. He had denied negligence, saying the motorbike had stopped suddenly and he could not avoid the collision.

The prosecutor had sought up to six years in prison for Mahmoud. Converting prison sentences to fines happens periodically in the Turkish judicial system. His driving licence in Turkey was revoked for six months.

British PM Sunak faces major rebellion over Rwanda legislation

LONDON - British Prime Minister Rishi Sunak is facing a major rebellion from rightwing politicians in his party on Tuesday over flagship immigration legislation to speed up the deportation of asylum seekers to Rwanda in a critical test of his authority.

Two Conservative Party chairmen said they were ready to defy Sunak to join the rebellion by voting to toughen the legislation before parliamentary votes on the plan on Tuesday and Wednesday.

Sunak's party is deeply divided over the bill, which aims to block asylum seekers bringing further court challenges against their deportations. Some Conservative lawmakers say it goes too far and others that it does not go far

Unless the legislation is changed, some Conservatives are threatening to vote against the government at its final parliamentary stage in the House of Commons, the lower house of parliament, which could take place on Wednesday evening.

One senior lawmaker said the rebels had the numbers to defeat Sunak in the final vote.

"There is zero purpose in putting in place a piece of legislation that doesn't work," he said, adding that the rebels only needed half of those who backed the amendments to defeat the government in the final vote.

Sunak has made stopping the arrival of asylum seekers crossing from France to Britain on small boats a central aim of his govern-

Fleeing

Most of those arriving in the boats say they are fleeing wars and poverty in the Middle East, Africa and South Asia. However, the British government says about 90% making the journey are men and many of them economic migrants rather than genuine refugees.

"DIVIDED PARTIES FAIL"

Sunak faced the most serious threat to his leadership last month when he saw off a threatened revolt by dozens of his lawmakers at the first parliamentary vote on the draft legislation.

The government comfortably won that vote after some lawmakers decided to abstain rather than rebel, but some warned that they could vote down the legislation at later stages of the parliamentary process unless the bill was changed.

More than 60 Conservative members of parliament are planning to back the amendments that would allow ministers to ignore last-minute rulings from judges at the European Court of Human Rights in Strasbourg seeking to ground flights to Rwanda.

Amendment

A similar number also support another amendment that would stop asylum seekers from bringing individual claims to prevent their removal to the East African nation.

Isaac Levido, the Conservative Party's election strategist, told lawmakers at a closed-doors meeting late on Monday that the party faced defeat at this year's national election unless they ended their infighting.

"Let me clear. Divided parties fail," Levido said, according to a Conservative official.

Conservative Party ty Chairmen Lee Anderson and Brendan Clarke-Smith said they would vote to toughen the legislation. Asked if this means he would be sacked, Brendan Clarke-Smith said: "It is not for me to decide."

Global tobacco use tumbles despite industry lobbying

GENEVA - Global tobacco use has tumbled in a generation with one in five people smoking versus one in three in 2000, the World Health Organization said on Tuesday.

The drop comes despite what the U.N. global health agency said were ongoing efforts by Big Tobacco to seek to influence global health policies to its own advantage.

"Good progress has been made in tobacco control in recent years, but there is no time for complacency," said Dr Ruediger Krech, Director of the WHO Department of Health Promotion. "I'm astounded at the depths the tobacco



global report said 1.25 billion people aged 15 or over used tobacco in 2022 versus 1.36 billion in 2000. Tobacco use is set to fall further by 2030 to around 1.2 billion people even as the world's population grows, the study said.

One example of tobacco companies' efforts to win influence cited by the WHO was their offers of technical and financial support to countries ahead of a major WHO meeting on tobacco control in Panama in February.

The regions with the biggest portion of smokers are Southeast Asia and Europe, the WHO said, with roughly a quarter of the population. In a handful of



HIGH cholesterol rarely causes symptoms, so it's important to have routine cholesterol screenings if you're at risk.

High cholesterol is a pretty common issue in the U.S. In fact, according to the Centers for Disease Control and Prevention (CDC), nearly 94 million U.S. adults ages 20 or older have what could be considered borderline high cholesterol.

However, because this condition can often present without any real symptoms, you may not even know you have it until you visit your doctor.

If you're wondering what causes high cholesterol, what to do if you've been diagnosed with it, and if there are ways to reverse it (hint: there are), read on for all the answers.

WHAT IS CHOLESTEROL?

Cholesterol is a type of lipid. It's a waxy, fat-like substance that your liver produces naturally. It's vital for the formation of cell membranes, certain hormones, and vitamin D.

Cholesterol doesn't dissolve in water, so it can't travel through your blood on its own. To help transport cholesterol, your liver produces lipoproteins.

Lipoproteins are particles made from fat and protein. They carry cholesterol and triglycerides, another type of lipid, through your bloodstream. The two major forms of lipoprotein are low-density lipoprotein (LDL) and high-density lipoprotein (HDL).

LDL cholesterol is any cholesterol carried by low-density lipoproteins. If your blood contains too much LDL cholesterol, you may be diagnosed with high cholesterol. Without treatment, high cholesterol may lead to many health issues, including heart attack and stroke.

High cholesterol rarely causes symptoms in the beginning. That's why it's important to get your cholesterol levels checked on a regular basis.

HIGH CHOLESTEROL SYMPTOMS

In most cases, high cholesterol is a "silent" condition. It typically doesn't cause any symptoms. Many people don't even realize they have high cholesterol until they develop serious complications, such as a heart attack or stroke.

That's why routine cholesterol screening is important. If you're 20 years or older, ask your doctor if you should have routine cholesterol screening. Learn how this screening could potentially save your life.

Causes of high cholesterol

Eating too many foods that are high in cholesterol, saturated fats, and trans fats may increase your risk of developing high cholesterol. Living with obesity can also increase your risk. Other lifestyle factors that can contribute to high cholesterol include inactivity and smoking.

Your genetics can also affect your chances of developing high cholesterol. Genes are passed down from parents to children. Certain genes instruct your body on how to process cholesterol and fats. If your parents have high cholesterol, you may be at a greater risk of having it too.

In rare cases, high cholesterol is caused by familial hypercholesterolemia. This genetic disorder prevents your body from removing LDL. According to the National Human Genome Research Institute, most adults with this condition have total cholesterol levels above 300 milligrams per deciliter and LDL levels above 200 milligrams per deciliter.

Other health conditions, such as diabetes and hypothyroidism, may also increase your risk of developing high cholesterol and related complications.

LDL CHOLESTEROL, OR "BAD CHOLESTEROL"

LDL cholesterol is often called "bad cholesterol." It carries cholesterol to your arteries. If your levels of LDL cholesterol are too high, it can build up on the walls of your arteries. This build-up is also known as cholesterol plaque. This plaque can narrow your arteries, limit your blood flow, and raise your risk of blood clots. If a blood clot blocks an artery in your heart or brain, it can cause a heart attack or stroke.

HDL CHOLESTEROL, OR "GOOD CHOLESTEROL"

HDL cholesterol is sometimes called "good cholesterol." It helps return LDL cholesterol to your liver to be removed from your body. This helps prevent cholesterol plaque from building up in your arteries. When you have healthy levels of HDL cholesterol, it can help lower your risk of blood clots, heart disease, and stroke.

TRIGLYCERIDES, A DIFFERENT TYPE OF LIPID

Triglycerides are another type of lipid. They're different from cholesterol. While your body uses cholesterol to build cells and certain hormones, it uses triglycerides as a source of energy. When you eat more calories than your body can use right away, it converts those calories into triglycerides. It stores triglycerides in your fat cells. It also uses lipoproteins to circulate triglycerides through your bloodstream.

If you regularly eat more calories than your

body can use, your triglyceride levels may become too high. This can raise your risk of several health problems, including heart disease and stroke.

Your doctor can use a simple blood test to measure your triglyceride level, as well as your cholesterol levels.

GETTING YOUR CHOLESTEROL LEVELS CHECKED

If you're 20 years or older, the American Heart Association recommends getting your cholesterol levels checked at least once every 4 to 6 years. If you have a history of high cholesterol or other risk factors for cardiovascular disease, your doctor may encourage you to get your cholesterol levels tested more often. Your doctor can use a lipid panel to measure your total cholesterol level, as well your LDL cholesterol, HDL cholesterol, and triglyceride levels. Your total cholesterol level is the overall amount of cholesterol in your blood. It includes LDL and HDL cholesterol. If your levels of total cholesterol or LDL cholesterol are too high, your doctor may diagnose you with high cholesterol. High cholesterol can be dangerous when your LDL levels are too high and your HDL levels are too

CHOLESTEROL LEVELS CHART

Being diagnosed with high cholesterol doesn't automatically mean you will be put on medication. If your doctor does prescribe you medication, different factors may influence the type of medication they recommend.

With this in mind, most physicians use generalized measurements to decide on

treatment plans. They may categorize these measurements as desirable, borderline high, or high cholesterol. According to the National Library of Medicine, the total cholesterol of most adults can be categorized as:

Total cholesterol less than 200 mg/dL 200-239 mg/dL 240 mg/dL and above Category desirable borderline high high

The National Library of Medicine also provides optimal to high categories of LDL ("bad") cholesterol levels:

LDL ("bad") cholesterol levels less than 100 mg/dL

100-129 mg/dL 130-159 mg/dL 160-189 mg/dL 190 mg/dL and above optimal near optimal borderline high high very high

Again, these measurements are general. You and your doctor will consider other personal factors before deciding on a treatment plan.

RECENT GUIDELINES FOR HEALTHY CHOLESTEROL LEVELS

Your body needs some cholesterol to function properly, including some LDL. But if your LDL levels are too high, it can raise your risk of serious health problems. In 2018, the American College of Cardiologists and the American Heart Association updated their recommendations for the treatment of high cholesterol. Under the new guidelines, in addition to your cholesterol levels, treatment recommendations analyze other risk factors for heart disease, such as family history and

other health issues. The guidelines use all these factors to consider a person's overall chance of developing complications during the next 10

RISK FACTORS FOR HIGH CHOLESTEROL

You may be at a higher risk of developing high cholesterol if you:

- are living with obesity
- consume a lot of saturated and trans fats, like those found in fast food
 - ► have limited physical activity
 - smoke tobacco products
 - have a family history of high cholesterol
- have diabetes, kidney disease, or hypothyroidism.

People of all ages, genders, and ethnicities can have high cholesterol.

COMPLICATIONS OF HIGH CHOLESTEROL

Without treatment, high cholesterol can cause plaque to build up in your arteries. Over time, this plaque can narrow your arteries. This condition is known as atherosclerosis.

Atherosclerosis is a serious condition. It can limit the flow of blood through your arteries. It also raises your risk of developing dangerous blood clots.

Atherosclerosis can result in many life threatening complications, such as:

- ▶ stroke
- ▶ heart attack
- angina, or chest pain
- high blood pressure
- peripheral vascular disease
- chronic kidney disease

High cholesterol can also create a bile imbalance, raising your risk of gallstones.

HOW TO LOWER CHOLESTEROL

If you have high cholesterol, your doctor may recommend lifestyle changes to help lower it. For instance, they may recommend changes to your diet, exercise habits, or other aspects of your daily routine. If you smoke, they will likely advise you to quit. Your doctor may also prescribe medications or other treatments to help lower your cholesterol levels. In some cases, they may refer you to a specialist for more

LOWERING CHOLESTEROL THROUGH DIET

To help you achieve and maintain healthy cholesterol levels, your doctor may recommend changes to your diet.

For example, they may advise you to:

- limit your intake of foods that are high in cholesterol, saturated fats, and trans fats
- b choose lean sources of protein, such as chicken, fish, and legumes
- eat a wide variety of high fiber foods, such as fruits, vegetables, and whole grains
- opt for baked, broiled, steamed, grilled, and roasted foods instead of fried foods avoid fast food and sugary, pre-packaged
- options when possible

Foods that are high in cholesterol, saturated fats, or trans fats include:

- red meat, organ meats, egg yolks, and high fat dairy products processed foods made with cocoa butter
- or palm oil deep-fried foods, such as potato chips,
- onion rings, and fried chicken certain baked goods, such as some cookies
- and muffins. Eating fish and other foods that contain omega-3 fatty acids may also help lower your LDL levels. For example, salmon, mackerel, and

herring are rich sources of omega-3s. Walnuts, almonds, ground flaxseeds, and avocados also contain omega-3s. Healthline

WHEN under stress, the body releases hormones that can cause blood glucose levels to increase.

HOW CAN DIFFERENT TYPES OF STRESS AFFECT YOUR DIABETES?

Stress can affect people differently. The type of stress that you experience can also have an impact on your body's physical response.

When people with type 2 diabetes are under mental stress, they generally experience an increase in their blood glucose levels. People with type 1 diabetes may have a more varied response. This means that they can experience either an increase or a decrease in their blood glucose levels.

When you're under physical stress, your blood sugar can also increase. This can happen due to sickness or injury. This can affect people with type 1 or type 2 diabetes.

HOW CAN YOU DETERMINE IF MENTAL STRESS IS AFFECTING YOUR GLUCOSE LEVELS?

track of additional Keeping information, such as the date and what you were doing when stressed, may help you determine specific triggers.

For example, do you always experience stress on Monday mornings? If so, you know how to take special steps on Monday mornings to lower your stress and keep your glucose in check.

You can determine if this is happening to you by capturing your stress and glucose levels.

After rating your stress, you should check your glucose levels. Continue doing this for the next couple of weeks. Before long, you may see a pattern emerge.

If you notice that your glucose is regularly high, your mental stress is likely negatively affecting your blood sugar.


WHAT ARE THE SYMPTOMS OF STRESS?

Sometimes, the symptoms of stress are subtle, and you may not notice them. Stress can affect your mental and emotional well-being and impact your physical health. Recognizing the symptoms can help you identify stress and take steps to manage it.

Physical symptoms of stress include:

- headaches
- muscle pain or tension sleeping too much or too little
- general feelings of illness
- fatigue

▶ Therapy

You may feel more comfortable talking with a professional about your stress. A therapist can provide coping mechanisms tailored to your situation and give you a safe environment to talk. They may also provide medical advice that online or in-person support groups can't offer.

WHAT YOU CAN DO NOW

Although diabetes can present a different set of challenges, it's possible to manage it effectively and lead a happy, healthy lifestyle. You can add short, meditative sessions or small workouts to your daily routine. You can also look into support groups and find one that best suits your personality and lifestyle needs. Being proactive can help ease the tension in your life.

SUMMARY

Physical and mental stress can trigger the release of adrenaline and cortisol into the blood. These hormones can cause blood glucose levels to rise. Unexpected peaks in blood glucose levels may negatively impact a person's diabetes management and lead to adverse symptoms. Roma sack Jose Mourinho appoint De Rossi as manager

AS Roma named their former player Daniele De Rossi as their new manager until the end of the season, hours after parting ways with manager Jose Mourinho on Tuesday.

Mourinho was sacked earlier in the day with Roma ninth in the league after Sunday's 3-1 loss to AC Milan, and have struggled to overcome the loss of key players due to injury, including striker Paulo Dybala.

They are 22 points behind league leaders Inter Milan.

"AS Roma are pleased to confirm that Daniele De Rossi has been appointed as head coach until 30 June 2024," the Serie A club said in a statement.

"After an 18-year playing career with AS Roma, De Rossi will return home as head coach, with his first game being the club's upcoming Serie A match against Verona on Saturday evening at the Stadio Olimpico."

Roma have taken just four points from their last five league matches, and were eliminated from the Coppa Italia last week in a 1-0 defeat to rivals Lazio.

Following that defeat, Mourinho had likened himself to fictional wizard Harry Potter, saying his position at the club was raising fans' expectations for success.

He also hit back at critics, labelling himself as the perfect example of professionalism despite his team suffering recent poor results.



AS Roma named their former player Daniele De Rossi as their new manager until the end of the season, hours after parting ways with manager Jose Mourinho on Tuesdav.

"We would like to thank Jose on behalf of all of us at AS Roma for his passion and efforts since his arrival at the club," club owners Dan and Ryan Friedkin said in an earlier statement.

"We will always have great memories of his tenure at Roma, but we believe that an immediate change is in the best interests of the club.

"We wish Jose and his assistants all the best in their future endeavours."

Mourinho, who has coached a

host of top European clubs including Porto, Chelsea, Inter Milan, Real Madrid and Manchester United, was appointed coach of Roma in 2021.

Under the Portuguese manager, Roma won the third-tier Europa Conference League in 2022. He also led them to the Europa League final in 2023, where they were beaten on penalties by Sevilla.

Roma next host 18th-placed Verona on Saturday.

Joshua stopped Otto Wallin on the same card and organisers were determined to find a bout for the 34-year-old on the same weekend which the Wilder showdown had been pencilled in for.

Joshua versus Ngannou will take place on a Friday to avoid a clash with Formula 1's Saudi Arabian Grand Prix, which is due to be held in Jeddah on Saturday 9th March.

Captain Youssef Msakni tested Lloyd Kazapua with a curled effort but the Tunisians grew frustrated as the game wore on. Yet while the Brave Warriors lacked attacking spark, their tireless industry and organisation kept a star-studded Tunisia at bay.

As a famous upset loomed ever larger, the minnows delivered a hamblow in the 89th minute. Deon Hotto latched onto a long ball over the top and outpaced the defence before coolly slotting past Bechir Ben Said.

The Orlando Pirates winger thought he had doubled the lead when the offside flag denied him another historic strike. But one goal proved enough as Namibia's warriors held on for the clean sheet to claim a monumental three points.

Few observers gave the southern underdogs hope before the tournament began but now sides in the tournament will give them serious attention thanks to the massive shock on Tuesday. But this shock victory over one of Africa's giants has given them a good chance of progressing from Group E. Namibia tops Group E with 3 points as South Africa prepare to play Mali in the group's other game on the day.

The Carthage will have to recover against Mali on January 20 while Namibia come up against regional foes South Africa on January 21.

The majority of the Super Stars players in the world who captained their national teams voted for Messi. They include Egypt's Mohamed Salah, England's Harry Kane, Scotland's Andy Robertson and Croatia's Luka Modric among others.

PLE U-19 league will be a single-leg

THE Under-19 Premier League of Eswatini (PLE) that commences on Wednesday will be played as a single-leg league. The development league was won by Royal Leopard last season, and they will start their campaign of defending the title against Nsingizini Hotspurs at King Sobhuza II Memorial Stadium, kick-off at 2 pm.

14 teams are campaigning in the league, and they are those from the MTN Premier League.

According to the rules and regulations, each under-19 team may utilize up to a maximum of three of its senior team players who are 21 years or younger and five players registered with the under-15 team.

Points

"Any Club fielding more than 3 over-aged players shall be liable to lose the points amassed in the games in which the player featured which points shall be awarded to their opponents. A player from the senior team eligible, under such a provision, shall be allowed up to a maximum of two consecutive matches, provided they do not play for their senior team in between one and the next match of the under-19 team. A senior team player who plays more than two consecutive games is a defaulter," reads article 2.4.2 of the rules and regulations.


