

CABINET RETREAT:

Govt prioritizes service delivery, economic growth and wellbeing

EMERGING from a productive and insightful retreat, the Eswatini government has laid out a clear roadmap for the nation's future, prioritizing service delivery, economic growth, and the well-being of emaSwati. Prime Minister Russell Mmiso, addressed the nation and shared details of the retreat held since Sunday, where Cabinet Ministers, Principal Secretaries, and government officials gathered to chart a course for a brighter Kingdom.

Service delivery at the forefrontThe retreat placed service delivery

at the heart of the government's agenda. Recognizing the importance of responsiveness to the needs of the people, the government pledged to prioritize all Sibaya submissions. These submissions, a cornerstone of the Tinkhundla system of governance, have served as a direct channel for emaSwati where they shared their concerns and aspirations for the Kingdom. His Majesty King Mswati III further declared and adopted the submissions as guideline policy which the

government has said will be a priority as they execute their duties. Prime Minister expressed that the government, addressing these submissions effectively will ensure that government services reach the people. "Our retreat focused on how we can grow the economy and improve the lives of emaSwati," said the Prime Minister "We based much of what we discussed on the submissions made by emaSwati at Sibaya. Cabinet agreed that we must develop and implement ambitious plans that should be implemented aggressively to grow the economy"

Boosting the Economy

Economic growth received significant attention during the retreat. Development partners, acknowledging the Kingdom's steady but sluggish economic progress, encouraged the government to develop ambitious plans and implement them with urgency. The government, receptive to this advice, vowed to focus on fostering

an environment conducive to investment and job creation. This renewed focus on economic growth promises a brighter future for emaSwati.

Performance Management for botton results

To ensure that government officials and civil servants deliver on their duties, the Prime Minister said

that on the retreat, there were discussions on the importance of robust performance management systems (PMS). The existing PMS strategy, designed by the previous government, will be fully implemented and further refined to ensure accountability and efficiency.

Decentralization

Decentralization emerged as a key strategy for bringing government closer to the people. Leveraging the Tinkhundla system, the government aims to ensure that services reach communities and constituencies effectively. This decentralized approach promises to enhance responsiveness to local needs and empower communities to participate in shaping their development.

Investing in Education

Recognizing the crucial role of education in shaping the future, the government highlighted the need for improvements in the education sector. Development partners pledged their support in this endeavour, aiming to equip young emaSwati with the skills and knowledge needed to thrive in a rapidly changing world.

Sustainable Energy

Prime Minister Russell Dlamini also shared that on the retreat, the government also addressed the critical issue of energy. The government acknowledged the need to streamline processes and engage with the Eswatini Electricity Company (EEC) to develop sustainable energy solutions and ensure reliable electricity generation.

Call to unity

The Premier further issued a heartfelt plea to the nation, urging all emaSwati to join hands in the collective endeavour to develop the country. Again, the Premier said that in due course, the government will share the full Government working programme which will be an outcome of the retreat.

Govt vows to aggressively fight corruption

IN a resolute stand against corruption, the government has pledged to plug the leaks and hold perpetrators accountable. Emerging from a productive cabinet retreat, Prime Minister Russell Mmiso Dlamini declared a zero-tolerance policy on graft, vowing to close the "tap" where public funds are siphoned off and ensure that "those who are found guilty of such are persecuted by the law."

Dlamini said that the government has discussed strategies on how it will deal with corruption by identifying and closing loopholes within existing systems that allow for the misappropriation of public funds.

World Bank, UN pledge support in education, health

Prime Minister Russell Dlamini announced a crucial commitment during his address to the nation following the Cabinet retreat. He expressed that during the retreat, the Development partners, recognizing the critical role of education in shaping the Kingdom's trajectory, have pledged their support for its growth and modernization. Such was delivered by representatives of the organisations which includes United Nations Resident George Wachira who further also made emphasis on helping the country on health. Apart from the United Nations, also the World Bank pledged to support the country.

SOS Children's Village, a haven for vulnerable children in the Kingdom, is seeking E2.7 million to continue its vital work.

Temalangeni Dlamini, the organisation's Communication Coordinator, announced the 'One Lilangeni' campaign, a call to action for the community to join hands in protecting and empowering children.

Dlamini said that previously, SOS Eswatini relied solely on funding from SOS Children's Villages International. However, due to global challenges like the Covid-19 pandemic, this support has decreased and now they can no longer solely depend on this funding to meet the needs of the children.

Dlamini said that SOS Children's Village provides a home and comprehensive care for 288 children in its villages. Additionally, it supports the well-being and education of 3,180 children within their communities. Their services range from providing daily necessities to ensuring access to education.

Dlamini urged individuals and organisations to join the 'One Lilangeni' campaign. "A small donation of E1 a day, E30 a month, can make a significant difference," she emphasised. "Every Lilangeni helps us provide food, shelter, education, and hope to these vulnerable children."

The appeal extends beyond just financial support. Dlamini encouraged religious entities, NGOs, and companies to consider donating essential materials like stationery, clothing, and hygiene products. These seemingly small contributions can have a major impact on the daily lives of the children.

Former Anglican Church Arch Deacon Reverend Bhekindlela Magongo dies

FORMER Chairperson the Council of Churches and Eswatini Anglican Arch Deacon Reverend Bhekindlela Magongo has died in a tragic car accident on Tuesday night near KaMahhala, Matsapha.

Sicelo Dlamini, spokesperson for the church, confirmed the news, stating that they received the devastating news and have since reached out to Reverend Magongo's family. Dlamini shared that due to the family's ongoing discussions, further details surrounding the accident and funeral arrangements will be communicated.

Reverend Sicelo Dlamini expressed that the Anglican Church and the wider community mourn the loss of Reverend Magongo, offering their heartfelt condolences to his family and loved ones during this difficult time.

His death was also confirmed by

the Council of Churches' Secretary General, Bishop Zwanini Shabalala who said they were still tonguetied over the sad news of Reverend Magongo's passing on.

"We were told that he died at around 10 pm on Tuesday when his car was involved in an accident," Bishop Shabalala said.

Magongo once served as the Youth Chaplain for Anglican Youth and the Chairperson of the Eswatini Council of Churches.

Served

Ndumiso Myeni a member of the Anglican Church said that Magongo served the church diligently, leaving a lasting impression on countless individuals with his dedication to his faith and community. "We are very saddened by his passing, he will be remembered for his passion, leadership, and unwavering commitment to God and the church," Myeni commented.

A member of the family who preferred to be only identified as Lilunga lemndeni lelincane (a young member of the family) also confirmed the tragic passing of Magongo.

"We are still shocked at the passing of our brother, and we will soon furnish you with details during the week," the member of the family

Deputy Police Public Information Communication Officer (PICO) Superintendent Nosipho Mnguni also confirmed the accident, which occurred approximately on Tuesday night.

Serious injuries

"On Tuesday around 8:10 pm at Galp/Breweries off-ramp towards Mahhala, Matsapha along MR3, a Kia sedan driven by a 49-year-old man of Mbabane lost control and knocked on the median concrete wall. The driver sustained serious injuries and was certified dead upon arrival at RFM Hospital. Three passengers sustained serious injuries, and they were treated and admitted at RFM Hospital. The three passengers include a 31-year-old man from Lobamba, a 35-year-old woman from Mvutjini and a 36-year-old woman from Matsapha," Superintendent Mnguni said in a statement.

Manzini Municipality closes Ngwane Park Cemetery

THE Manzini Municipality Council has relocated its burial services to a new multi-cultural cemetery at the new Golf Course Cemetery Extension.

Municipality Spokesperson Mathokoza Thwala said this has been necessitated by the Ngwane Park Cemetery reaching its full capacity.

He said the reaching of full capacity was exacerbated by a sharp rise in the demand for burial space during the Covid-19 pan-

Thwala stated that the Municipality has made necessary arrangements to open a new cemetery to accommodate the burial needs of the city's residents with the new Golf Course Cemetery Extension, whose capacity is over 8 200 graves. It is located on the remainder of 1231, below the municipal pound facility.

Relocation

He stated that the relocation of the cemetery comes with several changes, which is to ensure the longevity of the cemetery and prioritise the burial needs of their residents, hence, the Council has decided to restrict burial rights to city residents only.

He explained that proof of residence for a minimum period of six months will be required and in addition to the usual documentation such as a death certificate, national ID of both the applicant for burial space and the deceased, proof of the applicant's relationship with the deceased as well as proof of payment for burial space.

"For the burial of property owners' children, we will require the deceased's birth certificate. iv. Similarly; for tenants, a lease agreement, and a utility bill not older than 3 months will be necessary in order to confirm

residency," he said.

Thwala added that in the case of a tenant's child, an affidavit confirming residency and tions to cater to different needs and preferthe deceased's hirth certificate will be required.

"Residents living in informal settlements will have to provide an affidavit signed by the traditional authorities of that particular area, affirming the deceased's residency," he said. He said all these measures have been put in place to ensure that the new cemetery serves the needs of our residents and remains a sustainable option for future generations. Furthermore, the spokesperson stated that the new cemetery has been carefully designed to respect and accommodate the diverse cultural backgrounds that exist in our city.

"The cemetery is divided into several secences," he said.

He further explained that the various sections within the new cemetery include a lawn section that is dedicated to adults.

He stated that the lawn section is meant for people who will want to place only a headstone on the grave and no tombstone.

"Additionally, we have a separate lawn section that is specifically designated for children; ensuring a respectful and appropriate resting place for our young ones," he said.

Thwala added that in the cemetery they have created an adult monument section and a children's monument section stating that these sections will allow families to erect personalised monuments and memorials in remembrance of their loved ones.

He also stated that the cemetery has included an urn section for those who choose cremation as their preferred method of burial and that this area provides a tranquil setting for the interment of cremated remains.

"We also understand that some families may wish to reserve graves for future use. Therefore, we have allocated a section specifically for this purpose. These reserved graves will be available for families to pay for and secure in advance," said Thwala.

set aside

Moreover, he explained that they have also set aside a private cemetery section for those who wish to have an exclusive and intimate burial setting and this section will provide privacy and seclusion as desired by the fam-

"Lastly, we have dedicated an Islamic Faith section within the cemetery as a way of recognising and respecting the specific requirements and traditions of our Islamic city citizens," he said.

Thwala stated that in the absence of unforeseen pandemics such as Covid-19, their projections point to the fact that the new cemetery will last over 40 years. He said double burials will also be encouraged to prolong the cemetery's lifespan.

"Residents are, therefore, encouraged to embrace and adopt the practice of double burials so that we achieve this goal," he said.

Thwala said as a Municipality they trust that all citizens will understand the decision that has been taken and cooperate with us as we operationalise the new multi-cultural

"Burial fees remain unchanged at E1 000 for adults and E500 for children. We would like to assure residents and all stakeholders that we remain committed to providing a dignified and culturally inclusive final resting place for our beloved city citizens," he concluded.



3 men get 9 years for culpable homicide

THREE employees from Nkulu Investments, have been sentenced to 9 years without a fine for the culpable homicide of Sibusiso Hlawe.

The construction company is based in Buhleni. According to the judgement affidavit, the culpable homicide was committed on September 28, 2016, in Nkomanzi area by Makhosonkhe Dlamini, Goodman Magagula, and Bonginkhosi Dlamini. The trio did not plead guilty to culpable homicide charge.

During their trial, one of the accused, Bonginkhosi, told the Court how the deceased was killed. He said on September 24 2016. Hlawe arrived at his homestead in Nkomanzi at night, he opened one of the houses and stole two cell phones, keys then he left. The following day, his brother Makhosonkhe, who is the owner of the house, woke up during the night and went to his neighbour, Magagula, to inform him that there had been a break-in. The two men got information that Hlawe was the suspect in the said crime. The day after the breakin, Makhosonkhe asked for assistance from the Hlawe's father on the whereabouts of his son, however, his father did not know where he was. Later that day, Makhosonkhe got information that Hlawe was seen in the mountains of that area.

Makhosonkhe then called Magagula and Bonginkhosi to assist him in apprehending Hlawe. The trio went to the mountain and found the suspect who then attempted to escape, however, they were able to apprehend him and that is when Makhosonkhe began to assault him while Magagula and Bongikhosi held the suspect. Before the



assault, Hlawe had admitted to the break-in and had surrendered the two stolen mobile phones, however, the assault did not end as Makhosonkhe was demanding for the keys.

The accused (Makhosonkhe) realised that Hlawe was getting weak thus he stopped the assault to release him. Upon Hlawe's release, he fell and hit a rock with his chin. The trio then transported him to his homestead on a wheelbarrow.

Arrested

When they arrived at the Hlawe's homestead they called the community police and that is when the deceased lost his life. When the community police arrived they contacted the Royal Eswatini Police Service who then arrested the trio.

In the trio's mitigation statement, they mentioned that they are all breadwinners, as they are all family men and have children who are dependent on them. When handing down the judgement, Judge Magagula said he had taken into consideration all the personal circumstances of the accused persons as it appears that all of them have families.

"Unfortunately, all this was known to the accused persons before they embarked on this unnecessary unlawful conduct. This state of events is a direct consequence of their conduct.

"They should have acted more responsibly as breadwinners. Unfortunately, the interest of the society and the seriousness of the crime they have committed must trump their circumstances," Judge Magagula said. Judge Magagula added: "It crossed my mind to mete out a sentence of 12 years on each of the accused persons. However, I was immediately engulfed with a sense of pity and decided to blend the sentence with mercy as I am enjoined to do by law."

"I have come to the considered decision that 9 years fits the degree of severity in which the culpable homicide was committed. A 9-year sentence accords with the purpose punishment, which is deterrence, retribution, prevention, and rehabilitation," Judge Magagula asserted.

Land scam: Woman defrauded of E51 000 in Manzana

ANOTHER victim has been scammed E51 000 after she bought land that did not belong to the said owners.

The complainant, Siphesihle Dlamini of Manzana, Mbabane alleges that she was promised land by a trio of Olyvia Nomsa Dlamini, Jacob Ndlangamandla and Themba Gwebu, who all reside in Manzana.

The three accused persons have been charged with theft by false pretences. Their charge sheet reads; In the month of August 2023 in Manzana, Mbabane in the Hhohho region the accused unlawfully misrepresented themselves to Dlamini promising her land in Manzana and obtained a sum of E51 000. Upon their arrest in connection with the crime, the trio appeared at the Mbabane Magistrate's Court before Magistrate Qondile Mtetwa.

In Court, the crown submitted that may the accused be remanded into custody pending setting of their trial date on January 26 2024, and bail is not opposed. The trio moved their bail applications and cited their different reasons why they should be admitted to bail. All the accused were granted bail fixed at E2 000 each.

It is worth noting that last year, the Court heard testimony of one victim who suffered the loss of E165 000. Pensioner Simon Fakudze told the Court how he was scammed into buying property which he later found out did not belong to the said owners. These men are Sibusiso Velibanti Dlamini (39), Themba Gwebu (33) who is also involved in aforementioned case, Percy Thembinkosi Mnisi (57), Mandla Bhekithemba Sifundza (57) Majahondvwa Sipho Mhlanga (51).

Fakudze told the Court that on January 21 2021, he saw an advert for a house being sold in a local newspaper. The advert had Sibusiso Velibanti Dlamini's contact details, he contacted the number and Dlamini referred him to call Gwebu since Dlamini was far from Mbabane at that moment.

Confirmed

Fakudze said he proceeded to contact Ngwenya who confirmed the house sale stating that it is valued at E180 000. Fakudze told the Court that he suggested to both Dlamini and Gwebu that they should first go to Mangwaneni Umphakatsi to ensure that the house indeed belongs to Dlamini. Upon that request, Dlamini requested Fakudze to pay E7 000 to pay bandlancane.

Fakudze said the day they went to Mangwaneni Umphakatsi, Dlamini called him to come to the Magwaneni house where they would meet with bandlancane. Fakudze

was introduced to the other accused persons Mnisi, Sifundza, and Mhlanga and they were said to be bandlancane. Fakudze said he suspected that something amiss and that is when he questioned why they had to meet in a house and not emphakatsi, but Mhlanga replied that due to Covid-19 pandemic they could not meet at emphakatsi.

The meeting ended and Fakudze deposited the balance of E65 000 to the lawyer's account. Days passed and Fakudze said he received a call from one Musa Vilakati who told him that the house in Mangwaneni belonged to him.

In frustration, Fakudze went to the Ministry of Works and Public Service to confirm whom the house belonged to and that is when he got information that it belonged to the said Vilakati. Fakudze narrated that at that point in time, Dlamini and Gwebu were not reachable on their cellphones, thereafter, he went to report the matter at Mbabane Police Station.



Man breaks-in, steals items worth E10 000

SIBONELO 'Pupu' Sifundza KaShewula, was arrested and charged for allegedly stealing items worth E10 000 belonging to Dudu Gladys Mndzebele of Gelekeceni in Zulwini.

According to the charge sheet, on November 29 2023, near Gelekeceni in the Hhohho district, the accused unlawfully and intentionally broke-in and entered a house of Mndzebele and stole items worth E10 000. The items include a double bed worth E2 000, Univar gas stove worth E1 500 and 2 single sofas worth E2 000, among other things. In Court the accused conducted his own defense where he moved his bail application, citing he has children to take care of, he was, therefore, granted bail fixed at E2 000. Just last week another alleged suspect was said to have broken into a house that belongs to Jonker Monique two times on separate occasions, stealing items totaling E37

After being arrested by the Police, Sifiso Madolo made his first appearance at the Mbabane Magistrate's Court, where he was slapped with two charges of house-breaking with intent to steal, the second count being theft. The first count read; On February 24, 2023, at the Mountain Drive area in the Hhohho region, Madolo unlawfully broke-in and entered Monique's house and stole items worth E21 470. These items include a desktop valued at E14 000 and a Samsung Tablet valued at E6 000, among other things.

The second count in the charge sheet read; Madolo is charged with the same offense "On December 23, 2023, in Fonteyn the accused unlawfully broke into the house of Monique and allegedly stole items valued at E16 305". The stolen items include a Samsung soundbar and bluetooth subwoofer valued at E14 500 among other items.

Trail

The Crown stated that because of the high value of the items, the matter should go to trial and also asked how the accused is intending to plead. Madolo responded by saying he would plead guilty to both counts and went on to move his bail application.

In his bail application, he said he has children that he needs to take care of, and added that he is currently unemployed.

Magistrate Motsa said this is the second time the accused is appearing before him for a similar charge so he cannot be considered on the amount of bail he will grant him. "It's unfortunate for you, Madondo, that you are appearing before me for the second time with similar charges as prior, I cannot exercise leniency in any way because it means you are a hardcore criminal," Motsa said.

He further explained that the amount of bail Madolo should get must be half of the item's value (E37 000). Therefore, the accused received bail fixed at E10 000. He will return to Court on February


'SA inflation seen averaging 5% in 2024'



SA inflation seen averaging 5% in 2024 SARB governor

DAVOS, Switzerland — African central bank governor, Lesetja Kganyago, said on Wednesday that the disinflation process had begun and that he expected inflation to average 5 per cent this year.

Speaking to the Reuters Global Markets Forum in Davos, Kganyago said inflation was still a concern as both global and domestic risks weighed on the outlook.

The South African Reserve Bank (SARB) targets inflation between 3 per cent and 6 per cent.

Despite still-rising food costs, annual inflation slowed for the first time in four months in November in South Africa - to 5.5 per cent - thanks to cooling fuel prices.

However, Kganyago declined to indicate when the central bank would start cutting rates, saying that decisions would continue to be data-dependent.

"We would like to see that inflation has declined sustainably to the 4.5 per cent mark, then the central bank can look whether it is still necessary to keep policy tight,"

The SARB will hold its first monetary policy committee meeting next week, wherein they will revise the forecasts for the year. South Africa has suffered almost daily power cuts, some for up to 10 hours a day, for more than a decade.

The SARB estimated that these power cuts had shaved off up to 2 percentage points from growth in 2023, but now think that investments from renewable energy should ease the pressure.

Logistics constraints on the ports and rail network run by troubled state-owned operator Transnet will also impact growth

Kganyago said that, although it was difficult to quantify, it was clear that the inability of the rail network to move goods efficiently was feeding into inflation.

In addition, South Africa will hold its seventh democratic national election this year and pressure to increase spending could impact domestic inflation.

"There will be a lot of contestation in South Africa and that could spill into the labour market and that has implications for wage setting and domestic inflation," Kganyago said. (Reuters)

South African retail sales fell 0.9 per cent year on year in November

JOHANNESBURG South African retail sales fell 0.9 per cent year on year in November after falling by a revised 2.3 per cent in October, Statistics South Africa figures showed on Wednesday.

On a month-on-month basis, sales increased 0.4 per cent.

Sales in the three months to the end of November were down 0.7 per cent compared with the same period last year, the statistics agency said. (Reuters)

Oil falls as China's economic recovery disappoints, dollar strengthens

LONDON — Oil fell more than \$1 on Wednesday as economic growth in China, the world's second-largest crude user, slightly missed expectations, raising concerns about future demand, while U.S. dollar strength dented investor's risk appetite.

Brent crude futures fell \$1.26, or 1.6 per cent, to \$77.03 per barrel by 1158 GMT. U.S. West Texas Intermediate crude futures (WTI) were down \$1.35, or 1.9 per cent, at \$71.05.

Even the ongoing naval and air conflicts in the Red Sea have not been enough to support oil, despite increased concerns about tankers having to pause or reroute, increasing shipping costs and slowing deliveries.

China's economy in the fourth quarter expanded by 5.2 per cent year-on-year, missing analysts expectations and calling into question forecasts that see Chinese demand fuelling 2024 global oil growth.

The economic data "doesn't end the headwinds over crude oil demand, the Chinese outlook for 2024 and 2025 is still bleak," said Priyanka Sachdeva, senior market analyst at Phillip Nova.

"(The) oil industry was backing the notion that despite a bumpy recovery, oil demand from China has been resilient and will likely reach record levels in 2024."

Still, China's oil refinery throughput in 2023 rose 9.3 per cent to a record high, indicating elevated demand even if it lagged some analysts' expectations.

Other signs of steady Chinese demand have also appeared.

Additionally, the U.S. dollar hovered

near a one-month high on Wednesday after comments from Federal Reserve officials lowered expectations for aggressive interest rate cuts. A stronger dollar reduces demand for dollar-denominated oil from buyers using other currencies.

"Higher rates can lead to a weaker outlook for oil demand as economic activity tends to cool in a high interest rate environment, leaving oil prices vulnerable," Sachdeva said.

Also in the U.S., oil refiners are expected to have 1.5 million barrels per day (bpd) of capacity offline for the week ending Jan. 19, decreasing available refining capacity by 954,000 bpd, research company IIR Energy said on Wednesday.

In the Red Sea, tensions remained high as the U.S. on Tuesday mounted fresh strikes against Iran-aligned Houthi militants in Yemen after a Houthi missile hit a Greek vessel.

"While oil benchmarks may not reflect the Red Sea attacks, the realised price for oil and oil products for consumers has increased given the disruption to trade flows through the Red Sea and Suez Canal," Vivek Dhar, mining and energy commodities strategist at the Commonwealth Bank of Australia, wrote in a note. 

The City expressed its intent to repatriate the mummy following a thorough investigation of the circumstances surrounding its presence in Durban, which remain un-

The municipality recognises the importance of addressing historical injustices and upholding ethical standards in the preservation and handling of cultural artefacts.

"After extensive deliberation, the City acknowledges the significance of returning the mummy to its country of origin and honouring its cultural and historical importance to the people of Egypt," said eThekwini's head of Parks, Recreation and Culture, Dr Simphi-

He added that, along with the national De-

partment of Sport, Arts, and Culture and the South African Heritage Resources Agency, they will ensure that the repatriation process is undertaken with the utmost care.

The city explained that the mummy and coffin date back to the Late Dynastic or Early Ptolemaic periods. Peten-Amum originally came from Akhmim, which is about 354 kilometres from Cairo, Egypt.

The toxic patriarchal side of the bhinca lifestyle

THE Zulu culture, renowned for its rich traditions and heritage, has long faced challenges arising from patriarchal ideologies.

While the culture itself embodies deep respect for customs and rituals, there have been instances where certain patriarchal individuals have manipulated these traditions to serve their own selfish desires, often at the expense of women.

Patriarchy within Zulu culture has historically led to the subjugation of women, where societal norms often prioritise men's authority and power. This imbalance has allowed some men to exploit cultural practices for their benefit, misinterpreting traditions to assert dominance and control over women. Such individuals use cultural facets, often twisting their original meaning, to enforce oppressive practices.

Sub-culture

Many such misogynistic individuals nowadays practice or are immersed in what is termed the bhinca lifestyle. This is a Zulu sub-culture with its origins in the migrant labour system of colonial and apartheid South Africa where homesick men gathered in mine hostels and performed traditional music, got dressed in their best traditional clothes etc.

This extended to the holidays when they travelled back home and they would bring expensive city clothes and play what was then a new genre of "city" music.

There is now a resurgence of a romanticised modern version of this bhinca lifestyle seen mostly in rural KZN and the hostels of Gauteng and driven through social media platforms such as Facebook and TikTok. It is also driven through maskandi music and other social events like izingoma zezigodi (village traditional music shows). It is mostly represented in a particular fashion style, maskandi music, Toyota Hiluxes and Quantums and a generally showy lifestyle.

This romanticised version of the bhinca lifestyle is mainly influenced by self-styled cultural proponents, wealthy business people, media personalities and even some politicians who are all frequently seen mingling with known violent criminals at functions where another questionable bhinca lifestyle practice of ukushaya indishi (gifting hosts of a party, a traditional ceremony or wedding with wads of cash) is usually on crass display.

The lifestyle, however, has a stinking underbelly that is driven by misplaced Zulu nationalism, misogyny and abuse of Zulu culture. Embedded deep in the bhinca lifestyle is the constant need to prove one's ubunsizwa (manhood), a dangerous gun culture and the deliberate misinterpretation/ manipulation of Zulu culture. Criminality (hitmen, extortion rings, armed robberies etc) is also almost always found in the proximity of the bhinca lifestyle.

The Shembe church, an influential religious movement within the amabhinca proponents, has also faced criticism for harmful


perpetuating

beliefs and practices. While the church espouses principles of spirituality and unity, some factions within it have been accused of fostering a culture where men abuse their power, particularly in their treatment of

The Shembe church's emphasis on purity and reverence for virgins, while rooted in spiritual teachings, has been distorted by certain individuals to manipulate and exploit young women. These individuals, often in positions of authority or influence within the church, have been reported to coerce young virgins into non-consensual relationships under the guise of religious obligation. Tanzania lifts ban on Kenya Airways flights

DAR ES SALAAM - Tanzania said on Tuesday it had reinstated approval for Kenyan national carrier Kenya Airways (KQNA. NR), opens new tab to operate flights between the Kenyan capital Nairobi and Tanzania's commercial capital Dar es Salaam.

"Following this development, the aeronautical authorities of the United Republic of Tanzania hereby withdraw its decision of 15 January 2024 and therefore approval for Kenya Airways to operate... between Nairobi and Dar es Salaam, is hereby restored," state-run Tanzania Civil

Aviation Authority said in a statement.

Tanzania has been investing heavily on reviving its national carrier since 2016 by expanding its fleet, routes and operations to tap the local and regional markets.

Kenya Airways is one of Africa's largest airlines and Tanzania, where attractions including mountains and vast wildlife reserves draw more than a million tourists a year, is one of its biggest markets.

Russia, Niger agree to develop military ties

RUSSIA and Niger, under military rule since a coup last year, have agreed to develop military cooperation, the Russian Defense Ministry said on Tuesday.



foothold for Russia in the region.



Nigeria blast kills two, dozens hurt as buildings collapse

LAGOS - At least two people were killed and dozens injured when explosives stored at a private residence detonated in Nigeria's Oyo state, its governor said on Wednesday.

Several houses collapsed from the impact of Tuesday's blast, witnesses said, sending panicked residents into the streets.

In a statement, the governor, Seyi Makinde, said there were two deaths while 77 people were treated for injuries, most of them being discharged.

"Preliminary investigations by

the security agencies revealed that illegal miners occupying one of the houses in Bodija had stored explosive devices there which caused the blast," Makinde added.

The explosion was heard in the state's capital of Ibadan, 130 km (80 miles) from Nigeria's commercial capital of Lagos.

Makinde said search and rescue operations were underway and the state government would provide temporary accommodation for those who lost their homes.

'India to keep diversifying oil supply, accelerate energy transition'

DAVOS, Switzerland Supply cuts by OPEC+, costly shipments from some traditional Middle East suppliers and geopolitical tension is driving India, the world's third biggest oil importer, to diversify its crude sources and accelerate its energy transition, its Oil Minister Hardeep Singh Puri

"Whenever there is vulnerability and uncertainty in the market, the transition gets accelerated. Noone is looking at that", Puri told Reuters in an interview at this week's World Economic Forum in the Swiss ski resort of Davos, referring to attacks by the Houthis on ships in the Red Sea.

Puri said that while OPEC+ nations have a right to decide on their energy production, supply cuts against such uncertainty, and the resulting adverse impact on global prices, will dent long term

It is "imperative" for India to accelerate its transition to green energy in this scenario, he added.

Iraq followed Saudi Arabia in charging a premium for oil supplies to Asian markets which made their crude "more expensive than crude sourced elsewhere", the minister said, noting India is now buying from 37 countries up from 29 earlier.

Saudi Aramco, the national oil giant, this month cut the price of its flagship Arab Light crude to Asian customers to the lowest level in 27 months.

"I didn't tell them to reduce it but they did it because they also wanted to. If you look at the Indian figures in the last 2-4 years, some of the major suppliers suddenly became number three and somebody who had only 0.2% (import share) went up," Puri added.

Iraq replaced Saudi Arabia as the top oil supplier to India a few years ago and now cheaper supply

from Russia in the aftermath of Western sanctions for its invasion of Ukraine has pushed it to the top spot followed by Iraq and Saudi

While concerned over the disruptions in the Red Sea, Puri said he was "cautiously optimistic" that they will be resolved.

Puri said he had just signed a memorandum of understanding with Guyana to cooperate across the entire energy value chain of the South American country.

He is also talking to companies in Davos who are interested in making investments in India and with whom he would like Indian oil companies to partner with to explore acquisitions and assets in regions such as Latin America.

Puri said countries, including in the Middle East, had told him they want to acquire Indian oil companies outright, he said, but they are strategic and not for sale.

Kuwait forms first govt under new emir and prime minister

- Kuwait on Wednesday formed a government headed by Prime Minister Sheikh Mohammed Sabah al-Salem al-Sabah, the state news agency said, the country's first cabinet after the death of its previous ruler.

Sheikh Mohammed appointed new ministers for oil, finance and foreign affairs in the first cabinet formed under Kuwait's new Emir Sheikh Meshal al-Ahmad al-Sabah, which he said would carry out reforms to comply with the emir's guidance.

"This is a heavy responsibility of a new phase of Kuwait's history which includes challenges and aspirations, and requires further hard work and genuine accomplishment," the prime minister said, quoted by

The prime minister appointed Emad Mo-

hammed al-Atiqi as oil minister, Anwar Ali al-Mudhaf as finance minister and Abdullah Ali al-Yahya as foreign minister.

Kuwait's Emir Sheikh Meshal al-Ahmad al-Sabah, who came to power in December after his predecessor Sheikh Nawaf died, is expected to preserve Kuwaiti foreign policies including support for Gulf Arab unity, Western alliances, and good ties to Riyadh a relationship seen as a priority.

Kuwait will have to grapple with long-running strains between the ruling family and its critics in the deadlocked and fractious parliament that critics say has hindered fiscal and economic reform.

The legislature wields more influence than similar bodies in other Gulf monarchies, and political deadlock has for decades led to cabinet reshuffles and dissolutions of parliament. (Reuters)

'Past U.S. elections were rigged'

RUSSIAN President Vladimir Putin, running for a new six-year term in an election that his opponents say is a parody of democracy, said on Tuesday that past U.S. elections had been rigged by postal voting.

"In the United States, previous elections were falsified through postal voting ... they bought ballots for \$10, filled them out, and threw them into mailboxes without any supervision from observers, and that's it," Putin said, without providing evidence.

Putin's opponents say the March election in Russia is no real contest as the president wields unchallenged power and his main rival, Alexei Navalny, is serving more than 30 years in jail on charges that Navalny says were trumped up.



ALTHOUGH refined carbs can be harmful when consumed in excess, whole-food sources of carbs are incredibly healthy.

In fact, many of the world's healthiest foods are high in carbs. Carb intake is one of the most hotly debated topics in nutritional science. Carbs are now accused of causing weight gain, heart disease, and various other problems — just as fat once was.

Indeed, so-called "junk" foods are often high in carbs — particularly refined carbs. Low carb diets can also be beneficial, especially for weight loss, diabetes, and other health conditions.

However, not all carb sources are created equal. Here are 9 reasons why you shouldn't avoid all carbs.

1. Carbs are not uniquely fattening

Scientists once hypothesized that carbs increased the risk of obesity more than fat and protein.

According to this hypothesis, carbs are the primary cause of obesity due to their ability to raise insulin levels, promoting the storage of calories as fat. This idea is known as the carbohydrate-insulin model of obesity.

Of course, excessive intake of any calorieproviding nutrient — fat, carb, or protein — can be an effective recipe for weight gain.

However, no compelling evidence supports the idea that high carb diets are especially fattening. In fact, many studies suggest that there is no significant association between high carb intake and obesity.

Nevertheless, healthy low carb diets have been proven effective for weight loss — at least in the short term.

Scientists believe their effectiveness is due to the elimination of refined carbs like added sugars and an increased focus on healthy, high fiber carb sources, as well as protein and fat.

Still, one large, 12-month study that compared the effectiveness of a healthy low carb diet with a healthy low fat diet detected no significant differences in weight loss.

In short, the quality of the carbs you eat is of greater importance than the proportion of carbs in your diet.

2. Early humans frequently ate carbs

Learning to cook was a game-changer for early humans, as cooked meat provided increased protein, fat, and calories.

New evidence indicates that carb-rich foods like root vegetables, legumes, and even grains were cooked and consumed by human ancestors as well.

Cooked carbs would not only have been more nutritious but also more appealing to a hungry hunter-gatherer.

This theory is supported by emerging biological evidence showing that early humans began developing extra copies of the amylase gene, which helps produce the enzymes you need to digest starchy carbs.

In fact, this change in DNA occurred long before humans started farming. That's why people today can have up to 18 amylase gene copies, indicating that humans have evolved to digest starches more efficiently.

Also, consider that every single cell in your body runs on glucose, which is a carbohydrate sugar. Even the most fat-adapted brain requires at least 20 per cent of its energy from carbs.

3. Gluten intolerance isn't particularly common

Gluten is a protein found in wheat, barley, and rye. By cutting carbs from your diet, you





automatically cut out gluten, too.

A gluten-free diet is necessary for people with celiac disease or some other types of autoimmune disease. Gluten-free diets may also benefit people with non-celiac gluten sensitivity or wheat intolerance.

However, studies indicate that few people with self-reported gluten sensitivity actually have this condition. One 2015 study showed that only 3 out of 59 participants who believed they were gluten-sensitive reacted to gluten. Newer research suggests that the condition known as non-celiac gluten sensitivity is not sensitivity to gluten at all. Instead, it appears sensito fructan, a type of soluble fiber or FODMAPs found in wheat. FODMAPs like fructans cause digestive symptoms like gas, diarrhea, and stomach pain in some people especially those with irritable bowel syndrome (IBS). If you have FODMAP sensitivity, try to identify and avoid only those foods to which you're sensitive.

4. Fiber — a carbohydrate — is important for optimal health

Nutrition is rarely black and white. Still, most experts agree that eating fiber is good for your health.

Most dietary fiber is made of carbohydrates. Soluble fiber is particularly beneficial for weight maintenance and heart health. Fiber increases the time it takes to digest and absorb nutrients, contributing to reduced body weight and improved health.

5. Gut bacteria rely on carbs for energy

The balance between beneficial and harmful gut bacteria may influence your risk for many lifestyle-related conditions, both physical and psychological.

To grow, your beneficial gut bacteria need carbs to ferment for energy. As it turns out, soluble fiber is an important nutrient.

Some of the best food sources of soluble fiber include legumes and oats, which are high in carbs.

6. Legumes are a superfood on a nutrient-to-cost basis

Legumes are edible plant seeds that include beans, peas, chickpeas, lentils, and peanuts. They're naturally high in carbs and thus often excluded from low carb eating patterns. They're also eliminated on

a strict paleo diet. However, legumes are nutritionally unique. They're one of the few foods rich in both protein and fiber. Legumes are also high in vitamins and minerals. Plus, calorie for calorie, they're one of the most nutrient-dense foods available.

7. Cutting carbs does not improve exercise performance

It's a myth that a low carb diet can outperform a conventional high carb diet for athletes.

In a well-designed — albeit older — study of cyclists performing a 62-mile (100-km) trial with intermittent sprints, participants followed either a low carb or a high carb diet for the week leading up to the test.

Though both groups had similar race times, the high carb group outperformed the low carb group's sprint output on all four occasions.

While a single study cannot draw solid conclusions, the weight of evidence overwhelmingly supports these results.

If you're fat-adapted on a low carb diet, you can still perform very well, but no high quality studies show that cutting carbs allows you to outperform those on higher-

carb diets. This holds for cardio endurance events like cycling, as well as weight training and bodybuilding for muscular strength and endurance. For those who exercise to keep fit, a low carb diet likely won't hurt your performance — but it probably won't improve

8. Carbs don't cause brain damage

Some claim that carbs cause harmful brain inflammation. However, this idea is not based on scientific evidence. Unlike refined grains, whole grains are high in magnesium and fiber both of which are linked to less inflammation. In fact, the extensively studied Mediterranean diet, which is rich in whole grains, is strongly associated with slower age-related mental decline and a lower risk of Alzheimer's disease. On the other hand, a high intake of refined carbs and added sugars should be avoided. As part of an unhealthy lifestyle, these ingredients reduce overall health, adversely affecting your body as a whole.

9. The world's longest-lived populations eat plenty of carbs

The Blue Zones — the regions where people live measurably longer — provide scientists with unique insights into certain eating patterns. The island of Okinawa in Japan has the most centenarians (people who live over the age of 100) in the world. Their diet is very high in carb-rich sweet potatoes, green vegetables, and legumes. Before 1950, a whopping 69% of their calorie intake came from sweet potatoes alone. Another long-living population inhabits the Greek island of Ikaria. Nearly 1 in every 3 people lives to be 90, and they eat a diet rich in legumes, potatoes, and bread. Several other Blue Zone regions share similar dietary traits, indicating that carbs are not causing problems for these people.

The bottom line

It's important to think about foods as a whole and not just consider their nutrients. This is especially true when it comes to carbs. For instance, highly processed foods are unhealthy, providing little to no nutritional value. They're today's biggest contributors to excess calories. And though low carb diets can be an effective tool for weight loss and diabetes control, that doesn't mean carbs alone cause weight gain or disease — nor are they the sole cause of the current state of public health. This depends entirely on the context and varies between individuals. Some people do well with fewer carbs, while others function fine by eating plenty of carbs from nutritious food. In any case, whole-carb foods can be part of a healthy diet and don't need to be avoided at all costs.

SORE THROAT HOME REMEDIES TO TRY

Honey mixed in tea or taken on its own is a common remedy for a sore throat.

According to a 2021 research review, honey is just as effective as the cough suppressant dextromethorphan at taming coughs in children. Dextromethorphan is an active ingredient in products such as Robitussin and Delsym.

A 2021 literature review examined the effect of honey on acute upper respiratory infections. The researchers concluded that honey was more effective at relieving symptoms than other treatments, including antibiotics and the antihistamine diphenhydramine.

2. Saltwater gargle

Gargling with warm salt water can help soothe a sore throat and break down secretions. It may also help reduce bacteria in the throat. Make a saltwater solution by adding half a teaspoon of salt to a full glass of warm water. Gargle with it to help reduce swelling and keep the throat clear. According to the American Osteopathic Association, people with a sore throat should perform a saltwater gargle at least once an hour.

3. Baking soda gargle

While the saltwater gargle is more commonly used, gargling with a baking soda-saltwater mixture can also help relieve a sore throat. This oral solution can reduce bacteria and prevent the growth of fungi. The National Cancer Institute (NCI) recommends gargling with and gently swishing around a combination of:

- ▶ 1 cup warm water
- ▶ 1/4 teaspoon of baking soda
- ▶ 1/8 teaspoon of salt


The NCI suggests using the rinse three or four times daily and then rinsing your mouth with plain water.

4. Chamomile tea

Naturally soothing chamomile tea has long been used for medicinal purposes, including treating a sore throat. It has anti-inflammatory, antioxidant, and astringent properties. According to a 2023 review of research, chamomile powder may help relieve inflammation in the eyes, nose, and throat.

Drinking chamomile tea may offer

the same benefit. It may also stimulate the immune system to help your body treat the infection that caused your sore throat.

5. Peppermint

Peppermint is well known for its ability to freshen the breath. It also has anti-inflammatory properties and some antibacterial and antiviral qualities, according to a 2019 literature review.

Peppermint contains the compound menthol, which helps thin mucus and calm sore throats and coughs. While many peppermint teas are available, you can also make your own. Place some dried peppermint leaves in boiled water and let the mixture sit for a few minutes. After a few minutes have passed, strain the tea and allow it to cool slightly. Diluted peppermint oil sprays may also relieve sore throats. To make a spray, mix a few drops of food-grade peppermint oil with 1 ounce of plant-based oil, such as:

- ▶ olive oil
- ▶ almond oil
- ▶ softened coconut oil

6. Fenugreek

The herb fenugreek is available in many forms. You can eat fenugreek seeds, apply fenugreek oil to the skin, or drink fenugreek tea. Fenugreek tea is a common remedy for sore throats.

A 2018 literature review demonstrates the healing powers of fenugreek. Among other benefits, it may help:

- ► relieve pain, including menstrual cramps ▶ reduce bacteria that cause irritation or
- inflammation
 - ▶ serve as an effective antifungal ▶ promote lactation

The National Center for Complementary and Integrative Health (NCCIH) suggests that pregnant people avoid consuming large doses of fenugreek. Children should also not use it as a supplement.

7. Marshmallow root

Marshmallow root, a type of herb, contains mucilage, a mucus-like substance that coats and soothes a sore throat. A 2019 literature review notes that marshmallow root can be helpful for irritations of the respiratory tract, which may include a sore throat.

Marshmallow root is available:

- ▶ as an herbal tea
- ▶ as a tincture
- ▶ dried and in capsule form

Remember that marshmallow products, like those used in your favorite desserts, don't typically contain marshmallow root.

8. Licorice root

Licorice root has long been used to treat sore throats. A 2019 study found that, out of several herbal infusions, licorice root tea was the most effective at inhibiting the growth of Streptococcus pyogenes. This bacterium causes strep throat. Using licorice root lozenges or as a gargle before surgery may help reduce sore throat following surgery, according to the NCCIH. Though the organisation notes that licorice root remedies may not be safe for people who are pregnant or nursing.

9. Slippery elm

Like marshmallow root, slippery elm also contains mucilage. When mixed with water, slippery elm forms a slick gel that coats and soothes the throat.

To use slippery elm, pour boiling water over powdered bark, stir it, and drink. You may also find that slippery elm lozenges help.

Slippery elm is a traditional remedy for sore throat, but more research on its effectiveness is still needed. Slippery elm may slow the absorption of some oral medications. To prevent possible drug interactions, use slippery elm at least 1 hour after taking oral medications.

10. Garlic

Garlic has natural antibacterial properties as well. It contains allicin, a compound known for its ability to fight off viral infections, according to a 2020 literature review on the antiviral uses of garlic. Taking garlic supplements daily can help prevent and treat upper respiratory tract infections, according to a 2018 article. These same respiratory tract infections may potentially cause a sore throat. Healthline

Hearing date set for Man City's financial rule breach charges

A date has been set for the hearing into Manchester City's alleged financial rule breaches, the Premier League's CEO Richard Masters said on Tuesday.

City were charged in February with more than 100 alleged breaches of finance rules since their acquisition by the Abu Dhabi-based City Football Group, and were referred to an independent commission for a hearing

"There is a date set for that proceeding. Unfortunately, I can't tell you when that is but it is progress-

ing," Masters told the Culture, Media and Sport (CMS) Committee of the UK Parliament.

When the charges were announced in February, City said they welcomed "the review of this matter by an independent commission, to impartially consider the comprehensive body of irrefutable evidence that exists in support of its position."

The charges against City, who are targeting a fourth straight Premier League title this season, are different to those brought against Everton and Nottingham Forest on Monday, Masters told the committee.

"If any club, the current champi-

ons or otherwise, had been found in breach of the spending rules, they would be in exactly the same position as Everton or Nottingham Forest," he said.

"But the volume and character of the charges laid before Manchester City, which I obviously cannot talk about at all, are being heard in a completely different environment."

Everton and Forest are facing potential points deductions - which would be a second for Everton this season after they were docked 10 points in November.

Man U cuts profit forecast after CL exit

MANCHESTER United, opens new tab cut its annual revenue and profit forecasts on Wednesday, after the English Premier League club was knocked out of Europe's top tier Champions League tournament in the early stages this season.

The reduction will be a blow to British billionaire Jim Ratcliffe, who struck a long-awaited deal last month to buy a 25% stake in the club to try to revive its fortunes.

As part of that deal, Ratcliffe's IN-EOS group took over management of the club's soccer operations.

The club currently sits seventh in the Premier League table following a 2-2 draw against Tottenham Hotspur at the weekend.

Broadcasting revenue for the first quarter of its financial year rose 12.3% to 39.3 million pounds (\$49.9 million), thanks to its participation in the group stage of the Champions League.

But that revenue is expected to fall after the club's 1-0 defeat to Bayern Munich last month ended its hopes in Europe this season, piling pressure on manager Erik ten Hag.

UEFA, Europe's soccer governing

body, distributes a share of revenues to clubs competing in the lucrative tournament.

Manchester United reported a net loss of 25.8 million pounds for the quarter ended Sept. 30, compared with 26.5 million pounds a year earlier.

It now expects fiscal 2024 revenue of 635-665 million pounds, versus its previous forecast of 650-680 million pounds, and adjusted core profit of

125-150 million pounds, compared with 140-165 million pounds previously.

Operating expenses as well as costs related to players' salaries also rose in the quarter.

Under ten Hag, the club bolstered its squad in the summer transfer window, with new signings including Rasmus Hojlund from Atalanta, Mason Mount from Chelsea and Andre Onana from Inter Milan. (**Reuters**)

Djokovic survives Popyrin scare to reach third round

MELBOURNE - Defending champion Novak Djokovic survived a huge scare before beating home hope Alexei Popyrin 6-3 4-6 7-6(4) 6-3 to reach the third round of the Australian Open on Wednesday.

The 36-year-old Serb, bidding for a record-extending 11th crown in Melbourne, was in deep trouble in the third set when errors began to flow and he had to save four set points.

With the packed night-time crowd on the edge of their seats, top seed Djokovic used his vast experience to win the pivotal tiebreak and then broke a dispirited Popyrin midway through the fourth set to finally seize control.

Djokovic breezed through the fourth set to rack up his 30th successive victory at the Australian Open -- his last defeat coming in 2018 -- but for the second successive round he was pushed hard and looked short of his best form.

"He missed an easy forehand and I was lucky to get away with that game," Djokovic, who was riled up by a

heckling fan as the match neared its conclusion, said on court.

"He was the better player for a set and a half but the momentum shifted after the tiebreak."

Djokovic, bidding to claim a record 25th Grand Slam title, was kept on court four hours during his opening round victory over Croatian qualifier Dino Prizmic on Sunday. (Reuters)

Henderson, Al Ettifaq part ways after six months set to join Ajax

JORDAN Henderson has reached an agreement with Al Ettifaq to leave the Saudi Pro League club and is close to joining Ajax on a permanent basis, according to sources with knowledge of the deal.

The England international and his current side are in the process of finalising the termination of a three-year contract that he signed last summer, ensuring no transfer fee will be involved in the midfielder's exit.

Meanwhile, Henderson is flying back to the UK from Al Ettifaq's winter training camp in Abu Dhabi, having agreed a switch to Ajax in principle.

That proposed move also requires paperwork and details to be ironed out before the 33-year-old former Liverpool midfielder's return to European football is complete after a brief stint in the SPL.

Henderson's exit from Saudi Arabia comes just six months after his move from Anfield. Speaking about his move, Henderson said: "I wanted something that would excite me. But it needed to be something that I felt as though I could add value in and do and try something new — a new challenge and for different reasons. "And this opportunity with Stevie (Gerrard) in

a totally different league and totally different culture was something completely different, that maybe it would excite us in terms of the project that was put in front of us, in terms of the league and using my experience to try to help with that in many different areas and feeling that people value.

Last June, the Saudi Arabia ministry of sport announced the country's Public Investment Fund (PIF) was to take control of four teams in the Saudi Pro League: Al Ahli, Al Ittihad, Al Hilal and Al Nassr. Many high-profile transfers followed that announcement, with Karim Benzema, Roberto Firmino and Sergej Milinkovic-Savic among those to join Henderson in swapping European football for the Gulf state. The feat held since 2010 by the former Cameroonian international Rigobert Song and the Egyptian Ahmed Hassan is now equalled by the Ghanaian André Ayew and the Tunisian Youssef Msakni who are both present in Côte d'Ivoire for the 34th edition, at 34 and 33 years old respectively.

André Ayew had his first TotalEnergies CAF AFCON in 2008, hosted in his country, Ghana when he was just 18 years old.

Since then, he has only missed the 2013 edition, following an exclusion from coach James Kwesi Appiah's team due to injury

The Le Havre player has 118 caps with Ghana, including 35 in the TotalEnergies CAF AFCON and Msakni has worn the colours of the Tunisian National team since 2009. Since 2010, Youssef Msakni has taken part in all editions of the TotalEnergies CAF AFCON with the Carthage Eagles of Tunisia.

His game against Namibia in the TotalEnergies CAF AFCON Côte d'Ivoire 2023 is his 100th cap for Tunisia.

Rigobert Song and Ahmed Hassan both played in eight TotalEnergies CAF AFCON competitions between 1996 and 2010. The Cameroonian won two titles, in 2000 and 2002 while the Egyptian won four trophies (1998, 2006, 2008 and 2010).

Ayew and Msakni on the other hand, despite this long experience in the competition, have still not won the ultimate yet.

The Ghanaian has often come so close to winning, having played and lost two finals in 2010 against Egypt and in 2015 against Cota Pilvoira, Mealmi'a host



Onana back training with Cameroon and likely to play

GOALKEEPER Andre Onana (27) is likely to be included in Cameroon's line-up for Friday's Africa Cup of Nations group game against holders Senegal after returning to training with the team on Wednesday.

Onana missed Cameroon's opening match of the tournament in the Ivory Coast on Monday after he was allowed to stay at Manchester United and play in their 2-2 draw with Tottenham Hotspur on Sunday.

He flew by charter plane overnight to the Ivory Coast after the clash at Old Trafford but only arrived hours before kick off of the Group C clash against Guinea, in which Cameroon came from behind to force a 1-1 draw.

The decision to allow him to forgo the opening match of the tournament caused controversy among Cameroon supporters.

In an interview after his arrival in the Ivory Coast, Onana told reporters of the difficult tug of loyalty between club and country, especially for African internationals forced to leave their European clubs mid-season to compete at the Cup of Nations.

"It's like choosing between my father and my mother, but my country comes first, that's why I'm here," he said

"Let people continue to criticise me. I'm used to it. I do what is good for my country," Onana added.

Onana has a chequered history with Cameroon after breaking through into the team while still a teenager at Ajax Amsterdam.

Call-up

He turned down a call-up to the 2017 Cup of Nations finals, which Cameroon went onto win, and at the last World Cup in Qatar was sent home after one match following a row with coach Rigobert Song, which has since been patched up.

But he did compete at the last edition of the Cup of Nations two years ago, just months after returning from a lengthy doping ban.

Denver Sundowns Coach Milton Dlamini said there were no longer small teams in the tournament.


"All the teams are now equal and it is very hard to predict the results. All the team
