
This timely infusion of funds came just before schools reopened for the new year on

# Temporary fuel shortage at some stations, Ministry assures swift resolution

THE Ministry of Natural Resources and Energy has issued a statement acknowledging a temporary shortage of ULP 95 petrol at some fuel service stations across the country.

The ministry has assured motorists and stakeholders in the petroleum industry that the situation is being addressed and fuel supplies will be restored as soon as possible.

The current shortage is attributed to logistical supply challenges faced by one of the fuel suppliers in Eswatini's neighbouring countries, from where some oil companies source their ULP 95 petrol.

The specific details of the logistical issues were not disclosed in the Ministry's

industry that the country is currently facing at some service stations. This shortage is attributed to logistical supply challenges

emanating from one supplier in our neighbouring countries where some of the oil companies source fuel," reads the statement in part.

"We understand the inconvenience this temporary shortage may cause motorists to urge the public to remain patient while we work diligently with oil companies to resolve the issue." The statement reads in conclusion.

## Commitment

ministry emphasised commitment to ensuring a stable and reliable fuel supply for the nation. While the full extent of the affected stations remains unclear, reports suggest that the shortage is primarily impacting select areas within the country.

Motorists are advised to contact their preferred fuel stations for real-time updates on availability.

Theministry's promptack nowledgement and reassurance aim to minimise panic and maintain public trust during this temporary disruption.

ESWATINI Communications Commission (ESCCOM) has warned the public against using unlicensed Multiplex Investment (PTY) LTD t/a Broadband Technologies.

ESCCOM Chief Executive Officer (CEO) Mvilawemphi Dlamini said it had come to their attention of the Commission that an entity is advertising and portraying itself as a licensed Internet Service Provider providing internet services in Eswatini.

Dlamini said Broadband Technologies is not a licensed Internet Service Provider and as such is not allowed to offer electronic communication services in Eswatini.

#### Advertising

"The entity has been ordered by the Commission to desist from advertising or conducting its business as a licensed electronic communications service provider," he said.

The CEO further reminded and warned individuals and companies that in terms of the

Electronic Communications Act, 2013, it is an offence to operate or provide an electronic communications network or

service without a licence issued by the Commission.

Dlamini said the commission shall take stern legal action against any individual or company that is found to be operating or providing electronic communications

network or services without a license.

According to the commis-

commission's website, Eswatini Communications Commission (ESC-

COM) is the regulatory body responsible for regulating the commu-

nications sector in Eswatini, constituting of telecommunication services and networks, broadcasting services, postal services and the use and allocation of radio spectrum.

It derives its mandate from the Swaziland Communications Commission Act no. 10 of 2013.

The Commission became operational on the July 31, 2013, effectively taking over all the regulatory powers of the sector from the Eswatini Posts and Telecommunications Corporation (EPTC) and Eswatini Television Authority (Eswatini TV).

### Advertising

The Commission is mainly responsible for licensing all systems and services in the communications industry, including telecommunications, postal, courier and broadcasting, managing the country's frequency spectrum and numbering resources, facilitating the development of e-commerce, and type approving and accepting communications equipment meant for use in the country.

"The commission is also responsible for protecting consumer rights within the communications environment, managing competition within the sector to ensure a level playing ground for all players, regulating retail and wholesale tariffs for communica-

tions services, managing the universal access fund to facilitate access to communications services by all in Eswatini, and monitoring the activities of licensees to enforce compliance with the license terms and conditions as well as the law," read the website.

#### Decisions

The Commission is overseen by a Board of the Directors consisting of non-executive member and all decisions of the Board are executed by the Chief Executive Officer and is supported by an executive team.

# Man arrested for hacking wife, son with axe granted E15 000 bail

MCOLISI Sydney Hlatjwako of Mankayane who was charged with attempted murder after allegedly hacking his wife and son with an axe two times on the head, has been granted bail fixed at E15 000.

The accused charge sheet states that on December 28, 2023, at Mgazini Hlatjwako hacked her wife several times on the head and on the left thigh with an axe thus causing her to sustain severe injuries.

The second count states that the accused also slashed his son with an axe two times on the head thus causing him grievous harm.

The accused has moved his bail application at the High Court. In his affidavit the accused states that he is requesting the Honourable Court to admit him to bail, the accused said he is innocent of the charges leveled against him and he intends to plead not guilty at trial." Once evidence is led in the matter, I believe that I will be acquitted as I have a very good defense to the charges I am facing" the affidavit reads.

## Affidavit

In his affidavit, Hlatjwako said he must bring the Honorable Court into his confidence and make mention of the fact that the victims of the offences which he is charged with are his wife and his son and they are permanently residing at Sicunusa area where the accused established their matrimonial home.

Hlatjwako brought his side of the story on the incident, stating that on December 24, 2023, he had a misunderstanding with his wife. The misunderstanding was caused by the fact that his wife suspected that he was involved in an extramarital relationship with one of the girls in their community.

The accused said his wife then packed

her belongings and left their home, moving to her maternal home. Hlatjwako said on December 28, he went to his wife's maternal home to seek an audience with her to discuss the issue of the extramarital relationship which he states that was not true, as he had never engaged with any other woman other than his wife.

On arrival at Mgazini, her maternal home, Hlatjwako says he found his wife with their minor child. When trying to have a conversation with her she didn't respond, however, minutes later she eventually gave him an audience. "Whilst I was trying to explain to her that the issue of me being engaged in an extramarital relationship was not true, she slapped me on my face but due to the force of the clap she slipped and fell together with

the child on an axe, and both got severely hurt in the process" Hlatjwako asserted.

The accused emphasized that there was no point in time where he hacked his wife and son with an axe. He added that he firmly believes that once evidence is led in this matter his innocence will be proved as he strongly believes that everything that led to them getting hurt was an accident.

After the injury, Hlatjwako said he tried to organize transport for both of them to the hospital, and upon arrival at the hospital, they were informed that they should first obtain a police report so that they could be in a position to treat them.

Acting on the advice of the hospital personnel at Mankayane Hospital they proceeded to the police station, since his

wife was still angry at him,

accused had just hacked her and the minor child.

However, the police did assist them, and they left for the hospital, shortly after their arrival at the hospital the police also arrived and informed the accused that they had come to fetch him for questioning at the police station.

Indeed, they proceeded to the police station, and on arrival, he was never questioned, instead, he was informed, without giving any explanation, that he was under arrest for having committed the offense of attempted murder.

The accused said he is if granted bail he would not pose a danger to anyone in society. He also mentioned that he is a Swati national and is willing to surrender his passport at the Mankayane police station. He was therefore granted bail fixed at E12 000.



# Housing ministry Under-Sec. trial to begin in March

A senior government official, Hlobisile Dlamini, who holds the rank of undersecretary (US) in the Ministry of Housing and Urban Development's criminal trial is set to take place on March 4, 2024.

Dlamini was arrested in December 2023 by the police under the Commercial Crimes and Fraud Department. Dlamini's arrest came after an investigation by the police on allegations of playing a role in arranging an unauthorised trip to the United States of America. During this arrangement, it was alleged that the under-secretary forged the signature of the Deputy Prime Minister's Office (DPMO) Under-secretary, Lomkhosi

According to reports, the trip which was scheduled for February 18, 2023, was to be undertaken by a social worker employed under the DPM's Office, which houses the country's social welfare department.

It is worth mentioning that the arrest and subsequent appearance of Dlamini was

kept under wraps as she appeared in the chambers of a magistrate at the Mbabane

Magistrate's Court, where she was released on her own recognisance. The memo was said to have accompanied an application by the social worker whose name is Poppy Mavis Sithole, to be granted an international passport. A woman, from the United States, who is in Eswatini on a visitor's visa, was also found to be involved in the planned travel.

All three people, at the time, were planning to take an unidentified minor child to the United States, where they claimed the toddler was to undergo skin grafting surgery.

They reportedly claimed that a USbased non-profit organisation, known as The Stars Foundation, which advocates for underprivileged children and youth of the world, was going to fund the child's surgery. Dlamini's charge sheet states that the accused is charged with forgery and uttering. In detail, the charge sheet explains that in January 2023 at the Ministry of Home Affairs in the Hhohho region.

The said accused person unlawfully and intentionally defrauded or prejudiced Lomkhosi Dlamini of the Deputy Prime Minister's Office, by forging and uttering or presenting a forged memorandum for the application for a new Swazi service passport for Poppy Mavis Sithole.

In Court, on Tuesday, Dlamini appeared before Principal Magistrate Fikile Nhlabatsi, for the setting of her trial date.

The Crown proposed that her trial should resume on March 4, 2024 and the application was granted by Nhlabatsi.

# Ngwenya murder case: Man allegedly slapped him to death

IN connection with a murder case of Bongani Nkambule, the police have arrested Mangaliso Dlamini from

The accused (Dlamini) appeared at the Mbabane Magistrate's Court before Magistrate Xolile Nxumalo. According to sources close to the matter, while at Ngwenya, the accused engaged in an argument with an unidentified man, which led to a fight. It is said that the deceased (Nkambule) was trying to separate the two men who were fighting, when Dlamini allegedly assaulted Nkambule with open hands which led him to fall on concrete and made him suffer severe bruises. The Royal Eswatini Police Service Chief Police Information Communications Officer (CPICO) Senior Superintendent Phindile Vilakati confirmed the matter, stating

that on 21 January 2024, a 45-year-old man from Motshane was assaulted with an open hand twice on the left cheek and fell on a concrete structure at Ngwenya area. Vilakati said Nkambule sustained serious injuries and succumbed to his death while undergoing treatment at Mbabane Government Hospital. His charge sheet reads: "On January 21, 2023, at Ngwenya the said accused unlawfully and intentionally assaulted Nkambule with open hands who fell on the concrete ground and sustained fatal injuries which caused the victim to die," part of the charge sheet reads.

In court, the accused represented himself but informed the court that he would be seeking the services of an attorney. The crown applied that may the accused be remanded into custody pending his committal to the High Court on February

# Mbabane Pizza Inn scooter knocks down woman

A Pizza Inn employee who drives a delivery scooter knocked down a woman at Mbabane near the Magistrate's Court on a designated zebra-line crossing, causing severe injuries.

The accident occurred after lunch on Monday. According to eyewitnesses, the woman was crossing the zebra-line crossing when the scooter, which was driven by Bongiswa Dlamini, an employee at Pizza Inn, knocked her down.

One eye-witness, in Simphiwe Tsabedze said the scooter was speeding when it approached the woman. It knocked her and she fell on the ground. "The driver of the scooter did not adhere to the rule that cars stop for pedestrians in zebra-line crossing," Tsabedze said.

Tsabedze added that the woman spent a few minutes on the ground and she was able to get back on her feet, distressed and confused, the woman went to sit on the pavement near the

As she sat down, her face was visibly swollen and blood ozzed from her right cheek.

Another eye-witness, Themba Mkhonta, said

"The accident was caused by the negligence of the driver of the scooter. The driver failed to stop, just like other cars for people who are crossing the zebra-lines, his negligence resulted in this mess," Mkhonta said.

Dlamini (the driver) also sustained bruises on his arm. The police arrived to assess the situation, followed by the emergency services 20 minutes later, where they were given medical assistance.



### Oil eases slightly on mixed supply cues, geopolitical tensions

LONDON — Oil prices eased slightly on Tuesday as traders weighed simmering geopolitical tensions in several regions with supply outages in the U.S. and returning production in Libya. Brent crude futures lost 31 cents, or 0.39 per cent, to \$79.75 a barrel by 1019 GMT, while U.S. West Texas Intermediate crude futures (WTI) shed 33 cents, or 0.44 per cent, to \$74.43 a barrel. Brent slipped back below \$80 a barrel after settling above the threshold on Monday for the first time since December 26.

### Rand recovers from three-month lows

JOHANNESBURG — South Africa's rand firmed against a weaker dollar early on Tuesday, recovering from the lows it touched in the previous session. At 0624 GMT, the rand traded at 19.1025 against the dollar, 0.5 per cent stronger than its previous close. On Monday, the currency sank to its lowest in more than three months. The dollar was last down about 0.2 per cent against a basket of global currencies.



# Overpriced services hamper economic growth

THE value of public procurement amounts to 22.6 per cent of the country's gross domestic product (GDP), according to the Minister of Finance Neal Rijkenberg.

As a result, the Ministry of Finance, through the Eswatini Public Procurement Regulatory Authority (ESPPRA), has produced a market price reference catalogue as a mechanism that will, among other things, prevent corruption, ensure transparency, achieve economic efficiency and maximise competition as well as value for money in the use of public funds.

The Minister disclosed this during the launch of the market price reference catalogue for common use items following research commissioned by ESPPRA.

Rijkenberg said "overpricing does not only deplete government funds, but further hampers economic growth and sustainability. The funds that should be redirected towards crucial sectors such as healthcare, education, infrastructure development and maintenance are instead being absorbed by inflated prices. This, in turn, erodes public trust, undermines our commitment to good governance and perpetuates unethical business practices."

By establishing the market price reference catalogue for common use items, government is implementing a transparency tool and sending a clear message that Eswatini is committed to upholding the highest standards of accountability, transparency and integrity.

"It is an opportunity for us to reshape the way we do business, maximize limited resources and drive economic growth for the benefit of Eswatini," said the Minister.

ESPPRA's Chief Executive Officer Vusi Matsebula emphasized the importance of ensuring transparency and accountability in public procurement while maintaining appropriate confidentiality.

In an interview, Matsebula mentioned that the ESPPRA was launching the market price reference catalogue to provide guidance to all public enterprises when purchasing commonly used items. He mentioned that over 1 700 items were investigated and an average price was established, which will remain a guide. Matsebula said the procuring entities would be allowed a reasonable margin to deviate from should the need arise. All ESPPRA regulated enterprises will comply to the market price catalogue.

The catalogue was compiled after a market survey conducted by Eswatini Economic Policy Analysis and Research Centre (ESEPARC).

The survey ascertained that a majority of the country's economic activity took place in the Manzini and Hhohho regions. It also highlighted dissatisfaction among vendors with the public procurement regulatory environment. Their complaints pointed to overdue payments from government, which resulted on services being provided on high interest loans.

Responding to the issue of overdue payments by government, the Principal

Secretary in the Ministry of Finance Sizakele Dlamini said "sometimes the supplier is at fault because a transaction could not be completed without a purchase order. It is true, however, that overdue payments were unreasonable and affected small businesses, but government remain committed to pay in time."

ESEPARC's Research Fellow Tengetile Hlophe advised ESPPRA to use a pricing guide to monitor and audit public procurement. Hlophe further advised that the pricing guide should be updated and adjusted every two years to reflect changes.

"The pricing guide should be used as a reference point for suppliers when quoting prices for government tenders. The use of the catalogue by both the procuring entities and suppliers will ensure that value for money is achieved in Eswatini public procurement."

Another aspect to enhance the public procurement process in Eswatini was the electronic government procurement (e-GP) system. ESPPRA's CEO said "the system improved the quality of the tender documents provided increased

transparency on tender awards, tender opportunities, and procurement expenditure, as well as the adjudication supplier grievances.

Such a system provided improved efficiency and built the capacity procurement practitioners. Furthermore, provided for effective efficient

online service, leading to speedy supply

Matsebula said "deviations to the open tendering procedure may only occur after the regulator has granted authorisation. The procuring entity must apply in writing stating the reasons for the deviation in accordance with Section 6 of the Act and include supporting evidence."

The Act provides for deviation in the case of an emergency, humanitarian crisis, natural or man-made disasters, failure of critical infrastructure and political emergencies such as a civil unrest. This may lead to overpricing and many undesirable elements such as inefficiencies in the procurement process.

In such a situation, ESPPRA needs to evaluate the need for the emergency procurement, prioritize the immediate procurement activities and specify the time at which the procurement will be undertaken, among other requirements. The supplier will then report back to ESPPRA within thirty days after completion of the procurement.

## **Ongoing Consultations**

ESPPRA CEO further highlighted that the process of consulting relevant stakeholders on the pricing guide, which should become live once completed, will go ahead headed by ESEPARC. Critical stakeholders remain the suppliers in this exercise and will be thoroughly consulted to ensure that all the gaps are covered.

"With this tool set to be launched at completion, we believe that a number of current challenges related to public procurement as well as timely payment of invoiced goods will be a thing of the past," he said.

## **Reforms within procurement**

Matsebula further appreciated the Ministry of Finance for continued support in the implementation of the procurement reforms. He said the reforms would address the

economic development glitches caused by unscrupulous and exorbitant pricing. "Some are colluding with the procuring entities as evidenced by the audits conducted in the recent past. He emphasised that such reforms were a necessity, as currently, the ACT only addressed procurement from planning up to the contract management stage. In other countries, the ACT regulates even product storage, distribution, disposal and evaluation, which are part of the procurement process.

"Our ACT needs to provide oversight on issues of wastage at warehouses." he recommended.

# Oil eases slightly on mixed supply cues, geopolitical tensions

LONDON — Oil prices eased slightly on Tuesday as traders weighed simmering geopolitical tensions in several regions with supply outages in the U.S. and returning production in Libva.

Brent crude futures lost 31 cents, or 0.39 per cent, to \$79.75 a barrel by 1019 GMT, while U.S. West Texas Intermediate crude futures (WTI) shed 33 cents, or 0.44 per cent, to \$74.43 a barrel.

Brent slipped back below \$80 a barrel after settling above the threshold on Monday for the first time since December 26.

Prices had risen by around 2 per cent on Monday after a Ukrainian drone strike on Novatek's Ust-Luga Baltic fuel export terminal near Russia's second city St Petersburg raised supply concerns.

"The attack ... is a timely reminder that

a bigger, more influential war is still raging on," said PVM analyst John Evans.

Tensions also rose in the Middle East, where U.S. and British forces carried out a second joint round of strikes on Houthi positions in Yemen on Monday night.

In Libya, production at the 300,000 barrels per day Sharara oilfield restarted on Jan. 21 after the end of protests that had halted output since early this month.

But the returning supply could be offset by ongoing outages in the U.S. because of extreme cold weather. As much as 20 per cent of North Dakota's oil output was still shut in on Monday, the state's pipeline authority said.

The weather-induced shutdowns over the last week could see a drop in crude inventories in Tuesday's American Petroleum Institute (API) weekly report, PVM's Evans added.

A Reuters poll suggested that U.S. crude oil inventories would fall by about 3 million barrels in the week to January 19. (**Reuters**)

# South Africa's Clicks 20-week sales boosted by strong festive season

JOHANNESBURG — South African pharmacy chain Clicks Group said on Tuesday retail sales for its 20-week period rose by 11.8 per cent driven by strong festive season trading and growth in personal care, beauty and essentials such as cleaning products.

Sales in comparable stores increased by 8.4 per cent in the first 20 weeks of its 2024 financial year to Jan. 14, with selling price inflation averaging 7.5 per cent. Overall group turnover rose by 8 per cent to 16.8 billion rand (\$878.71 million).

Chief executive Bertina Engelbrecht said Clicks achieved its highest ever daily sales on Friday, Dec. 22, while the week preceding Christmas was a record trading week for the chain.

Strong growth in personal care, beauty

and everyday essentials was supported by strong sales of private label and exclusive brands, Clicks said.

Sorbet, the beauty salon chain acquired by the group in June 2023, increased franchise and corporate sales by 12.3 per cent over the comparable period.

However, total managed turnover at United Pharmaceutical Distributors (UPD) - its bulk and wholesale division - declined by 6.3 per cent due to its strategy of rationalising its bulk distribution portfolio to focus on profitable clients.

This strategy is expected to benefit margin, Engelbrecht said.

UPD's wholesale turnover was 0.8 per cent lower, owing mainly to the impact of the systems transition at UPD's main distribution centre, the group added. (Reuters)

# South African rand recovers from three-month lows

JOHANNESBURG — South Africa's rand firmed against a weaker dollar early on Tuesday, recovering from the lows it touched in the previous session.

At o624 GMT, the rand traded at 19.1025 against the dollar, 0.5 per cent stronger than its previous close.

On Monday, the currency sank to its

lowest in more than three months.

The dollar was last down about 0.2 per

The dollar was last down about 0.2 per cent against a basket of global currencies.

"The rand remains a passenger along for

the ride and will likely take its direction from developments in the dollar," ETM Analytics said in a note.

This week, investors will focus on consumer and producer price inflation figures for December, which will be released ahead of the South African Reserve Bank's (SARB) rate decision.

South Africa's benchmark 2030 government bond was stronger in early deals, with the yield down 2 basis points to 9.695 per cent. (**Reuters**)

# Woolworths flags lower half-year profit as shoppers spend less

JOHANNESBURG — South African retailer Woolworths expects its half-year profit to fall by as much as 10 per cent due to consumers pulling back on spending on clothes and as the country's energy and logistics crisis persisted.

The food, fashion and beauty retailer, which targets the mid- to upper-income segment of the country, said its headline earnings per share (HEPS) from continuing operations likely fell 5 per cent to 10 per cent in the 26 weeks ended Dec. 24.

Group turnover and concession sales from continuing operations, excluding retailer David Jones which it sold last year, rose 5.4 per cent and by 4.4 per cent in constant currency terms. That was lower than the 12.5 per cent reported in prior period.

Woolworths said performance for the current period has been effected by an increasingly challenging macroeconomic backdrop, given the sustained impact of interest rate increases and higher living costs.

"This has negatively impacted footfall, resulting in a greater-than-expected pullback

in discretionary spend," the retailer said.

Operations were further disrupted by a higher number of power cuts, port congestion and the impact of Avian flu on the availability of staple food product lines such as eggs. During the last six weeks of the period, which included trade during the festive season, sales growth accelerated to 7.2 per cent, supported by Black Friday promotions and holiday season trade, Woolworths said.

Its food business grew turnover by 8.4 per cent, while sales at its fashion beauty and home business grew by 2.2 per cent and by 1.5 per cent in comparable stores impacted by poor availability, due in part to the late arrival of certain summer ranges arising from port congestion.

Trading conditions in Australia and New Zealand have deteriorated further, with consumer sentiment in Australia at near-record lows and household savings the weakest since the global financial crisis, Woolworths said.

As a result, clothing business Country Road Group saw sales decline by 5 per cent, and by 9 per cent in comparable stores. **Reuters**)

make the drones even cheaper."

Some of the drone operators called for UAVs to be tested before they are used in battle.

"We must test drones supplied by new producers or made by a civilian," said one who goes by the call sign "Fest". "In addition to losing the drone itself, we can lose ammunition which is not cheap.'

Another, who uses the call sign "Pit", said drones should conform to standards so that operators know in advance how the device they are asked to operate will work.

"You work a lot and have to do flight after flight while drones differ a lot.

One has different controllers, another different settings, and so on," he said. "When under pressure, it happens that you miss a detail and it leads to missing a target."

### AN INTEGRAL PART OF **UKRAINE'S WAR EFFORT**

Ukraine's defence ministry did not immediately respond to a Reuters request for comment on the soldiers' remarks.

The use of what are known as First Person View (FPV) drones in battle has been one of the more successful low-cost strategies Ukraine has used on the battlefield.

Russia has expanded its own drone fleet since the start of the war, and has improved its ability to block Ukrainian UAVs through electronic warfare, but drones are an integral part of Ukraine's war effort.

Drones range from small UAVs controlled remotely to larger devices that can fly hundreds of kilometres deep into Russian territory. President Volodymyr Zelenskiy has said Kyiv plans to produce 1 million drones

Video footage provided by Ukraine's military, and demonstrating the use of UAVs in action, shows a small drone carrying an explosive device flying into a Russian armoured vehicle parked in a garage before the screen goes blank. Reuters could not independently verify the footage.

Despite their impact, Sam said drones could not win the war on their own. Artillery remains an important weapon against Russian forces using fortified trenches and dugouts, and Ukraine has told its allies it is running short of ammunition.

"This war has like a high-tech side of it and still the old-school trench warfare side of it," Sam said. "Modern warfare today combines modern tactics with old-school tactics working together."

# Doomsday Clock at 90 seconds to midnight

## ... in chilling warning that world is on brink of apocalypse amid WW3

THE Doomsday clock has stayed dangerously close to midnight as the world sits on the brink of nuclear Armageddon.

Scientists revealed today just how close we are to the end of the world as the clock stayed at 90 seconds to the feared midnight hour.

The update came at 3pm UK time or 10am local time in Washington DC by the Bulletin of Atomic Scientists, which organises the clock.

untouched, reflecting a "continuing and unprecedented level of risk", according to the Bulletin.

It is the same number as last year, when it marked the closest to midnight it has ever been.

The scientists who created the clock stressed that choosing not to modify it should not lead to complacency.

They said said the threats posed by Vladimir Putin and his war with Ukraine continue, with Bulletin president and CEO Rachel Bronson saying how the horror October 7 attacks in Israel added an extra source of concern.

The Middle East has become a powder keg unsettled by Israel's ongoing war against Hamas, Iranbacked Houthi rebel attacks in the Red Sea, and recent clashes and strikes between Iran and Pakistan.

However, despite the heightened and new hazards, there was some good news.

The Bulletin acknowledged that The Doomsday Clock has been left there has been some progress in responding to climate change, but the challenge continues to imperil humanity's future.

It also highlighted the weakening of nuclear weapons reduction agreements, the climate change crisis, with 2023 being the warmest year on record, new genetic engineering technologies and AI, and the dangers of disinformation.

The world has been moving towards the brink of WW3 as tyrants Kim Jong-un and Putin have sent a chilling warning to the West as they vowed to form a "New World

Warnings of a potential new world order had already been given by Putin's warmonger foreign minister Sergei Lavrov, who told the West that their time of "global domination" is

veteran Russian And Alexander Osovtsov said World War Three has already begun for the West's enemies and "we're all participating in it".

Meanwhile, Baltic states are racing to bolster defences on their borders with Russia and Belarus as Europe braces for an all-out war.

The Doomsday Clock operates as a wake-up call for the world about global threats such as nuclear war, dangerous technologies and mass health concerns.

Used as a metaphor to signal how close the human race is to selfdestruction by its distance from midnight, it is reset around the same time in January each year by varying lengths.

# Third South Summit ends in Uganda with calls for deeper cooperation

THE 3rd South Summit ended in Kampala on Monday (Jan. 22). It gathered high-level representatives from nearly 100 countries and heads of United Nations agencies.

Uganda's president called to keep promoting the interests of the global south.

"That the Group of 77 and China remains united in its pursuit of collective interests at the United Nations. In the inter-governmental processes of the United Nations, We must ensure that priorities of the Group are promoted and defended," Yoweri Museveni

The two-day meeting was held under the theme "Leaving No One Behind" and is expected to bring a new dynamic to the cooperation among its 134 member states amid the increasingly competitive global environ-

The summit aims to promote South-South cooperation in the fields of trade, investment, sustainable development, climate change, poverty elimination and digital economy.

The South Summit is the supreme decision-making body of the Group of 77 (G77), which was established in June 1964.

Since the 1990s, China has been coordinating and cooperating with the G77 through the "G77 and China" mechanism which is an important platform for developing countries to unite to strengthen themselves and coordinate to respond to challenges.

Over the years, China has joined hands with other member countries to promote South-South cooperation to achieve new and greater progress.

"That the Group of 77 and China remains united in its pursuit of collective interests at the United Nations. In the inter-governmental processes of the United Nations, We must ensure that priorities of the Group are promoted and defended," said Ugandan President Yoweri Museveni, who is also the

"Let us face it, those that benefit most from the present global governance system are unlikely to lead its reform. So momentum for change must come from you," said Antonio Guterres, Secretary-General of the United Nations.

# ActionSA holds municipality accountable for deadly CBD fires

ACTIONSA has called on the City of Johannesburg to account for the ongoing crisis of deadly fires in hijacked buildings.

The party's call comes in response to a fire that broke out on Sunday at the intersection of Commissioner and Nugget streets.

A woman, allegedly involved in a domestic dispute, has since been arrested for igniting the deadly blaze.

This tragic incident is not the first of its

In August, a fire swept through an illegally occupied and abandoned building in Johannesburg and claimed the lives of 77 people. More than 80 people were injured, while scores were left homeless.

It was recognised as one of the deadliest fires in the city's history.

The ActionSA caucus in Johannesburg believes that the fatalities resulting from fires across the CBD (central business district) are a direct consequence of the government's negligence.

## Tactics to Obstruct ActionSA

Caucus leader Nobuhle Mthembu has accused Johannesburg mayor Kabelo Gwamanda of employing various tactics to obstruct ActionSA motions aimed at tackling the problems associated with hijacked build-

Mthembu emphasised that the council's programming committee rejected two ActionSA-sponsored motions in September, citing an inquiry initiated by Gauteng pre-

"We will, however, use every legislative piece to compel the City of Johannesburg to reclaim hijacked buildings before another soul is lost and call upon Gwamanda to usher the City of Johannesburg into an era

mier Panyaza Lesufi, which, to date, has where hijacked buildings will be a thing of the past

She argued that the rejected motions sought to recommend the expropriation of hijacked buildings and their conversion into affordable rental units or social housing.

Said Mthembu: "The recent fire on the corner of Commissioner and Nugget streets, which claimed two lives, is another grim reminder of an administration that has lost touch with reality and believes in quick fixes as opposed to permanent solutions.

"This could have been avoided had the city heeded our calls and reclaimed hundreds of these hijacked buildings, which are not suitable for human occupation.

# Canada caps foreign student visas

CANADA on Monday announced a two-year cap on international student visas to ease the pressure on housing, health care and other services at a time of record immigration.

Immigration Minister Marc Miller said that there will be a 35% reduction in new study visas in 2024. He said that institutions offering "sham" degrees have exploited the international students program, putting pressure on housing and health care.

"It's a bit of a mess, and it's time to rein it in," Miller said.

The number of new visas handed out will be capped at 364,000. Nearly 560,000 such visas were issued last year.

Prime Minister Justin Trudeau's Cabinet retreat in Montreal this week will prioritize affordability and housing, according to a government statement.

The government said that there are about 1 million foreign students in the country now, and without any intervention, this number would keep increasing. The total number of foreign students is more than three times what it was a decade ago.

### Stabilizing

Miller said that officials have been working on stabilizing the number of people entering the country yearly as housing pressures mount.

Canada grew by about 1 million people last year, reaching a record of 40 million, as many Canadians struggle with an increased cost of living, including rents and mortgages.

"You cannot bring in 1.25 million people a year but only create 300,000 homes on average and think you're not going to have a structural problem on housing," TD Bank Group chief economist Beata Caranci said at the Economic Club of Canada's 2024 Annual Economic Outlook earlier this month.

The immigration minister said that there are unscrupulous schools that accept high tuition fees from foreign students without offering a solid education in return. In some cases, the schools are a way into Canada for students who can parlay their visas into permanent residencies.

## Sham

"It is not the intention of this program to have sham commerce degrees or business degrees that are sitting on top of a massage parlour that someone doesn't even go to and then they come into the province and drive an Uber," Miller said. "If you need a dedicated channel for Uber drivers in Canada, I can design that, but that isn't the intention of the international student program," he said. The leader of the opposition Conservative Party of Canada, Pierre Poilievre, called it a mess and blamed Trudeau for granting study permits to tens of thousands of students who attend fake schools. "People are still somewhat shell-shocked and responding to the steep inflationary increases of the past," said Nelson Wiseman, a political science professor at the University of Toronto "There is some debate over the impact of immigration and the massive increase in foreign students on the housing market and rents. The student influx has largely impacted rents and not house prices as few students buy houses." (AFP)

### GAZA/JERUSALEM -Twenty-four Israeli soldiers were killed in Israel's worst day of losses in Gaza, the military said on Tuesday while also claiming to have encircled southern Gaza's main city and killed dozens of Palestinian fighters in a major ground assault of the new year.

Spokesman Rear Admiral Daniel Hagari said 21 soldiers were killed when two buildings they had mined for demolition exploded after militants fired at a nearby tank. Earlier, three soldiers were reported killed in a separate attack in southern Gaza.

"Yesterday we experienced one of our most difficult days since the war erupted," Israeli Prime Minister Benjamin Netanyahu said. "In the name of our heroes, for the sake of our lives, we will not stop fighting until absolute victory."

The deaths came as the Israeli Defence Forces (IDF) attacked the western part of Khan Younis, the main city in the south of the enclave which is sheltering hundreds of thousands of Palestinians who have fled areas to the north. Israel says the city is now the principal base of Hamas, the Islamist group that rules Gaza.

"Over the past day, IDF troops carried out an extensive operation during which they encircled Khan Younis and deepened the operation in the area. The area is a significant stronghold of Hamas' Khan Younis Brigade," the military said.

"Ground troops engaged in close-quarters combat, directed (air) strikes, and used intelligence to coordinate fire, resulting in the elimination of dozens of terrorists."

Gazans say the advancing Israeli forces have since Monday blockaded and stormed hospitals in the crowded city, leaving the wounded and dead beyond the reach of res-

Bodies were being buried in the grounds of Khan Younis's main Nasser hospital because it was unsafe to leave to reach the cemetery. Another Khan Younis hospital, Al-Khair, was stormed by Israeli troops who arrested staff there, and a third, Al-Amal, run by the Pal-

estinian Red Crescent, was unreachable, according to Palestinian officials.

The Red Crescent said a tank shell had hit its headquarters on the hospital's fourth floor, and Israeli forces were firing from drones on anyone who moved nearby, making it impossible to dispatch ambulances for the entire Khan Younis area.

Israel says Hamas fighters operate in and around hospitals, making them legitimate targets. Hospital staff and Hamas deny this.

## 'Graveyard for the occupation'

As news of the Israeli losses spread through Gaza, Palestinians celebrated what they viewed as a victory.

"The resistance said it is going to make Gaza a graveyard for the occupation, and this is what is happening," said Abu Khaled, sheltering in a school in Deir al-Balah, one of the few areas yet to be stormed by Israeli forces, between Khan Younis and the central zone where the Israeli troops were killed.

"The more they stay, the more we will suffer for sure, but the more they will suffer

Israel has vowed to wipe out Hamas, which is sworn to Israel's destruction and sent fighters through Israel's border fence on Oct. 7, killing 1,200 people and abducting around 250 hostages, of whom about half remain in Gaza.

At least 25,295 Gazans have since been confirmed killed, according to Palestinian authorities, with thousands more dead feared lost in the rubble of a coastal strip largely laid to waste.

Nearly all of Gaza's 2.3 million people have lost their homes, the vast majority

now penned into small towns just north and south of Khan Younis, many sleeping rough in makeshift tents, with food and medicine running out and no clean water.

Israel itself is beginning to see the first stirrings of discontent with Netanyahu's war strategy - committed to the total annihilation of Hamas but with only vague discussion of what should come next for Gaza.

Since last week, Netanyahu has publicly vowed never to let Palestinians have an independent state, a break with Israel's main ally Washington, which has made a peace process ultimately leading to a Palestinian state the bedrock of its Middle East policy

Relatives of hostages still held in Gaza have called for more effort to bring them home, even if that means reining in the military campaign. A group of them burst into a parliamentary committee hearing on Mon-

Last week, a member of Netanyahu's war cabinet, former military chief-of-staff Gadi Eisenkot, whose own soldier son was killed in Gaza last month, said the campaign had yet to achieve its aim of dismantling Hamas and that there was no hope of freeing the hostages in a military operation. He called for elections to replace a government that he said had lost public confidence.

# Turkey set to approve Sweden's NATO membership bid

ANKARA - Turkey's parliament is widely expected to approve Sweden's NATO membership bid on Tuesday, clearing the biggest remaining hurdle to expanding the Western military alliance.

Turkey's general assembly, where President Tayyip Erdogan's ruling alliance holds a majority, is set to vote on Sweden's application about 20 months after Stockholm asked to join NATO following Russia's fullscale invasion of Ukraine.

Once parliament has ratified the move, Erdogan would be expected to sign it into law within days, leaving Hungary as the only member state not to have approved Sweden's ac-

Hungary has said it believes NATO membership is "not a priority" for Sweden based on its actions. It had pledged not to be the last ally to ratify Sweden's membership, but its parliament is in recess until around mid-February.

Turkey and Hungary maintain better relations with Russia than other members of the U.S.-led North Atlantic Treaty Organization.

While opposing Russia's invasion of Ukraine, Turkey has criticised Western sanctions on Moscow,

# China undergoes rare scrutiny of rights record at UN meeting

**GENEVA** China underwent scrutiny of its human rights record at a key U.N. meeting on Tuesday, with Western countries calling for more protections for Xinjiang Uyghurs and greater freedom in Hong Kong while Beijing said it had made historic progress.

The review at the U.N. in Geneva is the first since the global body's top rights official released a report in 2022 saying the detention of Uyghurs and other Muslims in China's Xinjiang region may constitute crimes against humanity.

China has been lobbying non-Western countries to praise its human rights record ahead of the meeting by sending memos to envoys in recent weeks, diplomats told Reuters.

China's diplomatic mission did not comment on the reported lobbying. Its delegation in Geneva said on Tuesday it had made progress since its last U.N. review in 2018, saying it had lifted nearly 100 million people out of poverty.

"We embarked on a path of human rights development that is in keeping with the trend of the times and appropriate to China's national conditions and scored historic achievements in this process," said Ambassador Chen Xu at the meeting.

Some 163 countries are set to speak at the Tuesday session and countries had only 45 seconds each to speak.

Many countries lauded China's efforts on human rights, including Ethiopia and Cameroon. Western countries raised concerns including Germany, which cited human rights violations in Xinjiang and Tibet, and Canada which called for China to repeal a controversial Hong Kong national security law.

# Conspiracy theories as jury selection starts for Jam Master Jay's murder trial

JURY selection began on Monday in the trial over the murder of Jam Master Jay, the innovative Run-DMC DJ who was killed in his Queens studio two decades ago.

The trial is centred on the events of October 30, 2002, when the pioneering rap music star Jason "Jay" Mizell was fatally shot in the head.

The artist was 37 years old and a father of three.

The infamous New York murder was in limbo as a cold case for nearly two decades, until federal prosecutors in August 2022 announced a 10-count indictment against suspects Ronald Washington, now 59, and Karl Jordan Jr, the alleged shooter who is now 40.

All three men hailed from Hollis, Queens. Both defendants are imprisoned in Brooklyn, and face charges of murder while engaged in narcotics trafficking, and

Jordan, who was 18 at the time of the alleged crime, also faces several additional narcotics distribution counts.

firearms-related murder.

According to court documents, the motive was linked to Mizell's acquisition of cocaine that was intended for distribution in Maryland by a group including Washington and Jordan

An internal dispute resulted in Mizell cutting Washington out of the deal, which according to prosecutors led to the murder

The killing was particularly shocking given the reputation of Run-DMC, a 1980s-era hip hop group known for hits including 'It's Tricky' and 'Christmas In Hollis.'

The trio regularly railed against violent gang culture, which in the early 1990s became associated with rap music.

Over the years, investigators had explored a number of possible motives - including that the fatal shooting involved a grudge against fellow Queens-born rapper 50 Cent, who was Jam Master Jay's protege. That theory was later dropped.

Jam Master Jay's slaying followed a spate of murders within the rap community in the 1990s, including the shootings of superstars Tupac Shakur and The Notorious B.I.G.

Along with LL Cool J and Public Enemy, Run-DMC were trailblazers of new school hip hop - a sound characterized by rock elements, aggressive boasting and sociopolitical commentary - and its outgrowth golden era hip hop, which included eclectic sampling.

All heralding from the Hollis neighbourhood of Queens, Run-DMC included its DJ - Jam Master Jay - and the MCs who dropped rhymes, Joseph "Run" Simmons and Darryl McDaniels, or "DMC."

They also established a new, enduring rap aesthetic incorporating street culture, a departure from the flashy, disco-inflected attire of the group's predecessors.

Their single 'My Adidas' off their hit album 'Raising Hell' led to a massive endorsement deal with athletic brand adidas, kicking off today's inextricable link between hip hop culture and sneakers.

And the 'Walk This Way' remake off the same album was even more successful than the original 1970s hit, with Run-DMC and Aerosmith performing a groundbreaking rap-rock version that became a touchstone of the genre and an international hit.

Prior to his death, Mizell became particularly influential in New York as a local cultivator of talent, working with young aspiring rappers and founding a DJ Academy.

Jurors will be anonymous, and opening statements are currently scheduled for January 29. There had been a chance that, if found guilty, the men would face the death penalty. But in 2021, the government notified the court that US Attorney General Merrick Garland had directed against that punishment in the event of conviction.

In May 2023 prosecutors filed a superseding indictment that charged a third defendant, Jay Bryant, now 50. He will be tried separately, according to a court spokesperson.

SO, what is the prostate and why does it cause so many problems for men?

It's a topic most people don't want to discuss. But it can have a big impact on your

The prostate is a small organ that sits just beneath the bladder. Its main function is to provide a nourishing fluid that helps transport

As men age, the prostate tends to increase in size. And as the gland enlarges, it can block the flow of urine from the bladder. In plain English, that can make it harder to pee, and lead to a lot of middle-of-the-night trips to the

That's what King Charles has: an enlarged prostate, also called BPH, or "benign prostatic hyperplasia." The key word here is "benign," with symptoms that are rarely life-threatening.

A bigger problem is when the prostate becomes cancerous. Prostate cancer is the second-leading cause of cancer death in men, and is what Defense Secretary Lloyd Austin was diagnosed with.

What makes this tricky is that, while about 1 in 8 men will be diagnosed with prostate cancer, it often grows so slowly that about 80% of those men, if untreated, would end up dying of another cause, including old age.

But sometimes prostate cancer is fastgrowing, and a real threat.

#### So, what to do?

You may be familiar with a screening blood test called PSA, or prostate specific antigen. There are limitations to using PSA testing to screen for prostate cancer, since this protein is made by both BPH (an enlarged prostate) and cancerous prostate tissue.


Since both BPH and prostate cancer lead to increasing levels of PSA, there are concerns PSA screening leads to overdiagnosis and overtreatment. That, in turn, has prompted disagreement among medical professionals about its overall benefits.

Tests can sometimes yield a false positive: you suspect you have cancer when you actually don't, leading to an unnecessary biopsy; or, you diagnose and over-treat a slow-growing cancer.

Bottom line: Talk to your health-care provider and have a careful discussion about the risks and benefits of screening, taking into account individual factors like family history, age, race, and more.

If your PSA is elevated, other tests may help decide if a biopsy is needed. If cancer is suspected, a biopsy can confirm it, and a wide range of approaches can be considered: from active surveillance (just monitoring the tests and seeing if the cancer grows), to zapping only the part of the prostate where cancer has been found, to removing or destroying the



When it comes to prostate cancer, Black men are also more likely than other races to:

- ► Be diagnosed at an earlier age
- ► Have fast-growing, or high-grade, tumor cells
- ► Have prostate cancer that has spread to other parts of the body (called advanced or metastatic cancer)

We have a better understanding about prostate cancer in Black men than we used to, but more research is needed. Racial minorities are often left out of clinical research for various reasons. But there's a growing push to include more Black men in clinical trials.

### **Why Does Prostate Cancer Affect Black Men Differently?**

Health disparities are largely blamed on decades of racial bias and discrimination. You may hear this called systemic or structural racism. It can impact every part of life, including access to healthy food, jobs, housing, and medical care.

But experts are still trying to find answers for exactly why prostate cancer is more common and fatal in Black men. Some theories include:

Barriers to care. Black men often have less access to health insurance and high-quality medical care. Access to medical services, education, employment, and income all impact how healthy you are. If you're a Black man with prostate cancer, racial and socioeconomic barriers can contribute to:

- ▶ Delays in treatment
- Lower rates of prostate cancer screenings
- Less health education about treatment choices

- ► Lower quality care
- Less high-benefit treatments, such as

Bad advice: From 2012 to 2018, the U.S. Preventive Services Task Force (USPSTF) said they didn't think the PSA test should be used for routine prostate cancer screening. That's a blood test commonly used to detect early signs of prostate cancer. They've changed their guidance since then, saying that men should make that decision with their doctors based on their personal risk of prostate cancer. But some researchers think the recommendation against PSA screening likely took a heavier toll on Black men compared to other races.

Medical mistrust: Black people are often less trusting of the health care system. There are cultural and historical reasons for this.

Fewer Black doctors: People may feel more comfortable with a doctor who shares their race. While 13% of the population is Black, only five per cent of the workforce includes Black doctors. And only two per cent of urologists are Black. Urologists are specialists who often diagnose and treat prostate cancer.

Other health problems: Your lifestyle, such as what you eat and whether you exercise or smoke, along with your genes, impact your health. And the ongoing stress of systemic racism can also make you sick.

Certain medical conditions occur more often in Black men. Some that can negatively affect prostate cancer outcomes include:

- ► Heart disease
- ▶ Diabetes
- Overweight or obesity

Genetic variants: Genes are passed down through families. And there's some evidence that Black men may inherit the risk for more aggressive types of cancer or certain genetic mutations, or changes. There's ongoing debate about how much biology impacts prostate cancer in Black men. We may know more in the future as genetic testing becomes widely available.

### Prevention, Screenings, and **Active Surveillance**


Early detection is key in prostate cancer. Nearly 100 per cent of men from any race will live 5 years past their diagnosis when prostate cancer is found early. But the disease is a lot harder to treat when it spreads to other parts of the body.

The 5-year-survival rate for men of all races drops to 30 per cent when they're diagnosed with advanced, or metastatic, prostate cancer.

Experts think prostate cancer screenings could save more Black lives than those at lower risk. That's because there's a strong link between midlife PSA levels in Black men and aggressive prostate cancer later on.

The American Cancer Society guidelines recommend the following for higher-risk groups:

▶ Discuss prostate cancer screening at age 45 if you're a Black man or you have a father or brother diagnosed with prostate cancer before



▶ Go over the pros and cons of active surveillance. This is when your doctor monitors your prostate cancer but doesn't give you treatment right away. This is also called watchful waiting. It's a common approach for low-risk tumors, but it might not work as well for Black men. Prostate cancer may be more likely to grow and spread in a Black man during active surveillance.

But if you choose this option, your doctor will likely:

- ► Check your PSA levels every six months
- ► Give you a digital rectal exam at least once
- Go over treatment options when your tests change

#### How Do Black Men Respond to **Treatment?**

Scientists don't know if certain prostate cancer treatments work better for men of different races. But there's evidence that Black men do just as well or better than men of other races when the same kind of care is available.

Black men with prostate cancer that hasn't spread to other parts of the body (called nonmetastatic) tend to live just as long as white men when both groups get the same kind of treatment. Radiation therapy may work better for Black men with early prostate cancer. And hormone-based therapy may be more effective for Black men with metastatic castration-resistant prostate cancer (mCRPC). That's a type of aggressive prostate cancer that no longer responds well to testosteronelowering therapy. Make sure your doctor goes over all your treatment choices. Black men with aggressive prostate cancer can benefit from surgery or radiation therapy. But they're less likely than other races to get it. If your doctor doesn't suggest these treatments, ask them why. You can also get a second opinion from another doctor.

## What You Can Do

To lower your chances of prostate cancer, you should:

- Exercise at least 150 minutes a week to get your heart rate up
- ► Eat plenty of fruits, vegetables, and whole
- ► Maintain a healthy body mass index (BMI) Limit red meat, alcohol, and highly

If you smoke, quit. Current smokers are more likely than nonsmokers to have aggressive tumors or cancer that comes back after treatment. Smoking also raises your odds of dying from prostate cancer.

You can also:

- Learn all you can about your treatment
- ► Find out which tests and treatments your insurance covers.
- ► Ask your doctor about genetic testing.
- ► Enroll in a prostate cancer clinical trial.

If you're a Black man who's been diagnosed with prostate cancer, you can share your experience with researchers leading the RESPOND study. These experts hope to uncover what's behind disparities in prostate cancer for Black men. The study is supported by the National Cancer Institute and the National Institute on Minority Health and Health Disparities along with the Prostate Cancer Foundation. DRINKING one glass or more of 100 per cent fruit juice each day is associated with weight gain in children and adults, according to a new analysis of 42 previous studies.

The research, published Tuesday in JAMA Pediatrics, found a positive association between drinking 100 per cent fruit juice and BMI — a calculation that takes into account weight and height — among kids. It also found an association between daily consumption of 100 per cent fruit juice with weight gain among adults.

100 per cent fruit juice was defined as fruit juices with no added sugar.

The increases were small — among children, for example, each additional serving per day was associated with a 0.03 higher BMI — but it did vary depending on age, with BMI increases appearing greater for younger children.

"Our analyses suggested that younger children," those under 11 years old, "showed a greater BMI gain per every 8-oz additional serving per day of 100 per cent fruit juice than the older

much you consume.

"Our findings are in support of public health guidance to limit consumption of 100 per cent fruit juice to prevent overweight and obesity," the authors write.

It also raises the question: If fruit is good for you and recommended as part of a healthy diet, why can 100 per cent fruit juice lead to weight gain? The authors point to "liquid calories" as a possible factor.

"A potential mechanism linking 100 per cent fruit juice to weight gain is the consumption of liquid calories, which has been shown to result in greater weight gain compared with the ingestion of solid calories," they note.

Juice contains "little to no fiber compared with the whole fruit form, resulting in low satiety," they add, meaning that juice will not make you feel as full as eating fruit itself. The authors also note their

If you want to enjoy that fruit flavor with fewer calories, the CDC recommends adding a splash of 100 per cent juice to plain or sparkling water for a "refreshing, lowcalorie drink." CBS Health

# Gavin Hunt gives Khama Billiat a thumbs-down

KHAMA Billiat's search for a club continues after he was told to stop training with SuperSport United.

## Going AWOL

The former Ajax Cape Town and Mamelodi Sundowns star has been kicking his heels in frustration since leaving Amakhosi under mysterious circumstances in June 2023.

With his future at the Chiefs uncertain since his contract expired on June 30, the Glamour Boys issued a statement that left fans dumbfounded, saying Billiat had gone AWOL

(absent without leave).

"Following the expiry of attacking midfielder Khama Billiat's Kaizer Chiefs contract on June 30, 2023, the club tabled a new offer for the Zimbabwean marksman to remain with Amakhosi, said Chiefs in a statement.

"However, to date, the player has not responded to the offer.

"Billiat was last seen at the Kaizer Chiefs Village on June 29 and has not answered any of the calls or messages sent to him by the club.

"The team is currently in camp with all the players, yet Billiat, who is also expected to be there with his teammates, failed to show up and is currently nowhere to be found."

Since leaving Chiefs, the former 2016 PSL Footballer of the Season and CAF Champions League winner has been linked with Cape Town City and some clubs in North Africa, but nothing has materialised.

# Royal AM confident on dodging FIFA ban bullet

ROYAL AM are optimistic about dodging the FIFA ban bullet because they believe they have strong cases in two matters that got them in trouble with the football governing body.

"MaMkhize" Shauwn Mkhize, a charismatic and outspoken businesswoman from KwaZulu-Natal, owns the team, and FIFA's ban on player registration has had a significant negative impact on the team's performance in the DStv Premiership.

Royal AM have had a difficult start to the season due to their inability to beef up the squad with new players. They are at number 14 on the log, one position away from relegation.

The team was handed a player registration ban for owing money to former players Samir Nurkovic and Ricardo Nascimento.

Nurkovic is now with TS Galaxy, while Nascimento is still without a club after he was released with two months left on his contract.

The club cleared the air on Tuesday and unpacked how it finds itself in this precarious situation.

## Contractual dispute

Reads a statement from Royal AM: "At the end of April 2023, two months before the expiry of Mr Nascimento's contract, Royal AM FC terminated the contract and paid out Mr Nascimento the remainder of the unexpired term of his employment contract — May and June 2023.

"Mr Nascimento referred a contractual dispute to FIFA's dispute resolution chamber [DRC] for payment of the salary for May and June 2023, payment of the salary for the option period, which Royal AM did not exercise, and an R120 000 bonus.

"On September 28 2023, the FIFA DRC granted Mr Nascimento an award for a payment of R600 000. Royal AM appealed with the Court of Arbitration for Sports [CAS] and requested a motivated decision from FIFA.

"On the 7th of November 2023, FIFA notified [of] its motivated decision, and upon perusal, Royal AM FC established that the award made by the FIFA DRC was [for a] salary for May and June 2023, which Royal AM had already paid to Mr Nascimento.

"All other claims by Mr Nascimento were rejected by the FIFA DRC. In light of this revelation, the CAS appeal was withdrawn."

### FIFA transfer ban

FIFA notified Royal AM of the transfer ban on January 15 2024, for non-compliance with the award that Royal AM had already paid.

"Royal AM legal representatives are in the process of clarifying this issue with both FIFA and Mr Nascimento's legal representatives and have already provided proof of payment to FIFA," said the club in a statement.

"The registration ban shall be lifted in due course."

In regards to the matter involving Nurkovic, the club explained: "Royal AM confirms that the appeal against the FIFA decision in the Nurkovic matter is still pending at CAS.

"The delay in the finalisation of the matter has been occasioned by the refusal by Mr Nurkovic and FIFA to have an expedited procedure and the refusal by Mr Nurkovic to pay his share of the advanced

"Royal AM has paid the full advanced costs, which include Mr Nurkovic's share of the advanced costs.

"It is worth noting that Mr Nurkovic has now expressed his desire to have the matter expeditiously resolved, and Royal AM agrees with this proposal.

"Currently, we await a directive from the CAS office regarding the appointed arbitrator in this matter, the procedure to be adopted, and the allocation of the date of this hearing." (Sunday World)

He further said they currently had limited resources to construct such a stadium.

"We do not have enough funds to construct a proper stadium with our limited budget of E40 million," he said.
