WITH public tenders valued at E10 billion per annum, the Government has moved swiftly to end the gravy train enjoyed by companies that have been supplying goods to the state at inflated prices.

The Eswatini Public Procurement Regulatory Agency (ESPPRA) has produced a detailed 713-page document on the market prices reference for common-use items two weeks after the catalogue was launched by the Minister of Finance Neal Rijkenberg at Sibanesami Hotel.

The new market prices reference for common items came as a result of a survey undertaken by ESPPRA in collaboration with Eswatini Economic Policy Analysis and Research Centre (ESEPARC) and carried out in all four regions of the country namely, Manzini, Shiselweni, Lubombo and Hhohho.

The report states that at least three quotations per item should be solicited from selected outlets in the different regions and in cases where it was impossible to obtain at least three price quotations per item, the prices were excluded from the Market Price Reference

The Market Price Survey for commonuse items within public and government agencies discovered glaring differences in the price of goods and services supplied to the government.

In the survey, it was mentioned that the extent of price variations was due to several factors. From now onwards, every public enterprise and government department will be expected to use the new prices as reflected in the catalogue which effectively means the government is switching off the inflated tender prices taps.

During the launch, ESPPRA Chief Executive Officer, Vusi Matsebula made it clear that any public entity that does not use the catalogue when procuring goods would be in breach of the Public Procurement Act of 2011.

Matsebula told the Eswatini Daily News on Sunday night that there will be a presentation to the suppliers to officially

inform them of the new Market Prices reference for common items.

"As a regulator, we believe the PS (Principal Secretary) will be the right person to explain everything regarding the new market prices and he did ask that when we do the presentation he must attend. He is the right person to answer all questions regarding this matter," Matsebula said.

Under the new Market Price Reference, a cabbage under 'Fruits and Vegetables', for instance, cannot be charged above E20.23, which is the upper limit value for the Lubombo region while it is E15.72 for the Hhohho region, E13.81 for Manzini and E15.46 for Shiselweni region.

ESPPRA has recommended the implementation of regional procurement restrictions to ensure that procuring entities only procure in their region, which in turn, will increase economic activity in particular in the Shiselweni and Lubombo regions.

Market price survey recommendations:

- The ESPPRA should create an online registration platform for all suppliers and procuring entities.
- The ESPPRA should ensure the use of the e-Catalogue by tackling resistance to change via dedicated campaigns that include a wide range of stakeholders such as procuring entities, vendors and policymakers.
- 3. The ESPPRA should also develop rules and regulations to enforce the use of the e-Catalogue by procuring entities when making procurement decisions and use

their pricing guide to monitor and audit public procurement in the country.

- 4. The functionalities and user-friendliness of the e-Catalogue should be continuously improved by soliciting user feedback.
- The list of commonly used items should be reviewed and updated because some items were discovered to be outdated in terms
- of description (e.g. building material) specification (e.g. ICT) and quantity (e.g. groceries)
- Vendors or suppliers of common-use items need to be sensitized and made aware of the Market Survey via targeted awareness campaigns on social media, radio, newspapers and television.

PM calls for unity in tackling crime

PRIME Minister Russell Dlamini, through Deputy Prime Minister Thulisile Dladla, made a strong call for police officers and emaSwati alike to take ownership of their communities and work together to combat crime.

The Premier made the clarion call during the Christian Police Association's Annual Prayer service held Friday at the Matsapha Police Academy.

Speaking to the theme of the service, "Being Your Brother's Keeper," the Prime Minister emphasized the importance of mutual care and fulfilling one's constitutional duty. He stressed the need for officers to not only look after each other but also to effectively carry out their mandate of curbing crime and minimizing road accidents. "This service is testimony that the police service as an organisation is constitutionally mandated to maintain and defend national safety and security is cognisant of the fact that whosoever watches over the city, devoid of

the Lord's presence, watches in vain." Said the Prime Minister. "The theme of this prayer service, Be Your Brother's Keeper, derives from the book of Genesis 4 verse 9 could not have been more significant than at this present moment in time when the country is experiencing an increase in contact crime like gender-based violence, passion killings and murder, kidnapping, human trafficking, anti-robberies, house breaking and theft, rape and many more."

The Prime Minister further expressed that corruption is preventing progress in the country. "This I would identify as one of the major stumbling blocks towards economic recovery and social cohesion, as well as the political and the political and economic development of the country." Shared the Premier. "This is an important moment in the future as the police service has a pivotal role to play in the suppression and uprooting of the scourge. That will not be easy. It is not going to be an easy task as this crime scourge is highly contagious and one can easily be contaminated by the temporary attraction and appeal of such unscrupulous, getrich-quick tendencies and shady dealings depriving the larger section of society of true

services and opportunity."

Acting National Commissioner of Police Lydia Dlamini echoed this sentiment, commending the service's focus on seeking divine intervention for the police force. She assured the public of the police's continued commitment to collaboration with all stakeholders in their efforts to maintain safety and security.

The annual prayer service, launched in

1995, serves as a vital platform for reflection and renewal for the police force. It comes at a crucial time, as Eswatini grapples with challenges such as murder, armed robbery, gender-based violence, and stock theft. Such was shared by the Acting NatCom who further highlighted the recent incidents of a mother who murdered her three children in Hhohho by forcing them to ingest poisonous substances. She also noted with disregard the ruthless killing of Sifiso Simelane, a Matsapha-based businessman who was slayed and found in Malkerns.

The Prime Minister further persuaded the police services to deduce that there is a spiritual warfare as the country grapples with the soaring crime rate. "One may be persuaded to deduce that there is a spiritual warfare as long as we look out for each other. Pray for love and peace, embrace our Christian beliefs and values, and pray for peace," the Premier asserted "Then we shall overcome all obstacles that an enemy may lay on our path. Our inspiration emanates from Jesus' teachings to the congregation as scripted in Mark 12 verse 31 that we must love our neighbours as we love ourselves. Therefore, I implore the people here present and members of the police service in particular to be your brother's keeper."

Bumper Cotton harvest expected this year

THE Eswatini Cotton Board is looking forward to an increased harvest this year.

Chief Executive Officer Dr Daniel Khumalo said the rains had given hope that there would be increased yield and production in the cotton industry this year.

He lamented that during the 2022 season, the industry saw a decline in production compared to the 2021 season, due to the late commencement of rainfall.

He said during the 2022 season, rainfall only came in February, denying most farmers a chance to grow cotton, which is a source of livelihood in drought-prone areas.

"However, in 2023, rains began in October until December, and cotton farmers went all out in the fields to plant cotton because this too is the planting season. The current season indicates a better focus going forward," Khumalo said. The CEO disclosed that the Board employs about 80 seasonal workers during cotton ginning. This creates the required employment for emaSwati living around the farming areas, giving them the most needed employment.

He said since the rainfall distribution has been good since October 2023, most farmers have planted in all cotton-growing areas.

He further highlighted the increase in cotton prices from E6,300 to E6,500 per tonne, making it E6.50 per kg, a price that was warmly welcomed by farmers. This he said was an indication that production would be high at the ginnery.

Khumalo said the Board also observed that

farmers were pleased with the new cotton seeds which were seen producing clean cotton balls. "This has restored confidence in the cotton industry as more are making a comeback, and we are looking forward to the yield this year," Khumalo said.

Production

He further stated that they were looking forward to the construction of a dam through the Umkhondvo and Ngwavuma rivers which will be used to irrigate cotton plants. Khumalo said the Board was confident and urged cotton farmers to go all out in planting and production.

He further highlighted that climate change continued to threaten agriculture worldwide and Eswatini has not been spared from its

impact, referencing the drought experienced by the industry in the 2022/23 season.

This he said saw the industry engaging irrigating growers to meet the ginnery throughput, further highlighting that in 2021, a total of 63 hacters was grown under irrigation and an increase of 93 hacters was observed in 2022. "With the future of crop production leaning towards irrigation, the industry was on the verge of recruiting more growers. Irrigated cotton saw a significant contribution to the ginnery throughout the 2022 season," he said.

The yield from irrigated cotton was 288 tonnes in 2022. Khumalo further mentioned that small-scale cotton farmers continued to thrive under rain-fed conditions in the past

season. The area under production was 450ha, producing 206 tonnes of cotton.

Small-scale cotton farmer Khanyisile Bhembe said her love and passion was revived by the new seeds as well as the price increment.

"With the previous seeds called scencana, there were a lot of worms that would damage the plant resulting in spoilt yield. Now with the new seed we don't get such and we were told this is good produce, we don't need to spray pesticides a lot," Bhembe said.

She further said she also noted that even the cotton balls were not falling off the plans which meant they would indeed produce and sell more yield. She also highlighted that she heard from those who sold cotton last year that the money was appealing, thus encouraging her to return to the field. Another, Gcamile Tsabedze said the process of selling bales of cotton and receiving immediate payments began last year.

This she said was very encouraging to them as farmers. "Two hours doesn't pass by after you deliver your bales and payment is received soon after. I think this will allow the industry to grow and encourage cotton farmers to work hard," Gamedze said.

MICS6 reveals more challenges for children in Eswatini

THE Ministry of Economic Planning and Development, in collaboration with UNICEF, recently unveiled the much-anticipated findings of the sixth Multiple Indicator Cluster Survey (MICS6).

This comprehensive survey sheds light on crucial aspects of life in Eswatini, focusing on education, health, social protection, and other areas impacting children, women, and men.

One striking finding is the prevalence of male-headed households, with 56 per cent falling under this category. Additionally, a quarter of household heads hold only primary education, highlighting potential limitations in educational attainment across generations.

The survey also paints a picture of a society with relatively low marriage rates among individuals aged 15-49. With 57 per cent of women and 70 per cent of men in this age group remaining unmarried, it raises questions about family structures and their potential implications for social dynamics.

Concerning children, the MICS6 reveals concerning trends. Only one in four children live with both parents, while a majority (38 per cent) reside solely with their mothers. Furthermore, a significant portion of children (22 per cent under 5 and 21 per cent aged 5-17) come from underprivileged households, raising concerns about poverty's impact on their wellbeing. Education levels among mothers of young children also present a challenge. 30 per cent of mothers with children aged 5-17

and 24 per cent of mothers with children under 5 possess only primary education. This could potentially influence educational opportunities for the next generation.

The Eswatini Multiple Indicator Cluster Survey (MICS) was carried out in 2021-2022 by the Central Statistical Office as part of the global MICS programme. Technical support was provided by the United Nations Children's Fund (UNICEF). UNICEF and the Government of Eswatini and other partners provided financial support. The objective of this snapshot is to disseminate selected findings from the Eswatini MICS 2021-2022related to Drinking Sanitation & Hygiene (WASH).

Originally, the Multiple Indicator Cluster Survey (MICS) is a household survey programme developed by UNICEF in the mid 90's to assist countries in filling data gaps for monitoring the situation of children and women. It is capable of producing statistically sound, internationally comparable estimates of these indicators.

Launch

Speaking at the launch, UNICEF Representative Amina Mohammed urged stakeholders to utilize the data to support vulnerable populations including children and women. She further thanked all users of the data for their input during the MICS inception, particularly their inputs on the questionnaire development phase to ensure the survey collects valid data. The Representative assured stakeholders that they can confidently use the evidence generated as the Central Statistics Office with support from UNICEF has the expertise to generate credible data to inform development

According to the Ministry, MICS6 survey aims to provide policymakers and program implementers with updated data on vital national indicators. This information is crucial for monitoring and evaluating existing programs, assessing progress towards the Sustainable Development Goals (SDGs), and informing future policy decisions.

Also, the survey's findings have revealed that almost 8 in 10 households use drinking water from an improved source which is accessible within 30 minutes. The use of basic drinking water is more in urban areas (95 per cent) than in rural areas (72 per cent). It also revealed that about 1 in 2 households obtain water within premises and collection of water is primarily the responsibility of women (57 per cent). Overall, 58 per cent of the household population use basic sanitation that is not shared with other households, and the use of this basic service is more in rural areas (61 per cent) than in urban areas (49 per cent). The availability of handwashing facilities on premises with soap and water is more in urban than in rural areas (62 per cent vs 52 per cent). Open defecation is at 4.6 per cent nationally, people in rural areas are 6 times more likely to use open defecation than those in rural areas. Lubombo region (10 per cent) has the highest proportion of population using open defecation. The quality of the water source is poor. The quality of the source in rural areas is worse than those in urban areas (73 per cent vs 36 per cent). Those with low economic status and living in the Hhohho region are highly likely to use poor quality water sources.

MINISTER of Health Mduduzi Matsebula has urged practitioners in the sector to ensure they create a healthy environment and appropriate service delivery to patients.

Matsebula was speaking during the seventh Health Sector Annual Prayer held for health practitioners at Ezulwini on Saturday. This is part of the Ministry's wellness programme.

The Minister said the Ministry and the country have done well in a lot of things despite the challenges encountered.

He said nationally, regionally, and internationally, Eswatini is greatly respected and highly spoken about when it comes to the health sector, therefore important to recognize and applaud such, and not be overwhelmed by the negative news/ feedback.

"Yes, we are supposed to be moving and working at full speed, and fix that which needs mending, but we also need to give ourselves a hand over the good we do as a Ministry and country," he said.

Matsebula urged the practitioners to leave the prayer service with a heart and mind to demonstrate that they are praying Christians, something that must be visible in the way they treat patients and execute their duties.

He said there had been complaints received about the sector and hoped the prayer session would be a reminder for all health workers to create a customer centric environment in their respective workplaces.

The Minister further stated that the annual prayer also allowed for health workers to connect spiritually through God, thus strengthening their relationship as colleagues and with patients.

"Gathering in prayer is very important and helpful for health practitioners because it is a challenging job whereby, in the long run when we are frail and losing our physical strength, we then tap into the spiritual for revival," he

Worth noting is that the country's health sector is in the process of recovering, following complaints from emaSwati during the people's parliament, specifically on the drug shortage that had engulfed the Ministry birthed by alleged corruption within the sector.

As a result, a National Drug Crisis Committee chaired by Minister of Commerce Industry and Trade Manqoba Khumalo was formed with the intent to investigate and address all the issues within the sector to ensure that no lives are lost due to drug shortages and those at fault face the law.

TWO unidentified pedestrians were knocked by a Volkswagen sedan which was driven by a 27-year-old near Madlangemphisi.

The accident was reported by Police Chief Information and Communications Officer Senior Superintendent Phindile Vilakati through a press release.

The press release states that on January 27, 2024, at about 00:05 am near the Madlangemphisi area, a Volkswagen sedan driven by a 27-year-old man from Gucuka knocked down two pedestrians a 22-yearold man of Maguga and a 29-year-old of Gucuka.

The 22-year-old sustained serious injuries all over the body and was taken to Dvokolwako Health Centre where he was

certified dead upon arrival while the other pedestrian was admitted as he got injuries on both legs. The suspect who was driving the motor vehicle has been arrested by police from Mliba and is set to make his court appearance on Monday.

It was also reported that on January 27, 2024, at 10:30 am at Ndlunganye intersection along MR3, Manzini lane a white Nissan NP300 driven by a 49-year-old man lost control, veering off the roadway and knocked down a 17-year-old pedestrian who was on the pavement. She sustained serious injuries and died while undergoing treatment at RFM Hospital.

In Big Bend, the police reported that on January 27 2024 at 12:00 pm three men ages 37, 37, and 35 of Bulandzeni, Mpolonjeni, and kaLanga were arrested and charged for being found in possession of eighteen (18) 9 mm live rounds of ammunition while without a licence or permit at Lunkuntu area. 88 cases of 'DD' reported over the weekend

OVER the past weekend, the police have reported that countrywide the were 88 people arrested for driving while under the influence of alcohol.

This was confirmed by Police Chief Information and Communications Officer Senior Superintended Phindile Vilakati through a press release. Stating that the police were able to apprehend 88 suspects who were found driving motor vehicles while under the influence of alcohol. All the suspects are set to appear in different Magistrate's courts around the country.

The increase of suspects arrested for this offense is alarming and it is worth mentioning that former National Commissioner of Police Isaac Magagula once stated that the correct structures must consider giving out custodial sentences to people found to have committed this offense.

Magagula made this known during a press

briefing in 2017, he said the issue of drunkdriving was showing no sign of abating besides all the warnings that have been issued and continue to flag about its hazards in the road safety landscape.

Magagula noted that the police service had time and again pointed out that drunk driving was one of the major causes of both fatal and serious accidents and it was worrisome that motorists were persisting with such an untoward and dangerous practice.

To show the seriousness of the scourge, the national commissioner pointed out that from a total of 401 accidents that occurred in the country in 2017, more than 50 per cent were attributed to drink-driving while the other half may be traced to speeding and reckless driving which could also be linked to drink-driving as well. It is worth mentioning that since the ban on breathalyzers was lifted the has been an increasing number of people who appear in court charged with drink and driving. The lifting of the ban came after Acting Magistrate Innocent Motsa, pleaded with the police to bring back the use of breathalyzes so that they can be able to give hand out maximum sentences to suspects.

Motsa stated that Section 122 (2) of the Road Traffic Act stipulates that a suspect should be granted a fine not exceeding E5,000 or sentenced to 2 years imprisonment.

"The government funds are going to waste as the courts cannot give suspects the maximum fine of E5,000 because the crown lacks evidence which is the measurements from the breathalyzer," Motsa said.

He said they are pleading with the police to bring back this device since it will make the court process easier. Motsa added that it is not professional that the only particulars of drink and driving will be that the alcohol had a strong smell of alcohol coming from his mouth, which is what is used by the police to place one under arrest.





National Data Protection Awareness Day Take Control of Your Data

Join us in celebrating the National Data Protection Week 2024 by taking control of your data.

The Eswatini Data Protection Act came into force in March 2022 and espouses the Right to Privacy as enshrined in the Eswatini Constitution, 2005. The object of the Act is "to provide for the collection, processing, disclosure and protection of personal data; balancing competing values of personal information privacy and sector-specific laws and other related matters". The Act designates the Eswatini Communications Commission as the Eswatini Data Protection Authority (EDPA) charged with the responsibility to enforce compli-

On Friday, 26 January 2024, Eswatini joined the world in commemorating the International Data Protection Day by hosting an event under the theme "Take Control of Your Data". The Data Protection Day is internationally celebrated each year on 28 January, which marks the anniversary of the Council of Europe's 'Convention 108' on the protection of personal information - the first legally binding international law on data protection which was open for signature in 1981.

However, other countries soon embraced the initiative, and now Data Protection Day is globally recognized. It is an international effort to create awareness about the importance of respecting privacy, safeguarding data, and enabling trust.

The National Data Protection Day is also a chance to catch up with new developments in the Data Protection area. As the EDPA we recognise the week of 22-28 January as the National Data Protection Week, during which we urge entities (data controllers and data processors) and other actors to organise activities to raise awareness about the importance of data protection and to promote best practices with regards to processing personal information. Data protection concerns mainly individuals (the data subjects) whose personal information is processed by entities in their line of business. Still, many people lack knowledge about how their personal data is being collected, used, and shared. As this year's theme indicates, taking control of one's data begins with the data subjects themselves. It is important to make informed and calculated decisions decisions when sharing your personal data, especially with entities. Your personal data such as age, gender, data related to children, health records, National Identity number, financial records, purchase history, location have great value and may be used for unintended purposes. It is important to keep that in mind when deciding what you share and with whom. Entities who in terms of the Act are data controllers and

data processors on the other hand need to make sure that they keep heir customers' data always protected and in accordance with the data protection principles and



other applicable legal frameworks on data protection. Complainant threatened to drink Masta 900 - Rape suspect

A rape suspect has told the court that after being caught having consensual sexual intercourse by a relative, the victim/complainant allegedly threatened to drink Masta

The accused person, 23-year-old Mduduzi Masuku was on Sunday, January 7 found having sexual intercourse with his neighbour's teenage daughter.

In his bail application, Masuku said he and the victim were in a love relationship, thus occasionally engaging in sexual intercourse with the 17-year-old whom he said her age was unknown to him because the couple never discussed their

On the day in question, Masuku said he returned from the fields in the afternoon, took a bath then rested. Later he called the complainant, but her phone was off, and he assumed she was in church as was a norm in her family.

He said due to exhaustion he decided to sleep and was awoken by a call-back message from the complainant at around 2 p.m. He called her back, and she invited him to come to her parent's place.

"I told her I was tired, and she insisted, begging me to come over. Jokingly I asked how many condoms I should bring, and she said 10. I told her I was tired and would only bring two," he stated.

Within a few minutes, Masuku was prepared and proceeded to his neighbours'. Upon arrival, they went into her house and had sexual intercourse.

According to the suspect, it was

consensual as per the phone discussion about condoms.

However, the duo forgot to lock the door and whilst engaged in the sexual activity, the complainant's male cousin entered looking for her and caught them in the act. The cousin was reportedly upset and left them, and they abandoned the act immediately.

"The complainant was trauma-

tized by the fact that we have been caught having sexual intercourse. She then suggested to commit suicide by ingesting Master 900 (a very poisonous pesticide). I tried to reason with her not to do that as it would complicate things for me as well. Luckily, she never did that. I then left and went home,"

Later that evening, the com-

according to Masuku, this was a norm as he would assist as a neigh-

He responded to the call and the father asked Masuku to explain what had happened and he confessed to engaging in sexual intercourse with his daughter. The accused also told his neighbour that the complainant was his girlfriend.

Upon hearing that the neighbour became angry and said his daughter had claimed to have been forced by Masuku to have sexual intercourse which he denied.

The father called the cousin to narrate what he had witnessed who gave a side of their story.

"I respectfully submit that in my presence, the father of the complainant never gave the complainant a chance to say anything," he

According to Masuku, in anger, the father of the complainant went to fetch his gun and ordered the cousin to tie his hands from behind and assaulted him all over the body with a fan belt, kicks, and fists.

Masuku further alleges to have been throttled by the complainant's father throttled him.

The beating supposedly went on for more than an hour until he was exhausted, after which the neighbour called Masuku's family, and his aunt and cousin responded, then were joined later by his mother and sister.

"He continued threatening me even in the presence of my family members saying he would hunt me down to kill me. He went on to tell me that he was a criminal, he could even lay his hands on me at home," Masuku said.

His cousin took him home where he dressed his wounds before taking him to hospital for medical

The suspect then went to the police station to open an assault case against his neighbour, where he requested a police form to be taken to the hospital the following day.

On his way home he received a phone call being instructed to return to the police, however, he was almost home, and he told them it would be impossible to turn back and undertook to come the following day, January 9.

In the morning, two police officers arrived at his parental homestead as he too was preparing to go to the police station.

The officers introduced themselves and stated that had come to arrest Masuku for allegedly raping the complainant.

Masuku told the court that during the relationship with the complainant, they never discussed the issue of her age.

Complainant

"During good times in our relationship with the complainant, she would say she was old enough to make decisions. There is no way I could have known her exact age. I verily believe that the complainant's father was angered by the fact that we were found having sexual intercourse in broad daylight in his homestead and that was the reason a charge of rape was levelled against me. He was also infuriated by the fact that I am a person well known to his family since we are neighbours," Masuku submitted.

The suspect told the court that he and the complainant had been in a love relationship since October 2023, they just decided to keep it under wraps.

Judge Zonke Magagula granted Masuku bail at E15,000. He was ordered to pay E3,000 cash and the balance as surety.

Mbabane government doctor arrested for assaulting his wife

THE Royal Eswatini Police Service has arrested a 50-year-old doctor working at the Mbabane government hospital who resides at Sandla in connection with the assault of his wife.

The accused identified as Percival Dlamini appeared at the Mbabane Magistrate Court before Magistrate Innocent Motsa, where he was formally charged with contravening Section 77(1) of the Sexual Offenses and Domestic Violence Act of 2018.

"On January 18, 2024, at the Sandla government houses the said accused did unlawfully and intentionally assault Thembi* who is a wife to the accused by pushing her and further dragging her" part of the charge sheet reads.

During court proceedings the accused pleaded not guilty, the crown then paraded the complainant as a witness to prove the commission of the crime.

Thembi told the court that she and the accused fought over car keys. She explained that on the fateful day while she was in the flat at Sandla she was with one of their three

come and visit with the children on rare occasions. Thembi says at around 5 pm the accused came home and began shouting at her telling her to hand over her car keys, she refused to hand over the keys because they belonged to both of them as they both contributed to purchasing the car.



ESCCOM to introduce centralized system for local courier service providers

IT's good news for local courier service providers as the Eswatini Communications Commission (ESCCOM) will soon have a centralized system for the service providers to use.

This was revealed by ESCCOM Director Technical Services Thulani Fakudze, who said as a regulator they have noticed that most courier service providers did not have an appropriate system they could use in terms of doing declarations.

"These declarations include how they collect their orders. If there are systems in place, they can be able to work smoothly," he said.

Fakudze stated that the system they are working on will assist the service providers to have a centralized system that can be used by every one of them.

"We know that bigger courier service providers have their systems, but the smaller ones do not have it. So, we are in the process of acquiring this system for all of them to have,"

He explained that the system will be used for tracking and all the functionalities of proving the service including pre-declarations at the border posts.

"We hope that this project will be starting soon as specifications have been developed which shows progress and that this system will help us see much progress in how they work," he said.

According to their website, The Eswatini Communications Commission (ESCCOM) is the regulatory body responsible for regulating

the communications sector in Eswatini, constituting telecommunication services and networks, broadcasting services, postal services, and the use and allocation of radio spectrum.

It derives its mandate from the Swaziland Communications Commission Act No. 10 of 2013.

The Commission became operational on July 31, 2013, effectively taking over all the regulatory powers of the sector from the Eswatini Posts and Telecommunications Corporation (EPTC) and Eswatini Television Authority (Eswatini TV).

The website stated that the Commission is mainly responsible for licensing all systems and services in the communications industry, including telecommunications, postal, courier, and broadcasting, and managing the country's frequency spectrum and numbering resources.

The website also states that the commission

is responsible for facilitating the development of e-commerce, type approving and accepting communications equipment meant for use in the country, protecting consumer rights within the communications environment, and managing competition within the sector to ensure a level playing ground for all players.

"The commission is also responsible for regulating retail and wholesale tariffs for communications services, managing the universal access fund to facilitate access to communications services by all in Eswatini, and monitoring the activities of licensees to enforce compliance with the license terms and conditions as well as the law," read the website.

The Commission is overseen by a Board of Directors consisting of non-executive members and all decisions of the Board are executed by the Chief Executive Officer and are supported by an executive team.

Get a JA entrepreneurship qualification online for free

JA Eswatini has joined JA Africa in offering a free online entrepreneurship course for all high school students across the country.

JA Eswatini Communications and Marketing Specialist Siphesihle Mkhonta said this online application allows students to do the entrepreneurship course and get a certificate at their comfort.

She said a school does not need to be part of JA Eswatini for students to access this online training. Mkhonta stated that the JA DEEP is an online-based interactive entrepreneurship curriculum, created specifically for young African learners, and it is an online version of the successful in-person Company Program and a part of the Futurepreneurship Initiative that JA Eswatini is offering to all students in high school.

She alluded to the fact that the establishment of this digital learning platform allows JA to reach youth across the country and continent, whether in-school or out of school, in rural or urban areas, unemployed or in employment, etc.

Chinese companies to invest up to \$7 billion in Congo mining infrastructure

KINSHASA — Chinese construction companies will invest up to \$7 billion in infrastructure projects as part of an agreement over their Sicomines copper and cobalt joint venture in the Democratic Republic of Congo, they said on Saturday.

Both parties agreed to maintain the current structure of the shareholding, while the Chinese partners, Sinohydro Corp (SINOH.UL) and China Railway Group Limited, will pay 1.2 per cent of royalties annually to Congo, according to a statement.

President Felix Tshisekedi's government had been revisiting the deal struck by his predecessor Joseph Kabila under which the Chinese partners agreed to build roads and hospitals in exchange for a 68 per cent stake in the joint venture with Congo's state mining company Gecamines.

Under the deal, the Chinese investors committed to spending \$3 billion on infrastructure projects, but the state auditor - Inspection Generale des Finances (IGF) - last year demanded that commitment be increased to \$20 billion.

Tshisekedi instructed his government to hold talks with the investors ahead of a visit to China in May 2023. He had aimed to boost Congo's stake in the joint venture to 70 per cent from 32 per cent.

"It is a win-win deal," IGF head Jules Alingete said in a press conference, adding that negotiations had not been easy.

Ernest Mpararo, head of the Congolese Anti-Corruption League, said the announcement was a step forward but flagged that Sicomines remained exempt from paying taxes.

He also pointed to money owed under the last agreement. A 2023 IGF report found that only \$822 million of the \$3 billion promised for infrastructure investments had been spent.

Congo is the world's biggest producer of cobalt, a key component in batteries for electric cars and mobile phones. It is also the world's third-largest copper producer. Its mining sector is largely dominated by Chinese companies.

Tshisekedi, who won a second mandate in December, had signposted the agreement in his Jan. 20 inauguration speech. (**Reuters**)

India's Tata and France's Airbus to manufacture helicopters together

NEW DELHI — India's Tata group and France's Airbus have signed an agreement to manufacture civilian helicopters together, India's Foreign Secretary Vinay Kwatra said on Friday.

The agreement was signed during French President Emmanuel Macron's ongoing state visit to India, he said.

Tata and Airbus are already cooperating to make C-295 transport aircraft in Prime Minister Narendra Modi's home state of Gujarat.

Tata did not immediately respond to a request for comment.

As part of his 40-hour visit to India, Macron held talks with Modi on Thursday and also attended a state-banquet hosted by India President Droupadi Murmu in his honour on Friday.

This was the fifth meeting between Modi and Macron since May.

Further cooperation in the defence sector was also discussed during the state visit, officials said, including the possibility that French engine maker Safran (SAF.PA) would assist in manufacturing fighter jet engines in India.

After Russia, France is the largest arms

supplier to India, which has relied on its fighter jets for four decades.

"Safran is fully willing to do it with a 100 per cent transfer of technology in design, development, certification, production and so on," India Ambassador to France Jawed Ashraf said, adding that discussions will continue on the matter.

Coinciding with Macron's visit, jet engine maker CFM International on Friday also announced an agreement with India's Akasa Air to purchase more than 300 of its LEAP-1B engines to power 150 Boeing 737 MAX airplanes

Akasa Air had earlier ordered 76 aircraft powered by the engine, of which 22 are in

France, both before and during Macron's visit, also raised the issue of New Delhi-based French journalist Vanessa Dougnac being served a notice by the Indian government regarding possible cancellation of her visa, Kwatra said.

The government termed her work "malicious" and said it may "provoke disorder and disturb peace", according to local media reports. Dougnac denied all the allegations in a statement released on Wednesday. (Reuters)

China securities regulator suspends restricted share lending from Monday

SHANGHAI — China's securities regulator said on Sunday that it will fully suspend the lending of restricted shares effective from Monday, in policymakers' latest attempt to stabilise the country's stock markets following recent sharp falls.

A string of supportive policies by Beijing including a deep cut to bank reserves helped lift Chinese stocks off 5-year lows early last week but they retreated again on Friday, reflecting deep investor pessimism over the outlook for markets and the shaky economy.

Analysts and investors say Beijing needs to roll out more support measures to revive consumer and business confidence and get activity back on a more solid footing.

Restricted shares are often offered to company employees or investors with certain limits on their sale, but they can be lent to others for trading purposes, such as short-selling, which can add pressure on markets during a prolonged slump.

Sunday's move will "highlight fairness and reasonableness, reduce the efficiency of securities lending, and restrict the advantages of institutions in the use of information and tools, giving all types of investors more time to digest market information and creating a fairer market order," the China Securities Regulatory Commission (CSRC) said a statement published on its official WeChat account.

The CSRC added that the move would "resolutely" crack down on illegal activities that use securities lending to reduce holdings and cash out.

The regulator also said it will limit the efficiency of some securities lending in the securities refinancing market from March 18.

Last October, the CSRC restricted securities lending businesses and tightened scrutiny of improper regulatory arbitrage by imposing higher margin requirements.

China's stock market tumbled in 2023 and has extended its slide in the new year. Though the blue-chip CSI300 Index has recovered some ground, it still down about 3 per cent year-to-date.

Small Chinese investors are scrambling even harder than foreigners to exit the crumbling stock markets, sending premiums on global index funds skyrocketing as they search for exposure to anything but the sputtering domestic economy.

China's economy grew 5.2 per cent for 2023, slightly above the government's target, but the comparison was flattered by a weak, lockdown-hit 2022 and the recovery has been highly uneven.

December data showed lacklustre consumption and the fastest fall in home prices for nine years, with the property market in a deep crisis.

Both Shanghai and Shenzhen stock

Monetary Policy Statement

26 January 2024

On the 26th January 2024, the Central Bank of Eswatini (Bank), together with the Monetary Policy Consultative Committee (MPCC) held a meeting to consider the appropriate monetary policy stance. Taking into consideration relevant global, regional, and domestic economic factors; as well as the price and financial stability mandate, the Bank decided to maintain the discount rate unchanged at 7.5 per cent.

On the global front, the ongoing effects of tighter monetary policy, the restrictive credit conditions and the intensifying geopolitical tensions are weighing down on growth prospects. Economic growth in advanced economies is subdued whilst growth in Emerging Markets and Developing Economies (EMDEs) with strong fundamentals is improving. The US economy grew by an annualized 3.3 per cent in the fourth quarter of 2023 from 4.9 per cent in the previous quarter whilst the UK and the Eurozone contracted by 0.1 per cent each in the third quarter of 2023. China grew by 5.2 per cent in the fourth quarter of 2023, compared to the 4.9 per cent recorded in the previous quarter. Inflation in advanced economies and EMDEs remain persistent and above target, and monetary conditions remained at restrictive levels.

Regionally, the South African economy shrank by 0.2 per cent in the third quarter of 2023, after a revision downward to 0.5 per cent in the second quarter. The South African Reserve Bank (SARB) marginally revised down its growth forecast for 2023 to 0.6 per cent (from 0.8 per cent forecasted in November 2023) whilst the forecasts for 2024 and 2025 remain unchanged at 1.2 per cent and 1.3 per cent, respectively. The South African inflation decreased to 5.1 per cent in December 2023 from 5.5 per cent the previous month, recording an average of 6.0 per cent in 2023. The SARB left its inflation forecast for 2024 unchanged at 5.0 per cent whilst the forecast for 2025 was marginally revised up to 4.6 per cent (from 4.5 per cent). The SARB maintained the reporate unchanged at 8.25 per cent in its 25 January 2023 meeting.

On the domestic front, economic activity as measured by the quarterly GDP, grew by a slower 7.7 per cent yearon-year (seasonally adjusted) in the third quarter of 2023, down from a revised growth of 8.2 per cent in the second quarter. The primary and secondary sectors recorded slower increases (on a year-on-year basis) in the quarter under review, whilst the tertiary sector remained resilient on double digit growth. On a quarter-onquarter basis, economic activity grew by 3.0 per cent (seasonally adjusted) in the quarter under review, from a revised growth of 1.3 per cent in the previous quarter.

The country's annual headline inflation declined further to 4.3 per cent in December 2023 from 4.7 per cent in November 2023. The slowdown is attributed to a decrease in prices for; 'food & non-alcoholic beverages' which grew by a slower 7.1 per cent in December 2023 from 8.4 per cent the previous month; 'furnishing & household equipment' which grew by 3.9 per cent in December 2023 compared to 4.1 per cent in the previous month, and 'transport' which fell by 0.5 per cent in December 2023 following a zero growth in November 2023. These decreases were counteracted by increases in the price indices for; 'clothing & footwear' which rose by 6.5 per cent in December 2023 from 6.0 per cent the previous month and 'miscellaneous goods & services' which grew by 0.2 of a percentage point to 9.6 per cent in December 2023. The country's headline inflation averaged 5.0 per cent in 2023. The Bank revised down its inflation forecasts to 4.9 per cent (from 5.2 per cent forecasted in November 2023) for 2024 and the forecast for 2025 is at 5.1 per cent. Risks to the inflation outlook include elevated crude oil prices, a weaker exchange rate and higher food prices, amongst others.

Credit extended to the private sector declined by 0.9 per cent month-on-month to E18.8 billion at the end of November 2023. Accounting for the slowdown in credit to the private sector were decreases in the credit extended to "other sectors of the domestic economy" and" households and NPISH". These sectors decreased by 16.6 per cent month-on-month to settle at E1.0 billion and 0.1 per cent month-on-month to E8.3 billion at the end of November 2023 respectively. Credit extended to businesses on the other hand grew by 0.5 per cent to E9.4 billion at the end of November 2023. The banking sector's total non-performing loans (NPLs) fell by 4.1 per cent in November 2023 compared to the previous month to settle at E1.1 billion. Consequently, the NPL ratio declined by 0.3 of a percentage point month-on-month to 6.9 per cent at the end of November 2023.

As at 19 January 2024, gross official reserves stood at E11.1 billion an equivalent to import cover of 3.5 months. Total public debt increased by 1.0 per cent to E34.7 billion in December 2023 from E34.3 billion the previous month. At this level, public debt is equivalent to 40.9 per cent of GDP.

The Bank will continue to monitor international and domestic developments that influence the movements of inflation and will act appropriately in line with its mission to foster price and financial stability that is conducive to the economic development in Eswatini.

Ethiopia's deputy PM Demeke to be replaced by spy chief Temesgen

ADDIS ABABA - Ethiopia's deputy prime minister Demeke Mekonnen, who has occupied the post for over 11 years under three successive prime ministers, will be replaced by spy chief Temesgen Tiruneh, a senior government official told Reuters on Friday.

Temesgen was elected to succeed Demeke as a vice president of the ruling Prosperity Party, state-run media reported. A vice president of the party typically serves as deputy prime minister.

Demeke has been a face of continuity during a turbulent period in Ethiopian politics. He was appointed to the post after the death of longtime prime minister Meles Zenawi in 2012 and survived a reorganisation of the ruling party that occurred after Abiy Ahmed took power in 2018.

Temesgen is the head of the national intelligence service and has coordinated the government's response to a conflict that broke out last year in the Amhara region with local militias.

Abiy appointed Demeke as foreign minister days after civil war broke out in November 2020 in the northern Tigray region, a conflict

that lasted two years and cost tens of thousands of lives.

While the government and rebel forces in Tigray signed a peace deal in November 2022, Ethiopia has remained dogged by insecurity.

Besides the unrest in Amhara, a decades-long conflict in the Oromiya region, the country's largest, has intensified in recent years, killing hundreds and displacing tens of thousands. (Reuters)

Kenyan court refuses to stay ruling invalidating housing levy

NAIROBI - Kenya's Court of Appeal on Friday refused to extend a stay that had allowed the government to continue collecting a 1.5% levy to fund affordable housing despite a lower court having found the measure unconstitutional.

The levy was part of a finance law adopted in June that also doubled the value-added tax on fuel and increased the top income tax rate.

The law, intended to shore up government finances amid a high debt burden and fast-depreciating currency, sparked violent protests the following month by opponents who said it would further squeeze households at a time of rising living costs.

A trial court ruled in November that the levy was unconstitutional because the government had not provided a rational explanation for why it applied only to workers with employment in the formal sector.

The trial court stayed its ruling until the government could appeal, allowing the levy to continue to be collected.

The appeals court said the stay should not be extended since "the presumption of constitutional validity ... was extinguished the moment the trial Court issued the declara-

sues raised in the intended appeals," the court said.

The housing levy is one of a raft of taxes President William Ruto's government, which faces a June deadline to repay a \$2 billion Eurobond, has introduced to increase revenues and fund social programmes.

Earlier this month, the Court of Appeal lifted a stay on a separate 2.75% tax intended to fund a national health insurance programme.

Following the trial court's ruling on the housing levy in November, parliament began taking views from the public for a law to guide how to provide affordable housing in accordance with the constitution.

Uganda says judge's dissent from World Court ruling on Israel does not reflect its position

KAMPALA - Uganda has distanced from itself an opinion written by a Ugandan judge on the International Court Justice (ICJ) dissenting from the panel's ruling in South Africa's genocide case against Israel, and said the remarks do not reflect Uganda's position.

Julia Sebutinde was the only judge on the 17-member ICJ panel to vote against all six measures adopted by the court in a ruling ordering Israel to take action to prevent acts of genocide as it fights Hamas militants in the Gaza Strip.

"The position taken by Judge Sebutinde is her own individual and independent opinion, and does not in any way reflect the position of the government of the republic of Uganda," the government said in a statement issued late on Saturday.

It added that the east African country supported the position of the Non-Aligned Movement on the conflict that was adopted at its summit in the Ugandan capital this month.

That NAM position contained in a document issued at the end of the summit condemned Israel's military campaign and killing of civilians and also called for an immediate ceasefire and unimpeded humanitarian access.

The movement was formed officially in 1961 by countries opposed to joining either of the two major Cold War-era military and political blocs. Many of the countries were newly independent from their colonial rulers.

Sebutinde was one of only two judges who issued dissenting judgements while 15 voted for the emergency measures which covered most of what South Africa had asked for in the case.

Zimbabwe opposition leader quits 'hijacked' party

ZIMBABWE'S main opposition leader Nelson Chamisa quit his Citizens Coalition for Change (CCC) party on Thursday, two years to the day after its formation, saying it had been hijacked by the ruling ZANU-PF in a power grab. "Fellow citizens, this is to officially and under my hand inform you that, with immediate effect I no longer have anything to do with CCC," Chamisa wrote in a lengthy statement posted on his X account.

The CCC party, which enjoys huge urban support, won 103 of the 280 seats in Zimbabwe's main house of Parliament and swept most of the urban councils in last year's general election.

However, several CCC lawmakers and councillors have been ejected from their seats by an official claiming to the party's secretary general, but who Chamisa and the CCC say is an imposter.

Efforts to reverse the recalls in the courts have failed. The CCC accuses ZANU-PF, in power since independence in 1980, of using the courts to destroy the opposition. ZANU-PF has dismissed the accusations, but has benefited from the recalls after winning most of the resultant by-elections.

"The CCC has to all intents and purposes been criminally handed over to ZANU-PF," Chamisa said in his statement.

The ZANU-PF spokesperson could not immediately be reached for comment.

It was not immediately clear if lawmakers and councillors loyal to Chamisa would quit their posts in solidarity, a move which would trigger a wave of by-elections.

Ukraine says it uncovered mass fraud in weapons procurement

UKRAINE'S SBU security service said on Saturday it had uncovered a corruption scheme in the purchase of arms by the country's military totalling the equivalent of about \$40 million.

The announcement of mass procurement fraud, confirmed by Ukraine's Defence Ministry, will have a huge resonance in a country beleaguered by Russia's nearly two-year-old invasion.

The fight to root out endemic corruption remains a major issue as Ukraine presses its bid to secure membership in the European Union.

The SBU said an investigation had "exposed officials of the Ministry of Defence and managers of arms supplier Lviv Arsenal, who stole nearly 1.5 billion hryvnias in the purchase of shells."

"According to the investigation, former and current high-ranking officials of the Ministry of Defence and heads of affiliated companies are involved in the embezzlement."

The embezzlement, it said, involved the purchase of 100,000 mortar shells for the military.

The SBU said a contract for the shells was clinched with Lviv Arsenal in August 2022 - six months into the war - and payment was made in advance, with some funds transferred abroad.

But no arms were ever provided, the statement said, with some funds then moved to other foreign

als had been served "notices of suspicion" - the first stage in Ukrainian legal proceedings - both in the ministry and the arms supplier. One suspect, it said, was detained while trying to cross the Ukrainian border.

Corruption within the military has been a particularly sensitive issue in Ukraine as it tries to maintain wartime public morale and present its case to join the 27-nation EU.

Defence Minister Oleksii Reznikov

was dismissed last September over various corruption cases despite enjoying a solid reputation in representing Ukraine in its discussions with Western allies.

THE U.S. is reviewing its sanctions policy against Venezuela after a court in that country upheld a ban preventing presidential candidate Maria Corina Machado from holding office, the U.S. State Department said on Saturday.

The ruling by Venezuela's Supreme Justice Tribunal on Friday means Machado, a 56-year-old industrial engineer, cannot register her candidacy for presidential elections scheduled for the second half of 2024.

"The United States is currently reviewing our Venezuela sanctions policy, based on this development and the recent political targeting of democratic opposition candidates and civil society," State Department spokesman Matthew Miller said in a statement.

The U.S. eased economically debilitating oil sanctions on the crude-exporting country in October after President Nicolas Maduro's government signed a deal with the opposition under which Caracas made commitments to hold a free

and fair 2024 presidential election.

Miller said the court ruling was a "deeply concerning decision" that ran contrary to the commitments made by Maduro to allow all parties to select candidates.

Maduro on Thursday said the deal with his opponents was in danger of collapse, citing what he has described as "conspiracies" against him. Gerardo Blyde, head of the opposition negotiating team, denied members had been linked to acts of violence and demanded the court ruling be reversed.

"We are not asking for sanctions, that is not our job. We are looking for the process to move forward," he told a news conference in Caracas on Saturday.

More countries pause funds for UN Palestinian agency

LONDON - Six European countries paused funding for the U.N. refugee agency for Palestinians (UNRWA) on Saturday, following allegations that some of its staff were involved in the Oct. 7 Hamas attacks on Israel.

Britain, Germany, Italy, the Netherlands, Switzerland and Finland on Saturday joined the United States, Australia and Canada in pausing funding to the aid agency, a critical source of support for people in Gaza, after the allegations by Israel.

"Palestinians in Gaza did not need this additional collective punishment," Philippe Lazzarini, UNRWA commissioner-general, said on X. "This stains all of us."

The agency said on Friday it had opened an investigation into several employees and severed ties with those people.

Encouraging more donor suspensions, Israeli Foreign Minister Israel Katz said UNRWA should be replaced once fighting in the enclave dies down and accused it of ties to Islamist militants in Gaza.

"In Gaza's rebuilding, @ UNRWA must be replaced with agencies dedicated to genuine peace and development," he added on X.

Deputy U.N. spokesperson Farhan Haq, asked about Katz's remarks, said: "We are not responding to rhetoric. UNRWA overall had had a strong record, which we have repeatedly underscored."

Lazzarini said the decision by the nine countries threatened its humanitarian work across the region, especially in Gaza.

"It is shocking to see a suspension of funds to the Agency in reaction to allegations against a small group of staff, especially given the immediate action that UNRWA took by terminating their contracts and asking for a transparent independent investigation," he said in a statement.

The Palestinian foreign ministry criticised what it described as an Israeli campaign against UNRWA, and Hamas condemned the termination of employee contracts "based on information derived from the Zionist enemy".

AGENCY PLAYS BIG ROLE IN GAZA AID

UNRWA was set up to help refugees of the 1948 war at Israel's founding and provides education, health and aid services to Palestinians in Gaza, the West Bank, Jordan, Syria, and Lebanon. It helps about two thirds of Gaza's 2.3 million population and has played a pivotal aid role during the war that Israel launched to eliminate Hamas after the Oct. 7 attacks.

Announcing the investigation, Lazzarini said on Friday that he had decided to terminate the contracts of some staff members to protect the agency's ability to deliver humanitarian assistance.

Lazzarini did not disclose the number of employees allegedly involved in the attacks, nor the nature of their alleged involvement. He said, however, that "any UNRWA employee who was involved in acts of terror" would be held accountable, including through criminal prosecution.

During weeks of Israeli bombardment of the Palestinian enclave, UNRWA has repeatedly said its capacity to render humanitarian assistance to people in Gaza is on the verge of collapse.

Hussein al-Sheikh, head of the Palestinians' umbrella political body the Palestine Liberation Organization (PLO), said cutting support to the agency brought major political and relief risks.

"We call on countries that announced the cessation of their support for UNRWA to immediately reverse their decision," he said on X. (Reuters)

They're all made up of tiny building blocks called amino acids. Nine of these are essential—meaning your body needs them but can't make them on its own, so you need to get them in your diet.

Not only is protein essential for your health but consuming it can keep you feeling full and satisfied, which supports a healthy body weight.

The recommended dietary allowance (RDA) for protein is set at 0.36 grams (g) of protein per pound of your body weight (0.8 g per kilogram). Remember that this reflects the minimum protein required to meet your body's needs .

Here are 16 delicious foods that are high in protein.

1. Eggs

Whole eggs are a good source of protein that's easy to absorb, and they're also an excellent source of vitamins, minerals, healthy fats, and antioxidants.

Remember that egg whites are almost pure protein, but whole eggs that include the yolk provide many more nutrients, including vitamins, minerals, antioxidants, and healthy fats.

2. Almonds

Almonds are a nutritious tree nut rich in essential nutrients like fiber, vitamin E, manganese, and magnesium. They're also high in plant-based protein.

Eating almonds may benefit your health in several ways, including lowering heart disease risk factors like high LDL (bad) cholesterol and high blood pressure.

3. Chicken breast



TREATING chronic migraine can be done acutely and preventively.

There are multiple medications and integrative treatments that may be able to provide relief.

Chronic migraine is defined as migraine that occurs 15 or more days a month for 3 consecutive months. At least 8 of these days, headaches will resemble a migraine

The migraine will last for 4 hours and up to 72 hours, and the pain will be moderate to severe. In addition, nausea or sensitivity to light and sound may occur.

Acute treatment is intended to provide immediate relief from migraine symptoms, while preventive treatment is meant to prevent a migraine from occurring. Along with acute and/or preventive treatment of chronic migraine, there are complementary treatments and therapies to manage coexisting conditions.

Acute treatments for chronic migraine

An acute treatment refers to a medication taken at the first sign of migraine. These treatments don't prevent migraine but may offer pain relief during an episode. Most of these drugs must be taken at the first sign of migraine for best results.

The most commonly prescribed drugs for acute treatment are:

- ▶ analgesics like nonsteroidal antiinflammatory drugs (NSAIDs)
 - ▶ dopamine antagonists
 - ergotamines
 - ▶ ubrogepant and rimegepant
- ▶ triptans, available as pills, injections, or nasal spray
- ▶ dihydroergotamine, available in a nasal spray, by injection, or IV

Oral drugs targeting the CGRP pathway linked to migraine disease have emerged in recent years. Gepants and ditans used to treat chronic migraine include:

- ▶ ubrogepant (acute treatment)
- ▶ rimegepant (also used as a preventive treatment)
- ▶ reyvow
- zavegepant

Reyvow works differently than the other medications of this class. It targets serotonin receptors on the brain's nerve endings to halt migraine attacks just as they begin. This medication can cause sedation, so driving up to 8 hours after taking it is not advised.

Newer migraine treatments may have fewer side effects than triptans and antidepressants. They're also safe for people who have other medical conditions like a history of heart disease, stroke, or vascular diseases.

Preventive treatments for chronic migraine

Preventive medications for chronic migraine are intended to stop migraine from occurring in the first place. Typically, this course of treatment is considered when headaches occur more than 4 days per month and other severe side effects, like debilitating auras, coincide with the headaches.

Preventive treatments include:

- ▶ beta-blockers
- ▶ anticonvulsants
- ▶ antidepressants

- (injection onabotulinumtoxinA therapy)
- ▶ anti-CGRP monoclonal antibodies

The effects of most preventive migraine treatment may not kick in for 2-3 months. Your doctor may also want you to take the preventive medication for up to a year, depending on your migraine history and your body's response to treatment. Finding the right dose is a part of the process.

Complementary treatments for chronic migraine

Prescription medications aren't the only source of potential relief for chronic migraine. There are some natural or integrative remedies that may help when used alongside traditional treatments.

These include:

- ▶ aerobic exercise
- biofeedback
- ► relaxation techniques

- ▶ cognitive therapies
- ► acupuncture
- dietary supplements like magnesium, CoQ10, butterbur, or feverfew
- cyanocobalamin with folate and pyridoxine

Lifestyle changes may also help. Getting enough sleep, hydrating, and limiting caffeine can all provide relief from migraine symptoms.

Antidepressants and migraine

Depression and anxiety disorders are common among people who have migraine. Research suggests that worsening depression is frequently linked to a greater risk of episodic migraine becoming chronic migraine. It's important for doctors to evaluate and treat people with migraine for the presence of depression or anxiety.

Certain antidepressant medications have been used successfully to treat depression and reduce migraine recurrence. One 2019 review found that serotonin-norepinephrine reuptake inhibitors (SNRIs) were shown to be effective in treating people who live with migraine and depression. But the authors said that more research is needed on the efficacy of selective serotonin reuptake inhibitors (SSRIs) in most people living with migraine and depression. One preventive treatment for chronic migraine may also act as an antidepressant. A 2022 review found that Botox can help with mild to moderate depression. How Botox works to reduce symptoms of depression is still being determined.

The takeaway

Chronic migraine is treated both acutely to provide immediate relief for pain and other symptoms, and preventatively to stop migraine from occurring. While chronic migraine isn't dangerous, it is serious due to its disruptive, often debilitating nature.

Consider keeping a migraine journal to track your migraine frequency and symptoms and what medications are or aren't working for you. This will help your doctor find the best course of treatment. Healthline

Sinner wins Australian Open

MELBOURNE - Jannik Sinner ushered in a new era at the Australian Open as the Italian capped off an outstanding fortnight with a superb comeback to outlast Daniil Medvedev and claim his first Grand Slam title on Sunday.

Sinner came from two sets down to beat Medvedev 3-6 3-6 6-4 6-4 6-3 and become the first Melbourne champion for a decade not named Novak Djokovic, Rafa Nadal or Roger Federer in the first title clash since 2005 not to feature any of the "Big Three".

He dominated the tournament up to the final, with a thumping win over holder Djokovic in the semi-finals, but had to dig deep to take his place as the king and become the first Italian man to bag a major since Adriano Panatta won the 1976 French Open.

"It takes a little while to process everything," said the 22-year-old after becoming the youngest champion since Djokovic won the 2008 title on Rod Laver Arena.

"I'm extremely happy how I handled things. The situation on court was very, very tough.

"The most important part was the support I had throughout these two wee by beating Djokovic at the ATP Finals and the Davis Cup at the end of last year when he led his country to their second title in the team competition.

A Grand Slam triumph was the next step to keep pace with fellow young gun Carlos Alcaraz, who already has two, and Sinner went about his task in Melbourne efficiently.

But in Medvedev, he faced a man eager to erase the pain of two defeats in the Australian Open final -- to Djokovic in 2021 and Nadal in five sets in 2022 -- and the Russian showed no sign of having a mental hangover from those clashes.

MULTIPLE COMEBACKS

Having become the first man since Pete Sampras almost three decades ago to reach the final after multiple comebacks from two sets down, Medvedev made a blazing start to ease through the opening set with a double break.

It was only the third and fourth times that Sinner had dropped his serve in the tournament and he appeared to be troubled by the flat trajectory of his opponent's shots early in the encounter.

Medvedev's only previous loss in 51 Grand Slam matches on hardcourts after winning the opening set came at Melbourne Park against Nadal in the 2022 final and the 27-year-old nicknamed the "Octopus" soon got one tentacle on the trophy.

After wasting four chances to break in the second game that had five deuces and lasted nearly 12 minutes, Medvedev got his nose in front 3-1 on his way to wrapping up the second set as Sinner's hopes of responding faded with the setting sun.

But Sinner grabbed a break back and nearly got another late in the second set as Medvedev showed signs of frailty after more than

20 hours on the court before Sunday but the Russian pushed himself on with plenty of backing from the crowd.

The fourth seed missed a forehand pass at the net after a 31-shot rally in the 10th game

of the third set but shrugged it off to break Medvedev and take the set, beginning his comeback in the clash which suddenly had a different feel to it.

Xavi to leave Barca at the end of the season

BARCELONA manager Xavi Hernandez said on Saturday that he had decided to step down at the end of the season after his side lost 5-3 at home to Villarreal in LaLiga, their third defeat in their last five games in all competitions.

Barca are third in the table on 44 points, 10 behind leaders Real Madrid and eight adrift of second-placed Girona.

"I'd like to announce that as of June 30 I will not continue as Barca coach," he told a press conference after meeting with club president Joan Laporta for over half an hour.

"It is a situation of common sense and I have decided that on June 30th I will not continue as Barca coach.

"I think the club needs a change of dynamic and I told the president Joan Laporta. As a fan, thinking about the club and the players, I think they will be freed up and will

"I think the best thing to do is to leave on June 30th. Having said that, I will give my all for the four months that are left, I think we can have a good season and I hope that the dynamic will change. I believe I am doing the right thing."

Xavi played for Barcelona for 17 years, making 767 appearances and winning 25 trophies, including four Champions League titles and eight LaLiga crowns.

But despite being a club great and winning LaLiga last term, Barca's stuttering campaign has put Xavi under pressure.

They were thrashed by Real in

the Spanish Super Cup final earlier in January and knocked out in the Copa del Rey quarter-finals by Athletic Bilbao on Wednesday. Barca face last season's Italian champions Napoli in a Champions League last-16 tie.

"I had a very human conversation with the president (Laporta), with a lot of common sense. The trust is absolute, he even got a little emotional," 44-year-old Xavi added. "But I think it is time. I'm not driven by financial matters, but by my heart. I think it's the best thing for the club. I don't want to be a problem for the club in my heart.

"This game today is an example that we need a change of direction because it has been unfortunate and it is a time to change this dynamic. I can't remember a game as cruel as today.

Liverpool through to FA Cup fifth round, Wolves win game marked by fan violence

LIVERPOOL, England - Liverpool cruised into the fifth round of the FA Cup with a 5-2 rout of Championship side Norwich City on Sunday, to kick off Juergen Klopp's long goodbye at Anfield.

Liverpool's beloved manager announced on Friday that he would leave the Merseyside team at the end of this season, his ninth at the helm.

The eight-times FA Cup winners had goals from Curtis Jones, Darwin Nunez, Dioga Jota, Virgil van Dijk and Ryan Gravenberch.

Liverpool will next play either Watford FC or Southampton after that fourth-round game earlier on Sunday ended in a 1-1 draw thanks to a last-gasp goal by Southampton's Stuart Armstrong to force a replay.

Ben Gibson and Borja Sainz scored for Norwich City, who are ninth in the Championship, 28 spots below Premier League leaders Liverpool in England's football pyramid.

Wolverhampton Wanderers' 2-0 victory in their fourth-round match at West Bromwich Albion on Sunday was interrupted for nearly 40 minutes due to clashes involving the two sides' supporters.

Wolves were leading 2-0 when projectiles were hurled on to one end of the pitch in the 82nd minute, sparking a brawl in a corner at The Hawthorns.

Matheus Cunha and Pedro Neto scored for Wolves, whose manager Gary O'Neil called the disturbances "really disappointing"

"Up until that point it was a good tie with good atmosphere," O'Neil told ITV. "How people behave at football is really important and we need to look at that, make sure everyone is safe. When we came back out the atmosphere had gone, it was really sad to see."

Mohamed Bayo's superb glancing header in the eighth minute of stoppage time in the last-16 clash proved the difference after Equatorial Guinea, who were down to 10 men in the second half, missed a penalty.

Guinea ended a long sequence of losing in the knockout stage of the Cup of Nations but took their time, and rode their luck, to claim victory.

It came after a spell of probing football at the end of the game and from an accurate cross on the right from full back Ibrahim Diakite that Bayo expertly flicked into the net, in a small gap between the near post and the goalkeeper.

Guinea had brought on the Bundesliga-based pair of Naby Keita and Serhou Guirassy to inject urgency into their attack and they slowly took command in the closing stages, setting up several chances.

Guinea had a man advantage from the 55th minute when Equatorial Guinea's influential holding midfielder Federico Bikoro was sent off for a high-foot tackle on Bayo that was dangerous.

But despite the disadvantage, Equatorial Guinea should have gone ahead just minutes later when Iban Salvador was clipped from behind in the penalty area by wing back Se-

kou Sylla.

It took a lengthy VAR review before the referee awarded the kick but Emilio Nsue, the tournament's leading scorer with five goals, hit his effort against the upright with the goalkeeper going the other away.

Equatorial Guinea then looked to play for time and try and force the game to an extra 30 minutes and post-match penalties.

However, Guinea snatched victory to end the fairytale run of the small central African nation, who had finished ahead of hosts Ivory Coast and Nigeria in Group A and who on Monday produced a shock by thrashing the Ivorians 4-0.

Guinea had the best chance of a pedestrian first half when they broke on the counter-attack after defending a corner and Aguibou Camara was running toward the opposing goal, but then inexplicably hesitated and allowed full back Basilio Ndong to steam across from the left and make a convincing tackle.

Morocco coach has suspension lifted, can return for last - 16 game against S.A

ABIDJAN, Ivory Coast — Walid Regragui has had his suspension lifted, clearing the Morocco coach to return for the team's Africa Cup of Nations last 16 game against South Africa on Tuesday.

The Confederation of African Football said Sunday it had partially upheld the appeal filed by the Moroccan federation against Regragui's four-game ban — with two suspended — for his part in the heated scenes at the end of the team's match against Congo the week before.

CAF's appeal board said it was setting aside the suspension and a fine of \$5,000 imposed on Regragui. It confirmed the fines of \$20,000 each on the soccer federations of Morocco and Congo, plus the \$10,000 fine on the Moroccan federation "for the use of smoke bombs by its supporters during the match," half the amount suspended.

The Moroccan federation had argued it was an "unjust decision" to ban Regragui because the coach "did not commit any behavior that violates the spirit of sportsmanship."

Regragui sat out Mo-

rocco's final group game as the Atlas Lions defeated Zambia 1-0 in the first game after his suspension.

Regragui and Congo captain Chancel Mbemba had a heated exchange after their teams' match ended 1-1 in San Pedro on Jan. 21. It led to a melee between players and officials from both teams that continued as they went down the players' tunnel.

Mbemba implied to journalists after the game that Regragui insulted him, but the Morocco coach on Tuesday denied making any racist comments.

Mbemba's Instagram account was subjected to a stream of racist abuse, while Regragui said he received death threats in the fallout.
