



OUTSPOKEN Mbabane businessman and former Senator Walter Bennett has told the Commission of Inquiry probing the Master of the High Court that there is a syndicate that allegedly sold and continues to sell emaSwati's properties illegally in the different major towns around the country.

According to Bennett, the alleged syndicate is made up of top lawyers, Master of the High Court officers, auditors and accountants, municipal officers and fund managers responsible for investing among others.

Before requesting the media to step out, Bennett told the Commission that he hoped there would be a solution for curbing criminality among lawyers in the country. He stated that he had a bone to chew with the Law Society because of its

"The Law Society only acknowledges the Rule of law when it suits them. I don't know who will resolve this matter with lawvers in the country because they are not clean," Bennett said.


He stated that he once complained to the Law Society in 2020 which was received by late activist and human rights lawyer Thulani Maseko, but was never tended to. He did not disclose what the complaint was about.

Bennett stated that what 'agitated' him was that Maseko acknowledged receipt of the complaint to the media and said the Law

Mbabane Businessman Walter Bennett says there is a report that was suppressed after findings showed that people's estates and properties were being sold and they did not receive the proceeds of the sales.

Instead, their money would go to lawyers and the respective municipalities in these towns. Bennett said when he was a Senator, he once called for a commission to inquire about the illegal sale of people's properties.

This was after he received a letter from a widow who sought assistance with her late husband's estate. At the time, the Minister of Housing and Urban Development was now Senate President Lindiwe Dlamini who approved the inquiry and the then Auditor General and a judge were appointed as part

After the inquiry, Bennett claimed to have visited the office of the Director of Urban Government at the time and asked about the report.

"He said to me, that report was found to be highly defamatory to the extent that it was not wise to release it. When he made that statement, I went back to the Commission made up of an auditor general and the other one was a judge both looking over this report, including the PS in the Ministry at the time. They all suppressed the document," he said.

According to Bennett, the document contained the fundamentals found by people who had expertise and could influence legislation and make the environment a better one. He said the report was suppressed because of the alleged corruption that was and continues to happen in the country.

### Prime Minister, Eswatini delegation reports back from AU Summit

ESWATINI'S delegation to the 37th Ordinary Session of the Assembly of the African Union (AU) returned to the country on Monday and reflected on the successful discussions from the

Prime Minister Russell Dlamini was accompanied by Cabinet Ministers including the Minister of Foreign Affairs and International Cooperation Pholile Shakantu, Minister of Education and Training Owen Nxumalo, Minister of Commerce, Industry and Trade Mancoba Khumalo, and Minister of Health Mduduzi Matsebula briefed the media on the discussions from the summit upon their arrival at the Ngwenya border post.

During the press briefing, the Prime Minister highlighted that one of the key moments of the Summit was the unveiling of a statue of former Tanzanian President Julius Nyerere, a pivotal figure in the fight for African independence and a strong advocate for African unity. He said the move serves as a lasting tribute to his legacy.

The Premier further shared that the Summit also saw the launch of the AU theme for the year which is "Educate an African fit for the 21st century: Building resilient education systems for increased access to inclusive, lifelong, quality and relevant learning in Africa."

He added that all Member States reaffirmed the critical role of education in driving development across the continent and committed to enhancing their education systems to meet the needs of the 21st century and empower Africa's future workforce.

Prime Minister Dlamini said that Eswatini actively participated in discussions on climate change, emphasizing the need to balance economic growth with the transition to clean energy, particularly for smaller nations like Eswatini.

AfCFTA Additional Protocol on Digital Trade, recognizing its potential to unlock continental e-commerce opportunities and benefit Eswatini businesses of all sizes, including Micro, Small and Medium Enterprises (MSMEs).

The Eswatini delegation led by the Prime Minister also visited Ethiopian Airlines to discuss implementing the Bilateral Air Services Agreement signed between Eswatini and the airline in December 2023. The Prime Minister added that they were impressed by the growth of the company. Ethiopian Airlines further expressed its intention to commence operations in Eswatini soon, fostering improved connectivity and potential economic benefits.

The Premier also asserted that they were not only impressed by Ethiopian Airlines' core operations but also by their extensive and diversified portfolio. He remarked on their impressive scale, boasting over 100 aircraft, 17,000 employees, and generating billions of dollars in revenue.

However, what truly stood out for the Eswatini delegation was the airline's ventures beyond traditional aviation. The Prime Minister specifically mentioned their ownership of one of Africa's largest hotels, offering over 1,100 rooms, and their cuttingedge aviation university.

# Eswatini, Ethiopia strengthen ties, explore deeper trade cooperation

THE Minister of Foreign Affairs and International Cooperation Pholile Shakantu shared a productive meeting between Eswatini's Minister of Commerce, Manqoba Khumalo, and His Excellency Ambassador Taye Atske-Selassie, Ethiopia's Minister of Foreign Affairs.

This engagement took place after the recent 37th Ordinary Summit of the Assembly of Heads of State and Government in Addis Ababa, Ethiopia, where Minister Pholile Shakantu accompanied Prime Minister Russell Dlamini who represented His Majesty King Mswati III.

The Minister highlighted that they had a "fruitful meeting" where both ministers explored various aspects of bilateral issues critical to strengthening the partnership between Eswatini and Ethiopia. The discussions emphasized a mutual desire to deepen diplomatic ties where both nations expressed their commitment to fostering stronger diplomatic relations, solidifying the foundation for continued collaboration.

Their meeting also touched on enhancing trade cooperation. The ministers explored avenues for expanding trade partnerships between Eswatini and Ethiopia, aiming to unlock mutually beneficial economic opportunities.

Eswatini and Ethiopia, this year commemorates 54 years of establishing diplomatic relations. The formal relations commenced on January 1st, 1971, when the first Eswatini Ambassador to Ethiopia, Martin Ndiniso, presented his credentials to Emperor Haile Selassie. Since then, both countries have fostered strong ties rooted in mutual respect, cooperation, and a shared commitment to

# 'Gawzela' asylum an advantage for the government to extradite him – Alpheous

ESWATINI government spokesperson Alpheous Nxumalo is of the view that the reports of Mduduzi 'Gawzela' Simelane being granted asylum in the United Kingdom (UK) put Eswatini in an advantageous position.

Nxumalo communicated this in a statement released on Monday, saying, "The asylum status given to Simelane only changes his status of staying in the UK, however it doesn't change his status of being a fugitive of the law who fled from Eswatini at a time when he was required to appear in court and prove his innocence over the charges he was facing."

He added that the former member of parliament status in the UK also gives Eswatini an advantage in knowing exactly the location of Simelane in case the government may be required to apply for his extradition in the future, they now know exactly where to go with their application papers.

Nxumalo emphasized that the responsibility now lies with the Government of the UK to ensure that Simelane does not violate the rules and regulations provided for by international law that govern the conduct of refugees. He further stated that it is not a significant concern for the Eswatini Government that Simelane has been granted asylum in the UK.

He highlighted previous instances where individuals from Eswatini were granted asylum in the UK, such as Prince Dumisa and Joy Maziya, the former spouse of the late Prime Minister Barnabas Sibusiso Dlamini. Nxumalo also mentioned the cases of

members of the Movement for Democratic Change (MDC) from Zimbabwe and individuals from Hong Kong seeking asylum in the UK.

"There's nothing out of the ordinary for Emaswati residing in other countries for various reasons.

The national security law introduced by Beijing established four crimes which are secession, subversion, terrorism, and collusion with foreign organizations. Granting asylum status to Simelane or anybody else, for that matter, is not a headline or front-page news item for any fundamental reason. It is just business as usual." Nxumalo emphasized.

#### Reacting

Nxumalo was reacting to an article published by the local media, which stated that after having fled the Kingdom of Eswatini over two years ago, Simelane has been granted a refugee asylum stay in the UK for the next five years, which will allow him to work.

Simelane fled the Kingdom of Eswatini in July 2021, shortly after news of an arrest warrant against him made rounds. His warrant of arrest was issued along with those of incarcerated former MPs Mthendeni Dube and Mduduzi Bacede Mabuza. The two were arrested on July 25, 2021, and charged under the Suppression of Terrorism Act of 2008.

After fleeing the country, Simelane stated that he was in the UK in a quest to spread the word about the human rights violations in Eswatini. He said he was on a global advocacy drive, fighting for freedom.

Last Monday, the former MP, who is the President of the Swaziland Liberation Movement (SWALIMO) addressed his followers on a late-night show dubbed 'Family Meeting', where he revealed that the Government of Eswatini cancelled the diplomatic passport that was issued to him.

The passport was given to Simelane as a working tool in his capacity as an MP. During the late-night show, Simelane told his followers that he was happy that in 2024 he would travel the whole world speaking about the plight of emaSwati.

"The UK ordinary passport travels to

153 countries including world superpowers without the need of a visa while the Eswatini diplomatic passport only covers 86 countries; I guess none of the superpowers included. Therefore, forcing me to take the UK stay propelled the calling to higher dimensions," he said.

# School reports transformation after World Vision Korea's E1 Million intervention







A 24-YEAR-OLD man has been arrested in connection with an alleged rape of a 21-year-old female at the Eswatini College of Technology (ECOT).

The suspect, identified as Mark Zwane from Mkhuzweni, was apprehended in connection with the matter and appeared before Principal Magistrate Fikile Nhlabatsi at the Mbabane Magistrate's Court.

The charge sheet states that Zwane is accused of contravening Section 3(1) of the Sexual Offences and Domestic Violence Act of 2018. According to the charge sheet, the alleged rape occurred in November 2023 at ECOT in the Hhohho region.

It is alleged that Zwane engaged in unlawful sexual intercourse with the 21-year-old victim without using a condom. However, it was not specified in court whether both the accused and the complainant were students at the tertiary institution.

"On November 22, 2023, at ECOT in the Hhohho region, the accused engaged in a sexual act with Zandile\* without using a condom, thereby committing the aforementioned offence," reads part of the charge sheet.

The charge against Zwane is also accompanied by an aggravating factor, as he allegedly did not use a condom during the

A 50-YEAR-OLD MAN, Samuel Madoda has been arrested for allegedly knocking down a nine-year-old child while driving under the influence of alcohol in Manzana.

Madoda appeared before Magistrate Principal Fikile Nhlabatsi at the Mbabane Magistrate's Court on Monday. He is facing two charges, one for operating a motor vehicle while under the influence of alcohol and another for negligent driving.

According to the charge sheet, on February 17, 2024, Madoda was driving his VW Polo sedan at Manzana with a blood alcohol concentration of 0.89 milligrams per litre when he struck a pedestrian, a nine-year-old female from Nkwalini.

As a result of the accident, the child sustained serious head injuries and a fracture in her left shoulder. She received medical treatment and was admitted to Mbabane Government Hospital.

The first count on the charge sheet states that on "February 17, 2024, around 4 pm in Manzana,

region, Mbabane, Madoda wrongfully and unlawfully operated a VW motor vehicle while under the influence of intoxicating liquor".

The charge sheet further states that Madoda failed to exercise proper care while driving, resulting in a collision with the pedestrian. It also mentions that he failed to take measures to avoid the accident, which a reasonable driver would have done.

The second count states that on the same day, around 4 pm, in or near Manzana, Hhohho region, Mbabane, Madoda, the driver of a VW Polo sedan, wrongfully and unlawfully struck the pedestrian on Manzana Public Road.

During the court proceedings, Madoda conducted his defence. The prosecution requested that Madoda be remanded into custody until they obtain information about the condition of the complainant. Bail was not opposed.

Madoda then successfully applied for an E5,000 bail. He is expected to appear in court on March 1, 2024, for the determination of the trial date.

#### ATM bombing case: Second bomb technician confirms explosives caused ATM damage

A BOMB technician from the Royal Eswatini Police Service (REPS) has reported that explosives were the definite cause of the ATM's explosion.

Police officer and bomb technician Constable Khumalo, who is working at the bomb squad unit at the Mbabane Magistrate Court, made this confirmation during the trial of Sicelo Msibi, Muziwandile Lukhele, Given Mavuso (all South African nationals), and Lindani Zitha (a Swati citizen).

The four defendants are facing a total of 17 charges, including robbery, malicious damage to property and kidnapping among others. These individuals are alleged to have stolen over E2 million and caused extensive property damage.

It is important to note that among the 17 charges, there is also the use of explosives to bomb the FNB ATM located in the Mbabane Industrial Site, resulting in property damage worth E785,000. The accused were apprehended by the police on August 21, 2022.

During the trial, the prosecution presented bomb technician Constable Zama Khumalo as a witness and his testimony comes after the first bomb technician Colane Shongwe told the court that commercial explosives were used in the ATM bombing.

Echoing his colleague's words, Khumalo testified that around 4 am, he received a call from his superiors informing him that there had been an explosion in Mbabane.

Acting on the information along with other members of the bomb squad, they proceeded to the scene at the Mbabane Industrial Site.

Upon arrival, they conducted a thorough assessment to ensure there were no unexploded devices present. Once the area was deemed safe, they proceeded with their work. Khumalo confirmed that the FNB ATM had indeed been bombed. He described the components of the bomb, including a firing line, which is a set of cables used to transmit power to the explosive or charge.

He mentioned the presence of a battery at the scene and explained that he disconnected some of the still-connected cables. Khumalo said the ATM suffered extensive damage, with its components displaced.

"The explosion caused shockwaves, resulting in the ATM bursting, fragmentation, and burning effects. Some of the money notes were partially burnt as a result. Additionally, a detonator residue and 18 components were found, with some components discovered 50 meters away from the ATM," Khumalo affirmed.

"To open the ATM, a bomb bust was used to pull the iron door, revealing another detonator inside," Khumalo said.

The ATM components were presented in court as evidence. He said after completing their onsite investigation, dry and water swabs were taken from the explosion site and the nearby components for further analysis in a laboratory. The findings confirmed the use of explosives in the incident.

"Our in-depth findings confirm that an explosive was used to damage the ATM," Khumalo asserted.

The crown council Sivesonkhe Ngwenya chose not to crossexamine the witness and the matter will return in court on March 4 2024.

#### Oil steadies as demand jitters


LONDON — Global benchmark Brent crude was little changed on Monday, hovering around \$83 a barrel as festering demand concerns were offset by continuing conflict in the Middle East. Brent crude futures eased by 9 cents to \$83.38 a barrel by 1434 GMT. ## Oil steadies as demand jitters counter Middle East conflict

LONDON — Global oil benchmark Brent crude was little changed on Monday, hovering around \$83 a barrel as festering demand concerns were offset by continuing conflict in the Middle East.

Brent crude futures eased by 9 cents to \$83.38 a barrel by 1434 GMT.

The March contract for U.S. West Texas Intermediate (WTI) crude, which expires on Tuesday, was up 20 cents at \$79.39 in tepid trade while the WTI April contract slipped 12 cents to \$78.34.

Front-month Brent and WTI futures last week gained about 1.5 per cent and 3 per cent respectively, reflecting increasing risk of Middle East conflict widening.

Capping those gains was slowing demand forecasts from the International Energy Agency and a bigger than expected increase to U.S. producer prices in January, amplifying inflation concerns.

"WTI and Brent eased on Monday morning as investors re-adjust to demand-side fears after a significant jump in U.S. producer price index numbers," Phillip Nova analyst Priyanka Sachdeva said in a note.

Demand jitters were magnified on Friday when U.S. Federal Reserve policymakers signalled the need for "patience" over expectations of cuts to interest rates.

Markets are also awaiting indications of the direction of demand from China after it returns from a week-long Lunar New Year holiday while Presidents' Day in the United States is set to keep trade relatively muted.

The conflict in the Middle East continued over the weekend as Israeli raids put the Gaza Strip's second-largest hospital out of service. On Saturday Yemen's Iran-aligned Houthi fighters claimed responsibility for an attack on an India-bound oil tanker.

A British-registered cargo ship was deemed to be at risk of sinking in the Gulf of Aden on Monday after a Houthi attack. Another cargo ship, this time U.S.-owned, reported two missile attacks in the Gulf of Aden on Monday and called for military assistance.

Houthi forces have carried out attacks on shipping in the Red Sea and Gulf of Aden since November in what they say is support of Palestinians in the war between Israel and Hamas militants in the Gaza Strip.

The Organization of the Petroleum Exporting Countries (OPEC) would be able to cover "most levels of disruption", ANZ Research analysts said in a note, citing spare capacity at an eight-year high of 6.4 million barrels of oil per day. (Reuters)

### South Africa's Telkom Q3 profit flat, revenue rises on value propositions

JOHANNESBURG — Telkom South Africa's third-biggest telecom company, reported flat third-quarter core profit on Monday, as cost-reduction initiatives partially offset inflationary pressures, expenses due to power cuts and increased bad debt provisions.

The earnings before interest, tax, depreciation and amortisation (EBITDA) was stable at 2.5 billion rand (\$132.45 million) in the three months ended Dec. 31, the company said in a statement.

But the resulting EBITDA margin at 21.9 per cent decreased, largely affected by product mix at its information and communications technology, or ICT, business BCX, higher-than-expected credit losses on trade receivables as retail and enterprises customers remained under pressure from the weak macroeconomic environment.

Overall group revenue ticked up 2 per cent to 11.3 billion rand, driven by compelling data-connectivity propositions from the operator's mobile and fixed networks.

Mobile revenue was up 4.8 per cent at 5.9 billion rand, while Openserve - its fibre

business - fixed data next generation revenue growth was at 6.2 per cent.

"Higher recharges by prepaid mobile subscribers, ongoing rollout of fibre network to homes and enterprises by Openserve drove revenue growth, supported by Swiftnet's commercialisation of the masts and towers portfolio," the company added.

Telkom said that enterprise demand for hardware and software remained healthy and grew in double digits at BCX but overall revenues were impacted by the continued decline in traditional voice and data revenues as customers migrate to next generation products such as fibre. (Reuters)

LONDON — World shares struggled to climb on Monday after the chances of early interest rate cuts globally receded and Chinese markets recorded modest gains on their return from the lunar new year break.

A holiday for U.S. markets made for thin trading, and results from AI star Nvidia on Wednesday could challenge the latest surge in tech stocks.

MSCI's broadest index of world shares and Europe's broader index of stocks both traded around 0.05 per cent as of 13:53 GMT.

"The mixed economic data released lately has put us in a transition period and we are waiting for the data to tell a consistent story," James Rossiter, head of global macro strategy at TD Securities, said.

A red-hot U.S. CPI print on Tuesday followed by another upside surprise in producer prices on Friday left investors anxious inflation will persist. A weaker retail sales report, suggesting slower economic momentum augmented their concerns.

However, U.S. labour market numbers

have continued to show plentiful jobs and elevated wage growth.

In Asia, Japan's Nikkei ended flat on Monday, pressured by chip-related shares following a slump in their U.S. counterparts late last week.

Chinese blue chips tab finished up just over 1 per cent, after tourism revenues during the Lunar New Year holiday surged by 47 per cent compared with a year earlier as more than 61 million rail trips were taken.

The country's central bank skipped another chance to cut rates on Sunday, limiting downward pressure on the yuan, but as deflation looms, analysts see scope for further policy stimulus.

The same cannot be said for the United States as high readings on producer and consumer prices led markets to scale back pricing for rate cuts.

"The risk to the rally is a stronger pick-up in inflation leading to higher yields," said Alain Bokobza head of global asset allocation in a Societe Generale note.

Non-recessionary rate cuts pushing up yields and a slowing of Nasdaq growth might drive volatility, which the note said was likely in the second half of this year.

Futures dropped, implying a 28 per cent chance rates will be cut in May. (Reuters)

# European Commission set to fine Apple

ABOUT 500 million euros (\$539 million) over alleged breaches of EU competition law, the Financial Times reported on Sunday, citing unnamed sources with knowledge of the matter.

Brussels first launched an investigation into allegations that Apple hindered third-party music services on its devices and favored its own Apple Music service, after Spotify filed a formal complaint to regulators in 2019.

#### Rules

In most regions, Apple's App Store rules prohibit companies such as Spotify from billing users for subscriptions directly within the app, making them instead use Apple's App Store billing service, which takes a cut of up to 30%.

Brussels formally charged Apple in an anti-competitive probe in 2021, but narrowed the scope of the investigation last year, abandoning a charge of pushing developers to use its own in-app payment system.

The latest version of the probe focused on whether Apple had restricted apps from informing users about cheaper subscription alternatives outside of its native App Store and thus violated EU competition laws.

The findings of the investigation will lead to the Commission accusing Apple of abusing its powerful position and banning its "unfair trading conditions" regarding its music service subscription policies, sources told the FT.

If imposed, the fine would be one of the most substantial financial penalties the EU has imposed on a major technology company. It follows a series of large contested fines against Google

While Apple has faced fines for antitrust behavior before — such as the €1.1 billion penalty in France that was later reduced to €372 million on appeal — this would mark its first such fine from Brussels.

The reported fine is part of a broader crackdown in the EU and comes ahead of the enactment of the bloc's landmark Digital Markets Act set for March. The new law aims to address anti-competitive practices from big tech players deemed as "gatekeepers," including companies such as Apple, Amazon and Google.

Smaller internet firms and other tech businesses, such as Spotify, have long complained of being unfairly limited by these tech giant's business practices.

In Apple's case, the Digital Markets Act will require it to allow third-party developers to distribute apps outside the iOS Store and for those apps to bill their customers directly.

Apple has made moves to address EU regulations by announcing changes to its iOS, Safari and the App Store in the EU, and announced that it will soon allow software developers to distribute their apps to Apple devices via alternative stores.

In a separate antitrust case, the European Commission is looking into the way Apple restricts rivals from accessing its Apple Pay mobile system. Apple has already made concessions in relation to the case.

The timing of the Commission's announcement on the fines has not yet been set, but that will not change the direction of the antitrust investigation, according to the FT report.

Apple has the right to appeal the decision in EU courts. The tech giant declined to comment on the report, referring CNBC to a previous statement that it was pleased regulators narrowed the focus of the probe.

# US awards \$1.5 bln to GlobalFoundries for domestic semiconductor production

WASHINGTON - The U.S. government is awarding \$1.5 billion to GlobalFoundries to expand semiconductor production, the Biden administration said on Monday, in a bid to strengthen domestic supply chains.

GlobalFoundries, the world's thirdlargest contract chipmaker, will build a new semiconductor production facility in Malta, New York, and expand existing operations there and in Burlington, Vermont, according to a preliminary agreement with the Commerce Department.

The grant will be accompanied by \$1.6 billion in available loans, with the funding expected to generate \$12.5 billion in overall potential investment across the two states.

The projects, funded under the CHIPS and Science Act, would generate more than 10,000 jobs over a decade, said Biden administration officials, adding that the positions will pay fair wages and offer benefits like childcare.

"The chips that GlobalFoundries will make in these new facilities are essential chips to our national security," Commerce Secretary Gina Raimondo told reporters at a briefing.

The chips, as small as a fingernail, are used in satellite and space communications and the defense industry, the officials said, in addition to everyday applications

such as blind spot detection and collision warnings in cars and electric vehicles, along with wifi and cellular connections.

"As an industry, we now need to turn our attention to increasing the demand for U.S.-made chips, and to growing our talented U.S. semiconductor workforce," said Thomas Caulfield, president and CEO of GlobalFoundries in a statement.

Raimondo said this is the government's third CHIPS announcement and her department planned to make several funding awards within the coming weeks and months from the government's

\$39 billion program to boost semiconductor manufacturing.

"We're just getting started," she

The Malta facility expansion will secure a stable supply of chips for auto suppliers and manufacturers, including General Motors (GM), Raimondo added.

GlobalFoundries and GM on Feb. 9 announced a long-term deal for the automaker to secure U.S.-made processors that will help it avoid factory-halting chip shortages that kept millions of cars from being manufactured during the COVID-19 pandemic.

#### OpenAI, Meta, other tech giants sign effort to fight AI election interference

A group of 20 tech companies announced on Friday they have agreed to work together to prevent deceptive artificial-intelligence content from interfering with elections across the globe this year.

The rapid growth of generative artificial intelligence (AI), which can create text, images and video in seconds in response to prompts, has heightened fears that the new technology could be used to sway major elections this year, as more than half of the world's population is set to head to the polls.

Signatories of the tech accord, which was announced at the Munich Security Conference, include companies that are building generative AI models used to create content, including OpenAI, Microsoft and Adobe. Other signatories include social media platforms that will face the challenge of keeping harmful content off their sites, such as Meta Platforms, TikTok and X, formerly known as Twitter.

The agreement includes commitments to collaborate on developing tools for detecting misleading AI-generated images, video and audio, creating public awareness campaigns to educate voters on deceptive content and taking action on such content on their services.

Technology to identify AI-generated content or certify its origin could include watermarking or embedding metadata, the companies said. (**Reuters Tech**)

# DR Congo: US accuses Rwanda of supporting M23 rebel group

THE United States has accused Rwanda of backing the M23 rebel group in the east of the Democratic Republic of Congo, prompting a backlash from Kigali.

In a statement on Saturday, U.S. State Department condemned the worsening violence and called on M23 to cease hostilities immediately and withdraw from its current positions around Sake and Goma.

It called on Rwanda to immediately withdraw all of its military personnel from the DRC and remove its DRC's "dramatic military build-up". surface-to-air missile systems.

The comments have provoked a backlash from Kigali, with the foreign affairs ministry saying that the US statement distorts the reality and that Rwanda reserves the right to self-defence against the DRC's actions in the area, which it claims threaten Rwandan security.

Kigali also expressed "deep concern" over what it terms the abandonment of the regional peace processes" and said that the international community is indifferent to

It comes amidst an escalation of violence in eastern DRC in recent weeks, with clashes between the M23 rebels, army forces and self-defence groups that support them. Hundreds of thousands have been forced to flee, many of them now in Goma, as M23 advances on the city.

Last week, South Africa said it would send a contingent of 2,900 troops as part of its contribution to a force deployed by southern African regional bloc SADC to help Congo fight rebel groups. (Reuters)

#### Morocco intercepts a boat with 141 immigrants

THE Moroccan navy said it intercepted 141 people attempting to traverse the Atlantic Ocean as migration from West Africa to Spain's Canary Islands has spiked since the beginning of the year.

Morocco's Royal Armed Forces said in a statement Sunday it was able to rescue all passengers on a boat off the coast of the Western Sahara, a disputed territory with a coastline that Morocco has controlled since

It said the 141 people all came from sub-Saharan Africa and likely embarked more than a week earlier from Mauritania - Morocco's southern neighbor and the primary point of departure for migrants attempting to reach Spain's Canary Islands.

The interception was the largest that Moroccan authorities have reported this year.

The Canary Islands are roughly 62 miles (100 kilometers) from Morocco's Atlantic coast but pirogues the wooden vessels migrants often use to cross — often launch from as far south as the Gambia, from where the journey can take up to 10 days,

Spain's Interior Ministry reported 11,704 migrants had arrived to the Canaries as of Feb. 15 — more than a sixfold increase from a year earlier. TUNIS **Imprisoned** Tunisian opposition leader Rached Ghannouchi went on hunger strike on Monday in solidarity with other antigovernment figures waging a protest fast to demand their immediate release, a team of opposition lawyers said.

Ghannouchi, 82, a fierce critic of President Kais Saied and head of the Ennahda main opposition party, was jailed last year on charges of incitement against police and plotting against state security.

Earlier this month in a separate case a judge sentenced him to three years in prison on charges of accepting external financing.

"While he is fighting the 'empty stomach' battle, Ghannouchi calls on Tunisians to adhere to a democratic Tunisia that includes everyone on the basis of freedom ... and the independence of the judiciary", the lawyers said in a statement.

The opposition says Saied's

sudden shutting down of the elected parliament in 2021 and moves to rule by decree amounted to a coup.

Saied, who enshrined his new constitutional powers in a referendum with a low turnout in 2022, has denied his actions were a coup and said they were needed to save Tunisia from years of chaos.

Six opposition leaders arrested last year in a crackdown began an open-ended hunger strike last week to protest at their imprisonment without trial and demand their immediate release.

They called for an end to judicial prosecutions against all politicians, journalists and civil society activists and for intimidation and threats to judges to stop.

The leaders -- Jawher Ben Mbarak, Khayam Turki, Ghazi Chaouachi, Issam Chabbi, Abdelhamid Jalasi, and Rida Belhaj -- were detained on suspicion of plotting against state security.

# In unusual move, China offers to back Hungary in security matters

BEIJING - China offered to support long-time strategic partner Hungary on public security issues, going beyond trade and investment relations, during a rare meeting with Prime Minister Viktor Orban, just as NATO struggles to expand its network in Europe.

China hopes to deepen law enforcement and security ties with Hungary as the two mark their 75th year of diplomatic relations, Public Security Minister Wang Xiaohong told Orban last week, the official Xinhua news agency said.

#### Relations

During a visit to Budapest, Wang said he hoped such efforts would be "a new highlight of bilateral relations" in areas such as combating terrorism and transnational crimes.

They would also encompass security and law enforcement capacity building under President Xi Jinping's Belt and Road Initiative, which aims to link China with the world through trade and infrastructure links.

Chinese state media have called NATO

a "grave" challenge to global peace and stability.

The security pact with Hungary represents a diplomatic win for China in the European Union, as the bloc weighs its ties with the world's second-largest economy over differences on human rights, trade imbalances and Russia's invasion of Ukraine.


The central European country's growing affinity to Beijing has already put a wedge in the EU's collective front.

#### Rights

On several occasions, Hungary has stood aside or opposed EU positions critical of China on issues such as human rights, and welcomed Chinese investments despite the EU's call for members to align relations with China in line with those of the bloc.

Hungary is home to Huawei Technologies' largest logistics and manufacturing base outside China, despite European Commission warnings that the telecom giant poses a risk to EU security.



BRUSSELS - Germany will propose new sanctions against Moscow over the death of jailed Russian activist Alexei Navalny, Foreign Minister Annalena Baerbock said ahead of an EU foreign ministers' meeting to be attended by his widow.

The ministers were already due to discuss the bloc's 13th package of sanctions against Russia since Moscow invaded Ukraine on Feb. 24, 2022. Hungary is the only EU state yet to approve the proposed restrictions against nearly 200 firms and people.

Yulia Navalnaya told a Western security conference on Friday that Putin and his allies would bear responsibility "for what they did to our country, to my family, to my husband".

Baerbock said she hoped the 27-nation bloc would agree on new sanctions against Russia soon.

"We have seen the brutal force with which the Russian president represses his own citizens who take to the streets to demonstrate for freedom or write about it in newspapers," she said. "We will propose new sanctions in light of the death of Alexei Navalny." Navalny died in an Arctic prison last week, just days before the two-year mark of Moscow's full-scale invasion of Ukraine.

"(EU) member states will propose sanctions for sure against those responsible," said the chairman of Monday ministerial talks, foreign policy chief Josep Borrell. "The great responsible is Putin himself."

"We can go down the institutional structure of the penitentiary system in Russia," he said indicating whom the bloc would add to its list of people subjected to asset freezes and travel bans. "But don't forget who is really responsible for Navalny's death." Navalny, a 47-year-old former lawyer, rose to prominence campaigning against corruption in Putin's Russia. He was known for his fiery rhetoric at public protests and in court rooms, vocal presence on social media, and his team's elaborate video investigations into state graft. (Reuters)

# Spain to impose sanctions on violent settlers if no EU deal

MADRID - Spain will impose sanctions on violent Israeli settlers in the West Bank unilaterally if its European Union partners fail to reach an agreement on the issue, Foreign Minister Jose Manuel Albares said on Monday.

He said Spain, which has also been critical of Israel's military offensive in Gaza, will push for the approval of such sanctions during a meeting of EU's foreign ministers held in Brussels on Monday.

"If there's no agreement, Spain will proceed individually with these sanctions against the violent settlers," Albares told reporters before the meeting.

Irish Foreign Minister Michael Martin said earlier on Monday he hoped the EU

countries would unanimously approve these sanctions.

Last week, French authorities banned 28 Israeli settlers from entering the country, accusing them of attacking Palestinians in the occupied West Bank.

U.N. figures show that daily settler attacks have more than doubled since Hamas' surprise attack on Israel on Oct. 7 and the ensuing assault on the Palestinian enclave of

While international attention has focused on that cross-border assault and Israel's subsequent war there, European officials have also expressed concern about rising violence against Palestinians in the West Bank. (Reuters)


The talented artist, known for her electrifying performances, is gearing up for the release of her 'We Love Waffles' video, and she is leaving no stone unturned in her quest for perfection.

#### 'Bob Marley: One Love' sings its own tune in spectacular box office debut

Bob Marley: One Love exceeded box expectations with a \$80 million global opening.

Despite mixed reviews, the film has strong audience ratings and a promising theatrical run ahead.

The movie set records at the Jamaican box office and is expanding to additional markets internationally.

Giving a much-needed boost to the struggling theatrical marketplace, Paramount's music biopic, Bob Marley: One Love, reported strong numbers both domestically and worldwide in its opening weekend of release. Starring Kingsley Ben-Adir as the reggae icon and directed by King Richard's Reinaldo Marcus Green, One Loveexceeded expectations in its domestic debut and appears to have well-received equally internationally.

According to Paramount's estimates, One Love is poised to generate around \$51 million in its six-day domestic opening — from Valentine's Day on Wednesday to President's Day on Monday. The film was originally expected to gross around \$15 million less in the same frame, but positive word-of-mouth is believed to have played a huge part in its stunning debut. One Love also grossed \$29 million from overseas markets, for a cumulative global opening of \$80 million.

NEVER have more than two eggs a day. Stick to wholegrain bread - and avoid white. And avoid sugary sodas at all costs

These are just three of the hundreds of the supposed diet 'rules' that we've been fed over the years, and led to believe are key to optimum health.

But increasing evidence suggests that in fact, a healthy diet is far more simple consisting of a balance of all food groups, with little sugar and junk, and plenty of fruits and vegetables.

Now, dietitians have revealed the most common diet beliefs that are totally bogus.

Many of them may come as a surprise; for instance the age-old idea that too many eggs are harmful due to high levels of cholesterol - the fatty substance that damages arteries.

You may also be shocked to hear that low calorie doesn't necassarily men healthier.

Read on to discover the seven mostbelieved nutrition myths that leave dietitians most exasperated.

#### 'NATURAL' SUGAR IS HEALTHIER THAN TABLE SUGAR

Honey and maple syrup may have antioxidant, antimicrobial and antiinflammatory properties.

But exactly how this impacts our health remains unknown. What has been proven, however, is that 'natural' sugars have the same calories as table sugar- and a virtually identical effect on our blood.

'At the end of the day, your body digests and views all of these foods as sugar,' Dietician Alyssa Pacheco told Yahoo Life.

Excessive sugar intake of any kind is bad for you, and can raise the risk of weight gain, leading to diabetes, cardiovascular disease, cancer, metabolic disorders, depression and cognitive impairment.

Instead of worrying about what kind of sugar you choose, Pacheco advises choosing whichever you prefer and having it in moderation.

The American Heart Association recommends no more than six teaspoons of added sugar a day for women and nine teaspoons for men.

#### SEA SALT HAS 'HEALING' PROPERTIES

Similarly to sugars, sea salt, Himalayan salt and table salt are ultimately all salt, containing roughly 40 percent sodium, which is the compound that impacts blood pressure.

Sea salt has minimal processing and might contain tiny amounts of magnesium, calcium and potassium.

Table salt, on the other hand, is processed to take away impurities and usually has added iodine for thyroid health.

But so long as your diet is well balanced, there is no need to get your minerals from sea salt. 'Excessive sodium consumption is linked to high blood pressure and other health issues so it's important to limit overall sodium intake regardless of the type of salt used,' said Michelle Rauch, a dietitian for the Actors Fund.

#### EAT NO MORE THAN TWO EGGS PER DAY

Yet another mistaken belief is that eggs are bad for you and will raise your cholesterol.

Because of their cholesterol content, eggs have long been the subject of fierce debate around their role in causing heart problems.

But scientists have said there is no link. Studies show that the cholesterol in eggs doesn't seem to raise cholesterol levels the way some other foods, such as those high in saturated fats.

In a 2020 study, a US team headed by a Harvard researcher found no association between egg intake and risk of cardiovascular disease (CVD) - which can lead to heart attack or stroke.

'Eggs can be part of a healthy diet and support muscle maintenance, overall wellbeing, help meet your daily protein needs and are a versatile protein source that can be added to many different meals,' said sports dietician Umo Callins.

#### DON'T EAT ANYTHING AFTER 6PM

'Your body doesn't have an internal clock that yells to your cells, "It's 6pm, time to store this food for weight gain!" said Katie Schimmelpfenning, dietitian and founder of

Eat Swim Win.

'Energy is energy no matter when it is consumed.'

People who are exercising late in the day, for instance, need a post-workout something for muscle repair and growth.

And people who do night shifts will need to eat while they are awake, said Schimmelpfenning.

Studies have shown that it is not when you eat that potentially causes weight gain, but what you eat.


Eating more earlier in the day can help manage hunger later on and stop you from eating too much.

Dietician and author Rhyan Geiger said: 'It all comes down to the types of foods you choose.

#### SKIP BREAKFAST AND HAVE COFFEE INSTEAD TO AVOID OBESITY

Most of us rely on our morning up of coffee. But it is not a meal replacement or breakfast substitute.

While a cup of coffee may be rich in antioxidants, it only contains around five calories and no protein, fat or carbs.

Dietician Patricia Kolesa said: 'While [some] coffee includes protein and fats from milk, it will not leave you full and energized the same way a conventional breakfast does.'

Nutritionists have also warned that coffee is acidic and therefore tough on an empty stomach.

#### STICK TO FRESH PRODUCE ONLY

Some people think you should stick to the outer areas of the store when food shopping as this is where the fresh produce is concentrated, but dietitian Lauren Harris-Pincus said this would be a mistake and is a 'damaging' myth.

'The center aisles contain a treasure trove of nutrient-dense and cultural foods including frozen fruit, veggies and seafood, canned beans, fruit and vegetables, as well as dried beans, whole grains, nuts, seeds and spices,' she said.

Ms Harris-Pincus recommends shopping across all areas of the supermarket that have high-quality whole foods.

But just because something is frozen doesn't make it worse than fresh, experts have said.

'Actually, frozen fruits and vegetables can contain higher levels of nutrients,' said UK based nutritionist Kim Pearson.

That's because they are frozen at their peak — right after being picked — and put through minimal processing before freezing, meaning they keep a lot of their nutrients, explained Ms Pearson.

In contrast, fresh produce can be in a supermarket for days or weeks after being picked, meaning they may have lost more nutrients by the time they are consumed.

Dietician Alyssa Pacheco said: 'Opting for the lowest calorie options possible will usually leave you feeling hungry and unsatisfied, causing you to eventually overeat.'

'Additionally, not eating enough calories can backfire in the long run because it can lower your metabolic rate.'

Some high-calorie and high-fat foods such as nuts, avocados and oils, are full of nutrients.

As with calories, low fat isn't necessarily better than full fat. Fat is needed to help us feel full, better absorb fat-soluble vitamins and give flavor.

# 'There's no such thing as healthy chocolate'

Nutritionists warn chocolate contains very few 'healthy' flavonols They say it is overblown to describe chocolates as healthy

THE idea that one chocolate bar can be 'healthier' than another is a 'fallacy' - regardless of how dark it is, a top nutritionist has claimed.

In recent years, newfangled products have popped up on the snacks market brandishing labels such as 'raw', 'better-for-you' and 'no added sugar'.

There's also varieties costing up to \$20 per pack such as cacao (cold, pressed raw cocoa beans) and 'raw' chocolate - which usually means little sugar has been added.

Some dark chocolate bars claim to be 'better-for-you' because they contain more flavonols - which studies suggest ward off heart issues.

But Dr Marion Nestle, a professor emeritus at New York University and nutritionist, has told DailyMail.com there is so little of this nutrient in the bars that someone would have to eat 'immoderate' amounts in order to get enough.

This, ironically, would put them at risk of weight gain, diabetes and heart disease - because of the inevitable excess calories.

Some nutritionists suggest you would need to eat as many as seven chocolate bars a day to get enough flavonols to experience any benefit at all - or 750 calories worth of dark chocolate, roughly half the daily recommended intake.

Dr Nestle told DailyMail.com: 'It is a fallacy to describe chocolate as healthy, but a great marketing ploy.

'Chocolate is a candy and should be enjoyed as such, in moderation of

'As a plant extract, cocoa has antioxidants that might promote health. 'But these are in such small amounts that you would need to eat chocolate immoderately to get


She added: 'And it's important to watch those calories!'

Suggestions that chocolate may be healthy have focused on flavonols - which have even been linked to improvements in brain function.

But when cacao — raw beans from cacao plants — is heated and crushed to make cocoa powder, this causes many of the flavonols to degrade.

To make processed chocolate, the powder is then mixed with sugars, cocoa butter and vegetable oils which involve more calories, sugar

Companies need to mix the powder with other substances

And a Snickers bar, which weighs 52g, contains half the saturated fat and around 250 calories - so only slightly more, per

Other products, such as Skin Glow's 'vitamin infused' chocolate, contains as much as sugar as two packs of Sour Patch Kid candies.

Nutritionists are careful not to completely demonize chocolate - saying it can still make up a part of a healthy balanced diet.

Dr Carolyn Williams, a nutritionist based in Alabama, told DailyMail.com: 'If a little chocolate brings you satisfaction and pleasure from food, then that can be a part of a healthy diet.

'So, eating tons of chocolate every day

is not going to improve your health and I would never recommend it.

'But if it is something you enjoy, then eating a little can be of benefit.' There is no official guidance on how much

chocolate someone should eat every day. But the American Heart Association suggests consuming no more than 100

calories worth of chocolate per day. About 268 million Americans are selfconfessed chocolate lovers according to polls, which is around every two in three

#### **Broos on Cameroon exit:**

# 'They accused me of asking players for money to be in national team'

BAFANA Bafana coach Hugo Broos has given his version of what went wrong when he was let go as coach of Cameroon in December 2017, 10 months after winning that year's Africa Cup of Nations (Afcon) with the Indomitable Lions.

Broos detailed alleged shenanigans around his departure, including being accused on a TV show of extorting money from players to be in the national team.

The coach admitted there are some similarities to his present situation where Bafana have exceeded expectations, winning the Afcon bronze medal in Ivory Coast this month and continuing a 2026 World Cup qualifying campaign in a group that includes nemesis Nigeria.

Bafana have friendly games in Algeria against Andorra (March 21) and Algeria (March 26) and then meet the Super Eagles and Zimbabwe in their next two Group C World Cup qualifiers in June.

In 2017, Afcon champions Cameroon lost 4-0 against Nigeria and then drew 1-1 at home as the bottom fell out of their 2018 World Cup campaign.

"It's a bit similar to the situation

in Cameroon. You won it [Afcon] and then played for the World Cup," Broos said.

"We won the first game but then lost twice against Nigeria, [including] 4-0 in Nigeria, and, I don't know, but I had the feeling there was something happening. I didn't recognise my team [in that game].

"There were two hotels where we played [in Uyo]. The best hotel was for Nigeria and we were in a very bad hotel. The chances of qualification were very slim after that game.

"Four days later we played Nigeria in Yaounde [in Cameroon]. Win that game and we had a chance, but we drew 1-1, and qualifying for the World Cup was over.

"The problems were already there then because they accused me of asking for money from players to be in the national team. It was on television.

"I was in the hotel with the staff, I forget before which game, and there was a sports programme [on TV]. There were two guests, and one of them said, 'I know the coach, team manager and team doctor asked for money for players to be in the national team. €5,000 (R102,000 at current exchange rates) if they want to play'.

"We were all in front of the TV saying, 'What is this guy saying?'. The team manager and the doctor went to court. They stopped the programme and the guy got a fine. That's Cameroon.

"From then on I could deny it but I could see they didn't believe me. So it went bad. And my contract ended and was not renewed."


Broos added, chuckling: "Let's hope that it is not the same scenario [here]. But I don't think something like that can happen in South Africa.

"But also, when you get a good result in Afcon, people expect more than they did two months before.

"So the games against Nigeria and Zimbabwe are very important."

Broos won the 2017 Nations Cup with a young Cameroon after many of the team's established stars turned their backs on the national team, or were excluded over commitment issues.

Nigeria's shock opening draws against Lesotho and Zimbabwe in November have given Bafana a chance in the 2026 World Cup qualifiers, though Broos' team were also unable to capitalise fully on that opportunity as they beat

Benin at home (2-1) but then lost away to Rwanda (2-0).

The winners of nine six-team groups in Africa reach the 48-team 2026 World Cup automatically.

The four best runners-up go into a mini tournament to decide one side to contest an intercontinental playoff.

Despite suggestions that he'd return to the octagon in 2023 to face lightweight contender Michael Chandler, McGregor is yet to make a comeback.


White previously teased that the return of 'Notorious' is being earmarked for autumn this year however, after his latest comments, that may not be the case.

He continued: 'I don't know. Conor McGregor's got a lot of money. Any time we get Conor, we'll be happy. You know, we'll be thrilled when he comes and fights.

'Money complicates a lot of things. He just filmed a movie. He's got to do the press for the movie, and he's got obligations with that. He does want to fight this year, but we'll see what happens'.

The UFC was also involved in the movie's production as Gyllenhaal's character appears to be an ex UFC fighter. The film shot fight and weigh-in scenes through UFC 285 in March with McGregor heavily involved in the marketing efforts.

The movie was shot in the middle of McGregor's hiatus after breaking his leg against Dustin Poirier in July 2021. The former two-division champion is yet to see the Octagon since.

In a video posted on New Year's Eve, McGregor announced that he will be fighting Michael Chandler at 185 lbs in Las Vegas however White shut that down.

The UFC chief continued: 'Conor McGregor has probably been one of the best business partners we've ever had.

'Getting Conor to show up to sh\*t on time is a problem. But Conor, as far as the business goes, everybody talks about how Conor used to be on the dole and all this stuff.

'For a guy that was on the dole, Conor McGregor is a very good business man, and Conor McGregor has always been a great partner to us.





The nation's pride is likely to face either Somalia, Djibouti, Sao Tome or Chad in the bid to qualify for the group stages in the quest to proceed to the main tournament to be hosted by Morocco in January 2025.

According to the CAF website, Sihlangu has been placed in Pot 2 which has Liberia, South Sudan and Mauritius. Pot 1 is made up of Somalia, Djibouti, Sao Tome and Chad which is where Sihlangu's preliminary round opponents will come

The AFCON 2025 qualifiers preliminary round matches will be during the FIFA week from March 18-26.

The eight lowest-ranked teams in the FIFA ranking will play the preliminary round and the remaining 44 teams will be exempted and will play directly in the group stage.

### Nsingizini, 'Birds' in hot soup after brawl

THE brawl that ensued between Nsingizini Hotspurs and Mbabane Swallows on Sunday at King Sobhuza II Memorial Stadium will not go unpunished.

The two teams will face charges that may carry a fine of over E100 000 if they are charged and found guilty by the Disciplinary Committee. The brawl ensued on Sunday during the week 17 of the MTN Premier League. The chaos started when Mbabane Swallows left back Kwakhe Thwala and Meshack Lushaba for Nsingizini Hotspurs, head-butted each other, and hell broke loose. Officials, supporters, and players from both teams were engaged in a brawl that led to Police Officers intervening to calm down the situation.

The two teams may be charged based on article 38 under misconduct. Some of the charges may include 38.3.1: By the home Member Club if it fails to provide adequate

Home Venue or at any ground at which a home match is played. In this regard, it will be presumed that a Member Club failed to provide adequate security where

the spectators at this venue, irrespective of their affiliation, are responsible for improper conduct.

38.3.3. Improper conduct includes but is not limited to invading or attempting to invade the demarcated area, throwing or attempting to throw projectiles or bottles, damage or attempted damage to property, letting off or attempting to let off incendiary devices, displaying insulting or

political slogans, uttering insulting words or sounds, smoking or contravening any statute, regulation or by law;

**38.3.5.** By a Member Club or its Member Club Officials or Players in the event of their insulting or assaulting Players, physically or verbally abusing other Member Club Officials, Match Officials, or any other person at a match.

**38.3.6.** By a Member Club, or its Member Club Official, or Players, should any of them commit or fail to take reasonable steps to prevent -

The following sanctions may be imposed warning, reprimand a monetary fine on any terms decided on by the Disciplinary Committee with a maximum of E100 000 (one hundred thousand Emalangeni) and minimum of E10 000 (Ten thousand Emalangeni).
