THE High Court has sentenced businessman Sipho Shongwe to 50 years in prison for orchestrating the contract killing of prominent businessman Victor Gamedze.

The sentence was delivered following a comprehensive ruling, which detailed the planning and execution of what the court termed a gruesome and cold-blooded murder on Thursday at the High Court in

Shongwe was found guilty of hiring a group of hitmen, Mbuso Ncaza Nkosi, Sandile Dzodzo Zikalala, and Simphiwe Tata Ngubane to carry out the assassination. The killing took place on January 14,2018 at the Galp Filling Station in Ezulwini, in full view of the public.

The judgment highlighted that the murder was audaciously bold, sudden, and striking, and that it required a lengthy custodial sentence to serve as a deterrent to others.

"This was a premeditated contract killing, part of a common purpose. It was planned, well-executed, and intended to shock. Crimes of this nature are heinous, wicked, and morally offensive," read the judgement.

The court noted the arrests of accomplices Ncaza and Ngubane in South Africa were facilitated through the Mutual Legal Assistance in Criminal Matters Protocol.

They were extradited to Eswatini after an investigation led by Detective Senior Superintendent Sikhumbuzo Fakudze, whose team presented extensive cellphone data, direct evidence, and circumstantial evidence linking Shongwe to the murder. $\,$

In establishing precedent, the Court cited South African legal standards, where individuals found guilty of hiring assassins

"There is no doubt in casu that the jurisprudence in Eswatini is in the main compatible with the South African jurisprudence. The planning and manner of execution justify the harshest sentence under the law," the court stated.

Policies

Although the sentence is 50 years, the Court acknowledged that remission policies may reduce the total time to be served. Shongwe is entitled to a one-third remission in accordance with correctional services procedures, potentially reducing the sentence by 16 years and 8 months.

Additionally, the court acknowledged the 7 years Shongwe spent in custody awaiting trial. Factoring in these reductions, the actual time to be served could be approximately 26 years and 4 months.

The court dismissed pleas for leniency from Shongwe's defence, which included mitigation submissions and testimony by a clinical psychologist.

However, the presiding judge ruled that individuals who engage in contract killings "do so at their own risk and peril" and must face the consequences.

"The interests of justice and society are prime in this matter," the judge said, emphasizing that sentencing must reflect the seriousness of the offence and provide closure to the public.

"This crime perpetrated against the deceased Victor Gamedze was morally and extremely offensive. I run short of words to describe the evil nature of his death."

. Court brands Gamedze murder 'a heinous contract killing'

THE High Court has described the murder of Victor Gamedze as a 'heinous' 'shocking', and 'morally offensive' crime carried out in a calculated, public assassination.

The ruling confirmed that Gamedze was murdered by hired assassins acting on instructions from convicted mastermind Sipho Shongwe. The court concluded that the murder was not only deliberately premeditated, but also intended to instil fear in the public.

"It would be in the best interest of justice that an appropriate sentence commensurate with the contract killing be imposed in order to serve as a deterrence," reads the ruling.

The judge referenced international studies and historic assassinations to emphasize the psychological impact of

Examples included the assassinations of U.S. President John F. Kennedy and Dr. Martin Luther King Jr., which the judge said left a permanent mark on public consciousness.

Similarly, the court said the death of Gamedze, a household name in Eswatini, has had a lasting effect.

"The public remembers vividly of the horrific brutal assassination of Victor Gamedze as if it happened yesterday."

The Court stressed that justice in highprofile public assassinations must serve more than just legal punishment; it must deliver societal closure.

This, the judge said, could only be achieved through a fair, just, and proportionate sentence.

"Such murders or assassinations always leave a lasting horrific impression on

those who witnessed it and equally on those who did not witness it but heard of it," the judge said. The murder was planned with elaborate and sophisticated preparation, and carried out in a manner that the court described as brazen.

Evidence presented during trial pointed to Shongwe's central role in financing and arranging the hit, including his communication with the assassins.

Cellphone records

Detective Senior Superintendent Sikhumbuzo Fakudze led a probe that exposed deep communication trails via cellphone records, as well as direct testimony and surveillance footage.

The court praised the thoroughness of the investigation and the cooperative legal efforts between Eswatini and South African

The judgment also cited legal precedent, including the Loyiso Ludidi & Others v The State case, to underline that proportionality


in sentencing is a constitutional right, but that the severity of the crime warranted a harsh penalty.

"When people engage in premeditated contract killings, they do so at their own risk

and peril," the judge concluded. Shongwe's sentence was officially arrest, meaning the seven years spent in custody are recognized in the computation of his time behind bars.

Considering the one-third remission rule and time served, his actual prison time may total around 26 years.

Nonetheless, the court emphasized that the key priority was not arithmetic, but justice remain an effective deterrent.

Minister of Health;

We're aware that some health officials own pharmacies but – Minister declares

MINISTER of Health Mduduzi Matsebula has addressed a series of pressing concerns raised by senators regarding drug shortages, health worker conduct, staff shortages, and perinatal deaths in the country's health facilities.

Speaking during the Ministry of Health Senate Portfolio Committee sitting on Tuesday, Minister Matsebula acknowledged the challenges facing the sector but assured lawmakers that his ministry was actively working to resolve them.

Responding to allegations that some health professionals are exploiting the system by owning pharmacies while still working in public service, the Minister said investigations were underway.

"We have received reports to the extent that some health officers double as employees and at the same time own pharmacies," Matsebula said. "We have instituted investigations, but these people connivingly register these companies in different names... not theirs."

He admitted there is a need to overhaul the current system used for drug stock-outs and distribution, which has been blamed for the persistent lack of essential medicines in clinics and hospitals.

"There is a need to come up with a system to resolve the stock-out and stock-take in the distribution of drugs and medicines, which continues to cause public outcry," he said.

Despite the concerns, Matsebula insisted that drug supply to health centres has improved significantly, and he invited senators to accompany him on inspection visits to see the improvements firsthand.

"There is improvement in the distribution of drugs to health centres and clinics. I challenge Senators to come with me to see for themselves that the situation has improved," he added.

He also addressed the issue of perinatal deaths, stating that in many cases, these are not caused by a lack of medication but rather delays in patients seeking medical attention.

"Perinatal deaths sometimes are not caused by the shortage of drugs, but most of the time, pregnant people visit hospitals late," the Minister explained.

On the matter of expired drugs discovered in some facilities, Matsebula clarified that the expired stock was not recently purchased but had been sitting in storage for over a decade.

"The expired drugs were not bought recently but have been there since 2008. We also do benchmarking with other countries to find solutions on how to monitor and prevent drug expiry," he said.

He further pointed out that the Ministry of Health has established a Medicine Regulatory Authority to ensure only safe and approved medications are supplied to health

Turning to human resource issues, the Minister expressed concern over the limited number of new hires in the ministry, stating that while 480 positions were needed, only 92 were filled — a decision made outside his ministry's control.

"On the issue of only employing 92 instead of 480, as a Ministry, we have no control over this matter as another ministry handles that," he said.

Matsebula concluded by highlighting a worrying trend: the ongoing exodus of healthcare workers seeking opportunities abroad, which continues to leave the ministry severely understaffed.

"Health employees are leaving the country every month, thus causing them to be understaffed in the ministry," he noted.

As Eswatini grapples with critical health sector challenges, the Senate Portfolio Committee sitting shed light on key weaknesses while also outlining the efforts underway to restore public confidence in the health system.

A CALL for the increase of Free Primary Education (FPE) grant to enhance the school feeding scheme has been made.

The call was made by different stakeholders on Thursday during the Systems Approach for Better Education Results in School Feeding (SABER-SF) two-day workshop held at The Gorge Hotel.

The SABER-SF assessment is led by the ministry of education and training, with technical support from an international consultant engaged by World Food Programme (WFP), and in close collaboration with colleagues from the WFP Eswatini Country Office and from the WFP Regional Office.

This collaborative approach underscores the spirit of partnership and country ownership that is so critical to the success of school meals programmes.

The increase of the FPE grant according to the different stakeholders, which included amongst others, schools' principals, ministry of education and training officials and Swaziland National Association of Teachers (SNAT) amongst others, is to allow schools to have enough money for maintenance.

The stakeholders further called for the standardisation of feeding times in schools.

"Schools that provide breakfast should have lunch at 1pm and those without breakfast should have lunch at between 10:30 and 11am," said the stakeholders.

The stakeholders also called for the escalation of nutrition education in schools through empowering school feeding focal teachers on nutrition, who will then educate the school community on production and preparation of meals. They pointed out that such teachers should be given a stipend for

The stakeholders further called for the empowerment of school administration on procurement, especially on local one (pro-

curement).

In addition, they called for the development of standard kitchens that are all inclusive and allows for the preparations of same meals as well as special meals for children with allergies.

It was also the stakeholders' call that schools administrators should be trained on sustainable farming practices and use of safe fuel for meal preparation.

Furthermore, they called for the implementation of a training programme for all personnel involved in the school feeding

They also called for the development of a risk-based approach in the management of food supply. Meanwhile, the Schools Manager Lungelo Nhlengethwa, who represented the Principal Secretary in the ministry Nanikie Mnisi during the workshop, said as a ministry, they were pushing for pupils to have meals three times a day.

He pointed out that there was a time where pupils were receiving two meals a day; however, the food had to be reduced to one meal per day due to financial constraints.

He urged all the stakeholders to work collaboratively with the ministry in ensuring that their goal of providing three meals per day to the learners was achieved.

Hunger Crisis Deepens:

72% in low-income countries can't afford healthy diets – WHO report

THE World Health Organization (WHO) has reported that over 544.7 million people in low-income countries amounting to 72% of the population were unable to afford a healthy diet in

The report, released this week, underscores a worsening global food insecurity crisis and calls for urgent international action.

"Food is a basic right, not a luxury," the report emphasizes, shining a spotlight on the dire consequences of rising food prices, economic instability, conflict, and climate change on the world's poorest populations," WHO states in the report.

The WHO explains that a "healthy diet" includes a balanced intake of essential nutrients from a variety of food groups. Yet for the majority in low-income nations, the cost of such a diet far exceeds their daily income. In some regions, the price of nutritious foods like fruits, vegetables, dairy, and lean proteins remains prohibitively high compared to starchy staples.

It should be noted that the affordability crisis is not merely about hunger it is about malnutrition in all its forms.

"Millions are not just going to bed hungry; they're consuming diets that lack the vi-



tamins and minerals needed to live healthy, productive lives," the report warns.

Moreover, according to the organisation, inadequate nutrition is directly linked to stunted growth in children, weakened immune systems, higher rates of disease, and lower school performance.

It is worth mentioning that for adults,

the consequences are equally alarming decreased productivity, vulnerability to illness, and a continued cycle of poverty.

The report also highlighted that the gender gap remains significant, with women and girls being disproportionately affected by food scarcity and rising costs.

The WHO has urged governments, do-

nors, and international organizations to scale up support for food systems that are sustainable, affordable, and equitable.

According to the WHO, this includes investing in local agriculture, subsidizing nutritious foods, expanding social protection programs, and mitigating the effects of climate change on food production.

In addition, the report encourages high-income countries to support global food aid efforts and to revise trade policies that might worsen food insecurity in vulnerable regions.

In the report, The WHO further points out that in countries like Eswatini, which rely heavily on imported food and have limited agricultural capacity, the impact is particularly severe.

In earlier reports in the Media, the Civil society organizations and local leaders called for a coordinated response to strengthen food systems and prioritize nutrition in national development plans.

It is worth mentioning that the WHO's findings are a clear reminder that access to food is a fundamental human right, not a privilege.

"With more than half a billion people unable to afford a healthy meal, the global community faces an urgent moral and humanitarian obligation: to act swiftly, decisively, and with compassion," the organisation has pointed out.





DPM brings hope to vulnerable families in Shiselweni 1, Sigwe constituencies

DEPUTY Prime Minister Thulisile Dladla officially handed over four newly constructed two-roomed houses to families in Shiselweni 1 and Sigwe Constituencies, offering them not just shelter but renewed hope.

This initiative marks a significant step in the government's efforts to uplift vulnerable communities and provide them with the necessary support to improve their living conditions. In her visit to Shiselweni 1, the Deputy Prime Minister first met with the Vilakati family, comprising Thandeka and Mxolisi Vilakati and their six children. The family had previously been living in a leaking, thatched hut that had sustained considerable damage during the heavy rains earlier this year.

To provide temporary protection, a tent was set up over their fragile home. The handover of a new house represents a monumental improvement in their living conditions, allowing the family to live in safety and comfort.

The emotional impact of this initiative was palpable as DPM Dladla visited Gogo Gladys Ntjangase, an 80-year-old resident of Shiselweni 1. Gogo Ntjangase's previous home collapsed in January 2025, leaving her in a precarious situation. Overcome with

emotion during the handover ceremony, she expressed her deep gratitude and admitted that she had initially doubted the DPM's promise of assistance during her earlier vis-

it. The new home not only shelters her but also restores her faith in the support offered by the government. Moving to Sigwe Constituency, the DPM met with the Nxumalo family, led by Gogo Josphinah Ndlovu. The family, which includes her daughter-in-law, Nomcebo Nxumalo, and four sons, had been living in a dilapidated structure riddled with cracks and holes.

Their previous living conditions posed significant risks, including exposure to dangerous snakes, which led them to frequently call for community assistance. The new home offers them a haven, alleviating their fears and providing them with a sense of security.

The last family to receive a new home was that of Ndoda and Dwana Simelane, who are raising nine children in a single, deteriorating room. The DPM had first visited them in January 2025 and, through the Asibambaneni Sibengumndeni reality programme, played a crucial role in reuniting the family by locating the father, who had been away for three years seeking employment.

In addition to their new home, the Simelane family is set to receive goats, indigenous chickens, fencing, and a solar energy system, further supporting their sustainability and self-sufficiency.

During the handover events, Deputy Prime Minister Dladla also distributed food parcels, including rice and noodles, along with essential household items such as basins to all the families. This gesture not only addresses immediate needs but also demonstrates the government's commitment to holistic support for vulnerable households.

Help police locate these missing girls

THE Royal Eswatini Police Service are seeking out assistance from the members of the public after several women went missing.

According to the notice, Sakhile Temlaba Nyawo of Moyeni (Siteki) went missing from home in September 2023. She has not been found yet.

The REPS is appealing for information that may assist in locating Promise Mngometulu, a missing teenage girl who was last seen on Monday, 21 July 2025.

"She was reportedly leaving home to go visit her father in Mbabane, but has not been seen since. At the time of her disappearance, Promise was wearing a pair of blue jeans, a white T-shirt, and black sneakers. She is described as fair in complexion, medium build and short," read the notice.

The police have revealed that an investigation into her disappearance has since been

opened by Matsapha Police.

Meanwhile, the REPS has also launched an urgent investigation into the disappearance of a 20-year-old woman and her 6-monthold baby, who were last seen during the first week of July.

The Police say the young mother and her



daughter reportedly left home at Ekuthuleni and have not been heard from since.

These cases now forms part of the #REPS' broader campaign #FacesWeMustFind, a national initiative aimed at raising the profile of missing persons' investigations and gathering public support in locating those unac-



counted for. According to REPS, efforts are currently underway to establish the circumstances surrounding their disappearance as they are working tirelessly to trace their whereabouts and are appealing to the public to assist in the investigation.

Microsoft poised for \$4 trillion valuation

Trump issues blitz of tariff

Vodacom wins appeal in compensation case

SOUTH Africa's Vodacom Group on Thursday secured a ruling from the country's Constitutional Court to overturn a lower court's decision regarding compensation owed to a former employee for his role in developing its call-back messaging service.

The Constitutional Court of South Africa set aside the Supreme Court of Appeal's judgment and sent the matter back to the court to be re-heard by a different panel of judges.

Cooperatives hold more than E3.5 bln in assets

COOPERATIVES in Eswatini now hold assets exceeding E3.5 billion, with the sector playing a growing role in driving inclusive economic growth, financial access and community development.

This was revealed by the Minister of Commerce, Industry and Trade, Honourable Manqoba Khumalo, during the 2025 International Day of Cooperatives commemorations held in Manzini.

The event marked a national celebration of the cooperative movement's contribution to the economy and to achieving the country's broader development goals.

The theme for this year's celebration, 'Cooperatives: Driving Inclusive and Sustainable Solutions for a Better World' was officially announced by the minister, aligning Eswatini with the United Nations International Year of Cooperatives.

The theme also resonates with key global platforms, including the Second World Summit for Social Development and the UN High-Level Political Forum.

In his address, Minister Khumalo shared key figures underscoring the cooperative movement's economic footprint.

According to him, Eswatini's cooperatives collectively hold assets above E3.5 billion, with members now being part-owners of institutions that are not only growing but also delivering tailored financial solutions. "These are not just enterprises, they are people-driven institutions that put community before competition and dignity before profit." said the Minister.

A significant portion of the cooperative sector's activity is centered around Savings and Credit Cooperative Societies (SACCOS). These institutions provide thousands of Emaswati with accessible financial services, often in areas underserved by traditional banking systems.

Through SACCOS, members have accumulated savings valued at over E2.6 billion. This growing pool of savings, the minister said, is enabling individuals and families to plan and invest in their futures with dignity.

In addition, loans issued through SACCOS have now exceeded E₃ billion. These funds are being channelled into a range of areas, including:

"These tailored services continue to enhance financial inclusion, promote dignity and improve livelihoods across all corners of our society," Minister Khumalo said.

According to the ministry, the cooperative movement is not only contributing to household welfare but also presenting growing investment opportunities.

Minister Khumalo said that cooperatives are actively revitalising local economies, providing a stable model that stands firm in the face of rising global inequality, climate challenges, and economic uncertainty.

"The cooperative model is a proven model of resilience, they are not just part of the solution they are the solution." he said.

With over E3.5 billion in assets, E2.6 billion in savings, and more than E3 billion circulating in loans, the cooperative sector is emerging as a significant player in Eswatini's financial landscape.

The government views this model as central to expanding financial access, especially in rural and semi-urban communities. The

minister also extended gratitude to development partners who continue to support the growth and professionalisation of the cooperative movement in the country.

Deutsche Genossenschafts-und Raiffeisenverband (DGRV) A German cooperative and credit union organisation providing technical support, governance training, and capacity building.

Minister Khumalo noted that both DGRV and Taiwan ICDF have played a critical role in strengthening cooperative governance and expanding access through digital platforms.

Beyond financial metrics, cooperatives are also advancing inclusion and empowerment goals. According to the ministry, cooperatives are opening access to financial products for women, supporting agricultural development, and creating employment pathways for young people.

"Youth empowerment is no longer a policy slogan. It is being implemented through cooperative enterprise," Khumalo said.

He also cited farmer cooperatives that are now enabling access to inputs, markets, and credit for rural producers, helping to improve food security and boost rural incomes.

The government reaffirmed its

commitment to the cooperative movement as part of Eswatini's broader strategy for inclusive development.

With a focus on digitization, governance reform and youth-led enterprise, the ministry said the sector would continue to be supported through policy and technical interventions.

The ministry plans to continue tracking cooperative performance, reporting annually on savings and lending activity, governance improvements, and membership growth.

Current projections suggest continued growth in the value of savings and the total loan book, which may surpass E4 billion in the next few years if current trends hold. As of 2025, cooperatives in Eswatini are no longer small-scale, peripheral players in the national economy. With assets now exceeding E3.5 billion, savings of E2.6 billion, and loans surpassing E3 billion, they are helping Emaswati build resilience, invest in education, and improve household security.

The Ministry of Commerce, Industry and Trade says this year's theme reflects the cooperative movement's power to offer concrete, scalable solutions to some of the country's toughest development challenges.

"We acknowledge and celebrate all those who are shaping and strengthening the Cooperative landscape in Eswatini and beyond," Minister Khumalo said.

Eswatini to modernize investment climate with new Trade promotion bill

THE Eswatini Investment Promotion Authority (EIPA) has taken a decisive step toward overhauling the country's investment landscape, unveiling a new Investment and Trade Promotion Bill during a high-level stakeholder consultation at Sibane Sami Hotel in Ezulwini.

Addressing business leaders, policymakers, and development partners, EIPA emphasized that the proposed legislation is set to replace the outdated Swaziland Investment Promotion Act of 1998, which no longer meets the demands of today's global economic environment.

The bill, which has been in the pipeline through a multi-stakeholder consultative process, is designed to reflect current international trade standards and align with Eswatini's obligations under global economic

According to EIPA, the legislation aims to streamline and modernize how the country attracts and manages both local and foreign investments, while also strengthening export capabilities.

"This consultation marks a significant milestone in our journey toward economic transformation and sustainable development," the EIPA representative said in remarks delivered on behalf of the CEO Sibani Mngomezulu.

"This is not just a legal document; it's a strategic tool to position Eswatini as a competitive, transparent, and investor-friendly economy." he said.

The law proposes major structural reforms aimed at creating a unified and agile system for trade and investment promotion. At the heart of this bill is a move to reduce bureaucracy, improve investor access, and consolidate institutional roles into a single coordinated framework.

Since the enactment of the 1998 Investment Promotion Act, the global economic terrain has shifted significantly. Eswatini has signed numerous international conventions and trade agreements, and EIPA says the current legal setup simply hasn't kept pace.

"The 1998 Act has been found wanting, particularly in terms of aligning with progressive international trade and investment regimes. We must now adapt or risk falling behind," EIPA noted.

The proposed bill not only repeals the older act but introduces provisions that address the long-standing pain points of doing business in Eswatini.

These include regulatory delays, overlapping mandates, and a lack of coordination among government agencies. The new bill will give EIPA greater clarity of purpose and tools to support investors efficiently.

EIPA was quick to point out that this legislative reform is part of a larger national effort to improve the ease of doing business. Notably, the country has already made strides under its Investor Roadmap initiative, which has helped streamline business licensing, company registration, and other administrative processes.

"While progress has been made, we recognize that we must continuously evolve to remain competitive in a fast-changing global economy. This Bill is part of that evolution,"

the representative said.

The bill is supported by Eswatini's broader investment policy, and aims to foster inclusive growth by deliberately supporting the participation of youth and women in economic activity.

EIPA also stressed the importance of aligning the law with the country's overarching national development goals, particularly those outlined in the Government Pro-

Perhaps the most notable feature of the day was EIPA's strong emphasis on consultation. Stakeholders were urged to critically examine the bill and offer frank, practical feedback.

The agency made it clear that it views stakeholder input not as a procedural formality, but as a foundational part of policymaking.

"Your insights are not just welcome they are essential. We are here to listen, to understand your concerns, and most importantly, to incorporate your expertise and experiences into a law that is fit for purpose." the CEO's representative told attendees.

Participants at the consultation included representatives from business support organizations, private sector leaders, and policy experts, many of whom have previously called for legal clarity and predictability in the country's investment framework.

EIPA also touched on the bill's potential to boost investor confidence by offering clear legal guarantees and institutional stability. The goal, according to the agency, is to build a rules-based environment where businesses can plan, invest, and grow with confidence.

"It's about sending a clear message to the global investment community: Eswatini is open for business and serious about creating a level playing field," the representative said.

In its closing remarks, EIPA extended gratitude to development partners, government ministries, and the private sector for their continued support in shaping this bill.

"We are the implementing agency for investment and trade policy, supported by the

Ministry of Commerce, Industry, and Trade. But this cannot be done in isolation. It will take coordinated action and continued collaboration." said the representative.

Following the consultation, EIPA will compile stakeholder input and finalize the draft legislation before it is presented to the appropriate legislative bodies.

The agency is hopeful that the bill will be passed into law within the current fiscal year. For now, the focus remains on building

"As we consult, let us ensure that the final outcome reflects the aspirations of the private sector, supports inclusive participation, and positions Eswatini on a clear path to high-income status," said the EIPA repre-

With pressure mounting for economic reform and private sector growth, all eyes will be on how this legislation evolves and how swiftly it moves from consultation to imple-

Microsoft poised for \$4 trillion valuation after solid results

MICROSOFT is set to soar past \$4 trillion in market valuation for the first time on Thursday, as a blockbuster earnings report helps the tech behemoth become the second company after Nvidia to surpass the milestone.

The software company forecast a record \$30 billion in capital spending for the current fiscal first quarter and reported booming sales in its Azure cloud computing business on Wednesday.

Shares of Microsoft were up 8.5% at \$557.03 in early premarket trading, valuing it at \$4.14 trillion.

Washington-head-Redmond quartered Microsoft first cracked the \$1 trillion mark in April 2019.

Its move to \$3 trillion was more measured than other tech giants, Nvidia and Apple with AI bellwether Nvidia tripling its value in just about a year and clinching the \$4 trillion milestone before any other company on July 9. Apple was last valued at \$3.12 trillion.

Lately, breakthroughs in trade talks between the U.S. and its trading partners ahead of President

Donald Trump's August 1 tariff deadline have buoyed stocks, propelling the S&P 500 and the Nasdaq to record highs.

Microsoft, the second largest U.S. company, has rebounded nearly 50% from its April 2025 lows, when global markets were rattled by Trump's tariff offensive.

Microsoft's multibillion-dollar bet on OpenAI is proving to be a game-changer, powering its Office Suite and Azure offerings with cutting-edge AI and fueling the stock to more than double its value since ChatGPT's late-2022 debut.

Armed with exclusive access to OpenAI's models, Microsoft has raced to the front of the generative AI pack - supercharging its Azure cloud business, now the company's top revenue driver, and solidifying its dominance in the tech landscape, compared to Google's cloud and Amazon's web services.

Wall Street's surging confidence in the company comes on the heels of back-to-back record revenues for the tech giant since September

The stock's rally had also re-

ceived an extra boost as the tech giant trimmed its workforce and doubled down on AI investments

While sweeping U.S. tariffs had - determined to cement its lead investors bracing for tighter busi-

ness spending, Microsoft's strong earnings have shown that the company's books are yet to take a hit from the levies. (**Reuters**)

Trump issues blitz of tariff announcements on copper, Brazil, South Korea imports

U.S. President Donald Trump on Wednesday issued a blitz of tariff announcements ranging from changes to previously threatened levies on imports of copper, goods from Brazil and South Korea, to ending an exemption from tariffs for small-value shipments from overseas.

The wave of announcements came as the clock ticked down toward an August 1 deadline for higher U.S. tariff rates, as Trump presses on with his bid to reshape global

Capping a day that began with Trump announcing a 25% tariff rate on goods from India, after months of negotiations between Washington and New Delhi failed to produce a trade deal, Trump said a 50% tariff on copper pipes and wiring would kick in on Friday.

Trump plans to sign new executive orders on Thursday imposing higher tariff rates on several countries that have been unable to reach negotiated trade deals with the United States, Politico reported, citing a White House official.

Details of the copper levy fell short of the sweeping restrictions expected and left out copper input materials such as ores, concentrates and cathodes.

The surprise move dragged down U.S. copper prices more than 17% on the Comex exchange and unwound a premium over the London global benchmark that had grown in recent weeks, with shipments diverted there in anticipation of higher domestic prices.

Zuckerberg signals Meta won't open source all of its 'superintelligence'

META CEO Mark Zuckerberg his vision Wednesday for "personal superintelligence," the idea that people should be able to use AI to achieve their personal goals.

Smuggled into the letter is a signal that Meta is shifting how it plans to release AI models as it pursues "superintelligence."

"We believe the benefits of superintelligence should be shared with the world as broadly as possible," wrote Zuckerberg. "That said, superintelligence will raise novel safety concerns. We'll need to be rigorous about mitigating these risks and careful about what we choose to open source."

That wording about open source is significant. Zuckerberg has historically positioned Meta's Llama family of open models as the company's key differentiator from competitors like OpenAI, xAI, and Google DeepMind. Meta's goal has been to create open AI models that were as good as or better than those closed models. In a 2024 letter, Zuckerberg wrote, "Starting next year, we expect future Llama models to become the most

Zuckerberg has previously left himself room to maneuver on this commitment. "If at some point however there's some qualitative change in what the thing is capable of, and we feel like it's not responsible to open source it, then we won't," he said in a podcast last

And while many say Llama doesn't fit the strict definition of open source AI — partly because Meta hasn't released its massive training datasets — Zuckerberg's words point to a possible change in priority: Open source may no longer be the default for Meta's cutting-edge AI.

There's a reason why Meta's rivals keep their models closed. Closed models give companies more control over monetizing their products. Zuckerberg pointed out last year that Meta's business isn't reliant on selling access to AI models, so "releasing Llama doesn't undercut our revenue, sustainability, or ability to invest in research like it does for closed providers." Meta, of course, makes most of its money from selling internet advertising.

Still, that stated viewpoint

while developing Llama 3.

Cut to June 2025, when Meta began its public AGI sprint in earnest by investing \$14.3 billion in Scale AI, acquiring Scale's founder and CEO, and restructuring its AI efforts under a new unit called Meta Superintelligence Labs. Meta has spent billions of dollars to acquire researchers and engineers from top AI firms and build out new data centers.

How 2 UC Berkeley dropouts raised \$28M for their AI marketing automation startup

marketing AI-POWERED automation startup Conversion, founded five years ago by two UC Berkeley dropouts, has raised a \$28 million Series A led by Abstract, with participation from True Ventures and HOF Capital.

The company's founding story sounds like it could have been an episode of the HBO show "Silicon Valley.'

The story begins all the way back when co-founder and CEO Neil Tewari, now 24, was in high school. He got busted one day watching a TechCrunch Disrupt livestream during class, was sent to the principal's office, and had to stay

Afraid to call his parents and tell them why they had to pick him up, he instead called one of their close friends. On the drive home, Tewari explained to the friend what got him in trouble. "I told him I had this interest [in entrepreneurship], and four years later, he was actually the first person to write us a check into the company," Tewari told TechCrunch.

James Jiao, Tewari's college roommate at Berkeley - now Conversion's co-founder and CTO — also dreamed of founding his own company, so the two tried building various products, like one for helping marketeers buy product placement ads. They stumbled on the idea for Conversion when they signed up for HubSpot to help them

with marketing tasks and decided to build a few extra automation features to layer on top of it.

"It was originally for us," Tewari said of his startup's tech. The cofounders enjoyed building their internal marketing tool so much, they wondered if they could sell it and began reaching out to marketing executives for "customer discovery"

"We actually spent like two

months doing like 160 customer interviews with VPs of marketing, 50- to 500-employee businesses, and got a much more positive response than we could have imagined," Tewari said.

Marketing teams had these tools deeply embedded in their workflows, but everyone had similar complaints about the parts they couldn't automate.

Google is experimenting with machine-learning powered age estimation tech in the U.S.

GOOGLE is testing a machine-learning-powered tech in the U.S. to determine the age of users and filter content across all its products accordingly.

The company said it will consider data from Google accounts, including types of details users have searched for or categories of videos they have watched on YouTube, to determine the age. If the company's tool decides that a user is under 18, they would get an email with details about how Google products might change for them.

For these users, Google will disable the timeline in Maps, stop personalized ads, restrict age-restricted ad categories, and bar them from accessing adult-themed apps on the Play Store. The company will

also turn on digital wellbeing features on YouTube, such as break reminders and "go to bed" notifications when consuming videos late at night. Plus, it will prevent underage users from accessing certain kinds of content — such as content that could trigger body image issues repeatedly.

If users think they have been tagged as an underage account by mistake, they can appeal the decision and prove their age using a photo of their government ID or a selfie.

Google rolled out similar measures for YouTube earlier this week, and now the company is experimenting with machinelearning-based age gating in the U.S. for Google accounts at

Nigerian nurses strike for pay and staffing as talks collapse

NURSES in Nigeria's public hospitals began a seven-day "warning" strike on Wednesday, demanding improved remuneration, better working conditions and increased recruitment, after a two-week ultimatum to the government expired without resolution.

The National Association of Nigeria Nurses and Midwives (NANNM) warned that if their demands are not met by next week, the union will embark on an indefinite strike, the first in over two decades.

"We hope that before the seventh day, we'll have attention and positive response from the federal government," said Christianah Adeboboye, head of the nurses' and midwives'

A meeting on Tuesday between the union and a government delegation led by Labour Minister Muhammad Dingyadi ended in a stalemate.

"When you look at the composition of the meeting, it already shows that no outcome could have been gotten out of that meeting," said Toba Odumosu, union secretary in

Lagos, citing the absence of Health Minister Ali Pate as a critical gap.

The impasse underscores the growing rift between healthcare workers and the government, leaving patients vulnerable as hospitals brace for further disruptions.

The union is pushing for the recruitment of more nurses, pointing to a sharp decline in personnel as over 42,000 nurses have left Nigeria for jobs abroad in the past three years, according to the Nursing and Midwifery Council of Nigeria.

Angola says death toll from protests rises to 22

ANGOLA'S government said on Wednesday that the death toll from violent protests against a fuel price hike had risen to 22 from the previous day's estimate of four.

The unrest broke out on Monday when minibus taxi associations launched a three-day strike against a government decision to increase the price of diesel by one-third, part of efforts to curb costly subsidies and shore up public finances.

Looting, vandalism and clashes with police started in the capital Luanda, then spread to other provinces.

President Joao Lourenco's cabinet met on Wednesday and received an update on the security situation and police response.

A presidency statement said there had been 22 deaths, 197 people injured and 1,214 arrests. Sixty-six shops and 25 vehicles had been vandalised, and some supermarkets and warehouses looted, the statement said.

Angola has been gradually removing fuel subsidies since 2023, when a petrol price hike also triggered deadly protests, encouraged by the International Monetary Fund among others.

Subsidies amounted to as much as 4% of gross domestic product (GDP) last year, according to the Southern African oil-producing country's finance minister.

Investors are closely watching the drive to phase out subsidies.

Pieter Niesten, portfolio manager for emerging market debt at Neuberger Berman, told Reuters that fuel subsidies were estimated to account for 1.8% of GDP this year, contributing to fiscal pressures.

SA readying last-minute trade offer to avoid US tariff

SOUTH Africa is preparing a last-minute "enhanced" trade proposal at the urging of U.S. officials in hopes of avoiding a 30% tariff which kicks in on Friday, its trade minister said on Thursday.

South Africa initially submitted a proposed trade deal to President Donald Trump's administration in May and revised it in June, but received no response.

"We're having to navigate a last-minute proposal that's enhanced from the proposal that we had initially given," Trade Minister Parks Tau said on South Africa's 702 radio, adding: "And to tell the truth, it's wait and

The countdown to the August 1 deadline has stirred fear and uncertainty in South Africa, where the central bank governor has estimated a 30% U.S. tariff would put 100,000 jobs at risk, with the agriculture and automotive sectors hit hardest.

The U.S. is South Africa's second-largest bilateral trading partner after China. South Africa

exports cars, some manufactured goods, citrus fruits and wine to the U.S.

Tau said South Africans spoke to U.S. officials on Wednesday night, both at the level of Washington's embassy in Pretoria and also the U.S. trade representative, but uncertainty lingered on what would happen as the tariff deadline approached.

"They (said) they would encourage us to resubmit our proposal, possibly an enhanced proposal, to the United States government," Tau said.

A top South African diplomat said on Tuesday that U.S. demands on domestic affirmative-action policies were complicating efforts to secure a trade

Bilateral relations have been strained by South Africa's Black Economic Empowerment (BEE) policies to address the legacy of centuries of racial inequality and its genocide case against Israel at the World Court, which Israel and the U.S. vehemently oppose.

Kenyan court orders exhumations in suspected cult-related deaths

A Kenyan court has ordered the exhumation of bodies suspected to belong to people who were starved and suffocated in the same county where hundreds of members of a doomsday cult were found dead two years ago, prosecutors said on Wednesday.

The bodies in the new case are believed to be buried in shallow graves on the outskirts of Malindi in southeastern Kenya's Kilifi County, and 11 suspects are being investigated, Kenya's Office of the Director of Public Prosecutions said on X.

"Investigators suspect multi-

ple individuals were murdered through starvation and suffocation," it said.

"The victims may have been starved and suffocated as a re sult of adopting and promoting extreme religious ideologies."

More than 400 bodies were exhumed from the nearby Shakahola Forest in 2023 in one of the world's worst cult-related disasters in recent history.

In that case, prosecutors have alleged that cult leader Paul Mackenzie ordered his followers to starve themselves and their children to death so that they could go to heaven before the world ended. (Reuters)

Are Trump tariffs authorised by emergency powers – Judges

U.S. appeals court judges sharply questioned on Thursday whether President Donald Trump's tariffs were justified by the president's emergency powers, after a lower court said he exceeded his authority with sweeping levies on imported goods.

The U.S. Court of Appeals for the Federal Circuit in Washington, D.C., is considering the legality of "reciprocal" tariffs that Trump imposed on a broad range of U.S. trading partners in April, as well as tariffs imposed in February against China, Canada and Mexico.

In hearing arguments in two cases brought by five small U.S. businesses and 12 Democratic-led U.S. states, judges pressed government lawyer Brett Shumate to explain how the International Emergency Economic Powers Act (IEEPA), a 1977 law historically used for sanctioning enemies or freezing their assets, gave Trump the power to impose tariffs. Trump is the first president to use IEEPA to impose tariffs.

The judges frequently interrupted Shumate, peppering him with a flurry of challenges to his arguments.

"IEEPA doesn't even say tariffs, doesn't even mention them," one of the judges said. Shumate said that the law allows for "extraordinary" authority in an emergency,

"extraordinary" authority in an emergency, including the ability to stop imports completely. He said IEEPA authorizes tariffs because it allows a president to "regulate" imports in a crisis. The states and businesses challenging the tariffs argued that they are not permissible under IEEPA and that the U.S. Constitution grants Congress, and not the president, authority over tariffs and other taxes. Neal Katyal, a lawyer for the businesses, said the government's argument that the word "regulate" includes the

power to tax would be a vast expansion of presidential power, Katyal said.

The arguments - one day before Trump plans to increase tariff rates on imported goods from nearly all U.S. trading partners - mark the first test before a U.S. appeals court of the scope of his tariff authority.

Policy

The president has made tariffs a central instrument of his foreign policy, wielding them aggressively in his second term as leverage in trade negotiations and to push back against what he has called unfair practices. Trump has said the April tariffs were a response to persistent U.S. trade imbalances and declining U.S. manufacturing power.

He said the tariffs against China, Canada

and Mexico were appropriate because those countries were not doing enough to stop illegal fentanyl from crossing U.S. borders. The countries have denied that claim.

Shumate cited a 1975 appeals court decision that authorized President Richard Nixon's across-the board surcharge of 10% on imported merchandise to slow inflation. But that decision added that the president did not have authority to impose "whatever tariff rates he deems desirable."

Shumate also said that courts cannot review a president's actions under IEEPA or impose additional limits that are not included in the law. Several judges said that the argument would essentially allow one law, IEEPA, to overwrite all other U.S. laws related to tariffs and imports. **Reuters**

Panama communities challenge canal expansion project

COMMUNITIES in Panama affected by a \$1.6 billion project by the Panama Canal to build a massive new water reservoir on Thursday introduced a lawsuit before the Supreme Court asking it to the declare the project unconstitutional, Coordinadora Campesina por la Vida representing farmers said.

The canal, a key global freight channel, has said the project to build a reservoir in the Rio Indio is essential to expand its operations and manage its water resources, after a recent drought in 2023 and 2024 forced it to limit transits. "We want it to be understood that the Canal has not done things right, that the Rio Indio project be stopped and that a process of dialogue be opened," Santander Tristan, a lawyer for the communities, said in court. According to canal authority data, approximately 2,500 people could be impacted by the project. The groups' suit alleges that the project would violate the constitution in six different ways, including disregard for international human rights and environmental treaties to which the country is a signatory. It also alleges the canal authority failed to conduct a prior consultation with the communities affected.

Zelenskiy, moving to defuse crisis, restores power of anti-graft agencies

PRESIDENT Volodymyr Zelenskiy restored the independence of Ukraine's two main anti-corruption agencies on Thursday, moving to defuse a political crisis that has shaken faith in his wartime leadership and worried Western partners.

Thousands of protesters rallied in Kyiv and other cities in recent days in a rare show of discontent after lawmakers led by Zelenskiy's ruling party rushed through amendments last week defanging the respected agencies.

Zelenskiy reversed course after the outcry, under pressure from top European officials, who warned that Ukraine was jeopardising its bid for European Union membership by curbing the powers of its anti-graft authorities.

He signed a new bill on Thursday shortly after lawmakers approved it 331 to 0, saying the legislation "guarantees the absence of any kind of outside influence (or) interference".

"Ukraine is a democracy - there are definitely no doubts," Zelenskiy said on the Telegram messaging app.

Thursday's law reverses amendments that had given his hand-picked general prosecutor the power to transfer cases away from the agencies and reassign prosecutors, a step critics alleged had been designed to protect his allies from prosecution.

Eradicating graft and shoring up the rule of law are key requirements for Kyiv to join

the EU, which Ukrainians see as critical to their future as they fend off a Russian invasion

European Commission President Ursula von der Leyen described Thursday's law as "a welcome step" and urged Ukraine to continue its reform drive.

PUBLIC PRESSURE

Popular demonstrations had continued even after Zelenskiy submitted the new

bill last week, with hundreds rallying near the presidential offices in Kyiv late on Wednesday chanting "Shame!" and "The people are the power!".

Ukrainians, following a night of deadly Russian air strikes, also rallied near parliament ahead of Thursday's vote to pressure lawmakers to approve the new measure.

After it passed, they burst into cheers and applause.

"Some fight on the front, and some need to put them (authorities) in their place here," said demonstrator Mykola Pominchuk, 42.

Speaking at the rostrum before voting, opposition member Yaroslav Yurchyshyn thanked Ukrainians for stopping authorities "one step from the abyss" of autocracy.

Some lawmakers appeared in parliament with handmade placards mimicking those carried by protesters.

CORRUPTION FIGHTERS

The National Anti-Corruption Bureau of Ukraine (NABU) and the Specialised Anti-Corruption Prosecutor's Office (SAPO) have stepped up a closely watched campaign against graft since Russia's February 2022 invasion.

They have brought charges against lawmakers and senior government officials, including a then-deputy prime minister who was accused last month of taking a \$345,000 kickback. **Reuters**





DREAMS can be exciting, scary, or just plain strange.

We all dream, even if we don't remember it the next day. But why? And what do our dreams mean, anyway?

What Are Dreams?

Dreams are basically stories and images your mind creates while you sleep. They can make you feel happy, sad, or scared. They may seem confusing or perfectly rational. Sometimes, they can feel so real that you may question whether you're dreaming or not.

Some experts say we dream at least four to six times a night. You can dream at any stage of sleep, but the most vivid dreams occur during a phase called REM (rapid eye movement) sleep. During this cycle of deep sleep, your brain is most active.

Dream lag

What you dream about may be linked to what's going on in your waking life. But it might not happen right away. Some experts have found what they call the "dream lag effect." Studies have found that it could take up to six days for a person's experience to show up in their dreams.

Why Do We Dream?

Many theories exist about why we dream, but no one knows for sure. Some researchers say dreams have no purpose or meaning, while others believe we need dreams for our mental, emotional, and physical health.

According to some experts, human beings have three basic needs to fulfill during our waking hours:

- ► **Autonomy:** We want to be able to make our own decisions.
- ► **Competence:** We want to feel effective as we move about our day.
- ▶ **Relatedness:** We crave connection with others.

When those needs aren't met, our frustrations may play out in our dreams.

Many studies have looked into the importance of dreams for our health and well-being. In one study, researchers woke people just as they were going into REM sleep. They found that those who weren't allowed to dream had:

- ► More tension
- ► Anxiety
- ▶ Depression
- ▶ Difficulty focusing
- ▶ Lack of coordination
- ► Weight gain
- ► A tendency to hallucinate (see things that aren't really there)

Dreams could also exist to:

- ▶ Help us solve problems in our lives
- ► Store away important memories
- ▶ Process emotions

If you go to bed with a troubling thought, you may wake up with a solution or at least feel better about the situation.


Some dreams may also help our brains organize our thoughts and events of the day. Others may simply result from normal brain activity and mean very little, if anything. Researchers are still trying to learn more.

Types of Dreams

Experts have so far been able to identify several types of dreams. Among them are:

Lucid dreams

An overview of dreaming



In this type, you know you're dreaming. Research shows that lucid dreaming comes with a boost of activity in parts of the brain that are usually restful during sleep. You can think of it as a brain state between REM sleep and being awake.

Some lucid dreamers are able to control some things that happen in their dreams, changing the story, so to speak. While this tactic may help sometimes, especially during a nightmare, many dream experts say it's better to let your dreams flow naturally.

Nightmares

A nightmare is a bad dream. It's common in both kids and adults. You can have a nightmare for several reasons, including:

- ▶ Stress
- ► A recent conflict in your life
- ► A red ► Fear
- ► A traumatic event
- ► Medications you're taking
- ► Recreational drug use
- A health issue, such as untreated sleep apnea

If you keep getting a certain nightmare repeatedly, your subconscious mind (the brain activity that happens without you being aware of it) may be trying to tell you something. Listen to it. If you can't figure out why you're having bad dreams, talk to a mental health expert. They may be able to help you figure out what's causing your nightmares and give you tips to put you at ease.

Keep in mind that no matter how scary a nightmare is, it's not real and most likely won't happen in real life.

Recurrent dreams

It's common to have the same dream again and again. In fact, many people do. One theory is that it happens because you're concerned about something that keeps appearing in your dream. Your brain might be trying to find a way to process your feelings about it.

Other types of dreams include:

- ▶ **Daydreams.** You're not asleep when you daydream. But at least one small study shows that these moments of quiet reflection could help improve your learning and memory.
- ▶ **Prophetic dreams.** Throughout history, people of different religions have had intense dreams that they claim predict the future.

Does Everyone Dream the Same?

We're all curious about dreams, and how ours compare to those of other people. Here are answers to some common questions.

Does everyone dream in color?

It's unclear whether everyone always dreams in color, but your media exposure may have something to do with it. In the early 20th century, most people who

participated in dream studies said that they dreamed in black and white. But by the 1960s, when you could watch movies and TV in color, that changed. By one expert's estimate, just over 82% of people began having "Technicolor dreams."

A small study compared the dreams of people who grew up watching black-and-white movies and TV with people who had access to color TV. The study found that people who watched these old types of media were more likely to dream in shades of gray.

Do blind people dream?

Yes, and not just people who recently became vision-impaired. People who were born without vision can also have lush, colorful dreams. The brain regions that control other senses, such as hearing and touch, appear to provide extra information, allowing the brain to create a mental "movie"

Do deaf and hard-of-hearing people dream the same?

Researchers found that people with hearing loss signed in their dreams to communicate, just like they did in real life, while the other group

used speech. The people with hearing loss also reported having much brighter and more vivid colors in their dreams.

How Long Do Dreams Last?

Although we're usually not aware of it, we sleep in 90-minute cycles. During that time, you move through different stages of sleep:

Stage I. Your brain and body are just starting to relax and drift off. This stage of light sleep usually lasts just 5-10 minutes.

Stage II. Your breathing and heart rate slow down as you get ready to fall into a deeper sleep. But you also have a few periods of brain activity that may have to do with "filing away" recent experiences. This stage lasts about 25

Stage III. Your body and brain are fully at rest. If you're woken out of this stage, you'll probably feel foggy and may not know what's going on right away. You'll spend 20-40 minutes in this stage.

Stage IV. Here's when you finally reach REM sleep, where most dreaming occurs. In fact, your brain could be more active than it is during your waking hours! REM sleep lasts only a few minutes early in the night but gets longer in later sleep cycles.

Some experts think we spend about two and a half hours dreaming every

Just as there are different opinions about why we dream, there are different views about what dreams mean. Some experts insist dreams aren't connected to our real emotions or thoughts. They believe dreams are just strange stories that don't relate to normal life.

The famous psychologist Sigmund Freud was the first person to suggest that dreams are a window into our subconscious and that they reveal our:

- ▶ Unconscious desires
- ▶ Personal thoughts
- ► Motivations

Freud believed that dreams were a safe way to satisfy urges and desires that weren't acceptable to society.

Common themes in dreams

Freud was also the first to point out that dreams often contain similar themes.

For instance, some common negative dream themes include:

- ► Falling
- **▶** Swimming
- ▶ Being chased
- ▶ Being naked in public
- ▶ Being paralyzed with fear
- ▶ Being around fire
- ▶ Being late

Trying over and over to do something Freud believed that the brain relied on such themes to process painful real-life situations, helping you distance yourself from things that may have really happened to you, but you may not want to think about them directly.

Rassie looks at player ages, prep for 2027 World Cup

SPRINGBOK coach Rassie Erasmus said aside from issues in their game play, the team is in a good place halfway through its four-year preparation cycle for the next World Cup.

When also asked whether some senior players would still be considered for the 2027 global showpiece in Australia, he said selection would be fair - If older players are still performing, they will be there.

Erasmus was speaking to media amid their two-week training camp in Johannesburg ahead of their Rugby Championship title defence. This begins with games against Australia in Johannesburg and Cape Town on 16 and 23 August, respectively.

Gap in player experience

Thirty-seven Test-capped players are included in the squad for those games, with eight capable Springboks acting as backup.

Three Junior Springbok stars who helped their team win the World Rugby U20 Championship joined the camp, as Erasmus seeks depth and eyes all "possibilities of players" in the coming months and years. When asked about preparation for 2027, Erasmus said, "I can't really say there are any problems - I am not saying with our game, there are lots of things we must fix."

He said during Covid, players lost out on rugby from school level all the way to domestic and international level. Erasmus saw the result of that in the quality of players currently aged 20 to 26. But he was adapting to this. "You lose two years of guys developing. But overall, apart from that I'll be looking for excuses because I think we are pretty much on track.

"But we are trying to focus on the now without forgetting the future. We know 2027 is going to be big but if we don't do well leading up to it, we might lose momentum."

Older Springboks will be selected if they perform

The Springboks have a number of older players who may retire in the coming years. Siya Kolisi, 34, Cobus Reinach, 35, Bongi Mbonambi, 34, Damian de Allende, 33, Eben Etzebeth, 33, Faf de Klerk, 33, Franco Mostert, 34, Makazole Mapimpi, 35, Vincent Koch, 35, and Willie le Roux, 35, are among them.

Erasmus said age was not as important as ability. "Probably all of us will be involved until 2027 if I don't get fired before then," he

PSG fined by UEFA for fan misconduct at Champions League final

PARIS St Germain have been fined after misconduct by their fans during the club's Champions League final win over Inter Milan in May, European soccer governing body UEFA said on Thursday.

The French champions, who thrashed Inter 5-0 at the Allianz Arena in Munich, were charged after a

pitch invasion by supporters, the ards who struggled to keep control. setting off of fireworks, throwing of objects, damage to property and the display of an inappropriate message. Thousands of PSG fans flooded onto the field after the whistle to celebrate the club's first European Cup triumph, with a large number of supporters from behind the goal spilling onto the pitch, overwhelming stew-

In total, PSG were fined 148,000 euros (\$169,208.40), with the biggest penalty for the pitch invasion and use of pyrotechnics.

UEFA's Control, Ethics and Disciplinary Body also issued a ban on PSG's away ticket sales for one UEFA match, suspended for two years.

A rising junior at the Benjamin School in Palm Beach, Fla., Woods won the AJGA's Team TaylorMade Invitational in May. He has not yet made a college commitment. (Reuters)

Verstappen confirms he will stay at Red Bull next year

BUDAPEST - Four-times Formula One world champion Max Verstappen has ended speculation about a move to Mercedes next season by confirming for the first time on Thursday that he will race on with Red Bull.

"I think it's time to stop all the rumours. For me, it was always quite clear that I was staying," the Dutch driver told reporters ahead of the Hungarian Grand Prix.

"And that was the general feeling in the team because we are always in discussion about what we could do with the car and when you're not staying you stop talking about these kind of things. And I never did." Formula One starts a new engine era next year in a major shake-up that could change the pecking order, with Mercedes expected to lead the way while Red Bull are making their own power unit after a split with Honda.

Reigning champion Verstappen has known break clauses in his contract but they have not been triggered, with the 27-year-old third in the standings at the mid-point and with two wins from 13 races.

It was widely accepted in Formula One that Verstappen would be staying, with the rumour-mill already turning to a possible exit from Red Bull in 2027 with performance clauses again applying next year. Verstappen otherwise has a Red Bull contract that runs through 2028.

The sacking of Christian Horner

this month as Red Bull team boss was also widely seen as another step by the energy drink company to convince the sport's most sought-after driver to stay with them.

"Some people just like to stir the pot, some people just like to create drama. But, for me, it's always been quite clear," said Verstappen.

Mercedes boss Toto Wolff said last week that retaining his current lineup of George Russell and Italian Kimi Antonelli was a priority.

Russell told reporters separately at the Hungaroring that he was sure to be racing for Mercedes next year but nothing would be signed until after the August break, which follows the Hungarian race.

While Russell's current deal expires at the end of the year, he has been under a management contract with Mercedes since he was 16 -meaning his employers are effectively negotiating with themselves. "Conversations have started but we are now heading into the summer break," said Russell.

"Toto and I have spoken a lot this week but we haven't spoken once about the contract because we're both trying to solve the car's performance and get the team in the right place.

"And I personally want to go into the summer break and enjoy the only two weeks off I have in the year and I don't want to be thinking about contracts," he added. "There isn't really a major time pressure now from my side, nor from Mercedes' side."
