

PM rallies MPs to back E200bln grand plan for Eswatini's transformation

PRIME Minister Russell Mmiso Dlamini has called on Members of Parliament to rally behind the government's ambitious Grand Plan, a 30-year national development blueprint aimed at transforming Eswatini's economic and social landscape.

The Prime Minister made the call during a consultative engagement held with the House of Assembly at Piggs Peak Hotel on Monday

The Grand Plan, which is currently in draft form, is built on three pillars Economic Transformation, Social Transformation, and Government Transformation and requires E200 billion to implement over the next three decades. The Prime Minister said the plan represents a bold and necessary shift from the incremental progress of previous national strategies.

"I am humbled to witness a presentation to this Honourable gathering, a long-awaited document, one that started as a wild idea and is finally taking shape," he told Members of Parliament

He further said that less than two years ago, he made a presentation at Sibaya and shared what had long been conceived in his mind, but something he never thought would come to fruition, let alone that he would have to be the one driving its formulation.

The Prime Minister said he was encouraged by the national response to the plan since its conception, and that public interest in it had grown rapidly, indicating a collective readiness to shift toward a long-term development strategy that extended beyond the normal five-year political cycles.

"It is almost as if we were all in one accord, just waiting for the right moment to come up with a long-term plan that would not only take Eswatini out of an economic conundrum, but bring continuity beyond the normal five-year term for politicians," he said.

The Prime Minister acknowledged that Eswatini had made progress through previous national strategies such as the National Development Strategy, the National Development Plan, and sector-specific master plans.

However, he said that despite these efforts, broad-based prosperity and inclusive growth had remained elusive.

"Despite pockets of growth, Eswatini remains far from achieving its ambition of broad-based prosperity. Economic challenges over the past decades, including slow GDP growth, limited foreign direct investment, fiscal constraints, and high youth unemployment, have underscored the urgent need for a bold and transformative response rather than incremental change," said the PM.

He said that while past development plans had achieved gains in areas like agricultural productivity, basic education access, and SME support, structural challenges such as weak infrastructure, gaps in the health sector, and limited private sector development continued to persist.

According to the Prime Minister, the Grand Plan is a response to this moment of national reckoning.

"Eswatini stands at a critical crossroads. Will we continue on the path that has led us here today, or will we brave a different path altogether?" he asked.

He said the long-term goal was to see Eswatini reach high-income status within the next two to three decades and be counted among the most developed nations in the world, a vision aligned with His Majesty's aspiration for the Kingdom.

"To get there, we need a deliberate and credible long-term strategy that corrals the whole of Government. We must work together to see this future materialise," he said.

Dlamini emphasised that the Grand Plan was not a quick fix, but rather a carefully structured long-term solution that had been built with extensive input from a team of young professionals, experts, and regional benchmarking efforts.

"It gives me such great pleasure to present to you a document that has taken months to put together a piece of work that has been done with such meticulous detail that it even justifies the time it has taken to produce," he said.

He said the Grand Plan would only succeed if MPs actively participated in its refinement and ultimately championed it.

"Honourable Members of Parliament, I do hope that this draft document will at least

meet some of your expectations, but most importantly, it should be able to deliver the desired outcome if executed, particularly as this plan is a direct response to the Sibaya mandate," he said.

The Prime Minister said unity was critical to the plan's success. "I have no doubt that if we pull in the same direction, having unity of purpose and driven by our common desire to serve the Nation well, we will achieve that target. For divided we fall, but united we stand," he said.

He described the strategy as one that was ambitious, innovative, and realistic, designed to attract participation from people across all sectors of society.

"We must address the multiple crises confronting the Nation and grow the economy at rates that sustainably surpass this polyresin," he added.

The Prime Minister said the Cabinet had already reviewed the framework and would do so again after Parliament's input, before final adoption.

"Our job today, therefore, is to first listen, secondly to critique, and thirdly to make an input. You are advised to provide detailed feedback or input in writing to the team so that the final document articulately captures our collective sentiments and vision for the future of this beautiful kingdom," he said.

Also speaking during the engagement was Speaker of the House of Assembly, Jabulani 'Buy Cash' Mabuza, who welcomed the consultation and called on MPs to actively contribute to the plan's development.

"This engagement is both timely and necessary. It allows Parliamentarians to not only understand the vision behind the Grand Plan but also shape it with meaningful contributions," said Mabuza.

Mabuza, who is also the Member of Parliament for Piggs Peak, said he was honoured that the historic engagement was taking place in his constituency.

"This is a proud moment for Piggs Peak. I want to encourage all Honourable Members to engage constructively. We all have a role to play in shaping the Eswatini we want to see over the next thirty years," he said.

MINISTER of Natural Resources and Energy, Prince Lonkhokhela, has assured senators that government is taking decisive steps to address key national concerns including copper theft, water billing inconsistencies, and land ownership disputes.

Speaking during the Ministry of Natural Resources Senate Portfolio Committee sitting, the Minister stated that the rising cases of copper theft were a serious concern, not just for Eswatini, but globally. He revealed that the matter is being treated with urgency at Cabinet level." Copper theft is a global challenge and not unique to Eswatini. Cabinet is currently working on finding a lasting solution to this issue which has become a thorn in the side of many utility service providers," he said.

Water Metering and Billing Concerns

Addressing issues around water billing inconsistencies raised by senators, Minister Lonkhokhela confirmed that the Eswatini Water Services Corporation (EWSC) has already begun rolling out prepaid water meters. "The rollout of smart prepaid water meters is ongoing and will help consumers better manage their water usage and spending," he said.

He attributed the unexplained spikes in some water bills to leakages, noting that many consumers may not be aware of under-

ground leaks that result in excessive charges. "Most increases are caused by undetected leakages. It is important for property owners to routinely check their water systems," the Minister advised.

Land Policy and Farm Disputes

The Minister also addressed land tenure and disputes between farm owners and dwellers, making specific reference to the Mbondzela Farm issue which has drawn public interest in recent months." Government is already attending to matters between farm dwellers and owners, such as the situation at Mbondzela," he said.

He added that the finalisation of the national Land Policy will play a critical role in promoting peace and stability in the country. "The Land Policy will ensure that there is peace in the country by providing clarity on land ownership, usage, and rights of occupation," he stated.

Senators welcomed the responses but urged the Ministry to speed up implementation of measures that directly impact the lives of ordinary citizens, especially in rural communities.

'Load shedding saves millions'

MINISTER of Natural Resources and Energy, Prince Lonkhokhela, has revealed that the ongoing load shedding measures by the Eswatini Electricity Company (EEC) are not only necessary but are saving the utility millions of Emalangeni.

Addressing the Ministry of Natural Resources Senate Portfolio Committee, the Minister explained that load shedding is strategically implemented during peak hours when electricity costs are at their highest. "During these times, which the company has identified for load shedding, the electricity becomes very expensive for EEC," said Minister Lonkhokhela.

He stated that by temporarily cutting supply in non-critical areas during high-cost periods, the company avoids purchasing electricity at inflated prices from regional suppliers, thus reducing operational costs significantly." This approach helps save the company millions, which can be redirected to improve infrastructure and maintain stable supply in the long term," he added.

The Minister acknowledged the inconvenience caused to citizens but emphasized the importance of understanding the economic logic behind the decision. He assured the committee that EEC is working on longterm solutions to reduce the country's dependence on imported electricity. "We are currently working on expanding local generation capacity, including renewable energy projects, which will reduce reliance on external suppliers and stabilise prices," he said.

Some senators raised concerns over poor communication and a lack of warning to the public when load shedding occurs. In response, the Minister urged EEC to enhance its customer engagement and improve its load shedding schedules' transparency.

The update came as part of a broader discussion covering energy supply, water billing, and land policy. Minister Lonkhokhela reiterated government's commitment to addressing the challenges affecting service delivery in these sectors, saying that reforms are already underway.

The committee noted the responses and called for accelerated implementation of energy efficiency projects, greater investment in local energy generation, and consistent communication with affected communities.

On another note, the Minister told the Senators that the Ministry and parastatals under it do have communication officers.

Ministry should exercise duty of care- Senator, Linda Nxumalo

SENATOR Linda Nxumalo has urged the Ministry of Natural Resources and Energy to prioritize public safety and communication during ongoing load shedding periods, highlighting the rising threat of crime in areas affected by blackouts.

The senator made her remarks during the recent sitting of the Senate Portfolio Committee on Natural Resources and Energy, addressing Minister Prince Lonkhokhela directly.

"Members of the public deserve to be educated on how to protect and defend themselves whenever they find themselves in the dark during load shedding," Senator Nxumalo emphasized. "Hooligans and robbers use this opportunity to pounce on members of the public and rob them of their valuables, like cars and many more."

She called on the Ministry to exercise a clear duty of care by initiating public education campaigns that inform citizens on safety measures during power cuts and by working collaboratively with security agencies to enhance protection during vulnerable periods.

In a shift to fiscal matters, Senator Nxumalo further interrogated the Ministry's financial performance, referring to revenue

reports presented during the session.

"In the first quarter, the Ministry reported revenue of E46 million. I would like to ask if the projected E221 million for the year will realistically be reached in the remaining quarters," she asked.

It should be noted that the question highlights growing parliamentary scrutiny over government revenue targets amid economic pressures and the urgent need for sustained service delivery in the energy and natural resources sectors.

breastfeeding as a preventive health measure for mothers, potentially reducing the burden of chronic diseases later in life. Dr. Nxumalo also addressed how breastfeeding influences infant development. "Breastfeeding promotes cognitive development, improves brain function, and supports overall growth and development," she noted.

This assertion aligns with growing research indicating that breastfed infants often perform better in cognitive assessments compared to their formula-fed peers.

The psychological benefits of breastfeeding for mothers were another focal point stressed by Dr Nxumalo. She remarked, "Breastfeeding can reduce stress and anxiety, promote feelings of calm and relaxation, and increase feelings of motherly love and connection." This emotional aspect is vital, as it contributes to the overall well-being of mothers and enhances their parenting experience.

The bond between mother and infant is profoundly affected by breastfeeding. Dr. Nxumalo explained, "Skin-to-skin contact and the closeness of breastfeeding strengthen the bond between mother and baby, promoting emotional connection and attachment." This connection is essential for the emotional and social development of the child, fostering a secure environment for growth.

Breastfeeding also offers emotional benefits for infants. Dr. Nxumalo pointed out that "breastfeeding provides a sense of security and comfort, which can lead to better emotional regulation and development." This sense of security is crucial during the early stages of life, as it lays the foundation for healthy emotional

The public health implications of breastfeeding cannot be overstated. Dr. Nxumalo stated "Breastfeeding plays a critical role in promoting public health by reducing infant mortality, improving child health outcomes, and supporting healthy growth and development."

Finally, Dr. Nxumalo discussed how breastfeeding can contribute to reducing healthcare costs. "Breastfeeding can decrease the incidence of illnesses and diseases, reduce hospitalisations, and promote healthier outcomes," she explained. This economic aspect is particularly relevant for healthcare systems, as investing in breastfeeding support can lead to significant cost savings in the long run.

Sr. Emerencia Stewart-Ngubane, Nursing Supervisor at Manzini Clinic and Matsapha Healthcare, shared that despite the clear health benefits, several societal challenges hinder breastfeeding practices.

marked. Traditional practices may also discourage exclu-sive breastfeeding, leading to mixed feeding dermine the benefits of breastfeeding.

Furthermore Emerencia highlighted the lack of family community support as a barrier. "Often, partners or elders may discourage breastfeeding, lead-ing to isolation for new mothers," she explained. The pressures of urbanisation and modern lifestyles, including time constraints and the perceived inconvenience of breastfeeding, also contribute to the challenges faced

Healthcare providers play a pivotal role in promoting breastfeeding. Sr. Emerencia emphasised the importance of personalised support from mid-wives, nurses, and paediatricians.

pelling myths and providing accurate guidance on positioning, latching, and milk supply," she stated. Immediate support after birth, particularly in the first 24-48 hours, increases the chanc-

es of successful breastfeeding.

She also noted that healthcare providers can quickly identify and address common issues such as sore nipples or low milk supply, which can discourage mothers from continuing to breastfeed. "Encouragement from trusted providers boosts a mother's confi-dence, especially for first-time moms," she added, highlighting the need for unified messages from healthcare professionals to reinforce trust and adherence.

To foster a supportive environ-ment for breastfeeding, Sr. Emeren-cia suggested several strategies for healthcare providers. "Starting early during antenatal visits to educate mothers about the benefits and basics of breastfeeding is essential," she advised. Being supportive and non-judgmental is equally important. "Listening to mothers' concerns and offering reassurance without pressure can make a significant difference," she said. Promoting skin-to-skin contact immediately after birth is also crucial to initiate breastfeeding effectively.

Providing practical help, such as demonstrating proper latching techniques and normalising challenges like engorgement, can empower mothers. "Involving family members in the education process can create a supportive home environment," she suggested, emphasising the importance of community in breastfeeding success.

In a recent interview, Sr. Takitsi Fakudze, Nursing Supervisor at Mbabane Clinic, shared her insights on breastfeeding, addressing common misconceptions, trends in breastfeeding rates, and offering practical tips for

new mothers. One of the most pervasive misconceptions that Sr. Takitsi encounters is the belief that the size and shape of a woman's breasts determine her ability to breastfeed. She firmly stated, "Every breast of a mom can feed a baby."This myth can discourage mothers who may feel inadequate

Additionally, Sr. Takitsi emphasised that breastfeeding is not always an easy task. "It is not every woman's reality. Some find difficulty in supply and the attachment of the baby to the breast," she explained. She highlights that breastfeeding is a skill requiring practice and patience for both mother

Another common myth is the notion that breastfeeding creates an over-ly dependent attachment between mother and child. "Breastfeeding ba-bies are not overly attached to mothers; it's a natural bonding process," she clarified. Furthermore, she addressed the stigma surrounding breastfeeding in public, stating, "Breastfeeding is a natural and legal way of feeding your baby and should be normalised in public spaces."

Reflecting on the changes in breastfeeding rates over the years, Sr. Takitsi notes a stark contrast between Eswatini and high-income countries, "We have seen a decrease in breastfeeding rates among the working class, while there has been an increase in low-income and poverty-stricken areas," she observed. She attributed this trend to the high costs associated with formula feeding, which many families cannot afford. "Availability and affordability significantly influence breastfeeding decisions," she added.

Looking ahead, Sr. Takitsi foresees several trends that may shape the future of breastfeeding practices. "We are seeing an increased use of breast pumps, especially those that are enabled for telehealth," she noted, indicating a shift towards more accessible breastfeeding support through tech-

nology.

She highlighted the role of online consultations for breastfeeding, which are already being conducted via social media and WhatsApp groups. "With increased education on the importance of this liquid gold (breast milk), companies are starting to implement supportive policies for breastfeeding mothers," she stated. Initiatives such as designated "breastfeeding hours" and nurseries for staff are becoming more common, which can alleviate anxiety for mothers and improve workplace morale. "This will ultimately enhance performance at work and boost revenue," she opined.

For new mothers navi-gating the challenges of breastfeeding, Sr. Takitsi offers several practical

a bond. Nipple Care: It's essential to maintain good hygiene. Clean your nipples regularly and monitor for any cracks that may develop.

Senators raise concerns over water billing

CONCERNS over erratic water billing and the rising tide of copper theft dominated discussions during the Ministry of Natural Resources and Energy's appearance before the Senate Portfolio Committee this week.

Senator Stukie Motsa raised the issue of inconsistencies in water charges by the Eswatini Water Services Corporation (EWSC), calling for a shift to a prepaid system to eliminate confusion among consumers.

"There are inconsistencies in the charging of water by EWSC. One month a customer is charged over E1,000 and the next month only E250 — this is confusing and boggling," Senator Motsa told Minister Prince Lonkhokhela. "I think it's time for the members of the public to buy the amount of water they want to use, meaning prepaid."

Smart water meters

The senator also questioned when the utility would consider rolling out smart water meters across the country to allow real-time monitoring of water usage, improve billing accuracy, and empower households to better manage their consumption.

Meanwhile, Senator Tony Sibandze turned the spotlight on copper theft, expressing concern over how some licensed scrapyards may be fuelling the crime by purchasing stolen materials.

"I am asking the ministry to define what is meant by 'scrap' and a 'scrapyard,' because some scrapyards are buying fresh stolen copper instead of actual scrap," he said. "It's time the Ministry sits down with the Min-

istry of Commerce, Industry and Trade and scrapyard operators to understand why they continue to accept fresh materials. This only worsens copper theft in the country."

Both senators called on the Ministry to act swiftly and decisively, citing public safe-

ty, fair billing, and national economic security as key areas of concern. Minister Prince Lonkhokhela acknowledged the issues and pledged that the ministry would investigate further, while also engaging relevant stakeholders. It should be noted that the session forms part of ongoing parliamentary oversight to strengthen accountability and improve service delivery in the natural resources and energy sectors.

I chose to drink alcohol so to drown my sorrows

"I was facing family challenges which led me to drink alcohol in a bid to drown my sorrows."

These sentiments were shared by Sikhumbuzo Makhubula (42) of Maphungwane area yesterday when mitigating for a lenient sentence before Principal Magistrate David Khumalo at the Manzini Magistrates Court.

This came after Makhubula was nabbed for drink driving, an offence he committed on August 3, 2025 at Mafutseni area, along MR3 public road, while driving a Honda sedan registered WSD 628 CH.

His breath specimen was found with a reading of 1.84 milligrams per litre (mg/l), which was above the legal limit of 0.37 mg/l.

He pleaded guilty to the offence

and was found guilty as per his own plea.

According to Makhubela, the reason why he committed the offence was because he was stressed.

This, he said, came after he learnt that both his mother and wife were sick at the same time.

"Your worship, I decided to drink the alcohol in order to numb the pain and to drown my sorrows," he said

He was sentenced to two years in prison with an option of a fine of E5

Meanwhile, Magistrate Khumalo informed another drink-driver that he was lucky that the maximum fine for drink drivers was E5 000, otherwise if it was not for that, he would have given him a much stiffer sen-

tence following his irresponsible act.

This came after Philani Nhlengethwa (28), from Hhelehhele area ferried passengers in a kombi, while he was under the influence of alcohol.

According to Khumalo, it was a gross irresponsibility for Nhlengethwa to drive the public transport and ferry passengers while he was intoxicated.

"You can't ferry passengers in public transport and make them to pay a bus fare while you are intoxicated. This is totally unacceptable. You are fortunate that the maximum fine for drink-driving is E5 000, otherwise you deserve more than that," he said

Khumalo subsequently sentenced Nhlengethwa to two years in prison with an option of a fine of E5 000.



BSA student arrested

A PART-TIME student at BSA Training Centre was arrested after he caused an accident while driving a motor vehicle whilst under the influence of alcohol.

Ndumiso Khumalo (24) of Mpolonjeni area appeared before Principal Magistrate David Khumalo at the Manzini Magistrates Court yesterday.

He was slapped with two charges; namely drink-driving and causing an accident after he knocked a motor vehicle from behind.

He committed both the offences on August 1, 2025 at Mabhodini area while driving a Toyota Hilux LDV registered USD 515 AH.

He pleaded guilty to both the offences and he was found guilty as per his own plea.

According to Ndumiso, he was still young and therefore, he forms part of this county's future generation

"Your worship when a young child has transgressed, you chastise him, not with the intention of killing him, but to show him the right direction he should take in order to succeed in life, hence I plead for a lenient sentence," he said

Ndumiso mentioned that the car which he was driving on the day he committed the offence belonged to his father.

When the presiding magistrate asked him if his father was aware that he drinks alcohol, he responded to the affirmative.

"My father was not aware that I drink alcohol but now he knows since I have been arrested for drink-driving," he said.

Ndumiso further mentioned that he was a part-time student at BSA Training Centre at Motshane area and therefore, he was pleading for a lenient sentence, since his continued incarceration may affect his studies.

In response, Magistrate Khumalo mentioned that in as much as Ndumiso was young, but he still has the obligation of doing things responsible.

"Since you say you are still a student, you still have a responsibility of shaping your future but if you are imbibing alcohol it means your future is in shambles. You must change your mind if you want to reach your destiny," he said.

He pointed out that it was unfortunate that Ndumiso was found with the highest alcohol content in his breath specimen of 2.00 milligram's per litre (mg/l).

He therefore, subsequently sentenced him to two years in prison with an option of a fine of E5 000 on the count of drink-driving and six months imprisonment with an option of a fine of E800 on the charge of causing a road accident.



Over 10 suspects fined for drink-driving offences

OVER 10 individuals charged with drink-driving offences appeared before Principal Magistrate Fikile Nhlabatsi at the Mbabane Magistrates Court.

The court session, held on Monday, involved cases of varying severity, with sentences reflecting the different levels of alcohol content found in the offenders.

Most of the suspects were fined

A DOMESTIC dispute over maize meal sparked a tense courtroom exchange at

E₅ 000 or sentenced to two years in prison, with an option to pay the fine. Those found with lower levels of alcohol in their systems were fined E₃ 000 or two years imprisonment.

One individual received a particularly steep fine of E7 000 after resisting arrest and leading police officers on a brief car chase.

According to court documents, the suspect ignored police signals to stop and instead attempted to evade capture. The court noted that such behaviour put other road users at risk and warranted a harsher sentence.

Magistrate Nhlabatsi stressed the dangers of drink-driving, reminding the accused that the law does not tolerate reckless behaviour on public roads.

She urged drivers to act responsibly, noting that these cases were becoming more common and endangering innocent lives.

The Eswatini Police Service has reiterated its commitment to clamp down on road violations and has increased stop-and-search operations, particularly during weekends and holidays.

Minor arrested for DD, misses exam

A 17-year-old Form V pupil is facing legal consequences after he was arrested for drink-driving in Mbabane.

The minor appeared before Magistrate Nhlabatsi and is being held accountable for driving under the influence with a recorded blood alcohol content (BAC) of 1.35 mg/l.

The teenager was apprehended on Friday night during a police roadblock. According to court evidence, he failed a breathalyser test, leading to his arrest and detention.

He missed a scheduled examination because of his detention. The school authorities were notified, and the court was informed that the pupil could not write one of his final term papers. His legal guardian, who

is also his mother, attended the court proceedings.

Magistrate Nhlabatsi remanded the teenager into his mother's custody and set the trial date for August 19, 2025. She noted the seriousness of the offence, especially given the driver's age and the fact that he did not hold a valid driver's licence.

Police officials stated that this is one of the youngest reported drink-driving cases in the country. They expressed concern over increasing reports of teenagers engaging in risky behaviour and warned that road safety enforcement would continue.

The court has ordered that the teenager remain under strict supervision until his case is finalised.

This followed continued back-and-forth between the pair, with both presenting conflicting claims regarding their domestic arrangement and financial disputes.

The man told the court that he had given the woman E350,000 over a period to maintain the household. He claimed that despite his financial support, issues had persisted at home, and he believed he was being unfairly excluded from decision-making, particularly regarding shared resources such as the maize meal in question.

In response, the woman denied receiving that amount and stated that the man had not been residing at the family home for some time. She said he had instead relocated to a rondavel situated on the same property but lived separately from her and the children.

She argued that he had removed himself from the home and family responsibilities and was therefore not able to make unilateral decisions regarding household property.

The magistrate listened to both parties before moving the matter to chambers for further deliberation. The case remains ongoing, with the protection order still in effect. Under the terms of the order, neither party is permitted to dispose of shared assets without mutual agreement.

Magistrate Nhlabatsi advised both parties to respect the court's ruling and reminded them that failure to comply with a protection order is a criminal offence.



SACU at risk, says Govt

THE Minister of Finance, Neal Rijkenberg, has warned that Eswatini must begin preparing for a possible future without Southern African Customs Union (SACU) receipts a major source of national revenue as the country faces growing fiscal uncertainty.

Speaking during this week's Finance in Focus segment, Rijkenberg said while there is no immediate threat to the SACU agreement, government is acutely aware that the stream of revenue could end if any member country initiates withdrawal.

"SACU could come to a grinding halt," he said, noting that the agreement allows for a 12-month notice period before dissolution.

"It's not dangerous at the moment and nothing to be scared about, but it could end, and that's something we must prepare for." he said.

Billenberg, said, government is currently

Rijkenberg said government is currently reliant on SACU transfers for a substantial share of its budget and that a sudden stop would be fiscally destabilising.

"It would be terrible for us as a country to acclimatise to a non-SACU revenue environment. We would need time and possibly more debt to navigate that transition," he said.

The Minister explained that this fiscal vulnerability underscores the importance of maintaining a conservative debt-to-GDP ratio.

"If SACU ended, we would need that headroom. We're currently just above 40 percent, and that gives us room to grow even up to 60 percent if we were forced into a crisis response," he said.

He stressed that while SACU receipts remain a lifeline for now, Eswatini must begin developing a 'Plan B' to gradually reduce its dependency.

This includes expanding domestic revenue streams, attracting private investment, and diversifying the economy to absorb potential future shocks.

"Right now, SACU is a large portion of our funding, but we cannot afford to be complacent. It is wise of us to plan for a situation where SACU could no longer be relied upon." said the Minister.

Rijkenberg maintained that Eswatini's economic strategy should prioritise resilience, not just growth.

He called on policymakers to take the SACU risk seriously and begin preparing for a future where the fiscal framework is no longer propped up by regional customs revenues.

Debt-to-GDP could hit 60% if SACU ends

MINISTER of Finance Neal Rijkenberg says Eswatini's current debt-to-GDP ratio just above 40 percent remains within a safe and manageable range but warned that the number could escalate significantly if SACU receipts are withdrawn.

Rijkenberg addressed Members of Parliament who recently questioned why government continues to maintain the 40 percent threshold, despite most African countries having ratios exceeding 60 percent.

He explained that Eswatini's approach is a deliberate and prudent strategy to preserve fiscal flexibility.

"There was a good motion in Parliament asking why we keep our debt-to-GDP at around 40 percent when other countries are at 60 percent or higher. The answer is that once we raise our debt, interest payments start to crowd out essential spending especially in education and health," he said.

He further noted that Eswatini has already taken on E36 billion in total government debt but has only drawn down on a portion of that.

"There's still about E17 billion in loans that we've signed for, but haven't yet accessed. So those amounts are sitting there and will be drawn down in future budgets," he said.

Rijkenberg stressed that while the current debt load appears moderate, the actual commitment is higher due to undrawn loans already accounted for. He added that keeping the ratio low has multiple benefits for both government and the private sector.

"One of the main advantages is that we get very good lending rates. Because of our prudent approach, we're seen as a low-risk borrower, which brings down the cost of our external debt," he said.

"If we go beyond 45 or 50 percent, we lose that credibility. Lenders will begin to charge more, and some may become hesitant to lend at all." he added.

The Minister also touched on the cost difference between domestic and external debt.

"Domestic debt is a bit more expensive, but our external debt is still very well priced due to our disciplined fiscal approach," he explained.

He noted that the low debt ratio not only affects government borrowing costs but also improves investor confidence.

"When investors especially foreign ones look at our macroeconomic indicators, they feel confident that their money is safe here," he said.

He further said it's part of why people are willing to invest in Eswatini. Rijkenberg said that if SACU revenues were to be cut off, government could temporarily allow the debt ratio to rise as high as 60 percent to cushion the impact but only as a short-term solution.

"We could manage it if we had to. It wouldn't be fun, but it would be manageable. That's why we need to preserve the space to grow our debt if we face such a crisis," he said.

He also shared broader advice on debt management, drawing a parallel between national policy and household budgeting.

"Debt is expensive," he said, adding that Emaswati should aim to keep personal debt repayments below 30 percent of income.

He encouraged citizens to begin paying off smaller debts first such as retail accounts to reduce the total number of obligations and gradually ease financial strain.

In closing, Rijkenberg reiterated the need for responsible debt management at both government and household levels, especially as global and regional risks continue to evolve.

He said the finance ministry remains committed to staying within the 45 percent ceiling, as a way to future-proof the country's economy.

"We're choosing the conservative path, not because we fear debt, but because we want to be ready for whatever comes next," he said.

Textile industry players in the country which produces jeans and other garments for popular U.S. brands such as Levi's and Walmart - said the uncertainty around tariffs over the past few months had already devastated the sector, with orders cancelled and jobs cut.

"We were on the verge of building (our) American market," Teboho Kobeli, founder and managing director of Afri-Expo Textiles, told Reuters at his factory in Maseru.

He said the U.S. market made up 10 per cent of his company's production - about \$1 million a year - and that he had to lay off

200 workers, or 40 per cent of his workforce, after the announcement in April as orders

"That is a lot lost," he said.

Lesotho, which Trump had ridiculed in March as a country "nobody has ever heard of", is a poor and landlocked country with a gross domestic product of just over \$2

Trade Minister Mokhethi Shelile said that Lesotho would struggle to compete against other African textile manufacturers such as Kenya and Eswatini, which got a lower U.S. tariff rate of 10 per cent.

"We have close to 12,000 jobs that are directly on the firing line because of this

The sector, which is the country's leading export industry and biggest private employer, was heavily dependent on the Africa Growth and Opportunities Act, a U.S. trade initiative granting duty-free access to qualifying African nations.

It employs around 40,000 people and accounts for roughly 90 per cent of manufacturing exports, according to Oxford Economics. One of the people affected by the uncertainty is Matsoso Lepau, a 48-yearold who lost his job at protective outerwear maker Leo Garments in April.

"I have a big problem because the money that I was making is not there anymore," he said, adding he used to earn the equivalent of

"Now that Mr Trump has lowered the tariffs, I am still hoping that we will get our

Kobeli, the head of Afri-Expo Textiles, said he was confident he could get his business back on track now that the reduced 15 per cent rate has been set, noting the uncertainty over U.S. trade policy had weighed on investors' and retailers' decisions globally.

"It was a global problem, even the buyers in America were stagnant as they did not know where to go... Now with the 15 per cent we are starting to talk, it's not like we were affected alone," he said. (Reuters)

SA outlines support measures in response to US tariffs

JOHANNESBURG — South Africa on Monday outlined support measures for local companies that will be hit by a 30 per cent U.S. tariff this week, including exemptions from some competition rules and financial support facilities.

It also dismissed speculation that its failure to negotiate a lower tariff was because of its local affirmative action policies, which U.S. President Donald Trump has criticised.

Africa's biggest economy has tried for months to negotiate a deal with Washington, offering to buy U.S. liquefied natural gas and invest \$3.3 billion in U.S. industries in a "framework deal" proposed to Trump's


But the effort was unsuccessful, even after Pretoria made a last-minute attempt to

South African officials say the U.S. tariff could cause tens of thousands of job losses, especially in the agriculture and carmaking industries, as Trump pushes to reshape global trade in favour of the United States.

Addressing a press conference, South Africa's trade and foreign ministers said a "block exemption" from some aspects of the Competition Act was being developed that would allow competitors to collaborate and coordinate.

They said the exemption would be published by the end of this week.

The government is also working on a support programme, which will include a working capital facility and plant and

equipment facility, and ways to cushion the impact of job losses via the Unemployment Insurance Fund.

The ministers said South Africa posed no "trade threat to the U.S. economy nor its national security," emphasising that its exports supported the U.S. industrial base and often do not compete with U.S. products.

Foreign affairs minister Ronald Lamola did not want to focus on speculation the country faces such a high tariff because of points of tension with the U.S. like its policies to address racial inequality or genocide case against Israel at the World Court, which Trump opposes.

He said South Africa would continue to engage with U.S. counterparts on the basis of the framework deal it had submitted.

Trade officials said an export support desk would try to help companies enter new markets by linking them up with embassies and potential buyers. A more detailed set of support measures will be discussed at a cabinet meeting on Wednesday. (Reuters)

South African goods will be subjected to a 30 per cent duty when imported in the U.S., the highest rate among Sub-Saharan African countries. Pretoria has been trying to get Washington to reduce the rate, saying it could harm tens of thousands of jobs.

Trade minister Parks Tau and foreign minister Ronald Lamola are set to update the nation on the issue later on Monday.

"Our foremost priority is protecting our export industries. We will continue to engage the U.S. in an attempt to preserve market access for our products," President Cyril Ramaphosa said in a newsletter on Monday.

South Africa should accelerate the diversification of export markets by deepening intra-African trade, he said.

"We will in due course be announcing the modalities of a support package for companies, producers and workers that have been rendered vulnerable by the U.S. tariffs," Ramaphosa said.

The dollar index, which tracks the currency against a basket of major peers, was slightly stronger in Monday trade. It fell more than 1 per cent on Friday following weak U.S. jobs data that sent traders scrambling to price in aggressive Federal Reserve interest rate cuts.

Africa's benchmark government bond was marginally stronger in early deals, as the yield rose one basis point to 9.615 per cent. (Reuters)

Tesla approves share award worth \$29bln to Elon Musk

TESLA has granted CEO Elon Musk shares worth about \$29 billion in a new pay deal aimed at keeping the billionaire entrepreneur at the helm during a crucial pivot from its struggling core auto business to robotaxis and humanoid robots.

The company described the "interim award" of the 96 million new shares as a first step, "good faith" payment to honor Musk's more than \$50 billion pay package from 2018 that was struck down by a Delaware court last year. Musk can claim the new award if he remains in a top executive role for another two years and a court does not reinstate the 2018 package currently on appeal.

He has to hold the shares for five years and can buy them for \$23.34 per share, the same as the exercise price of the 2018 award. Tesla will also put to vote a longer-term CEO compensation plan at its annual investor meeting on November 6.

The move is meant to keep Musk, the public face of Tesla and architect of its robotaxi strategy, focused on the electric-vehicle maker as it navigates a shift to cybercabs and robotics from its mainstay auto business.

It also seems to quell any speculation that the board's patience with Musk could be wearing thin because of the recent tumultuous months, including the CEO's foray into politics.

The move to give Musk greater control of the company suggests that directors still see him as best-suited to tackle Tesla's growing list of challenges in the years ahead.

Sales have been falling at the company due to its aging vehicle line-up, tough competition and Musk's right-wing political stances that have tarnished its brand.

S&P Global Mobility data shared exclusively with Reuters showed on Monday that Tesla's brand loyalty had plunged since Musk endorsed U.S. President Donald Trump last summer.

Musk's involvement in politics and his wider business empire, including AI startup xAI, have also sparked concerns about his devotion to Tesla, the main source of his wealth. Musk has threatened to leave unless he gets more control over Tesla.

The new stock award will take his Tesla

stake, already the largest, to more than 15 per cent from the 12.7 per cent currently, according to Reuters calculations based on data compiled by LSEG.

Before Monday's grant, Musk had no active compensation plan and Tesla said he had not received meaningful pay since 2017. With the legal fight over his 2018 package expected to continue, the board said it moved to retain Musk's "extraordinary talent."

Talent magnet

"While we recognize Elon's business ventures, interests and other potential demands on his time and attention are extensive and wide-ranging... we are confident this award will incentivize Elon to remain at Tesla," said a special committee Tesla formed this year to consider Musk's compensation. It consists of chair Robyn Denholm and independent director Kathleen Wilson-Thompson.

The company said it would not record compensation expense for the award as it does not currently expect the performance condition to be "probable of being met." It will re-evaluate and recognize the expense if it determines the award is likely to be met, including after the two-year vesting period.

The new shares will also be forfeited or offset if the Delaware courts fully reinstate the 2018 stock award, ensuring there is no "double dip," the special committee said.

Investors and analysts welcomed the news, with Tesla shares rising nearly 2 per cent in early trading. The stock has lost a quarter of its value this year, as of last close.

"Under normal circumstances, a compensation package in the billions would

raise some eyebrows. (But) clearly investors have benefited from Musk's stewardship of Tesla," said Camelthorn Investments adviser Shawn Campbell, who owns Tesla shares. "This stock grant will bind Musk to Tesla for the next two years."

Battle for pay

The Delaware ruling on Musk's 2018 pay package, the largest in Corporate America, had cited flaws in the board's approval process and unfairness to investors. Musk kicked off an appeal against the order in March, claiming a lower court judge made multiple legal errors in rescinding the record compensation. He has argued that the package resulted in spectacular growth for Tesla and yet was determined by the lower Court of Chancery to be unfair to shareholders, who voted twice to approve the plan.

Tesla shares have risen nearly 2,000 per cent over the past decade, far outperforming the around 200 per cent rise in the benchmark S&P 500 index in the same period.

"This is simply a repackaged version of what was done years ago and was ruled improper by a judge. It renders the Delaware court decision effectively meaningless," said Charles Elson, founding director of the Weinberg Center for Corporate Governance at the University of Delaware.

"You don't have to incentivize him to stay. If he leaves, he throws away 13 per cent of the company, which is still a huge part of his net worth, said Elson, who had filed amicus briefs supporting the court's decision to void Musk's 2018 award. (Reuters)

Spotify to raise prices

SPOTIFY said on Monday it would increase monthly price of its premium individual subscription in select markets from September, as the Swedish streaming giant looks to improve margins.

The subscription price will rise to 11.99 euros (\$13.86) per month from 10.99 euros in markets including South Asia, the Middle East, Africa, Europe, Latin America and the Asia-Pacific region.

Spotify said subscribers will receive an email explaining the price rise over the next month.

Price increases in the past, combined with cost-cutting efforts in recent years, have helped it to achieve its first annual profit for 2024.

The company saw an increase in monthly active users and premium subscribers during the second quarter, while higher taxes related to employee salaries led it to post a loss during the period and weighed on its third-quarter profit forecast.

Spotify has been expanding its library of video content to attract subscribers, including through its partner program, which is designed to help podcast creators by offering them monetization options.

A growing number of creators are joining the Spotify Partner Program, resulting in a significant increase in video content on the platform, CEO Daniel Ek had earlier told Reuters.

The streaming company is also benefiting from Apple's approval of its U.S. app update to show subscription prices and external payment links, after a judge barred the iPhone maker from charging commission on off-app purchases.

Ek said this change has led to "a very positive uptick" in the U.S. If similar rules are adopted in Europe and the UK, it would benefit both Spotify and other app developers. (Reuters)

NEW YORK — Google has signed agreements with two U.S. electric utilities to reduce its AI data center power consumption during times of surging demand on the grid, the company said on Monday, as energy-intensive AI use outpaces power supplies.

Utilities in the country have been inundated with requests for electricity for Big Tech's AI data centers, with demand eclipsing total available power supplies in some areas.

That power crunch has led to concerns about spiking bills for everyday homes and business and blackouts.

It has also complicated the technology industry's expansion of AI, which requires

massive amounts of electricity - fast.

Google's agreements with Indiana Michigan Power and Tennessee Power Authority would involve scaling back power use at the technology giant's data centers when called upon by the electric utilities to free up space on the grid.

They are the first formal agreements by Google in demand-response programs with utilities to temporarily curtail its machine learning workloads, a subset of artificial intelligence.

"It allows large electricity loads like data centers to be interconnected more quickly, helps reduce the need to build

new transmission and power plants, and helps grid operators more effectively and efficiently manage power grids," Google said in a blog post. Demand-response programs have typically been used by other energy-intensive industries like heavy manufacturing or cryptocurrency mining. In exchange, the businesses generally receive payments or reduced power bills.

The programs involving AI activity in data centers is generally new, and details of the commercial arrangements between Google and the utilities were not clear.

While demand-response agreements apply only to a small portion of demand on the grid, the arrangements might become more common as U.S. electricity supply tightens. (**Reuters**)

Funding for refugees in Uganda will run out next month, UN warns

GENEVA — Emergency funding to help hundreds of thousands of refugees in Uganda will run out next month unless more support comes in, a United Nations agency said on Monday.

A funding crisis is threatening programmes for people fleeing there from strife-torn countries in the region including Sudan, and Uganda's neighbours South Sudan and Democratic Republic of Congo, the UN refugee agency UNHCR said.

"Emergency funding runs out in September," Dominique Hyde, the agency's Director for External Relations, said in a statement

"More children will die of malnutrition, more girls will fall victim to sexual violence, and families will be left without shelter or protection unless the world steps up."

UNHCR and other UN agencies face one of the worst funding crises in decades, compounded by U.S. and other donor states' decisions to slash foreign aid funding.

Uganda is home to 1.93 million refugees, more than a million of them under 18, according to UNHCR figures.

An average 600 people are still coming in every day and the overall figure, already the largest in Africa, is due to rise to 2 million by the end of the year, the agency says.

It said it would only be able to meet a third of the costs associated with supporting Sudanese refugees in Uganda - and would have to cut its monthly funding to \$5 per refugee from \$16 unless more money is found

Malnutrition rates are rising as food, water, and medicine supplies shrink, while the risk of suicide is increasing among young refugees due to a reduction in mental health staff, the agency added. (**Reuters**)

RABAT — U.S. President Donald Trump has reaffirmed support for Morocco's sovereignty over Western Sahara, saying a Moroccan autonomy plan for the territory was the sole solution to the disputed region, according to state news agency MAP.

The long-frozen conflict pits Morocco, which considers the territory as its own, against the Algeria-backed Polisario Front, which seeks an independent state there.

Trump at the end of his first term in office recognised the Moroccan claims to Western Sahara, which has phosphate reserves and rich fishing grounds, as part of a deal under which Morocco agreed to normalise its relations with Israel.

His secretary of state, Marco Rubio, made clear in April that support for Morocco on the issue remained U.S. policy, but these were Trump's first quoted remarks on the dispute during his second term.

"I also reiterate that the United States recognises Moroccan sovereignty over Western Sahara and supports Morocco's serious, credible and realistic autonomy proposal as the only basis for a just and lasting solution to the dispute," MAP quoted

Trump reaffirms support for Morocco's sovereignty over Western Sahara

Trump as saying in a message to Morocco's King Mohammed VI.

"Together we are advancing shared priorities for peace and security in the region, including by building on the Abraham Accords, combating terrorism and expanding commercial cooperation," Trump said.

As part of the Abraham Accords signed during Trump's first term, four Muslimmajority countries agreed to normalise diplomatic relations with Israel after U.S. mediation.

In June this year, Britain became the third permanent member of the U.N. Security Council to back an autonomy plan under Moroccan sovereignty for the territory after the U.S. and France.

Algeria, which has recognised the self-declared Sahrawi Republic, has refused to take part in roundtables convened by the U.N. envoy to Western Sahara and insists on holding a referendum with independence as an option. (**Reuters**)

'Nigeria's July oil output tops 1.8 million bpd'

LAGOS — Nigeria's oil production surpassed 1.8 million barrels per day (bpd) last month, with current average output at 1.78 million bpd, the head of the country's upstream regulator said on Monday.

The West African country, Africa's largest oil producer, relies on crude oil for nearly two-thirds of government revenue and over 80% of foreign currency earnings, making production gains critical for stabilising its economy

But widespread oil theft, unrest and years of underinvestment curtailed output and strained public finances before Nigeria stepped up a crackdown in the oil-rich Niger Delta region.

Gbenga Komolafe, chief executive of the Nigerian Upstream Petroleum Regulatory Commission, told delegates at an energy conference that the output increase, largely possible due to the step-up in security operations, is part of a push to boost oil production by 1 million bpd to 3 million bpd.

Oil output last reached 1.8 million bpd in November. Komolafe said the commission would continue working with stakeholders to sustain production gains and improve industry transparency. (**Reuters**)

Israel to decide next steps in Gaza after ceasefire talks collapse

JERUSALEM — Benjamin Netanyahu will convene his security cabinet this week to decide on Israel's next steps in Gaza following the collapse of indirect ceasefire talks with Hamas, with one senior Israeli source suggesting more force could be an option.

Last Saturday, during a visit to the country, U.S. Middle East envoy Steve Witkoff had said he was working with the Israeli government on a plan that would effectively end the war in Gaza.

But Israeli officials have also floated ideas including expanding the military offensive in Gaza and annexing parts of the shattered enclave

The failed ceasefire talks in Doha had aimed to clinch agreements on a U.S.-backed proposal for a 60-day truce, during which aid would be flown into Gaza and half of the hostages Hamas is holding would be freed in exchange for Palestinian prisoners jailed in Israel.

After Netanyahu met Witkoff last Thursday, a senior Israeli official said that "an understanding was emerging between Washington and Israel," of a need to shift from a truce to a comprehensive deal that would "release all the hostages, disarm Hamas, and demilitarize the Gaza Strip," - Israel's key conditions for ending the war.

A source familiar with the matter told Reuters on Sunday that the envoy's visit was seen in Israel as "very significant."

But later on Sunday, the Israeli official signalled that pursuit of a deal would be pointless, threatening more force:

"An understanding is emerging that Hamas is not interested in a deal and therefore the prime minister is pushing to release the hostages while pressing for military defeat."

"Strategic clarity"

What a "military defeat" might mean, however, is up for debate within the Israeli leadership. Some Israeli officials have suggested that Israel might declare it was annexing parts of Gaza as a means to pressure the militant group.

Others, like Finance Minister Bezalel Smotrich and National Security Minister

Itamar Ben-Gvir want to see Israel impose military rule in Gaza before annexing it and re-establishing the Jewish settlements Israel evicted 20 years ago.

The Israeli military, which has pushed back at such ideas throughout the war, was expected on Tuesday to present alternatives that include extending into areas of Gaza where it has not yet operated, according to two defence officials.

While some in the political leadership are pushing for expanding the offensive, the military is concerned that doing so will endanger the 20 hostages who are still alive, the officials said.

Israeli Army Radio reported on Monday that military chief Eyal Zamir has become

increasingly frustrated with what he describes as a lack of strategic clarity by the political leadership, concerned about being dragged into a war of attrition with Hamas militants.

A spokesperson for the Israel Defense Forces (IDF) declined to comment on the report but said that the military has plans in store.

"We have different ways to fight the terror organization, and that's what the army does," Lieutenant Colonel Nadav Shoshani said.

On Tuesday, Qatar and Egypt endorsed a declaration by France and Saudi Arabia outlining steps toward a two-state solution to the Israeli-Palestinian conflict, which included a call on Hamas to hand over its arms to the Western-backed Palestinian Authority.

Hamas has repeatedly said it won't lay down arms. But it has told mediators it was willing to quit governance in Gaza for a non-partisan ruling body, according to three Hamas officials.

It insists that the post-war Gaza arrangement must be agreed upon among the Palestinians themselves and not dictated by foreign powers.

Israel's Foreign Minister Gideon Saar suggested on Monday that the gaps were still too wide to bridge.

"We would like to have all our hostages back. We would like to see the end of this war. We always prefer to get there by diplomatic means, if possible. But of course, the big question is, what will be the conditions for the end of the war?" he told journalists in Jerusalem. (Reuters)

South Korea starts removing anti-North Korean loudspeakers on border

SEOUL – South Korean authorities began removing on Monday loudspeakers blaring anti-North Korea broadcasts along the country's border, Seoul's defence ministry said, as the new government of President Lee Jae Myung seeks to ease tensions with Pyongyang.

Shortly after he took office in June, Lee's administration switched off propaganda broadcasts criticising the North Korean regime as it looks to revive stalled dialogue with its neighbour.

But North Korea recently rebuffed the overtures and said it had no interest in talking to South Korea.

South Korea's dismantling of the loudspeakers from Monday is just a "practical measure to help ease tensions between the South and the North," the ministry said in a statement on Monday.

Soldiers could be seen unplugging loudspeakers, mounted together like a wall, and taking them down, photographs provided by the defence ministry show.

The countries remain technically at war after the 1950-53 Korean War ended in a truce and relations have deteriorated in the

last few years.

Propaganda broadcast through loudspeakers across the border has been used by both sides as relations between South and North Korea have ebbed and flowed over the years.

In 2018, the then President Moon Jaein dismantled the loudspeakers as his administration agreed to stop every hostile act that could be a source for military tensions.

But last year former conservative leader

balloons to the South filled with trash amid heightened tensions.

Since Seoul suspended its own loudspeaker broadcasts in June, North Korea appears to have stopped its broadcasts, which had disturbed South Korean border residents for months, officials in the South say.

Kim Yo Jong, the powerful sister of North Korean leader Kim Jong Un, recently said, however, that South Korea's decision to stop the broadcasts was "not the work worthy of appreciation". (**Reuters**)

U.S. TARIFF TALKS

EU to suspend countermeasures for 6 months

BRUSSELS — The European Union will suspend its two packages of countermeasures to U.S. tariffs for six months following a deal with U.S. President Donald Trump, a Commission spokesperson said on Monday.

The EU-U.S. agreement leaves many questions open, including tariff rates on spirits, and Trump's executive order last week setting tariffs on most EU goods at 15% did not include carve-outs such as for cars and car parts.

EU officials have said they expect more executive orders to follow soon.

"The EU continues to work with the U.S. to finalise a Joint Statement, as agreed on 27 July," the spokesperson said in a statement.

"With these objectives in mind, the Commission will take the necessary steps to suspend by 6 months the EU's countermeasures against the US, which were due to enter into force on 7 August."

The retaliatory tariffs are in two parts: one in response to U.S. steel and aluminium duties, and the other to Trump's baseline and car tariffs. (**Reuters**)

"We are currently receiving medical attention and support as we begin the process of healing physically, emotionally, and psychologically. We ask for privacy and understand-

ing as we focus on recovery and rebuilding our strength," reads the pair's statement.

The statement also acknowledged the swift action of law enforcement authorities, with the artists expressing heartfelt appreciation for their diligent efforts.

They noted that a picture of one of the perpetrators will be circulated as the investigation continues.

What Is a Personality Disorder?

THESE mental health conditions affect your everyday life and relationships. They're about how you think, feel, and act.

You might have a tough time with change, or you may be impulsive or suspicious. You might even do or say things other people find odd or upsetting, making it harder to connect. These long-term patterns can harm your personal and work life as well as your mental health. And you don't always know if you have one.

Paranoid Personality Disorder

With this condition, you feel that people are always trying to take advantage of you, even when there's no logical reason for it. You may get angry when someone questions you, or not want to tell people about yourself because you think they'll somehow use it against you. All this can make it hard to trust others and build healthy relationships.

Schizoid Personality Disorder

This condition can make it hard to express your emotions. You might show little or no reaction if someone yells at you or sings your praises — this can make you come across as "cold." You may find it hard to feel pleasure and have little interest in sexual relationships. Others may think you lack goals or ambition.

Schizotypal Disorder

You may have strange beliefs -- that you can read people's minds, for example -- and your clothes may be odd or messy. You might not react to things that make most people emotional and often doubt or suspect others' intentions. People may not know how to respond to your rambling and unclear conversation. You might be really anxious around people outside your immediate family and prefer to be alone.

Antisocial Personality Disorder

You may try to make others angry, trick them, or treat them badly to get what you want. You may not care what's right or wrong. You may lie and do things that are reckless, violent, and even illegal. You usually don't feel bad when you hurt others, and drug and alcohol abuse may be problems, too. People with this condition often have a hard time keeping a job or taking care of their families.

Borderline Personality Disorder

You may have strong feelings of anger, sadness, or anxiety that suddenly change. You may frantically try to connect with someone if you think they want to separate from you. You swing between extremes: A friend may be "perfect" one day and awful the next. This makes for intense, rocky relationships. You can act impulsively -- drug abuse, reckless driving, or risky sex, for example -- if you don't have a strong sense of who you are.

Histrionic Personality Disorder

Your desire to be noticed is stronger than every other feeling. You probably have good social skills, but you use them to make yourself the center of attention. You don't

seem interested in other people. You may be too concerned about how you look, and dress sexy to attract people even when it's not appropriate. You may act like you're on stage, with over-the-top emotions and speech that changes very quickly.

Narcissistic Personality Disorder

You want to make yourself look good, even if you must hurt or ignore others to do it. You may brag a lot or pretend to be

someone you're not, or stop people who want to have their say, especially if you think you're more important. You may get angry when you don't get treated the way you want. Inside, you're insecure, oversensitive, and may lash out if criticized. You get moody and depressed if someone makes you feel less than perfect.

Avoidant Personality Disorder

No one wants to look foolish, but with

this condition, you'd rather be alone than take even the smallest risk that someone will reject you or make you look bad in front of others. You may make problems bigger than they need to be, find it hard to try new things, and see yourself as unattractive. This can make you afraid to connect with others and very uncomfortable in large groups.

Obsessive-Compulsive Personality Disorder

A desire to control people, tasks, or situations is at the core of this disorder. Your attention to rules, details, and order can be extreme. You may find it hard to relax or like you have to do everything yourself. You may judge other people harshly.

This isn't the same as obsessivecompulsive disorder, where a pattern of unreasonable thoughts can lead you to do something over and over, like wash your hands too much to avoid germs.

Dependent Personality Disorder

You may be too clingy because you hate to be apart from those you're closest to. The thought they could leave forever causes serious fear. You don't have a lot of confidence and aren't eager to try new things. Even everyday decisions can be hard as you feel you need approval from others first. When a romantic relationship ends, you often start a new one right away. And you may put up with abuse from someone just to keep them around.

Do I Have One?

You probably won't know it on your own. People with personality disorders often don't believe it. You may find out only after you get help for something else, like anxiety or depression, or if someone suggests you start therapy and you go. Because people with these conditions often manage well enough to get by -- though they may have a hard time with relationships -- many never get the help they need.

Diagnosis

Doctors ask questions to learn if parts of your personality are so strict that they harm your relationships at home and at work. They also check how well you control your impulses and see if your view of yourself matches reality. You might have some symptoms without having one of these conditions. Only a professional can tell if you have a personality disorder.

Treatment


These conditions can be intense, constant, affect lots of parts of your life, and be hard to manage. But you can get help. The most common method is talk therapy. You talk with a mental health professional who helps you see -and change -- patterns of thinking and behavior that cause you problems. Over time, this can help you deal with stress and with other people in a healthier way.

What About Medications?

None are specifically approved to treat personality disorders. But some drugs may help with serious symptoms. In that case, your doctor might prescribe one of these in addition to therapy:

- ► Antidepressants
- ▶ Mood stabilizers
- ► Antipsychotic medicines
- ► Anti-anxiety meds, except for people with certain personality disorders.

A little darkness can be good for you

NATURE can be a form of therapy — even when you spend time with it in the dark. "Dark nature" activities like stargazing and moonlit hikes can spark feelings of connectedness and awe, which may offer mental health

You might often hear about the benefits of spending a little time under the sun, as our bodies make some vitamin D this way.

But what about spending some time outside in the dark? Research shows that this might also be beneficial.

What the research says

Try to recall a time when you went outside at night and glanced up at the sky. What did you feel in that moment? Connectedness? Awe?

Recent studies may help explain the benefits of these emotions on mental wellness.

Connectedness

A 2024 study developed a Night Sky Connected Index (NSCI) to measure people's connection to the night sky.

The researchers interviewed participants to develop the NSCI, and to test it, they selected 406 people from the general population.

One of the many findings of this study was that a higher NSCI score is associated with greater scores of mental well-being and happiness.

Particularly, nature connectedness, or the relationship you hold with the natural world, may help predict well-being, as another study also suggests.

Nature is often a source of awe, which is a feeling you might be familiar with when



looking up at a sky full of stars. According to a 2022 research review, experiencing this emotion can help improve:

- ▶ emotional, social, and psychological well-being
- ▶ levels of anxiety, stress, depression, and PTSD
- ▶ physical health
- ▶ symptoms of autoimmune disorders
- ▶ heart health

A study from 2018 also suggests that college-age students who had nature experiences demonstrated more awe, which was associated with improved well-being.

Dark nature activities

Dark nature activities can be a form of ecotherapy, which focuses on the healing power of nature.

Beyond stargazing, other opportunities to spend time with nature in the dark include nighttime walks or moonlit hikes and having a bonfire or campfire.

Safety first

If you plan to do any activities in the dark, make sure you follow safety guidelines.

For example, if you plan to take a nighttime stroll, wear reflective clothing so others can see you and bring a flashlight.

If you want to start a campfire, make sure you're familiar with any city or park regulations.

The takeaway

Just as spending time in the sun and nature can have health benefits, hanging out in the dark while still connecting with nature can, too.

Dark nature activities, such as stargazing, moonlit hikes, or nighttime walks, can have the effects of ecotherapy. This may include improved mental well-being.

So, while an after-dinner walk might be beneficial, you might also want to consider going on after-dark walks.

The Central Bank of Eswatini (CBE) maintained the interest rate at 6.75 per cent.

What does this mean?

Banks are expected to maintain the prime lending rate on loans extended to individuals and businesses at **10.25 per cent** until the next monetary policy meeting.

Inflation

2.9%

Headline inflation decreased to 2.9 per cent in June 2025 from **3.2 per cent** in May 2025.

What to expect?

The CBE expects the cost of goods and services to increase moderately in 2025. The Bank revised down its inflation forecast for 2025 to 3.49 per cent (from 3.66 per cent forecasted in May 2025).

Economic Activity

Eswatini's Quarterly Gross Domestic Product (GDP) recorded a year-onyear decline of 0.3 per cent (seasonally adjusted) in the first quarter of 2025, compared to a revised growth of 1.7 per cent in the previous quarter.

Monetary Policy Statement

1 August 2025

On the 1st August 2025, the Central Bank of Eswatini (Bank), together with the Monetary Policy Consultative Committee (MPCC) held a meeting to consider the appropriate monetary policy stance. Taking into consideration relevant global, regional, and domestic economic factors; as well as the price and financial stability mandate, the Bank decided to maintain the discount rate at 6.75 per cent.

On the global front, the IMF has marginally revised up the economic growth outlook to 3.0 per cent (from 2.8 per cent forecasted in April 2025) for 2025 and 3.1 per cent (from 3.0 per cent) for 2026. Economic growth in advanced economies has been revised up by 0.1percentage point for both 2025 and 2026 to 1.5 per cent and 1.6 per cent $respectively.\ Growth in emerging\ markets\ and\ developing\ economies\ has\ been\ revised\ up\ to\ 4.1\ per\ cent\ (from\ 3.9\ per\ continuous)$ cent) for 2025 and 4.0 per cent (from 3.9 per cent) for 2026. Global headline inflation depicts mixed trajectories, and the IMF kept the global inflation outlook steady at 4.2 per cent for 2025 and 3.6 per cent for 2026. Interest rates have somewhat eased, and the IMF broadly projects further cuts before the end of the year.

On the regional front, the South African economy expanded by 0.1 per cent in the first quarter of 2025, quarter-onquarter, following a growth of 0.4 per cent in the previous quarter. The South African Reserve Bank (SARB) revised down its growth forecast to 0.9 per cent (from 1.0 per cent forecasted in May 2025) for 2025 and 1.3 per cent (from 1.5 per cent) for 2026. South Africa's inflation slightly increased to 3 per cent in June 2025 from 2.8 per cent in the previous month. The SARB kept its inflation forecast steady at 3.3 per cent for 2025 while the medium-term forecasts were reviewed down to 3.3 per cent (from 4.2 per cent) for 2026 and 3.0 per cent (from 4.4 per cent) for 2027. The SARB reduced the reporate from 7.25 per cent to 7.0 per cent during its 31st July 2025 meeting.

On the domestic front, Eswatini's quarterly gross domestic product recorded a year-on-year decline of 0.3 per cent (seasonally adjusted) in the first quarter of 2025, compared to a revised growth of 1.7 per cent in the previous quarter. This negative growth performance was largely driven by poor performance in the primary sector which contracted by 7.3 per cent in the first quarter of 2025 from a growth of 7.2 per cent in the fourth quarter of 2024 and the secondary sector which also contracted by 10.2 per cent in the quarter ended March 2025, from 4.5 per cent in the previous quarter. The tertiary (services) sector, rebounded strongly with a year-on-year growth of 7.2 per cent in the first quarter of 2025, up from 0.4 per cent in the previous quarter. On a quarter-on-quarter basis, economic activity grew by 0.5 per cent (seasonally adjusted), from a revised contraction of 1.6 per cent in the previous quarter.

Headline consumer inflation eased to 2.9 per cent in June 2025 from 3.2 per cent in May 2025. This disinflation was largely driven by declining price pressures in key categories, namely; 'food & non-alcoholic beverages' index which grew by a slower 2.3 per cent in June 2025 from 3.2 per cent in the previous month, 'transport' index which registered a 0.3 per cent deflation in June 2025, from 0.5 per cent in May, and the index for 'restaurants & hotels' which recorded a decline of 8.5 percentage points. Counteracting the above downward pressures were increases in the price indices for 'housing & utilities' which grew by 0.5 of a percentage point to 4.2 per cent in June 2025 and 'household furniture & maintenance' which increased from 2.0 per cent to 3.0 per cent. The Bank revised down its short-term inflation forecast to 3.49 per cent (from 3.66 per cent forecasted in May) for 2025 on account of a lower food inflation outturn, stronger exchange rate assumption and the lower oil prices. In the medium term, the Bank revised down its inflation forecast to 3.95 per cent (from 4.05 per cent) for 2026 and 3.71 per cent (from 3.92 per cent) for 2027.

Credit extended to the private sector marginally decreased by 0.05 per cent month-on-month to close at E21.6 billion in June 2025. Credit to the business sector fell by 2.2 per cent month-on-month to E11.7 billion at the end of June 2025 and credit extended to other sectors of the economy also contracted by 2.9 per cent to E1.0 billion over the review period. The banking sector's loan book registered an improvement month-on-month as none performing loans (NPLs) fell by 1.9 per cent to close at E1.3 billion in June 2025. The NPL ratio rose by 0.3 percentage points year-on-year to reach 7.0 per cent in June 2025.

As of 25th July 2025, gross official reserves stood at E11.8 billion equivalent to an import cover of 3.0 months. At the end of June 2025, total public debt stood at E38.4 billion from E36.6 billion in May 2025, depicting an increase of 4.9 per cent. At this level, it is equivalent to 40.2 per cent of GDP.

In taking the decision, the Bank cautiously considered the credibility of the peg against the South African Rand and the need to ensure adequate gross official reserves. The Bank will continue to monitor international, regional and domestic developments that influence the movements of inflation and will act appropriately in line with its mission to foster price and financial stability that is conducive to the economic development in Eswatini. Furthermore, the Bank is currently reviewing its policy toolkit and will announce in due course other policy actions that will be taken to support the Bank's mandate.

PREMIER Soccer League (PSL) chairman Irvin Khoza revealed the staggering viewership numbers of PSL matches that have even surpassed the Fifa World Cup and the Rugby World Cup finals.

"I cannot stop talking about the achievements we have made in terms of making sure that the content that we produce becomes more attractive. Again, I want to juxtapose the success of the PSL – when Pirates played against Sundowns in the final of the MTN8, they achieved a viewership of 9,5-million viewership, which was an unbelievable achievement," said Khoza. He revealed the mind-blowing numbers at the 2024/25 PSL Awards, where the league's and cup tournament best performers were honoured and bestowed with accolades and trophies.

Last year, Khoza mentioned to selected journalists that when the Buccaneers defeated the Brazilians in that 2023 final, the viewership surpassed that of the final of the

2023 Rugby World Cup between the Springboks and New Zealand in France, which the Boks won.

"In the 2024/25 Nedbank Cup final between Chiefs and Pirates, the viewership was 9,9 million, bigger than the 2022 Fifa World Cup final between Argentina and France [in Qatar].

"This tells the story that from the soccer

Rushine de Reuck also departed during the same window, joining Israeli side Maccabi Petah Tikva on loan. Lorch impressed during his stint at Wydad, particularly with his performances at the FIFA Club World Cup, sparking speculation that he could be reintegrated into the Sundowns setup. However, Phakaaathi understands that Cardoso remains unconvinced and is looking to move in a different direction.

The 32-year-old failed to report for pre-season, prompting the Sundowns hierarchy to explore possible exit options. Having signed from Orlando Pirates in a high-profile switch in January 2024, Lorch's move to Chloorkop has ultimately failed to live up to expectations. He is currently training on his own while plotting his next move, which is believed to be in North Africa.

Cardoso, who has consistently expressed a preference for a smaller squad, has already approved de Reuck's switch to Simba SC in Tanzania. Lorch is expected to be the next to leave as Sundowns continue to trim their squad for the new season with other bigname players expected to depart the Chloorkop-based side. (**The Citizen**)

Fernandes critical of 'lazy' Man Utd

MANCHESTER United captain Bruno Fernandes let rip at his teammates following their 2-2 pre-season draw with fellow Premier League side Everton, saying their performance was "lazy" and calling for further reinforcements.

A second-half goal from Mason Mount had United on course for victory in Atlanta, Georgia after Fernandes's opener was cancelled out by Iliman Ndiaye, but a bizarre 75th-minute own goal by Ayden Heaven gifted Everton the draw on Sunday.

The draw put a slight damper on the Old Trafford club's tour of the United States, after promising victories over West Ham United and Bournemouth last month.

"It's been important for developing how we want to play and getting the new players involved too," Fernandes told NBC Sports.

"We didn't want to finish in this way. Our performance wasn't the best and we were a little bit lazy today. We want to avoid that because with laziness you can pay at any moment."

United had their worst-ever Premier League campaign in the 2024-25 season, finishing 15th in the standings, and are looking to strengthen in the transfer window, signing Matheus Cunha and Bryan Mbeumo - both of whom started against Everton.

"It's improving. But it's not the place it needs to be. I don't want to take a dig at anyone but the club is doing the best they can in terms of the financial situation they talk about," Fernandes said.

"Because football is more than victories and goals, it's legacy, it's family, it's love for our land. "Our new jersey brings in the great image of Diogo Jota and his brother Andre Silva, two sons of Gondomar who left us too soon, but who will live forever in the history of our club and our football.

Inter Miami calls Lionel Messi's leg injury 'minor'

A return date for Lionel Messi to the Inter Miami lineup is uncertain, but the Herons announced Sunday that the superstar's right leg injury isn't serious.

Messi came out of Miami's Leagues Cup match against Necaxa on Saturday in Fort Lauderdale, Fla., in the 11th minute, shortly after getting hurt in a collision with two opponents.

After Messi underwent medical tests, the team issued a statement on Sunday that read, in part, "The results confirmed a minor muscle injury in his right leg. His medical clearance will depend on his clinical progress and response to treatment."

In Messi's absence, Inter Miami rallied late to equalize the match at 2-2, then prevailed 5-4 in a tiebreaking penalty-kick shootout.

Through two Leagues Cup matches, Miami sits in second place in the MLS standings with one regulation win and one shootout win, good for five points. The top four of the 18 MLS clubs in the competition will advance to the quarterfinals, where they will be joined by the top four of the tournament's 18 Liga Mx clubs.

The Herons conclude the group phase with a Wednesday home match at Pumas UNAM.

Inter Miami resumes MLS regular-season action on Aug. 10 at Orlando City.

FIFA faces class action over player transfer regulations

A Dutch soccer players' group is preparing a "potentially billion-dollar" Europe-wide class action claim against FIFA and other associations, seeking compensation over alleged loss of income due to restrictive transfer rules, it said on Monday.

The Dutch Foundation for Justice said world soccer governing body FIFA's rules had affected approximately 100,000 players in European member states and the United Kingdom since 2002.

The foundation added that consultancy firm Compass Lexecon had estimated that damages could run into billions of euros, with the foundation's board member Dolf Segaar telling Dutch news agency NOS that "it is a billion-dollar claim".

The Dutch Football Association (KNVB) is among the associations to be named in the suit.

"This case is being brought in the Netherlands under the Dutch Act on the Settlement of Mass Damages in Collective Action (WAMCA), which allows this legal action to be launched by JfP on behalf of a large group of professional footballers," it added.

FIFA and the KNVB did not immediately respond to emailed requests for comment.

ATP relocating tournament from Serbia to Greece

THE ATP Tour announced Monday that the Nov. 2-8 tournament in Belgrade, Serbia, is relocating to Athens, Greece.

No official reason was given. Serbian media reported that Novak Djokovic and his family, who run the tournament, are behind the move.

The 24-time Grand Slam champion recently expressed his support for students protesting government corruption in his native Serbia.

Djokovic's brother, Djordje, has been the director of the ATP 250 tournament in the Serbian capital since 2021.

The tournament in Athens, dubbed the Hellenic Championship, will be played on an indoor hard court at the OAKA Basketball Arena.

"ATP 250 Hellenic Championship is organized by the experienced team behind nine previous international tournaments in Belgrade. This latest project builds on that legacy, with preparations well underway to deliver a world-class event in the historic city of Athens," read a statement from tournament organizers.

tournament sponsored by MU and Lee Investment. The tournament was played at Mlandvo Restaurant and Bar, just past Luyengo.


