King wants two Turkmenistan companies to operate in Eswatini

AWAZA, TURKMENISTAN — Just a day after the Kingdom of Eswatini and Turkmenistan established diplomatic relations, His Majesty the King wants two major Turkmenistan companies to open their offices in the country.

The King, accompanied by Inkhosikati LaMotsa, Emazinyane Princess Sikhanyiso, Princes Sicalo, Lindani, Princess Ngobile and Ministers Pholile Shakantu of Foreign Affairs and Chief Ndlaluhlaza of Public Works, toured Türkmenbaşy Oil Processing Complex (TNGIZT) and Türkmenbaşy International Seaport to be apprised and establish links with the view to working closely with the Kingdom.

The King's tour of these two major facilities took place on the sidelines of the third UN Conference on Landlocked Developing Countries (LLDCs). The experience from these tours is expected to aid in the establishment of the E_{5.2} billion Strategic Oil Reserve to be built at Phuzamoya in Siphofaneni, commencing before the fall of the

His Majesty the King was taken through the company's operations by General Director Cishiywe Dovran Gurbangeldiyevich and Deputy Minister of Oil and Mineral Resources Batyr Jumayev, who informed him that it was established in 1943.

"TNGIZT is involved in the processing of oil and gas condensate, the production of various oil and petrochemical products and their sale in the domestic and foreign mar-

"The production capacity of the complex of plants includes a number of oil refineries, as well as a number of oil refineries that increase the depth of primary oil refining. The company produces over 150 oil products amongst which are types of products produced at the complex includes amongst which is jet fuel purifier, diesel fuel water purifier, paraffin, olefin alkylation and light gas isomerizer, production of polypropylene

coatings, bitumen, general oil coating, drying oil coating, polypropylene and polypropylene packages," he said, to name just a few.

The complex is completed with power-generating gas turbine plants, seawater desalination plants, steam generators, secondary water coolers, pumping stations, tank farms, power plants and other auxiliary

Dovran stated that their high-quality oil and petrochemical products produced at the Türkmenbaşy Oil Processing Complex are exported to different directions, namely to Europe, Asia, and the Middle East.

His Majesty the King expressed the country's interest in partnering with the company and in future considering establishing strong links and sales agreements that would see the company's products reaching Eswatini.

The King said the Ministry of Foreign Affairs and International Cooperation will soon make follow-ups to see what could be done to ensure that relations between the two countries are strengthened and open more trade opportunities.

From the Türkmenbaşy Oil Processing Complex, the King and his delegation toured Türkmenbaşy International Seaport, where he also had an interest in the possibilities of opening trade routes and further benefit

from the company's experience as a landlocked country in the movement of goods.

Yunus Kakabayor, the Channel's director, explained to the King that their port is involved in the movement of millions of cargo per annum to various markets across the world, especially in Central Asia, Europe and neighbouring countries.

Chief Ndlaluhlaza, the Minister of Public Works and Transport, expressed the country's interest in learning from Türkmenbaşy International Seaport, especially because the country was exploring options of joining the International Maritime Organisation (IMO).

"The United Nations promotes that even landlocked countries should have access to the coasts and operate their own seaports. Part of the bilateral agreements we signed with Mozambique would assist in such an endeavour, hence our visit to this seaport here," the minister said in an interview.

The companies appreciated His Majesty the King's gesture to visit each one of them and indicated that it will forever remain in their records that such an esteemed guest visited their facilities.

AWAZA, TURKMENISTAN — Eswatini has shared its goal to transform itself into a regional technology hub to the global community.

The Minister for Information, Communication and Technology, Savannah Maziya, outlined how the nation is harnessing digital innovation to overcome its landlocked geography and drive inclusive economic growth.

This was during the third United Nations Conference on Landlocked Developing Countries (LLDC3), being held from 5-8 August 2025.

Reframing Eswatini's landlocked status as "land-linked," Minister Maziya emphasised the potential for connectivity and collaboration. "It is very important for countries that share the same structural positions to get together and share how best to create opportunities for their citizens," she said.

The nation, she said, is leveraging ICT to

access global markets and bring the world to its doorstep. "We in ICT see this positioning as a way to garner advantage in leading in the technology space," Maziya said, underscoring the goal of opening new markets and opportunities.

In this regard, she said a core focus is empowering marginalised groups, particularly youth and women, to participate fully in the economy. "We are focused on ensuring that we develop so as to ensure that the youth, women, and others who are currently marginalised are able to participate," Maziya

Senate President pledges Parliament's commitment to implementing the Grand Plan for National Transformation

SENATE President Lindiwe Dlamini has pledged that Parliament will play a crucial role in ensuring the Grand Plan for National Transformation transitions from mere documentation to tangible implementation.

This commitment, according to the Senate President, involves legislative refinement, thorough budget scrutiny, and ongoing oversight, all aimed at transforming the vision into a reality that impacts the lives of emaSwati. Prime Minister Russell Dlamini, alongside selected Cabinet Ministers, was

engaging Senators in Pigg's Peak to discuss the Grand Plan, which embodies His Majesty's vision for a developed Eswatini. The Prime Minister has called on Senators to unite in support of this ambitious initiative, which reflects the aspirations of the people articulated during the Sibaya gathering.

During the opening session of this critical engagement, the Prime Minister elaborated on how the Grand Plan aims to build upon the successes and lessons learned from previous development strategies while addressing existing gaps. He emphasised that the goal is to achieve sustainable economic prosperity over the next two to three decades.

"Past plans laid an important foundation," the PM noted, highlighting gains in agricultural productivity, increased access to basic education, and support for small and medium enterprises (SMEs). However, he pointed out that structural issues such as inadequate infrastructure, gaps in the health sector, and limited private sector development continue to hinder progress.

The Prime Minister framed the current moment as a pivotal juncture for Eswatini. "Today, Eswatini stands at a critical crossroads. Will we continue the path that has led us here today, or will we brave a different path altogether?" he asked. The Grand Plan represents the government's ambition to aim higher than ever before and to explore new possibilities for the nation.

He further asserted that the kingdom should aspire to achieve high-income status within the next two to three decades,

positioning Eswatini among the world's most developed countries, as frequently mentioned by His Majesty. "To get there, we need a deliberate and credible longterm strategy that corrals the whole of Government. We must work together to see this future materialise in the coming years," he stated.

The Grand Plan proposes a transformative 30-year agenda anchored around three main pillars: Economic Transformation, Social Transformation, and Government Transformation. This framework is designed to build on previous successes while addressing their shortcomings, ensuring that growth is broad-based, socially inclusive, and institutionally sustainable.

FORMER Ministry of Information, Communication and Technology (ICT) Principal Secretary Phesheya Dube has transitioned to the Ministry of Commerce, Industry and Trade as Under Secretary.

Aiming to enhance the efficiency and effectiveness of government operations, the Civil Service Commission has announced a series of administrative and technical transfers of senior government officials.

Mpumie Dlamini has shifted from the Ministry of Home Affairs to the Ministry of Labour and Social Security, where she will take on the role of Under Secretary, Administration. Neamsile Mntshali, moving from the Ministry of Health, will now serve as Under Secretary, Administration at the Ministry of Education and Training.

A 32-year-old man was arrested after being caught with a large consignment of compressed dagga smuggled from Eswatini, with an estimated street value of E4 million.

The dramatic arrest unfolded on the R33 highway near Dundee in KwaZulu-Natal on Monday, following a high-speed chase involving several elite police units. Acting on intelligence, members of the Glencoe K9 Unit, the Zululand Task Team, and Dundee Crime Prevention intercepted the suspect's vehicle, which was found to be carrying 90 bags of compressed dagga.

Police confirmed that the dagga had been smuggled across the border from Eswatini, a growing concern for law enforcement agencies on both sides of the border.

"The operation was a success thanks to collaboration and swift action from multiple policing units," said KwaZulu-Natal police spokesperson Colonel Robert Netshiunda. "This is a significant blow to cross-border drug trafficking syndicates operating between Eswatini and South Africa."

The suspect, whose identity has not been publicly disclosed, was expected to appear

SA cops seize E4mln dagga smuggled from Eswatini

in court yesterday to face charges related to drug trafficking and possession of illegal substances.

Authorities have not ruled out the possibility of further arrests, as investigations continue to determine the full extent of the smuggling network.

This latest seizure underscores the persistent challenges faced by border enforcement agencies dealing with the illegal flow of narcotics between Eswatini and South Africa.

It is worth noting that in recent months, both countries have ramped up efforts to tighten border controls and dismantle drug syndicates using rural routes and secondary roads to transport contraband.

It should be noted that the bust comes amid renewed calls from community leaders and anti-drug organisations for stronger collaboration between Eswatini and South African law enforcement to combat the scourge of drug trafficking and protect vulnerable communities.



UK, EU diplomats urge Eswatini to maximise SADC-EU trade opportunities

THE European Union-Southern African Development Community (EU-SADC) Economic Partnership Agreement (EPA) has been described as a vital tool for unlocking inclusive

growth, sustainable development, and regional economic transformation.

This was the central message delivered by top European diplomats during the stakeholder validation workshop for the EU-SADC EPA Implementation Strategy and Action Plan (2025–2029), held at the Royal Villas in Ezulwini.

British High Commissioner to Eswatini, Colin Wells, encouraged local businesses and stakeholders to fully exploit the trade and investment opportunities presented under the agreement. He emphasised that regional collaboration and proactive engagement in the EPA framework could open significant economic prospects for Eswatini and the wider SADC region.

"This is an opportunity to deepen trade relationships, strengthen value chains, and enhance market access between the SADC region and the European Union. Businesses must seize this moment to innovate, grow and expand their footprint," said High Commissioner Wells.

His sentiments were echoed by European Union Ambassador to Eswatini, Karsten Mecklenburg, who described the EU-SADC EPA as "a bridge between regions, a catalyst for inclusive growth, and a reminder that economic prosperity thrives when countries

Mecklenburg noted that the meeting was a pivotal milestone in ensuring that the agreement is not just a policy document, but a "living instrument" that delivers tangible benefits to citizens across SADC.

"This strategy and action plan will guide implementation over the next five years, ensuring that trade remains not just free and fair, but also inclusive and transformative," he added.

The workshop brought together govern-

ment representatives, private sector players, development partners, and civil society stakeholders to validate the roadmap for the next phase of the EPA's implementation.

The EU-SADC EPA provides duty-free, quota-free access to the European market for goods originating in the SADC EPA states, including Eswatini. It also promotes regional integration, supports sustainable agriculture, and encourages fair trade practices.

It is worth mentioning that as Eswatini looks to diversify its economy and expand its export base, stakeholders say fully embracing and implementing the EPA will be key to enhancing competitiveness and boosting investor confidence.

The 2025–2029 Implementation Strategy is expected to be finalised and rolled out early next year.

This is an opportunity to deepen trade relationships, strengthen value chains, and enhance market access between the SADC region and the European Union.

10 yrs for killing another man for E50

A 37-year-old man has been sentenced to 10 years in prison without an option of a fine after killing another man for E50.

Nkosingiphile Makhiza (32) Magagula of Dvokolwako was sentenced by Principal Magistrate David Khumalo yesterday at the Manzini Magistrates Court.

This comes after he killed Simanga Gamedze by assaulting him with stones alongside Bafanabakhona Magagula (29) of Ngculwini area, who stabbed him with a knife.

However, Bafanabakhona is still at large as he escaped trial shortly after being granted bail. This resulted in the Crown, applying for a separation of trial in the matter, thus Nkosingiphile ended up being the only one sentenced so far.

Bafanabakhona will be tried separately as soon as he is re-arrested.

The partners in crime were both charged with Culpable Homicide, an offence they committed at New Village area on November 29, 2025.

According to one of the witnesses, Mfanawenkhosi Nhlabatsi, when leading evidence before court, he was coming from work on the fateful evening of November 29, 2019 when he heard someone raising an



alarm

"I proceeded to the spot, where the alarm was being raised and I found the accused before court together with Bafanabakhona assaulting the deceased," he said.

He mentioned that Bafanabakhona was carrying an okapi knife while Nkosingiphile was using stones to assault Gamedze, who was already lying down on the ground.

Nhlabatsi pointed out that Bafanabakhona used the knife to stab Gamedze.

"I told the two to stop what they were doing. When they had stopped and left the scene, the deceased stood up and told me that he was being attacked for E50. The deceased was badly injured and was bleeding. I left him and went home and when I returned to the scene, I found that he was dead," he said.

He mentioned that police were called to the scene and they ferried the lifeless body of Gamedze to the mortuary. Nkosingiphile pleaded guilty to the charge and was found guilty as per his own plea.

He mitigated for a lenient sentence on grounds that he was married with three children, who were dependent on him. He also informed the court that he was a sickly person

However, his mitigation did little on nothing to convince the presiding magistrate otherwise as he was given the aforementioned sentence.



REPS clamp down on copper thieves

THREE men were arrested for stealing copper cables belonging to Eswatini Electricity Company (EEC) worth over E17 000.

Nhlanhla Makama (28) Simphiwe Makama (23) both from Phuzumoya area and Siboniso Shabangu (32) of Luve area appeared before Magistrates Lucia Lukhele at the Matsapha Circuit

They were charged with theft after they stole a 75 metres long underground copper cable valued at E17 430.

They committed the offence on February 20, 2025 at Mahhala area.

They all pleaded guilty to the offence and they were found guilty as per their own pleas.

Nhlanhla mitigated for a lenient sentence on grounds that he was tempted by his co-accused to commit the offence.

He further mentioned that his wife was sickly.

"I apologise for committing the offence," he said.

Simphiwe on the other hand, pleaded for a lenient sentence based on the fact that he was apologetic for committing the offence, while Siboniso mitigated for a lenient sentence on grounds that he was a bread winner at home.

Nhlanhla was sentenced to one year in prison without an option of a fine, while Simphiwe and Siboniso were each sentenced to two years imprisonment without an option of a fine.

Person living with disability arrested for armed robbery

AN 18-year-old teenager, who is living with a speech impediment, has been arrested after allegedly committing two armed robberies.

This comes after Mlindo Maylo Shongwe, who appeared before Principal Magistrates Florence Msibi at the Manzini Magistrates Court yesterday, allegedly used a bush knife on January 11, 2025 to induce submission of a jacket from Thando Simelane worth E640.

He allegedly committed the offence at Logoba area.

On the same day at Kakhoza area, Shongwe is alleged to have used the same bush knife to induce submission of a Hisense cellphone valued at E1 500 and a black leather jacket worth E350 from Fezile Masilela.

Shongwe, who was speaking through the assistance of an interpreter, applied for bail on grounds that they were two when they committed the offence and his co-accused, Thabiso Magagula has been granted same (bail) fixed at E2 000 and was already out of custody.

He further pointed out that prison was not a conducive place for him since he could hardly communicate with anyone.

"May I be granted bail, so that I can attend trial from home," he said.

However, the Crown mentioned that bail was opposed based on instruction from the investigating officer, who stated that Shongwe was a flight risk. He further mentioned that Shongwe did not provide a permanent residential address, yet it was difficult to arrest him.

He added that Shongwe was vicious when committing the crimes and could not hear even when people were reprimanding him, hence denying him bail was in the best interest of his safety as he might be attacked by a mob in the event he committed another offence whilst out on bail.

He mentioned that the least they could do was to afford him a speedy trial.

As a result, Shongwe's bail application was therefore, denied. He was remanded in custody until August 13, 2025 pending trial.

Ngwane Park High pupil granted bail in E119 000 theft case

AN 18-year-old Form 4 pupil from Ngwane Park High School and his co-accused, 21-year-old Nkosenhle Celimphilo Dlamini of Lonhlupheko, have been granted bail after being arrested for housebreaking and theft involving property worth E119 000.

The two were remanded at Zakhele Remand Centre after their arrest on 29 July 2025. They face a charge of housebreaking with intent to steal and theft, after allegedly breaking into the Ngwane Park home of one Njabulo Mabuza.

Stolen property includes seven diesel engine pumps valued at E105 000 and two clutch pressure plates worth E14 000.

They made their initial court appearance at the Manzini Magistrate's Court on 31 July.

Following an urgent bail application by their attorney, Simo Simelane of Demhleta Legal, the High Court granted them bail at E15 000 each. They were ordered to pay E2 000 in cash and provide surety for the remaining E13 000.

In court documents, Dlamini claimed he was unaware the items were stolen and said he was helping a mutual friend, Mcolisi Mazibuko, transport what he believed was scrap metal to the Recycle Zone in Matsapha.

He alleged Mazibuko was paid in scrap for work done at a local garage.

The Ngwane Park pupil offered a similar explanation, saying he used his family's van and was only assisting. He also expressed concern over missing school and possibly facing expulsion.

EEC copper cables worth over E70 000 stolen in Siphofaneni

COPPER cables worth E70 670 were stolen from a storage facility belonging to a farmers' scheme near Madlenya in Siphofaneni.

The copper cables were the property of the Eswatini Electricity Company (EEC).

The break-in occurred on Monday night. A staff member who discovered the theft reported it to the nearest police station, where an investigation was launched.

According to the report, burglars broke into the storage unit and made off with the cables. The theft disrupted farming operations dependent on electrical infrastructure at the site.

The incident was confirmed by acting Deputy Chief Police Information and Communications Officer, Inspector Mazwi Ndzimandze.

Teen sentenced for assaulting mother

A 19-year-old girl has been sentenced to a fine of E5,000 or five years in prison for assaulting her mother.

The sentence was handed down by Principal Magistrate Fikile Nhlabatsi, following a physical altercation that arose after the mother allegedly threw out the young woman's clothes.

During mitigation, the accused admitted to pushing and beating her mother but expressed remorse and apologised for her actions.

In delivering her sentence, Magistrate Nhlabatsi emphasised that disrespect towards parents would not be tolerated, stating that the punishment should serve as a lesson to others. The sentence was aimed at deterring similar conduct, especially among young people.

Alpheous Nxumalo's constitutional challenge to proceed to next session

FORMER Government Spokesperson Alpheous Mfana Nxumalo's constitutional challenge against the Sexual Offences and Domestic Violence (SODV) Act of 2018 will be placed on the court roll in the next judicial session, scheduled for next month.

Nxumalo is facing rape charges involving two teenage siblings, aged 17 and 18. He contends that the Act under which he is being prosecuted is unconstitutional.

He argues that it was passed without adhering to Section 115 of the Constitution, which mandates consultation with the Council of Chiefs when significant changes to Swazi Law and Custom are involved.

Appearing before Judge Mumcy Dlamini, Nxumalo's attorney, Khumbulani Msibi, confirmed the application seeks to halt all criminal proceedings until the constitutional challenge is determined.

Nxumalo is demanding production of the Hansard or any parliamentary records to prove that the appropriate legislative procedures were followed during the enactment of the SODV Act.

The application lists six respondents, including Principal Magistrate David Khumalo, the Director of Public Prosecutions, the Speaker of the House of Assembly, the President of the Senate, the Deputy Prime Minister, and the Attorney General.

The State is expected to file opposing affidavits in the coming weeks. Nxumalo, who was granted E50,000 bail in April, continues to deny all allegations.

Misiwe Jele's case removed from Magistrate's court roll

THE criminal case against Assistant Immigration Officer Misiwe Jele has been temporarily removed from the Magistrate's Court roll pending a decision on a related legal challenge at the High Court.

Jele is facing 14 counts under the Prevention of Corruption Act and the Immigration Act. The charges relate to her alleged role in unlawfully issuing entry permits to foreign nationals, including a Pakistani citizen, without proper committee approval.

The Anti-Corruption Commission (ACC) claims Jele manipulated permit processes and misled officials to influence application outcomes.

Attorney Zweli Jele, representing the accused, informed Principal Magistrate Fikile Nhlabatsi that he had filed a High Court application contesting the legality of certain actions taken by the ACC.

He argued that continuing the Magistrate's Court proceedings could prejudice his client and that justice would best be served by awaiting the High Court's ruling.

Following the submissions, the matter was removed from the roll until the High Court case is finalised.



Minister calls for emaSwati to localise manufacturing sector

THE Minister of Commerce, Industry and Trade, Mancoba Khumalo, has called on emaSwati to take ownership of the manufacturing sector, citing low participation by locals in an industry that continues to be dominated by foreign investors.

He made the remarks last week during the 19th edition of the Eswatini Entrepreneur of the Year Awards regional ceremony held in Manzini.

The event, which recognises and celebrates outstanding entrepreneurship, was attended by government officials, private sector representatives, business stakeholders and entrepreneurs from various sectors.

Khumalo said the manufacturing industry in Eswatini remained largely underdeveloped due to limited local participation, and emphasised the need for deliberate efforts by aspiring entrepreneurs to explore opportunities in the sector.

"Our manufacturing sector continues to be accommodated by foreign nationals. We want to see more emaSwati tapping into this sector. It is time we take it over, localise it and own it," said the minister.

He stated that while Eswatini has made progress in supporting small businesses and creating enabling policies for entrepreneurship, the local manufacturing industry still lacked significant local ownership.

He said this gap presented an opportunity for emaSwati to not only grow their own enterprises but also strengthen the national economy.

"The economy cannot grow to its full potential if our people are not fully participating in critical sectors. Manufacturing is one such sector that has the ability to transform livelihoods and create sustainable employment. We need to see our people active in that space," he said.

Khumalo explained that his ministry was actively working to ensure that more emaSwati were empowered with the tools and support needed to enter industries that remain underserved by local business owners.

"We are working around the clock as a ministry to make sure emaSwati have the economy in their hands. It should not be a foreign-led economy when we have capable and skilled citizens," he said.

The minister highlighted that the government was already working with stakeholders to remove barriers to entry in the sector and to increase access to infrastructure, financing, and technical support for entrepreneurs.

"There are existing interventions through our ministry and our partners to support manufacturers. What we now need is increased uptake by locals. The opportunity is there, and we are ready to walk with entrepreneurs through the process," he added.

Khumalo said entrepreneurship played a key role in industrial development and national economic growth, and noted that localising manufacturing would reduce the country's dependency on imports and improve the trade balance

He also pointed out that many of the prod-

ucts consumed in Eswatini are manufactured outside the country, including those that could be produced locally with sufficient investment and innovation.

"We are importing things that can easily be produced here. If we want to build a strong and resilient economy, we must stop exporting opportunities. We must be the ones supplying the goods we consume," Khumalo stated.

He further urged entrepreneurs in attendance to consider industrial production as a viable path, and not limit their ambitions to sectors that are already saturated.

"Everyone is doing the same thing. We need to diversify and explore new ground. Manufacturing is one of those sectors with real growth potential, especially for youth and women entrepreneurs," he said.

Khumalo acknowledged that the journey into industrial entrepreneurship was not without its challenges but reiterated government's commitment to offering consistent support through policy reforms, incentives, and capacity-building programmes.

He said the ministry would continue to engage with business development service providers, financial institutions, and the private sector to ensure that aspiring manufacturers were not left behind.

"We have institutions like SEDCO, SIPA, FINCORP and the SME Unit, among others,

that are all aligned to support the vision of increasing local participation in the economy. The structures are in place; what is needed now is participation," he said.

The minister noted that the Entrepreneur of the Year Awards were a platform to celebrate excellence and also identify gaps that need to be addressed.

"These awards are not just a recognition ceremony. They are a mirror that shows us what sectors we are excelling in and where we need to do more. We want to start seeing more manufacturers among the winners," Khumalo said.

He concluded by encouraging young people to take bold steps and seek out opportunities beyond traditional business models.

"Young people must not be afraid of big industries. The same energy used to build startups can be used to start production lines. Think big, act bold, and know that government is here to support you," he said.

The Eswatini Entrepreneur of the Year Awards are part of an ongoing national programme aimed at recognising and promoting excellence in business.

The initiative is supported by the Ministry of Commerce, Industry and Trade in partnership with local enterprise development agencies and private sector sponsors. The awards are held regionally ahead of the national awards ceremony scheduled for later this year.

Dollar falls as traders bet on more rate cuts

NEW YORK — The dollar dropped on Wednesday and the euro hit a one-week high as traders bet that the Federal Reserve will cut rates more times than previously expected this year, following weaker than expected jobs data for July.

With no major U.S. economic releases on Wednesday traders continued to focus on the implications from Friday's jobs report.

U.S. employment growth was weaker than expected in July while the nonfarm payrolls count for the prior two months was revised down by a massive 258,000 jobs, suggesting a sharp deterioration in labor market conditions. The greenback fell sharply after the report, paring gains from what had been a relatively strong July for the currency, the first month this year in which the dollar index posted a gain.

"We had the first dollar bounce under Trump's second term, and many people thought that maybe it had some legs, but I think Friday's jobs data killed it," said Marc Chandler, chief market strategist at Bannockburn Global Forex in New York. "The renewed speculation of not only a cut in September, but another cut at the end of the year, has capped the dollar's bounce."

Fed funds futures traders are now pricing in an 89 per cent probability of a 25 basis point cut at the Fed's September meeting, up from 48 per cent a week ago, according to the CME Group's FedWatch Tool. In total, traders see 58 basis points in cuts this year.

The Fed may need to cut interest rates in the near term in response to a slowing U.S. economy, even though it remains unclear whether tariffs will continue to push inflation higher, Minneapolis Fed President Neel Kashkari said on Wednesday.

The dollar added to its drop on Friday after U.S. President Donald Trump fired a top Labor Department official, alleging data ma-

The dollar index was last down 0.33 per cent on the day at 98.41 and reached 98.36, the lowest since July 28. It posted a 1.35 per cent drop on Friday, the largest one day fall since April.

The euro rose 0.47 per cent to \$1.1628 and got as high as \$1.1636, the highest since July 28. It recorded a 1.48 per cent gain on Friday.

Investors are also focused on Trump's expected nomination to fill a coming vacancy on the Federal Reserve's Board of Governors and the candidates for the next Fed Chair.

Trump said on Tuesday he would decide on a nominee to replace outgoing Fed Governor Adriana Kugler by the end of the week and had separately narrowed the possible replacements for Fed Chair Jerome Powell to a short list of four.

Trump said he has narrowed his list of candidates to replace Powell to economic adviser Kevin Hassett, former Fed governor and Trump supporter Kevin Warsh, and two other people. Trump did not name those people, but one is thought to be current Fed Governor Christopher Waller.

"From what we can ascertain, Warsh seems to be the most hawkish of the three, while Waller is clearly the most dovish, having dissented at the last FOMC meeting, so any shift in the odds towards the latter would likely be bearish for the dollar," Matthew Ryan, Head of Market Strategy at Ebury said in a note.

The dollar fell 0.21 per cent to 147.3 yen. It fell 2.24 per cent against the Japanese currency on Friday, the largest daily drop since

The greenback pared earlier gains against the Japanese currency after Taro Kono, touted as a candidate to become the next prime minister, said that Japan must balance its budget and push the central bank to raise interest rates to alleviate concern over the country's finances.

Ruling party heavyweight Ken Saito, meanwhile, told Reuters that The Bank of Japan must be cautious about raising interest rates given the expected hit from U.S. tariffs on the fragile economy.

Sterling rose 0.19 per cent to \$1.3323 before the Bank of England on Thursday is expected to cut interest rates by 25 basis points.

In cryptocurrencies, bitcoin gained 0.56 per cent to \$114,293. (Reuters)

TotalEnergies maintains buybacks despite profit drop

TOTALENERGIES reported a 23 per cent fall in second-quarter earnings on Thursday, the French oil major's worst performance in four years but in line with expectations, as lower oil and gas prices outweighed a rise in production and power sales.

Adjusted net income fell to \$3.6 billion for the three months to June 30, down from \$4.7 billion a year earlier and \$4.2 billion in the first quarter.

Shares were down 4.1 per cent to 51.17 euros at 1335 GMT.

CEO Patrick Pouyanne told analysts on a call that the company could maintain shareholder returns in a low oil price environment, as several expressed concern about a sharp increase in the company's net

Brent crude prices have fallen 20 per cent from a year ago, reaching \$67.9 per barrel in the second quarter of 2025, as members of the Organization of the Petroleum Exporting Countries and allies such as Russia started to unwind output cuts of 2.17 million barrels per day in April.

TotalEnergies' net debt leapt 89 per cent year-on-year to \$25.9 billion, pushing gearing - a measure of debt to equity - to 22.6 per cent including leases, as the company made \$2 billion of acquisitions and saw its working capital increase - even as it extended a \$2 billion share buyback into the third quarter.

"We have a strong balance sheet ... and we are committed to \$2 billion in quarterly buybacks at \$70 per barrel," Pouyanne said on a call with analysts.

The CEO added that according to the company's definition of normalised gearing, the ratio of debt to equity was 15 per cent.

He said that 15 per cent figure would not increase this year, as the company finalised sales of stakes in renewable assets and disposals of oil and gas assets in Nigeria, Argentina and other areas, expected to bring in some \$3.5 billion.

TotalEnergies' integrated power business beat forecasts with a 14 per cent rise in quarterly profit to \$574 million, but was unable to offset poorer performance across nearly all other units.

Refining and chemicals earnings fell 39 per cent from a year ago, the company said.

TotalEnergies' margin for refining crude into fuels dropped 21 per cent from a year ago to \$35.3 per ton, despite a slow recovery in the first half of 2025 from a collapse last year due to sagging demand and an increase in global competition.

The company said it expected refining margins to rise above \$50 per ton in the third quarter due to increased fuel demand during Europe's summer driving season. (Reuters)

"The rand is trading below the R17.90 level this morning as it continues to recover from Monday's tariff-driven blowout and strong dollar," said Andre Cilliers, currency strategist at TreasuryONE.

This week's major focus for the country is whether it can negotiate a better trade pact as it faces a 30 per cent duty on goods exported to the U.S., the highest rate among Sub-Saharan African countries.

The dollar last traded flat against a basket of currencies as investors held back from making big bets ahead of U.S. President Donald Trump's decision on appointments to the Federal Reserve.

Trump on Tuesday said he would soon

Google says hackers stole its customers' info by breaching its Salesforce database

GOOGLE has confirmed that some customers' information has been stolen in a recent breach of one of its databases.

In a blog post late on Tuesday, Google's Threat Intelligence Group said one of its Salesforce database systems, used to store contact information and related notes for small and medium businesses, was breached by a hacking group popularly known as ShinyHunters, formally designated as UNC6040. "The data retrieved by the threat actor was confined to basic and largely publicly available business information, such as business names and contact details," the company said.

Google did not disclose how many customers are affected, and a company spokesperson did not immediately respond to a request for comment. It's not clear if the company has received any communication, such as a ransom demand.

ShinyHunters is known for targeting big companies and their cloud-based databases.

This is the latest in a series of breaches targeting Salesforce cloud systems, after recent thefts of customer data from Cisco and airline giant Qantas, retail giant Pandora, among others, as reported by Bleeping Computer. According to Google's blog post, the ShinyHunters group relies on voice phishing techniques to trick company employees into granting them access to their cloud-based Salesforce databases.

Google said the ShinyHunters group is likely preparing a data leak site, which some ransomware gangs use to publish stolen data to extort their corporate victims into paying a ransom. The group is said to have overlaps with other groups, including The Com, a known collective of cybercriminals who use hacking, extortion and sometimes threats of violence to break into networks.

Two arrested for smuggling AI chips to China; Nvidia says no to kill switches

HE U.S. Department of Justice (DOJ) said on Tuesday that two Chinese nationals have been arrested for their alleged involvement in illegally shipping "tens of millions of dollars" worth of high-performance AI chips to China.

The DOJ said Chuan Geng and Shiwei Yang were arrested in California on August 2 and charged with violating the Export Control Reform Act, a felony that carries a statutory penalty of a maximum of 20 years in prison.

Geng and Yang are accused of knowing and willfully shipping "sensitive technologies," including GPUs, to China from the U.S. through their California-based company, ALX Solutions.


The DoJ did not name the company whose chips ALX Solutions was allegedly smuggling, but quoting a complaint, it said the chip is "the most powerful chip in the market" and is "designed specifically for AI applications." That description makes it likely that the chips being smuggled were made by Nvidia. A report by Reuters specifically named Nvidia's H100 GPUs as

the chips being shipped.

A review of export documents by the DOJ found that ALX Solutions sent chips and other tech to shipping and freightforwarding companies in Singapore and Malaysia, but received payments from entities in Hong Kong and China in return. The department also found records of communication regarding shipping the tech to Malaysia to specifically go around U.S. export restrictions.

"This case demonstrates that smuggling is a nonstarter," an Nvidia spokesperson said in a statement. "We primarily sell our products to well-known partners, including OEMs, who help us ensure that all sales comply with U.S. export control rules. Even relatively small exporters and shipments are subject to thorough review and scrutiny, and any diverted products would have no service, support, or updates."

The news comes as the U.S. tries to figure out how to strike a balance between fostering global AI innovation and imposing export restrictions to China, which many in the West perceive to be a major threat in the AI race. (**TechCrunch**)

Microsoft brings OpenAI's smallest open model to Windows users

MICROSOFT is making OpenAI's new free and open GPT model, gpt-oss-20b, available to Windows 11 users via Windows AI Foundry, the tech giant's platform that lets users tap AI features, APIs, and popular open-source models on their computers.

The company said in a blog post that gpt-oss-20b is "tool-savvy and lightweight," adding: "Optimized for agentic tasks like code execution and tool use, it runs efficiently on a range of Windows hardware, with support for more devices coming soon. It's perfect for building autonomous assistants or embedding AI into real-world workflows, even in bandwidth-constrained environments."

Launched on Tuesday, OpenAI's gpt-oss-20b can run on consumer PCs and laptops with at least 16GB of VRAM, which a modern GPU from Nvidia or Radeon would have. OpenAI said the model was trained using high-compute reinforcement learning, which helps it excel at powering AI agents and call tools, such as web search or Python code execution, as part of its chain-of-thought process.

However, the model is text-only, meaning it will not be able to process or generate images and audio like the company's other models.

Also, the model has a habit of hallucinating a lot: gpt-oss-20b hallucinated in response to 53% of questions on PersonQA, OpenAI's in-house benchmark for measuring the accuracy of a model's knowledge about people. Microsoft says it will bring the model to macOS soon, as well as other devices, though the company did not name any more. Microsoft is also making both gpt-oss-20b and older model gpt-oss-120b available via its hosted Azure AI Foundry platform. (**TechCrunch**)

"Thousands of students continue to face uncertainty due to delayed NSFAS accommodation payments and the absence of a sustainable student housing funding model," said Mamabolo.

He said that the housing sector was challenged when it comes to affordability and quality gaps. The capped NSFAS allowances needed to be discussed, he added.

He said the sector will not be able to offer affordable, decent, and legal housing unless serious changes are made soon.

The association's Mmabatho Sebake told Sunday World that they are still engaging with NSFAS to address the issues. She said they have built a constructive and respectful working relationship.

"As an association, we remain steadfast in our commitment to placing the wellbeing and safety of students at the heart of all our efforts. Their welfare is not merely a priority for us. It is the guiding principle that shapes our advocacy, decision making, and collaborative engagement," said Sebake.

In response, NSFAS denied the alleged debt from January 2024 to July 2025.

NSFAS released a statement highlighting that they do not pay the association but landlords directly. It also said the PHSA has not provided a full breakdown of the alleged

outstanding claims.

NSFAS explained that it only processes payments for claims that have passed all verification steps.

They emphasised that delays in payment may happen when students are not funded. Or when their registration data is missing, or institutions have not confirmed the claims.

According to the statement, NSFAS paid over R744-million to landlords in April 2025 to help reduce arrears. It also denied that it has run out of money, saying that all payments depend on valid and confirmed claims. The organisation claimed to be working with institutions to prevent problems like student evictions.

It also confirmed that it is reviewing the role of third-party middlemen in the payment process. And it promised to improve transparency and efficiency.

Gunmen abduct 60 in Nigeria, kill villagers in overnight raids

GUNMEN abducted at least 45 women and children in an overnight raid on five villages in northwest Nigeria, witnesses said, in the second mass kidnapping in the area within days.

The attackers returned to Sabongarin Damri on Monday and raided nearby villages including Sade, Tungar Tsalle, Tungar Sodangi and Tungar Musa Dogo, in an assault that lasted until dawn, Shehu Musa, the traditional head of Damri, told Reuters by phone late on Tuesday.

The incident followed a separate mass abduction in Sabongarin Damri, in Zamfara state, on Saturday in which 70 people were taken.

"The attackers invaded the communities and kidnapped no fewer than 45 people from the five neighbouring villages, which are less than half a kilometre apart," Musa said.

Armed groups, often referred to locally as "bandits", have killed hundreds and abducted thousands across Nigeria's northwest in recent years. They typically hold captives for extended periods, demanding ransoms for their release.

Security forces engaged the assailants during Monday's attack, killing three, but were unable to stop the bandits from fleeing with hostages and rustling cattle. Civilian casualties were reported, though the number of fatalities was unconfirmed.

"They mostly kidnapped women and children after killing some of our people," said Hassan Dauda, a resident of Tungar Tsalle. "As I'm speaking to you now, some residents have started fleeing their community due to fear."

Separately, Boko Haram militias attacked the remote Kennari village, in the Damasak area of the northeastern Borno state, on Monday, abducting at least 15 people and killing one person, according to a security report seen by Reuters.

Modu Bukar, a resident, said the assailants killed the village head and demanded a 30 million naira (\$19,650) ransom for the release of the captives. (**Reuters**)

Gauteng portfolio committee wants accountability after suspensions of HOD, CFO

THE Gauteng provincial legislature's portfolio committee on community safety has welcomed the suspension of two high-ranking officials following the outcomes of a forensic audit.

On Tuesday, Premier Panyaza Lesufi suspended Mduduzi Malope, the chief financial officer (CFO), and Nontsikelelo Sisulu, the head of the department (HOD) of community safety.

They were suspended following the outcome of a probe conducted by the provincial forensic audit unit in Lesufi's office, which uncovered serious financial irregularities within the department.

Dr Bandile Masuku, the committee's chairperson, praised Lesufi's disciplinary actions.

"As the oversight body for the department of community safety, the committee views this development with serious concern, particularly as both the head of the department and the chief financial officer regularly appear before the committee to present reports on the department's financial performance.

"No indications of such irregularities were evident during these engagements, which raises important questions about the effectiveness of current oversight mechanisms," said Masuku.

Review of oversight model recommended Additionally, the committee has called on the legislature to strengthen and review its sector oversight model in order to ensure that departmental financial performance is monitored more closely.

"This includes ensuring that committees implement more robust accountability measures and intensify efforts to detect and prevent financial mismanagement.

"The committee strongly condemns any acts of corruption or financial misconduct within public institutions, especially within a department whose core mandate is to safeguard the lives and wellbeing of the people of Gauteng.

"Those entrusted with positions of

authority must uphold the highest standards of integrity and service," said Masuku.

Crezane Bosch, the DA's member of the provincial legislature responsible for community safety, expressed her party's dismay regarding the delayed suspension of Sisulu and Malope. (Sunday World)

Musk vs. Modi: Inside the battle over India's internet censorship

IN January, an old post on Elon Musk's social media platform, X, became a concern for police in the Indian city of Satara. Written in 2023, the short message from an account with a few hundred followers described a senior ruling-party politician as "useless".

"This post and content are likely to create serious communal tension," inspector Jitendra Shahane wrote in a contentremoval notice marked "CONFIDENTIAL" and addressed to X.

The post, which remains online, is among hundreds cited by X in a lawsuit it filed in March against India's government, challenging a sweeping crackdown on social media content by Prime Minister Narendra Modi's administration.

Since 2023, India has ramped up efforts to police the internet by allowing many more officials to file takedown orders and to submit them directly to tech firms through a government website launched in October.

X argues India's actions are illegal and unconstitutional, and that they trample free speech by empowering scores of government agencies and thousands of police to suppress legitimate criticism of public officials.

India contends in court documents that its approach tackles a proliferation of unlawful content and ensures accountability online. It says many tech companies, including Meta and Alphabet's Google, support its actions. Both companies declined to comment for this story.

Musk, who calls himself a free-speech absolutist, has clashed with authorities

in the United States, Brazil, Australia and elsewhere over compliance and takedown demands. But as regulators globally weigh free-speech protections against concerns about harmful content, Musk's case against Modi's government in the Karnataka High Court targets the entire basis for tightened internet censorship in India, one of X's biggest user bases. Musk said in 2023 that the South Asian nation had "more promise than any large country in the world" and that Modi had pushed him to invest there.

This account of the behind-the-scenes battle between the world's richest person and authorities in the world's most populous country is based on a Reuters review of 2,500 pages of non-public legal filings and interviews with seven police officers involved in content-removal requests. It reveals the workings of a takedown system

shrouded in secrecy, some Indian officials' ire over "illegal" material on X, and the broad spectrum of content that police and other agencies have sought to censor.

While the takedown orders include many that sought to counter misinformation, they also encompass directives by Modi's administration to remove news about a deadly stampede, and demands from state police to scrub cartoons that depicted the prime minister in an unfavourable light or mocked local politicians, the filings show.

X didn't respond to Reuters questions about the case, while India's IT ministry declined to comment because the matter was before the court. Modi's office and his home ministry didn't respond to questions.

There have been no immediate signs of souring personal relations between Musk and Modi, who have enjoyed a warm public rapport. But the showdown comes as the South African-born entrepreneur, whose business empire includes EV maker Tesla and satellite internet provider Starlink, gears up to expand both ventures in India.

Even supporters of Modi's Bharatiya Janata Party (BJP) have faced scrutiny of their online musings from police officials newly empowered by the IT ministry to target social media activity.

Koustav Bagchi, a lawyer and BJP member, posted an image on X in March that depicted a rival, West Bengal chief minister Mamata Banerjee, in an astronaut suit. State police issued a takedown notice, citing "risks to public safety and national security".

Terrible thirst hits Gaza with polluted aquifers and broken pipelines

WEAKENED by hunger, many Gazans trek across a ruined landscape each day to haul all their drinking and washing water - a painful load that is still far below the levels needed to keep people healthy.

Even as global attention has turned to starvation in Gaza, where after 22 months of a devastating Israeli military campaign a global hunger monitor says a famine scenario is unfolding, the water crisis is just as severe according to aid groups.

Though some water comes from small desalination units run by aid agencies, most is drawn from wells in a brackish aquifer that has been further polluted by sewage and chemicals seeping through the rubble, spreading diarrhoea and hepa-

COGAT, the Israeli military agency responsible for coordinating aid in the Israeli-occupied Palestinian territories, says it operates two water pipelines into the Gaza Strip providing millions of litres of water a day.

Palestinian water officials say these have not been working recent-

Israel stopped all water and electricity supply to Gaza early in the war but resumed some supply later

though the pipeline network in the territory has been badly damaged.

Most water and sanitation infrastructure has been destroyed and pumps from the aquifer often rely on electricity from small generators - for which fuel is rarely available. COGAT said the Israeli military has allowed coordination with aid organisations to bring in equipment to maintain water infrastructure throughout the conflict.

Moaz Mukhaimar, aged 23 and a university student before the war, said he has to walk about a kilometre, queuing for two hours, to

fetch water. He often goes three times a day, dragging it back to the family tent over bumpy ground on a small metal handcart.

"How long will we have to stay like this?" he asked, pulling two larger canisters of very brackish water to use for cleaning and two smaller ones of cleaner water to drink.

His mother, Umm Moaz, 53, said the water he collects is needed for the extended family of 20 people living in their small group of tents in Deir al-Balah in the central Gaza

Russia says Putin and witkoff hold 'useful' talks

U.S. envoy Steve Witkoff held and constructive" talks with Russian President Vladimir Putin on Wednesday, a Kremlin aide said, two days before the expiry of a deadline set by President Donald Trump for Russia to agree to peace in Ukraine or face new sanctions.

Witkoff met Putin for around three hours on a last-minute mission to seek a breakthrough in the 3-1/2-year war that began with Russia's full-scale invasion of

Kremlin foreign policy aide Yuri Ushakov said the two sides had exchanged "signals" on the Ukraine issue and discussed the possibility of developing strategic cooperation between Moscow and Washington, but declined to give more details until Witkoff had reported back to Trump.

Russian investment envoy Kirill Dmitriev, who earlier greeted Witkoff on arrival and strolled with him in a park near the Kremlin, posted on social media: "Dialogue will prevail."

There was no immediate comment from the U.S. side.

Trump, increasingly frustrated with Putin over the lack of progress towards peace, has threatened to impose heavy tariffs on countries that buy Russian exports.


Histo's 'Makoti Longeva' hits 30 000 views

'DJ Sumbody murder accused Katiso Molefe involved in drug trade'

KATISO Molefe, the businessman and alleged mastermind of the murder of music producer and club owner Oupa John Sefoka, also known as DJ Sumbody, is actively involved in the illicit trade of drugs.

Molefe's involvement in the illicit drug trade is supported by evidence from his bank statements showing unidentified sources of income.

This information was revealed by the state on Wednesday during the formal bail application of Molefe, 61, at the Alexandra Magistrate's Court. The state is opposing Molefe's bail application.

Molefe and three alleged hitmen, Michael Pule Tau, 55, Musa Kekana, 35, and Tiego Floyd Mabusela, 47, have been charged in relation to the murders of DJ Sumbody and his two bodyguards, Sibusiso Mokoena and Sandile Myeza.

The four men are facing charges of three counts of murder, two counts of unlawful possession of a firearm, and one count of unlawful possession of ammunition in connection with the murders of DJ Sumbody, Mokoena and Myeza in November 2022.

DJ Sumbody, Mokoena, and Myeza were shot and killed by unknown men while travelling in their cars. This happened on November 20 2022 on the corner of Woodmead and Woodland drives in Sandton, Johannesburg.

During court proceedings on Wednesday, Molefe appeared in leg chains to bring his bail application.

Molefe's lawyer, Adv Michael Hellens SC, read Molefe's bail affidavit in court.

Hellens said Molefe should be granted bail because he has not violated his bail conditions. This was with regards to bail he received in June this year on a separate matter.

He said Molefe was arrested in December 2024 at his Sandton, Johannesburg, home. The arrest was for the April 2024 murder of Vereeniging engineer Armand Swart. Hellens said Molefe was denied bail by the Vereeniging Magistrate's Court in April this year.

However, on appealing the bail decision, Hellens said the Pretoria High Court, through now Acting Gauteng Judge President Aubrey Ledwaba, granted Molefe bail on June 27 2025.

Hellens said from the time of being released on bail in June this year until the time of his arrest on July 21 2025 for the murder of DJ Sumbody, Molefe never violated

his bail conditions.

In reply, the state prosecutor said the Pretoria High Court decision is not relevant in this particular case.

The state prosecutor was reading the affidavit of the lead investigating officer in the case. The latter cannot be named because she is under 24-hour protection by the police task force.

In a bid to oppose Molefe's bail, the investigating officer's affidavit stated that Molefe is actively involved in illicit drug trade. And that he killed DJ Sumbody and his friend Hector "DJ Vintos" Buthelezi due to the illicit drug trade.

The prosecutor said Molefe's bank statements showed that he has unidentified sources of income. He said Molefe's bank statements showed that he has made cash deposits whose purpose could not be identified.

"The applicant [Molefe] is a dangerous criminal with no regard for human life," said the prosecutor.

After the presentation of the

After the presentation of the state's case, Hellens asked magistrate Renier Boshoff to postpone the matter.



Sleep apnea may hurt your kidneys in part by preventing your body from getting enough oxygen. CKD in turn may cause sleep apnea by narrowing your throat, toxin buildup, and other ways.

This may happen if your kidneys can't flush out toxins and they build up in your blood. That can cause a rash or make you itch all over. Swollen Face and Feet



Cramps in your legs and elsewhere can be a sign of poor kidney function. Imbalance in the levels of sodium, calcium, potassium, or other electrolytes can interrupt how your muscles and nerves work.

Breathlessness

When you have kidney disease, your organs don't make enough of a hormone called erythropoietin. The hormones signal your body to make red blood cells. Without it, you can get anemia and feel short of breath. Another cause is fluid buildup.



What does this mean?

Banks are expected to maintain the prime lending rate on loans extended to individuals and businesses at **10.25 per cent** until the next monetary policy meeting.

Inflation

Headline inflation decreased to 2.9 per cent in June 2025 from **3.2 per cent** in May 2025.

What to expect?

The CBE expects the cost of goods and services to increase moderately in 2025. The Bank revised down its inflation forecast for 2025 to 3.49 per cent (from 3.66 per cent forecasted in May 2025).

Economic Activity

Eswatini's Quarterly Gross Domestic Product (GDP) recorded a year-onyear decline of 0.3 per cent (seasonally adjusted) in the first quarter of 2025, compared to a revised growth of 1.7 per cent in the previous quarter.

Monetary Policy Statement

1 August 2025

On the 1st August 2025, the Central Bank of Eswatini (Bank), together with the Monetary Policy Consultative Committee (MPCC) held a meeting to consider the appropriate monetary policy stance. Taking into consideration relevant global, regional, and domestic economic factors; as well as the price and financial stability mandate, the Bank decided to maintain the discount rate at 6.75 per cent.

On the global front, the IMF has marginally revised up the economic growth outlook to 3.0 per cent (from 2.8 per cent forecasted in April 2025) for 2025 and 3.1 per cent (from 3.0 per cent) for 2026. Economic growth in advanced economies has been revised up by 0.1percentage point for both 2025 and 2026 to 1.5 per cent and 1.6 per cent $respectively.\ Growth in emerging\ markets\ and\ developing\ economies\ has\ been\ revised\ up\ to\ 4.1\ per\ cent\ (from\ 3.9\ per\ continuous)$ cent) for 2025 and 4.0 per cent (from 3.9 per cent) for 2026. Global headline inflation depicts mixed trajectories, and the IMF kept the global inflation outlook steady at 4.2 per cent for 2025 and 3.6 per cent for 2026. Interest rates have somewhat eased, and the IMF broadly projects further cuts before the end of the year.

On the regional front, the South African economy expanded by 0.1 per cent in the first quarter of 2025, quarter-onquarter, following a growth of 0.4 per cent in the previous quarter. The South African Reserve Bank (SARB) revised down its growth forecast to 0.9 per cent (from 1.0 per cent forecasted in May 2025) for 2025 and 1.3 per cent (from 1.5 per cent) for 2026. South Africa's inflation slightly increased to 3 per cent in June 2025 from 2.8 per cent in the previous month. The SARB kept its inflation forecast steady at 3.3 per cent for 2025 while the medium-term forecasts were reviewed down to 3.3 per cent (from 4.2 per cent) for 2026 and 3.0 per cent (from 4.4 per cent) for 2027. The SARB reduced the reporate from 7.25 per cent to 7.0 per cent during its 31st July 2025 meeting.

On the domestic front, Eswatini's quarterly gross domestic product recorded a year-on-year decline of 0.3 per cent (seasonally adjusted) in the first quarter of 2025, compared to a revised growth of 1.7 per cent in the previous quarter. This negative growth performance was largely driven by poor performance in the primary sector which contracted by 7.3 per cent in the first quarter of 2025 from a growth of 7.2 per cent in the fourth quarter of 2024 and the secondary sector which also contracted by 10.2 per cent in the quarter ended March 2025, from 4.5 per cent in the previous quarter. The tertiary (services) sector, rebounded strongly with a year-on-year growth of 7.2 per cent in the first quarter of 2025, up from 0.4 per cent in the previous quarter. On a quarter-on-quarter basis, economic activity grew by 0.5 per cent (seasonally adjusted), from a revised contraction of 1.6 per cent in the previous quarter.

Headline consumer inflation eased to 2.9 per cent in June 2025 from 3.2 per cent in May 2025. This disinflation was largely driven by declining price pressures in key categories, namely; 'food & non-alcoholic beverages' index which grew by a slower 2.3 per cent in June 2025 from 3.2 per cent in the previous month, 'transport' index which registered a 0.3 per cent deflation in June 2025, from 0.5 per cent in May, and the index for 'restaurants & hotels' which recorded a decline of 8.5 percentage points. Counteracting the above downward pressures were increases in the price indices for 'housing & utilities' which grew by 0.5 of a percentage point to 4.2 per cent in June 2025 and 'household furniture & maintenance' which increased from 2.0 per cent to 3.0 per cent. The Bank revised down its short-term inflation forecast to 3.49 per cent (from 3.66 per cent forecasted in May) for 2025 on account of a lower food inflation outturn, stronger exchange rate assumption and the lower oil prices. In the medium term, the Bank revised down its inflation forecast to 3.95 per cent (from 4.05 per cent) for 2026 and 3.71 per cent (from 3.92 per cent) for 2027.

Credit extended to the private sector marginally decreased by 0.05 per cent month-on-month to close at E21.6 billion in June 2025. Credit to the business sector fell by 2.2 per cent month-on-month to E11.7 billion at the end of June 2025 and credit extended to other sectors of the economy also contracted by 2.9 per cent to E1.0 billion over the review period. The banking sector's loan book registered an improvement month-on-month as none performing loans (NPLs) fell by 1.9 per cent to close at E1.3 billion in June 2025. The NPL ratio rose by 0.3 percentage points year-on-year to reach 7.0 per cent in June 2025.

As of 25th July 2025, gross official reserves stood at E11.8 billion equivalent to an import cover of 3.0 months. At the end of June 2025, total public debt stood at E38.4 billion from E36.6 billion in May 2025, depicting an increase of 4.9 per cent. At this level, it is equivalent to 40.2 per cent of GDP.

In taking the decision, the Bank cautiously considered the credibility of the peg against the South African Rand and the need to ensure adequate gross official reserves. The Bank will continue to monitor international, regional and domestic developments that influence the movements of inflation and will act appropriately in line with its mission to foster price and financial stability that is conducive to the economic development in Eswatini. Furthermore, the Bank is currently reviewing its policy toolkit and will announce in due course other policy actions that will be taken to support the Bank's mandate.

Nabi awaits confirmation if Sundowns striker will join team

KAIZER Chiefs coach Nasreddine Nabi is waiting for the club to confirm whether he will get one of his top targets, Etiosa Ighodaro, or if they will go for a different striker.

Amakhosi have been active in the transfer market, making six signings so far, with the club also confirming that more players will be recruited to bolster Nabi's squad.

Tuesday, Nabi shed some light on Ighodaro, saying that he is a striker the club has been looking at but is waiting for management to confirm whether he will land the player.

"That player [Ighodaro] belongs to another team with administrative issues, but he or another striker that we listed on our transfer list will be welcomed," Nabi said.

"For now, we will wait to hear from our administration if he or another striker will join.

"I saw the player you are asking about, who was playing for AmaZulu last season, and I believe he is a good player; however, he does not belong to our club, so we can't say much about him."

Amakhosi's six signings include Ethan Chislett, Siphesihle Ndlovu, Nkanyiso Shinga, Flavio Silva, and former Orlando Pirates defensive duo Thabiso Monyane and Paseka

Stadium Management offers update on new FNB Stadium pitch

STADIUM Management South Africa CEO Bertie Grobbelaar has provided an update on the state of the FNB Stadium pitch, which has undergone a makeover during the off-season in order to host Betway Premiership matches.

The iconic 2010 FIFA World Cup venue serves as the home ground for Kaizer Chiefs, who kick off their 2025/26 Betway Premiership campaign away to Stellenbosch FC at Athlone Stadium on Sunday.

Following the trip to the Mother City to take on Stellies, Amakhosi are scheduled to return to FNB Stadium next Wednesday to host Polokwane City, followed by another home tie against Richards Bay six days later.

"A lifespan of a GrassMaster pitch is anything between 10, 12 to 15 years depending on the usage. We didn't run away last year, we got experts who advised us the FNB pitch is beyond its lifespan and that we have to replace it," Grobbelaar said to Thabiso Mosia on Radio 2000. "We couldn't do it mid-season and had to wait until the end of the season. It was a bad playing surface towards the

end of the season. They took out the pitch, did the work, maintenance and renovations.

"As I said to you, they are halfway with the stitching now, and the GrassMaster machine is on the pitch as we speak. So it's not about the point of not caring about it."

When pressed about whether the stadium will be ready to host Chiefs' upcoming fixtures, starting with the clash against City, Grobbelaar admitted that the surface still has some bit of patches after work was done on it. "We're hosting the first game on the 13th (August) and you're going to ask me again why is the northern side not as good as other sides," he said.

"On the northern side, it (will still) have a bit of patchiness for about two weeks and it will be fully grown in. As a stakeholder in the football industry, we must play our role as venues. A football page is dependent on a good playing surface.

"For the spectacles that we anticipate this year, we all need to play our roles. I do understand it (the public frustration) but, as I said to you, not all pitches are hybrid. With the Kikuyu pitches, there is a problem with the change of the season." FNB Stadium is a multi-purpose venue and frequently hosts major music concerts, with the most recent being American R&B superstar Chris Brown, who performed in front of over 90,000 fans. Grobbelaar acknowledged that such events contribute to the challenge of keeping the pitches in top condition.

"Most of the stadiums rely on other events as well. If you only maintain a pitch to play football, then that's a different story, but the minute you've got concerts and other events on the pitches, the maintenance and keeping it up to standard becomes a challenge," he explained. "We need to find the balance to be commercially viable and still deliver good surfaces for playing football. It is a challenge and no one can run away from that, but the venues need to also accept responsibility. "That is the problem and it's not commercially viable to only have football at the stadium. I can't speak for others, but a stadium like FNB, you won't be able to maintain the facility without it being used as a multi-purpose venue."

Springboks will be eager to make a statement in Rugby Championship

The Springboks will be looking to stamp their authority during the Rugby Championship and hammer home their status as the top team in world rugby and the side to beat heading towards the Rugby World Cup in Australia in 2027.

The Boks superbly backed up their 2023 World Cup triumph in France with a fantastic 2024, in which they won 11 out of 13 games, won the full (double round) Rugby Championship for the first time, and enjoyed an unbeaten end-of-yeartour to the UK.

Their two losses came in one-point thrillers, with Ireland needing a drop goal after the fulltime hooter to win in Durban, while a fringe side was edged by Los Pumas in Argentina.

With coach Rassie Erasmus and his management team continuing to evolve the Boks and strengthen their depth, they now have a great chance to make a big statement to the rest of the world in 2025 that they are seriously going for the three-peat in 2027.

It has been an underwhelming start to the season for the Boks, as they have yet to be seriously challenged, so they may be heading into the Rugby Championship a tad undercooked. They crushed a well-known but ageing invitational Barbarians side 54-7 in their opening match, before easily dispatching Italy 42-24 and 45-0, and then cruising to a 55-10 win over second-tier Georgia. With the opposition not the strongest, the Boks took the opportunity to give fringe players game time, tried out some combinations and mixed it up with some innovative plays during their four matches so far.

Wallabies up next

However, they now head into the meat of the season, and defending their Rugby Championship title will be at the top of their agenda.

Starting off at home against the Wallabies is probably the perfect way for them to build up a head of steam, heading into a huge two-game tour of New Zealand against the All Blacks. Australia are not the strongest opposition, but they look to be a much improved team from last year when the Boks dispatched them easily 33-7 and 30-12 Down Under.

They will also have plenty of momentum and motivation after an impressive showing against the British and Irish Lions, where despite losing the series 2-1, they were very unlucky to lose the second Test and won the admittedly dead rubber finale over the past weekend.

So they definitely can't be underestimated, but if the Boks can up their game from what they have produced so far this season, they should be able to comfortably deal with them on home turf. Rest of the season If they can start as expected, with two bonus-point wins against the Wallabies, that will set up their tour to New Zealand, where the Boks will be chasing a famous win over the All Blacks in Auckland, as well as in Wellington. The final two games of the Rugby Champs are against Argentina in Durban, and at Twickenham in England to close out the competition, and if they have sewn up the championship by then, they may use that game to shake things up a bit. US government restricts sports visas for transgender women

THE U.S. Citizenship and Immigration Services announced on Monday it has updated its immigration policy to restrict visa eligibility for transgender women seeking to compete in women's

Under the policy update, USCIS will consider "the fact that a male athlete has been competing against women" as a negative factor when evaluating visa petitions in categories such as O-1A for extraordinary ability, EB-1 and EB-2 green cards for highly skilled workers, and national interest waivers.

"USCIS is closing the loophole for foreign male athletes whose only chance at winning elite sports is to change their gender identity and leverage their biological advantages against women," said USCIS spokesperson Matthew Tragesser.



"It's a matter of safety, fairness, respect, and truth that only female athletes receive a visa to come to the U.S. to participate in women's sports." The move aligns with broader efforts by the administration of U.S. President Donald Trump to regulate transgender participation in athletics and follows similar policies enacted at the state level across the

runners was so special -- I think Flo has this quality as well in a totally different position."

Liverpool paid tribute to late forward Diogo Jota in their first matches at Anfield since the forward and his brother Andre Silva died in a car crash in Spain last month. Slot said in his programme notes that it had been a "tough time for everyone connected with the club, but especially for Diogo's family, his wife, his children and friends".

"We cannot imagine the pain that they have been going through, and the club will continue to give them all the support they can going forward," he wrote.

"We will always carry him with us in our hearts, in our thoughts, wherever we go." (AFP)



Arsenal have 'belief' to end trophy drought, says Arteta

ARSENAL manager Mikel Arteta said the Gunners believe this season will be different as they aim to get over a series of near misses at winning silverware.

Arteta has not won a trophy since lifting the FA Cup in his debut season in charge in 2019/20.

However, he has transformed Arsenal back into serial contenders for major trophies.

Arteta's men have finished second in the Premier League for the past three years and reached the Champions League semifinals for the first time since 2009 last season.

The pressure is now on the Spaniard to get over the line after another major investment in new players in the transfer window. Nearly £200 million (\$266 million) has been spent on new striker Viktor Gyokeres, midfielders Martin Zubimendi and Christian Norgaard, centre-back Cristhian Mosquera as well as winger Noni Madueke and goalkeeper Kepa Arrizabalaga.

"We know what our targets are and what we want to achieve this season - there is a big belief in our ability to achieve that," Arteta said in his programme notes ahead of Wednesday's pre-season friendly against Villarreal. "We have been very, very close the last few seasons and the whole team is going to determine whether we achieve that

"But at the same time, we have to make sure that we don't lose sight of what we have to do on a daily basis to get to the levels that we want.

"We have to set the demands that we want within this goal, because that's the most important thing - the internal demands have to always exceed any external demand. That is what we are trying to achieve every single day."

Arteta added he wants his players to feel "invincible" at home thanks to a special connection with the club's fans. "We want our people to start connecting with our players straight away, to start to build momentum and to start to feel that at home we are invincible," he said.

"That we play here with such passion, energy and connection with our people, that we are going to win the game."

Arsenal begin their Premier League campaign with a blockbuster trip to Manchester United on 17 August . (AFP)

Isak told to train alone by Newcastle

ALEXANDER Isak's future at Newcastle hangs in the balance after the Swedish striker was reportedly told to train apart from the rest of the squad on Wednes-

The 25-year-old has been linked with a British transfer record move to Liverpool after failing to feature in Newcastle's pre-season preparations. Isak missed the Magpies' trip to Singapore and South Korea, citing a minor thigh injury, and instead flew to Spain to train at former club Real Sociedad.

He has since returned to Tyneside but Sky Sports reported that Isak was instructed to train after the rest of the squad had departed on Wednesday. "You have to earn the right to train with us. We are Newcastle United," manager Eddie Howe told reporters earlier in pre-season. "We will make sure that any player earns the right to train with the group. No player can expect to act poorly and train with the group as normal."

Liverpool have seen a £110 million bid for Isak rejected, according to reports, with Newcastle seeking closer to £150 million. Another major hurdle to any deal is Newcastle's ongoing struggles to finalise a deal to replace Isak. They face competition from Manchester United for RB Leipzig striker Benjamin Sesko after missing out on Joao Pedro, Hugo Ekitike and Liam Delap earlier in the window. Liverpool have already splashed out over £250 million this window on Ekitike, Florian Wirtz, Milos Kerkez and Jeremie Frimpong.
