EEC faces financial strain amid rising procurement costs

THE Eswatini Electricity Company (EEC) is navigating a complex financial landscape as it strives to balance customer service with the rising costs of electricity procurement.

With a customer base of nearly 299,000, including 277,312 domestic users and 20,582 small commercial enterprises, the EEC is poised to play a pivotal role in the nation's economic stability.

However, the financial projections for the upcoming fiscal year reveal significant challenges that could impact both operations and customer tariffs.

Ernest Mkhonta, Managing Director of EEC, stated, "As we look ahead to the 2024/25 financial year, we anticipate energy sales reaching 1,181 GWh, which is crucial for sustaining our operations and meeting the growing electricity demand."

The current national population is estimated at 1.231 million, and with electricity access having increased to 82 per cent by

March 2024, the EEC is focused on expanding this access to 88 per cent by March 2025.

Despite these optimistic projections, the financial outlook for the EEC raises concerns.


The company expects the National Transmission System Charge Account (NTSCA) bill to surpass E200 million monthly, while total power procurement costs are projected to be around E235 million.

Mkhonta elaborated on this, saying, "Our monthly sales revenue averages E252 million, but with procurement costs soaring, we are facing a cash position that will be highly overdrawn in the coming months."

The financial strain is evident in the projections that indicate a significant decline in the company's bank balance, which is expected to drop from E48 million in June 2025 to a staggering deficit of over E292 million by September 2025.

This alarming forecast underscores the need for immediate strategic adjustments.

In its unaudited figures for 2024/25, EEC reported energy sales of 1,181 GWh and a sales revenue generation of E2.95billion. However, the reliance on imported power, which constitutes 1,084 GWh of total energy

supply, raises questions about sustainability and cost-effectiveness. Mkhonta emphasised, "While local power generation stands at 280 GWh, our dependence on imports makes us vulnerable to fluctuations in global energy prices."

To address these financial challenges, the EEC has proposed tariff increases exceeding 25% per year.

However, the government has only approved increases of 8 per cent for FY2025/26 and 7 per cent for FY2026/27, which Mkhonta acknowledged as insufficient.

"The approved tariff increases do not align with our operational costs and the necessary investments in infrastructure," he noted. This discrepancy could lead to further financial strain on the company and potentially affect service delivery to customers.

The company's commitment to large commercial clients remains strong, as they are viewed as the backbone of Eswatini's economy. Mkhonta stated, "We recognise the importance of our large customers and are dedicated to providing them with reliable electricity, which is essential for their operations and the overall economic growth of the country."

As the EEC prepares for the upcoming financial year, the focus on maintaining and expanding electricity access while managing costs will be critical. With nearly 803 employees and an additional 1,050 contractors, the company is not only a significant employer but also a vital component of the nation's infrastructure.

Fuel prices expected to drop in September


MOTORISTS in South Africa could see some relief at the pumps next month, with early forecasts pointing to a reduction in petrol prices for September

According to the Central Energy Fund (CEF), indicators suggest that petrol prices may drop by between five and 10 cents per litre. The announcement, published on the CEF's website, comes as part of ongoing updates based on global oil price movements and the rand-to-dollar exchange rate.

If confirmed, the decrease would mark the continuation of a downward trend in fuel prices, a welcome development for consumers grappling with persistent high living

The reduction could ease financial pressure on households, particularly those reliant on private transport and businesses with fuel-dependent operations.

Economic analysts note that while the projected drop is relatively modest, even small reductions can have a cumulative impact, especially when combined with previous price cuts. They also caution that market



volatility, geopolitical factors, and fluctuations in international oil prices could still affect the final adjustment before it is officially announced by the Department of Mineral Resources and Energy (DMRE).

The official September fuel price changes

are expected to be confirmed at the end of August, with the new prices taking effect on the first Wednesday of the month.

Alleged Goje township murder accused in fresh bail fight

DEPUTY Sheriff Vusi Mncina, accused of killing four women in Ezulwini in 2023, is back in court seeking bail, arguing that delays in his trial amount to 'new facts' that should secure his release.

Mncina is facing multiple counts of murder after the shooting incident at Goje Township in 2023, where his girlfriend and three other women were killed during the early hours of the morning.

The women were reportedly attending a gathering when the accused allegedly opened fire.

Following the incident, Mncina handed himself over to the police. His arrest and the nature of the charges drew widespread public attention due to both his position as a Deputy Sheriff and the number of victims involved.

In his latest bail application, Mncina's defence team told the court that the prolonged delay in bringing the matter to trial was infringing on his constitutional right to a speedy trial.

They submitted that the stalled proceedings constituted new facts, and that the accused should be granted bail under these changed circumstances.

The Crown opposed the applidown its ruling on the application at cation, arguing that no substantive new evidence had been presented to alter the court's previous bail ruling.

Prosecutors maintained that the seriousness of the offences, the potential flight risk, and the need to ensure justice for the victims justified continued detention.

The prosecution also pointed out that while delays had occurred, they were not unusual in complex murder cases involving multiple victims and witnesses.

The court is expected to hand

a later date.

The killings occurred at Goje Township, Ezulwini, in 2023. It is alleged that Mncina confronted his girlfriend and the other women over accusations of infidelity before fatally shooting them.

Police said at the time that the victims were pronounced dead at the scene. Superintendent Phindile Vilakati of the Royal Eswatini Police Service had not responded to a questionnaire on the case at the time of publication.

Minister launches future pioneers STEM Mentorship programme to empower youth

Interested youths are encouraged to register via the online application form provided by the Ministry, with slots available for various mentorship tracks.

"This program is a gateway for the youth to not only dream but to actively participate in building a modern, innovative Eswatini," Minister Maziya concluded.

Woman stabs her allegedly cheating husband

A WOMAN has been arrested for stabbing her husband with a sharp object.

Ntombifuthi Shabangu appeared on Monday before Principal Magistrate Florence Msibi at the Manzini Magistrates Court.

She was charged with contravening the Sexual Offences and Domestic Violence Act after she allegedly stabbed her husband, Senzo Shaban-

She was not made to plead during her court appearance, but rather, she was remanded in custody until August 19, 2025.

She applied for bail and was granted a fine fixed at E2 000.

Meanwhile, according to statements recorded and submitted before the court, Ntombifuthi alleged that she committed the offence in self-defence following her husband's alleged extramarital affair.

She alleged that her husband was in love with a certain teacher and had a tendency to invite her girlfriend to family gatherings from



time to time and some of the family members would advise him to desist from doing so, but their counsel would fall on deaf ears.

She alleged that on the day the offence was committed, they had a family event that was taking place and as per his custom, her husband allegedly invited his girlfriend to at-

Ntombifuthi alleged that she then called the brother of her husband's girlfriend in a bid to try and reason with him to intervene by rebuking his sister to stop seeing her husband, since he was a married man.

She claimed that her husband, who overheard her talking to the brother of the girlfriend in question over the phone, summoned her to the house, where he allegedly asked her if she still remembered that she was a married woman, before chok-

She alleged that in a bid to defend herself, she picked up a nail and used it to stab Senzo, who then rushed to the police station to lay charges against her.

Unidentified man found hanging in Mankayane

POLICE are investigating the death of an unidentified man who was found hanging from a tree in the Mabovini bushes on Monday morning. Senior Superintendent Phindile Vilakati, the Chief Police Information and Communications Officer, confirmed the incident, stating that it was reported to authorities on 11 August 2025 at about 10:05 hours.

Vilakati said officers attended the scene where the body was discovered and initiated an investigation to determine the circumstances surrounding the death. The man's identity has not yet been established, and police are appealing to members of the public who may have information to come forward.

It should be noted that the

discovery adds to a growing number of reported suicide cases in the country in recent months, with several incidents involving people of various ages being found hanged or dead under unexplained circumstances. Police have repeatedly urged communities to be alert to signs of distress among friends, relatives, and neighbours, and to seek help early.

The REPS say investigations will focus on establishing whether foul play was involved and gathering any evidence that may help identify the deceased.

Vilakati reiterated the importance of public cooperation in both identifying the man and supporting ongoing efforts to address the rising incidence of suspected suicides.

Somalis detained, wait for deportation in prison

WHILE Eswatini received five deportees from the U.S last month, the Ministry of Home Affairs has issued an order to have two Somali nationals who were staying in the country illegally deported to their home country.

In a letter signed by the Minister of Home Affairs, Princess Lindiwe, it is stated that Ehmed Usuf (36) and Abdi Fatah (30), both from Somalia, shall be immediately detained at a correctional facility, pending their deportation to their home country.

"They will, thereafter, be prohibited from entering this territory without prior application and approval of entry," the letter further read.

The deportation order was enforced by Magistrate Philisiwe Simelane on Tuesday at the Manzini Magistrates Court.

During court proceedings, Usuf pleaded with the court to at least deport him to South Africa, where he claimed he had a status as an asylum seeker. He also pointed out that his wife and children were residing in the neighbouring country (South

However, magistrate Simelane informed him that the law dictates that he should be deported to his home country, where, upon arrival, he can then come back to South Africa, if he so wishes.

Meanwhile, the two Somali nationals were deported after contra-

they unlawfully entered into and stayed in the Kingdom of Eswatini without valid passports or permits.

They both pleaded guilty to the offence and they were found guilty as charged.

Usuf mitigated for a lenient sentence on the grounds that he had six children who were dependent on

He further stated that he was not employed in the country and, as such, the Somalian community would assist him with food and shelter from time to time during his

vening the Immigration Act 17/1982, stay in the country. "I came to this in that not being emaSwati citizens, country seeking a job. I just need the necessary documents to stay in this country," he said.

Fatah, on the other hand, pleaded for a lenient sentence since he had a family back home.

"It has not been long since I came here, and I was provided for by the Somalian community. I came here looking for a better life," he said.

They were both sentenced to five months in prison with an option of a fine of E500.

According to the judgment, they will be deported to their home country upon serving their sentences.



15-year-old found dead in Mahlabaneni

A 15-year-old boy was found dead on Monday evening after being discovered hanging from the rafters inside a house in the Mahlabaneni


Senior Superintendent Phindile Vilakati, the Chief Police Information and Communications Officer, confirmed the incident, stating that it occurred on 11 August 2025 at about 20:30 hours. She said police officers responded to the scene after the matter was reported.

According to Vilakati, preliminary information indicates that the boy was found by individuals at the residence, who then alerted authorities. The scene was attended by police investigators to gather evidence and establish the sequence of events leading to the incident.

Vilakati said investigations are still ongoing, and police will determine whether there was any foul play involved. She urged members of the public to allow the investigation process to proceed without speculation.

No additional details, including the identity of the deceased, were released at the time of going to press, pending notification of the boy's next of kin.

Police stated that once investigations are complete, findings will be communicated through the appropriate channels.



Duo caught inside church after break-in

TWO men accused of breaking into Mpolonjeni Evangelical Church and stealing property worth E8 500 have been remanded in custody while awaiting sentencing.

Sibonele Mkhweli and Siphosethu Dlamini appeared before the Mbabane Magistrate's Court facing charges of housebreaking and theft.

The court heard that on the day of the incident, Pastor Sibusiso Mthembu was contacted by two church members, alerting him that they had found people inside the church premises.

When Mthembu arrived, he discovered the accused hiding in the toilet. One attempted to flee but was apprehended. The church's main

door and an internal door had been forced open.

Stolen items included a bass guitar valued at E4,500, copper cables, and wiring materials worth about E4,000. The prosecutor told the court that the men were caught at the scene and could not explain their presence. Both pleaded guilty and offered no mitigating factors. Magistrate Xolile Nxumalo remanded them until Thursday for sentencing.



Ex-Shop worker among trio accused in E8 000 theft

A WOMAN and two men have been charged with breaking into a shop and stealing goods valued at over E8,000.

Former shop employee Khulile Gamedze (32) is accused of leading Sibonelo Maziya (29) and Ndumiso Dlamini (37) into the break-in at a Big-Bend store owned by Nhlanhla Maziya.

The stolen goods reportedly included groceries and cash totalling E8 470.

All three opted to represent themselves in court. They were remanded in custody pending the trial date.

In a separate matter, the same court heard the case of Philani Mkhabela (31), who assaulted Zinhle Ndzabandzaba at a drinking spot. He admitted guilt, saying the victim provoked him by taking his alcohol and insulting him. Mkhabela was sentenced to two years in prison or a fine of E2 000.

Drunk-driver crashes car into house

A 23-year-old man has been convicted on three charges under the Road Traffic Act after crashing a car into a house while spinning it in the early hours of Sunday.

Ntokozo Shongwe appeared before the Manzini Magistrate's Court, charged with driving under the influence, refusing to give a breath specimen, and reckless driving.

Police testified that Shongwe staggered when walking, smelled strongly of alcohol, and was spinning a Toyota sedan before losing control and hitting a veranda pillar. He pleaded guilty and was sentenced to four years in prison or a fine of E5,000 for drink-driving, six months or E800 for refusing a breath test, and six months or E800 for reckless driving.

In a separate incident, bus driver Sandile Gama (43) was arrested for driving a Tata bus while intoxicated along the MR3 public road.

His breath specimen measured 0.71mg/l, almost double the legal limit. He told the court he had five children to support and claimed the offence was a mistake. He was sentenced to four years in prison or an E5,000 fine.



Man gets 26 years for girlfriend's Murder

A 46-year-old man has been sentenced to 26 years in prison for the murder of his girlfriend, a teacher, in what the High Court described as a "callous and senseless" act.

Judge Bongani Sydney Dlamini found Sifiso Pirrie Dlamini guilty of murder with direct intent for the shooting of Angel Shongwe in January 2023 at Othandweni, Lubombo region. Evidence showed she was shot at close range.

The defence argued that the couple's relationship was

troubled and clouded by mistrust and property disputes. They claimed Shongwe had threatened the accused and that he acted under emotional distress.

The judge acknowledged that Dlamini, a father of six and sole breadwinner, had no prior convictions and cooperated with authorities. However, he stressed that no hardship justified taking a life. The court backdated the sentence to January 2023, the date of arrest.



Man fined for carrying knife to church

A MAN who was found in possession of a knife inside a church in Ezulwini has been fined E500 or, alternatively,sentenced to three months in prison.

Bandile Mzini was arrested inside the All Nations Church after members discovered he was carrying a weapon. The knife, which was later presented in court as evidence, was seized during his arrest.

The incident occurred after Mzini's vehicle was reportedly taken by police officers. He told the court that he had been forced to walk on foot and, feeling tired and in need of shelter, he entered the church to rest.

Mzini insisted that he had no intention of causing harm or disturbing the congregation. "I was only looking for a place to rest. I was not there to create any chaos," he explained.

However, the presiding magistrate questioned the logic of his actions, noting that bringing a dangerous weapon into a place of worship raised serious concerns about safety and public order.

When asked why he had the knife, Mzini offered no clear justification beyond saying it was in his possession when he entered the premises.

During mitigation, Mzini apologised for his actions and

pleaded for leniency, stating that he had children who depended on him for support.

He said he regretted the incident and assured the court that it would not happen again.

In handing down the sentence, the magistrate emphasised the importance of ensuring that places of worship remain safe spaces for all who attend.

The court noted that, regardless of intent, carrying a weapon into a public gathering could cause alarm and pose a potential threat. Mzini was given the option of paying the fine immediately or serving his prison sentence.

72% of Eswatini's Agriculture driven by rural area activity


MINISTER of Agriculture Mandla Tshawuka says 72 per cent of the country's agricultural activity is generated in rural areas, describing the figure as the result of deliberate national policy. Speaking ahead of the Eswatini Agriculture Business and Investment Forum 2025, Tshawuka said the rural sector remains the backbone of the country's agri-food systems and a key focus for development initiatives.

SA to offer US a revised trade deal

SOUTH Africa will submit a revised offer for a trade deal to Washington on Tuesday, the trade minister said, in an effort to lower the 30 per cent tariff rate U.S. President Donald Trump imposed on exports to the United States last week. The government of Africa's biggest economy has tried for months to negotiate a U.S. trade deal but failed to reach agreement before Trump's deadline.

Rand steady before local mining and jobs data

JOHANNESBURG — The South African rand was steady in early trade on Tuesday before the release of domestic mining output and unemployment figures. At 0618 GMT, the rand traded at 17.74 against the dollar, about 0.2 per cent firmer than Monday's close. Statistics South Africa will publish June mining production numbers and second-quarter unemployment data at 0930 GMT on Tuesday.



EEC reports over E200 million loss

ESWATINI Electricity Company (EEC) Managing Director (MD) Ernest Mkhonta has revealed that the company recorded a loss of more than E200 million in the 2024/25 financial year, warning that its financial position is under pressure.

Speaking during the EEC media stakeholder breakfast meeting held at the Hilton Garden Inn Hotel, Mkhonta said the utility faces the challenge of providing electricity at an affordable price while dealing with reduced revenue.

"The company's financials are not looking good. In the past years, the tariff increases we applied for were not granted according to our projections, and this has contributed to the unhealthy financial performance," he said.

Mkhonta said the losses have been compounded by rising operational costs and the need to invest in infrastructure to meet the growing electricity demand across the country.

The MD confirmed that EEC is continuing to explore geothermal energy as a potential long-term solution for the kingdom's power needs.

"Under the surface lies geothermal energy, a power source that is sustainable and does not run out or flood. It provides a steady supply of electricity for the future, but the costs of developing it are significant," Mkhonta said.

He revealed that millions of emalangeni have already been spent on studies to assess the viability of tapping into geothermal resources.

"This is not a small investment, but we believe it is important to secure our energy future," he said.

Mkhonta also highlighted the continued growth in electricity demand, which puts additional strain on the company's workforce and resources.

"We currently serve almost 299,000 customers with just over 800 employees and more than 1,000 contractors. This shows the scale of work required to meet demand and maintain service quality," he said.

He added that population growth, urbanisation and industrial expansion are driving increased power consumption.

... Load shedding explained

ADDRESSING the ongoing load shedding in the country, Mkhonta explained that the main cause is a combination of peakhour demand and reduced electricity imports.

"Our peak periods are from 6 am to 8 am and from 5 pm to 8 pm. During these times, demand shoots up and pushes the grid to its limits. To meet this demand, we have to import electricity, which is very expensive," he said. He said the situation is worsened by regional supply constraints.

"Drought has affected major hydroelectric plants in Zimbabwe, Zambia and Mozambique. Their output has been reduced, which means there is less power available for purchase in the Southern African Power Pool," Mkhonta said.

According to Mkhonta, the combination of higher costs and reduced availability has forced EEC to implement load shedding to protect the stability of the national grid.

Meanwhile, during the question-and-answer session, one editor raised concerns about the declining purchasing power of E200 for electricity units and asked where levies on electricity purchases are directed.

Mkhonta said the issue goes beyond electricity pricing and is linked to inflation.

"E200 will no longer buy you as many electricity units as before. It is the same situation with groceries, what you could buy

with that amount three years ago is not the same today," he said.

He explained that the value of money has decreased, which affects how much electricity customers can afford. Mkhonta said inflation affects the cost of producing and delivering electricity, including expenses such as fuel, maintenance, and imported power.

"The reduction in the value of money means the same amount today buys less electricity because our costs have increased," he said.

He emphasised that tariffs are regulated and that EEC applies for adjustments through the Eswatini Energy Regulatory Authority (ESERA).

Despite the financial challenges, Mkhonta said EEC is continuing with strategic projects aimed at improving supply reliability. These include:

1. Upgrading transmission lines to handle higher

capacity.

2. Expanding rural electrification to meet government targets.

3. Exploring renewable sources such as solar and wind in addition to geothermal.

"We are committed to finding sustainable ways to meet the growing demand without compromising service quality," he said.

Mkhonta said the company is focusing on maximising efficiency with its limited staff.

"With just over 800 employees, supported by more than 1,000 contractors, we have to ensure our operations are streamlined. We have a responsibility to deliver value to our customers despite the challenges," he said.

The MD noted that Eswatini remains reliant on imports from neighbouring countries for part of its electricity supply and is working within the Southern African Power Pool to secure affordable power.

"We are engaging with our regional partners to explore flexible supply agreements that can help reduce costs," he said.

On geothermal development, Mkhonta said feasibility studies are progressing and will guide the next steps.

"This is a long-term project, but we have to start now if we want energy security in the future," he said.

Once developed, geothermal can provide a stable and clean power source for decades, he said. The company is also looking into small-scale renewable energy initiatives to complement the main grid.

Mkhonta acknowledged that finding the balance between keeping tariffs affordable and investing in infrastructure is one of the company's greatest challenges.

"We cannot stop investing in the network because demand is growing. At the same time, we know customers are already feeling the impact of higher living costs," he said.

Closing his address, Mkhonta said EEC is committed to transparency and engaging with the public on energy issues.

"We appreciate the feedback we receive from stakeholders. We want to keep the lights on for the nation, but it requires a collective understanding of the challenges we face," said Mkhonta.

72% of Eswatini's Agriculture driven by rural area activity

MINISTER of Agriculture Mandla Tshawuka says 72 per cent of the country's agricultural activity is generated in rural areas, describing the figure as the result of deliberate national policy.

Speaking ahead of the Eswatini Agriculture Business and Investment Forum 2025, Tshawuka said the rural sector remains the backbone of the country's agri-food systems and a key focus for development initiatives.

"Seventy-two per cent of agricultural activity comes from rural areas by design. Our policies are aimed at empowering rural farmers, improving infrastructure, and ensuring that communities have access to markets," he said.

He said the contribution from rural communities includes smallholder crop production, livestock rearing, and horticulture, as well as participation in value chains for sugarcane, cotton, maize, and fresh produce.

"Rural households depend heavily on agriculture for their livelihoods. By strengthening these systems, we also address food security and income generation," he

Tshawuka said government programmes such as irrigation schemes, mechanisation support, and training initiatives arebeing implemented to increase productivity in rural areas.

"These interventions are not accidental. They are targeted investments to ensure rural areas remain active participants in the national economy," he said.

The minister also noted that the agricultural sector employs a significant portion of the population, with rural farmers playing a central role in supplying both domestic and export markets.

"From the maize fields of the Highveld to the horticulture projects in the Lowveld, rural farmers are keeping Eswatini's food systems running," he said.

He added that partnerships with private companies, development agencies, and farmer associations are essential to improving market access and production capacity in rural areas.

"We are committed to building resilient rural economies that can adapt to climate change, compete in regional markets, and contribute to food sovereignty," he said.

THE Ministry of Agriculture will host the second Agriculture Business and Investment Forum from Wednesday to Thursday this week, bringing together stakeholders to discuss investment opportunities in the agri-food sector.

Minister of Agriculture Mandla Tshawuka said the event will take place from August 13-14, 2025, starting at 9:00 a.m. each day.

The theme is Mobilising Investments in Agrifood Systems for Youth Empowerment and Food Sovereignty.

"This is a key platform to drive transformation in our agri-food systems. We want to connect potential investors, development partners, and agripreneurs to explore how agriculture can be a sustainable source of livelihoods for young people," Tshawuka said.

The forum is organised by the Ministry in partnership with agencies including FAO Eswatini, Namboard, Eswatini Water and Agricultural Development Enterprise, Eswatini Cotton Board, and the National Maize Corporation.

Tshawuka said the event is by invitation only, but the Ministry will provide a live broadcast on its Facebook page to allow the public to follow discussions in real time.

"This way, farmers, students, and other stakeholders can participate from wherever they are," he said.

The minister said topics to be covered include investment opportunities in value chains, financing for youth-led agribusiness, sustainable water use, and strategies for improving food sovereignty.

"We will also look at how to strengthen rural-urban linkages in agricultural markets and how technology can improve productivity," he said.

According to the Ministry, the forum will feature presentations, panel discussions, and

networking sessions between policymakers, investors, and farmer representatives.

Tshawuka said the event aligns with the government's long-term agricultural strategy, which places emphasis on youth empowerment and innovation.

"Our young people must see agriculture as a viable career and business opportunity, not just subsistence farming," he said.

He added that food sovereignty, the ability of the country to produce enough for its own needs, is central to Eswatini's agricultural agenda.

"The forum is not just about increasing production. It is about building systems that are self-sustaining, environmentally sound, and inclusive," he said.

The Ministry expects participation from local agribusiness owners, farmer cooperatives, international investors, and regional development partners.

irrigation infrastructure to mitigate the impact of drought.

Presentations were delivered by the Food and Agriculture Organisation (FAO), Namboard, and the Eswatini Water and Development Enterprise, Agricultural among others.

Participants discussed the need for youthtargeted funding schemes, better rural road networks to connect farms to markets, and investment in agro-processing facilities to add value to raw produce.

According to the Ministry, the 2023 forum resulted in several follow-up initiatives,

Key topics included improving access to including pilot projects for youth-run agricultural finance, strengthening value vegetable farms, partnerships to expand chains for crops such as maize, cotton, cold-storage capacity for perishable goods, and horticultural produce, and upgrading and feasibility studies for renewable energy use in farming operations.

Tshawuka described the event as a starting point for building the investment momentum needed to transform agriculture into a driver of national growth.

The Ministry said lessons from the inaugural forum have informed the structure of this year's event, which will continue to focus on youth empowerment, food sovereignty, and sustainable water

"We are carrying forward the conversations from last year and turning them into concrete projects," Tshawuka said.

SA to offer US a revised trade deal

SOUTH Africa will submit a revised offer for a trade deal to Washington on Tuesday, the trade minister said, in an effort to lower the 30 per cent tariff rate U.S. President Donald Trump imposed on exports to the United States last week.

The government of Africa's biggest economy has tried for months to negotiate a U.S. trade deal but failed to reach agreement before Trump's deadline.

South African exports to the U.S. were hit with the highest tariff rate in sub-Saharan Africa.

"Cabinet has approved that South Africa submits a revised offer as a basis for negotiations with the U.S.," Parks Tau told a press conference. The revised offer was expected to be submitted on Tuesday, he

"The new offer substantively responds to the issues the U.S. has raised in the 2025 National Trade Estimates Report," Tau said, adding that South Africa had addressed some sanitary and phytosanitary issues from the report. He did not provide further details on the offer.

Containers of poultry and pork were to be shipped from the U.S. to South Africa in two weeks' time, showing that these issues had been resolved, Tau said.

Agriculture Minister John Steenhuisen had previously said that Trump's team felt South Africa's initial offer for a trade deal was not ambitious enough.

Steenhuisen, also leader of the secondbiggest party in the coalition government, said the new offer was a "broad, generous and open offer that I think meets the ambition criteria."

"If one was to look at this through the trade and tariff perspective, I think this offer represents something that would be good for the United States and also good for South Africa," he said.

In an interview with Reuters on Monday, Steenhuisen said there was a risk the 30 per cent tariffs would remain unless South Africa's government changed some domestic race policies such as affirmative action, which Trump has criticised. (**Reuters**)

Rand steady before local mining and jobs data

JOHANNESBURG — The South African rand was steady in early trade on Tuesday before the release of domestic mining output and unemployment figures.

At 0618 GMT, the rand traded at 17.74 against the dollar, about 0.2 per cent firmer than Monday's close.

Statistics South Africa will publish June mining production numbers and second-quarter unemployment data at 0930 GMT on Tuesday.

Mining production rose 0.2 per cent yearon-year in May, and economists polled by Reuters expect it to have risen by 1.4 per cent this time around.

The unemployment rate of Africa's most industrialised economy was estimated to have picked up to 33.0 per cent in the second quarter from 32.9 per cent in the previous quarter.

Also in focus is a U.S. inflation report due at 1230 GMT, which could offer further

insight into the Federal Reserve's rate-cut trajectory.

The rand, like other risk-sensitive currencies, often takes cues from global drivers such as U.S. policy and economic data.

The dollar last traded flat against a basket of currencies.

South Africa's benchmark 2035 government bond was also little changed in early deals, with the yield up half a basis point at 9.675 per cent. (**Reuters**)

Oil steadies as US, China announce tariff extension

LONDON — Oil prices were broadly steady on Tuesday as the United States and China extended a pause on higher tariffs, easing concerns an escalation of their trade war would hit oil consumption.

Brent crude futures lost 2 cents to \$66.61 a barrel by 0904 GMT, while U.S. West Texas Intermediate crude futures eased 10 cents, or 0.2 per cent, to \$63.86.

U.S. President Donald Trump extended a tariff truce with China to November 10, staving off triple-digit duties on Chinese goods as U.S. retailers prepared for the critical end-of-year holiday season.

This raised hopes that an agreement could be attained between the world's two largest economies and avert a virtual trade embargo between them. Tariffs risk slowing global growth, which could sap fuel demand and drag oil prices lower.

Oil's gains have also been supported by fresh signs of softness in the U.S. labour market, which have boosted expectations for a Federal Reserve rate cut in September, said Priyanka Sachdeva, senior market analyst at brokerage Phillip Nova.

Also on the radar is U.S. inflation data later in the day, which could shape the Fed's rate path. Interest rate cuts typically boost economic activity and oil demand.

Potentially weighing on the oil market, Trump and Russian President Vladimir

Putin are due to meet in Alaska on Friday to discuss an end to the war in Ukraine.

The meeting comes as the U.S. steps up pressure on Russia, with the threat of harsher penalties on Russian oil buyers such as China and India if no peace deal is reached. Trump set a deadline of last Friday for Russia to agree to peace in Ukraine or have its oil buyers face secondary sanctions, while pressing India and China to reduce purchases of Russian oil.

"If Friday's meeting brings a ceasefire or even a peace deal in Ukraine closer, Trump could suspend the secondary tariffs imposed on India last week before they come into force in two weeks," Commerzbank said in a note.

"If not, we could see tougher sanctions against other buyers of Russian oil, like China". (Reuters)

European Union awaits US followup on trade deal promises

BRUSSELS — The European Union could not say when a joint statement on tariffs with the United States would be ready, nor when the White House would issue an executive order on European car import duties, a spokesperson said on Tuesday.

The EU and U.S. reached a framework trade agreement at the end of July but only the 15 per cent baseline tariff on European exports had so far come into effect, as of last week.

EU officials previously said a joint statement would follow the deal "very soon" along with executive orders from U.S. President Donald Trump on key carve-outs.

"It is an agreement that we believe is strong and the best we could have ... Of course, we expect the U.S. to take further steps that are part of this agreement but I don't believe at this stage we can put a timeline on these engagements," the European Commission spokesperson said.

The carve-outs include a reduction of the current 27.5 per cent U.S. import tariff on EU cars and car parts to 15 per cent.

While duties on pharmaceuticals and semiconductors are currently zero, if they rise as a result of a U.S. probe into imports of those products, Trump assured these would not exceed the 15 per cent ceiling.

As part of the deal, the EU and U.S. are still finalising a list of products where tariffs would go down to zero on both sides, such as on aircraft, while other products would revert to a much lower most-favoured-nation rate. Separately, negotiations on rates for spirits and wine are expected to drag into the autumn.

Europe still faces tariffs of 50 per cent on steel and aluminium exports to the U.S. but the two sides have agreed to set a quota system and a "metals alliance" that would later lower duties. In the interim, however, EU smelters are under pressure as U.S. tariffs have led to a surge in exports of their main input, scrap metal. (**Reuters**)

WHEN Ritz-Carlton opens its first safari lodge on Friday in Kenya's Maasai Mara reserve, guests will pay nightly rates starting from \$3,500 per person for tented suites with private decks overlooking a river crossed by migrating wildebeest.

But the director of a Maasai conservation institute and researchers say the true cost of those sublime views will run much higher by damaging one of the world's most renowned

On Tuesday, Meitamei Olol Dapash from the Institute for Maasai Education, Research and Conservation (MERC) filed a lawsuit in a Kenyan court against Ritz-Carlton, its owner Marriott (MAR.O), opens new tab, the project's local developer Lazizi Mara Limited and Kenyan authorities to try to block the scheduled opening.

Dapash alleges in the lawsuit that the 20-suite camp, which boasts plunge pools and personalised butler service, obstructs a crucial migration corridor between Maasai Mara and Tanzania's Serengeti. Researchers say migration allows wildebeest to find food and maintain genetic diversity among herds.

The lawsuit also says there is no evidence an environmental impact assessment was conducted. Dapash's lawyers asked the Environment and Land Court in Narok to suspend the lodge's opening and hear the case on a priority basis.

Marriott, which entered into a franchise agreement with Lazizi, said in a statement it was committed to respecting the environment and that Lazizi had obtained all necessary approvals.

Lazizi's managing director, Shivan Patel, said Kenyan authorities conducted an environmental impact assessment, which had established that the site was not a wildlife crossing point.

The Narok County government and National Environment Management Authority, which are also named as respondents in the lawsuit, did not respond to Reuters' requests for comment.

The dispute is the latest flashpoint in East Africa's grasslands between luxury tourism and Maasai herders who say that the sector's development is harming their habitats and wavs of life.

In Kenya, local communities have complained about what they say are land grabs by wealthy investors. In Tanzania, protests

against the eviction of tens of thousands of Maasai to make way for hunting lodges have led to deadly clashes with police.

Dapash, who founded MERC in 1997 as a grassroots network of Maasai leaders, said the Ritz-Carlton's development was the latest in a long list of lucrative tourism projects that government officials have green-lighted at the expense of local wildlife and people.

"Without the county government regulating the tourist behaviours, the tourist activities, we saw the habitat, the environment degraded so badly," he told Reuters.

County officials have acknowledged that over-tourism has harmed Maasai Mara's natural environment but have said that focusing on "high-value tourism" can help address this by bringing in more money at less environmental cost.

MIGRATION PATH

Announcing the new Ritz-Carlton in February, Marriott said it would offer a "frontrow seat" to the annual Great Migration of millions of wildebeest, zebras and gazelles.

The lodge lies along the Sand River, an important water source for animals from elephants to birds, that snakes back-and-forth across the border between Kenya and Tan-

Hotel staff declined to let Reuters reporters enter the property.

Dapash, who is a PhD candidate in sustainability education at Prescott College in the United States and has run unsuccessfully for parliament several times, said the lodge sits on a wildebeest crossing point wellknown to locals.

Joseph Ogutu, a Kenyan researcher at the University of Hohenheim in Germany who has studied wildlife migration in Maasai Mara, said the new construction would deal a further blow to fauna in the reserve. Many species' populations in the reserve have shrunk by over 80% since the 1970s, according to Kenyan government data.

"It is highly ill-advised to build a lodge on

one of the most critical paths of the Great Migration," he said.

Grant Hopcraft, an ecologist at the University of Glasgow, said the project would "likely have large and long-term ecological implications for the migration". Neither Hopcraft nor Ogutu are party to the lawsuit.

Lazizi's Patel said it was the county government that proposed the site to him. And he questioned why Dapash had only started raising objections to the project in recent

"The project has been ongoing for a year," he told Reuters. "We pushed it so hard to ... avoid any disruption, damage to the environment."

Dapash said he only learned of the project in May because it is far from the main population centre.

The lawsuit questions whether a required environmental impact assessment was ever conducted.

Under Kenyan law, the National Environment Management Authority must publish a summary of the assessment in the official gazette indicating where it may be inspected.

Reuters could not find any such notice in the official gazette. Patel said he could not share the assessment for confidentiality reasons and referred Reuters to NEMA. NEMA did not respond to requests for comment.

The lawsuit also says the project violated a management plan for Maasai Mara adopted by the Narok County government in February 2023, which calls for "no new tourism accommodation developments" before 2032.

Patel disputed this, saying the project was built at an "existing" site that had already been in use for many years. He did not say how it had been used. Narok County did not respond to requests for comment.

Dapash said the public needed answers.

"The preservation of wildlife migration for us is a treasure that we cannot afford to lose," he said. "We need to see that due diligence was done."

South African jobless rate rises, highlighting coalition challenge

SOUTH Africa's unemployment rate rose for the second quarter in a row, official data showed on Tuesday, highlighting one of the biggest challenges faced by the country's yearold coalition government.

The official unemployment rate stood at 33.2% in April-June, up from 32.9% in January-March (ZAUNR=ECI), opens new tab, one of the highest rates worldwide.

The coalition government formed after the African National Congress lost its parliamentary majority in the 2024 election has struggled to achieve a meaningful drop in the jobless rate, despite making that a pri-

Statistics South Africa said the number of unemployed people increased to 8.367 million in the second quarter (ZAUEMP=ECI), opens new tab, though there was a slight drop in an expanded definition of unemployment, which includes those discouraged from seeking work.

Six of the 10 industries tracked by the statistics agency recorded employment decreases, while four had increases in the latest three-month period.

The most jobs were lost in community and social services, agriculture and finance.

Top statistics official Risenga Maluleke

said it was too early to tell whether U.S. tariffs were having an effect on the jobs data.

South African exports to the U.S. were hit with a 30% tariff last week, the highest rate in sub-Saharan Africa.

Maluleke dismissed criticism by the former head of major local bank Capitec (CPI-J.J), opens new tab that the statistics agency was underestimating the number of people with informal jobs.

He told a press conference his agency had always measured that and made its numbers available, adding that South Africa would be making "a big mistake as a country if we want to assume that we do not have an unemployment challenge".

Desiree Manamela, chief director of labour statistics, said updates to the way Statistics SA collects unemployment data that will be rolled out in the next quarter were unlikely to significantly affect the official jobless rate.

But they should allow the agency to include additional measures of the health of the economy in its reports, she said.

EU leaders say Ukraine should have freedom to decide its future

UKRAINIANS must have the freedom to decide their own future, European Union member states said on Tuesday, weighing in ahead of talks between U.S. President Donald Trump and Russian President Vladimir Putin, opens new tab on Friday.

European leaders and Ukrainian President Volodymyr Zelenskiy plan to speak with Trump on Wednesday, before the summit in Alaska, amid fears that Washington, hitherto Ukraine's leading arms supplier, might dictate unfavourable peace terms to Kyiv.

"The path to peace in Ukraine cannot be decided without Ukraine," the leaders of

all EU countries except Hungary said in a joint statement, adding that any peace deal must respect international law, including Ukraine's independence and territorial in-

Trump has said any peace deal would involve "some swapping of territories to the betterment of both" Russia and Ukraine, prompting consternation in Kyiv and European capitals as virtually all the territory in question is Ukrainian.

Sergei Markov, a former Kremlin adviser, said the Russians had been able to advance due to "a partial collapse in the front" caused by Ukraine's shortage of soldiers.

"This breakthrough is like a gift to Putin and Trump during the negotiations," Markov said, suggesting it could heighten pressure on Kyiv to yield territory under any deal.

Kyiv's military meanwhile said it had retaken two villages in the eastern region of Sumy on Monday, part of a small reversal in more than a year of slow, attritional Russian gains in the southeast.

Russia, which launched its full-scale invasion of Ukraine in February 2022, has mounted a new offensive this year in Sumy after Putin demanded a "buffer zone" there.

Kyiv and its European allies fear that Trump, keen to claim credit for making peace and seal new business deals with Moscow, could in effect reward Moscow for its 11 years spent in efforts to seize Ukrainian territory, the last three in open warfare.

EUROPEANS LINK UKRAINE TO OWN SECURITY

The EU statement stresses that a Ukraine capable of defending itself effectively is an Russian forces have made a sudden thrust integral part of any future security guaran-

tees, adding that EU nations were ready to contribute further to security guarantees.

"Ukraine cannot lose this war and nobody

has the right to pressure Ukraine into making territorial or other concessions, or making decisions that smack of capitulation," Polish Prime Minister Donald Tusk said.

"I hope we can convince President Trump about the European position," he told a government meeting.

Zelenskiy welcomed the EU statement, adding in a message on X that Russia was preparing new offensive operations.

"Indeed, we all support President Trump's determination, and together we must shape positions that will not allow Russia to deceive the world once again," he said.

However, Hungarian Prime Minister Viktor Orban, Putin's principal ally in Europe, mocked the statement from his EU counterparts.

"The fact that the EU was left on the sidelines is sad enough as it is. The only thing that could make things worse is if we started providing instructions from the bench," Orban said on X.

Trump had been recently hardening his stance towards Moscow, agreeing to send more U.S. weapons to Ukraine and threatening hefty trade tariffs on buyers of Russian oil in an ultimatum that has now lapsed.

Even so, the prospect of Trump hosting Putin on U.S. soil for the first U.S.-Russia summit since 2021 has revived fears that he might put narrow U.S. interests ahead of the security of European allies or broader geo-

Russia makes sudden advance in Ukraine before Trump-Putin summit

RUSSIAN forces have made a sudden thrust into eastern Ukraine near the coal mining town of Dobropillia, a move that may be designed to increase the pressure on Kyiv to give up land as the U.S. and Russian presidents prepare to meet.


Ukraine's authoritative DeepState war map showed on Tuesday that Russian forces had advanced by at least 10 km (six miles) north in two prongs in recent days, part of their drive to take full control of Ukraine's Donetsk region.

The advance is one of the most dramatic in the last year. DeepState said the Russians had surged forward near three villages on a section of the frontline associated with the Ukrainian towns of Kostyantynivka and Pokrovsk, which Moscow is trying to encircle by exploiting Kyiv's lack of manpower

"The situation is quite chaotic, as the enemy, having found gaps in the defence, is infiltrating deeper, trying to quickly consolidate and accumulate forces for further advancement," DeepState said on its Telegram

U.S. President Donald Trump and Russian President Vladimir Putin are expected to discuss a possible deal to end the war in Ukraine when they meet in Alaska on Friday. Unconfirmed media reports say Putin has told Trump he wants Ukraine to hand over the part of the Donetsk region that Russia does not control.

There was no immediate comment on the advance from Moscow. Ukraine's top mil-

itary commander, Oleksandr Syrskyi, had ordered reinforcements to be deployed "to detect and destroy enemy sabotage groups that penetrate the line of defence," Andriy Kovalov, a spokesperson for the Ukrainian army, told Interfax-Ukraine.

He said Russia was using its numerical superiority to try to infiltrate Ukrainian defence lines in small groups and had made 35 attempts to push back Ukrainian units, suffering heavy losses in the process. Viktor Trehubov, another Ukrainian military spokesperson, played down the development, saying the infiltration did not amount to a breakthrough.

Pasi Paroinen, a military analyst with the Finland-based Black Bird Group, said the situation had escalated rapidly, with Russian forces infiltrating past Ukrainian lines to a depth of roughly 17 km (10 miles) during the past three days.

"Forwardmost Russian units have reportedly reached the Dobropillia - Kramatorsk road To514 and Russian infiltration groups

have also been reported near Dobropillia proper," he wrote on X.

RUSSIA MAY GAIN LEVERAGE FOR TRUMP TALKS

Tatarigami_UA, a former Ukrainian army officer whose Frontelligence Insight analysis tracks the conflict, posted: "In both 2014 and 2015, Russia launched

major offensives ahead of negotiations to gain leverage. The current situation is serious, but far from the collapse some suggest." Sergei Markov, a former Kremlin adviser,

said the Russians had been able to advance due to "a partial collapse in the front" due to Ukraine's shortage of soldiers.

Ukrainian President Volodymyr Zelenskiy has publicly pushed back against the idea of ceding territory to Russia, saying any peace deal must be a just one.

Bohdan Krotevych, former chief of staff of Ukraine's Azov brigade and a National Guard lieutenant colonel, took to X late on Monday to warn Zelenskiy of the threat, saying the frontline in the area was "a complete


Reflecting on the impact of 'Siyabonga Gogo,' Sancheziey shared, "The song made



If a health professional has advised you to follow a low sodium diet, it may be challenging to find meals that are not too high in salt. Many popular foods, including restaurant meals and packaged foods, can be high in sodium.

Making homemade meals with whole ingredients and non-salt seasonings can help you reduce the amount of sodium you eat. To make low sodium eating a reality, it's helpful to have a list of recipes on hand.

How we define low sodium

We define a low sodium meal as a meal with 500 milligrams or less of sodium per serving. If you're looking for a low sodium snack, look for a snack with 250 milligrams or less of sodium per serving.

Roasted lamb with mint pesto and spiced carrots & potatoes

This low carb, high protein dinner consists of seared lamb loin and roasted carrots and potatoes. The lamb is topped with a mint pesto sauce made with garlic, mint leaves, pistachios, lemon juice, and olive oil.

This recipe recommends salting the lamb, vegetables, and pesto to taste, so there is no set amount of salt. However, each serving contains 247 milligrams (mg) of sodium. Since this recipe makes four servings, you may consider measuring out around 1,000 mg of salt to ensure that each serving contains around the estimated amount.

Sloppy joe with cabbage noodles

While traditional sloppy joes are usually made with hamburger buns, this low carb version uses cabbage as noodles. However, if you don't like cabbage, you can replace it with the low carb noodles of your choice, such as zucchini noodles or spaghetti squash.

Each serving contains 197 mg of sodium. It doesn't call for a specific amount, so you may want to measure out around 800 mg to ensure each serving contains around 197 mg. This recipe uses only salt for the cabbage noodles. However, it also calls for butter; ensure that the butter is unsalted.

Turkey taco bowl with rice

This balanced taco bowl contains brown rice, ground turkey, cherry tomatoes, jalapenos, red onions, corn, lime juice, and feta cheese. The turkey is cooked in a skillet, and the rice is cooked according to package directions. The rest of the toppings are arranged on top of the turkey and rice.



This recipe calls for coating the trout with egg and a mixture of almond flour and dill and pan-frying it until flaky. It is served with a side salad made with arugula, Brussels sprouts, and tomatoes.

Each serving contains 202 mg of sodium. Salt is used in the almond flour mixture to coat the fish, in the salad dressing, and on the fish itself. Since each step does not call for a specific amount, you may want to measure out around 800 mg of sodium so that each serving ends up with around 200 mg.

Tilapia tacos with peach salsa

Both the coating for the fish and the peach salsa are salted to taste. Each serving contains around 135 mg of salt, so you may consider measuring out around 500 mg of salt to divide between the fish and the peach salsa. Consuming peaches may help reduce your risk of heart disease.

Coconut sweet potatoes with creamy kale and salmon

The American Heart Association (AHA) recommends consuming two servings of fatty fish, such as salmon, per week. This is because they contain omega-3 fatty acids, which are good for your heart.

The mixture used to glaze the salmon and the vegetables is salted to taste, and more salt is needed to finish the dish. Each serving contains 368 mg of sodium, so you may want to measure out around 1400 mg of salt so that each serving contains around 268 mg

Avocado tartine with spring veggies

A tartine is a French open-faced sandwich. This vegan tartine is essentially two pieces of avocado toast topped with grilled asparagus and arugula.

The asparagus and avocado are salted to taste. Each serving contains 264 mg of salt, so you may consider measuring our around

1,000 mg to use in the recipe to ensure each serving has around 250 mg.

Rice noodles with broccolialmond pesto

The pesto in this vegan recipe is made with boiled broccoli, almonds, basil, garlic, olive oil, and lemon juice. The sauce is mixed with rice noodles, which are then topped with more broccoli and almonds.

Each serving contains 46 mg of sodium, so you may wish to measure out around 160 mg of salt. Salt is only called for to be added to the pesto in this recipe.

Red beans and sesame salad

Consuming kidney beans may reduce the risk of high blood pressure and promote better kidney health, especially for individuals who are monitoring their sodium intake.

Each serving contains 237 mg of sodium.

Autumn stew with pumpkin and chickpeas

This vegan recipe may have autumn in the name, but it can be a satisfying dish in any season. It is made with carrots, onions, chickpeas, pumpkin puree, vegetable broth, orzo, nutritional yeast, and sage.

Canned pumpkin is high in vitamin A, which can help support your heart health. Each serving contains 365 mg of sodium.

Vegetarian skillet

This recipe is packed with whole foods, including onions, black beans, tofu, cherry tomatoes, spinach, and dill. Everything is cooked in the skillet, and the recipe is ready in 20 minutes.

- ► Tofu may lower your risk of heart disease.
- Each serving contains 255 mg of sodium.

Sweet potato chana masala

Chana masala is an Indian chickpea curry. This dish features sweet potatoes, onions, and crushed tomatoes and is seasoned with cumin, coriander, and garam masala.

Each serving contains 322 mg of sodium.

ACCORDING to new research, unhealthy lifestyle habits could contribute to premature aging of the heart.

A new research letter unveiled a "heart age" calculator that suggests most Americans' hearts are aging faster than their chronological age.

Other cardiologists have developed a method for measuring the heart's "functional age" to help predict complications like heart disease.

Physical activity and eating heart-healthy foods are some of the best ways to preserve your heart's biological age.

The concept of trying to understand heart health by determining its biological "age" relative to chronological age has become a topic of interest among cardiologists, researchers, and physicians.

Assessing the heart's age could offer a simple, clear way to understand its overall health. It might also predict cardiovascular risks that could be minimized by making heart-healthy lifestyle changes.

Now, researchers have developed a new tool to calculate "heart age." Using heart health measures like blood pressure and cholesterol levels, cardiologists say the heart age of most Americans is "older" than their chronological age.

In a research letter published on July 30 in JAMA Cardiology, scientists introduced the PREVENT heart age calculator that can predict long-term cardiac health. They say the estimate can be used by physicians during routine primary care visits to assess patients heart health.

Cardiovascular risk factors like a person's age, sex, blood pressure, cholesterol, kidney health, smoking status, and comorbid conditions like diabetes, are fed into the calculator to determine future cardiac events.

Researchers say the PREVENT calculator uses contemporary data from a broader population compared to an older model that was introduced in a 2008 study and based on the well-known Framingham Heart Study.

In another recent study published in the European Heart Journal, researchers from the University of East Anglia in England published the results of a trial introducing a novel way to measure "functional heart age" using cardiac magnetic resonance imaging (MRI) scans. This "game-changer," the researchers said, could help detect signs of heart disease earlier.

As these new research models suggest, the biological heart age of those with chronic health conditions like obesity and diabetes, or those with unhealthy lifestyles, may be higher than their chronological age.

Determining 'heart age' vs. biological age

To better understand the heart's functional age, University of East Anglia researchers measured the amount of blood remaining in the heart's left atrium after completing a contraction phase and examined the fraction of blood ejected from the left atrium with each heart contraction.

The method was validated using 366 heart patients with known cardiac risk factors.

Participants' heart ages were older compared to healthy controls, and were significantly higher in people with conditions such as high blood pressure, diabetes, atrial fibrillation, and obesity.

"In healthy people, we found that heart age was similar to chronological age. But for patients with things like diabetes, hypertension, obesity, and atrial fibrillation - their functional heart age was significantly higher," lead researcher Pankaj Garg, MD, from UEA's Norwich Medical School and a consultant cardiologist at the Norfolk and Norwich University Hospital, said in a press

could get advice or treatments to slow down the aging process, potentially preventing heart attacks or strokes. It could also be the wake-up call people need to take better care of themselves — whether that's eating healthier, exercising more, or following their doctor's advice. It's about giving people a fighting chance against heart disease," he

Jayne Morgan, MD, a cardiologist with Hello Heart, said that chronological age may not always be consistent with biological age. "The aging process is uneven throughout one's life span," she told Healthline. Morgan wasn't involved in the new research.

Cheng-Han Chen, MD, medical director of the Structural Heart Program at MemorialCare Saddleback Medical Center in Laguna Hills, CA, who was likewise not involved in the research, told Healthline there is not yet an agreed-upon definition of "heart age."

"This research is a good first step toward evaluating whether an imaging-based assessment of 'heart age' can provide clinically useful prognostic information," Chen said.

Signs of heart aging

As people age, common heart changes may occur, even among healthy individuals with no prior history of heart problems.

For instance, the heart may begin to produce extra beats or occasionally skip a beat. This is not generally a problem unless it becomes persistent. If the heart is frequently racing or fluttering it may be a sign of arrhythmia. In addition, the heart's chambers — its ventricles and auricles may grow larger with age. As their walls thicken, the amount of blood they can hold decreases. The risk of arrhythmias, such as atrial fibrillation (AFib), increases, with the accompanying risk of stroke, particularly among older adults.

Similarly, the valves controlling the flow of blood as it passes between the heart's chambers may thicken and become stiffer, limiting the flow of blood.

Heart valves may also develop leaks, which could lead to fluid buildup in the lungs, feet, abdomen, or legs.

What causes premature heart aging?

As indicated by the new study, people with certain health conditions may have a higher risk of premature heart aging.

According to the Centers for Disease Control and Prevention (CDC), four common factors that may lead to premature heart aging include:

► High blood pressure (hypertension)

- With higher blood pressure, the heart has to work harder to pump blood throughout the body. This can cause the lower left ventricle, the lower left chamber, to thicken and enlarge, increasing the likelihood of heart attacks and heart failure.
- Diabetes Research has found that having high blood sugar can damage blood vessels in the heart, leading to a buildup of fatty deposits there. It is associated with a greater likelihood of heart disease.
- ► **High LDL cholesterol** This causes a plaque buildup of a waxy, fat-like substance in arteries that can decrease blood flow to the heart, as well as the brain, kidneys, and other parts of the body.
- ▶ **Obesity** Obesity has been associated with both hypertension and high LDL cholesterol levels.

How to keep your heart young

There are currently no universal measurements for determining heart age, but the Australia Heart Foundation's online Heart Age Calculator can provide you with a

"We are still in the early stages of understanding how best to determine a 'heart age' and how such a calculation could help us to better take care of patients," Chen noted.

To preserve heart health and its functional age, following the American Heart Association's Life's Essential 8 is a great place to start. Here's a closer look at how lifestyle factors influence heart health.

Exercise regularly

There is widespread consensus that 150 minutes of moderate aerobic exercise each week or 75 minutes of vigorous exercise combined with strength training two days a week is the optimal amount for optimal heart

Leading a sedentary lifestyle has been consistently linked with an increased risk of heart disease and related deaths.

"A sedentary lifestyle causes circulation to slow. The heart muscle weakens, and leads to weight gain, high blood pressure, and insulin resistance," Christopher Berg, MD, board certified cardiologist at MemorialCare Heart and Vascular Institute at Orange Coast Medical Center in Fountain Valley, CA, explained to Healthline. Berg wasn't involved in the study.

"Sitting for extended periods of time also promotes inflammation and poor arterial function, and as a result raises your risk of heart disease," he said. "Even those who exercise can be at risk if they are sedentary for most of the day."

Beyond exercise, there are ways to enjoyably add more movement to one's day, including:

- taking walks
- standing up and briefly getting away from one's desk
 - doing yoga
 - parking a longer distance from the door
 - dancing
 - engaging in any sport
- taking the stairs instead of the elevator when going up or down just a few floors
- gardening and doing housework

Eat a healthy, balanced diet

Build meals from healthy, unprocessed foods as much as possible, with an emphasis on vegetables, fruits, whole grains, legumes, beans, and nuts.

For protein, emphasize lean animal proteins. These include skinned poultry, fish, seafood, and low-fat dairy. Alternately, go with plant-based proteins such as beans, nuts, and lentils, tofu (soy), or seitan (wheat gluten). Prepare your healthy ingredients with plant-based oils. These include extravirgin olive oil and avocado oil.

Try to avoid fast foods, processed meats, and other ultra-processed foods that tend to be high in trans fats that can damage the heart. Healthline

And Chiefs looked to seize an opportunity, believing they could sign the player as a free agent, with Spurs demoted to amateur status.

Spurs contested this, but this week Velebayi was declared a free agent, sparking outrage from the Mother City club.

Poland manager says Lewandowski wants to return to national team

Lewandowski wants to play for his country again, Poland manager Jan Urban said on Tuesday, after the Barcelona striker quit the national team amid a row over the previous coach's decision to replace him as captain.

"I wouldn't just like to talk to Robert, but also to those involved - Piotr Zielinski and the players on the team council. The decision will be mine, but I'd like to listen to the players and find out what they think."

Poland's next World Cup qualifier is against the Netherlands away on 4 September before they host Finland three days later.

The Wallabies take on the Springboks in their first two Rugby Championship matches, first in Johannesburg this Saturday and then in Cape Town the following weekend.

Australia have not won at Ellis Park since 2009 but they are coming from an encouraging performance in their home series against the British & Irish Lions. They lost the series 2-1 but only due to a controversial refereeing decision in the dying minutes of the second game. The Wallabies won the final match emphatically, 22-12, and have spoken about carrying that momentum into the Rugby Championship.

Erasmus, who in a friendly wager with his fellow coaches thought the Wallabies would win the second Lions Test, was again full of praise for their resurgence in world rugby, after they came last in the last two Rugby Championships and failed to reach the World Cup quarter-finals for the first time

"We are under no illusions that the moment you start clicking, start understanding each other and the real belief is there - it is not plastic belief - people don't just talk it up but they play it up," Erasmus said, after naming his squad for the first match.

"I think they are currently playing it up on the field. So I think this Rugby Championship is very open to all four teams."

Still, the Springbok coach said it was hard to know the level an opposition team was at physically and mentally until they actually played them.

Springbok coach lauds work done by Schmidt

Erasmus applauded the work done by Schmidt, who will be replaced by Les Kiss next season.

He said that while coaching Munster from 2017 to 2019, he actually reported to Joe Schmidt, who was coaching Ireland at the time, because of the organisational structure


"Joe is a great coach. He is a very particular guy, a very detail-driven guy. He certainly knows what he wants."

Erasmus said Schmidt would like to finish on a high, and the Wallabies have respect for

"Everyone is talking about the belief he brought back. The fight for the jersey is back. We have a lot of respect for that and also the squad he is building."

"Sacha and Handre will probably play in Cape Town, so we are just trying to spread the load a bit there. And we know Damian (Willemse, on the bench) can play flyhalf, so we feel we are well covered," said Erasmus on Monday after naming his team for the match on Saturday. Bournemouth have now sold three of their first-choice defensive line-up from last season after Milos Kerkez moved to Premier League champions Liverpool and Dean Huijsen was transferred to Real Madrid.

Qatar-owned PSG, who thrashed Inter Milan 5-0 to win the Champions League for the first time in May, also signed highly-rated Lille goalkeeper Lucas Chevalier last Saturday, a move that appears to herald

"It was just a rollercoaster," said the second seed, who was winning his 12th straight match at the Masters 1000 level after taking the titles in Monte Carlo and Rome.

"Lots of good feelings, bad feelings, back to the good ones. I am happy to get the win at the end. I know that I have chances to do bet-

Alcaraz committed 44 unforced errors and said conditions in Cincinnati, where he was runner-up in 2023, were always tricky.

"The ball flies a lot, goes super fast," he said. "You have to be ready to be in a good position for each shot and that is really difficult to do."

JANNIK Sinner ignored power failure interruptions and a blaring alarm to defeat Gabriel Diallo 6-2, 7-6 (8/6) on Monday's day of distractions at the ATP and WTA Cincinnati Open. The top seeded defending champion got down to business against a Canadian ranked

35th who was plagued by eight first-set double-faults and 49 unforced errors in the match as he faced the best in the world. Sinner recovered smoothly

That minor malfunction came two hours after the chaos of a widespread power outage which completely stopped play around the grounds for 75 min-

Five minutes later, with Sinner leading 1-0 in the second set after winning the first, the chaos continued with an alarm going off somewhere in the stadium and play suspended for the third time.

Sinner and Diallo continued to carry on with the distraction blaring somewhat faintly in the background before it finally halted after another game.

Sinner polished off victory for his 23rd consecutive hardcourt win in under two hours.

"It was a very difficult day at the office," the Italian said. "You have to find the balance against these big servers. I struggled with that at times today.

"But I need tough matches

like this, I'm happy I got one before the Grand Slam... I'm happy about today, but I know I can do things better."

US fourth seed Taylor Fritz endured a one-hour delay after the first set before defeating Lorenzo Sonego 7-6 (7/4), 7-5 for a 21st win in 25 matches.

"I can play better, but there has been no time to really train and get ready," Fritz said. "I'm looking forward to fine tuning the week before the US Open."

Compatriot Frances Tiafoe advanced past Ugo Humbert of France 6-4, 6-4 in 82 minutes and lines up next against Holger Rune, who beat Alex Michelsen 7-6 (7/4), 6-3.

NO 1 SABALENKA WINS

In the WTA event, topranked Aryna Sabalenka fought through a three-hour battle to hold off an inspired Emma Raducanu 7-6 (7/3), 4-6, 7-6 (7/5) for a fourth-round spot in a repeat of a victory from the Wimbledon third round in July.

Defending champion Sabalenka endured a struggle but finished with two aces in the closing stages.

"I'm happy to get through this difficult match," Sabalenka said. "I just hope tomorrow is a day off. I need time to recover from such a great battle."

British No 1 Raducanu survived a 25-minute eighth game of the final set, which went to 13 deuces, with Raducanu saving four break points before finally holding for 4-all and eventually into a tiebreaker.

Sabalenka squeezed out victory with a sixth ace for 5-4 in the breaker and delivered her seventh on her second match point to win in three hours and nine minutes.

"It was all about momentum," Sabalenka said. "I took some risks at the end, went for crazy shots, went to the net."

Sabalenka is bidding for her 10th trophy at the 1000 level and second this season after winning at Madrid.

"I can take lessons from this," Raducanu said. "With work and practice I think I can hold my level higher for longer.



MBABANE Highlanders patrons have hit back at the club's former President, Bheki 'Rubber' Simelane.

The capital city giants' veterans, through their Chairman Thembinkosi Mamba, says the termination of Simelane's 18-month contract was lawful.

This is contained in his answering affidavits prepared by their lawyer Emmanuel Shabangu from Robinson & Bertrams Attorneys.

Simelane took the Patrons to court demanding his reinstatement as the capital city giants' President following the termination of his 18 months contract.

"The termination of the management contract was lawful and the contract to the application assertion was never reinstated," the Patrons said.

Mamba further averred that Simelane breached his contract after he allegedly failed to pay the players' salaries during the 2024/25 season.

"This was, in essence, a contract for personal service because it entailed administering the club, paying salaries, and looking after the welfare of persons associated with the club. It is established that parties to a personal service contract of this nature have at common lawful the law the right to terminate a contract. In the present Instance, the respondents terminated the management agreement on Grounds of breach," Mamba said.

Mkhize has been cited as the third respondent on the matter, and she is represented by Nkosingivile Dlamini from Dynasty Inc. Attorneys.
