HIS Majesty King Mswati III on Wednesday commissioned the continuation of the Butimba hunting expedition, leading thousands of regiments in a spirited march to Emalahleni.

The warriors, dressed in their traditional regalia, marched with enthusiasm and pride despite the scorching summer heat. Singing and dancing echoed across the landscape as the King led his regiments in one of the most celebrated cultural events of the Swazi nation.

Butimba, a traditional hunting ceremony, is a centuries-old practice that brings together warriors from across the Kingdom. It is not only a test of endurance and bravery but also a reaffirmation of unity, culture, and loyalty to the throne. Selected wild game is hunted during the exercise, symbolizing both the sustenance and the collective strength of the nation.

Addressing the regiments through his leadership, His Majesty reminded warriors of the sacredness of the occasion, encouraging them to preserve the cultural values that have been passed down from generation to generation.

Observers noted the high spirits among the warriors as they braved the long march, some chanting victory songs, while others performed war dances. The energy and vibrancy of the regiments underscored the deep cultural significance of Butimba to emaSwati.

The hunting expedition, which began earlier this week, will continue in selected game reserves under the guidance of His Majesty. Beyond its cultural importance, the event also serves to strengthen bonds of brotherhood among regiments while reviving traditional practices that form the cornerstone of Eswatini's identity.

THE Eswatini National Provident Fund Pension Bill of 2025, in its current form if turned into an act of Parliament, would leave the Public Service Pension Fund (PSPF) a staggering E7 billion in the red.

The PSPF current deficit stands at E5 110 943 while the net assets stand at E37 589 103 and the liabilities stand at E42 700 042.

"The administration costs will be doubled as it were if this goes ahead. If implemented now, it could carry as much as E2 billion in five years worse off in terms of deficit and we are currently at E5 billion, so in five years we would be E7 billion," Vilakati explained

Outlining why they are standing their ground on the ENPF Pension Bill in its current state with the inclusion of civil servants, PSPF CEO Masotja Vilakati told members of the Editor's Forum on Thursday evening at Ingcamu Building that the bill in its current form would systematically kill PSPF.

"Civil Servants must not be made worse off. Reducing PSPF contributions or including civil servants in the conversion will make members worse off. Pension rights are protected under both the Pensions Order and the Constitution of the Kingdom," he said.

Vilakati re-emphasised that PSPF

supports the conversion of ENPF for its members, but excluding civil servants since government is not committing additional funds. He revealed that civil servants were excluded from ENPF as far back as 1974 and were catered for under separate legislation.

Vilakati further raised legal issues around the ENPF Pension Bill, saying that forcing civil servants into two statutory funds could be unconstitutional and financially unsustainable.

"There is no new budget allocation: Government has not provided fresh funds to support the conversion, which means contributions from the state as an employer would be reduced," he added.

Vilakati hightighted that there is a deficit risk and any reduction in contributions would require reducing benefits, a move that is not legally supported and would push PSPF towards unsustainability.

"Civil Servants dedicate their lives to serving the nation. Their pensions are a promise of dignity after years of service and that promise must be protected," Vilakati stressed.

IN the quest to ensure dedication to transparency and participatory governance, Parliament has called upon members of the public to share their views on the proposed Leadership Code of Conduct Bill of 2025, which proposes that public officials should not receive gifts above E5000 and the conversion of ENPF to Eswatini National Pension

The conversion of the Eswatini National Provident Fund (ENPF) is contained in the Eswatini National Pension Fund Bill of 2025.

The call, which has been communicated by Clerk to Parliament Benedict Xaba, follows recent wide-ranging stakeholder engagements where a strong recommendation was made that, in the spirit of zero tolerance in the fight against corruption, pastors should also be compelled not to receive gifts above E5000 either from congregants, businesses, or individuals. There have also been mixed reactions from various stakeholders on the conversion of ENPF to the Eswatini National Pension Fund.

It has been explained by ENPF Chief Executive Officer (CEO), Futhi Tembe, that the conversion was a progressive step aimed at creating a more equitable society. She said the new

pension system would not only include employees in the formal sector but also extend to workers in the informal economy and domestic workers who have long been excluded from such systems.

The CEO stated that this would broaden the fund's scope, marking a pivotal moment for social security in Eswatini.

One of the key highlights of the conversion was the shift from the lumpsum payments offered under the provident fund

to monthly pensions for retirees.

ENPF explained that currently, when workers retire, they are provided with a lump sum, which could quickly run out, leaving them vulnerable to financial insecurity.

However, with the new pension system, retirees would receive consistent monthly payments, ensuring they have a steady source of income to support them throughout their retirement years. "This shift addresses the issue of income security, a challenge that many retirees face after leaving the workforce," ENPF explained.

On another note, it has also been emphasised by stakeholders that it would be important for pastors as well to be incorporated in the list of public officials bound by the Leadership Code of Conduct Bill of 2025.

In terms of the legislation, public officials include Members of Parliament (MPs), Royal Trustees, executive leadership of all institutions that receive government subvention, and regional administrators.

Other public officials who will not be expected to accept gifts or benefits that may influence their duties include school principals and their deputies, and lawyers affiliated with the Law Society of Eswatini.

Xaba explained that the bills are being reviewed by the House of Assembly and the House of Senate.

The leadership code of conduct stipulates that a public official shall not receive any gift or benefit or hospitality in kind of the value of E5,000.

The legislation stipulates that a gift or donation to a public official on any public or ceremonial occasion, or commission to a public official on any transaction, would

be treated as a gift or donation or commission to the government or institution represented by that public official, and such donation is to be declared to the commission or institution concerned. The commission shall keep an inventory of any gift.

Public to weigh in on ENPF conversion,

"Where a public official is in doubt as to the need for a declaration or the appropriateness of accepting an offer of a gift, hospitality, or other benefit, that public official shall consult the Commission for advice. The minister may, from time to time, prescribe the type, value of the gifts, donations, or benefits in kind. A public official who fails to comply with the provisions of this section contravenes this code and is liable to forfeit the benefit equivalent to the gift, hospitality, or benefit to the government or institu-

tion, and shall stand warned; or (b) be warned in writing," reads the act in part.

The Clerk to Parliament announced that the public would be allowed to submit their views in writing or orally.

He mentioned that those interested in making oral submissions should notify the designated Parliament Portfolio Committee Clerks on or before September 12, 2025.

Director of Communications at the Anti-Corruption Commission, Jabu Phakathi, recently called for zero tolerance towards any form of corruption. He warned that allowing any form of gift would be tantamount to acknowledging that corruption exists in the kingdom.

#### ETVA tightens grip on TV licence defaulters

TELEVISION viewers in the past who did not honour their TV licence payment obligation will soon be haunted by their action.

The Eswatini Television Authority (ETVA) intends to introduce a new TV license management system to counter significant gaps in TV license revenue collection.

In the quest to achieve this objective, the television station has issued an expression of interest to invite technologically capable service providers to express interest in designing, developing, integrating, and deploying a TV License Management System (TLMS) that is capable and but not limited to, accurately registering and billing TV owners, handling applications, and issue of TV trading licenses.

It has been explained that the desired system should also handle applications and the issuing of TV together with decoder import

When unpacking what prompted the development of a new management system, ETVA recounted that it had been experiencing significant gaps in TV license reve-



nue collection due to fragmented data systems, untracked TV imports, and limited enforcement

"Currently, there is no efficient, unified system that helps to reconcile customer data records with licensing compliance, therefore hindering both revenue collection and regulatory compliance," ETVA explained in the expression of interest issued by the Eswatini Public Procurement Regulatory Agency (ESPRRA).

The state-owned broadcaster added that it was embarking on a national initiative to enhance TV license compliance and revenue collection. IT was stated that this would be achieved through the development and integration of a centralized management system that would integrate with third-party systems.

"This system aims to streamline the management of TV licensing, billing, and compliance," it was

# Ex-MPs launch drone project

TINTFUNGO Consortium has launched a project of renting out drones for spraying or fertiliser spreading purposes to sugar cane and general farm-

Tintfungo Consortium is an investment company established and registered by former members of the 11th Parliament.

It was formed after the 2023 general elections, after a group of 24 ex-Members of Parliament (MPs), came together to establish a business company to invest some of their gratuity in wealth creating projects.

The company is registered and operating from Tshaneni office with another satellite office in Manzini.

The shareholders' meeting was held on Wednesday at Asante Guest House in Manzini. During the meeting, the Board also presented the first drone purchased by the company.

On Wednesday, the company received their first agricultural drone which will take part in the sugar industry and any general farming in need of spraying or fertiliser

The drones aim to provide a safe and cheaper option compared to using aerial spraying with aeroplanes that are expensive and environmentally unfriendly.

"We are proud to introduce this innovation to the kingdom and we look forward to the support of the local farmers currently spending a fortune renting aeroplanes for spraying crops," said the Chairman of Tintfungo Consortium and former Ndzingeni MP Lutfo Dlamini.

Dlamini mentioned that they are a commercial company rooted in the Tinkhundla philosophy of growing their own economy.

A GRUESOME murder has shocked the Macetjeni community in the Kholwane area after a 64-year-old man was brutally hacked to death inside his home on Tuesday night.

According to a police statement issued by the Deputy Chief Police Information and Communication Officer, Assistant Superintendent Nosipho Mnguni, the incident occurred on 26 August 2025 at around 8:00 p.m.

The victim, whose name is being withheld until his next of kin are officially informed, was attacked with an unknown sharp object by yet-to-be-identified assailants. He sustained multiple deep wounds on the head, one between the shoulders, and a fatal slit across the peck

Assistant Superintendent Mnguni described the incident as "a disturbing act of violence" and confirmed that police have launched an intensive investigation to track down the suspect(s).

"This is a serious case, and we are appealing to members of the public to come forward with any information that may assist investigators," she said.

The motive behind the brutal killing re-

mains unknown at this stage, though authorities have not ruled out the possibility of personal disputes, robbery, or other criminal elements.

Community members of Macetjeni expressed fear and shock following the murder, calling for increased police patrols in the area. "We are terrified because this happened inside a home, where one is supposed to feel safe. We hope the police will bring the killer to justice," said one resident.

The body of the deceased was taken to the morgue as investigations continue. Police have urged anyone with information to contact the nearest station or use the Crime Stop line.

It should be noted that this latest incident adds to the growing concerns about violent crime in rural areas, where residents often feel vulnerable due to isolation and limited security.





# Landlord applies for eviction order against owing tenant

A LANDLORD has taken a tenant, who owed rent for many months to the small claims court.

The plaintiff, Vukani Mpandze from Matsapha, informed the Small Claims Court Commissioner Phetsile Dlamini that he has rental houses at Matsapha and the defendant, Themba Mbhamali was a tenant in one of the one-room rented houses and as per the lease agreement, he was supposed to pay a sum of E500 per month in respect of rent.

He stated that however, Mb-hamali has defaulted payment of the rent for some many months, resulting in his debt accumulating to E<sub>3</sub> 500.

He mentioned that he was therefore, claiming the sum of  $E_{3}$  500 from Mbhamali.

"I am also praying for an eviction order against the defendant as he has breached our lease agreement," he said.

It is worth mentioning that Mbhamali did not attend the court session despite a summon having being issued to him to that effect and as a result, commissioner Dlamini issued a judgement, in Mbhamali's absentia, ordering him to pay Mpandze the sum of E3 500.

Commissioner Dlamini further issued an ejectment order against Mbhamali.

An ejectment order is a court order directing someone to vacate real property because they occupying it without the owner's permission, and it is typically used when there is no landlord-tenant relationship. Unlike an eviction, which usually involves a tenant, an ejectment action is for situations like a squatter occupying land or a tenant who has stayed after a lease has ended or breached. The property owner must prove their rightful ownership and that the occupant has no valid right to be there to obtain an order for the occupant to leave.

#### Man gets 15 years in jail for raping 11-year-old girl

A 30-year-old man has been sentenced to 15 years in prison without an option of a fine for raping an 11 year-old minor.

Mcoleleni Shongwe of Bhahwini area was sentenced by Principal Magistrate Florence Msibi on Thursday at the Manzini Magistrates Court.

This comes after he was charged with contravening the Sexual Offences and Domestic Violence Act, following his inhumane act of forcefully having sexual intercourse with a minor

He committed this offence on March 22, 2025 at Bhahwini area.

According to the charge sheet, the rape was accompanied by aggravat-

ing factors in accordance with the Criminal Procedure and Evidence Act, in that he did not use a condom during the commission of the offence, thus exposing the minor to sexually transmitted diseases, including HIV.

When the survivor, who is doing grade VI in one of the primary schools in Manzini, was called into the witness dock to lead evidence in order to prove the commission of the offence, she told the court that on the day the offence was committed, she was washing her grandmother's blanket when Shongwe approached her and requested that they should go behind one of the houses within

the family compound because he wanted to see how her private part looked like.

"I refused to heed to his directive, and he pulled me towards a rondavel house which was fortunately locked. He then pulled me towards the kitchen in one of the houses within the family yard, where he proceeded to rape me," she said.

Even though Shongwe had pleaded not guilty to the charge, after overwhelming evidence implicating him to the offence, he was found guilty as charged and had the sentence meted against him.

SURVIVORS of convicted serial rapist Carlos Nhabombe told the High Court that they were able to identify him through his distinctive facial scar and unusual way of speaking.

Judge Mbutfo Mamba read testimonies in which survivors consistently described a man of medium height and build, dark in complexion, with short hair and a beard.

The court heard that Nhabombe's speech was mainly in Siswati but carried a different accent which immediately stood out.

Survivors said his voice, along with a scar on his face, became defining features that helped them remember and eventually point him out.

Another tactic used by Nhabombe, according to the indictment, was to terrify survivors by claiming that if they screamed, other men hiding in the bushes would join in the assault. This psychological threat, combined with strangulation and the use of a knife, often paralysed his victims with fear.

The High Court this week confirmed that Nhabombe was guilty of raping 12 minors and young women, in cases stretching back

more than a decade. Initially facing 18 charges, he was acquitted on three and convicted on 12 counts.

Judge Mamba said full written reasons for the judgment would be handed down on September 9.

Meanwhile during submissions, Crown Counsel Precious Dlamini argued that the crimes were aggravated by several factors: most of the survivors were minors, violence was repeatedly used, threats of death were made, and the accused deliberately refused to use protection, exposing survivors to the risk of HIV and other sexually transmitted infections.

The Crown called on the court

to impose the harshest sentence possible, noting that Nhabombe's actions displayed a calculated and predatory pattern that spanned years.

"He endangered an entire community of women and girls," Dlamini submitted, emphasising that the repeated nature of the attacks showed clear disregard for human dignity and life.

Judge Mamba pointed out that under the law, each count with aggravating circumstances carries a minimum sentence of nine years.

If the Crown's plea is upheld, Nhabombe could face a cumulative sentence of over 100 years behind bars. When asked if he understood the implications, Nhabombe responded in the affirmative.

The indictment outlined a chilling timeline of attacks which mentioning that on June 23, 2010, a 16-year-old was raped in Mbabane after being strangled and threatened with a knife. On March 31, 2012, a 13-year-old was raped repeatedly in a single episode, which the Crown described as one of the

most brutal incidents. On May 13, 2012, another survivor, aged just 11, was attacked. On March 16, 2012, yet another 13-year-old was raped.

Worth mentioning is that, several other counts involved young women aged 19 and 20 who were strangled, threatened with death, and raped multiple times.

In total, the Crown listed more than a dozen incidents marked by extreme violence, psychological manipulation, and intimidation.

The court also heard that some charges had to be abandoned because survivors were too traumatised to testify.

In certain instances, children broke down crying uncontrollably when recounting their experiences. For others, the memories remained fresh years later, causing what Judge Mamba called scars invisible to the court but deeply entrenched in their lives.

He warned the media to report carefully and sensitively on the matter, given the ages of the survivors and the lifelong trauma they carry.

#### Kombi conductor arrested for alleged rape of toddler

IN a separate case, a kombi conductor has been arrested for allegedly raping a 15-month-old toddler in the Shiselweni region.

Police confirmed that Nduduzo Dlamini (18) of Ndubazi was taken into custody after the child's mother discovered the assault on Monday.

The accused had been living with the family after being taken

in by the toddler's father, who is a kombi driver.

Sources said the incident unfolded while Dlamini was playing with the child. The mother reportedly noticed the toddler did not have her diaper on and went inside to fetch a new one.

When she returned, suspicions were raised and the matter was immediately reported to police.

The child was taken to hospital

for medical examination. Dlamini has been charged under the Sexual Offences and Domestic Violence (SODV) Act and appeared in the Nhlangano Magistrate's Court, where he was remanded in custody pending trial.

Under Section 3(1) of the Act, rape of a child under 14 carries sentences of up to 35 years for a first conviction, and up to 40 years if aggravating factors are proven.

#### Man fined for assaulting ex-girlfriend

A 38-year-old man from Khuphuka has been sentenced after assaulting and threatening to kill his former girlfriend, whom he accused of aborting his child. The accused, Vusi Sicucumba Mantimakhulu, appeared before Principal Magistrate Florence Msibi at the Manzini Magistrates Court, facing two counts under the Sexual Offences and Domestic Violence (SODV) Act.

According to court evidence, Mantimakhulu physically assaulted his former girlfriend, Temaswati Dlamini, hitting her several times with open hands and fists.

The assault, the court heard, caused harm and imminent danger to Dlamini's safety, health and well-being.

On the second count, Mantimakhulu intimidated Dlamini by threatening to kill her.

When narrating events leading to the offence, Mantimakhulu told the court that he had acted after learning from a friend of his ex-girlfriend that she had allegedly aborted his child.

"I was told by her friend that she had aborted my baby. I approached her and she confessed in the presence of my parents that she had indeed aborted the baby," he claimed.

After considering the evidence, Princi-



pal Magistrate Msibi found Mantimakhulu guilty on both counts.

In mitigation, Mantimakhulu pleaded for leniency, stating that he was unemployed and survived through odd jobs. He also expressed remorse for his actions.

The court sentenced him to one year imprisonment with an option of E<sub>3</sub>, 000 for the assault charge. On the intimidation charge, he was cautioned and discharged.

# Govt extends input subsidy with new reforms to strengthen food security

THE Government of Eswatini has reaffirmed its commitment to strengthening national food security and supporting livelihoods through the continuation of the Input Subsidy Programme for the 2025/26 farming season.

The programme, which will open for payments on September 1 and close on September 30, 2025, or once the budget has been exhausted, introduces several reforms aimed at tightening eligibility and ensuring the subsidy benefits the most vulnerable and productive farmers.

The Ministry of Agriculture in collaboration with the National Maize Corporation (NMC) announced on Thursday that, the scheme will maintain its co-financing structure, under which government and farmers share the cost of input packages.

The arrangement is intended to lower the financial burden on producers while promoting accountability and shared responsibility in food production.

According to the Minister Mandla Tshawuka the cost of a white maize input package remains set at E12,000, with government and the farmer each contributing E6,000.

"Similarly, red speckled beans are priced at E12, 000 per package, split equally between the farmer and the state at E6, 000 apiece. Sorghum is valued at E6, 400, with each party contributing E3, 200," said the Minister.

Tshawuka further noted that, by halving the upfront cost for producers, the subsidy effectively doubles farmers' purchasing power and makes vital inputs more accessible.

He highlighted that the pricing structure was designed to encourage broader participation, particularly among small and medium-scale producers.

Payments for the subsidy can be made through Eswatini Bank, MTN MoMo, and Eswatini Mobile's e-Mali platform, with no changes to the payment systems used in previous years.

Farmers are urged to pay early to secure their packages, as disbursements will be made on a first-come, first-served basis until the allocation is depleted.

The tractor hire component of the programme also remains in place, with government continuing to subsidise E180 per tractor hour.

Farmers will pay E400 per hour, compared to the full cost of E580. However, once the allocated budget is exhausted, farmers will be required to cover the entire rate.

The Ministry noted that the tractor hire subsidy has been particularly valuable for smallholder farmers who lack access to mechanisation. By keeping this provision in place, the programme aims to preserve affordability and ensure timely land preparation ahead of planting.

Following sustained public criticism that the subsidy disproportionately benefited larger and wealthier farmers, the Ministry of Agriculture, working with NMC, has revised the eligibility criteria.

These reforms are intended to direct benefits more effectively to vulnerable households and ensure greater transparency in programme administration.

The key changes effective for the 2025/26 season include:

Farmers must now apply to be part of the pro-

gramme, rather than accessing packages automatically.

Applicants must demonstrate that soil analyses have been conducted by presenting test results not older than three years, or proof that soil samples have been submitted for laboratory processing.

Farmers with stable incomes exceeding E12,000 per month will not qualify for the subsidy.

#### Cultivation

Input allocation will be guided by agro-ecological zoning, ensuring that crops are distributed in areas best suited for their cultivation.

Beneficiaries of other government farming programmes, such as Hamba Ubuye, will not be eligible for the input subsidy.

Each nuclear family will be limited to one beneficiary, preventing duplication within households.

Beneficiaries will remain in the programme for a maximum of three years, after which they will graduate to make room for other applicants. This count begins with the 2025/26 season.

In addition, farmers with as little as 0.5 hectares are now eligible to participate. These smaller producers will be allowed to purchase input packages proportionate to their land size, either 0.5 hectares or one hectare.

The new threshold is expected to broaden participation by accommodating subsistence and semi-commercial farmers who were previously excluded.

A further adjustment is that bean input payments will not be required in September. Instead, a short payment window will be available in January, aligning the schedule more closely with the planting season for beans.

The Minister emphasised that the reforms are aimed at balancing inclusivity with accountability.

"This programme is a cornerstone of our national food security strategy. By refining eligibility and expanding access to smallholders, we are ensuring that support reaches those who need it most while protecting the integrity of the subsidy," he said.

The Minister added that the three-year graduation system is designed to prevent long-term dependency and encourage farmers to transition toward self-sufficiency.

"We want to empower farmers, not create reliance. By setting a three-year limit, we are providing a ladder for many to climb, while opening the door for others to benefit in future seasons,"

Agriculture remains a critical sector for Eswatini's economy, supporting both livelihoods and industrial supply chains.

Analysts note that the subsidy programme has the potential to stabilise rural incomes, stimulate local demand for inputs and services, and reduce the country's reliance on imported grains and legumes.

By lowering the cost of production, the scheme is expected to improve profitability margins for participating farmers.

This in turn may enhance food availability in local markets and contribute to price stability for staple commodities.

Furthermore, the inclusion of smallholder farmers with plots as small as 0.5 hectares is seen as a step toward more inclusive agricultural growth. The expansion is anticipated to increase aggregate production levels, particularly in maize, which is the country's primary staple.

# American Bitcoin, backed by Trump sons, aims to start trading in September

SIBANYE Stillwater narrower first-half loss on Thursday, as production credits at its U.S. palladium business and the restructuring of its South African mines partly offset big writedowns at its U.S. and Finnish

The Johannesburg-based miner posted a loss of \$211 million, for the six months to June 30, down from a \$372 million loss the year before, when it booked a \$407 million impairment on its U.S. operations after cutting its forecast for palladium prices.

Under the Inflation Reduction Act enacted in 2022, the U.S. offers credits as an incentive for the domestic production of critical minerals, including palladium.

"The positive financial outcomes from solid operational management and decisive restructuring were amplified by the incorporation of Section 45X credits in terms of the Inflation Reduction Act," Sibanye said in a statement.

Sibanye said a total \$285 million of combined estimated credits from the 2023 financial year had been recognised, boosting profitability for the first half of 2025. Cash payments are expected in 2026, it added.

However, the company said the produc-

tion credits would be phased out from 2031 and terminated in 2034 under U.S. President Donald Trump's signature spending law. That prompted Sibanye to book another 3.8 billion rand impairment of its U.S. business due to the expected decrease in future cash

Sibanye on July 31 petitioned the U.S. to impose a tariff on Russian palladium imports to support the long-term viability of U.S. supplies. Russia's Nornickel is the world's largest palladium producer with a 40% share of global mined output.

A final decision on the petition is expected within 13 months.

"The preliminary duties and determinations are expected in the next three to five months," Charles Carter, Sibanye's chief regional officer for the Americas, said during a results call.

U.S. imports of palladium from Russia jumped 35% from 2022 to 2024, and increased by another 50% in the first quarter of 2025, Carter added.

Sibanye also wrote down 5.4 billion rand from the value of its Keliber lithium project in Finland, citing a decrease in the long-term price forecast for the battery mineral.

Ethiopia will have a 40% stake in the venture while Dangote Group will own 60%, EIH Chief Executive Brook Taye said at the signing ceremony in Addis Ababa.

An EIH statement on X quoted billionaire Dangote as saying that the investment represented a "shared vision to industrialise Africa and achieve food security across the continent". (Reuters)

# American Bitcoin, backed by Trump sons, aims to start trading in September by two of U.S. Provident Popular.

American Bitcoin, the bitcoin miner backed by two of U.S. President Donald Trump's sons, has locked in crypto and traditional investors to back an all-stock merger that will allow the firm to soon start trading on the Nasdaq, the company's largest investor said.

The unlisted firm's merger with Gryphon Digital Mining (GRYP.O), opens new tab is set to be finalised shortly, and the goal is to start trading in early September, according to Asher Genoot, the CEO of Hut 8 (HUT.O), opens new tab, which holds 80% of American Bitcoin.

Anchor shareholders in the listing have been finalised, he said, adding crypto exchange Gemini's co-founders Tyler and Cameron Winklevoss had invested in the new firm.

Gemini did not immediately respond to Reuters' requests for comment.

American Bitcoin's co-founder, Eric Trump, his brother Donald Trump Jr and Hut 8 (HUT.O), opens new tab, will own a combined 98% of the newly formed entity, which will retain the name American Bitcoin and trade under the stock code ABTC.

"Instead of going public directly via IPO, we thought that there was a lot more advantages to financing if we had an existing company that already had access to different financing too," Genoot told Reuters at the Bitcoin Asia conference in Hong Kong.

Eric Trump is also in Hong Kong and will travel to Tokyo at the weekend for an event for Metaplanet, a Japanese bitcoin treasury firm, Genoot said.

American Bitcoin is hunting for crypto assets to buy in Hong Kong and Japan to build out its global business, the Financial Times reported two weeks ago.

Genoot said American Bitcoin could take stakes in companies outside the U.S. to give people access to publicly listed bitcoin assets, as some investors were prevented from buying Nasdaq-listed stocks.

"Right now it's very early. So we haven't been committed to anything," he said.

Launched in March 2025 by Hut 8, together with Eric Trump and Donald Trump Jr, American Bitcoin has vowed to become "the world's largest, most efficient pure-play bitcoin miner."

The creation of the firm comes as the U.S. accelerates crypto-related legislation to support the growth of the industry under President Donald Trump.

Genoot said the new firm would accumulate the cryptocurrency through both mining and buying.

"Instead of just a treasury strategy where companies raise money to buy bitcoin or just a mining company... we ebb and flow between which one is the best return at different times," he said.

Miami-based Hut 8 was also a crypto miner but has shifted its focus to energy infrastructure and data centers after launching American Bitcoin with the Trump sons.

Hut 8 will lease data centers to American Bitcoin, Genoot said.

President Trump's critics have accused him of conflicts of interest in promoting the crypto industry at a time when his family is involved in the sector, allegations which the White House has brushed aside.

Genoot said American Bitcoin's business had nothing to do with government, and Eric Trump was mainly involved in strategy, such as in relation to bitcoin mining, new site development and treasury strategy.

Separately, at the same conference, Nakamoto Holdings, a bitcoin treasury company led by crypto advocate David Bailey, said it was looking across Asia's crypto startup scene and planned to support early-stage companies to grow the crypto ecosystem.(Reuters)

#### Nvidia CEO says AI boom far from over after tepid sales forecast

NVIDIA opens new tab CEO Jensen Huang on Wednesday dismissed concern about an end to a spending boom on artificial intelligence chips and said opportunities will expand into a multi-trillion-dollar market over the next five years.

Despite Huang's upbeat view on AI demand, shares of the chip designer clocked losses triggered by a tepid third-quarter sales forecast that excluded potential revenue from China. The stock was down nearly 2% at \$178.43 in early trading on Thursday.

eeping China out of its forecast underscored the uncertainty caused by Sino-U.S. trade tensions despite Nvidia striking a deal with President Donald Trump for export licenses in exchange for 15% of China sales of its H20 AI chips.

Huang on Thursday also indicated that Nvidia would be open to giving the U.S. government a cut of sales from new Blackwell chips for China if it is allowed to sell them to Beijing, a Fox Business reporter said in a post on X

Following the earnings report, Huang had sought to reassure investors rattled by indications of slowing growth at the chipmaker at the center of the investment frenzy.

The founder and CEO's bullish outlook contrasts with recent signs of fatigue in AI-focused stocks and comments from industry leaders about overheated investor enthusiasm.

"A new industrial revolution has started. The AI race is on," Huang said. "We see \$3 trillion to \$4 trillion in AI infrastructure spend by the end of the decade."

While Nvidia shares have outpaced a roughly 10% gain in the broader market (.SPX), opens new tab, AI-facing stocks have shown signs of fatigue. OpenAI CEO Sam Altman set off alarm bells this month

when he said investors may be "overexcited" about AI.

On Wednesday, Huang sounded unperturbed.

"The more you buy, the more you grow," Huang said, arguing that Nvidia's technological advances allow customers to process increasing amounts of data while using less energy. "The buzz is: everything sold out."

Case in point: A customer outside China bought \$650 million worth of Nvidia's H20 reduced-capability chip aimed at the Chinese market in the latest quarter, the chipmaker said.

For China, Nvidia has been working to get a variant of its latest Blackwell chips approved for sale in the region, after Trump suggested he might allow the company to sell a scaled-down version.

#### HOME TURF DEMAND


Besides China, expectations of demand from Big Tech and data center owners known as hyperscalers have pushed up Nvidia's shares over the last two years ago.

"The mega caps are the ones propelling a lot of the capex that Nvidia is benefiting from. But obviously Nvidia still is growing, is able to sell," said Matt Orton, head of advisory solutions at Raymond James Investment Management.

"If anything, this just highlights that there's a lot of durability to this (AI) trade... The businesses of these hyperscalers can continue to accelerate, and you're not seeing any sort of sign of a slowdown being reflected in the results of Nvidia."

Huang based his forecast in part on the \$600 billion he expects for data center capital spending this year from major customers such as Microsoft, opens new tab and Amazon, opens new tab.

For a data center costing as much as \$60 billion, Nvidia can capture about \$35 billion, Huang said.

Nvidia and Huang, however, see little reason for AI chip profit growth to slow as second-quarter net income surpassed the fiscal third-quarter profit of Big Tech peer Apple opens new tab.

The company's high-end Blackwell chips are largely spoken for based on 2026 forecasts from its biggest customers. Its earlier-generation Hopper processors are being

snapped up too.

"When you have something that is new, and it's growing as fast as it is, and with all of the huge capex announcements from the hyperscalers, it's evidence that we're in the early stages" of the AI boom, said Globalt Investments portfolio manager Thomas Martin.

AT least four African countries will run out of specialised life-saving food for severely malnourished children in the next three months due to shortages caused by aid cuts, Save the Children said on Thursday.

Supplies were getting dangerously low in Nigeria, Kenya, Somalia and South Sudan of high-energy biscuits, peanut-based Plumpy'Nut paste and other treatments known as Ready-to-Use Therapeutic Food (RUTF), the British-based aid group said.

"At a time when global hunger is sky-rocketing, the funding that could save children's lives has been cut because of recent aid cuts," Yvonne Arunga, the charity's regional director for East and Southern Africa, said.

Save the Children did not name specific donors or funding reductions in its statement. Under President Donald Trump, the U.S. has slashed humanitarian assistance this year, and other Western powers have also been cutting funding as part of longerterm reductions.

Trump has said cuts to humanitarian aid are needed to ensure that grants align with his "America First" agenda and that other countries shoulder more of the burden.

Some clinics in the four African countries were turning to less-effective treatments for malnourished children, Save the Children

In Kenya, where an estimated 2.8 million people are estimated to have experienced high levels of acute food insecurity during this year's March-to-May rainy season, stocks are expected to run out in October, it added.

The statement said RUTF supplies in Nigeria, Somalia and South Sudan would run out within three months.

Government officials from the four coun-

tries did not immediately respond to requests for comment.

Globally, funding cuts are expected to cut off nutrition treatment this year to 15.6 million people across 18 countries, including 2.3 million severely malnourished children, Save the Children said.

Cuts by the Trump administration left 60,000 to 66,000 metric tons of food, including 1,100 tons of fortified biscuits, stranded in warehouses for months earlier this year, Reuters reported in May.

The U.S. government later agreed to hand over 600 tons of the biscuits to the U.N. World Food Programme but said it would have to destroy nearly 500 tons which expired last month.

Earlier this month, the U.S. State Depart-

ment announced it would provide \$93 million for RUTF supplies to treat more than 800,000 children suffering from severe acute malnutrition in 13 countries, including Nigeria, Sudan, Kenya and Democratic Republic of Congo.

## Egusi soup in space? Nigerian seeds launch into orbit

A staple of Nigerian cuisine, egusi soup, could one day be consumed on the Moon or on Mars after melon seeds from which the thick, fragrant dish is made orbited the Earth for seven days and returned to be studied by space scientists.

The egusi seeds were transported to the International Space Station by a capsule that launched from NASA's Kennedy Space Center in Florida this month, as part of a project to study how they react to conditions in space.

"The goal is that in the next couple of decades, when people are living on the Moon, on Mars, and they're looking at growing food ... foods that are native to Africa would be part of that," said Temidayo Oniosun, who selected the seeds for the mission.

"So even in 50 years' time, if Africans are living on the Moon, we want them to be growing and planting egusi," said the Nigerian entrepreneur, founder of intelligence company Space in Africa.

Egusi seeds, an excellent source of protein, were packed into specialised test tubes on the Crew-11 space capsule launched on August 1 along with some heritage seeds from Costa Rica, Guatemala, Armenia and Pakistan.

University of Florida scientist Wagner Vendrame, one of the researchers involved in the project, said that future astronauts would

need a better variety and quality ly space staples.

"Being able to grow their own, let's say, lettuce, tomatoes, or melons in space, is not only important for nutrition, for their health, but also it has psychological effects when you eat a melon that is fresh versus something that is processed," he said.

Oniosun, who picked the space-travelling egusi seeds from markets in the southwestern Nigerian state of Oyo, said the choice was motivated not only by the seeds' nutritional properties but also by culture and symbolism.

"Everybody in Nigeria eats eguof foods than the ultra-processed si, and even other people in some freeze-dried meals that are current- West African countries and Africans in the diaspora, so this (mission) is something they could identify with," he said. "Egusi is the seed that tells our story."

The seeds that were in orbit are now being distributed to researchers. Vendrame said they would be propagated in vitro and studied for genetic changes triggered by their time in orbit.

"By looking at the changes in the plants and the seeds themselves, we can tell - are those plants still the same? Would they still provide the same level of nutrition to astronauts?"(Reuters)

#### Valterra Platinum plans to start underground trial mining in late 2026

VALTERRA Platinum, opens new tab will start trial mining at an underground pit at its Mogalakwena openpit mine in South Africa late next year, an executive said on Wednesday.

Mogalakwena in Limpopo province, north Johannesburg, is the world's largest open-pit platinum group metals (PGM) mine, comprising five open pits. The ore body of its Sandsloot pit, where the underground mine is being developed, has higher grades of ore.

Platinum miners in South Africa have faced declining ore grades for years. To keep production going, companies have had to mine deeper underground, which makes operations more expensive and risky.

The mine is the crown jewel of Valterra's portfolio, contributing about 50% of the company's PGM production. The project to develop the Sandsloot underground mine is a nod of confidence in the future of PGMs, used primarily in autocatalysts and jewellery.

Prices of the white metals have mostly slid in the past two years, with demand hit by the rise of battery electric vehicles, which don't require them, leading miners to cut supply.

In July, the company said it has begun the feasibility study for the underground project with a targeted completion and investment decision in the first half of 2027.

"We're also envisioning a trial mining ...in the back end of 2026," Martin Poggiolini, executive head of corporate strategy told reporters during a media tour of the mine on Wednesday.

"If it meets our capital allocation we will be able to truck the first ore out of the top part of the ore body to the surface," Poggiolini said, adding that ramping up to a 3.6 to a 4.5 million tonne a year operation was possible beyond 2030.

With the underground mine, Valterra hopes to achieve its targeted 10% to 50% overall increase in Mogalakwena concentrate production, it said in July.

Poggiolini and Agit Singh, Valterra's head of processing operations, said the company is scaling up demand across existing markets such as hydrogen production and fuel-cell electric vehicles and creating demand in new segments.

"So we have really good confidence in the fundamentals around the PGM sector in the short term and certainly in the longer term," Singh said.

# Russian missiles pound Ukraine, damage EU and British offices

RUSSIA pounded Ukraine with deadly missiles and drone strikes early on Thursday in a sweeping attack that President Volodymyr Zelenskiy said was Moscow's answer to diplomatic efforts to end its war.

At least 18 people, including four children, were killed in the capital, officials from the city administration said. As the sun rose, rescuers dug through a wrecked block on Kyiv's left bank and pulled at least two bodies from the rubble.

The strikes damaged the European Union's mission and British Council offices in the city, officials said. The European Union and London summoned Russian envoys to protest. There were no reports of casualties at either site.

"Russia chooses ballistics instead of the negotiating table," Zelenskiy said on X, calling for new sanctions on Russia. "It chooses to continue killing instead of ending the

Russia said its attack had hit military industrial facilities and air bases, and that Ukraine had also attacked Russian targets. The Kremlin said it was still interested in pursuing peace talks.

Moscow has regularly denied targeting civilians. Ukrainian officials say scores of civilians have died in Russian strikes on densely populated areas over the recent months, and thousands since the start of the war.

During the attack on Kyiv, explosions rang out as clouds of smoke rose into the night sky. Drones whirred overhead.

Mayor Vitali Klitschko described it as one of the biggest attacks on the city in recent months. At least 38 people were wounded in the hours-long assault which damaged buildings in all city districts, officials said.

Across the country, Ukraine's military said Russian attacks struck 13 locations. National

grid operator Ukrenergo said energy facilities were hit, causing power cuts.

A push by Kyiv and its allies to end the invasion that Moscow launched in February 2022 has yielded little, despite meetings between U.S. President Donald Trump and his Ukrainian and Russian counterparts.

Russia has stepped up air strikes on Ukrainian towns and cities far behind the front line and pushed a grinding offensive across much of the east in a bid to pressure Ukraine into giving up territory.

"This is another grim reminder of what is at stake. It shows that the Kremlin will stop at nothing to terrorize Ukraine, blindly killing civilians and even targeting the European Union," EU Commission President Ursula von der Leyen told reporters in Brussels.

She said two missiles had struck near the

office within 20 seconds of each other. EU countries would soon come up with a were advancing work on how to use frozen Russian assets to help Ukraine, she added.

British Prime Minister Keir Starmer condemned the assault, which he said had damaged the British Council building. "Putin is killing children and civilians and sabotaging hopes of peace," he wrote on X.

Ukraine's military said air defences had downed 563 of nearly 600 drones and 26 of 31 missiles launched by Russia across the

One attack damaged a railway hub in central Ukraine's Vinnytsia region, where officials said a strike on critical infrastructure had left 60,000 residents without power.

Ukrainian officials have warned that Russia would step up strikes on the country's energy grid as winter approaches.

Russia's Defence Ministry said Russian air defences destroyed 102 Ukrainian drones overnight in at least seven regions.

Ukraine's drone force said it had struck the Afipsky and Kuybyshevskyi oil refineries as part of that attack.

Russia added that its forces had used an unmanned speedboat to hit and sink a Ukrainian reconnaissance boat on Thursday in the mouth of the Danube River.

Dmytro Pletenchuk, a spokesperson for Ukraine's navy, said the attack killed one person and several others were wounded or missing. He did not comment on the strike location.

The Danube ports are critically important for Ukraine, serving as an alternative to the Black Sea ports through which fuel and other critical cargoes are imported into the country.

#### 19th package of sanctions against Russia and In Chicago, locals prepare for Trump's possible deployment of National Guard

WHEN U.S. President Donald Trump threatened to flood Chicago with  $National \, Guard \, troops \, and \, Immigration$ and Customs Enforcement agents earlier this month, Illinois Governor J.B. Pritzker said the president lacked the legal authority.

But privately, Pritzker and Chicago Mayor Brandon Johnson began discussing what they could do to shield Chicago from a federal deployment like those underway in two other Democrat-run cities with Black mayors, Los Angeles and Washington, D.C. Their conclusion: not much.

As Trump has amped up the threat of a federal deployment in the nation's third-largest city in recent days, public officials and community organizers said they are doing what they can to get ready, however.

The offices of Pritzker and Johnson are closely coordinating. The state's attorney general, Kwame Raoul, said on Monday he was developing a legal strategy to execute if troops arrived. Immigrant advocates are stepping up legal training.

While some locals have expressed support for Trump's decision, many in the heavily Democratic-voting city are appalled.

Some community group leaders who work in Chicago neighborhoods most affected by violent crime said the presence of National Guard troops could undermine efforts to build trust. So would the appearance of cooperation between Chicago police officers and ICE, Chicago Police Superintendent Larry Snelling said.

At a press conference on Thursday, Snelling said that officers would not assist with federal law enforcement, but would not interfere with it either.

"We know people are living in fear," he said, "and working with ICE, it does nothing to help those relationships and in fact, it hurts. We're not going to ask for anyone's immigration status, we don't care. We're going to continue to stand up for the people in our city to make sure that they're safe."

On Monday, Pritzker spoke on the riverfront in downtown Chicago, flanked by Johnson and the state's most powerful Dem-

#### **CHICAGO CRIME**

Trump has justified his decision by painting a bleak picture of crime in Chicago, calling it a "disaster." Illinois Republicans have echoed that description, and are increasingly speaking up in support of Trump's pledged intervention.

Families "need leaders who will finally make Chicago safe," state Senator Neil Anderson said in a statement to Reuters.

Chicago has long had a reputation as a city with an elevated crime rate, particularly around gun violence. There have been 1,229 shootings so far this year, including a high-profile drive-by shooting in July target-

However, the city has made marked progress since the end of the pandemic, accord-

ing to Chicago crime data. Fatal shootings fell 36% from January 1 through August 25 compared to the same period a year ago. Its July homicide rate, opens new tab of 1.66 per 100,000 residents ranks it below Washington, New Orleans, Kansas City and Little Rock, Arkansas, among other cities.

The falling crime trend mirrors other U.S. cities, reflecting the impact of hundreds of millions of federal dollars allocated in recent years for teachers, police and social workers

- the people likely to influence at-risk youth most vulnerable to gun violence, said John Roman, a senior fellow at the research organization NORC at the University of Chicago.

Some of those funds, including \$158 million in grants for violence prevention programs across the U.S., were cut in April as part of the Trump administration's reshaping of government.



## Blxckie responds to backlash over Prokid comments in freestyle debate

HIP hop is still at the centre of hot topics weeks later, with conversations growing and different opinions flying after K.Keed refused to freestyle on DJ Speedsta's 5FM show.



#### What Is an Ice Pick Headache?

WHAT'S the best way to describe how an ice pick headache feels? It's like someone's stabbing your face with an ice pick. So, they're also called stabbing headaches.

Many people, from time to time, feel quick jabs or jolts of severe pain around one of their eyes or at their temple. They usually last only a few seconds.

They might happen in the same spot over and over again. Or you could feel them in different places each time, such as one temple and then the other.

#### Thunderclap Headache vs. Ice Pick Headache

Like an ice pick headache, a thunderclap headache comes on suddenly. But the difference is that an ice pick headache lasts a few seconds, while a thunderclap headache can stick with you anywhere between 1 and 5 minutes. Also, ice pick headaches happen in clusters, but a thunderclap headache happens in one burst. A thunderclap headache could also be a sign of a serious health issue, while an ice pick headache usually isn't.

#### Who Gets Ice Pick Headaches?

You're more likely to get ice pick headaches if you're prone to migraines or cluster headaches. But you could get them even if you don't normally have migraines. People usually first notice them between the ages of 45 and 50.

#### **Ice Pick Headache Causes**

It's not clear what causes ice pick headaches. But doctors do know they're not caused by disease or injury. You may get them because something is wrong with how your brain sends pain signals to your body.

Ice pick headache triggers may include:

- ► Sudden movements
- ▶ Bright light
- Stress

#### **Track Your Triggers**

It's a good idea to keep a headache diary. Write down when you have an ice pick headache and what happened before it started. If you had a stressful day at work before it hit, write that down. You can also use a mobile phone app instead of a diary.

Take this information to your next doctor's appointment so you can discuss ways to prevent these headaches. They may be able to suggest lifestyle changes, such as relaxation, to reduce stress.

#### Ice Pick Headache Treatment

Ice pick headaches may come and go quickly, so they're hard to treat. One medicine you might try to prevent an attack is indomethacin (Indocin, Tivorbex). It's a nonsteroidal anti-inflammatory drug (NSAID). It could cause side effects such as nausea, stomach bleeding, heartburn, and eye or kidney problems. You'll need an annual eye exam to make sure your eyes are healthy if you take it.

#### Ice Pick Headache Home Remedies

At-home treatments are another option to ease an ice pick headache. You can try:

suddenly start having stabbing headaches, especially if they're always on the same side, get worse over time, or are triggered by movement, see a doctor right away.

#### **Ice Pick Headache Prevention**

You may be able to avoid ice pick headaches with these steps:

- ► Eat nutritious foods.
- ▶ Get enough sleep.
- ► Cut back on caffeine and alcohol.
- ► Manage stress with exercise and relaxation techniques.
- ▶ Don't smoke or use other tobacco products.
  - ► Try biofeedback or acupuncture.

#### When to Seek Emergency Help

Ice pick headaches aren't serious in most cases. But other serious brain conditions could also make you feel similar pains. If you have brief headaches that feel like

#### Postural orthostatic tachycardia syndrome (POTS)

An excessive increase in the heart rate when moving from lying down to standing up characterizes POTS. This can cause dizziness, lightheadedness, and palpitations, which are also common in anxiety disorders.



#### Lyme disease

Lyme disease is an infectious disease caused by the bacterium Borrelia burgdorferi. It's transmittedTrusted Source through tick bites. Lyme disease can get progressively worse over time, especially if left untreated and unmanaged.

- ► How Lyme disease mimics anxiety: Many symptoms of Lyme disease, such as fatigue, headaches, and cognitive difficulties including a lack of concentration or "brain fog" — can be mistaken for anxiety or depression. Feelings of irritability and anxiety are common among people with Lyme disease.
- ▶ **Differentiating features:** Lyme disease often has a characteristic bull'seye rash, joint pain, and flu-like symptoms. Blood tests for Lyme antibodies can confirm the diagnosis.

#### **Fibromyalgia**

Fibromyalgia is a chronic condition, and widespread musculoskeletal pain, fatigue, and tenderness in localized areas characterize it.

- ► How fibromyalgia mimics anxiety: The chronic pain and fatigue associated with fibromyalgia can lead to significant stress and anxiety. In fact, anxiety and depression are common symptoms of fibromyalgia. Traumatic events may also trigger fibromyalgia, as they can anxiety disorders.
- Differentiating features: Fibromyalgia often affects specific, tender points on the body, as well as causing symptoms, like sleep disturbances and cognitive difficulties. To make a fibromyalgia diagnosis, a healthcare professional will usually rule out other causes and use specific criteria to assess your pain levels.

#### **Takeaway**

If you have received an anxiety disorder diagnosis but suspect a different condition may be at play, it may be a good idea to seek a second opinion with another medical professional. No matter what condition, or conditions, you may have, proper diagnosis and treatment can improve your quality of life. The correct diagnosis can be the first step in feeling better.

# 'Something has to change', says Amorim after United humiliation

A furious Manchester United manager Ruben Amorim said "something has to change" within the team after the pressure mounted on him following a humiliating League Cup loss to Grimsby.

In arguably their worst result since legendary boss Alex Ferguson retired at the end of the 2012/13 season, United were knocked out of an English cup competition by a fourth-tier side for the first time.

Having fought back from 2-0 down to draw 2-2, they lost a penalty shoot-out 12-11 on Wednesday.

Amorim cut a disconsolate figure having hoped the nightmare of last season, when United finished a woeful 15th in the Premier League, was behind them.

He had been backed by the board and spent £200 million on the attacking talent of Bryan Mbeumo, Matheus Cunha and Benjamin Sesko alone.

"(I have) no more answers. I do not even have anything to say," the 40-year-old Portuguese told the BBC after the match at Grimsby.

Amorim, who claimed his team deserved more points than just the one they have garnered in league matches with Arsenal and Fulham, conceded the performance against Grimsby rang alarm bells.

"I think something has to change," he said. "I think the team and the players spoke re-

ally loud today, so that's it. (Tonight) I think the best team won, the only team that was on the pitch.

"The way we start the game without any intensity, we were completely lost."

Amorim is the sixth permanent United manager since Ferguson retired.

Louis van Gaal and Jose Mourinho were among those to find the challenge of restoring the club as title contenders beyond them despite huge investment in players.

United defender Diogo Dalot said the team had lacked any fight.

"I think we gave the game to them, clearly, straight away, exactly what they wanted. Win duels, second balls, set-plays," Dalot told MUTV.

"We fought back, but I think that was the minimum that we could show to the fans that travelled for ourselves, for the club, but clearly not good enough."

AMORIM 'NEEDS TIME'

United have yet to win after three games so far this campaign, with Amorim repeatedly criticised for tactical inflexibility given he remains wedded to a 3-4-3 formation.

The Portuguese boss has overseen more defeats (19) than wins (17) in 10 months in charge at United.

But the former Sporting Lisbon coach received support from an unlikely source in victorious Grimsby manager David Artell.

"Ruben Amorim needs time," he said.

"He is an excellent manager and you don't become Manchester United manager, having done what he has done in his career, if he is not good at his job.

"He has shown he can do it. Just give him time and he will get it right.

"He is a good guy, I can see he is a good guy and he will put that club back to the top table if he does get that time." Amorim and United's next challenge is a Premier League home game against Burnley, who are coming off a 2-0 win over fellow newly-promoted side Sunderland, on Saturday.

"In this moment, we need to focus on the weekend and then we have time to think," said Amorim.

# Norris sees others closing gap with dominant McLaren

LANDO Norris said on Thursday that other teams were catching up with his McLaren outfit, expecting many tough battles ahead as the Formula One season enters the home straight.

McLaren have swept all before them this season, a dominant 299 points ahead of closest rivals Ferrari, with Norris and teammate Oscar Piastri clear favourites to take the individual title.

"Of course, we as a team (have) been strong this year. But I feel like other people have caught up a little bit the last couple of races," Norris told reporters.

"I don't expect to win by 20 seconds or something," added the 25-year-old, quipping however that he would "love it if that were the case".

He said McLaren were going into every race hoping to wrap up the top two positions but were careful to guard against complacency.

"I don't think we expect any race to go easily now... I don't think we ever get complacent and think it's going to be an easy one," he stressed.

He predicted a "long, tricky, challenging second half of the season" with 10 races to go.

One of the key factors in this year's Formula One run-in will be the extent to which McLaren allow their two drivers to race competitively for the title.

Norris said both drivers were still free to choose their own strategies

and race fairly – what McLaren calls "papaya rules" after the team colours.

As for championship leader Piastri, the Australian said he was steeling for a fierce climax to the season.

"The intensity will kind of naturally increase as we get close to the end of the year and I'm ready for that," said the 24-year-old.

The current world champion, Dutch driver Max Verstappen, goes into his home Grand Prix in an unfamiliar position – he is not the favourite.

While the hoardes of orange-clad fans will be hoping Max can pull off a miracle, his Red Bull is unlikely to have the pace to challenge the McLarans

However, the famously changeable weather at the Zandvoort circuit – just a stone's thrown from the North Sea – is poised to play a role again.

Rain is forecast for all three days of the weekend and Verstappen is known for his skill at wet-weather racing.

"There might be some weather coming in as well. So that always creates a bit of chaos, so we just need to see what happens," said Verstappen.

Verstappen currently sits third in the drivers' championship, 97 points behind pace-setter Piastri, but insisted the situation was not getting to him.

#### Pirates coach looking to juggle selection

ORLANDO Pirates coach Abdeslam Ouaddou wants to get his squad back to full fitness as quickly as possible to ensure he has many players to choose from as their fixture demands get more intense.

After Sunday's clash against Chippa United in Gqeberha (live on SuperSport, kick off 3pm), Pirates will have played eight matches in the first month of the new campaign and with participation in the African Champions League coming up next month, they face an even more hectic schedule as they juggle commitments both domestic and continental.

"We have such a big squad, and we are playing many competitions," Ouaddou said. "So like I always say, everybody will be important in the team. Everybody will have time to show his abilities in the team, depending on the situation, regarding the games and the competitions that will come."

The Pirates coach referred to the case of 34-year-old left-wingback Deon Hotto, who he took off at halftime on Tuesday when he showed signs of fatigue against Orbit College in their 1-0 victory in the Betway Premiership.

"With Hotto, we have to manage him because we are playing every three days, and I am not sure that if we want to protect the health of the players and for them to perform in the season, we can overplay them," he added.

There remains an added caveat, however, in that Bafana may be docked three points for fielding an ineligible player – Teboho Mokoena – against Lesotho in March.

The rules suggest this will happen, but Fifa have thus far said absolutely nothing. Nigeria, currently six points behind Bafana, are certainly doing all they can to get Fifa to act.

Bafana seem to still be leaning on a suggestion that as Lesotho did not submit an official complaint, Fifa may not act. "There was no complaint. How can you punish someone if there is no complaint?," added the Bafana coach.

"It is not Lesotho who are pushing. We didn't know Mokoena couldn't play that game.

"They (Nigeria) were not involved. They have an opportunity to come three points closer now. But if we see what we did until now why should we doubt and be worried and afraid? We have won all the games we needed to win."

#### Al-Ahly begin search for Riveiro's replacement

AL-AHLY are reportedly considering sacking head coach Jose Riveiro after an indifferent start to the Egyptian Premier League season.

Riveiro joined the Reds at the end of May, following a successful three-year stay at Orlando Pirates, where he won five trophies.

The Spanish coach led Al-Ahly at the FIFA Club World Cup in the US in June, but was knocked out in the group stag-

Now, after only three games in the new Egyptian Premier League season, fans are calling for his axing.

The Reds currently sit in sixth place in the league table with five points, having collected five points from three matches, with one win and two draws, prompting fans to revolt against the Spanish coach.

They next face Pyramids FC in the league on Saturday, a match that could determine Riveiro's future with Al-Ahly.

Search for Riveiro's replace-

ment begins

According to reports, Al-Ahly have already begun the search for a replacement for the Spanish coach.

"A source within Al-Ahly club revealed that Mahmoud El-Khatib has tasked Mohamed Youssef, the club's sporting director, with opening a line of communication with former Zamalek coach Jose Gomes," reported Eremnews.com.

"Youssef will contact Gomes in the coming hours and test his interest in coaching Al-Ahly, if Riveiro's departure is decided.

"Gomez achieved good results with Zamalek, winning the African Confederation Cup and then the African Super Cup against Al-Ahly."

Meanwhile, club legend Ahmed Shobier has called on the Al-Ahly fans to defend Riveiro like they did with other former Reds coaches like Pitso Mosimane and Marcel Koller.

"I see that Riveiro has been surrendered over a little to the fans," said Shobier as quoted by Nabd.com. (**Supersport**)

## US Ryder Cup captain Bradley won't have playing role

US Ryder Cup captain Keegan Bradley rounded out his squad on Wednesday, opting not to become the first playing captain in 62 years in the biennial match play showdown with Europe.

Bradley named his six captain's selections to complete the 12-man US team and didn't call his own name, saying he ultimately decided he must focus on his captain's duties as the Americans vie to regain the trophy they lost in Rome two years ago.

"I grew up wanting to play Ryder Cups," Bradley said at a press conference at the PGA of America headquarters in Frisco, Texas. "I grew up wanting to fight alongside these guys. And it just broke my heart no to play.

"But ultimately I was chosen to do a job," he added. "I was chosen to be captain of this team. And my ultimate goal to start this whole thing was to be the best captain that I could be.

"And this is how I felt like I could do this." The 39-year-old's strong season -- including a victory at the Traveller's Championship and six other top-10 finishes -- sparked speculation he would choose himself and become the first US playing captain since Arnold Palmer in 1963.

US President Donald Trump, who plans to attend the first of three days of competition at Bethpage Black in New York, was among those weighing in with the opinion that

Bradley should select himself -- Bradley calling it "surreal" that the matter would catch the attention of the president.

Bradley, who said he thought the Ryder Cup had grown into "a different animal" since Palmer's day, instead named two-time major winners Justin Thomas and Collin Morikawa, Ryder Cup veterans Patrick Cantlay and Sam Burns and Ryder Cup rookies Ben Griffin and Cameron Young.

"It was an extremely difficult decision," Bradley said. "I would say there was a point this year where I was playing, a while ago, and these guys stepped up in a major way and played their way onto this team," Bradley said.

"It was an extremely difficult decision, but one that I'm really happy with and with these six players.

"And I'm glad it's over," he added of the agonizing selection process.

They join the six automatic qualifiers for the US lineup: top-ranked Scottie Scheffler, two-time major winners Xander Schauffele and Bryson DeChambeau, US Open winner JJ Spaun and fellow Ryder Cup rookie Russell Henley and Harris English.

Scheffler has enjoyed another stellar season, with his five victories including major titles at the PGA Championship and British Open.

He headlines a US team vying to regain the

trophy they surrendered with a 16.5-11.5 loss to Europe in Rome.

Team Europe will retain the bulk of their
