HIS Majesty King Mswati III has made a strong call for an end to global conflicts, urging the international community to prioritise peace and development in the aftermath of the devastating Covid-19 pandemic.

The King made this strong call on Thursday at Lozitha Royal Palace during a ceremony to receive letters of credence to newly accredited ambassadors from five European countries- Hungary, Slovakia, Lithuania, Italy, and Finland. The new envoys are Attila György Horvath (Hungary), Vladimir Gracz (Slovakia), Rasa Jankauskaité (Lithuania), Gabriele Phillip Annis (Italy), and Satu Lassila (Finland).

His Majesty reflected on the hardships brought by war and global unrest, emphasizing that humanity must shift its focus toward healing and rebuilding.

"To experience all these big problems of conflict, we wish one day all these problems would be something we can put behind us so that we can concentrate more on development, especially because of Covid-19. The pandemic has taken a lot of lives in the world, and now it is time to put more effort into building nations, countries, economies, and so on. Therefore, we count on all of you as our partners, and we will work together in making this dream a reality," the King said.

The King warmly welcomed the diplomats to Eswatini, expressing hope that they would find their assignments both rewarding and enjoyable. He urged them not only to strengthen ties between their countries and Eswatini but also to take time to experience the Kingdom's people, culture, and traditions.

"I am very happy to welcome you all as the new ambassadors here in Eswatini, and I hope you will all enjoy being here. I hope that when the dialogue between the government and the EU takes place, most of you will be here so that we can discuss a lot of issues very constructively. I look forward to you making new friends, and I hope you will also give yourself enough time to visit the country and meet the people of Eswatini, to understand what they stand for," His Majesty continued.

Speaking on behalf of the new envoys, Hungarian Ambassador Attila György Horvath reaffirmed Europe's commitment to deepening ties with Eswatini and supporting the Kingdom's development path.

"Our presence here speaks volumes about the shared values and interests that connect us. In the framework of the 50-year-

strong partnership established between the European Union and the Kingdom of Eswatini, our countries have had various degrees of engagement with the Kingdom, evolving over the years to address the pressing issues in Eswatini's development journey," he said.

Investments

He highlighted Europe's contributions to Eswatini's key sectors, including infrastructure, agriculture, social protection, green energy, and emergency food security assistance. These investments, Horvath noted, were "testaments to unwavering commitment to the prosperity and growth of the Kingdom of Eswatini."

Efforts

Beyond infrastructure, the EU member states have also supported community-based groups across the country, recognizing them as vital drivers of social change in both rural and urban areas. Horvath said such efforts would continue as part of the ambassadors' missions.

"Our work is based on shared values, anchored in the rule of law, democracy, respect for human rights, and the fundamental freedoms enshrined in the African Charter on Human and Peoples' Rights, the International Covenant on Civil & Political Rights, and the Constitution of Eswatini," he said.

HIS Majesty King Mswati III has called upon government, businesses, and strategic stakeholders to take the world-renowned Umhlanga Reed Dance to even greater heights by transforming it into a full cultural festival.

The King emphasised that Umhlanga should not only showcase the dignity and tradition of Eswatini maidens but also serve as a grand platform for Eswatini's cuisine, organic teas such as Timbita, and other cultural offerings that will enrich the experience of visiting tourists.

Speaking at Ludzidzini Royal Residence, where he received gifts worth E18.9 million in support of the annual cultural ceremony, the King said the idea of displaying traditional dishes came to him during a visit abroad, where he witnessed the power of food exhibitions in promoting culture and heritage.

"Since Umhlanga has now become a global attraction, as witnessed by the thousands of tourists from Africa and beyond who attended this year's successful ceremony, it provides us with a classical opportunity to display what Eswatini has to offer," His Majesty said. "This includes our unique nutritional delicacies, organic teas with massive health benefits, and other cultural experiences that make Eswatini a special destination."

The King noted that transforming Umhlanga into a week-long cultural festival aligns perfectly with Eswatini's broader vision of becoming a preferred tourist and investment destination. "Making Umhlanga bigger and better will not only preserve tradition but also showcase the creativity and potential of our people," he said. His Majesty expressed his delight at the ever-increasing number of maidens (Imbali) who participate in the Reed Dance, describing their loyalty as a symbol of the nation's pride and unity. This year, Umhlanga also attracted former presidents, including Jacob Zuma of South Africa, traditional leaders, members of the diplomatic corps, and throngs of tourists-demonstrating the event's growing global stature.

The King further applauded the generosity of individuals, companies, and institutions that made significant contributions towards the success of the Reed Dance. The gifts included

groceries, toiletry packs, 40,000 backpacks and T-shirts for maidens, as well as cattle and other livestock, all valued at E18.9 million. The King was also presented with a report on expenses, which were slightly above E19 million, including the buses that ferried Imbali from their homes and chiefdoms.

Among the corporate contributors were Inyatsi Group Holdings and its subsidiaries (Lidwala Insurance, Inyatsi Construction, Eswatini Mobile), The Clinic Group, Maloma Colliery, and Construction Associates of who donated E150,000. Eswatini Meat Industries (EMI) contributed E100,000, bringing the combined total to E1 million. Additional support came from Magomba Coal Mining, Eswatini Communications Commission (ESCCOM), Public Service Pension Fund, Eswatini National Provident Fund (ENPF), Eswatini Energy Regulatory Authority (ESERA), Grindrod, Eswatini National Petroleum Council (ENPC), and Huawei, among others.

Minister of Home Affairs Princess Lindiwe praised the remarkable show of solidarity, noting that the support from businesses, Cabinet ministers, princes, and individuals underscores the deep respect held for His Majesty and for Eswatini's cultural heritage.

"We will use these donations to ensure that the second leg of Umhlanga, convened at Mbangweni Royal Residence, also becomes a resounding success," she assured.

Government donates E1.1mln ambulance to RFM Hospital

IN a significant boost to the nation's healthcare sector, the Minister of Health, Hon. Mduduzi Matsebula, officially handed over a state-of-the-art ambulance worth E1.1 million to Raleigh Fitkin Memorial (RFM) Hospital on Thursday morning.

The donation forms part of His Majesty King Mswati III's broader mandate to strengthen healthcare delivery across the Kingdom of Eswatini. The new ambulance is expected to ease pressure on the hospital and improve response times for patients in need of urgent medical attention. Speaking at the ceremony, Minister Matsebula reaffirmed government's commitment to supporting both public and private health institutions. He announced that the government will cover fuel and maintenance costs for the vehicle, a measure aimed at alleviating RFM's financial challenges.

"This ambulance is not just a vehicle it is a lifeline," said the Minister. "By ensuring that it is fully serviced and fuelled, we are making certain that no patient is left unattended due to transport constraints." RFM Board Chairman, Straidom Mpanza, expressed gratitude on behalf of the hospital, saying the donation would go a long way in improving service delivery.

"This ambulance will greatly reduce the workload and enhance our capacity to save lives," Mpanza said. "We thank government for responding to the needs of our hospital and community." Over the past 22 months, the Ministry of Health has procured about 70 vehicles, with more than 20 being ambulances, underscoring government's deter-



mination to modernise the country's health infrastructure. The Minister also highlighted that the newly donated ambulance is equipped with a tracking system that allows the Ministry's transport department to monitor its movements and usage. He warned against misuse, noting that any abuse of the vehicle would result in its immediate recall and reassignment to other sectors in need. bThe handover ceremony comes at a time when the country continues to strengthen its healthcare response capacity to meet the growing needs of Emaswati. The government's ongoing investment in ambulances and hospital support is seen as a step toward achieving equitable access to quality healthcare across the nation.

Muzi bows out as Competition Commission CEO

ESWATINI Competition Commission (ESCC) Chief Executive Officer, Muziwandile Dlamini, will leave the organisation on March 31, 2026, marking the end of a five-and-a-half-year tenure that saw the Commission strengthen its enforcement role and expand its advocacy on fair competition and consumer protection.

Dlamini assumed office on April 1, 2020, when the Commission was consolidating its mandate to safeguard fair trade practices and protect consumers.

Over the years, he led the organisation through key investigations and adjudications on competition matters, reinforcing the application of the Competition Act and ensuring that businesses complied with regulations designed to protect both the market and consumers.

In a statement, the Board of Commissioners announced Dlamini's impending departure and outlined plans for a leadership transition. Board Chairperson Sandile Simelane said the new Chief Executive Officer recruitment process will begin shortly to ensure continuity.

"The CEO and his committed secretariat team advanced investigations and successful adjudications on competition matters, strengthened stakeholder management, advocacy and public awareness of the mandate, while also driving the organisation's transformation agenda," Simelane said.

He added that the priority for the Board is to identify a leader who will build on the existing foundation and guide the Commission into its next chapter. Focus areas include developing a high-performance culture within the organisation and ensuring financial sustainability to support its long-term mandate.

The Ministry of Commerce, Industry and Trade also paid tribute to Dlamini's leadership. In a statement, the Ministry noted that his expertise had been instrumental in promoting fair competition, protecting consumers and creating a competitive business environment that supports economic growth and innovation.

"Under his guidance, the Commission has made significant strides in enforcing competition laws, advocating for policy reforms and raising awareness about the importance of competition in the marketplace. His contributions will have a lasting impact on our economy," Minister Manqoba Khumalo said.

The Ministry further extended its best wishes to Dlamini as he prepares to leave office, expressing confidence that the work achieved during his tenure will continue to inspire future leaders in the field of competition and consumer protection.

During his tenure, the Commission not only strengthened its enforcement capacity but also expanded its role in public education and stakeholder engagement.

Awareness campaigns and advocacy initiatives under his leadership were aimed at deepening the public's understanding of the Commission's mandate, while also encouraging compliance from businesses across sectors

Dlamini also presided over the organisation's transformation agenda, which sought to align internal systems and processes with the broader vision of building an effective and responsive competition authority.

This involved embedding a performance-driven culture within the Commission and improving institutional capacity to deliver on its mandate.

Responding to questions about Dlamini's future plans, the Commission's Communications Officer, Mancoba Mabuza, said the focus for now remains on his current role.

"The Board Chair's statement provides sufficient information for now, and it would only be ethical and professional to consider such reflective questions at a later stage, as Muzi Dlamini remains the incumbent CEO for the next six months," Mabuza said.

As the Commission prepares for a new leadership chapter, both the Board and the Min-

istry have emphasised that Dlamini's contribution has strengthened the institutional framework of the ESCC.

His departure, scheduled for the end of March 2026, will open the way for new leadership to steer the Commission's work in advancing competition law, safeguarding consumers and supporting the broader national objective of economic growth.

For now, Dlamini continues to serve as CEO until his final day in office, leading the Commission through its ongoing programmes and ensuring that the transition process unfolds smoothly.

Approximately 22 per cent of children under five are stunted in Eswatini

THIS was revealed by the National Child Health and Malnutrition Program Officer at the Eswatini National Nutrition Council (ENNC) Siniketiwe Zwane on Thursday during a signing of a Memorandum of Understanding (MoU) between Tzu-Chi Foundation and the Ministry of health.

When a child is stunted, it means the child's growth and development have been hindered due to chronic undernutrition and other factors (like frequent infections, poor sanitation, or lack of proper care) over a long period of time.

During the signing of the MoU which took place at Happy Valley Hotel, Tzu-Chi Foundation, an organisation from the Republic of China (Taiwan) also donated 4 800 2kg nutritional powders to ENNC.

When making her presentation during the event, Zwane stated that the fact that Approximately 22 per cent of children under five were stunted in Eswatini was a sign of irreversible damage to a child's physical and cognitive development.

She added that while the prevalence of wasting (low weight for height) was generally lower, at around 2 per cent, it can still be a significant issue, especially in certain regions or during periods of drought.

Wasting

Zwane mentioned that wasting indicates a sudden and severe lack of food and often requires urgent medical attention. She added that many children also suffer from hidden hunger, or micronutrient deficiencies, which can weaken their immune systems and impair development.

She mentioned that the regions of Lubombo and Shiselweni were disproportionately affected by food insecurity and malnutrition due to their high vulnerability to climate change and drought.

"Children in these areas are at an especially high risk," she said.

She said the nutrition situation was closely linked to broader issues such as high rates of poverty, unemployment, and HIV prevalence, which can affect household food security and a child's health status.

She said in children, undernutrition can lead to stunting (low height for age) and wasting (low weight for height), which are signs of long-term and acute malnutrition, respectively. She said these conditions can cause irreversible damage, including impaired physical growth and a reduced ability to fight infections.

Zwane said the most critical period for

brain development was from conception to a child's second birthday.

"A lack of essential nutrients like iron, iodine, and protein during this time can cause permanent cognitive impairment, leading to lower IQs, poor academic performance, and reduced intellectual capacity in adulthood,"

Zwane stated that malnutrition compromises the immune system, making individuals more susceptible to infectious diseases like pneumonia and diarrhoea. She said this creates a vicious cycle where illness worsens malnutrition and vice versa.

She pointed out that malnourished individuals, particularly children, were at a significantly higher risk of illness and death. She highlighted that under nutrition was a factor in nearly half of all deaths among children under five.

Malnutrition

In addition, she said malnutrition can lead to apathy, depression, anxiety, and a reduced ability to interact socially, further isolating individuals and limiting their life opportu-

She mentioned that the challenges leading to malnutrition included inconsistent supply of nutrition commodities, decreased financial landscape and lack of nutrition commodities for the management of moderate malnutrition

Meanwhile, the Minister of Health Mduduzi Matsebula, who spoke through the voice of the Principal Secretary Khanya Mabuza

said the occasion was particularly meaningful as the ministry continues to emphasise the importance of good nutrition, and particularly breastfeeding, whilst also scaling up the national response to malnutrition.

"Firstly, I would like to extend my deepest gratitude to the Tzu-Chi Foundation for their unwavering support to our national health goals," he said.

He said their recent participation during their commemoration of breastfeeding week and donation of breastfeeding cushions was a simple yet profoundly impactful gesture.

Breastfeeding

"We know that breastfeeding is one of the most effective ways to improve a child's health and survival. These cushions will provide comfort and support to new mothers, making the breastfeeding journey easier, successful and more meaningful," he said.

The minister said this gift was a testament to the foundation's deep commitment to the well-being of mothers and children in the nation, in line with the country's overall health goals for primary health care.

Furthermore, he said the ministry was incredibly grateful to receive this new consignment of nutritional commodities.

"I am informed that there about 4 800 nutritional powders of 2 kg each for use, which are easy to mix and very nutritious. These supplies are a lifeline for our most vulnerable children and have been approved by our nutritionists in the ministry," he stated.

He stated that malnutrition remains a serious challenge in the country, hindering a child's growth and development and leaving them susceptible to illness.

Matsebula said these commodities will be strategically distributed to health facilities across the country, ensuring that they can effectively manage and treat malnutrition

He pointed out that the generosity of the Tzu Chi Foundation reflects a beautiful synergy between their organisations.

"It is for this reason that we as a ministry are glad to cement our relationship through the signing of the MOU today. It is through such collaborations that we can bridge critical gaps in our healthcare system and reach those who need our support the most," he

The minister said this partnership was a shining example of how a shared vision can translate into tangible, life-saving outcomes.

"I want to thank the Tzu Chi Foundation once again for their incredible support. We are proud to call you our partners in health, and we look forward to a continued collaboration as we work together to build a healthier, more nourished future for all our children," he said.

IN a bold show of unity, scores of security guards under the Swaziland Amalgamated Trade Union (SATU) took to the streets of Matsapha Industrial Site on Thursday, demanding formal recognition from their employer, Stallion Security.

The workers marched peacefully through the industrial hub, carrying placards and chanting slogans as they delivered a petition to the company. At the heart of their

demand is a recognition agreement, which would allow SATU to formally represent its members in negotiations and workplace matters. This push follows a decisive verification exercise in which SATU secured a 61.1 per cent majority win, giving it the mandate to speak on behalf of the guards. Union leaders say this victory demonstrates the overwhelming confidence workers have placed in SATU to protect their rights and advance their interests.

"Recognition is not just about paper-

work, it is about giving workers a voice at the table," one union representative said. "Our members have spoken clearly, and it is time for the employer to respect their choice." The march drew widespread attention across Matsapha, with bystanders and fellow workers showing support as tensions simmered between the guards and management. SATU has vowed to stand firm until Stallion Security acknowledges the will of its employees.

Labour observers note that recognition

disputes are not uncommon in Eswatini's security industry, where workers often face low wages, long hours, and minimal benefits. Today's action, however, signals growing assertiveness among employees who are increasingly determined to secure fair representation.

As the petition was delivered, chants of solidarity echoed across the industrial landscape, underscoring the guards' message: their collective strength cannot be ignored.

ESWATINI'S leading bank, FNB Eswatini, has declared itself a E10 billion company, marking a historic milestone in its 30-year journey of resilience, innovation, and growth.

At a media and stakeholders' breakfast hosted at the bank's headquarters in Ezulwini, Chief Financial Officer Njabulo Dlamini confirmed that the audited 2025 financial results cleared by regulators including the Central Bank of Eswatini and the Eswatini Stock Exchange show the balance sheet has expanded to E10.3 billion, driven by steady growth in both advances and deposits.

Looking back, Dlamini noted that when FNB Eswatini opened in 1995, it posted a modest profit of just E890, 000. Three decades on, annual profit has climbed to E268 million, reflecting a compounded growth rate of 21%.

"This company has demonstrated resilience, whether faced with shocks such as Covid-19, global conflicts, or shifting policy environments, we did not only rebound but emerged stronger. The E10 billion milestones is a true growth story for this country," said Dlamini.

According to Dlamini, the growth was driven primarily by a sharp increase in net advances, which climbed to E4.7 billion compared to E4.1 billion in the previous year.

Deposits also increased to E6.6 billion, re-

flecting continued confidence from customers and businesses in the bank's financial strength.

Property and equipment values stood at E325.8 million, slightly lower than last year's E339 million, while other assets amounted to E5.26 billion.

CEO Thokozani 'TK'Dlamini said the E10 billion milestone underscores FNB's resilience and ability to deliver consistent growth in a challenging economic environment.

"Crossing the E10 billion mark is a reflection of the trust our customers place in us and our commitment to innovating while remaining financially strong," Dlamini told stakeholders.

The bank also reported total capital and reserves of E1.43 billion, up from E1.36 billion last year, providing a solid cushion to support on-going lending and expansion.

The results come against a backdrop of regional and global uncertainties, but FNB Eswatini maintains that its focus on digital banking, financial inclusion, and customer-driven innovation will continue to drive long-term growth.

FNB Eswatini eWallet transactions hit 4.5 million

FNB Eswatini has reported a surge in digital payments with eWallet transaction volumes climbing to 4.5 million in the 2024/25 financial year, up from 4.1 million in 2024 and 3.5 million in 2023.

The milestone, announced during the bank's Annual Financial Results presentation on Thursday, highlights the continued importance of mobile money services in Eswatini's payment ecosystem. eWallet, which allows customers to send and receive funds instantly, remains one of the most widely used domestic payment channels in the country.

Chief Financial Officer Njabulo Dlamini said the growth reflected deliberate investment in self-service and digital platforms.

"The 8 per cent increase in service fees was driven by the wider adoption of self-service channels. Our digitisation strategy is central to how we serve customers, and the results confirm that clients are embracing these solutions," he said.

Alongside eWallet's growth, the bank successfully migrated low-value electronic payments within the Common Monetary Area (CMA) to Forex platforms and went live on the Eswatini Payment Switch.

The latter now enables clients to transfer funds instantly to other local banks, eliminating traditional clearing times.

Non-Interest Revenue (NIR) closed the financial year at E579

million, supported by customer acquisition and digital adoption.

However, NIR growth was partly disrupted by the CMA migration. Transaction-related fees made up the largest share of NIR at 39 per cent, followed by credit-related administration fees at 18 per cent, and banking fees and commissions at 15 per cent. Cash handling fees contributed 14 per cent, while fair value gains accounted for 7 per cent. Insurance income, other NIR, and exchange commissions

made up the balance.

As at June 30, 2025, FNB Eswatini's active customer base grew by 7 per cent compared to the previous year. Retail clients increased by 7 per cent, commercial clients by 10 per cent, and corporates by 1 per cent.

According to management, the expansion in customer numbers reflects the bank's efforts to provide value across different segments while strengthening digital solutions and service delivery.

The bank posted a profit after tax of E268.8 million for 2024/25, matching the performance of the previous year.

Total Assets increased by 6 per cent to E10.3 billion, while Advances rose by 13 per cent to E4.7 billion and Deposits grew by 5 per cent to E6.6 billion.

Cost-to-income rose to 63.3 per cent from last year's 59.2 per cent, reflecting increased investment in technology and people. The bank's credit impairment ratio stood at

o.6 per cent, return on assets at 2.7 per cent, and return on equity at 19.2 per cent.

CFO Njabulo Dlamini said the bank's deliberate investments would continue to drive performance. "We are building for the future by balancing operational efficiency with innovation. Our results show a resilient business that is committed to creating long-term value for customers, employees and stakeholders," he said.



FNB Eswatini closes year with E268.8 million profits

FNB Eswatini has announced a profit after tax of E268.8 million for the 2024/25 financial year, reaffirming its dominance in the banking sector despite flat growth compared to the previous year.

The results were presented at the bank's head office in Ezulwini on Thursday, where senior executives outlined performance highlights, strategic investments, and milestones achieved over the past year.

Chief Financial Officer Njabulo Dlamini attributed an 18 percent rise in operating expenses to what he described as deliberate investment in their people, technological development and support, as well as regulatory and channel projects.

Meanwhile Chief Executive Officer Thokozani 'TK' Dlamini said the financial year was marked by initiatives designed to strengthen the bank's long-term growth.

"We honoured our commitment to investing in our people the engine of the business. At EXCO level, we on boarded CIO and CPO functions, strengthened our retail and commercial segments, and expanded support teams in human capital and IT. I also had the opportunity to conduct CEO road shows, introducing myself to the full staff complement while reinforcing our strategy and objectives," he told stakeholders.

Among operational highlights, the bank became live on the Eswatini Payment Switch, allowing clients to transfer funds instantly to

It also completed the Common Monetary Area EFT migration, enabling cross-border payments through the SWIFT channel. In addition, FNB rolled out an upgraded private banking proposition and financed Eswatini's first green loan for a solar power project.

rose by 13 per cent to E4.7 billion, while deposits increased by 5 per cent to E6.6 billion. Cost to income moved up from 59.2 per cent to 63.3 per cent

FNB Eswatini also reported a 7 per cent growth in its customer base across all segments, with retail clients increasing by 7 per cent, commercial clients by 10 per cent, and corporates by 1 per cent.

The CEO said this growth was underpinned by a six-pillar strategy focused on customer and employee experience, efficiency, and shared prosperity.

"Our commitment is to create solutions that are both relevant and impactful, and to ensure our teams are supported, engaged, and positioned to deliver excellence," he said.

Through its Corporate Social Investment programme and the FNB Eswatini Foundation, the bank invested E_{5.48} million in community projects during the year.

Of this, E3.85 million went to initiatives in economic growth, entrepreneurship, sports development, social impact, education, and cultural promotion.

Additionally, FNB partnered with the FNB Eswatini Foundation to co-sponsor the 2024 Entrepreneur of the Year Awards with a contribution of E1.6 million.

Another E1.6 million was disbursed to projects in knowledge economy, gender diversity, climate change, and humanitarian support.

"We are intentional about allocating our capital to initiatives that drive long-term

growth for the country. That is why we say, Sitintile Eswatini futsi asiyindzawo," Dlamini said.

The bank was certified as a Top Employer for 2025 both in Eswatini and across Africa by the Netherlands-based Top Employers Institute. The certification recognises excellence in human resources and workplace practices.

Chief People Officer Veronica Ntshalintshali described the dual certification as an incredible achievement that validated the bank's focus on employee wellbeing, diversity, and talent development.

During the year, FNB also strengthened its leadership team, appointing three new executives including Thandeka Dlamini, the first woman to serve as Chief Operating Officer in the bank's 30-year history.

Celebrating three decades in the country, FNB Eswatini reflected on pioneering milestones such as introducing cell phone banking in 2007, eWallet in 2011, the FNB App in 2013, and automated deposit machines in 2017. "Now that's real help," CEO TK Dlamini concluded.

Eswatini, U.S. Embassy explore new avenues for economic cooperation

MINISTER of Commerce, Industry and Trade, Manqoba Khumalo, on Thursday held talks with the U.S. Chargé d'Affaires Marc Weinstock and senior officials from the U.S. Embassy to reaffirm Eswatini's commitment to deepening bilateral economic relations and to explore new areas of collaboration.

The engagement, which also included Principal Secretary Melusi Masuku, Economic and Commercial Specialist Dumsani Dlamini, and Economic Officer Martha Amaya, underscored the importance of strong partnerships in advancing trade, investment, and job creation.

Introducing himself and his principal secretary, Minister Khumalo reflected on his seven years of service at the ministry, describing its role as the interface with all other ministries in driving business investment, company registrations, and employment. He stressed his conviction in building an export-led economy, declaring Eswatini a great place to do business.

"The Minister speaks my language," he remarked, while reiterating the U.S. Embassy's commitment to partnership.

Turning to the African Growth and Opportunity Act (AGOA), Weinstock stressed the importance of dialogue on how Eswatini can better position itself. "Let's come together as a team, figure out what kind of business suits Eswatini, how we can do it, and what the best approach is," he said.

He concluded with a call to action of creating opportunities and jobs.

The meeting reinforced the shared objective of expanding economic cooperation between Eswatini and the United States, with both sides recognising the potential for growth, innovation, and prosperity.

How New York turns millions of pounds of food waste into 'black gold'

WATERMELON rinds, greasy pizza boxes, and yard trimmings. In many cities, these items would head straight to a landfill.

But in New York, they are the raw ingredients for something surprisingly valuable: "black gold."

"We're making this awesome compost that we can use throughout the city and improve soil health," said Jennifer McDonnell, Deputy Commissioner for Solid Waste Management at the New York City Department of Sanitation. At the Staten Island Compost Facility, managed by Denali Water Solutions, landscaper waste has long been processed - but it now also handles residential organic waste. On an average day, the facility takes in 100 to 150 tons of organic material, going up to 250 tons when leaf fall is heavy.

Upon arrival, the waste is shredded, screened, and transferred into aerated static pile bunkers where composting begins. The piles heat up to over 100 degrees Fahrenheit (37.8°C), hot enough to kill pathogens and weed seeds.

Over the course of several weeks, fungi, bacteria, and insects break down the material. After cur-

ing and screening, the end product forms a dark, nutrient-rich compost. The city sells some to landscapers and distributes the rest free of charge to residents, schools, and community gardens.

"We've given out, we think, almost 6 million pounds of compost to the residents of New York City this year," McDonnell said. The compost helps improve soil health, manage stormwater, and keep city greenspaces thriving.

Nationwide, food scraps and yard waste are the largest share of household trash, according to the National Resources Defense Council. When sent to landfills, they generate methane, a potent greenhouse gas.

"If we want to take a bite out of the climate crisis, we've got to get our food scraps out of landfills and into composting," said Eric Goldstein, New York City Environment Director at the council.

The city's organics collection program requires all residents to separate food scraps, food-soiled paper, and yard waste from trash. While enforcement was paused earlier this year, it is expected to resume in 2026. (Reuters)

Astronomers get best view yet of two merging black holes

The merger of two black holes is a momentous event, revealing the wildest and most extreme configurations of space, time and gravity known to science.

Researchers have now gotten their best look yet at such an event based on the detection of ripples in space-time called gravitational waves in an observation that lends strong support to hypotheses from eminent physicists Albert Einstein and Stephen Hawking.

The collision occurred 1.3 billion light-years from Earth in a galaxy beyond our Milky Way, and involved two black holes - one about 34 times the mass of the sun and the other about 32 times the sun's mass. They merged in a fraction of a second after orbiting each other at nearly the speed of light, and left behind a single black hole around 63 times the mass of the sun that was spinning at approximately 100 revolutions per second.

A light-year is the distance light travels in a year, 5.9 trillion miles (9.5 trillion km). Black holes are extraordinarily dense objects with a gravitational pull so strong not even light can escape.

The merger unleashed a tremendous amount of energy that radiated outward as gravitational waves, an amount equivalent to pulverizing three sun-sized stars. These waves were detected on January 14 at research sites in Hanford, Washington and Livingston, Louisiana that are part of the U.S. National Science Foundation's Laser Interferometer Gravitational-Wave Observatory, or LIGO.

These observations came about a decade after the groundbreaking first detection of gravitational waves, which were produced by a similar merger. Technological improvements since 2015 meant this merger was observed with four times better resolution than the prior one.

Gravitational waves propagate outward from

a source like ripples in a pond. In this case, the pond is space-time, the four-dimensional fabric that combines the three dimensions of space - height, width and length - with the dimension of time.

"Thanks to Albert Einstein, we know that space and time are intertwined and are best thought of as facets of a single entity, spacetime," said astrophysicist Maximiliano Isi of Columbia University and the Flatiron Institute, one of the leaders of the study published on Wednesday in the journal Physical Review Letters, opens new tab.

"This manifests, for example, in that time flows at different rates depending on where you are: close to a heavy object, like a black hole, time flows more slowly compared to someone farther away, so that someone close to a black hole would age more slowly," Isi said.

The researchers analyzed the frequencies of the detected gravitational waves to discern fundamental qualities of the black holes immediately before and after the merger. While these frequencies were not sound waves, the researchers compared them to the ringing of a bell.

"This is just like trying to figure out what a bell is made out of from the ringing sound it makes when struck," Isi said.

A large iron bell, for instance, makes a different sound than a small aluminum bell. What the researchers learned based on the frequency of gravitational waves offered validation for a basic tenet of scientific understanding of black holes advanced by Hawking, who died in 2018.

Hawking hypothesized that the total surface area of black holes - specifically the surface area of the event horizon, the boundary beyond which nothing can escape - should never decrease. His hypothesis implies that the surface area of the single black hole produced in a merger should exceed the

combined surface areas of the two black holes that merged.

This merger met that expectation. Before colliding, the black holes together had a total surface area of about 93,000 square miles (240,000 square km). The single black hole produced by the merger had a surface area of about 155,000 square miles (400,000 square km).

"This is the first time that we have been able to make this measurement so precisely, and it's exciting to have direct experimental confirmation of such an important idea about the behavior of black holes," said astrophysicist Will Farr of Stony Brook University and the Flatiron Institute, one of the study leaders.

The observations also provided the most direct evidence yet that black holes are the


paradoxically simple objects foreseen in Einstein's theory of general relativity, which holds that gravity results from the curvature of space-time caused by mass and energy.

The findings validated Einstein's proposed simplicity of black holes - that they can be fully understood based exclusively on their mass and spin - as worked out by mathematician Roy Kerr in 1963.

The gravitational wave measurements were obtained in a remarkably short time. Caltech astrophysicist Katerina Chatziioannou said the black holes were observed spiraling inward toward each other for about 200 milliseconds, and the signal from the merged black hole was measured for about 10 milliseconds.

Investors retreat as shares in bitcoin buyers decline

COMPANIES that accumulate and hoard bitcoin and other cryptocurrencies have suffered sharp drops in their share prices as the crypto mania that has gripped investors for much of the year recedes.

These so-called digital asset treasury companies sell shares or issue debt to raise cash for buying crypto held on their balance sheets. Investors have been snapping up their shares, encouraged by bitcoin's record

highs this year as U.S. President Donald Trump embraces the sector.

At least 61 publicly listed companies that are not primarily engaged in digital assets have adopted bitcoin treasury strategies, Reuters reported in June.

Shares in Michael Saylor's Strategy , the best known of these bitcoin buyers, have fallen from \$457 in July to as low as \$328 this week. That is the lowest since April and cuts their gains this year to 13%.

Japanese bitcoin treasury company Metaplanet (3350.T), opens new tab this week hit its weakest since May. The shares are down more than 60% from their June peak but remain up 105% so far this year.

Small companies that have transformed the fortunes of their shares - and their stock-owning executives - simply by announcing a sudden shift in strategy to bitcoin-buying have also taken a hit.

The scale of the reversal is "entirely unsurprising," said Kaiko analyst Adam McCarthy

"These are all essentially volatility plays as they are leveraged exposure ... so if bitcoin is down 3%, they're down a multiple of that, sometimes four or five times as much," he said.

"For retail users it's a shock a lot of the time, so it probably compounds the downturn when some sell out of fear."

When these shares tank, the companies' market value can be less than the crypto holdings on their balance sheets.

Digital asset treasury companies also often rely on capital market access to fund their crypto buying, which can "dry up when sentiment cools," said Lale Akoner, global market analyst at eToro.

"Beyond their bitcoin exposure, most (companies) have only modest fundamentals, so their valuations don't have much of a cushion."

Shares of Smarter Web Company(SWC.

ASE), opens new tab soared after the UK-based website designer announced a bit-coin-buying strategy in April. The stock is down more than 70% since June.

Shares in Alt5 Sigma (ALTS.O), opens new tab, which has been buying tokens in Trump's World Liberty Financial crypto venture, have tumbled more than 61% from their June high reached before the company announced a \$1.5 billion deal with the venture

Bitcoin-hoarding has spread to other cryptocurrencies, too, with more companies buying up ether and lesser-known digital currencies.

"Until retail users realise that these firms aren't buying into crypto, rather they're selling a crypto narrative to pump their equity value, this circle will persist," Kaiko's McCarthy said.

Shares of Peter Thiel-backed BitMine (BMNR.A), opens new tab and gaming media network GameSquare (GAME.O), opens new tab rocketed this year after they announced plans to buy ether. Both have slumped by about 67% since July.

Police search for sniper who killed conservative activist Charlie Kirk in Utah

POLICE and federal agents mounted an intense manhunt on Thursday for the sniper believed to have fired the single gunshot that killed conservative activist Charlie Kirk as he was fielding questions about gun violence during a university appearance.

Kirk, 31, a podcast-radio commentator and an influential ally of Donald Trump, is credited with helping build the Republican president's base among younger voters. He was gunned down on Wednesday in what Utah Governor Spencer Cox called a political assassination.

The slaying, captured in graphic detail in video clips that rapidly spread around the internet, occurred during a midday event attended by 3,000 people at Utah Valley University in Orem, Utah, about 40 miles (65 km) south of Salt Lake City.

In one clip, blood could be seen gushing from Kirk's neck immediately after a shot rang out, and he slumped in his chair.

Kirk, co-founder and president of the conservative student group Turning Point USA, was pronounced dead at a local hospital hours later. His murder stirred immediate expressions of outrage and denunciations of political violence from Democrats and Republicans alike.

Cox said Kirk's events on college campuses were part of a tradition of open political debate that was "foundational to the formation of our country, to our most basic constitutional rights".

"When someone takes the life of a person because of their ideas or their ideals, then that very constitutional foundation is threatened," Cox said.

ERA OF POLITICAL VIOLENCE

The shooting punctuated the most sustained period of U.S. political violence since the 1970s. Reuters has documented more than 300 cases of politically motivated violent acts across the ideological spectrum since supporters of Trump attacked the U.S. Capitol on January 6, 2021.

Trump himself has survived two attempts on his life, one that left him with a grazed ear during a campaign event in July 2024 and another two months later foiled by federal agents.

The lone perpetrator suspected of firing

the single gunshot that struck Kirk in the neck, apparently from a rooftop sniper's nest on campus, remained "at large," said Beau Mason, commissioner of the Utah Department of Public Safety, at a news conference four hours later.

Security camera footage showed a person believed to be the assailant dressed in all-dark clothing, Mason told reporters. But some eight hours after the killing, authorities said they still had no suspect in custody.

State police issued a statement on Wednesday night saying that two men had been detained, and one was interrogated by law enforcement, but both were released.

"There are no current ties to the shooting with either of these individuals," the statement said. "There is an ongoing investigation and manhunt for the shooter."

NO SUSPECTS IN CUSTODY, MUL-TIPLE 'CRIME SCENES'

One of the two detainees, an older man seen in photos that circulated online shortly after the killing, was familiar to locals as a political "gadfly," according to the Salt Lake Tribune. Officials said he had been charged with obstruction by university police.

The other man had been initially described by the governor as a "person of interest" in the investigation.

Police said late on Wednesday that investigators were seeking clues at "multiple active crime scenes," pinpointed on the basis of where Kirk was shot and "locations where the suspect and the victim traveled."

Kirk, who was married and the father of two young children, had just returned to the United States from an overseas speaking tour in South Korea and Japan.

His appearance on Wednesday was the first in a planned 15-event "American Comeback Tour" of U.S. college campuses.

Known for his often-provocative discourse on topics ranging from race and gender to immigration and firearms regulation, Kirk often used such events to invite members of the crowd to debate him live.

At the moment he was shot, Kirk, a staunch advocate of the Constitution's Second Amendment right to bear arms, was being questioned by an audience member about gun violence, according to multiple videos of the event posted online. (**Reuters**)

Belarus frees 52 prisoners after Trump appeal, US eases some sanctions on Minsk

BELARUS released 52 prisoners of various nationalities on Thursday after an appeal from U.S. President Donald Trump and they were headed to Lithuania with the U.S. delegation that negotiated their release, the U.S. embassy in Vilnius said.

Trump had earlier called on Belarusian President Alexander Lukashenko, a close ally of Russian President Vladimir Putin, to release detainees whom the U.S. leader has described as "hostages". Belarus later confirmed their release.

In return for Lukashenko's gesture, the U.S. will grant sanctions relief to Belarus's national airline Belavia, allowing it to service and buy components for its fleet, which includes Boeing aircraft, the U.S. embassy spokesperson in Vilnius said.

It was the biggest batch of prisoners so far pardoned by Lukashenko, who is seeking to repair relations with the U.S. after years of isolation and sanctions on his former Soviet state.

But it was far short of the total of 1,300 or 1,400 prisoners whose release Trump had called for in a conversation with Lukashenko last month and in subsequent social media posts.

It was also not immediately clear whether those released included some of the most prominent critics of Lukashenko's decades-old rule, such as human rights campaigner Ales Bialiatski, co-winner of the 2022 Nobel Peace Prize.

"What happened (today) is a great diplomatic success for the United States and for us all," Lithuanian President Gitanas Nauseda said, as he announced that the ex-prisoners were crossing into Lithuania, a NATO

and EU member state.

Belarus' state news agency Belta said they included 14 foreign nationals from Lithuania, Latvia, Poland, France, Britain and Germany.

'RARE ACT OF PERSONAL FRIEND-SHIP'

Belta also quoted John Coale, a lawyer who headed the U.S. delegation, as saying that Trump had told Lukashenko that Washington wants to reopen its embassy in Minsk.

Earlier, Coale had passed a letter from Trump in English to Lukashenko signed "Donald", Belta showed. The fact that Trump had signed the letter simply Donald was "a rare act of personal friendship", it quoted Coale as saying.

"If Donald insists that he is ready to take in all these released prisoners, God bless you, let's try to work out a global deal, as Mr. Trump likes to say, a big deal," said Lukashenko, who also praised the U.S. leader for seeking a peace deal in Ukraine.

"Our main task is to stand with Trump and help him in his mission to establish peace," Belta later quoted Lukashenko as saying, referencing Trump's claim that he has solved six or seven world conflicts.

Lukashenko has led Belarus through more than three decades of authoritarian rule. He had said as recently as August 22 that he was not prepared to release "bandits" who might "wage war" against the state.

Trump has flattered the veteran leader, long treated as a pariah by the West, and said he plans to meet with him. Last week he described him as a "very respected man, strong person, strong leader".

The release took place at a difficult moment in the Russia-Ukraine war, a day after Poland shot down suspected Russian drones

over its territory and on the eve of a major joint exercise between the Russian and Belarusian armed forces.

Belarus shares borders with three NATO countries and with Ukraine. Lukashenko allowed Putin to use Belarusian territory for his full-scale invasion of Ukraine in February 2022 but his army has not directly participated in the war.

Vytis Jurkonis, a Belarus human rights activist who leads the Vilnius office of Freedom House, a U.S. government-funded human rights advocacy organization, told Reuters that Lukashenko was using the prisoners to leverage his own influence.

"Lukashenko is dragging out the release

of the political prisoners because he does not have much else to trade with the West. At the same time, he is continuing to arrest more prisoners," Jurkonis said.

"He is using the releases to uphold the illusion of change in Belarus, but the real change would be happening if terror in the country ceases, the exiles are allowed to return, the Russian army leaves."

Lukashenko says there are no political prisoners in Belarus and that those behind bars are law-breakers who chose their own





THE reason is ethylene, a gas from some fruits and vegetables that speeds ripening. It's a big reason for food waste.

So store ethylene-emitting foods away from those that are sensitive to it.

Ethylene producers:

- ► Apple
- ► Cantaloupe
- ► Avocado
- ▶ Pear
- ► Tomato
- ▶ Pepper
- ► Banana

Ethylene sensitive:

- ► Mango
- ► Asparagus
- ▶ Peach
- ▶ Onion

- ► Cucumber

Wash Your Greens

Leafy green vegetables such as spinach and bibb, romaine, red leaf, and other types of lettuce will stay fresher longer if you rinse them in cool water before refrigerating. Toss out any wilted or discolored leaves. Dry the greens in a salad spinner or shake off the water and wrap them loosely in paper towels. Seal them in a plastic bag or container.

Leave the Wax On

Many fruits and vegetables, especially those grown in warm climates, have a natural waxy outer layer to prevent shrinking. Some crops get a coating of artificial wax. Wash it off only just before you're ready to eat. That helps prevent bruising and premature rotting. Coated produce includes apples, lemons, nectarines, oranges, cucumbers, bell peppers, potatoes, and eggplants.

Trim Carrots

Those green tops may be pretty. But they wick nutrients and freshness from the rest of the carrot. Slice off the green tops before storing. Refrigerate trimmed carrots loosely in a plastic bag in the crisper drawer. They should keep for several weeks. Pro tip: Save the greens to make pesto, chimichurri, or salad topping.

Keep Bananas Cool

Your sunny kitchen may be one of the worst places to keep these tropical fruits. Humid, warm air will speed up the browning. Keep them away from other produce. Once they've ripened to your liking, refrigerate bananas to extend their shelf life by a couple of days. The skin may turn mottled, but the inside should stay tasty.

Freeze Ginger

Love the pungent flavor of fresh ginger but never use it quickly enough before it turns gnarly or moldy? Ginger, also called ginger root, can last in your fridge for a few weeks. To keep it longer, toss it in your freezer. Chop, grate, or slice the ginger (no need to peel it). Wrap tightly with foil or a freezer bag to keep out air. It'll keep fresh for at least 3 months.



Scientific tips to keep your produce fresher longer







Let Onions Breathe

Good air circulation is key to keeping decay at bay. Store onions without plastic wrap in a cool, dry spot. If they're sold in a mesh bag, you can hang in on a hook in your pantry. Or make your own ventilated storage with an old, clean pair of pantyhose. Drop an onion in one leg and push it down to the toe. Then tie a knot above it, and drop another onion. Cut onions will keep for several days in the refrigerator.

Chill Berries

Strawberries are among the sweetest harvests of summer. But these tender fruits actually are cold hardy. In fact, strawberries, raspberries, blueberries, and blackberries should be refrigerated below 40 F, or even as cold as 32 F. That lengthens their shelf life. Moisture will turn them mushy or moldy quicker, so wash berries only at the last minute.

Wrap Celery in Foil

Like most vegetables, celery is almost all water. It's also sensitive to ethylene, the ripening gas. Help keep your celery from going limp by tightly covering it in foil and storing it in the crisper drawer. Or you can wrap it in a dry paper towel and put it into a plastic sleeve. The celery should last several weeks.

A bright yellow pile of citrus can brighten up any kitchen counter. That's also an ideal place to dry out your lemons and limes into hard orbs. But you can keep them juicy for up to a month. Seal the lemons tightly in a plastic storage bag with all the air out and put them in the fridge.

Keep Your Herbs Vertical

Treat cilantro, parsley, and mint like cut flowers. Place them in jars with water and then refrigerate. Bouquets of other softstemmed herbs like basil may prefer the warmer temperature on your counter. Or try this: Place fresh dry herbs in a plastic produce bag and blow into it like a balloon. The carbon dioxide from your breath is a known food preservative and can help keep the greens perky.

Vent Your Mushrooms

They're not a fruit or vegetable, but fungi. Mushrooms like to be kept cool and wellventilated. A porous paper bag is a good choice. Free the mushrooms from their plastic-wrapped grocery container, which can trap moisture. They may keep in the fridge for up to a week. Run them under cool water just before you cook with them.

Deep-Clean Your Fridge

Several things affect how quickly your food spoils. They include light, air, temperature, and time. One you can control is microorganisms like bacteria, mold, and yeast. So wipe down the insides of your refrigerator regularly. White vinegar or soapy water work. Avoid packing too much food on the shelves and drawers so that air can circulate. WebMD

Go for high-fiber foods, such as:

- ▶ Fruits
- ▶ Nuts and seeds
- ▶ Whole grains
- ▶ Beans and lentils

Start slowly. As you gradually add fiber to your diet, also increase the amount of water you drink. Water is fiber's best friend. Fiber soaks it up, and this will help you avoid cramping or gas.

2. Have a Side of Soup

Water and other fluids such as soup, broth, and juice can ease things through your system.

Not a soup fan? Try herbal tea or water with a slice of cucumber, lemon, or lime. Or anything, really, as long as it doesn't have alcohol (which dehydrates you) or too much caffeine (which can stimulate your intestines too much).

If you favor fizzy drinks, keep in mind that they increase stomach acid, which gives some people heartburn.

3. Break It Down

Eat smaller amounts more slowly. Chew your food thoroughly to make your digestive system's job a little easier.


4. Keep Moving

Is there anything exercise can't do for you? The list of benefits just keeps growing. You already know it's good for your heart and your waistline. Turns out that active people also have smoother digestion.

Watch the timing. For some people, exercise right after a meal can cause indigestion. So schedule your workouts before meals or wait at least an hour after eating.

5. Bring on the "Good" Bugs

Probiotics are "good" bacteria that are in your gut. They are in some yogurts and fermented foods. They help with your digestion. You can also add them to your diet with supplements.



6. Outsmart Fatty Fare

Fats tend to stay in your system the longest, making them harder to digest. You may have even noticed a feeling of fullness or burning after a rich meal.

Limit fatty foods such as chips, burgers, and greasy foods. Instead, eat lean meat and fish. Also, try to grill your meals more often than you fry them.

7. Dear (Food) Diary

Pay attention to foods that seem to trigger stomach discomfort. Write down what you ate and how you felt so you remember for

Some people find that acidic foods, like tomatoes or citrus fruits, trigger heartburn. For others, wheat, onion, or dairy products such as milk or cheese cause problems.

Spicy food is a common cause of heartburn, stomach pain, or diarrhea, so you may want to stay away from anything that heats up your mouth.

Smoking can also upset your digestion. Add that to your list of reasons to quit. If you've tried to quit before, that's OK! Keep trying and ask your doctor for help.

8. Soothe Your Stress

Stress affects your whole body, including your digestive system. Ditch stress whenever you can. For those problems you can't avoid, find ways to relax. It may also help to sign up for a few sessions with a counselor or to take a stress management class. For better digestion, do what you can to keep your stress under control.

9. Get Expert Advice

Some medications or medical problems can interfere with smooth digestion. If you've ruled out other problems but still have symptoms, tell your doctor what's been going on. Bring a list of any medicines you take. This might help spot the source of your problem.

New Forest boss Postecoglou shoulders great expectations

NOTTINGHAM Forest's new manager Ange Postecoglou is adamant he can handle the pressure of turning his club into trophy winners as he prepares for his debut against Arsenal on Saturday.

Postecoglou was hired by Forest earlier this week, returning to the Premier League just three months after being sacked by Tottenham.

The Australian, who lost his job at Tottenham 16 days after winning the Europa League, arrived at the City Ground following Nuno Espirito Santo's dismissal.

Nuno fell out with Forest owner Evangelos Marinakis over the club's transfer policy and paid the price despite leading them to European qualification for the first time in 30

Marinakis hailed Postecoglou's appointment by insisting Forest are ready to challenge for silverware.

That might seem an ambitious statement given Forest have not won a major trophy since the 1990 League Cup.

But Postecoglou delivered on his boast that he always wins a trophy in his second season while at Tottenham and the 60-year-old knows he might have to achieve success even more quickly to satisfy Marinakis.

"I have won a couple in my first season. At Celtic I won a double in my first," he said on Thursday.

"I may have to win one to get a second year here. That's what I want to do. I want to win trophies."

He added: "Every club wants to be successful, but since the president took over the club those ambitions are backed up with actions. Perfect conditions for me."

If Postecoglou can win a trophy for Forest, he would follow in the footsteps of Brian Clough, who led the club to a pair of European Cups and the English title during the club's golden era in the late 1970s and early 1980s.

However, Postecoglou did not want to be compared to Clough as he looks to create his own legacy.

"He's a standalone legend. He's one of these figures you cannot compare to," said the Australian.

"He's one of the most legendary figures going around. He did it at a football club where no one expected that. If I can bring similar joy to this club and this city, I'll be a very happy

Postecoglou was criticised for his ultra-attacking tactics at Tottenham, which contrast with the cautious style that brought Forest success under Nuno.

The Australian's game-plan was exposed as Tottenham finished 17th last season but he will not compro-

South Africa well prepared for Davis Cup tie against Morocco

HAVING spent more time together than usual, captain Pietie Norval is confident the Renault SA Davis Cup team are ready to face Morocco in a crunch World Group II tie to be held at Groenkloof Tennis Club in Pretoria on Saturday and

"Some of our players came in from low altitude and they needed the extra day (to acclimatise), and altogether we felt our preparation for this tie needed to be even better than before.

"So all is good in the team. We have a couple of newcomers for this tie and with the extra day and more emphasis on high intensity training that went in over the last five days, I feel the guys are the best prepared that they've ever been."

The five-member Renault SA squad includes Alec Beckley and

19-vear-old Leo Matthysen, who both have experience playing in the

The other three members of the squad - Thando Longwe-Smit, experienced 30-year-old player Marc van der Merwe and 17-year-old prospect Connor Doig - will be hoping to make their Davis Cup debuts.

And while they were heading into the tie with a young team, missing some higher-ranked players who were either injured or unavailable, Beckley felt the hosts were ready to put up a fight against Morocco.

"I think it does put a little bit more pressure on us, but I think we are well prepared for it and we know what to do," said Beckley, the SA team's top-ranked player.

"We realise the situation and Pi-

etie has been working well with us, and everything is in place, so we're not worrying about 'what ifs'. This is what we have, so we're going to make the best of it, and we feel pretty confident in our capabilities this weekend."

MOROCCO CONFIDENT IN FOREIGN CONDITIONS

Morocco, who are seven places above South Africa in the Davis Cup rankings, were also confident heading into the tie, despite playing in foreign conditions.

Taha Baadi, Morocco's top-ranked player, said they had spent a week in camp in Ifrane (more than 300m higher in altitude than Pretoria) and they had acclimatised well to the conditions since arriving in South Africa's capital city. (Supersport)

...Postecoglou admits Spurs sacking 'not a surprise' despite European glory

ANGE Postecoglou said he knew he was going to be sacked by Tottenham well before he ended their long trophy drought by winning the Europa League.

The Australian is back in the Premier League after replacing Nuno Espirito Santo as Nottingham Forest manager earlier this week.

Postecoglou was axed by Tottenham in June, just 16 days after beating Manchester United in the Europa League final to secure the club's first silverware since the 2008 League Cup.

Despite that success, Postecoglou had been certain he would be dismissed as Spurs slumped to a 17th-placed finish that ranked as their lowest in the top-flight since 1976/77.

"It wasn't great. I knew it was coming so it wasn't a surprise. I knew it was coming a fair way before the final,"

he told reporters ahead of his first game in charge of Forest at Arsenal on Saturday.

"We won it and had the parade and had a great three days and I didn't want to tarnish that, but I knew it was done.

"From my perspective, I had the chance to process it. Whether I feel it was unjust, other people make those decisions, they make those determinations." "I do like my teams to play exciting football and score

Get fans excited for sure. No apologies about that. That's just the way I am and the way I want to see my teams play," Postecoglou said.

"The fans are not going to love me from the first day. I've got to earn their respect."

Postecoglou endured a turbulent two years at Tottenham.

The former Celtic manager got off to a flying start but his first season ended in disappointment when Spurs blew an opportunity to qualify for the Champions League.

Their decline in 2024/25 was stark, with miserable league results proving his downfall despite the European triumph, which secured Champions League action this season for his successor Thomas Frank.

"I had two years where it was very challenging but we were with some fantastic people in the football department," Postecoglou said.

"The supporters, we've put through some tough times, but there isn't a Spurs supporter that I come across now that doesn't want to hug me and take me home for dinner.

"So I must have done something right. I'm very proud of what we achieved there. It will always take a special place in my heart."

Spurs have since parted company with chairman Daniel Levy, who was instrumental in Postecoglou's dismissal.

The 60-year-old was diplomatic when asked about Levy's

"I didn't have a great deal of interaction with Daniel Levy. I tend to get on with my daily business and do what I need to do," he said.

"He was there for a very long time. He invested a hell of a lot in the football club in terms of building it up to where it was.

"Obviously, he appointed me so I've got to be thankful for that."

US captain Keegan Bradley is on the scene, too. He decided not to use one of six captain's picks on himself, nor is he playing in the Procore, yet he spoke at length to reporters Wednesday about the task ahead of him before the competition against Team Europe at Bethpage Black on September 26-28.

"Now we know our 12 (players) and it's great to be around those guys, hear what they're saying, really kind of finalising pairings and figure out how to send them out," Bradley said.

"And it's really fun for me to be the captain in front of the guys and not be playing because when I'm out there playing, I have to still be focused on that job and practicing and getting ready to play. Now I have one job and that's to prepare them and to do whatever they need this week to help them play better."

besides Scheffler are J.J. Spaun, Russell Henley, Harris English, Justin Thomas, Collin Morikawa, Ben Griffin, Cameron Young, Patrick Cantlay and Sam Burns.

It's unclear how much to read into the pairings of the first two rounds, but Scheffler will start out in a threesome with Spaun and Henley; Morikawa and English are together; Thomas, Griffin and Young make up a group; and Cantlay and Burns will play together as two of the best putters on tour.

"I felt like for myself going into the last Ryder Cup, my prep work may not have been as good as it should have been," Scheffler said. "I think I could have been a little bit sharper at that tournament. It's just because it's just different playing tournament golf, it really is. That was a learning experience for me."

Relegated to a subplot this week is the Fedex Cup Fall, where players who missed the top 50 in the in-season Fedex Cup race have multiple motivations to compete. Finishing the fall Nos. 51-60 unlocks berths in two signature events, the 2026 AT&T Pebble Beach Pro-Am and Genesis Invitational. The top 100 retain their PGA Tour cards, Nos. 101-125 keep conditional status and falling outside that spells danger for losing your card.

It's an important tournament for twotime champion Max Homa, who begins the fall No 111. Patton Kizzire is No 180 but earned a two-year exemption on tour when he won last year's Procore Championship by five shots.(**Supersport**)
