

ESWATINI and Taiwan are forging a stronger economic partnership that promises to transform the Kingdom's development trajectory.

At a high-profile business seminar held in Mbabane, Hilton Garden Inn in Mbabane on Tuesday, November 11, 2025, government and industry leaders unveiled plans for a groundbreaking Taiwan Innovation and Business Park in Phocweni, signalling a new era of collaboration focused on technology, manufacturing, and trade.

Manqoba Khumalo, Minister for Commerce, Industry and Trade, delivered a keynote address that underscored the significance of this partnership and its transformative potential for Eswatini's economic landscape.

Minister Khumalo opened his address by expressing his honour in speaking at the seminar and highlighted the multiple engagements between Eswatini and Taiwan this year, all aimed at fostering trade and investment.

He praised the Government of the Republic of China Taiwan for its unwavering commitment to Eswatini's economic development agenda. "The latest partnership has manifested in the form of the Taiwan Innovation and Business Park which will be built in Phocweni, an initiative that received the blessing of His Majesty King Mswati III earlier this year," he said.

This Innovation and Business Park is poised to be a game-changer, providing Taiwanese companies with a strategic working space to access regional markets with ease from Eswatini. Khumalo emphasised that this project is part of Eswatini's broader ambition to become a manufacturing hub for the region. "This is the third mission we have

received this year from Taiwan, and we are putting our efforts into turning these missions into real tangible projects for economic development," he added.

The minister outlined several key sectors where opportunities abound for collaboration. He described Eswatini as offering a "unique landscape for diverse economic activities," supported by a steadfast commitment to creating a conducive environment for trade. He noted that various incentives for foreign investors would be detailed by

the Eswatini Investment Promotion Authority during the seminar.

Highlighting Taiwan's global leadership in technology and innovation, Minister Khumalo invited Taiwanese businesses to share their expertise and invest in Eswatini's growing industries. "This will not only boost our economy but also enhance technological advancement in Eswatini," he remarked.

He also pointed to agriculture as the backbone of Eswatini's economy and expressed keen interest in collaborations in agro-processing technology. "The strength that Taiwan has in the food processing and packaging space deserves our attention, and hence we want to host companies in this area," he said.

Tourism was another sector identified for growth through bilateral cooperation. Minister Khumalo referenced recent engagements between tourism stakeholders of both nations aimed at increasing tourist traffic. "Given our rich cultural heritage and natural beauty, partnering in tourism can unlock new avenues for growth," he stated, envisioning joint ventures that would benefit both countries economically.

In a call to action, the Minister urged businesses present at the seminar to think creatively about partnership opportunities that would foster sustainable development and mutual prosperity.

He highlighted several government initiatives designed to attract and support investors, including the Permanent Resident by Investment program and the operational business one-stop shop. The Permanent Resident by Investment program aims to provide long-term certainty for investors to live and work in Eswatini.

Minister Khumalo further expressed heartfelt gratitude to Taiwan for its commitment to making Eswatini an investment home. "Together, we can build a brighter future through innovation, investment, and cooperation," he affirmed, emphasising that active participation in Eswatini's economy is essential for shaping a shared economic future.

TAIWAN's Ambassador to Eswatini, His Excellency Jeremy Liang, underscored the transformative potential of the Taiwan Industrial Innovation Park (TIIP).

"Eswatini is our most important diplomatic ally in Africa," he said, emphasising the deepening economic ties between the two countries.

"The construction of the Taiwan Industrial Innovation Park is the most significant initiative we have undertaken together. It will help Eswatini upgrade its industries, create jobs, and support Taiwanese businesses' global expansion, achieving mutual benefit and win-win results."

Ambassador Liang extended a warm welcome to the delegation led by Lo Chingjung and expressed gratitude to Eswatini's Ministry of Commerce, Industry and Trade and the Eswatini Investment Promotion Authority (EIPA) for organising the investment seminar

He highlighted the rapid momentum behind the TIIP, noting that nearly 50 Taiwanese companies have shown strong interest in investing in Eswatini within just a few months.

"Eswatini offers numerous investment advantages," Liang explained. "Competitive labour costs, good public security, political stability, and an impressive economic growth forecast of around 6 per cent over the next two years make it an attractive destination. Furthermore, the new U.S. tariff

policy places Eswatini at a base tariff of only 10 per cent, giving it a competitive edge over neighbouring countries when exporting to the U.S."

The Ambassador also pointed out the strategic timing of the TIIP initiative, which followed the visit of Minister Lin Chia-lung, special envoy of Taiwan's President Lai Ching-te, who met with His Majesty the King in April to discuss trade and economic cooperation. "Minister Lin's visit helped solidify important agreements, and the TIIP is a cornerstone project born from that dialogue," Liang said.

Taiwanese companies visiting Eswatini represent a broad spectrum of industries, including textiles, plastics, cosmetics, auto parts, building materials, packaging, casting, office furniture, and banking.

Ambassador Liang emphasised that their investments will significantly contribute to Eswatini's industrial diversification and upgrading.

He also praised Eswatini's efforts to create a favourable investment environment, citing the establishment of the Business One-Stop Service (BOSS) office to streamline company registration and investor-friendly immigration policies. To ensure reliable infrastructure, Eswatini has secured a 10-year power supply agreement with South Africa's ESKOM, guaranteeing stable electricity for the next decade.

Looking ahead, Ambassador Liang revealed that the Taiwanese government is considering incentives to encourage companies to join the TIIP, boosting investor confidence further. "With the strong determination and cooperation of both governments, I am confident we can build a high-quality industrial park that will become a benchmark in Southern Africa," he stated.

He concluded by thanking the Eswatini government for its swift action in allocating

158 hectares near Matsapha for the TIIP and singled out Minister Khumalo for his personal dedication to the project. "His presence at every investment seminar and direct engagement with business delegations clearly demonstrate the Kingdom's commitment to this partnership," Liang said.

"Together, we aim to make the TIIP a model industrial park that benefits the people of Eswatini and strengthens Taiwan-Eswatini relations."

THE long-awaited return of Siyabonga and Malusi Ndimande to South Africa has marked a turning point in one of the country's most high-profile murder investigations, the killing of rapper Kiernan 'AKA' Forbes and his close friend Tebello 'Tibz' Motsoane.

The brothers, who were extradited from Eswatini, are now back in police custody in Durban after months of legal processes and diplomatic coordination between the two neighbouring countries.

The Ndimande brothers arrived at King Shaka International Airport under heavy police escort late Sunday evening. Their extradition was finalised following a ruling by the Eswatini High Court, which dismissed their final appeal to block transfer to South African authorities.

The pair had been held at Matsapha Correctional Facility since their arrest earlier this year. South African Police Service (SAPS) spokesperson Brigadier Athlenda Mathe confirmed that the two suspects are now under police custody in Durban, where they are expected to make a first court appearance in connection with the murder case later this week.

"The extradition process has now been concluded. The suspects are in South Africa and will appear before a court of law to answer to the charges related to the murders of Kiernan Forbes and Tebello Motsoane," Mathe said.

Meanwhile, AKA's father, Tony Forbes, has expressed relief at the latest development, describing it as a long-awaited moment for the family and for the public who have followed the case closely since February 2023.

"It has been a long and painful journey. We've had to live every day not knowing if those responsible would ever be brought back to face justice. Seeing this progress gives us some comfort, but the real closure will only come through the court process,"

The case has drawn regional attention due to the cross-border nature of the investigation. The Ndimande brothers were arrested in Mbabane after police traced them through cooperation between the SAPS and the Royal Eswatini Police Service (REPS).

Their extradition marks the first major

criminal handover between the two nations since the signing of their updated bilateral agreement on mutual legal assistance.

Lt-Gen Nhlanhla Mkhwanazi, KwaZulu-Natal's Provincial Police Commissioner, who has overseen the investigation from its earliest stages, said the return of the brothers will strengthen the prosecution's case.

"Our focus has always been to ensure that everyone involved in the planning and execution of this crime is accounted for. The extradition of the Ndimande brothers means we can now consolidate all evidence and proceed toward prosecution."

Kiernan AKA Forbes and his long-time friend, celebrity chef and entrepreneur Tebello Tibz Motsoane, were shot dead outside Wish Restaurant on Florida Road, Durban, on February 10, 2023. CCTV footage of the incident, showing two gunmen approaching and firing at close range, spread widely online, sparking national outrage and grief.

The police investigation later identified multiple suspects, alleging a coordinated hit involving spotters, shooters, and getaway

Six men were previously arrested in connection with the killings, and authorities have stated that the Ndimande brothers are believed to have played key roles in the orchestration of the attack.

According to court documents filed earlier this year, the Ndimande brothers allegedly fled to Eswatini within days of the murder.

They were arrested in March following an international manhunt and had since been fighting extradition through local courts in Mbabane, claiming fears for their safety.

Eswatini's Ministry of Justice confirmed last week that all procedural requirements for extradition had been met, paving the way for their transfer to South African authori-

"The government of Eswatini has acted in accordance with the law and the principles of cooperation between states. This was a sensitive case, but justice must take its course," said the Ministry at the time.

While the case progresses, Tony Forbes has continued to urge the public to remain patient and allow the courts to do their work. He has consistently emphasised that the family seeks justice, not revenge.

" We have always trusted the justice system. Our family has gone through unimaginable pain, but we believe in letting the truth come out in court. We just want accountability, nothing more, nothing less," he said.

Forbes also thanked the public for their continued support and solidarity, noting that his son's legacy continues to inspire fans across the continent.

"AKA was more than just a musician. He was a son, a father, a friend, and a proud South African. Seeing how many people still care about him and want to see justice done gives us strength," he said.

Meanwhile, in Durban, residents gathered outside the courthouse early Tuesday morning, expressing relief at the news of the brothers' return. Some said they had lost faith that the suspects would ever be extra-

Durban local Sanele Dlamini, who witnessed the police convoy passing through the CBD, said the sight brought back memories of the night the rapper was killed.

The Ndimande brothers are expected to ace multiple charges, including premeditated murder, conspiracy to commit murder, and unlawful possession of firearms. They are likely to be joined to the existing case involving six other suspects already in cus-

Police sources say additional arrests cannot be ruled out, as investigations into the financial trail behind the alleged contract killing continue. Authorities have not yet confirmed who allegedly ordered the hit.

"We are not closing the investigation. Our team continues to follow leads. Everyone who had a hand in this crime will be brought before the court," said

Family survives hail of bullets in Big Bend

POLICE in Big Bend are investigating an attempted murder case after a family of six narrowly escaped death in a late-night shooting at the Mahlabaneni area on Saturday.

The incident occurred around 2030 hours on November 8, 2025, when the family was returning home from an outing. According to police reports, as they approached their homestead, gunmen opened fire, riddling the house with bullets in what investigators believe was a planned attack.

"Four shots were fired through the house window, but fortunately, no one was injured," said Deputy Police Information and Communication Officer Assistant Superintendent Nosipho Mnguni in an official statement.

Mnguni said early investigations suggest that the assailant or assailants were waiting

outside the family's property before opening fire. A 16-year-old boy, who was walking slightly behind his family at the time, told police he heard the gunfire but could not identify the shooter. "The shots came from outside the fence," he said, indicating that the attacker may have been lurking nearby.

Police have not yet established a motive, and no arrests have been made. Mnguni said the Royal Eswatini Police Service (REPS) is pursuing all leads and has appealed to the public for assistance.

"Anyone with information that may lead to the arrest of the suspect or suspects is urged to contact Lubombo RCBO Mr. Justice Mabuza at 7606 8572, Desk Officer Inspector Dlamini at 7628 2166, or the Big Bend Police Station at 2363 6416," she said. Members of the public may also dial 999, 9999, or 112 in case of emergencies.

Police patrols have reportedly been intensified in the area as residents express concern over the attack, which has left the Mahlabaneni community shaken.

Focus on Army Recruitment Race

First graduate wins army race

THE army recruitment drive reached its 40th stop at Madlangemphisi Inkhundla, where a graduate made history by taking top honours in the ladies' category.

Thabile Matfonsi, 29, a teacher graduate from Mavula, emerged victorious after outpacing dozens of other determined women in the tough army recruitment race. Matfonsi, who completed her studies at CIT College in Siteki last year, showcased both physical strength and mental endurance as she crossed the finish line to the sound of loud cheers from an enthusiastic crowd.

The ongoing army recruitment exercise, coordinated by the Umbutfo Eswatini Defence Force (UEDF), has seen hopefuls from all over the country participate in competitive races designed to test fitness, determination, and discipline key traits for those seeking to serve in the military.

"I am overjoyed and grateful for this moment. It's not just about winning, but about

proving that hard work and education can go hand in hand with strength and resilience," Matfonsi said after the race, still beaming with pride.

Her victory, organisers noted, marks the first time a university graduate has won in the ladies category since the nationwide recruitment drive began earlier this year. Officials said her success highlights the growing interest among educated young people in contributing to national service through the army.

Brigadier General Luhlanga, who presided over the event, congratulated all participants for their effort and perseverance despite the scorching heat. He commended Matfonsi's performance, describing it as a testament to Eswatini's youth potential and a reflection of the army's values of excellence and discipline.

Madlangemphisi Inkhundla's event forms part of the ongoing UEDF national recruitment campaign, which has already covered 40 of the country's constituencies, with more races expected in the coming weeks as the force continues its search for the next generation of disciplined men and women ready to serve the Kingdom.

Massive crowds turn out in Gilgal and Madlangemphisi

HUNDREDS, if not more than a thousand spectators, gathered over the weekend to witness the latest leg of the Eswatini National Army recruitment races held in Gilgal and Madlangemphisi Inkhundla respectively.

The events drew large crowds of young men and women hoping to secure a place in the country's military, as well as families and community members who came out in support.

The recruitment races have become a national spectacle's recent weeks, attracting massive participation across the country as the army continues its drive to enlist new recruits for the 2025 intake. At both venues, hopefuls arrived as early as dawn, some traveling long distances to take part in the grueling endur-

ance test that has become the hall-mark of the selection process.

Senate passes MVA bill raising accident compensation to E3 mln

ACCIDENT survivors and families of victims may soon receive higher compensation after Senators on Tuesday passed the Motor Vehicle Accidents Fund Bill No. 6 of 2025, which seeks to raise the total liability limit for multiple claimants from E1 million to E3 million.

The Bill, tabled by Minister for Finance Neal Rijkenberg, was approved by the Senate and will now be referred to the Ministry of Finance Portfolio Committee for further review before final enactment.

Once signed into law, the Bill will amend the Motor Vehicle Accidents Act No. 13 of 1991 to align with current legal developments, extend the mandate of the Sincephetelo Motor Vehicle Accidents Fund (SMVAF), and remove disparities between categories of claimants.

The amendment has been welcomed by road accident victims and families who have long lobbied for an increase in the maximum claims payable under the Fund. Under the current law, multiple claimants involved in a single accident can claim up to E1 million, while the total amount for general damages is E150 000 per claimant. The proposed Bill will double these amounts, raising the general damages limit to E300 000 per claimant and the total pay-out for multiple claimants to E₃ million.

Additionally, compensation limits for fare-paying passengers will rise from E200 000 to E1.5 million, while benefits for social passengers those travelling without paying will increase from E50 000/E500 000 to E200 000/E1.5 million, respectively.

also introduces general capping provisions relating to medical stabilisation, treatment, and rehabilitation costs.

It establishes new categories of liability, ensuring that different types of claimants are treated fairly and equitably. Previously, critics argued that the Fund's pay-out structure was out dated and unfair, particularly in cases involving multiple victims.

For years, emaSwati have called for higher claim limits, citing tragic accidents such as the Malagwane collision, where over 20 cars collided with a truck and later caught fire.

In such cases, survivors were forced to share the existing E1 million ceiling, which many argued was insufficient to cover medical, rehabilitation, and other costs.


According to Minister Rijkenberg, the Fund has paid out over E600 million in compensation over the past five years, highlighting the growing financial burden of road accidents on both the government and society.

Speaking at the SADC Road Accident Funds' Meeting at Hilton Garden Inn earlier this year, the Minister emphasised that the agencies, collectively shoulder costs that run into billions of Emalangeni over the same period.

Meanwhile the Bill also proposes several modernisation measures. It broadens the definition of fuel to include alternative sources such as electric vehicles, reflecting the rise of clean energy transport solutions.

The definition of driving will now also include driverless vehicles, and the fuel levy will apply not only to importers but also to blenders and producers of fuel within the

Another significant change is the reduction in the claim lodging period. Currently, claimants have up to 24 months to file a claim, barring exceptional circumstances. The proposed law shortens this period



ty of certain provisions of the existing Act. One such case involved Muzikababa Benedict Sibiya, who in 2013 was severely injured in a hit-and-run accident. Section 11 of the Motor Vehicle Accidents Act previously required victims to identify the vehicle or driver involved in order to claim compensation for bodily injury or death.

Sibiya contended that the provision was unfair and irrational, as he had been rendered unconscious and could not identify the vehicle responsible.

He was admitted to the Mbabane Government Hospital Intensive Care Unit, underwent a craniotomy, and was later transferred to Hope House for a month of rehabilitation. At the time of the accident, he was a thirdyear student at Luyengo Campus, University of Eswatini, pursuing a BSc in Animal Sci-

The High Court ultimately declared Section 11 unconstitutional in 2021, ruling that it discriminated against victims unable to identify the offending vehicle and unfairly limited compensation. The judgment prompted legislative reforms now incorporated into the 2025 Bill.

E856mln processed through Eswatini


OVER E856 million worth of transactions have been processed through the Eswatini Payment Switch (EPS) since its launch less than a year ago, signalling a major advance in the country's digital financial inclusion efforts. The figures were revealed by Brian Sihlongonyane, Deputy Head of Information Technology at the Central Bank of Eswatini (CBE), during the unveiling of the 2025 State of Inclusive and Instant Payment Systems (SIIPS) Report in Ezulwini.

ALONGSIDE the report launch, the State of Inclusive Instant Payment Systems (SIIPS) 2025 Media Workshop was hosted at the CBE Complex in Ezulwini. Both local and international journalists gathered for an interactive learning session focused on financial inclusion and digital finance reporting.

Stocks rise as US shutdown nears end

European shares rose for a second day, fuelled in part by gains in London's FTSE 100. It hit record highs as the pound fell following British employment data that gave investors more confidence in the chances of a growth-boosting rate cut from the Bank of England next month.



Central Bank reserves rise to a sharp E14.4 billion

THE Central Bank of Eswatini (CBE) has reported a strong increase in the country's gross official reserves, which climbed to E14.4 billion in October 2025.

This marks a significant 34.2 per cent increase month-on-month and a 14.2 per cent rise compared to the same period last year.

According to the Bank's latest Monthly Statistical Release for September and October 2025, the rise in reserves improved the nation's import cover from 2.5 months in September to 3.4 months in October.

The CBE noted that this improvement strengthens Eswatini's external position and enhances its ability to meet international payment obligations.

The report also shows that credit extended to the private sector rose by 2.1 per cent from the previous month and 8.9 per cent year-on-year, reaching E21.7 billion in September 2025.

"The steady expansion in private-sector lending reflects continued business and household borrowing, particularly in sectors such as manufacturing, trade, and real estate," states the report in part.


The increase indicates growing credit demand and activity in the economy. The Bank said the private-sector credit performance contributes to overall financial sector stability and supports on-going recovery in various industries. It is further reported that Eswatini's broad money supply, known as M2, rose slightly by 0.2 per cent month-on-month and 10.3 per cent year-on-year to close at E26 billion in September 2025.

"The rise in money supply suggests a modest increase in liquidity within the banking system during the period under review," stated the report.

Furthermore, the report shows that despite the moderate monthly gain, the annual growth in M2 remains strong, reflecting continued expansion in deposits and savings held by individuals and businesses.

According to the report the steady growth of broad money is important for supporting lending activity and economic transactions throughout the financial system.

Meanwhile domestic liquid assets were recorded at E8.7 billion in September



Noting that, the slight monthly drop indicates some drawdowns in cash balances or short-term placements, while the annual increase points to stronger overall liquidity compared with the previous year.

Meanwhile the Bank maintained both the discount rate and the prime lending rate during the reporting period. The discount rate remained at 6.75 per cent, while the prime lending rate was steady at 10.25 per cent in October 2025. The decision to keep rates unchanged reflects a balanced approach by the CBE in supporting economic activity while maintaining price stability.

The current rates influence the cost of borrowing for businesses and households and help determine lending conditions across the financial sector. Worth noting is, the October report presents a generally positive picture for Eswatini's monetary indicators. The sharp growth in official reserves and the steady increase in private-sector credit indicate resilience

in the financial system.

The reserves' import cover improvement from 2.5 months to 3.4 months suggests a stronger external buffer.

◀CBE Governor Phil Mnisi. Analysts note that import cover above three months is typically viewed as a sign of adequate foreign-exchange strength.

Meanwhile, the 8.9 per cent annual growth in private-sector credit and 10.3 per cent increase in money supply show that domestic financial activity continues to expand, even amid moderate global economic pressures.

In addition the mild contraction in liquid assets is not seen as a major concern, given the overall year-on-year growth and sustained availability of funds in the banking sector.

Worth mentioning is the CBE's latest data come as Eswatini continues to pursue policies aimed at stabilising its economy and enhancing fiscal discipline.

The government and the central bank have prioritised maintaining foreign-exchange stability, improving investment confidence, and ensuring that inflation remains under control.

The report also highlights the role of the central bank in monitoring financial and liquidity trends to ensure that sufficient reserves and domestic credit are available to support economic growth.

With gross official reserves now at E14.4 billion, Eswatini is in a stronger position to manage external shocks and maintain currency stability. The year-on-year increases across most key indicators suggest that the financial system remains healthy and responsive to both publicand private-sector demand.

OVER E856 million worth of transactions have been processed through the Eswatini Payment Switch (EPS) since its launch less than a year ago, signalling a major advance in the country's digital financial inclusion efforts.

The figures were revealed by Brian Sihlongonyane, Deputy Head of Information Technology at the Central Bank of Eswatini (CBE), during the unveiling of the 2025 State of Inclusive and Instant Payment Systems (SIIPS) Report in Ezulwini.

The event is being hosted by the CBE in partnership with the AfricaNenda Foundation, which leads Africa's research on real-time and inclusive payments.

Sihlongonyane reported that the EPS has successfully processed 194 000 transactions, representing more than USD 46 million (E856 million) in value since its introduction on December 11, 2024.

The platform allows instant money transfers between banks and mobile money service providers, a first for Eswatini's financial landscape.

"Eight financial institutions have now joined the national payment switch: First National Bank (FNB), Eswatini Building Society, Eswatini Bank, and Standard Bank. The mobile money providers include E-mali, MTN Mobile Money (MoMo), and Insta-Cash," presented Sihlongonyane.

In addition, he confirmed that Nedbank

Eswatini will officially connect to the EPS on November 15, 2025, following its licence approval on October 27, 2025.

"The Eswatini Payment Switch connects all participating institutions under one secure network, enabling customers to transfer funds instantly across banks and mobile wallets," he said.

Worth noting the EPS is designed to simplify real-time, low-cost transfers between different financial platforms, reducing delays and improving access for consumers and small businesses.

"The EPS forms part of the Central Bank's broader strategy to modernise the national payment system and expand financial access across all population groups. Sihlongonyane said the switch has remained stable and secure since going live, maintaining strong performance and regulatory oversight," said Sihlongonyane.

"Every transaction is processed instantly, with full security and traceability. This has strengthened public confidence in digital payments," he added.

He further mentioned that plans are underway to extend the switch to include microfinance institutions, utility companies, and public-sector services, creating a fully connected payment environment.

Eswatini hosts SIIPS report launch

ALONGSIDE the report launch, the State of Inclusive Instant Payment Systems (SIIPS) 2025 Media Workshop was hosted at the CBE Complex in Ezulwini.

Both local and international journalists gathered for an interactive learning session focused on financial inclusion and digital finance reporting.

In hindsight, the workshop programme is designed to deepen journalists' understanding of the evolving payment ecosystem and their role in communicating it to the public.

Sessions included an in-depth look at Eswatini's national payment switch, exploring the policy and regulatory lessons it offers for achieving interoperability and harmonisation across financial institutions.

Another component, the Data-to-Story Challenge, provides practical newsroom exercises aimed at helping reporters translate complex financial data into clear and engaging media narratives.

Participants were also guided through the key findings of the SIIPS 2025 Report, with experts outlining expectations for the next phase of inclusive payment systems across the continent.

Later in the day, a journalist-led panel discussed the opportunities and challenges of reporting on digital inclusion, focusing on access, gender, consumer protection, and cross-border payments.

This is all set against the backdrop of Africa's growing digital finance landscape, where instant and inclusive payment systems are rapidly transforming how individuals and businesses interact with money.

Across the continent, digital public infrastructure spanning identity systems, nation-

al switches, and mobile payment platforms is strengthening connectivity between formal and informal economies.

Meanwhile, the SIIPS 2025 Report tracks the expansion of Inclusive Instant Payment Systems (IIPS) across the continent platforms that make real-time, affordable transactions possible for individuals and businesses alike.

This year's report introduces Africa's first fully mature IIPS, a landmark in the continent's financial development. It highlights how countries are building Digital Public Infrastructure (DPI) to link identity systems, payment rails, and secure data frameworks that enable inclusive growth.

The AfricaNenda Foundation commended Eswatini for its leadership in implementing the EPS, describing the system as an example of how small economies can achieve full interoperability within a short period.

Countries with similar systems, the report notes, are seeing measurable increases in financial access, growth in small-business activity, and wider adoption of digital commerce

Data deluge incoming

"Obviously, the shutdown isn't completely sorted yet. The House has got to get it through, but given the arithmetic of the House, that seems pretty certain," Investec chief economist Philip Shaw said, referring to the Republican majority in the House of Representatives.

"The data deluge is going to be essentially a huge market event. One question is whether the data and the analysis by the Fed are consistent with each other."

The Federal Reserve cut interest rates at its most recent meeting, but Chair Jerome Powell cautioned against assuming another cut in December is a given, not least because of the uncertainty over what key data on

employment and inflation might show.

The STOXX 600 was up 0.6 per cent on Tuesday, defying a 0.2-0.3 per cent drop in S&P 500 and Nasdaq futures . The FTSE 100 rose 0.8 per cent.

Shutdown compromise clears senate

The deal on the shutdown now heads to the House, where Speaker Mike Johnson has said he would like to pass it as soon as Wednesday and send it on to President Donald Trump to sign into law.

Prediction markets, such as the online

Polymarket, have nearly fully priced in the reopening of the U.S. government for the end of the week.

The nearly six-week shutdown will have likely already knocked somewhere between 0.4 and 1 percentage points from fourthquarter gross domestic product, said UBP economist Carlos Casanova in Hong Kong.

"However, if you look at previous instances, typically what happens is in the quarter after the activity bounces back ... So, I think what the market is doing is looking ahead one quarter and repricing that rebound."

On Wall Street the S&P 500 closed up 1.54 per cent on Monday for its biggest one-day percentage gain since mid-October, while the Nasdaq notched its largest daily gain since May.

Also on Monday, a basket of the biggest AI-linked U.S. tech stocks staged its largest one-day rally since May, rising 2.8 per cent . Some of that enthusiasm could be tempered by news that Japan's SoftBank Group, in its results, said it had sold its entire stake in Nvidia for \$5.83 billion in October. Nvidia shares fell 1.6 per cent in premarket trading.

Oil stable as investors balance sanctions risks against oversupply

LONDON — Oil prices were stable on Tuesday, as oversupply concerns balanced uncertainty over the impact of the latest U.S. sanctions on Russian

Brent crude futures were up 39 cents, or 0.61 per cent, to \$64.45 a barrel at 1254 GMT. U.S. West Texas Intermediate crude was at \$60.46 a barrel, up 33 cents, or 0.55 per cent.

Investors continue to assess the fallout from the U.S. sanctions on Russia, and their impact on both crude oil and refined fuel markets.

Lukoil declared force majeure at an Iraqi oilfield it operates, sources told Reuters on Monday, marking the biggest fallout yet from the sanctions imposed last month.

Restricted fuel exports as a result of the sanctions are propping up oil prices in the face of a crude oil glut, PVM analyst Tamas Varga said.

"Fresh U.S. sanctions on major Russian oil producers and exporters are weighing on product exports. As a result, heating oil/ gasoil and RBOB gasoline are moving in a different direction from crude," he said.

European diesel futures' premium to Brent crude was at a 21-month high of over \$31.50 per barrel on Tuesday, while European gasoline profit margins were at their highest in 18 months at almost \$21 per barrel on Monday.

Worries about crude oversupply are keeping a lid on oil prices.

Earlier this month, OPEC+ agreed to increase December output targets by 137,000 barrels per day, but also agreed to a pause in increases in the first quarter of next year.

"The oil market is also facing a considerable oversupply in the coming year, which is why prices are likely to remain under pressure. The main cause of the oversupply is the significant expansion of supply by OPEC+," Commerzbank analysts said in a note.

OPEC+ has added 2 million bpd of output since April, and a willingness within the group to reverse voluntary production cuts further after the first quarter pause could add an extra 1 million bpd in the coming year, Commerzbank said.

Additionally, the volume of oil stored on board ships in Asian waters has doubled in recent weeks after tightening Western sanctions hit exports to China and India, analysts said.

Otherwise, wider markets saw support as the longest government shutdown in U.S. history could end this week after the Senate approved a compromise that would restore federal funding. (Reuters)

Dollar steadies against yen, falls vs euro as focus turns to US data

THE U.S. dollar edged up versus the safe-haven yen and dropped against the euro on Tuesday as investors were uncertain about the U.S. economic outlook while awaiting a strong run of data once the U.S. government shutdown ends.

Australian dollar and British pound have strengthened recently, while safe-havens like the yen have weakened amid optimism that the U.S. government shutdown will end quickly, averting significant economic damage.

In early Asian trade, the yen touched its weakest level since February, while the Australian dollar held firm against the greenback.

Market participants expect the U.S. closure to end in the next few days after the Senate on Monday approved a compromise that would restore funding for federal agencies and would stall President Donald

Trump's campaign to downsize the federal workforce.

The deal to end the shutdown now heads to the House, where Speaker Mike Johnson has said he would like to pass it as soon as Wednesday and send it on to Trump to sign into law.

"There will be little sense of direction in the coming days: reopening prospects allow markets to price out the negative growth impact, but a resumption of data releases in the U.S. does carry non-negligible downside Growth-sensitive currencies such as the risks to the dollar," said Francesco Pesole, forex strategist at ING.

"We think markets are underestimating the downside risks for the labour market, U.S. front-end rates and, by extension, the dollar into year-end," he added.

The euro was up 0.15 per cent at \$1.1572.

The single currency is supported by a firmly-anchored outlook for European Central Bank policy, with its key rate expected to stay unchanged through 2027, while the Fed is seen easing policy.

Risks to euro zone inflation are balanced and growth is stronger than once expected, two ECB policymakers said on Tuesday. (Reuters)

A packed field of parties is contesting Egypt's parliamentary election but those set to dominate the chamber agree on most issues of substance, including their staunch support for President Abdel Fattah al-Sisi.

Voting in Egypt began on Monday, nearly two years after Sisi was elected to a third, six-year term, the final term he is allowed under Egypt's current constitution. Polling is held over several phases and continues for more than five weeks.

Campaign banners hanging on streetsides and traffic circles featured a dozen logos – on paper as crowded a field as at practically any time since the 2011 Arab Spring uprising ended decades of one-party rule.

Unlike those days, however – when Islamists, liberals, socialists and regime loyalists waged hardscrabble campaigns for hearts and minds – the parties are now broadly aligned as they try to drum up enthusiasm among a disengaged electorate.

SEATS ALLOCATED TO CLOSED PARTY LIST

They are also running together under a hybrid voting system that allocates a little under half of seats to closed party lists.

This year only one list made the ballot – one that gives the lion's share of seats to three pro-government parties, meaning many lawmakers were effectively guaranteed a win before the first vote was cast.

Several opposition figures were barred from competing as individual candidates, including both ultraconservative Islamists and leftists, based on a new interpretation of a military service requirement. Campaign costs and medical screening kept others out.

Critics say such moves have left many voters apathetic, especially after being worn down by years of economic hardship. Turnout in a vote for parliament's advisory upper house this summer was just above 17%.

At one polling station in Giza, a 58-yearold electrician who gave his name as Amgad said people working for the candidates had bussed him in to vote, but he wasn't sure who those candidates were, since "all the

delegates work together."

Defenders of the system say the party lists include a diversity of views and interests and help secure better representation for women and minorities. They deny voter manipulation.

The State Information Service, which liaises with foreign media in Egypt, did not immediately respond to a request for comment.

NEW PARTY PRESENTED AS 'UNI-FYING ENTITY'

Under former president Hosni Mubarak, who was ousted in 2011, lawmaking was dominated by the National Democratic Party, in which businessmen and Mubarak's son held prominent roles.

By contrast, Sisi has never joined a party. The group most closely associated with his agenda, the Nation's Future party, will likely lose ground based on the upper chamber results.

One of the biggest gainers in that vote was the National Front Party, founded late last year and now fielding businessmen and former ministers.

The party – which needed just 5,000 endorsements to be established but said it gathered over half a million – is "neither loyalist nor opposition, nor is it a single school of thought," its co-founder Diaa Rashwan, who also heads the State Information Service, said in a TV interview early this year.

It is instead a "unifying entity", he added.

Others on the list are Nation's Future and the Homeland Defenders, a party founded by former military officers in 2013 which also made gains in the upper house vote.

Homeland Defenders seek to fulfill "a long-term developmental vision aligned with the state's leadership," spokesperson Amr Suleiman told Reuters.

The election involved "strong competition among parties and independents for individual seats," he said.

OPPOSITION IN A BIND

Timothy Kaldas, an analyst at the U.S.-based Tahrir Institute for Middle East Policy, said the proliferation of pro-government parties helps centralise authority by preventing rival power centres from coalescing.

"Going from the Nation's Future Party dominating parliament to a bunch of loyalist parties is a way to further weaken all of them, and also a way to reward new loyalists," he said.

Opposition figures have been left with a dilemma; join the list or risk being shut out.

The Social Democratic Party decided to add its name. "We still feel there's room to influence politics in the house, so we're not going to waste it," said Maha Abdel Nasser, a parliamentarian with the party who is running again.

The Constitution Party – founded in 2012 by Nobel laureate Mohamed ElBaradei – took the opposite tack, teaming up with the Conservative Party to contest individual seats.

The campaign was an uphill battle against "political money" and voter indifference, said Mariam Farouk, the bloc's spokesperson.

Sudan relief operations are 'on the brink of collapse,' UN migration agency warns

THE U.N. migration agency warned on Tuesday that humanitarian efforts in Sudan's war-torn North Darfur region might come to a complete halt unless immediate funding and safe delivery of relief supplies are ensured.

"Despite the rising need, humanitarian operations are now on the brink of collapse," the International Organization for Migration (IOM) said in a statement. It added: "Warehouses are nearly empty, aid convoys face significant insecurity, and access restrictions continue to prevent the delivery of sufficient aid."

The IOM said more funding is needed to mitigate the humanitarian impact of the war between the Sudanese army and its rival paramilitary Rapid Support Forces. The agency warned of "an even greater catastrophe" if its appeal went unheeded.

"Our teams are responding, but insecurity and depleted supplies mean we are only reaching a fraction of those in need," IOM Director General Amy Pope said in a statement.

The RSF's recent capture of North Darfur's capital, el-Fasher, left hundreds dead and forced tens of thousands of people to flee reports of atrocities by the paramilitary force, according to aid groups and U.N. officials. The IOM said nearly 90,000 people have left el-Fasher and surrounding villages, undertaking a perilous journey through unsafe routes where they have no access to food, water or medical assistance.

Tens of thousands of people have arrived at overcrowded displacement camps in



Tawila, about 70 kilometers (43 miles) from el-Fasher. In the camps, the displaced find themselves in barren areas with few tents and insufficient food and medical supplies.

"We have been getting little food from community kitchens here; we only get lunch meals," Sohaiba Omar, 20, told The Associated Press from a shelter in Diba Nayra camp in Tawila.

"We also need a nearby source of water and toilets. Disposing of our wastes in the open can make us fall sick and catch diseases like Cholera," she added.

Batoul Mohamed, a 25-year-old volunteer at the camp, said: "The displaced are too many; they are also hungry. It is very difficult to have people come up to us saying that they could not eat because there not was not enough food."

The violence has spread to other parts of Sudan including Western Darfur and the Kordofan region, forcing more people to flee their homes. Nearly 39,000 people fled the conflict in the North Kordofan from Oct. 26

and Nov. 9, according to the IOM.

The war between the RSF and the military began in 2023 when tensions erupted between the two former allies that were meant to oversee a democratic transition after a 2019 uprising. The fighting has killed at least 40,000 people, according to the World Health Organization, and displaced 12 million. However, aid groups say the true death toll could be many times higher.

Trump re-nominates Musk ally and private astronaut Jared Isaacman as NASA chief

U.S. President Donald Trump said on Tuesday he was re-nominating Jared Isaacman, the private astronaut and ally of fellow billionaire and SpaceX founder Elon Musk, for the post of NASA administrator, five months after Isaacman's original nomination was withdrawn.

Isaacman, an e-commerce mogul who flew to orbit twice on all-private astronaut missions as a customer and collaborator with SpaceX, was removed from consideration to lead the space agency in late May amid a high-profile falling-out between Trump and Musk. Sean Duffy, the head of the U.S. Department of Transportation, was named interim NASA chief in July.

At the time, NASA's workforce of 18,000 and the space industry at large were being whipsawed by looming layoffs and proposed budget cuts threatening cancellation of dozens of U.S. science programs. Nearly 4,000 NASA employees took buyouts the Trump administration offered in January and April, according to a union that represents about 8,000 space agency personnel.

The return of Isaacman as Trump's nominee to fill the NASA vacancy on a permanent basis came about two weeks after Duffy said he was inviting other companies to compete with SpaceX for the agency's marquee lunar landing contracting, leading to a public spat between Duffy and Musk over who should be leading the space agency.

Responding to reports that Duffy was looking to fold NASA into the Transportation Department, Musk wrote online last month, "The person responsible for America's space program can't have a 2 digit IQ."

In a Fox News appearance a day earlier, Duffy said SpaceX's development of its next-generation moon rocket, Starship, was falling behind schedule and could undermine NASA's goal of returning humans to

the lunar surface under the agency's Artemis Party holds a 53-47 majority. program, an effort rivaling China's lunar ambitions.

By then, the agency had confirmed that Duffy and Isaacman were engaged in talks about possibly resurrecting Isaacman's NASA nomination.

"This evening, I am pleased to nominate Jared Isaacman, an accomplished business leader, philanthropist, pilot, and astronaut, as Administrator of NASA," Trump said on social media. The role requires confirmation by the Senate, where Trump's Republican

the SpaceX chief executive officer who had been an influential adviser to the president and sought to more closely align the U.S. space program with his goal of flying missions to Mars.

Isaacman, a billionaire investor and amateur jet pilot with thousands of hours of flight time under his belt, then spent months navigating the Senate confirmation process, balancing the desire of Musk and the Trump administration to focus on Mars with NA-SA's multibillion-dollar strategy to return astronauts to the moon by 2027, ahead of China in a geopolitical race to the lunar surface.

"Jared's passion for Space, astronaut experience, and dedication to pushing the boundaries of exploration, unlocking the mysteries of the universe, and advancing the new Space economy, make him ideally suited to lead NASA into a bold new Era," Trump wrote in his post.

Isaacman, founder and CEO of the financial transactions service Shift4 Payments (FOUR.N), opens new tab, was the commander and chief benefactor of the first all-private space crew to reach Earth orbit in 2021. He led a four-member team of civilian rookie astronauts aboard a SpaceX rocket vessel on a three-day mission dubbed Inspi-

He returned to orbit in September 2024 with a follow-up commercial voyage that he again bankrolled, leading another quartet of private astronauts on a mission dubbed Polaris Dawn, in which he joined a SpaceX engineer in conducting the world's first private spacewalk.

Hours before Trump announced his re-nomination, Isaacman restated on X some of the priorities that he said he had outlined during previous Senate testimony, including an emphasis on putting "more astronauts in space with greater frequency."

Isaacman said he embraced the goal of returning American astronauts to the moon under the Artemis program to "determine the scientific, economic and national security reasons to support an enduring lunar presence," before eventually shifting resources toward "the near-impossible that no one else will work on like nuclear electric propulsion."

He also said he supported "maximizing the remaining life" of the International Space Station as part of a longer-term effort to build an "orbital economy" with various commercial interests. (Reuters)

OPENAI'S chatbot ChatGPT violated German copyright laws by reproducing lyrics from songs by best-selling musician Herbert Groenemeyer and others, a court ruled on Tuesday, in a closely watched case against the U.S. firm over its use of lyrics to train its language models.

The regional court in Munich found that the company trained its AI on protected content from nine German songs, including Groenemeyer's hits "Maenner" "Bochum".

The case was brought by German music rights society GEMA, whose members include composers, lyricists and publishers, in another sign of artists around the world fighting back against data scraping by AI.

Presiding judge Elke Schwager ordered OpenAI to pay damages for the use of copyrighted material, without disclosing a figure.

GEMA legal advisor Kai Welp said GEMA hoped discussions could now take place with OpenAI on how copyright holders can be remunerated.

COPYRIGHT INFRINGED

OpenAI had argued that its language models did not store or copy specific training data but, rather, reflected what they had learned based on the entire training data set.

Since the output would only be generated as a result of user inputs known as prompts, it was not the defendants, but the respective user who would be liable for it, OpenAI had

However, the court found that both the memorisation in the language models and the reproduction of the song lyrics in the chatbot's outputs constitute infringements of copyright exploitation rights, according to a statement on the ruling.

POTENTIAL PRECEDENT

The outcome of the case could set a precedent in Europe for how AI companies use copyrighted materials.

"The internet is not a self-service store, and human creative achievements are not free templates," said GEMA CEO Tobias Holzmueller. "Today, we have set a precedent that protects and clarifies the rights of authors: even operators of AI tools such as ChatGPT must comply with copyright law."

The decision can be appealed.

"We disagree with the ruling and are considering next steps," a spokesperson for OpenAI said. "The decision is for a limited set of lyrics and does not impact the millions of people, businesses and developers in Germany that use our technology every day."

Earlier this year, leading Bollywood music labels asked a New Delhi court to join a copyright lawsuit against OpenAI over alleged unauthorised use of sound recordings to train AI models, underscoring global concerns about AI and music rights.

Venezuelan military preparing guerrilla response in case of US attack

VENEZUELA is deploying weapons, including decades-old Russian-made equipment, and is planning to mount a guerrilla-style resistance or sow chaos in the event of a U.S. air or ground attack, according to sources with knowledge of the efforts and planning documents seen by Reuters.

The approach is a tacit admission of the South American country's shortage of personnel and equipment.

U.S. President Donald Trump has suggested the possibility of ground operations in Venezuela, saying "the land is going to be next" following multiple strikes on alleged drug-trafficking vessels in the Caribbean and a large U.S. military build-up in the region. He later denied he was considering strikes inside Venezuela.

Venezuelan President Nicolas Maduro, in power since 2013, says Trump is seeking to oust him and that Venezuelan citizens and the military will resist any such attempt.

The U.S. military dwarfs Venezuela's, which is debilitated by a lack of training, low wages and deteriorating equipment, six sources familiar with Venezuela's military capabilities said.

Some unit commanders have even been forced to negotiate with local food producers to feed their troops because government supplies fall short, two sources with knowledge of state security forces told Reuters.

That reality has led Maduro's government to bet on two potential strategies - including a guerrilla-style response referenced publicly, though without details, by high-ranking officials, and another which officials have not acknowledged.

CREATING ANARCHY ON STREETS

The guerrilla-style defense, which the government has termed "prolonged resistance" and mentioned in broadcasts on state television, would involve small military units at more than 280 locations carrying out acts



of sabotage and other guerrilla tactics, according to the sources and several years old planning documents for the tactic seen by Reuters.

The second strategy, called "anarchization," would use the intelligence services and armed ruling-party supporters to create disorder on the streets of capital Caracas and make Venezuela ungovernable for foreign forces, said one source with knowledge of defense efforts and another source close to the opposition.

It was unclear when the government might deploy each of the tactics, which sources said are complementary, in case of U.S. attack.

Any resistance strategy faces long odds of success, the sources acknowledged.

"We wouldn't last two hours in a conventional war," said a source close to the government.

Another source with knowledge of defense

and security inside Venezuela said that the country was not "prepared or professionalized for a conflict," despite government assertions to the contrary. "We're not ready to face one of the world's most powerful and well-trained armies," the source said.

The communications ministry, which handles media inquiries on behalf of the Venezuelan government, did not respond to

Government officials publicly have been dismissive of a U.S. military threat, though they have called for peace. "They think that with a bombing they'll end everything. Here in this country?" scoffed Interior Minister Diosdado Cabello on state television in early November, while Maduro has repeatedly praised the "soldiers of the homeland" as heirs of independence hero Simon Bolivar.

"The aggression will be responded to with national unity," Defense Minister Vladimir Padrino said on Tuesday, amid renewed military exercises around the country. "We are ready here, we don't want war."

SOLDIER SALARIES ARE LOW

Maduro has enjoyed strong military loyalty by following the strategy of his predecessor Hugo Chavez, who placed officers in government roles as ministers or heads of state-run companies to ensure allegiance.

Military leadership backed Maduro's victory in the 2024 election, despite evidence, backed by many international observers, that the opposition candidate had resound-

Venezuelan troops, however, have to deal with poor working conditions and there could be desertions in the event of an attack, the sources said.

Rank-and-file soldiers earn roughly \$100 a month in local currency - far short of the estimated \$500 monthly cost of a basic food basket, according to April data from the Venezuelan Teachers Federation's Center for Documentation and Social Analysis.

In recent years, their primary experience has been confronting unarmed civilians during street protests, the source close to the opposition said.

Maduro has said there are 8 million civilians training in militias to defend Venezuela, and some civilians have told Reuters in recent months that they are ready and willing to die to defend their homeland against a foreign force.

But a source with defense and security knowledge estimated that in an anarchization scenario, just 5,000 to 7,000 people would participate, including intelligence personnel, armed ruling-party supporters and militia members.

Meanwhile, there are some 60,000 members of the Army and National Guard that the government would deploy for its guerrilla-style "war of resistance," the source said.

US Senate passes bill to end government shutdown, sends to House

THE U.S. Senate on Monday approved a compromise that would end the longest government shutdown in U.S. history, breaking a weeks-long stalemate that has disrupted food benefits for millions, left hundreds of thousands of federal workers unpaid and snarled air traffic.

The 60-40 vote passed with the support of nearly all of the chamber's Republicans and eight Democrats, who unsuccessfully sought to tie government funding to health subsidies that are due to expire at the end of the year. While the agreement sets up a December vote on those subsidies, which benefit 24 million Americans, it does not guarantee they will continue.

The deal would restore funding for federal agencies that lawmakers allowed to expire on October 1 and would stall President Donald Trump's campaign to downsize the federal workforce, preventing any layoffs until

It next heads to the Republican-controlled House of Representatives, where Speaker Mike Johnson has said he would like to pass it as soon as Wednesday and send it on to Trump to sign into law. Trump has called the deal to reopen the government "very good."

The deal would extend funding through January 30, leaving the federal government for now on a path to keep adding about \$1.8 trillion a year to its \$38 trillion in debt.

Coming a week after Democrats won

high-profile elections in New Jersey, Virginia and elected a democratic socialist as the next mayor of New York City, the deal has provoked anger among many Democrats who note there is no guarantee that the Republican-controlled Senate or House would agree to extend the health insurance subsidies.

"We wish we could do more," said Senator Dick Durbin of Illinois, the chamber's No. 2

Democrat. "The government shutting down seemed to be an opportunity to lead us to better policy. It didn't work."

A late October Reuters/Ipsos poll found that 50% of Americans blamed Republicans for the shutdown, while 43% blamed Dem-

U.S. stocks rose on Monday, buoyed by news of progress on a deal to reopen the government.

Trump has unilaterally cancelled billions of dollars in spending and trimmed federal payrolls by hundreds of thousands of workers, intruding on Congress's constitutional authority over fiscal matters. Those actions have violated past spending laws passed by Congress, and some Democrats have questioned why they would vote for any such spending deals going forward.



Before this, fans believed the "Woza" hitmaker had already responded to the cheating rumours through a video she posted online, where she spoke about choosing peace and not wanting to react to negativity. However, that clip was not a response to the allegations as many assumed. The video was from October, weeks before the cheating claims surfaced. In that earlier video, DJ Zinhle said she wanted to let things go and avoid public conflict. "I don't want to fight. I don't want conflict. I don't want to explain myself. I just want an easy life," she said.

Before Zinhle's recent TikTok video, both she and Mörda subtly responded to the allegations by sharing an Artificial Intelligence (AI) video on social media. The video showed Khawula singing along to DJ Zinhle's hit song "Sorry". The post was seen as their way of addressing the rumours without words. The DJ later apologised to her supporters, saying her first reaction to the situation shouldn't have been something

"I want to apologise to you. I don't take your support and love for granted, and I want to say thank you. You're the only people that deserve my attention," she said.

Lynn Forbes: 'I can't breathe' as AKA suspects arrive

LYNN Forbes is feeling heavy-hearted today as the two men accused of killing her award-winning rapper son, Kiernan "AKA" Forbes, have arrived in Durban, South Africa, to face murder charges.

The tragic shooting took place in February 2023, when AKA and his friend, Tebello "Tibz" Motsoane, were shot outside the Wish restaurant on Florida Road.

Brothers Siyabonga and Malusi Ndimande were arrested by the Eswatini Royal Police earlier this year and have now been brought back to South Africa to face the music.

Earlier today, police spokesperson Colonel Athlenda Mathe confirmed that a special Interpol team had left South Africa to retrieve the brothers. "I can confirm that a high-risk team has left South Africa ... Only upon arrival at King Shaka International Airport will our Interpol officers hand them over to the lead investigator in the case, who will then execute a J50 warrant of arrest," said Mathe.

The Ndimande brothers are facing 23 other charges in addition to AKA and Tibz's murder allegations.

The brothers will be taken to a police station for further processing and are expected to appear in court soon after.

For Lynn, this day is filled with mixed emotions. Responding to the news of the brothers' landing in South Africa, she posted

"I'm very ... excitement is probably not the right word, but I am pleased that they have arrived on this day. It's been a long time coming, but for me, I feel satisfied now that when the trial starts, all seven will be on tri-

"I hope all seven will be on trial together. In particular, the (Ndimande) brother that pulled the trigger.

"It has taken a long time, but for me, the investigating team, along with the NPA (National Prosecuting Authority), kept me abreast over the last two and a half years ... Today it is happening, so I am very pleased with that," said Tony.

Sho Madjozi: 'Let's embrace motherhood without shame'

AWARD-WINNING artist and cultural trailblazer Sho Madjozi, real name Maya Christinah Xichavo Wegerif, has sparked a national conversation following her heartfelt appearance on Nandi Madida's podcast, The Motherhood Net-

In the deeply personal interview, Sho Madjozi opens up about embracing motherhood by choice, making her one of the public figures bringing visibility to the growing community of women choosing to become mothers independently and intentionally.

Sho Madjozi describes herself as a "choice mom", a woman who becomes a mother not because of marriage, pressure, or circumstance, but purely out of love, readiness, and purpose. "A choice mom means I chose to be a mom. It wasn't because I was married or because of a relationship; it was because I truly wanted to become a mother.

"As women, we should be allowed to embrace motherhood on our terms, free from shame or societal expectation," she said. Desire to offer emotional safe-

Sho Madjozi shared that her decision was influenced by her desire to offer her child stability, softness, and emotional safety, something she says she learned to value deeply through her upbringing, shaped by movement and cultural tran-

"I wanted love that felt safe. I wanted to give my child the kind of grounding I didn't always have growing up," she

She also stressed the role of community, explaining that, like many African children, her baby is being raised by a circle of loving women and elders.

"I grew up in a village of women. My child is also being raised in a community. I'm not doing this alone; I'm doing it differently." While Sho Madjozi has historically been private about her personal life, she says motherhood has grounded her more than it has changed her.

"Motherhood hasn't slowed me down; it has centred me," she said, hinting at returning to music soon, but with new clarity, new grounding, and a new voice. (Sunday World)

What is leaky gut syndrome?

Leaky gut syndrome is a proposed condition caused by increased intestinal permeability.

The digestive system consists of many organs that collectively break down food, absorb nutrients and water, and remove waste products. Your intestinal lining acts as a barrier between your gut and bloodstream to prevent potentially harmful substances from entering your body.

Nutrient and water absorption mostly occurs in your intestines. Your intestines have tight junctions, or small gaps, that allow nutrients and water to pass into your bloodstream. How easily substances pass across the intestinal walls is known as intestinal permeability.

Certain health conditions cause these tight junctions to loosen, potentially allowing harmful substances like bacteria, toxins, and undigested food particles to enter your bloodstream.

Alternative health practitioners claim that leaky gut triggers widespread inflammation and stimulates an immune reaction, causing various health problems that are collectively known as leaky gut syndrome.

They believe leaky gut leads to various conditions, including autoimmune diseases, migraines, autism, food sensitivities, skin conditions, brain fog, and chronic fatigue.

Yet, there is little evidence to prove that leaky gut syndrome exists. As a result, mainstream physicians do not recognize it as a medical diagnosis.

Although increased intestinal permeability exists and occurs alongside many diseases, it's not clear if it's a symptom or underlying cause of chronic disease.


What causes leaky gut?

The exact cause of leaky gut is a mystery. However, increased intestinal permeability is well known and occurs alongside several chronic diseases, including celiac disease and type 1 diabetes.

Zonulin is a protein that regulates tight junctions. Research has shown that higher levels of this protein may loosen tight junctions and increase intestinal permeability.

Two factors are known to stimulate higher zonulin levels in certain individuals bacteria and gluten.

There is consistent evidence that gluten increases intestinal permeability in people with celiac disease.



The leaky gut diet plan:

aid the growth of beneficial gut bacteria. An unhealthy collection of gut bacteria has been linked to poor health outcomes, including chronic inflammation, cancers, heart disease, and type 2 diabetes.

- The following foods are great options for improving your digestive health:

SIGNIFICANT events in life tend to linger in your memory.

Some might spark happiness when you recall

Others might involve less pleasant

You might make a conscious effort to avoid thinking about these memories. Repressed memories, on the other hand, are those you unconsciously forget. These memories generally involve some kind of trauma or a deeply distressing event.

Maury Joseph, a clinical psychologist in Washington, D.C., explains that when your brain registers something too distressing, "it drops the memory into a 'nonconscious' zone, a realm of the mind you don't think

It sounds simple enough, but the concept of memory repression is a controversial one that experts have long debated.

Where did the idea come from?

The idea of memory repression dates back to Sigmund Freud in the late 1800s. He began developing the theory after his teacher, Dr. Joseph Breuer, told him about a patient, Anna O.

She experienced many unexplained symptoms. During treatment for these symptoms, she started remembering upsetting events from the past she previously had no memory of. After regaining these memories and talking about them, her symptoms began to improve.

Freud believed that memory repression served as a defense mechanism against traumatic events. Symptoms that couldn't be traced to a clear cause, he concluded, stemmed from repressed memories. You can't remember what happened, but you feel it in your body, anyway.

The concept of memory repression had a resurgence in popularity in the 1990s when an increasing number of adults started reporting memories of child abuse they hadn't been aware of previously.

Why is it controversial?

Some mental health professionals believe the brain can repress memories and offer therapy to help people recover hidden memories. Others agree repression could theoretically be possible, even though there's no concrete proof.

But the majority of practicing psychologists, researchers, and other experts in the field question the whole concept of repressed memories. Even Freud later discovered many of the things his clients "remembered" during psychoanalysis sessions weren't real memories.

Finally, there's the fact that we'll likely never know a whole lot about repressed memories because they're so hard to study and evaluate. To run an objective, high-quality study, you'd need to expose participants to trauma, which is unethical.

What is repressed memory therapy?


Despite the controversy surrounding repressed memories, some people offer repressed memory therapy. It's designed to access and recover repressed memories in an effort to relieve unexplained symptoms.

Practitioners often use hypnosis, guided imagery, or age regression techniques to help people access memories.

Some specific approaches include:

brainspotting

What's the deal with repressed memories?



- somatic transformation therapy
- primal therapy
- sensorimotor psychotherapy
- neurolinguistic programming
- internal family systems therapy

Scientific evidence generally doesn't support the effectiveness of these approaches.

Repressed memory therapy can also have some serious unintended consequences, namely false memories. These are memories created through suggestion and coaching.

They can have a negative impact on both the person experiencing them and anyone who might be implicated in them, such as a family member suspected of abuse based on a false memory.

What else might explain the phenomenon?

So, what's behind the countless reports of people forgetting major events, especially those that took place early in life? There are a few theories that might explain why this

Dissociation: People often cope with severe trauma by dissociating, or detaching from what's happening. This detachment can blur, alter, or block the memory of the

Some experts believe children who experience abuse or other trauma may not be able to create or access memories in the usual way. They have the memories of the event, but they may not recall them until they're older and better equipped to deal with the distress.

Denial: When you deny an event, Joseph says, it may never register in your

consciousness.

"Denial might occur when something is so traumatic and upsetting your mind doesn't let a picture form," he adds.

Maury offers the example of a child who witnesses domestic violence between their parents. They might temporarily check out mentally. As a result, they might not have a "picture" of what happened in their memory. Still, they get tense when watching a fight scene in a movie.

Forgetting: You may not remember an event until something later in life triggers your recollection.

But it's not really possible to know whether your brain unconsciously repressed the memory or you consciously buried it, or simply forgot.

New information

Joseph suggests old memories you're already aware of might take on different meanings and make more sense later in life. These new meanings may emerge during therapy or simply as you get older and gain

When you realize the significance of a memory you didn't previously consider traumatic, you might then become extremely distressed by it.

What if I feel like I have some kind of repressed memory?

Both memory and trauma are complicated topics that researchers are still working to understand. Leading experts in both fields continue to explore links between the two.

If you feel like you're having trouble recalling an early memory or don't remember a traumatic event people have

told you about, consider reaching out to a licensed therapist.

American The **Psychological** Association (APA) recommends looking for one trained to treat specific symptoms, such as:

- anxiety
- somatic (physical) symptoms
- depression

A good therapist will help you explore memories and feelings without leading you in any particular direction.

Keep in mind a therapist should never coach you through memory recollection. They shouldn't suggest you experienced abuse or guide you to "repressed" memories based on their beliefs about what happened.

They should also be unbiased. An ethical therapist won't immediately suggest your symptoms are the result of abuse, but they also won't completely write off the possibility without taking time to consider it in therapy. (**Healthline**)

Cristiano Ronaldo says 2026 World Cup 'definitely' his last

PORTUGUESE superstar Cristiano Ronaldo on Tuesday said next year's World Cup would be his last as he winds down one of the all-time great careers.

The 40-year-old forward, with more than 950 club and international goals, also said he would retire from football in "one or two years".

"Definitely, yes," he told a Saudi forum by video link, when asked if 2026 would be his World Cup swansong. "I'm gonna be 41 years old and I think it will be the moment."

Ronaldo, who began a lucrative stint at Saudi Arabia's Al Nassr in 2023, also elaborated on comments last week when he said he would retire "soon".

"Let's be honest, when I mean soon, it's probably one or two years I'll still be at the game," he said.

The five-time Ballon d'Or winner is targeting a sixth World Cup next year. He came closest to lifting the trophy in 2006, when Portugal lost

Portugal have yet to qualify for the 2026 tournament in the USA, Canada and Mexico, but can secure their spot if they beat Ireland on Thursday.

Ronaldo joined Al Nassr after leaving Manchester United for a second time in late 2022, a move that

heralded a influx of late-career stars to the oil-rich kingdom.

Saudi Arabia, which is spending big on sports and entertainment as part of its economic diversification plan, was named as host of the 2034 World Cup last December.

Perez targets podium return with new team Cadillac

RACE winner Sergio Perez reckons he can get back onto the Formula One podium with Cadillac, even if the sport's newest team will likely also be the slowest when they debut next season.

The Mexican and his Finnish teammate Valtteri Bottas are not short of experience, with a combined 527 starts and 16 grand prix victories, but at 36 both will be returning from an involuntary year on the sidelines.

Perez, dropped as Max Verstappen's Red Bull teammate at the end of 2023, has 39 career podiums and sees no reason why he cannot take his tally to 40 before he finally calls it a day.

"Yes, I think so. I really believe it," the former Sauber, McLaren and Force India/Racing Point driver told Reuters from Cadillac's Silverstone factory, where he was having a seat-fit for the team's 2026 car.

"I think I've been on the podium with all the teams I drove for, except McLaren," he added

"I think we're going to start at the back, progressively move forward. But ultimately, in the near future, that (the podium) is a target.

"It doesn't matter who gets there, as long as it's Cadillac."

TEST RUN IN 2023 FER-RARI

Backed by General Motors, the US-owned team are well-funded and staffed, recruiting several familiar names from other established teams and with more than 400 people on board already and a target of about 600.

Preparations are on schedule and Perez will drive a 2023 Ferrari at Imola this month to shake off some cobwebs and give the team a chance to gel, even if many of the faces are already familiar.

"I'm curious, you know, to find out how many laps my neck will do before it gets destroyed," said the Mexican, already flexing his muscles on the video call.

"But it's great, you know. It's a great test and a great way to finish the year before getting back in the car next year."

The 2026 Cadillac will have a Ferrari engine, but has yet to be built, with testing scheduled for the end of January in Barcelona.

Instead, Perez will get behind the wheel of one of Ferrari's red cars for the first time since he was in the Italian team's young driver academy and raced for Sauber in 2011.

"It's basically just a time for us to be able to get together with the engineers, mechanics, start working all together, you know, start talking the same language," he explained.

Perez said he was already enjoying the atmosphere and was excited to be part of the first all-new team on the grid since Haas a decade ago.

"Normally the new teams that have come in the past, they've always been struggling financially," he said. "And this is a team that is coming for real and it's coming to do things in the best way and to win.

"Cadillac are here for big things, and it doesn't really matter for me where we start; it's how quickly we are able to develop and how quickly we are able to move forward. How the team is working weekend after weekend."

Perez said when he was announced as a Cadillac driver in August, that he had nothing to prove and just wanted to enjoy racing again.

His legion of fans are excited already; plenty of Cadillac shirts and flags were evident at the races in Texas and Mexico City last month.

"Yeah, they've got more kit than we have at the moment," joked the Mexican.

Mitchell hits back at Bafana coach Broos over Links comments

BAFANA Bafana coach Hugo Broos has come under fire from Gift Links' representative, Paul Mitchell, after publicly stating that the Danish-based winger is "not at the level" required for the national team.

Broos' comments have caused a stir both in South Africa and Denmark, where Links is a key player for Aarhus GF (AGF).

The 27-year-old has been one of AGF's standout performers this season, helping the club climb to third place in the Danish Superliga after 15 matches.

When asked why Links continues to be overlooked for national selection, Broos told the media: "I don't think Links has the level that we need at Bafana."

That statement didn't sit well with Mitchell, the Managing Director of Siyavuma Sports Group Africa, who represents the former Cape Town City midfielder.

Speaking on Radio 2000 with Thabiso Mosia, Mitchell expressed disappointment at the national coach's choice of words.

"Normally, I wouldn't comment on this sort of thing because it's the coach's prerogative to pick who he feels fit for his squad, but I've been inundated by the Danish media on this story because it's blown up in Denmark," said Mitchell.

"From Gift's side, he's upset and rightfully so. The comments were uncalled for. Gift has never gone public or complained about not being in the squad. He's been in Denmark for six years now, he moved there for €850,000 (around R16.8 million) and he's turned down very good offers to move on. We feel it's about

Links has been one of AGF's most consistent performers, contributing two goals and three assists in 15 league games. He has also helped his side reach the quarter-finals of the Danish Cup (Oddset Pokalen) with a goal and an assist in two matches.

According to Mitchell, Broos' comments have sparked amusement in Denmark, where Links is highly regarded.

"The Danish media are actually laughing because Hugo Broos has come out to say that Gift doesn't have the level to play for Bafana but he's quoted as being the left wingback in the Danish Super League,"

"If we're saying the Danish Super League is lower level than the South African PSL then we've got a pro-

African PSL then we've got a problem. Gift is not somebody who will be knocking on the door asking why [not being selected] and neither are we as representatives because his performances speak for themselves.

"He has been in the team of the week five times this season and he was in the team of the season in the Danish Super League last season and I think he was the only foreign player on it and his performances have been outstanding."

Sinner dominates injury-hit Auger-Aliassime in ATP Finals opener

ITALY'S Jannik Sinner got his title defence off to a solid start with a dominant straight-sets win over ailing Canadian Felix Auger-Aliassime at the ATP Finals on Monday in Turin.

Nine days after their duel in the final of the Paris Masters, Sinner was again the strongest, winning 7-5, 6-1.

But fellow Italian Lorenzo Musetti was earlier outclassed 6-3, 6-4 by American Taylor Fritz.

After a tight first set, Sinner swept aside Auger-Aliassime, who had been hampered by a left calf injury by breaking serve to rush to a 3-0 lead.

He broke him a second time to close out the match with an ace after one hour 41 minutes.

"Obviously winning the first match is very important in this competition and this format," said 24-year-old Sinner.

"It was a very tough match until 6-5. I had some chances to break. He served very well, only once I missed a return, but it can happen. He played some very aggressive tennis, so I'm happy to overcome a very tough test today.

"I hope it's nothing too serious," Sinner added of his rival. "I wish him obviously a very speedy recovery and hopefully he is back to 100 per cent physically."

Sinner notched his 27th consecutive victory on his preferred indoor hard courts surface and took the lead in the Bjorn Borg Group, which will also see the world number

two face Germany's Alexander Zverev and American Ben Shelton.

The native of South Tyrol, the German-speaking region of northeastern Italy, won the 2024 edition of the tournament which brings together the eight best players of the year, by stringing together five wins without dropping a single set.

The 2025 edition could allow him to finish

the season as world number one, currently held by his great Spanish rival Carlos Alcaraz, who has beaten him four times this year.

'FIRED UP' FRITZ

Earlier, Fritz got his bid for a first ATP Finals crown off to the best possible start with a comprehensive win over Musetti.

The 28-year-old American, who lost to Sinner in last year's final, was out of the

blocks quickly in the Jimmy Connors group match, taking an early break and holding on to pocket the first set.

The crowd did their best to lift a visibly fatigued Musetti, who was a late addition to the line-up.

He only qualified for the Finals on Satur-

day after Novak Djokovic pulled out with injury, shortly after beating the Italian in the final of the Athens event.

Winning 84 per cent of his first serves and

giving away just four break-point chances, none of which were taken, Fritz continued to control the match.

The American broke to go 3-1 up and served cleanly all the way to the line.

"I am really happy. I thought I did a lot of things really well," Fritz said.

"I did a great job early on in the match to serve my way out of trouble and save some break points. The whole second set I played well and had a lot of chances to break that I didn't get.

"I am really happy I was able to serve it out there and it didn't come back to ruin it."

Fritz qualified sixth for the Finals and after finishing runner-up last year is gearing up for another tilt at the title.

"Every time I come here, I like the conditions and it is very easy to get motivated and fired up," said Fritz.

"You can lock in, it is the last tournament of the year and it is the ATP Finals, it's a big deal."


He left the country on November 10,2025, for a one-week course under the auspices of World Athletics.
