developmental screening.

"When we started our dream to form this organisation over 10 years ago, it was difficult as the country didn't understand it, and it was linked with witchcraft. We had a lot of explaining to do. So, we thank companies like SEL who supported the course with passion and understanding.

"We can't forget to express our sincere gratitude to our Patron Inkhosikati LaMatsebula as she brings exceptional leadership," he said.

Hlatshwayo then revealed that due to their growth over the years, the country was set to benefit holistically through a centre specialising in Autism.

"We're building an E75 million worth Autism Centre at Luhokohla in Manzini. Construction phase 1 is already underway, and that's worth E5 million as we have decided to do it in phases. It's a big project," explained Hlatshwayo.

He said the centre will have trained experts, hostel ans education, sporting and specialised clinic facilities to allow life to continue and get better for those with the condition, which is not an illnesses and can be outgrown if discovered at a tender age.

Autism, or Autism Spectrum Disorder (ASD), is a lifelong neurodevelopmental condition affecting social interaction, communication, learning, and behaviour, characterised by varied strengths and challenges, intense interests, sensory differences, and repetitive actions, with its spectrum nature meaning unique experiences for each individual, though often identified in early childhood through developmental screening.

Ministry of Education, Cancer Network in E0.7mln SEL windfall

IT was empowerment unlimited with Swazi Empowerment Limited (SEL) on Wednesday.

Just when the festive spirit is buzzing around, SEL dished out the goodies in the form of three donations to the value of E700 000 (E0.7 million).

The company donated E400 000 to their annual benefactor, the Ministry of Education and Training, E200 000 to Eswatini Autism and E100 000 to Eswatini Cancer Network, formerly Breast Cancer Network. The namechange was officially launched on December 8, last week.

The SEL gesture, as announced by SEL's Corporate Social Responsibility (CSR) Chairman Shaka Ndlangamandla in a press conference at their PriceWaterHouse Coopers (PWC) offices inside the capital city, totals

"SEL is an investment company with its major investment on Swazi MTN. As part of its corporate social responsibility, SEL has a policy to donate 0.005 per cent of dividends

received to needy and most vulnerable citizens at Eswatini, with emphasis on the youth, disabled, elders and health.

"Every year, SEL identifies organisations with people who are most vulnerable and, as part of its corporate social responsibility, make donations to selected organisations based on the SEL CSR budget available for the year," said Ndlangamandla in his opening remarks.

He said he was happy to announce that for the fiscal year 2025/2026, the following organisations were identified for donation:

1. Autism Eswatini – E100,000,

2. The Breast and Cervical Cancer Network, now Eswatini Cancer Network – E200,000, and

3. Ministry of Education and Training – E400,000.

Ndlangamandla said this was 50 per cent of their dividends, also explaining that the Ministry of Education was like a partner now as they benefitted for a second consecutive time on the premise of the scope of their responsibilities with children.

"It's heart warming that we have again donated to the Cancer Network and then the Eswatini Autism because this also touches on the Ministry of Education which deals with autism and cancer among learners and teachers," he said. He encouraged all the beneficiaries to go out and serve Eswatini as their responsibility was huge. However, Ndlangamandla said they also had challenges

often times when it comes to selecting organisations deserving to be donated for.

"There is no database for the needy and most vulnerable people or cases in the country. There are too many instances of most vulnerable people in the country," he said.

Ndlangamandla observed that this resulted in organisations using their CSR budgets based on limited knowledge of the needs of the country or on a first come, first served basis. "Given that organisations do not know which organisation has donated to who, there is sometimes duplication in donations to

some organisations while other most needy people or organisations are left out


"Many organisations in the country have corporate social responsibility (CSR) budgets, but the budgets are not coordinated. There is no guidance on how the organisations can use their CSR budgets," he claimed.

He said his wish was that there could be a national central information or database about all vulnerable people and their needs for the corporates wth CSR budgets to refer.

He also made an example of the MTN 21 Days of Y'ello Care initiative, saying having a Three Months Care initiative would also help donate to the right organisations and reach as many as possible than teo big entities all donating for the same organisation.

Meanwhile, the Ministry of Education's contribution is half of the E800 000 it needs to help two schools with ablutions for pupils and teachers. The Ministry Under Secretary (US) Lungelo Nhlengetfwa represented Minister Owen Nxumalo in the check presentation

UNESWA Alumni Gala Dinner injects E0.5 million for the institution

THE University of Eswatini (UNES-WA) raised E500,000 towards its Endowment Fund during the 3rd Annual Alumni Gala Dinner held on December 4, 2025, at the Ligcabho LemaSwati Sports Emporium.

The gala, hosted by the UNESWA Endowment Fund under the theme 'Masquerade Ball, A Night in Disguise' brought together more than 200 alumni, senior government officials, business executives, and development partners in support of the university's long-term financial sustainability.

The funds raised contribute to the Endowment Fund's E100 million target set over a three-year period, aimed at reducing the institution's reliance on government subventions and positioning UNESWA for financial independence.

Speaking during the event, UNESWA Vice Chancellor Professor Justice Thwala emphasised the importance of diversified funding in expanding access to higher education.

He said the Endowment Fund was central

to ensuring that deserving liSwati students are not excluded from tertiary education due to financial constraints.

The Minister for Education and Training Owen Nxumalo endorsed the initiative, describing diversified funding models as global best practice for public universities facing increasing enrolment pressures and constrained public resources.

A key feature of the gala was the strong participation of corporate and public institutions, highlighting growing collaboration between the university and the business sector.

Partners included the Eswatini Investment Promotion Authority (EIPA), Eswatini Revenue Service (ERS), Eswatini Civil Aviation Authority (ESWACAA), Liberty, ESCCOM, ESRIC, SMVAF, Eswatini Bank, Kellogg Tolaram Eswatini, and the Conciliation, Mediation and Arbitration Commission (CMAC), among others.

UNESWA Endowment Fund Chief Executive Officer Vuli Simelane said the level of corporate support demonstrated confidence in the university's transformation agenda and its role in producing graduates aligned with national labour market needs.

He said the Endowment Fund is pursuing a hybrid funding model that blends alum-

ni contributions, corporate partnerships, events-based fundraising, and long-term investments to ensure sustainable income streams for the institution.

Beyond fundraising, the gala served as a platform to promote the Endowment Fund's Business-to-Business (B2B) Partner Programme, which offers structured engagement between UNESWA and the private sector.

"The programme provides participating companies with opportunities including talent recruitment from the alumni network, co-branded research and development initiatives, and branding at high-profile university events," said Simelane.

Simelane further said participating companies also benefit from tax incentives, enhanced corporate social investment visibility, and direct contribution to national human capital development.

Meanwhile Board Chairperson Dr Nozizwe Mulela said the Endowment Fund was established to reposition UNESWA as a financially resilient institution capable of supporting national development priorities.

She said partnerships between universities and industry were critical in responding to changing economic demands and ensuring graduates possess relevant, market-ready

skills. The gala took place against the backdrop of His Majesty King Mswati III's declaration of 2025 as the 'Year of Transformation to the Promised Land' a theme speakers said resonated strongly with UNESWA's renewal efforts.

Organisers indicated that additional fundraising activities, including a sports tournament and a music festival, are planned to further grow the Endowment Fund and expand corporate participation.

Educators declare readiness for Competency-Based Education rollout

SECONDARY school head teachers across Eswatini have declared their readiness for the implementation of the Competency-Based Education (CBE) and Four-Year Programme, following the completion of a series of national infusion workshops.

The workshops, coordinated by the Ministry of Education and Training in collaboration with the National Curriculum Centre and In-Service Education and Training, were designed to prepare school leadership for the transition to CBE in Form 1 starting next year.

Secondary school head teachers from the Lubombo Region are currently concluding their competency infusion workshop at the George Hotel in Manzini, which began on Tuesday and ends Thursday.

The Lubombo workshop marks one of the final stages in a national rollout that has covered all regions. Head teachers from the Manzini Region were the first to attend the workshops, followed by Hhohho Region, where participants took part in a three-day residential programme.

Shiselweni Region head teachers attended their workshop from December 7-9, while

Lubombo concludes the process.

According to the Ministry of Education and Training, the workshops were aimed at strengthening leadership capacity, aligning school management systems with the new curriculum, and ensuring a smooth transition from content-based to competency-based learning.

Participants engaged with curriculum specialists, education inspectors, and training officials on key components of the CBE framework, including learner-centred pedagogy, continuous assessment, skills development, and classroom-based competencies.

Head teachers who attended the sessions said the workshops had addressed long-standing concerns about implementation readiness, assessment methods, and institutional support.

"We are now clear on what is expected of schools and leadership under the CBE system. The training has given us confidence to guide our teachers and learners through this transition," said one Lubombo Region head

Another participant said the workshops helped demystify the Four-Year Programme structure and clarified how schools should

support learners' academic and practical skill development.

The Minister for Education and Training Owen Nxumalo said the infusion workshops were deliberately targeted at school leadership as a foundation for wider institutional readiness.

"The next phase will involve deputy head teachers, heads of department, and Form 1 (Grade 8) teachers, who will undergo similar training ahead of the 2026 academic year. The consistent national rollout ensured

alignment across regions and reduced the risk of uneven implementation," said Nxumalo

The Ministry noted that lessons from pilot schools and earlier phases of curriculum reform were incorporated into the workshops, enabling head teachers to anticipate challenges and plan mitigation strategies at school level.

Participants were also briefed on monitoring and reporting mechanisms that will be used to track implementation progress once the CBE programme is introduced.

The Ministry of Education and Training said the completion of the head teachers' workshops represents a major milestone in national preparedness for curriculum re-

With school leadership trained and aligned, the Ministry said the country is now well positioned to proceed with educator-level training and classroom implementation.

Worth noting, the CBE reform is intended to equip learners with practical competencies, critical thinking skills, and adaptability, aligning education outcomes with national development and labour market needs.

National Commissioner of Police, Vusie

Five arrested in Simunye over illegal guns, wildlife and dagga



ON the morning of December 16, 2025, Simunye Police carried out an intelligence-led operation that resulted in the arrest and charging of five individuals for illegal possession of firearms, protected wildlife, and dagga.

The arrests took place around 5 a.m. at the suspects' homes in the Malindza and Sikhuphe areas.

A 40-year-old man from Malindza was apprehended for possessing a single-barreled shotgun and one live round of 12-bore ammunition without the required license or permit. Additionally, he was found with a spotted Dikkop bird (Umkhokhoni), a species protected under the Game Act, further compounding the charges against him.

Another suspect, a 60-year-old man also from Malindza, was arrested for illegal possession of a Baikal shotgun without the necessary licensing while in the Sikhuphe area. The third individual, a 63-year-old man from Sikhuphe Village, faced charges for possess-



ing a bush buck trophy consisting of a skull and horns without a permit, violating wildlife protection laws.

The operation also led to the arrest of a 41-year-old man and a 39-year-old woman, both from Sikhuphe village, who were found in possession of 13 kilograms of dagga without a license or permit. This seizure highlights ongoing efforts to combat illegal drug possession and trafficking within the community. The Royal Eswatini Police Service reaffirmed its commitment to suppressing crime and ensuring that individuals found in violation of the law face appropriate legal consequences. This operation underscores the effectiveness of intelligence-led policing in protecting community safety and preserv-

The arrests and charges serve as a strong message that illegal possession of firearms, protected wildlife, and controlled substances will not be tolerated, and law enforcement agencies remain vigilant in their efforts to uphold the law and protect citizens.

Man arrested for sexual assault of step-grandchild

weni has been arrested and charged by Mbabane police in connection with the sexual assault of his three-year-old step-grandchild, a case that has shaken the local community and highlighted ongoing concerns about child protection.

The disturbing incident came to light on 21 November 2025 at approximately 9:00 a.m., when the child's grandmother left the young girl in the care of the suspect while attending a funeral.

During this time, the suspect reportedly shared a bed with the child. The following

A 65-year-old man from Luhlendl- morning, the girl confided in one of her older cousins, revealing that she had been sex

> Upon learning of the abuse, the child's father was immediately contacted, and the girl was promptly taken to a hospital for a medical examination to document and assess the extent of the assault. Law enforcement was also notified and responded swiftly to the situation.

> The suspect was arrested on December 12, 2025, and has since appeared before the Mbabane Magistrates' Court. He was remanded in custody and is scheduled to remain detained until January 6, 2026, as investigations continue.

The Royal Eswatini Police Service (REPS) has publicly commended the Mbabane Directorate for Crime Scene (DCS) officers for their unwavering dedication and relentless efforts in combating sexual abuse and exploitation of children. Their work is instrumental in ensuring that perpetrators are brought to justice, providing some measure of hope and safety for vulnerable children.

Sexual abuse of children by relatives and trusted individuals remains a troubling and pervasive issue in Eswatini. The police service has emphasised its commitment to forging a safer and better future for emaSwati children by intensifying efforts to prevent such crimes and support victims.

N a powerful demonstration of corporate social responsiveness (CSR), the staff of the Eswatini National Provident Fund (ENPF), widely known as Lidlelantfongeni, this week visited Mawelawela Wom-



en's Correctional Centre, in Luyengo, to deliver a significant donation of hygiene packages, clothing, and baby supplies.

The value of the donation was over E60, 000.

The donation of sanitary hygiene packs, clothing and baby supplies at Mawelawela was made possible by Hamba Vangeli, a regional NGO led by Pastor Trusty Simelane that focuses on correctional facilities ministry and rehabilitation, which approached Lidlelantfongeni for support. This is a partnership Lidlelantfongeni has proudly maintained over the years to help Hamba Vangeli, and other NGOs, provide care and dignity to inmates."

The initiative, led by the ENPF CEO Futhi Tembe and employees of the Fund, sought to address the immediate humanitarian needs of incarcerated women while advocating for a shift in how society views those behind bars. It was also a practical gesture that throws a spotlight on gaps in menstrual care and the importance of mother-child programmes behind bars.

"Hamba Vangeli has for many years taken ministry and practical support into correctional settings across the region, including Mawelawela Correctional Facility," said Pastor Trusty Simelane, Director of Hamba Vangeli.

"We approached Lidlelantfongeni because our work in correctional facilities in Eswatini and neighbouring countries such as Mozambique, South Africa and Malawi, is about restoring dignity as much as meeting needs. The sanitary hygiene packs, clothing and baby supplies we distribute protect health and preserve self-respect. Alongside those items we provide counselling, life-skills training and vocational support to tackle the root causes of offending.

"These include unemployment, lack of education, trauma and fractured family structures. When people are treated as human beings with potential, not simply as inmates, we reduce the cycle of reoffending and give them a real chance to rebuild their lives."

Pastor Simelane thanked CEO Tembe and all Lidle-lantfongeni employees.

"Their long-standing support is a powerful example of corporate compassion in action. Over the years Lidlelantfongeni has lived its values; agility, excellence, integrity and strong relationships, by investing time, resources and care in people many others overlook. That kind of partnership strengthens reintegration, improves public safety and heals communities. I urge other companies to emulate Lidlelantfongeni: when staff lead by example and live their values, we all benefit."

In another matter, for many of the women resident at the correctional facility, the packages brought by the Lidlelantfongeni employees were more than toiletries; they were a reminder that someone outside the walls still remembered their dignity, and their children. "Lidlelantfongeni exists to safeguard futures. Sometimes that means meeting people where dignity is most fragile," said CEO Tembe.

She was represented by Human Resources Manager Muzi Mngometulu, who delivered a poignant message on the importance of compassion and second chances. "By standing with women and newborns at Mawelawela, Lidlelantfongeni's employees continue to prove that nation-building begins with dignity. Lidlelantfongeni is not only a custodian of savings, it is a custodian of dignity."

This charitable initiative underscores the organisation's commitment to social responsiveness and uplifting the most vulnerable members of the community. Team Lidlelantfongeni; from support and facilities personnel to frontline member services officers, compliance and benefits administrators, finance professionals, communications practitioners and senior management, dedicated the day a full week to assembling dignity and infant care packs for the women inmates at Mawelawela Correctional Ser-

vices. The initiative saw the team working together as they prepared kits containing menstrual products, soap, toothbrushes, underwear, diapers, baby formula samples, baby blankets and diapers.

A separate allocation of infant supplies was specifically set aside for mothers enrolled in the correctional service's mother-and-child or nursery programme, recognising the unique needs of infants born or raised within custodial settings.

Presented as a staff-driven act of solidarity rather than a corporate exercise, the donation was accompanied by a commitment from ENPF employees to sustained engagement. This includes financial literacy mentorship, basic retirement and savings awareness, and employment readiness sessions designed to support reintegration and economic dignity upon release. "For women in custody, basic hygiene products are not luxuries, they are essential to health, self-respect and dignity," said CEO Tembe.

"Menstrual access in custodial settings remains patchy in many respects, as local charities and advocacy groups have repeatedly documented shortages and obstacles for women needing hygiene packs. For mothers who give birth while serving sentences, access to baby supplies and breastfeeding support is crucial to early bonding and infant wellbeing."

CEO Tembe said individuals within correctional facilities must never be treated as outcasts, but recognised as members of society undergoing correction, rehabilitation and renewal. "Correctional centres exist to reform, not to erase human dignity," she said.

"When people have served their time and return to their communities, they should be welcomed, ap-



preciated, supported and not stigmatised. Reintegration is a shared responsibility. By offering acceptance, opportunity and care, we enable former inmates to rebuild their lives, contribute positively to society and live healthy, purposeful futures."

Meanwhile, CEO Tembe praised Commissioner General LaMakhosini Phindile Dlamini, National Commissioner of His Majesty's Correctional Services, and her entire team for embracing future-focused correctional practices that go beyond traditional custodial functions to include meaningful skills training and rehabilitation for inmates.

"Under Commissioner General Dlamini's leadership, our correctional centres are no longer defined by confinement alone," said CEO Tembe.

"They are spaces of transformation, where individuals are equipped with practical vocational skills, access to education and personal development opportunities that prepare them to return to society as productive, self-reliant citizens. That is the true meaning of correction." She added: "When we invest in rehabilitation rather than punishment, we reduce reoffending, strengthen community safety and uphold human dignity. This approach supports successful social reintegration and ultimately makes our correctional system more efficient, humane and forward-looking than outdated prison-only models."

VOICES FROM INSIDE

The heartfelt impact of the donation was immediately evident among the mothers at Mawelawela, who expressed deep gratitude for the support from

Lidlelantfongeni and Hamba Vangeli.

Thandiwe* said no words could capture her gratitude. "From the bottom of my heart, I thank Lidlelant-fongeni and Hamba Vangeli for thinking of us and our children. These hygiene packs, clothes and baby supplies are more than gifts; they are a reminder that God has not forgotten us," she said.

"Watching my child grow up in prison is heartbreaking, but today I feel hope. I pray to live a clean life, to repent for my past mistakes, and to be accepted by society when I return. May God bless everyone who has supported us."

Nomsa* added that she was grateful to Lidlelantfongeni and Pastor Trusty Simelane with Hamba Vangeli for this blessing.

"The children need love, care and support even behind these walls, and today I see God's mercy through this donation. Growing up in prison is not easy; every small gift helps my child feel human and loved," she said.

"I want to turn my life around, follow the Word of God, and show that I can live righteously. I ask society to forgive us and welcome us back, so we can raise our children in dignity."

Phindile* echoed the sentiment. "Thank you to Lidlelantfongeni and Hamba Vangeli for this kind act of giving. It is hard for children to grow up in prison, but these supplies bring comfort and remind us of God's love. I am determined to repent, walk in His ways, and be a better mother and citizen. We ask for society's forgiveness and acceptance, and pray that others see the importance of caring for those who have stumbled. God's Word guides us, and today His love is visible through your generosity."

One mother who had her newborn with her in the correctional nursery described the relief of having nappies and a warm blanket provided, as God sent from Lidlelantfongeni and Hamba Vangeli.

"When you do not have the basics, you feel smaller than your crime. This lets me hold my baby without worrying about tomorrow," she said.

A Lidlelantfongeni employee reflected afterwards.

"It is humbling. We thought we were donating goods; we left feeling like we'd been given a lesson in compassion," she said.

IMPACT AND BEST PRACTICE

Corporate institutions such as Lidlelantfongeni can maximise impact by pairing donations with sustained volunteer programmes, training for corrections staff, and partnerships with community organisations that provide long-term wraparound services; mental health support, parenting classes, transitional housing and employment pathways for women upon release.

When businesses bring staff, resources and expertise into these settings, they humanise incarcerated women and make rehabilitation pathways more visible. The boxes left behind that day were small in volume but large in meaning. For a few hours the visiting hall felt less institutional and more familiar. "We want to be part of our community's healing, not just its ledger," said General Manager of Corporate Services, Sindi Mango. "Our work is not simply about numbers or balance sheets; it is about people — their lives, their futures, and the hope we can nurture together. If dignity is the currency of citizenship, then everyone deserves to be paid, not just in wages or benefits, but in respect, opportunity and care."

She continued: "Through initiatives like our partnership with Hamba Vangeli, we are reminded that social responsibility extends beyond the office walls. By supporting correctional facilities, families and vulnerable communities, we invest in the very fabric of society. These actions reduce cycles of disadvantage, restore self-worth, and create a community where every individual has the chance to contribute positively. At Lidlelantfongeni, living our values; integrity, excellence, agility and strong relationships means turning principles into practice, and showing that business can lead with compassion as well as competence."


Diageo sells E African Breweries stake for \$2.3 billion

Eswatini spends E1.5 billion importing beans, maize annually

ESWATINI spends approximately E1.5 billion every year importing beans and maize.

This was revealed by National Maize Corporation (NMC) Chief Executive Officer Mavela Vilane during the signing of Memoranda of Understanding (MoUs) by the Eswatini Water and Agricultural Development Enterprise (EWADE) with various ministries and parastatals.

The signing ceremony took place on Tuesday, at the Hilton Garden Inn in Mbabane. Vilane said government was actively working to reduce the country's dependence on imports by strengthening domestic food production systems, particularly for staple crops such as maize and beans, which account for a significant share of the import bill.

He noted that Eswatini has historically relied on food imports to meet national demand due to factors including recurrent droughts, climate variability, limited irrigation infrastructure, and low productivity among smallholder farmers.

"These challenges have constrained local production, leaving the country vulnerable to regional supply disruptions and rising food pric-

es. The newly signed partnerships fall under the Smallholder Agricultural Productivity Enhancement and Marketing Project (SAPEMP), which aims to address these structural challenges by improving coordination among key institutions in the agriculture sector," said Vilane.

During the signing EWADE stated that the agreements are intended to strengthen collaboration between government entities and parastatals to support smallholder farmers with climate-smart agricultural practices, improved production inputs, irrigation development, and better access to markets.

"The project places emphasis on transforming farming from subsistence-based activity into a commercially viable sector capable of contributing meaningfully to national food security and economic growth. By supporting increased local production, the initiative seeks to reduce the need for imports and retain financial resources within the domestic economy," added Vilane.

Worth noting SAPEMP also aligns with broader national priorities of improving agricultural productivity, enhancing resilience to climate change, and promoting inclusive rural development.

EWADE indicated that implementation of the partnerships will focus on measurable outcomes, including increased crop yields, im-

proved market participation by smallholders, and reduced dependence on imported staple foods.

The initiative represents a coordinated effort to tackle longstanding production gaps and strengthen Eswatini's food system in a sustainable and economically viable manner.

AO review key challenges in the country's agrifood systems

THE Food and Agriculture Organization of the United Nations (FAO), in collaboration with the Government of the Kingdom of Eswatini, has convened a two-day consultative workshop to guide the development of Eswatini's Country Programming Framework (CPF) for the 2026–2030 period.

The Consultative Workshop for the Development of Eswatini's CPF 2026–2030 is currently underway at the George Hotel, bringing together government officials, private sector representatives, non-governmental organisations, farmer organisations, and development partners.

The workshop seeks to review key challenges within the country's agrifood systems and jointly define priority outcomes that will guide FAO's technical and strategic support over the next five years.

Discussions are also focusing on validating

FAO's added value in supporting national priorities, particularly in the areas of climate resilience, sustainable agricultural production, inclusive governance, and food security.

Participants are further reflecting on achievements recorded in 2025, drawing lessons learned, and using these insights to inform FAO's 2026 work plan and resource mobilisation strategy.

Expected outcomes of the consultative process include the development of a draft CPF methodology and theory of change, outlining clear outcomes, outputs, and indicators aligned with FAO's Four Betters framework, Better Production, Better Nutrition, Better Environment, and Better Life.

The workshop is also expected to produce a consolidated summary of stakeholder inputs to ensure the framework remains inclusive and responsive to national needs.

The CPF development process directly contributes to Eswatini's national priorities, in-

cluding poverty reduction, food security, increased agricultural productivity, sustainable natural resource management, and the empowerment of youth and women.

Officially opening the workshop, Principal Secretary Sydney Simelane reaffirmed FAO's continued alignment with Eswatini's National Development Plan.

He highlighted ongoing support in strengthening agricultural financing through the Agriculture Fund, building farmer resilience through climate-smart agriculture initiatives, and empowering youth through practical infrastructure such as shade nets and tunnels to support sustainable livelihoods.

The two-day engagement is expected to lay the foundation for a results-driven programming framework that aligns national development aspirations with global sustainable development goals.

Other members appointed to the Commission include Welcome Ncobizwe Nxumalo, who holds a Master of Laws in International Commercial Law and represents the Economic Association of Eswatini, Renata Ntshangase, holder of a Master of Business Administration representing the Ministry of Finance Noncedo Ncedile Dlamini, who holds a Bachelor of Commerce in Ac-

counting and Finance and represents the Eswatini Institute of Accountants and Mandla Ntshakala, a B-Tech Chemical Engineering graduate representing the Consumer Association of Eswatini, serving his second term.

Khumalo said the composition of the Competition Commission Board reflected Government's intention to ensure strong oversight and effective regulation of competition in the economy.

"This Board brings together strong competencies in economics, law, finance, consumer protection and regulatory oversight, which are central to the Commission's mandate," he said.

The Minister also announced the appointment of the Board of the Small Enterprises Development Company (SEDCO). The Board will be chaired by Dr Mandlenkhosi Dlamini, who holds a PhD in Curriculum and Instructional Design and is serving his second term. Beauty S. Mavuso, who has completed ACCA Part 1, was appointed as a Board member for a second term.

According to Khumalo, the SEDCO Board is expected to play a critical role in providing strategic direction to the organisation as it continues to support micro, small and medium enterprises across the country.

NAMIBIA'S diamond revenue has been surpassed by income from other minerals for the first time, the country's mining chamber said, with record gold prices and higher uranium output helping to offset the impact of weak gem prices.

Diamond income has traditionally boosted Namibia's state coffers, accounting for about 30% of export earnings. But the natural diamond industry has faced a price decline since mid-2022, largely owing to growing popularity of lab-grown gems.

Tax revenue from diamonds in the six months to September was down 79% year on year, after falling 49% in the previous financial year, according to the country's tax collector. "As a result, non-diamond mineral revenues have surpassed diamond revenues for the first time, reinforcing a structural shift towards a more diversified and resilient mining revenue base," the Chamber of Mines of Namibia said in its report for October, published late on Tuesday.

Tax revenue from other minerals, mainly uranium and gold, rose to 2.87 billion Namibian dollars (\$171.09 million) in the past financial year, almost double the original budget estimate. It is expected to rise further to N\$3.54 billion in the current financial year. Non-diamond royalty income also surpassed expectations, rising from a budgeted N\$747.8 million to N\$1.03 billion in the past financial year and maintaining that trend in the current year.

Namibia's two gold mines, Navachab and B2Gold's Otjikoto Mine, benefited from the bullion price rally that sent spot prices as high as \$4,380 an ounce in October, up about 60% from a year earlier.

Production of uranium, which is used in nuclear technologies, was up 22% year on year in the first 10 months of 2025. Namibia is the world's third-largest uranium producer behind Kazakhstan and Canada.

Diageo, the world's largest spirits group, has agreed to sell its 65% stake in East African Breweries to Japan's Asahi Holdings for \$2.3 billion, divesting its last direct African beer holding.

The deal values EABL, a Nairobi blue chip stock and one of East Africa's top five companies by market capitalisation, at around \$4.8 billion, Diageo and Asahi said on Wednesday.

EABL, which also operates in Tanzania and Uganda, is known for its Tusker beer brand, named after the elephant that gored one

of the brewery's founders on a hunting expedition in 1923.

Under the deal, EABL will retain Tusker and other local brands and sign new agreements with Diageo to produce Guinness and some spirits, while importing and distributing others.

London-listed Diageo, maker of Johnnie Walker whisky and Captain Morgan rum, is grappling with tariff hikes in its key U.S market, high debt levels and indications some younger consumers could be shifting away from drinking alcohol.

Amazon in talks for \$10 billion OpenAI investment

Amazon.com Inc (AMZN.O), opens new tab is in talks to invest in ChatGPT-maker OpenAI in a potential deal that could value the artificial intelligence firm at more than \$500 billion, a source familiar with the matter said on Tuesday.

Amazon may invest about \$10 billion in OpenAI, but the talks between the two firms are "very fluid", the source said on condition of anonymity because the matter is private.

The potential deal highlights the AI sector's relentless demand for computing power as companies race to build systems rivaling or surpassing human intelligence. Firms such as Nvidia(NVDA.O), opens new tab and Oracle (ORCL.N), opens new tab have signed AI deals worth several billion dollars with OpenAI this year. OpenAI also signed a \$38-billion-deal to buy cloud services from Amazon in November.

However, investors are on guard for signals that demand for AI is tailing off or that the massive spending is not paying off as anticipated.

The discussion between Amazon and OpenAI come at a time when the AI giant is laying the groundwork for an initial public offering that could value the company at up to \$1 trillion, Reuters reported in October.

The approach underlines OpenAI's ability to partner widely after moving on from its non-profit roots and settling its deal with Microsoft (MSFT.O), opens new tab, the source said.

The Microsoft deal makes OpenAI a public benefit corporation that is controlled by a non-profit with a stake in OpenAI's financial success, removing major constraints on the firm's ability to raise capital and secure computing resources.

Microsoft holds a 27% stake in OpenAI and has secured an exclusive right to sell OpenAI models to its cloud customers.

OpenAI, Amazon and Microsoft did not immediately respond to a Reuters request for comment.

The Information, which first reported the talks, said OpenAI plans to use Amazon's Trainium chips, which compete with Nvidia and Google's <GOOGL.O> chips, and added that Amazon's financing could lead to a broader fundraising round with other investors

OpenAI is also looking to sell an enterprise version of ChatGPT to Amazon, but it is unclear whether the deal includes provisions for integrating ChatGPT features such as shopping features that Amazon is developing for its own apps, the report said.

OpenAI, Google woo Indian users with freebies and data

OpenAI, Google and Perplexity have begun an unprecedented fight for artificial intelligence users in India, rolling out freebies in a strategy seen as a way to harvest troves of multilingual training data in the world's most populous nation.

India is the second-biggest smartphone market with 730 million devices. On average, Indians consume 21 gigabytes of data each month, paying 9.2 cents per gigabyte, one of the world's lowest mobile data rates.

To lure price-conscious users, Google in November started giving its \$400 Gemini AI Pro subscription for free for 18 months to 500 million customers of Reliance Jio, India's biggest telecom player. Last week, it added India to dozens of countries where it is offering its heavily discounted "AI Plus" package.

OpenAI has also made its ChatGPT Go plan, which offers extended but not unlimited usage compared with existing plans, free for a year. The plan incurs charges in more than 100 countries and was \$54 in India before being made free to everyone in the country in November.

Just like Google's AI Pro, the free package is only available in India.

Early download data suggests a jump in usage due to the free plans, with daily active users of ChatGPT in India surging 607% year-on-year to 73 million as of last week more than double the number in the U.S., according to data from market intelligence firm Sensor Tower compiled for Reuters.

Gemini's daily users in India rose 15% from when it launched the Reliance Jio offer in November to touch 17 million last week, compared to 3 million in the U.S., the data showed.

Perplexity, meanwhile, has made its Pro tool - priced at \$200 a year globally - free for a year for users of Indian telecom company Airtel. It says the plan gives unlimited access to its most advanced research tools.

India now accounts for more than a third of Perplexity's global daily active users, up from just 7% last year. (**Reuters**)

Blackstone backs Cyera in \$9 billion investment

Blackstone (BX.N), opens new tab is leading a \$400 million investment in Cyera that values the Israeli data-security startup at \$9 billion, the Wall Street Journal reported on Tuesday, citing people familiar with the matter.

Cyera, founded in 2021 and backed by venture capital firms Sequoia Capital and Accel, has an artificial intelligence (AI)-powered platform.

Alternative asset manager Blackstone and Cyera did not immediately respond to Reuters' requests for comment. Reuters could not immediately verify the report.

Cyera had raised \$540 million in a funding round in June this year that doubled its valuation to \$6 billion.

The rapid adoption of AI has resulted in companies spending more to protect their systems from hack, leading to higher demand for firms such as Cyera that provide data security using its AI-driven platform.

In June, the company said it posted 353% growth in Fortune 500 companies over the past 18 months, expanded to 10 countries and more than doubled its size to nearly 800 employees globally. (**Reuters**)

Dembele, 28, won the Ballon d'Or in September, rewarding an exceptional season with PSG, which included the Ligue 1 club's first Champions League title.

"I wanted to thank my teammates. Hard work pays off, it's been a fantastic year for me, both individually and collectively," said Dembele after the ceremony, which took place on the eve of the Intercontinental Cup final between PSG and Flamengo, also being held in Qatar.

Former Borussia Dortmund and Barcelona forward Dembele, who was part of the France team that won the World Cup in 2018, scored 35 goals in all competitions as PSG claimed a French league and cup double as well as European glory.

PSG's Spanish coach Luis Enrique was named best coach of a men's team, ahead of Barcelona's Hansi Flick and Liverpool's Premier League winning manager Arne Slot.

Bonmati, 27, was crowned women's player of the year for the third time in a row, after also picking up her third consecutive Ballon d'Or in the autumn.

"I am grateful to have the honour," she said, before thanking her team-mates and coaches, as well as the fans who voted for

The personal awards come at the end of a year of ups and downs for the Spaniard, who won the Spanish domestic league crown lost both the Champions League and European Championship finals last season.

Bonmati was named player of the tournament at the Euros, despite not starting either of Spain's first two matches as she recovered from a bout of viral meningitis.

She is currently out of action after fracturing her leg in training on the eve of Spain's successful Nations League final second leg win over Germany.

England manager Sarina Wiegman picked up the award for coaching a women's side after she won a third consecutive Euros title in the summer.

In the goalkeeping category, Italy's Gianluigi Donnarumma, who joined Manchester City after winning the Champions League with PSG, picked up the men's award, while Chelsea's Euro 2025 winner Hannah Hampton won the trophy in the women's category.

Santiago Montiel won the coveted Puskas award for best goal of the year thanks to his overhead kick from outside the penalty area

'Sincaraz' rivalry lights up 2025 season, women share the spotlight

CARLOS Alcaraz and Jannik Sinner turned 2025 into a gripping tug-of-war for tennis supremacy by carving up the Grand Slams for a second straight year, while the women's game showcased depth and drama with four different major champions.

Sinner's dominant victory over Alexander Zverev at the start of the season helped him retain his Australian Open title and become the first Italian to capture three majors, moving past Nicola Pietrangeli who won back-to-back French Opens in 1959-60.

What followed after Sinner's three-month ban in February for anti-doping violations in 2024 was nothing short of spectacular, as he took his era-defining rivalry with Alcaraz to the biggest stage in an epic five-set Roland Garros final.

Alcaraz ultimately prevailed after saving three match points - one of the sport's great comebacks in the longest Paris final at five hours and 29 minutes - with the Spaniard establishing himself as the "Prince of Clay" in the post-Rafael Nadal era.

The "Sincaraz" slugfest continued in the Wimbledon final, where Sinner avenged his painful defeat by beating Alcaraz to raise his first trophy on the famous All England Club lawns, perfectly setting up their inevitable US Open showdown.

After thumping Novak Djokovic in the semifinal to prolong the Serb's wait for a record 25th major title, Alcaraz dazzled under New York's lights to dismantle Sinner in the final and tighten his grip on their ri-

"Having this rivalry means a lot. It's super special for me, for him and for people who enjoy it every single time we play."

CAREER GRAND SLAM

With six Grand Slam titles under his belt to Sinner's four, Alcaraz will look to eclipse Nadal and become the youngest man to complete the set of all majors when he heads Down Under in the New Year.

Melbourne provided the biggest surprise in the women's game as Madison Keys dethroned Aryna Sabalenka to win her first Grand Slam title at 29, the American becoming the fourth-oldest first-time major champion in the professional era that began in 1968.

Coco Gauff hoisted the French

Open title, beating Sabalenka in the final to give American fans another high point but Amanda Anisimova endured a brutal reality check in the Wimbledon final, where Iga Swiatek triumphed without dropping a game.

Anisimova shrugged off the double bagel and reached the US Open final but more heartbreak was in store as Sabalenka proved too strong in the battle of big-hitters and retained her title, taking her Grand Slam tally to four.

Sabalenka's hopes of finishing the season with another title were dashed when the world No 1 was comprehensively beaten in the WTA Finals decider, where Elena Rybakina pocketed \$5.235 million after a flawless Riyadh campaign.

Maresca relishes support of Chelsea fans after difficult week

ENZO Maresca said he appreciated the backing of Chelsea's fans after they sung his name during 3-1 win at Tuesday's Cardiff in the League Cup quarterfinals.

Chelsea moved into the semifinals thanks to Alejandro Garnacho's double and a Pedro Neto strike after David Turnbull equalised for League One leaders Cardiff.

The Blues didn't have it all their own way in a hard-fought clash, but reaching a third semifinal in 18 months provided further evidence of Maresca's impact since he arrived from Leicester in 2024.

It was a well-timed victory after Maresca claimed following Saturday's 2-0 win over Everton that the previous 48 hours had been his worst at Stamford Bridge because he and his team lacked "support" from "many people".

The Italian's rant had fuelled speculation he was criticising the club's co-owners Todd Boehly and Behdad Eghbali and sporting directors Laurence Stewart and Paul Winstanley.

It has been suggested that Maresca was unhappy with the failure of Chelsea's hierarchy to publicly support him amid criticism of his rotation policy during the team's recent dip in

The win over Cardiff was only their second in six games in all competitions.

But Maresca, who led the Blues to Club World Cup and UEFA Conference League glory earlier this year, was serenaded by Chelsea's travelling supporters, who sang his name throughout the Cardiff match.

"I'm just happy, we're going to play another semifinal and I think it's what the fans deserve," Maresca said after making a point of marching across the pitch to acknowledge the fans at the final whistle.

Senegal talisman Mane overcame grief to become an African icon

SENEGAL talisman and striker Sadio Mane could have missed out on a glittering football career had he agreed with a wish of his late father.

The 33-year-old was discouraged from playing football as a child because his father, a devout Muslim, wanted his son to concentrate on religious studies instead.

Mane - 'This is a hard thing to deal with when you are so young'

Mane, who would go on to become an African football icon, made this revelation when speaking to a senior Confederation of African Football (CAF) official.

Despite differing views about football, the two-time African player of the year stressed his love for his father, and how heartbroken he was as a seven-year-old when his parent

"When I was young my dad was always saying how proud he was of me. He was a man with a big heart. His death had a major impact on me and the rest of my family," Mane said.

"I said to myself — now I have to do my best to help my mother. That is a hard thing to deal with when you are so young."

But he succeeded, going on to play for clubs in France, Austria, England, Germany and Saudi Arabia, and helping his country win the Africa Cup of Nations (AFCON) for the first time in 2002.

After stints with Metz and Salzburg, Mane joined Southampton in 2014 and his 176-second hat-trick against Aston Villa remains the fastest in the Premier League.

After two seasons with the Saints, Mane

joined Liverpool, operated alongside Egyptian star Mohamed Salah, and the pair helped bring many trophies to Anfield.

The silverware haul included the Champions League, UEFA Super Cup, Club World Cup, Premier League, FA Cup and League

After six seasons with the Reds, Mane spent one at Bayern Munich, then joined many other African stars in the lucrative Saudi Pro League.

Happy memories

A goalless 2022 AFCON final against Egypt in Yaounde meant a penalty shootout, and Mane converted the spot kick that brought glory to Senegal.

Victory was particularly joyful as the Teranga Lions had also reached the previous AFCON final, three years earlier in Cairo, but conceded after just two minutes and lost 1-0 to Algeria.

Senegal were unable to achieve back-toback titles in 2024, though, losing on penalties to hosts and eventual champions Ivory Coast in a round-of-16 clash.

They have been drawn with Botswana, the Democratic Republic of Congo and Benin in Group D at the 2025 AFCON in Morocco, which kicks off on Sunday.

The clash with the Congolese will bring back happy memories for the Senegalese, who came from two goals behind to win 3-2 in Kinshasa last October and went on to secure a place at the 2026 World Cup.

Mane did not score in the DR Congo capital, but a month later netted twice in a 4-0 home victory over Mauritania that sealed the World Cup slot.

Senegal hit 22 goals in 10 World Cup qualifiers and Mane was the leading scorer with five, one more than Tottenham Hotspur midfielder Pape Matar Sarr.

Senegal spoilt for choice

Like a number of other 2025 AFCON title hopefuls, Senegal are spoilt for choice when head coach Pape Thiaw selects his strikers.

Mane of Al Nassr, Nicolas Jackson, on loan from Chelsea to Bayern Munich, Iliman Ndiaye of Everton and Ismaila Sarr of Crystal Palace are just some of the options.

Then there is 17-year-old Ibrahim Mbaye from Champions League title-holders Paris Saint-Germain, who made his international debut in a friendly defeat by Brazil last

A few days later he became the youngest scorer for Senegal by netting in an 8-0 rout of Kenya in another AFCON warm-up

Mane scored a hat-trick against the east Africans — a timely reminder to AFCON rivals that age has not diminished his predatory instincts.



"Let this match be played for Bondas, for the love he gave, the loyalty he showed, and the passion he carried until his final day," wrote Thwala.

To the Simelane and Swallows families, his friends, and the entire Eswatini football fraternity, Thwala extended his deepest and most sincere condolences.



Alleged Bondigunman charged with 15 murders

A man who allegedly opened fire on a Jewish Hanukkah celebration on Sydney's famed Bondi Beach has been charged with 59 offences, including murder and terrorism, police said on Wednesday.

The alleged father-and-son perpetrators opened fire on the celebration at Sydney's famed Bondi Beach on Sunday, killing 15 in an attack that shook the nation and intensified fears of rising antisemitism and violent extremism.

Funerals of the Jewish victims of the attack began on Wednesday, amid anger over how the gunmen - one of whom was briefly investigated for links to extremists - were allowed access to powerful firearms.

Sajid Akram, 50, was shot dead by police at the scene, while his 24-year-old son Naveed Akram emerged from a coma on Tuesday afternoon after also being shot by police.

New South Wales Police said on Wednesday that a man had been charged with 59 offences, including 15 counts of murder, 40 counts of wounding with attempt to murder, as well as a terror offence and other charges.

"Police will allege in court the man engaged in conduct that caused death, serious injury and endangered life to advance a religious cause and cause fear in the community," it said in a statement.

"Early indications point to a terrorist attack inspired by ISIS, a listed terrorist organisation in Australia."

A court filing on Wednesday named Naveed Akram, who remains in a Sydney

hospital under heavy police guard, as the man charged.

He will appear via video link before a local court on Monday morning.

The father and son had travelled to the southern Philippines, a region long plagued by Islamist militancy, weeks before the shooting that Australian police said appeared to be inspired by Islamic State.

U.S. President Donald Trump told a Hanukkah event at the White House late on Tuesday that he was thinking of the victims of the "horrific and antisemitic terrorist attack"

"We join in mourning all of those who were killed, and we're praying for the swift recovery of the wounded," he said.

UK inflation falls to 3.2% ahead of rate decision

British consumer price inflation fell unexpectedly sharply to 3.2% in November, its lowest since March, from 3.6% in October, official figures showed on Wednesday, a day before the Bank of England is widely expected to cut interest rates.

A Reuters poll of economists had shown a median forecast of a fall to 3.5% in November's annual inflation rate, though the BoE had pencilled in a slightly bigger drop to 3.4%.

Sterling dropped by around half a cent against the U.S. dollar after the data came out, which reinforced expectations for looser monetary policy.

Financial markets have been pricing in a more than 90% chance of the BoE cutting rates by a quarter point to 3.75% on Thursday, though many economists have said they see the decision as more finely balanced.

Wednesday's data showed services price inflation, which the BoE sees as reflecting as a guide to longer-term inflation pressures, fell to 4.4% rather than holding at 4.5% as economists and the BoE had expected.

Food and non-alcoholic beverage inflation dropped to 4.2% from 4.9% in October. The BoE has said it expects this to rise 5.3% in December, the highest in nearly two years. Core CPI - which excludes more volatile

food, alcohol, energy and tobacco prices - also slowed to 3.2% rather than holding at 3.4% as economists had forecast in the Reuters poll.

Last month the BoE's Monetary Policy Committee voted 5-4 to keep interest rates on hold, breaking the quarterly cadence of rate cuts in place since 2024 and economists

expect a December rate cut by only a narrow 5-4 margin.

Of those members who opposed a cut in November, Governor Andrew Bailey looks most likely to switch votes as he said in minutes of the decision that he wanted to see further falls in price pressures "this

year" before backing a cut.

British inflation has been higher than in other major advanced economies and in November the central bank forecast it would remain above its 2% target until the second quarter of 2027.

'Australia's gun laws riddled with loopholes'

After Australia's deadliest mass shooting in 1996, the country rushed in some of the world's toughest gun laws, including mandatory licensing and background checks, as well as registration of every firearm.

But a winding back of those laws, failure to update them with the internet age and growing complacency with background checks may have made it easier for two suspects behind Sunday's shooting during a Hanukkah celebration at Sydney's Bondi Beach to acquire weapons, gun safety experts said.

Reeling from the attack that killed 15 people, Australia is now questioning the effectiveness of laws that have become a point of national pride. Australia typically has fewer gun deaths per year than the U.S. has in a day, a statistic many Australians credit the gun laws with.

In effect, the laws are a patchwork system run by the eight state and territory police forces, negotiated by the federal government after the 1996 attack in Port Arthur, Tasmania, that killed 35 people. Tweaks by some states in the years since have relaxed the oversight, enabling people to acquire more weapons with less supervision, the experts said.

According to the authorities, the older shooter at Bondi, named as Sajid Akram, 50, who was shot dead by police, received his gun licence in 2023 and had six legally owned weapons that he and his son allegedly used in the attack. In 2008, the state of New South Wales removed a mandatory 28-day cooling-off period when a person with one gun wanted more; most states have done similar

"The idea was that for each subsequent gun, the scrutiny should be more intense because it should be more difficult," said Rebecca Peters, a gun control advocate who advised the Australian government on the 1996 law.

"Imagine if he'd had to have a 28-day waiting period for each of those guns. He wouldn't have, because New South Wales has abandoned it," added Peters. The state government, which has said it will urgently meet to consider new gun laws, did not immediately respond to a request for comment.

In the wake of the Bondi attack, Australia's federal government has acknowledged shortcomings in the current laws and proposed changes including setting a limit of how many guns a licenceholder can own, plus an end to giving licences "in perpetuity". (Reuters)



The artist, whose real name is Lehlogonolo Katlego Chauke, has been in custody since his arrest in November.

He is facing several serious charges, including three counts of attempted murder, assault, and alleged possession of an illegal firearm

The state opposed his bail application, arguing that the charges were severe and that releasing him could pose a risk to public safety and the administration of justice.

In its ruling, the court found that Shebeshxt had failed to demonstrate exceptional circumstances that would justify his release on bail

The court's ruling has drawn criticism from sections of the entertainment industry.

The Limpopo Artists Movement (LAM) said the outcome and its timing had negatively affected artists and promoters benefiting from Shebeshxt's value chain.

LAM chairperson Mphoza Mashabela said the ruling had financial consequences beyond the accused.

"As LAM, we are very disappointed with the outcome, especially the timing, which was bad. Shebe lost money, and promoters also lost money. This situation is bad for the entertainment industry," Mashabela said.

Case postponed to February 18.

Shebeshxt, a polarising figure in South Africa's music scene, has enjoyed massive popularity through viral hits and energetic performances but has frequently courted controversy due to repeated run-ins with the law. The National Prosecuting Authority

Artists benefiting from Shebeshxt's gigs face bleak festive

(NPA) welcomed the court's decision, saying it affirmed the principle that serious violent crimes must be dealt with decisively.

NPA regional spokesperson Mashudu Malabi-Dzhangi said the State had successfully demonstrated that the accused's release would not be in the interests of justice.


"The court correctly found that the accused failed to show exceptional circumstances as required in Schedule 6 matters. The State presented evidence indicating a likelihood of further offenses and that releasing the accused would undermine the criminal justice system," Malabi-Dzhangi said. She added that the NPA remains committed to ensuring that justice is served for the victims.

"We will continue to oppose bail in serious violent crime matters and ensure that perpetrators are held accountable through the courts," she said.

The matter has been postponed to February 18, 2026, and Shebeshxt will remain in custody until his next court appearance.

The well-known musician was nabbed during an intelligence-driven operation in November in the upscale suburb of Bendor, outside of Polokwane.

The arrest was made during a joint operation between the provincial investigation unit and the provincial tracking team, following a warrant issued in connection with two counts of attempted murder registered at Westernburg SAPS (South African Police Service). (Sunday World)
